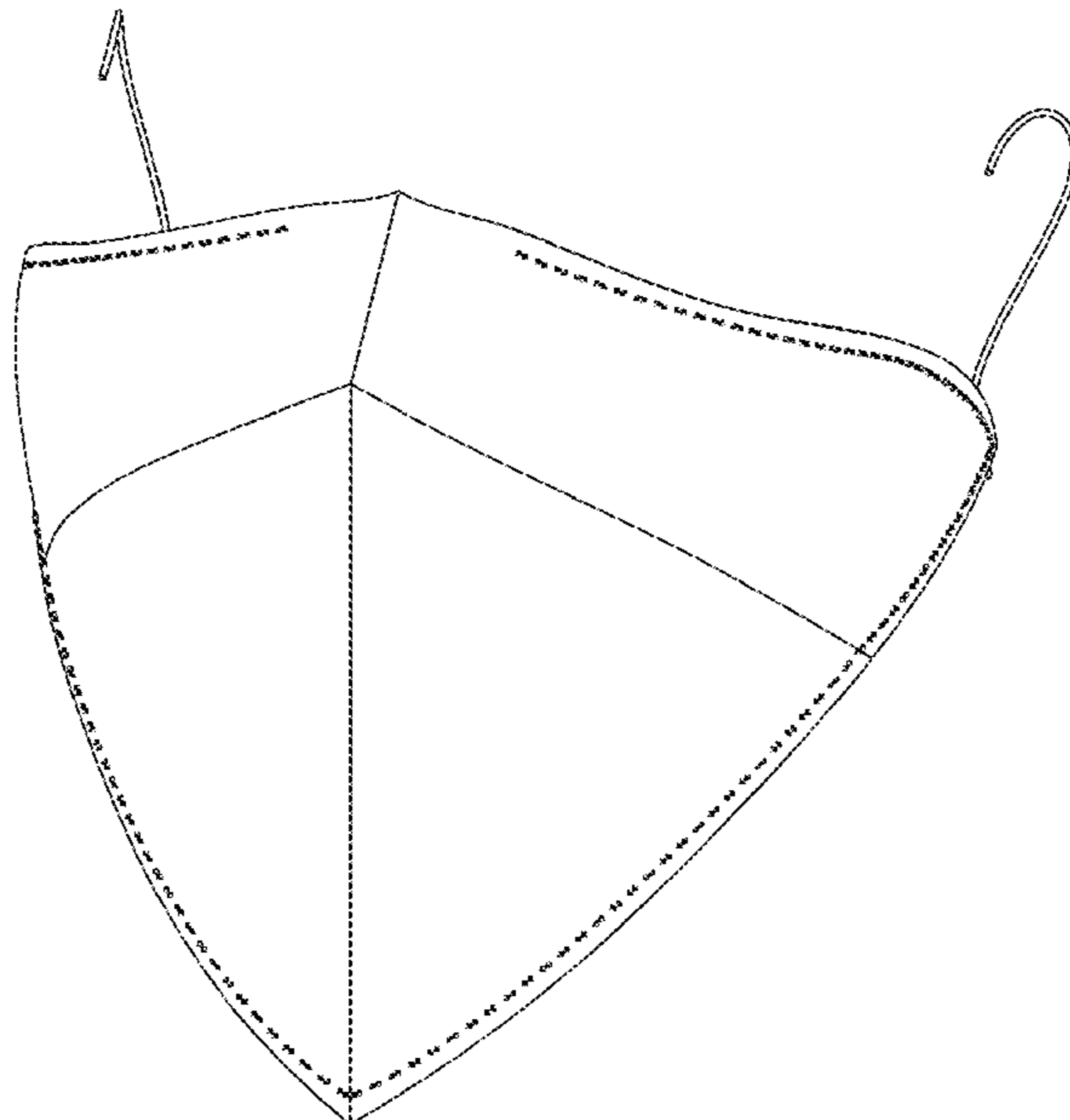

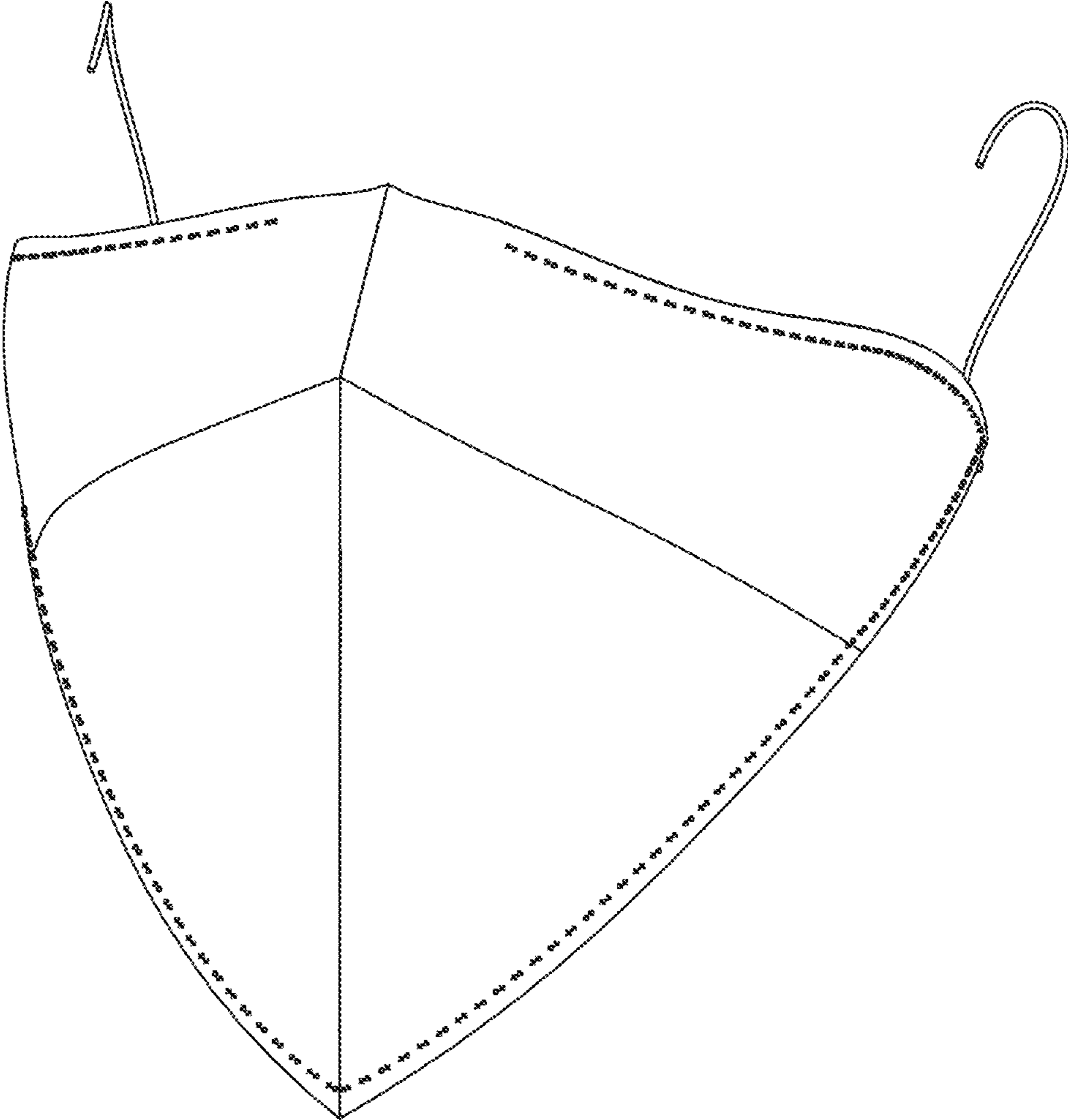

The broken lines in the drawings depict portions of the face mask that form no part of the claimed design.

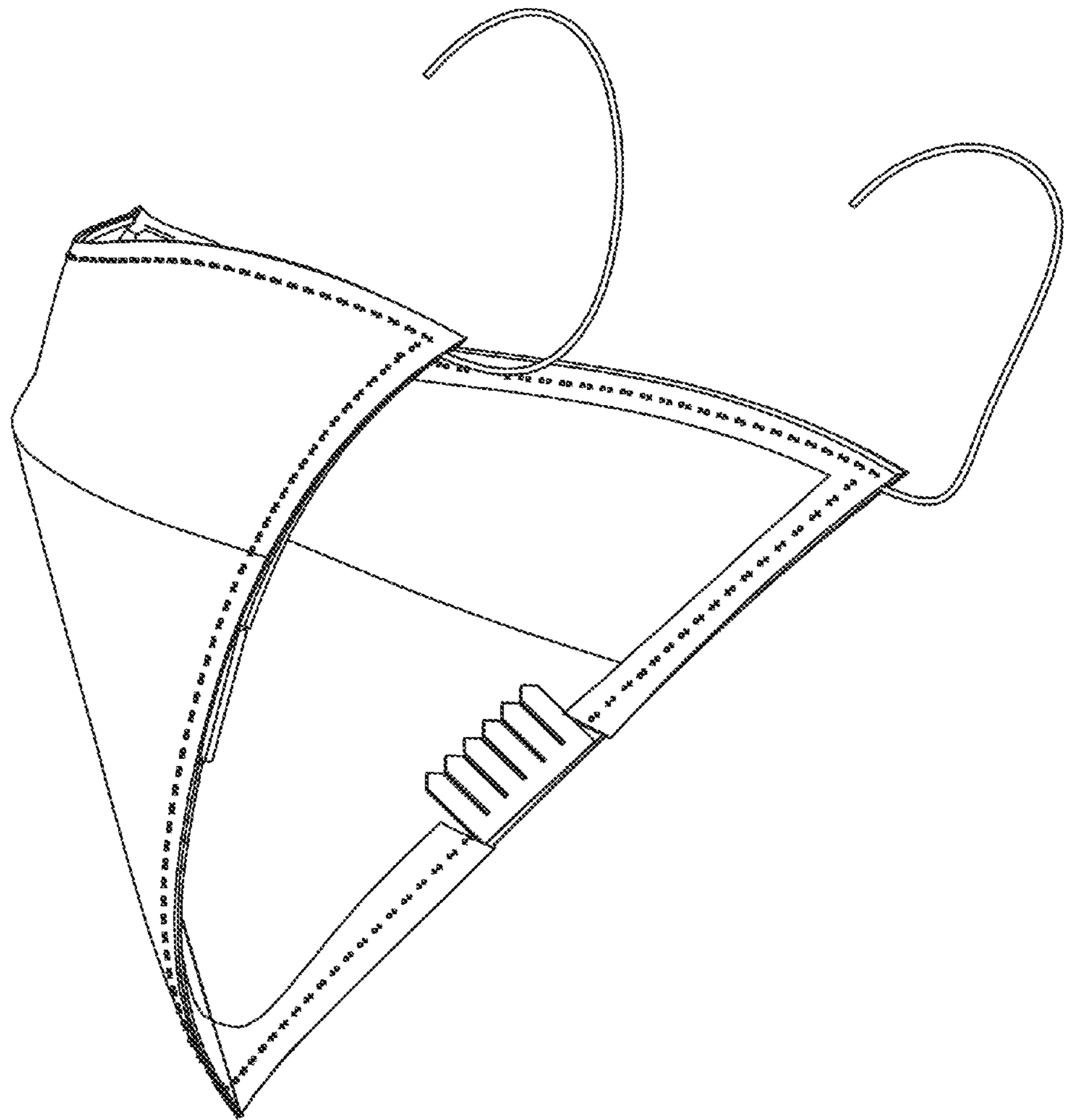

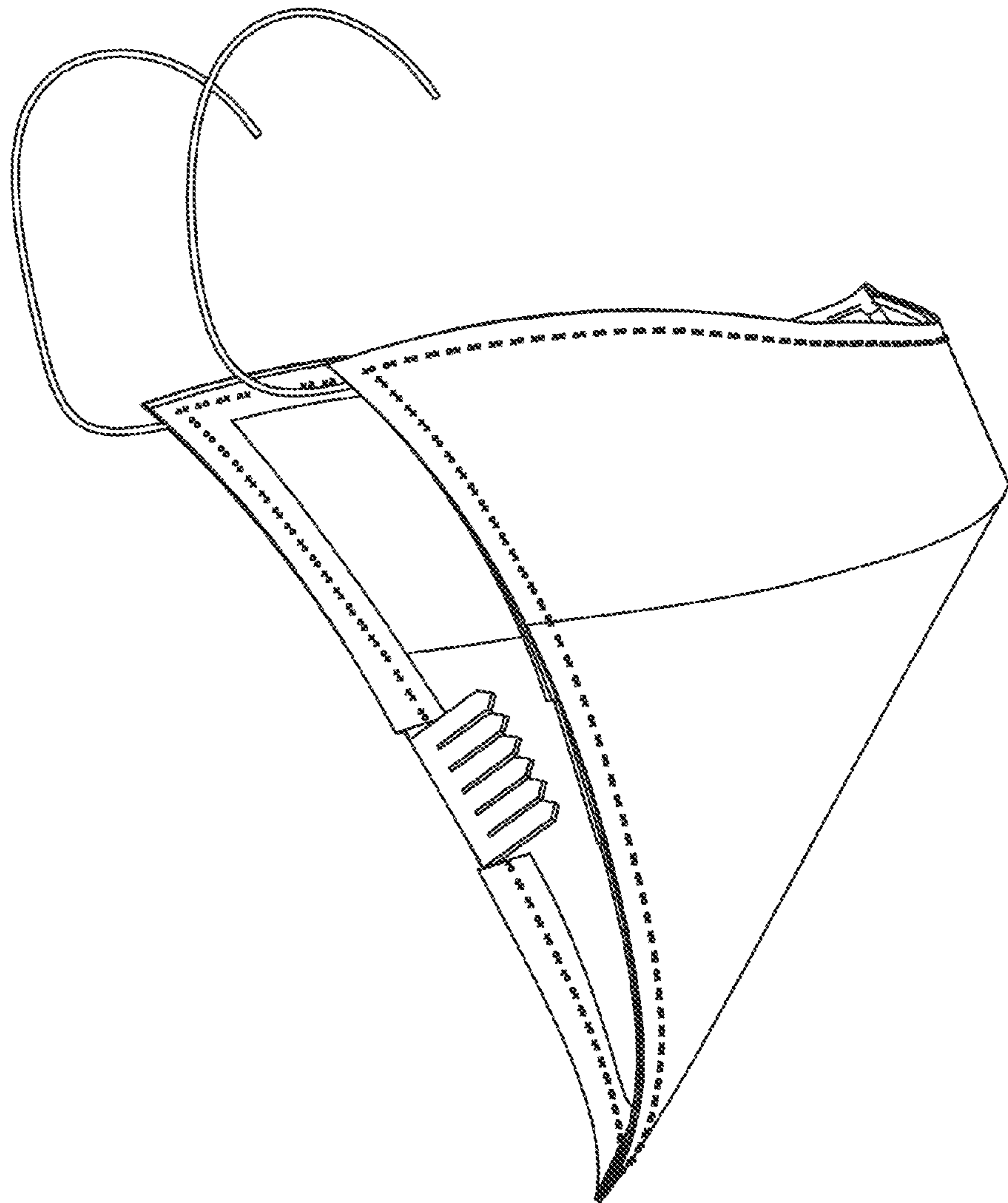

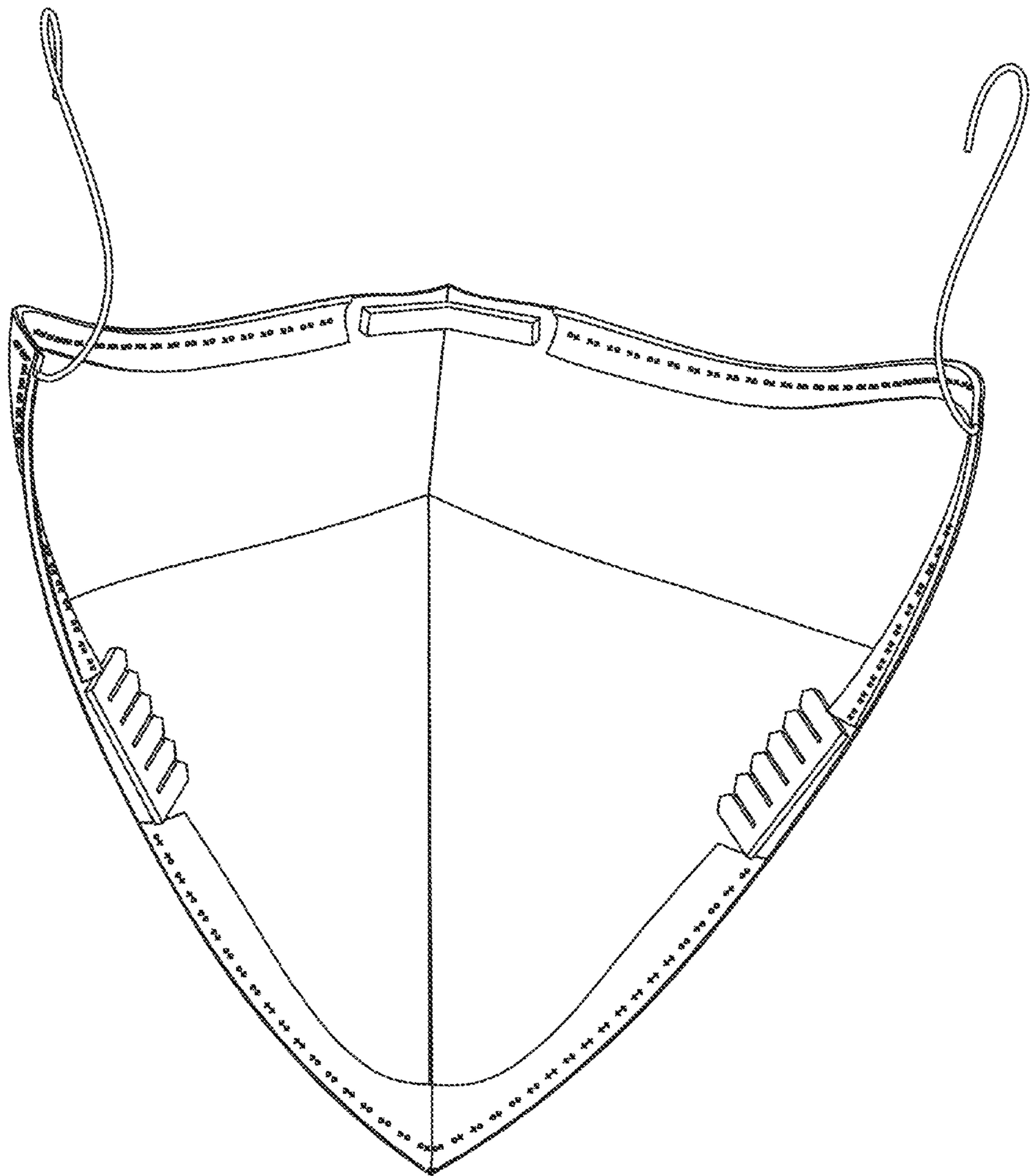

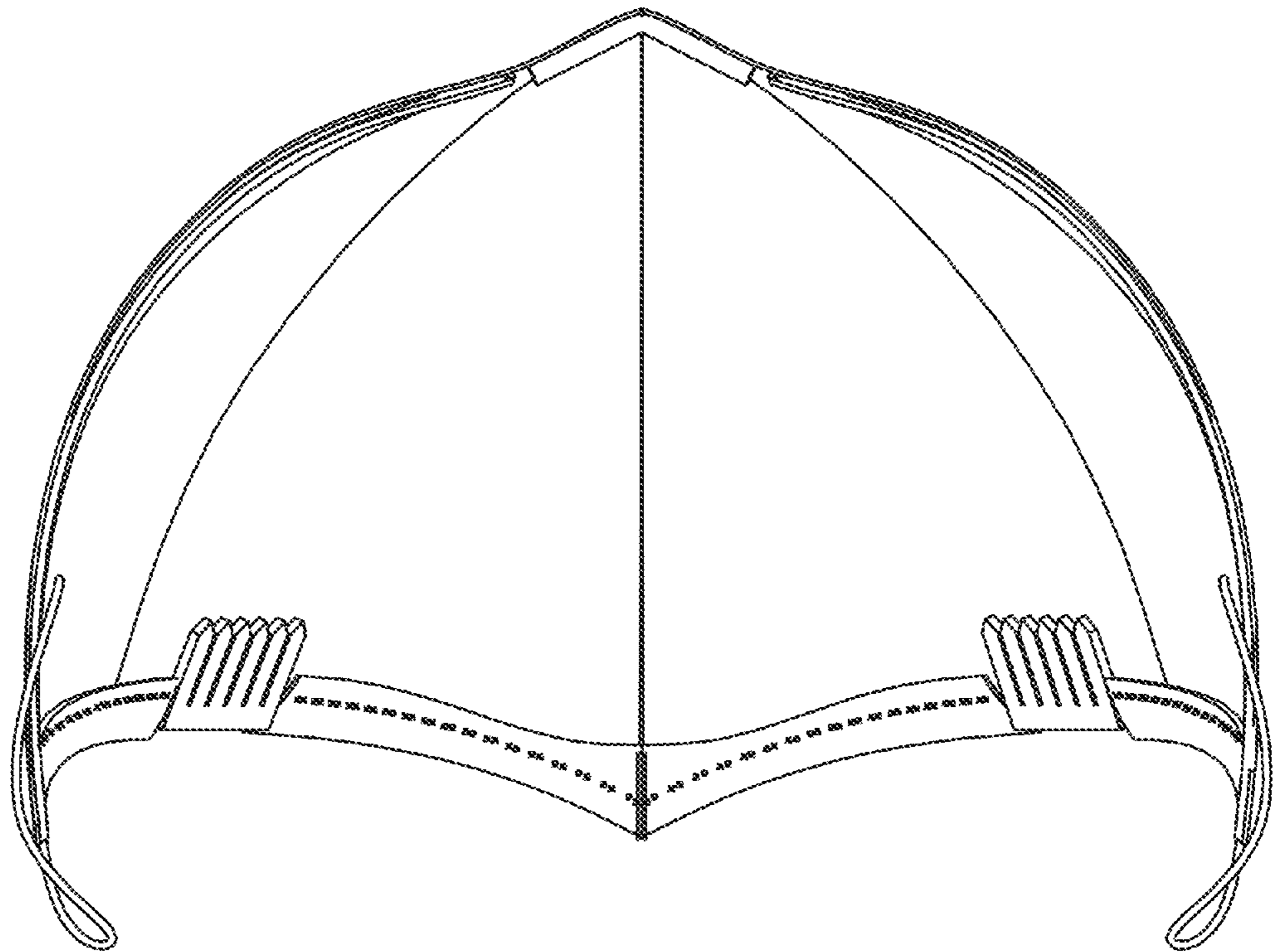
