DESCRIPTION

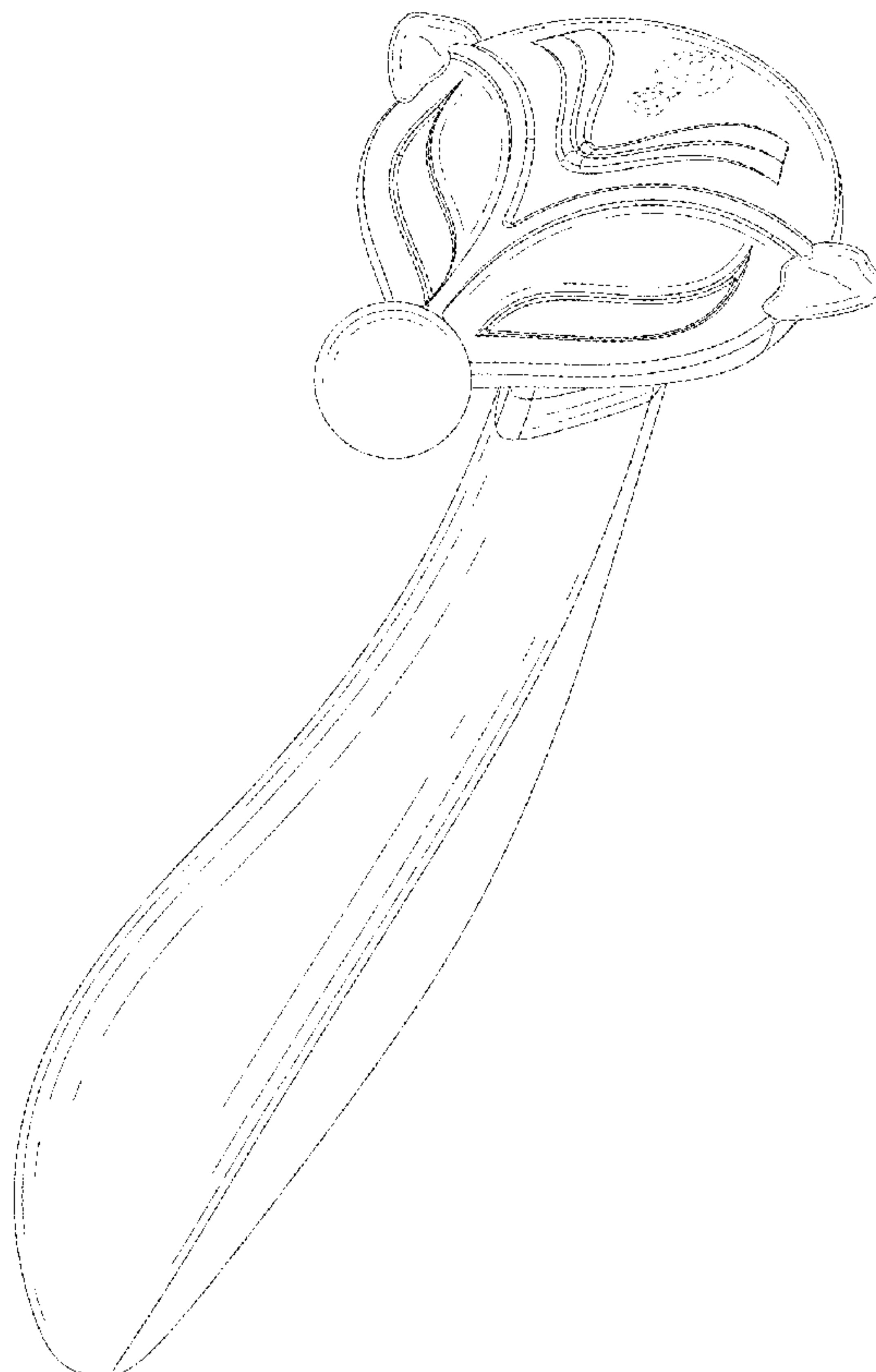
FIG. 1 is a front perspective view of a sex toy, showing my new design;

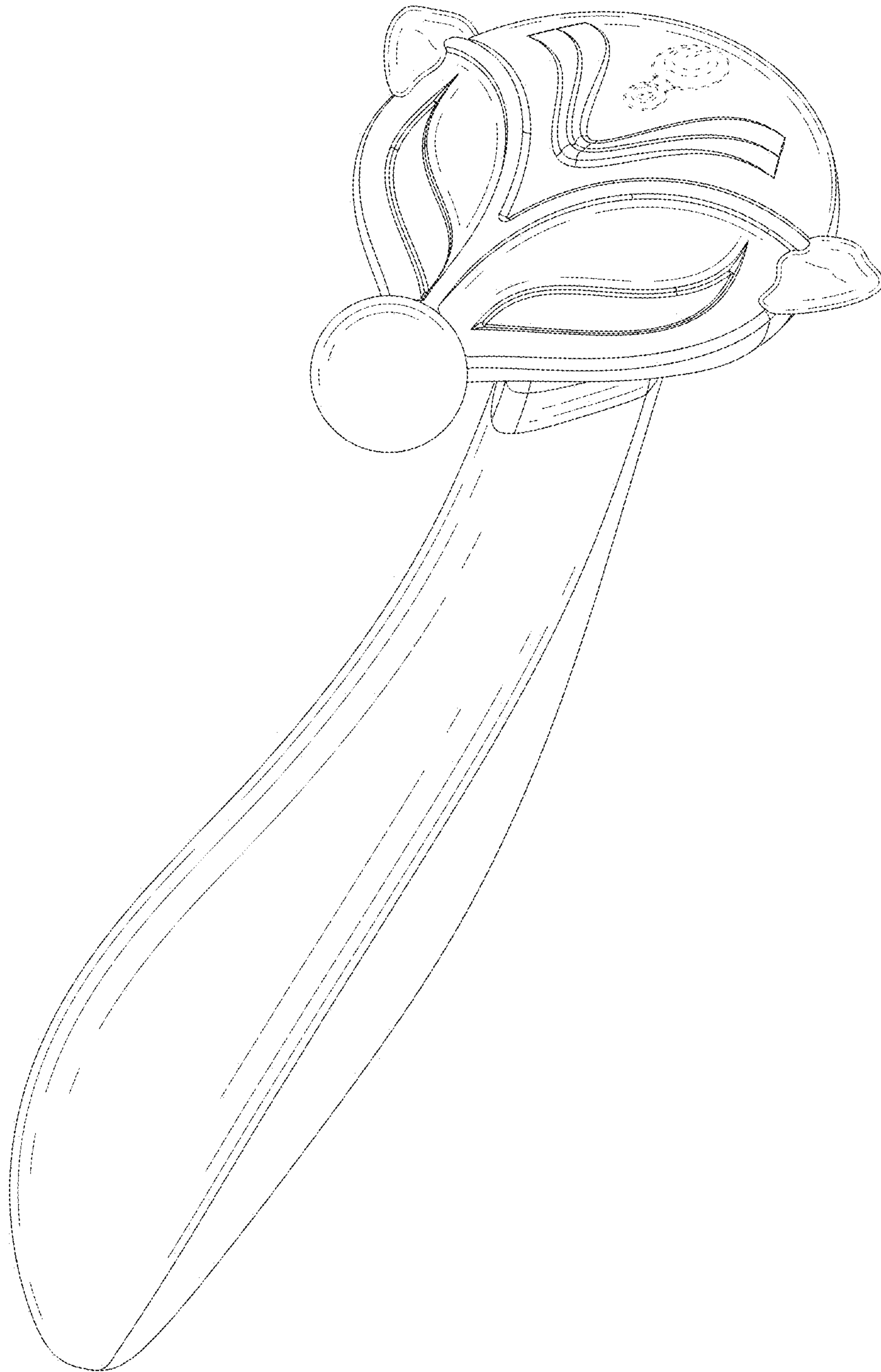

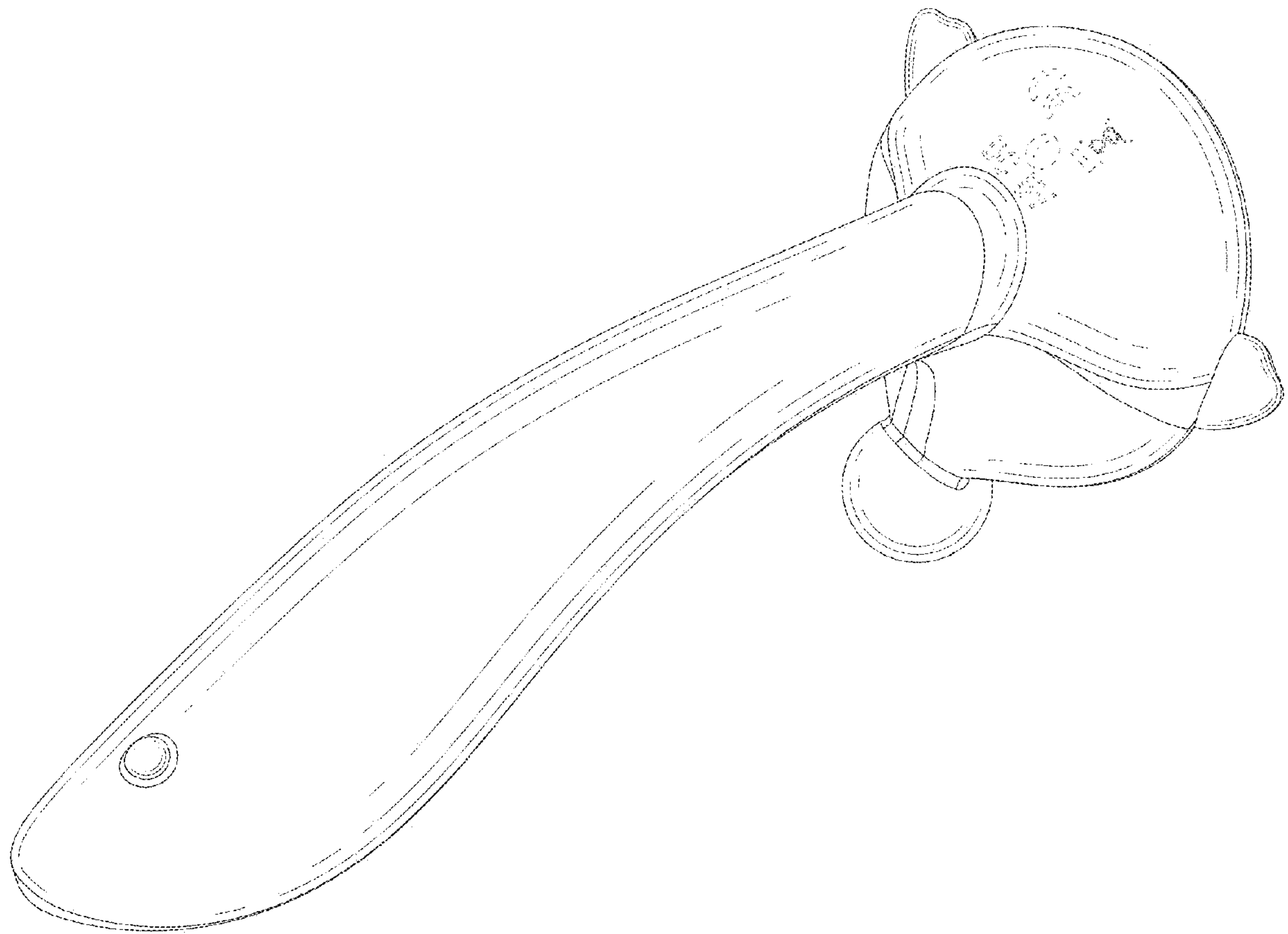

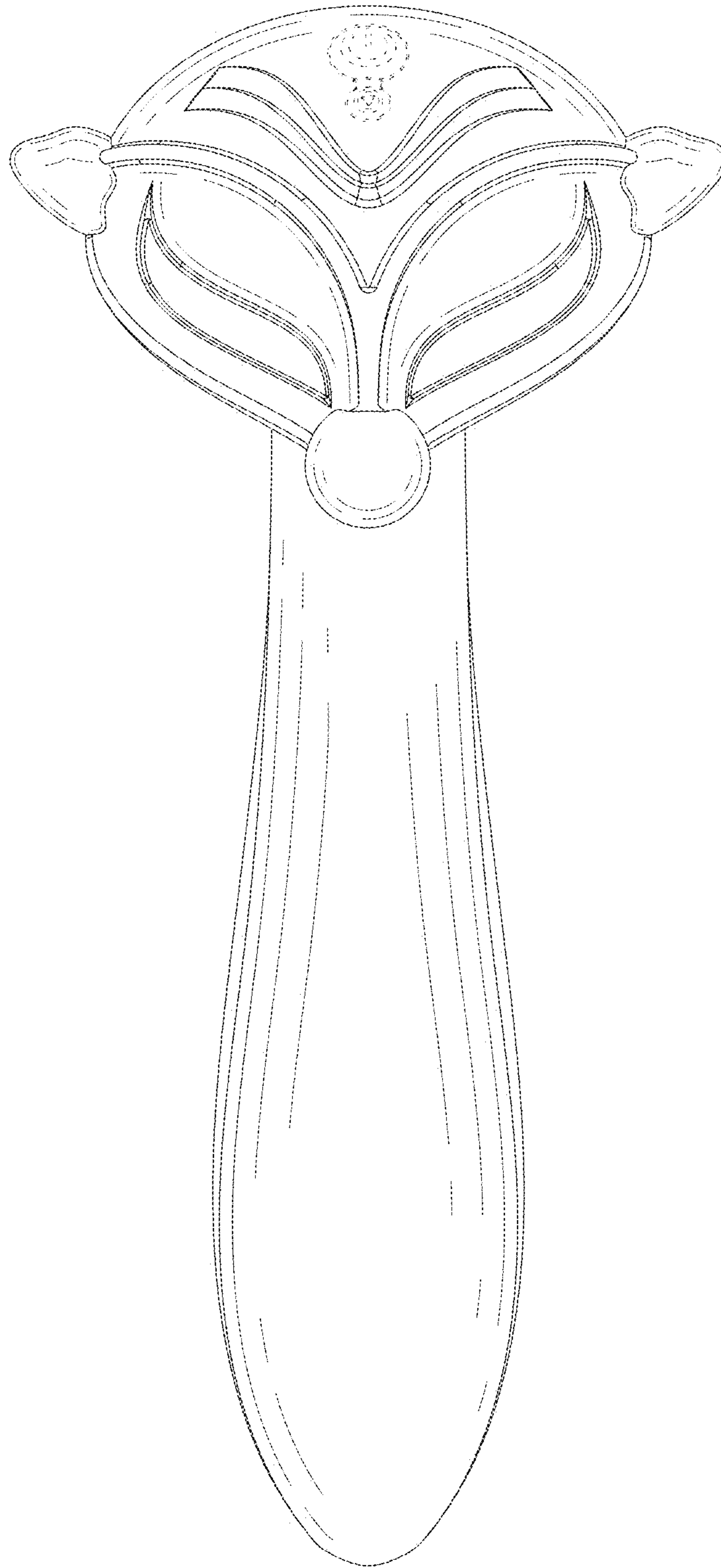

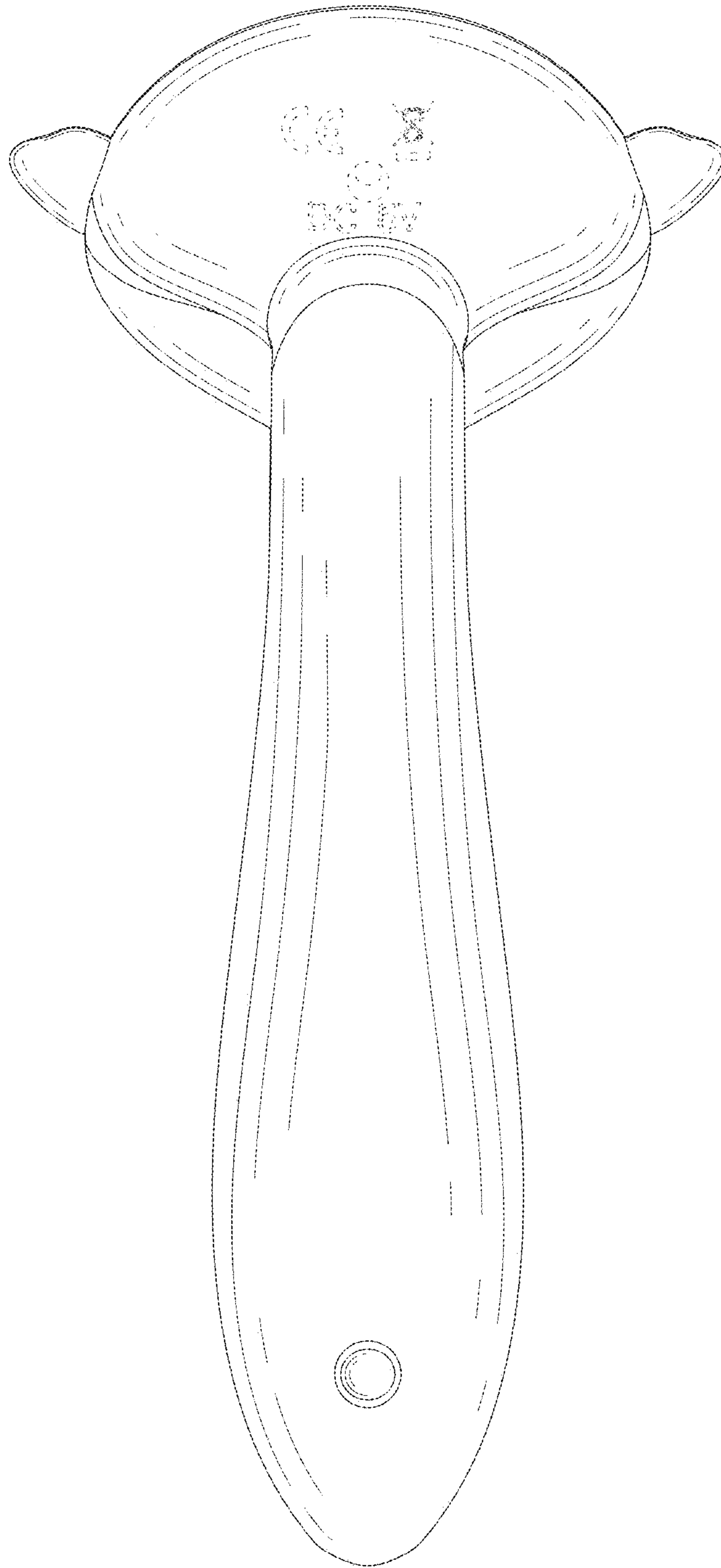

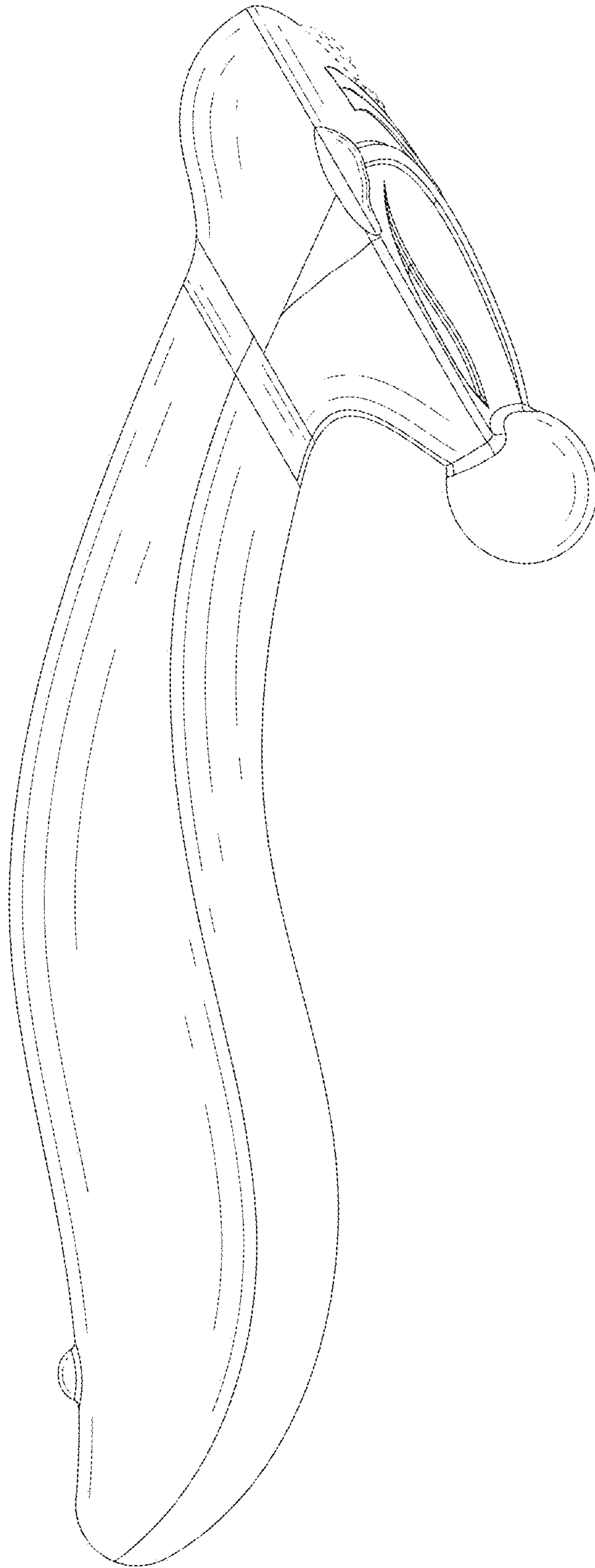

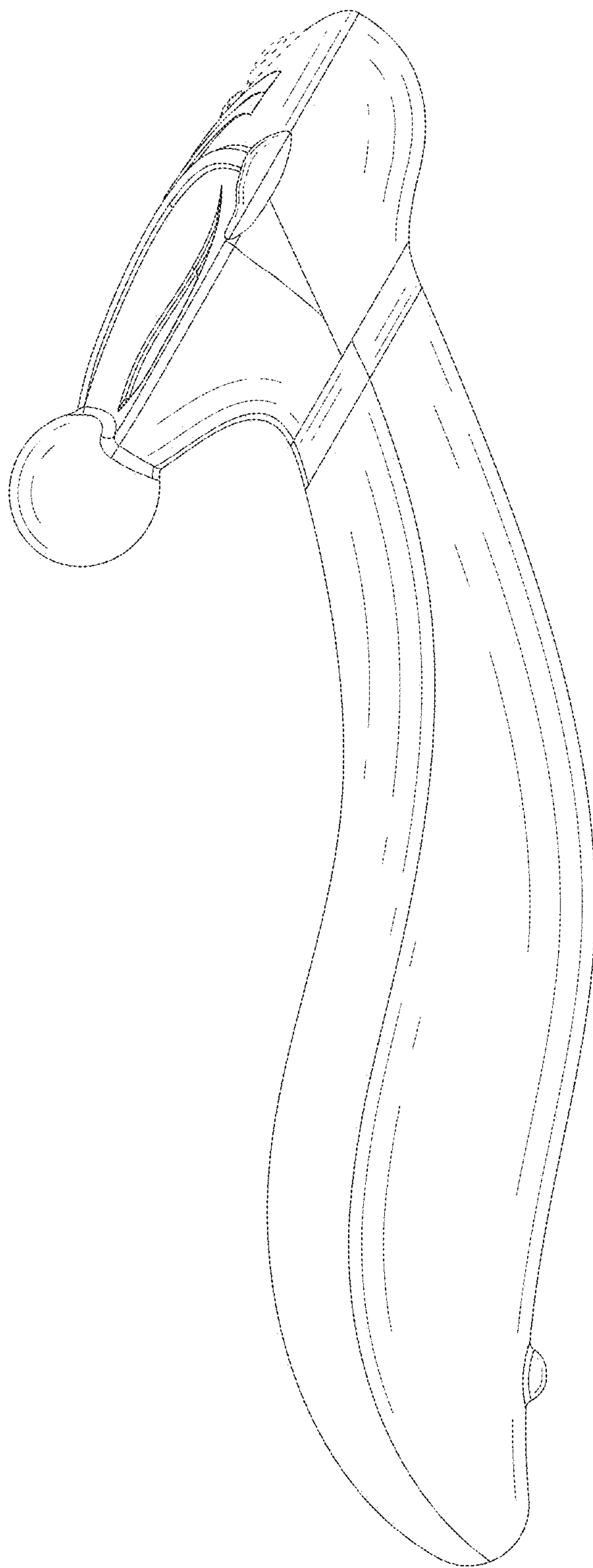

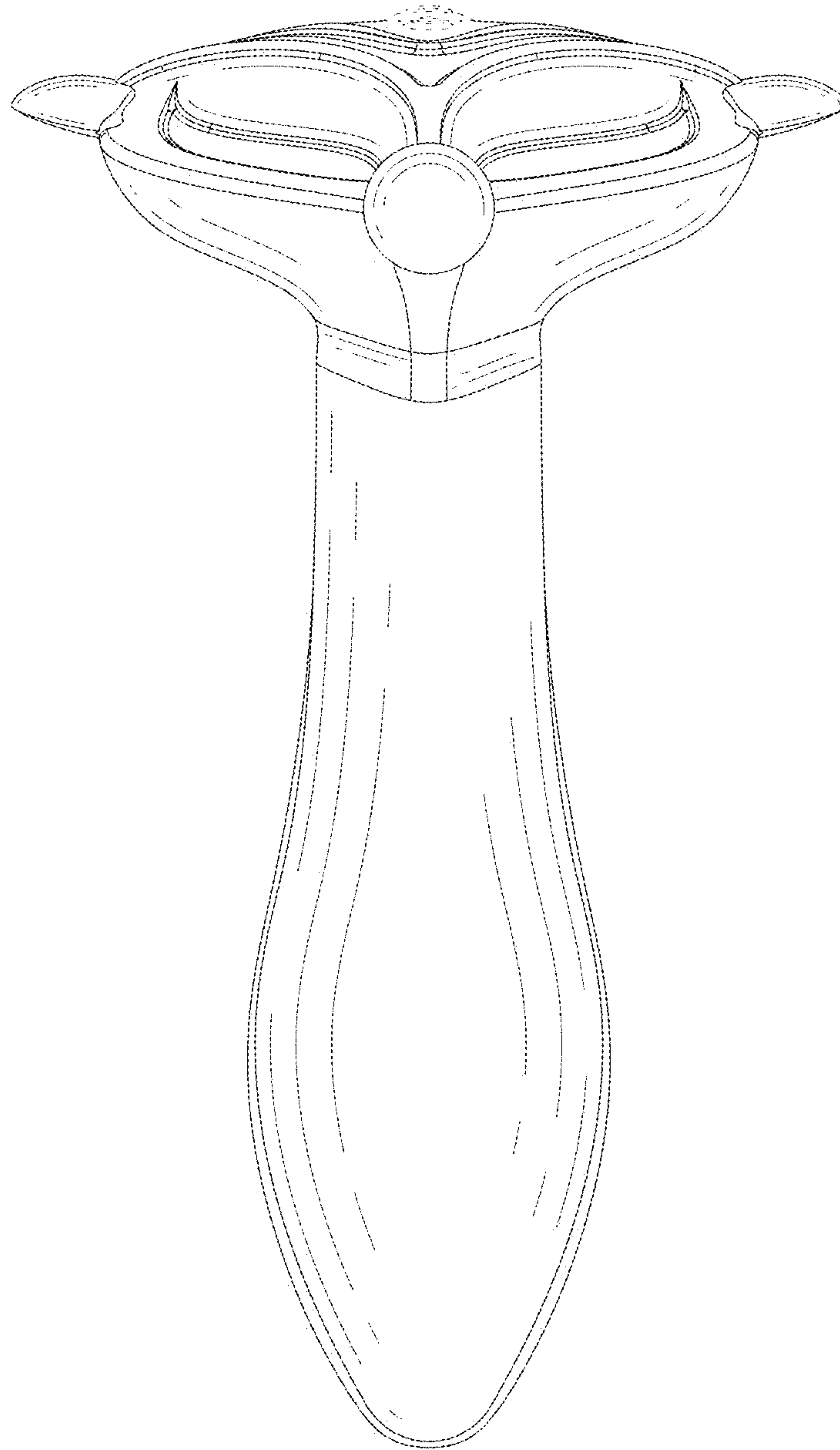

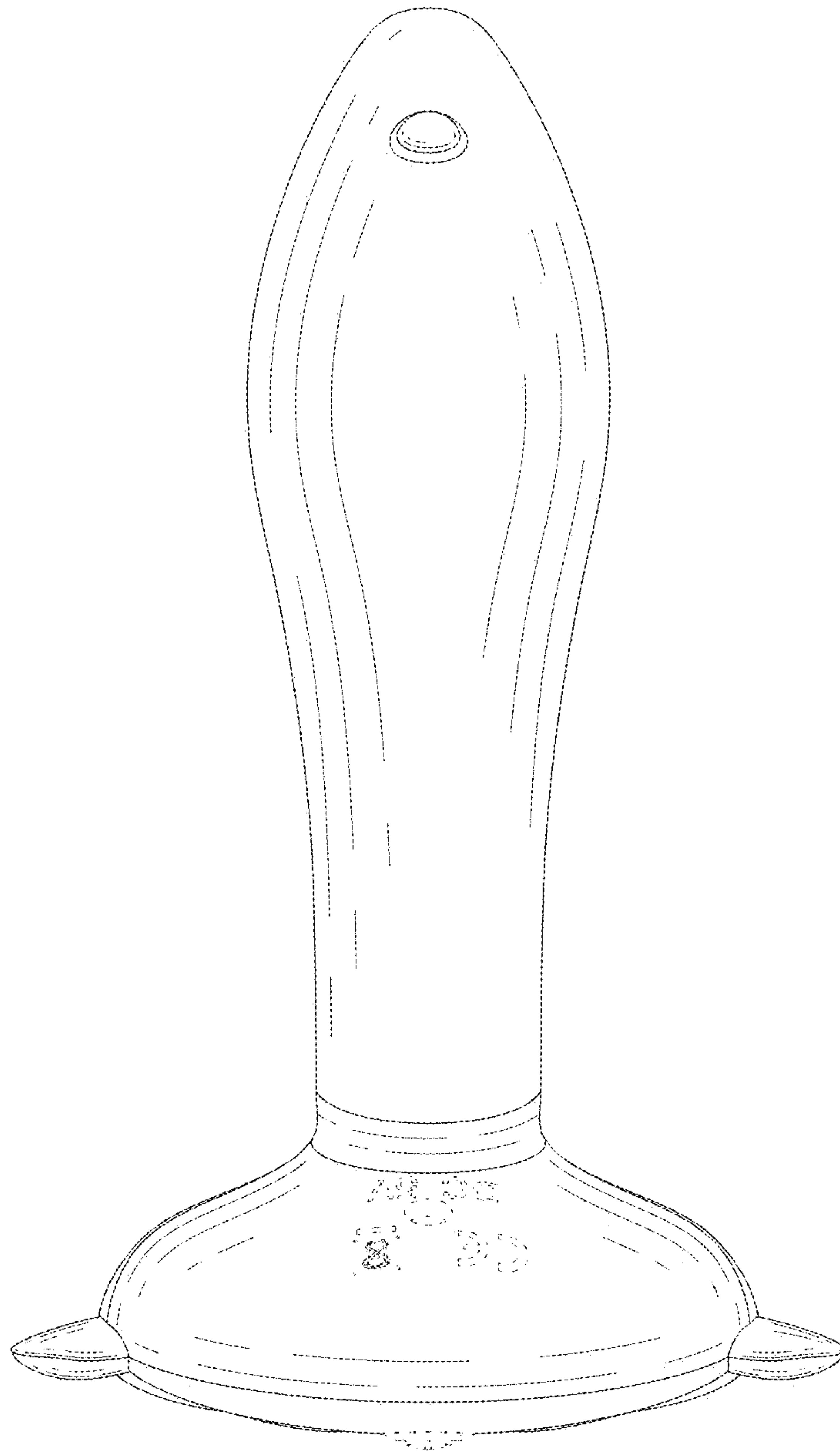
