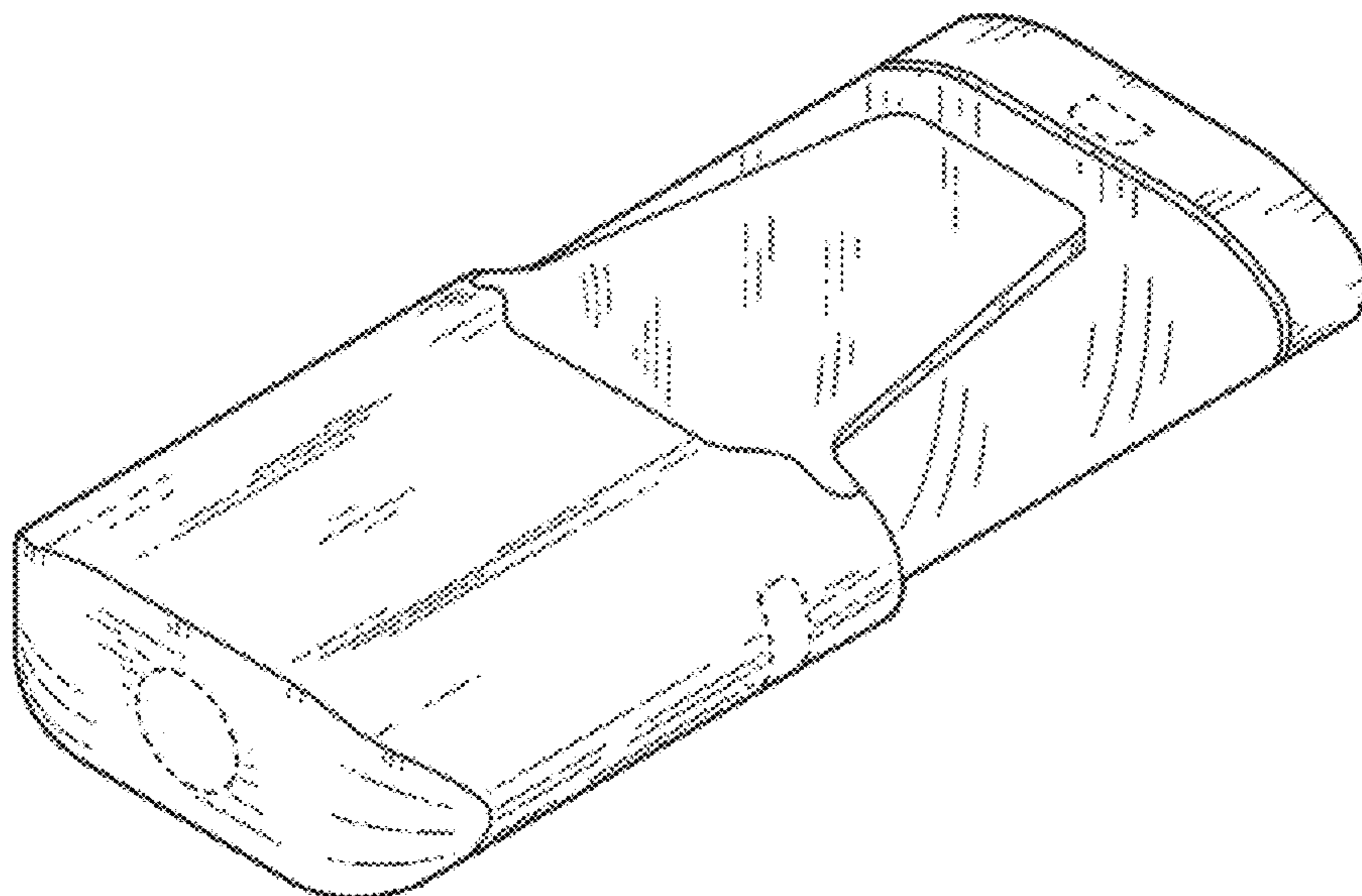
(57) **CLAIM**

We claim the ornamental design for a vaporizer pod, as shown and described.

**DESCRIPTION**

FIG. 1 is a front (and identical rear) elevation view of the vaporizer pod, showing our new design; FIG. 2 is a right (and identical left) elevation view thereof; FIG. 3 is an enlarged top plan view thereof; FIG. 4 is an enlarged bottom plan view thereof; and, FIG. 5 is a top perspective view thereof. The broken lines in the drawings depict portions of the vaporizer pod that form no part of the claim.

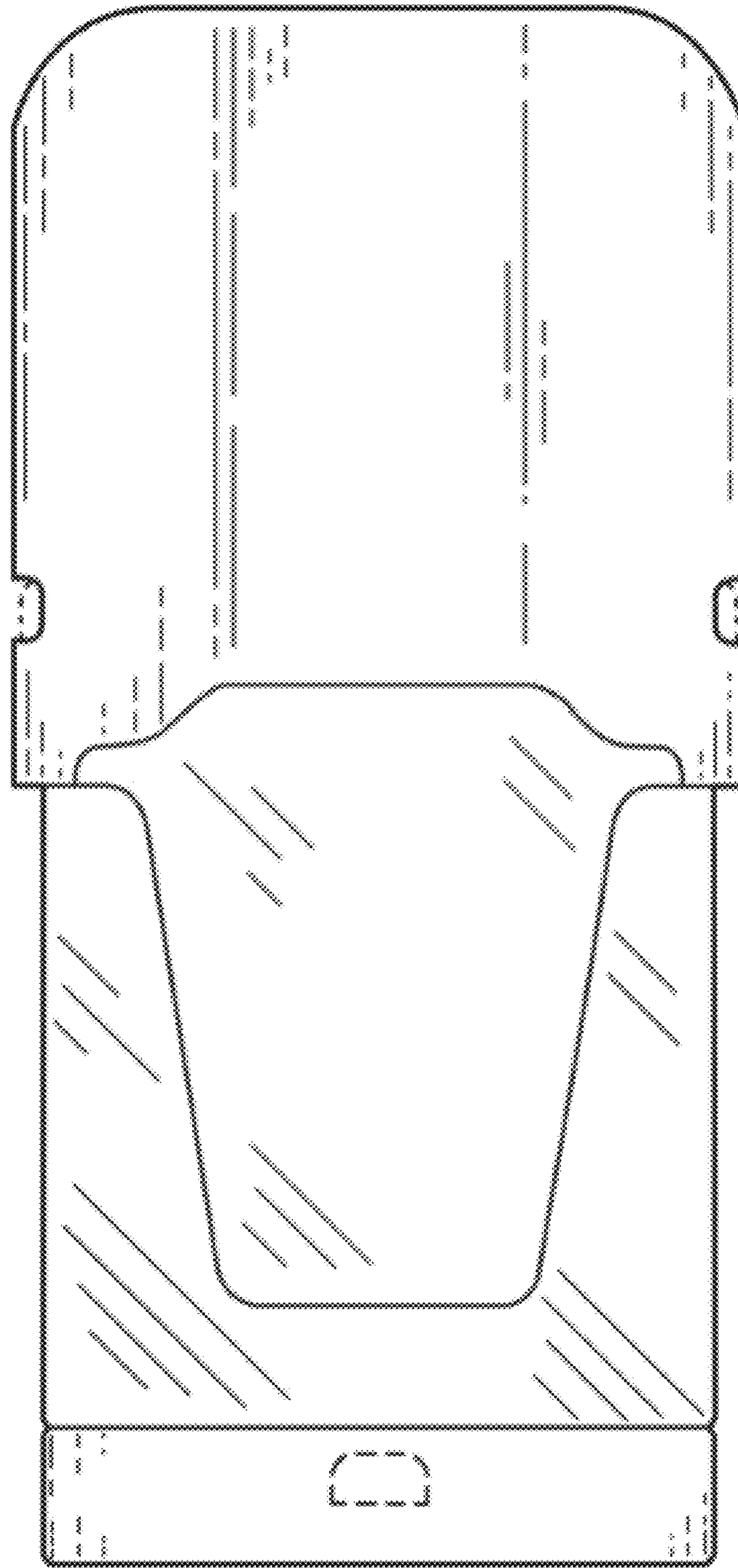

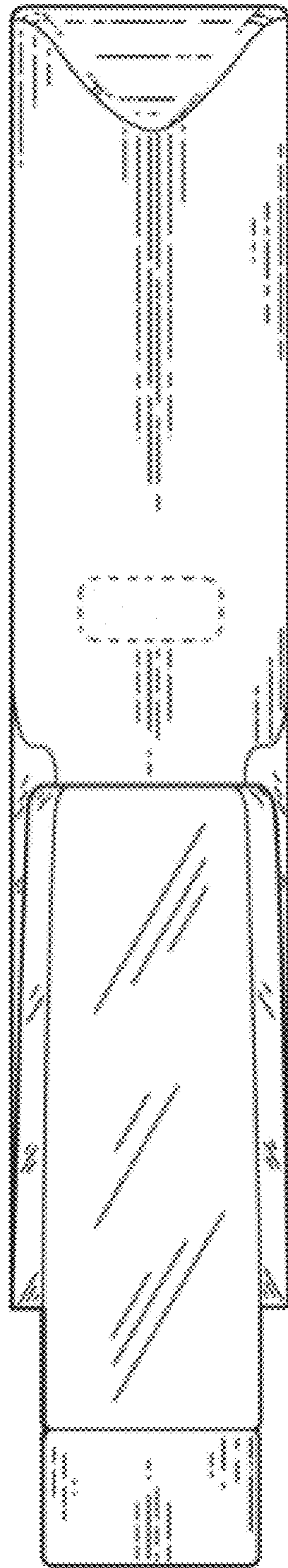

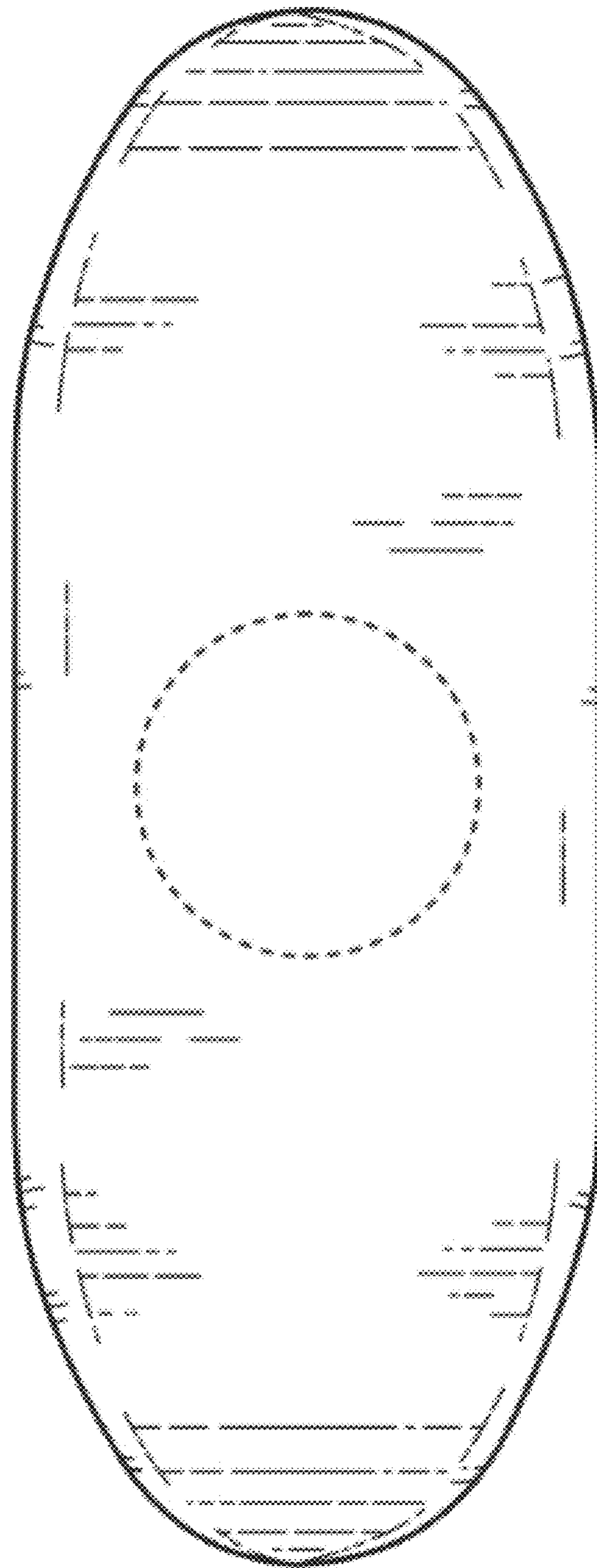

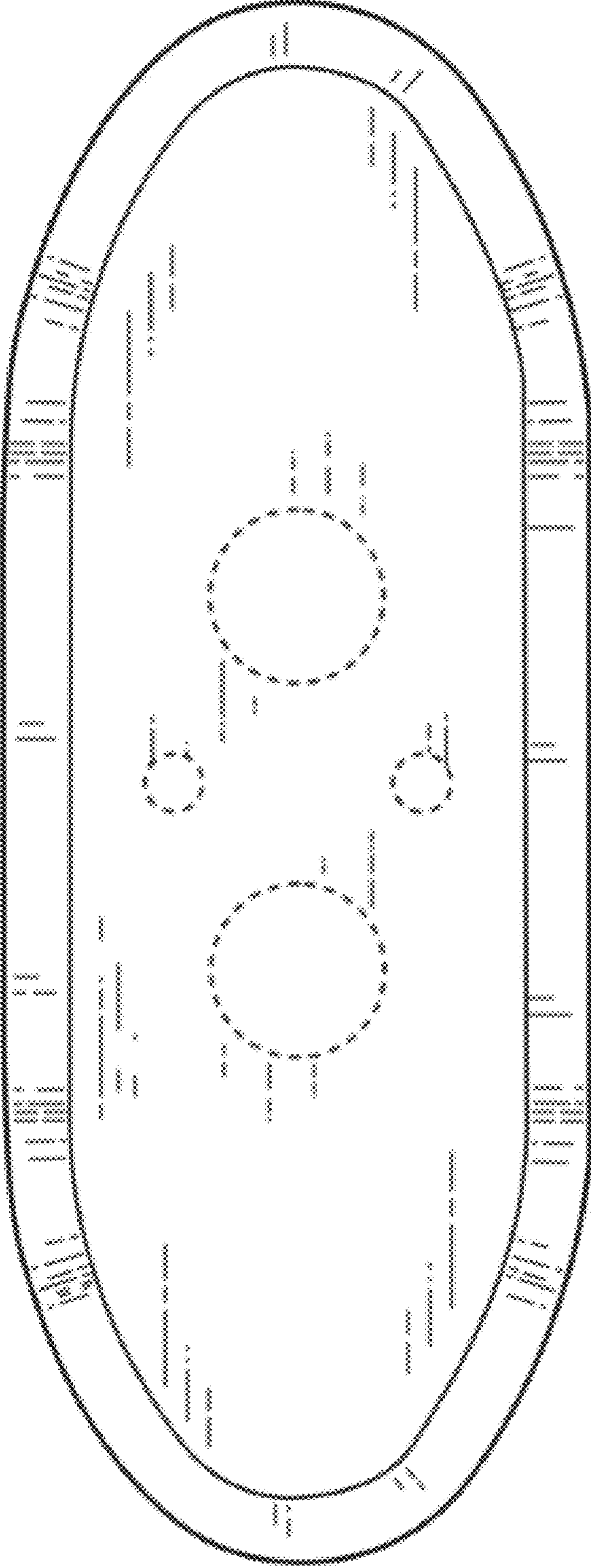

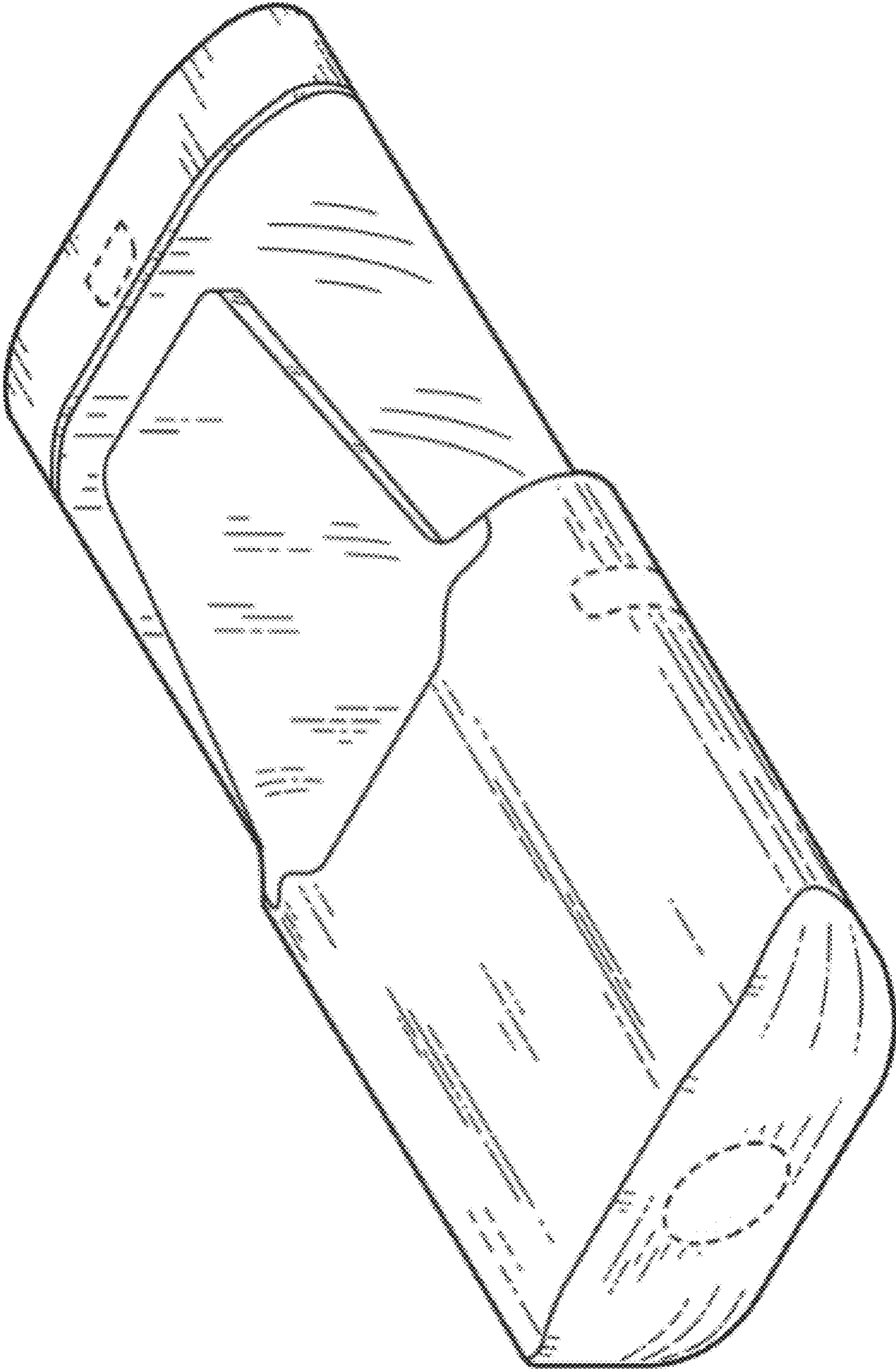
