FIG. 8 is a perspective view thereof, showing the corset belt in a state of use.

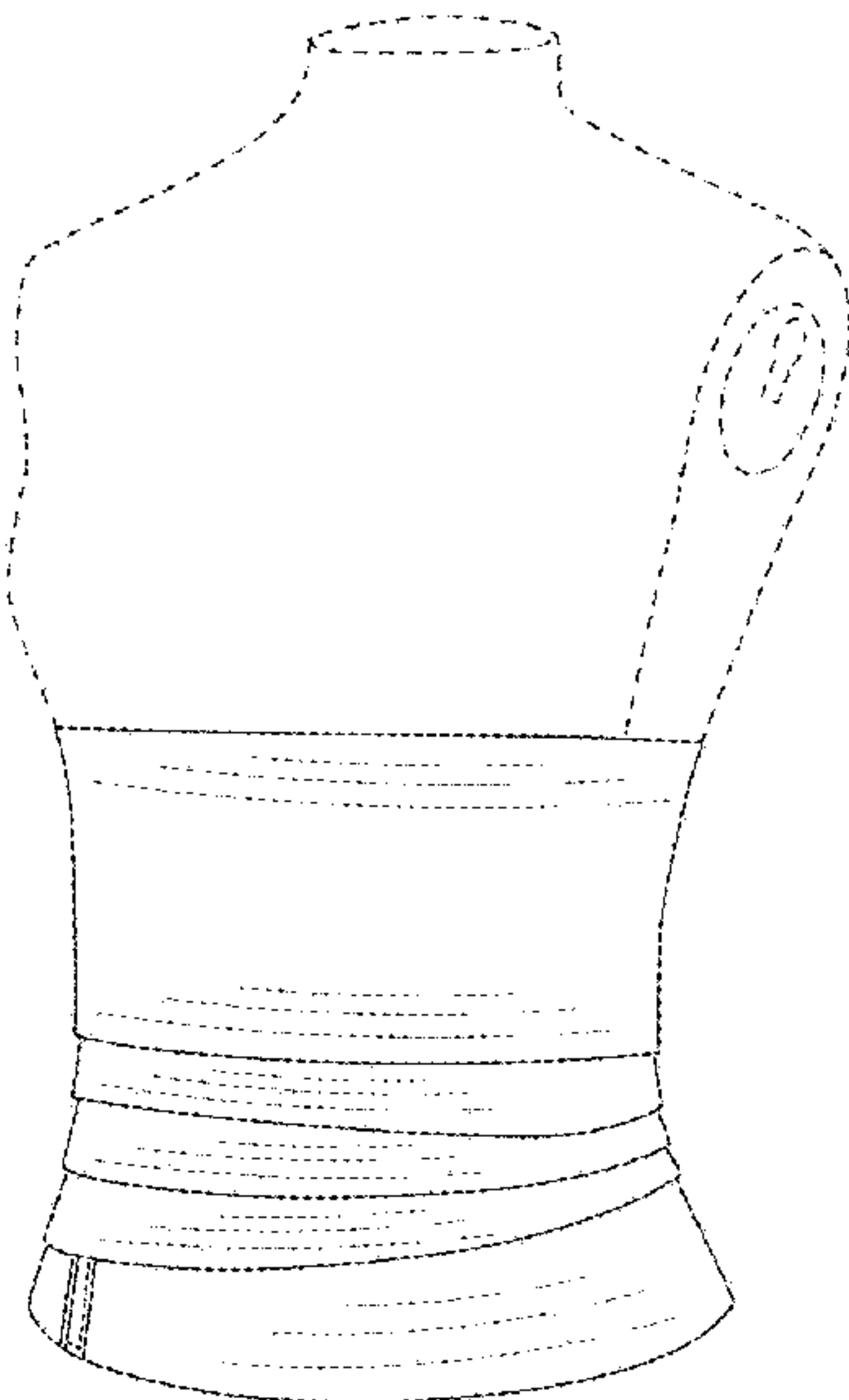
Any shading and cross-hatching are not features of the design but are utilized to illustrate the surface contours of the corset belt design in the drawings.

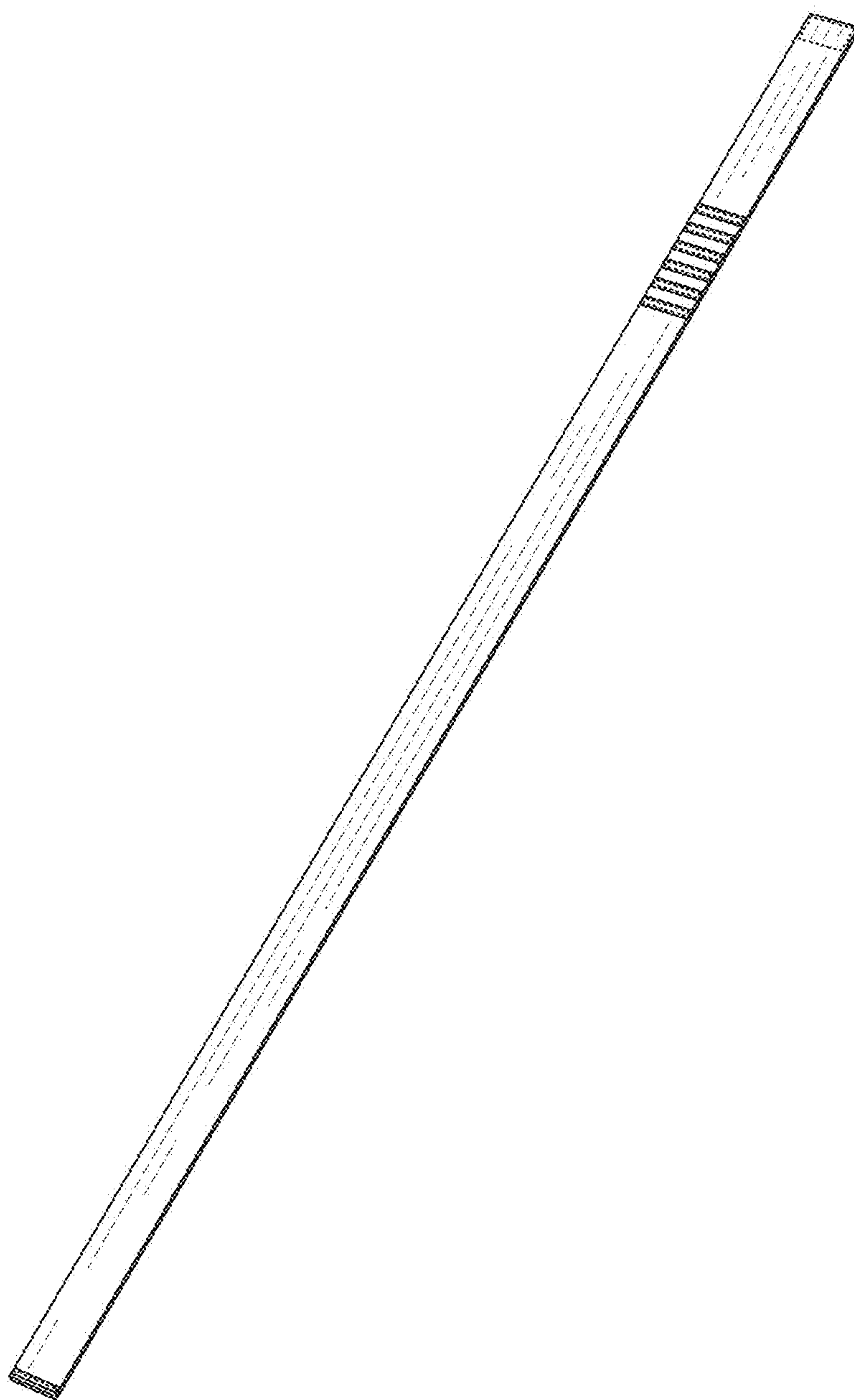

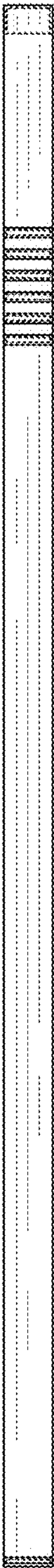

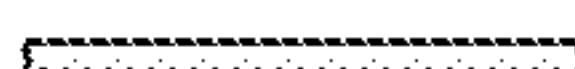

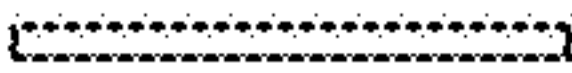

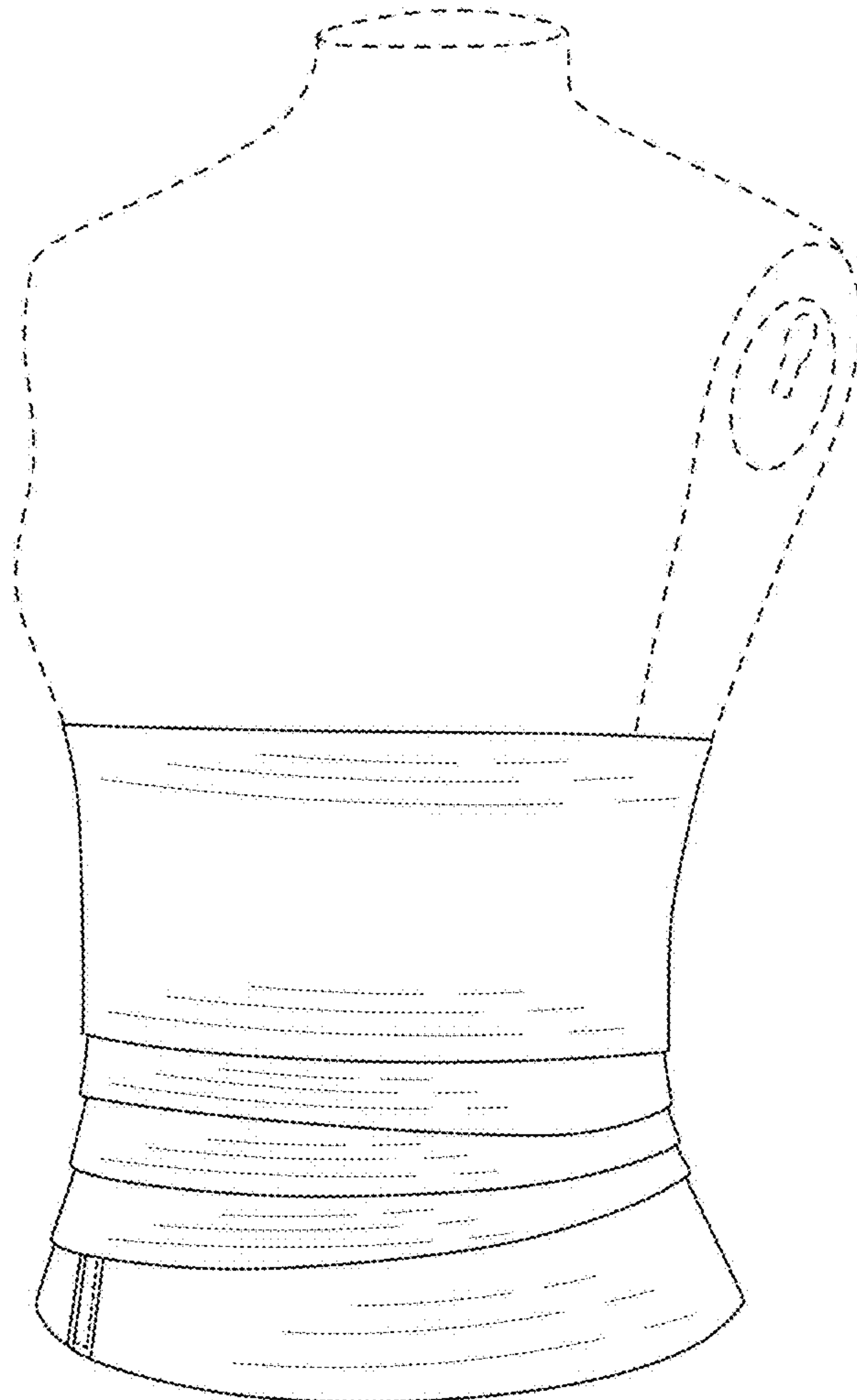
