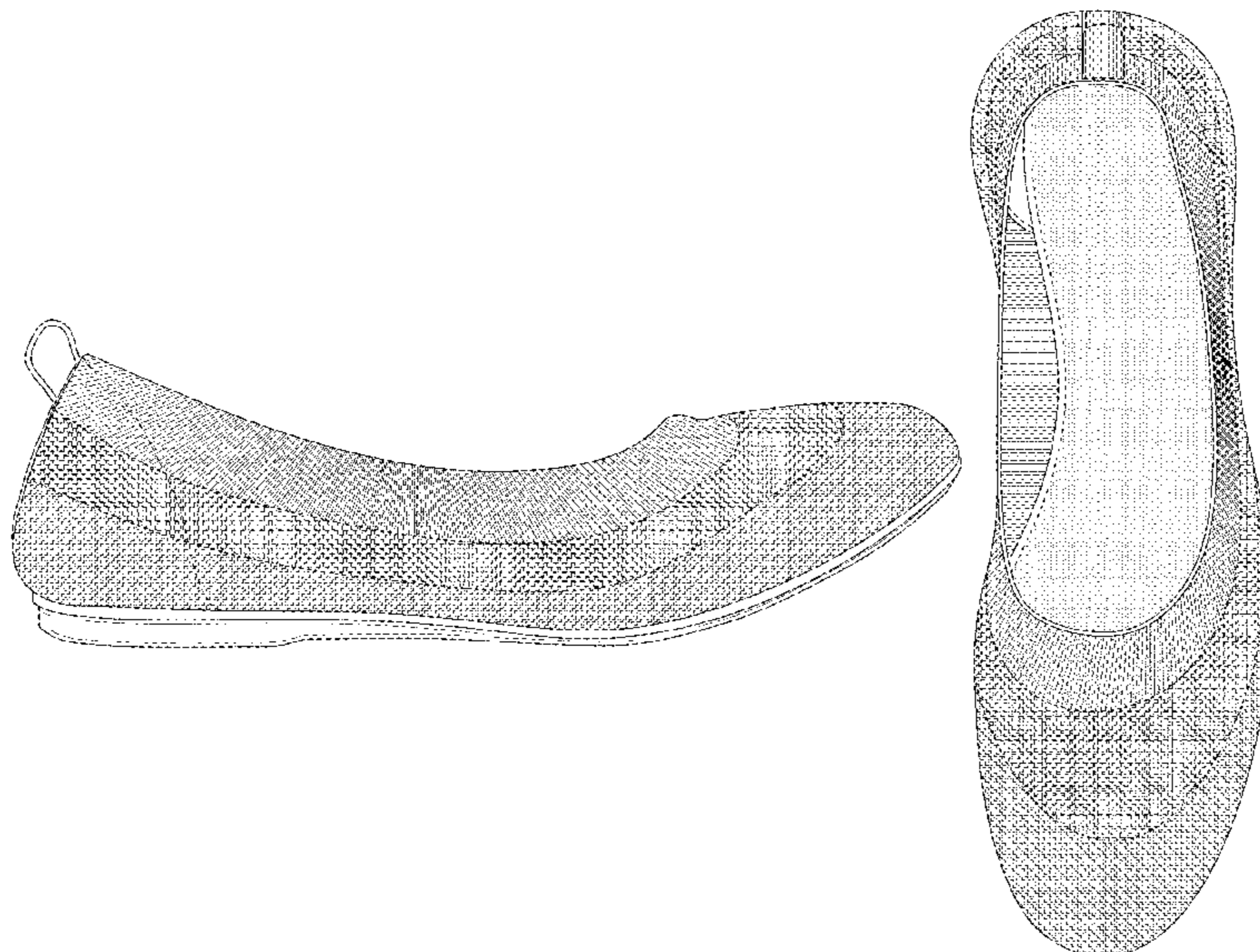
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe, showing my new design;
FIG. 2 is a front view thereof;

FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines crossing claimed surfaces depict portions of a shoe and form no part of the claim. The patterned surfaces encircled by broken lines on the outsole of the shoe form no part of the claim.

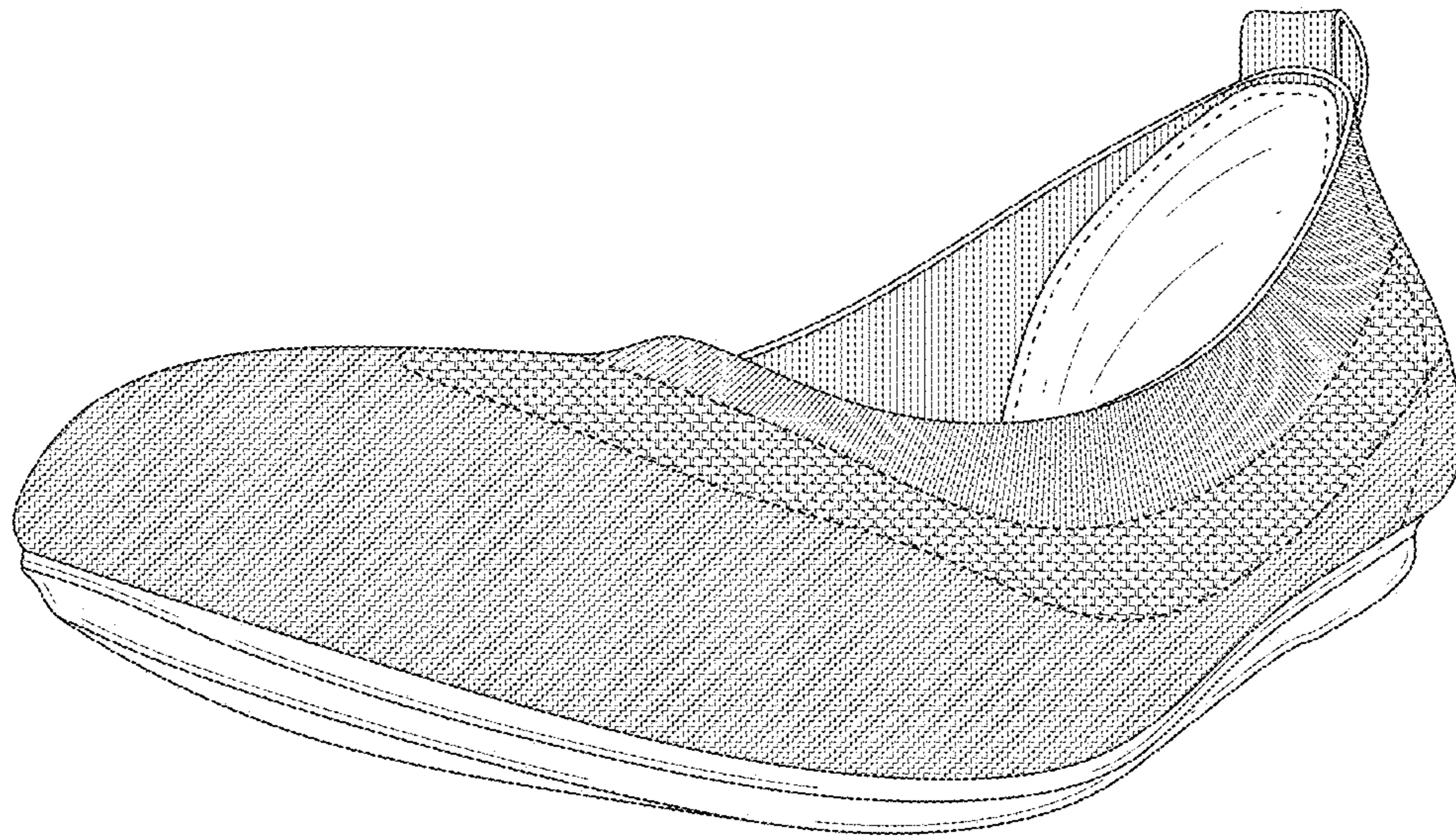

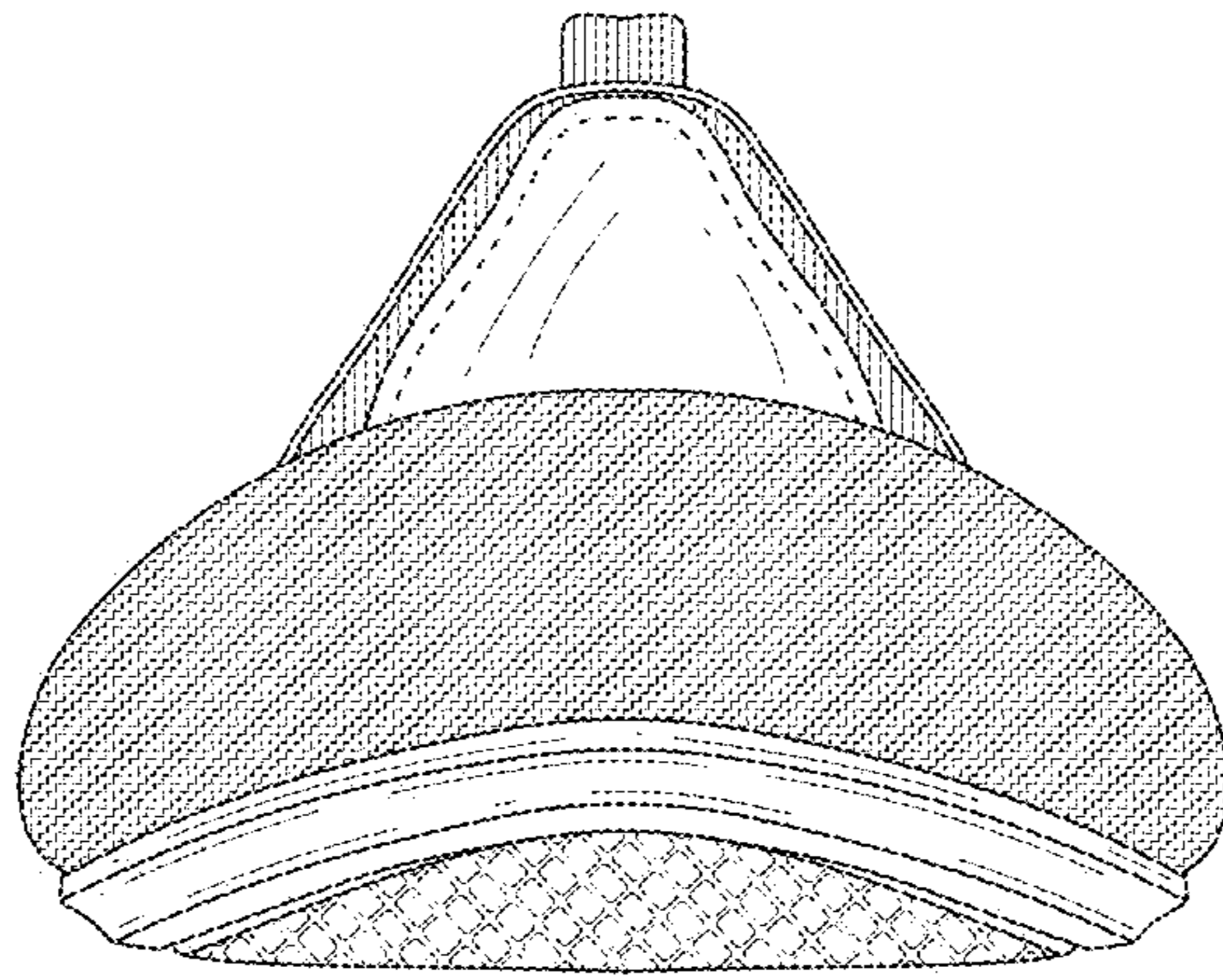

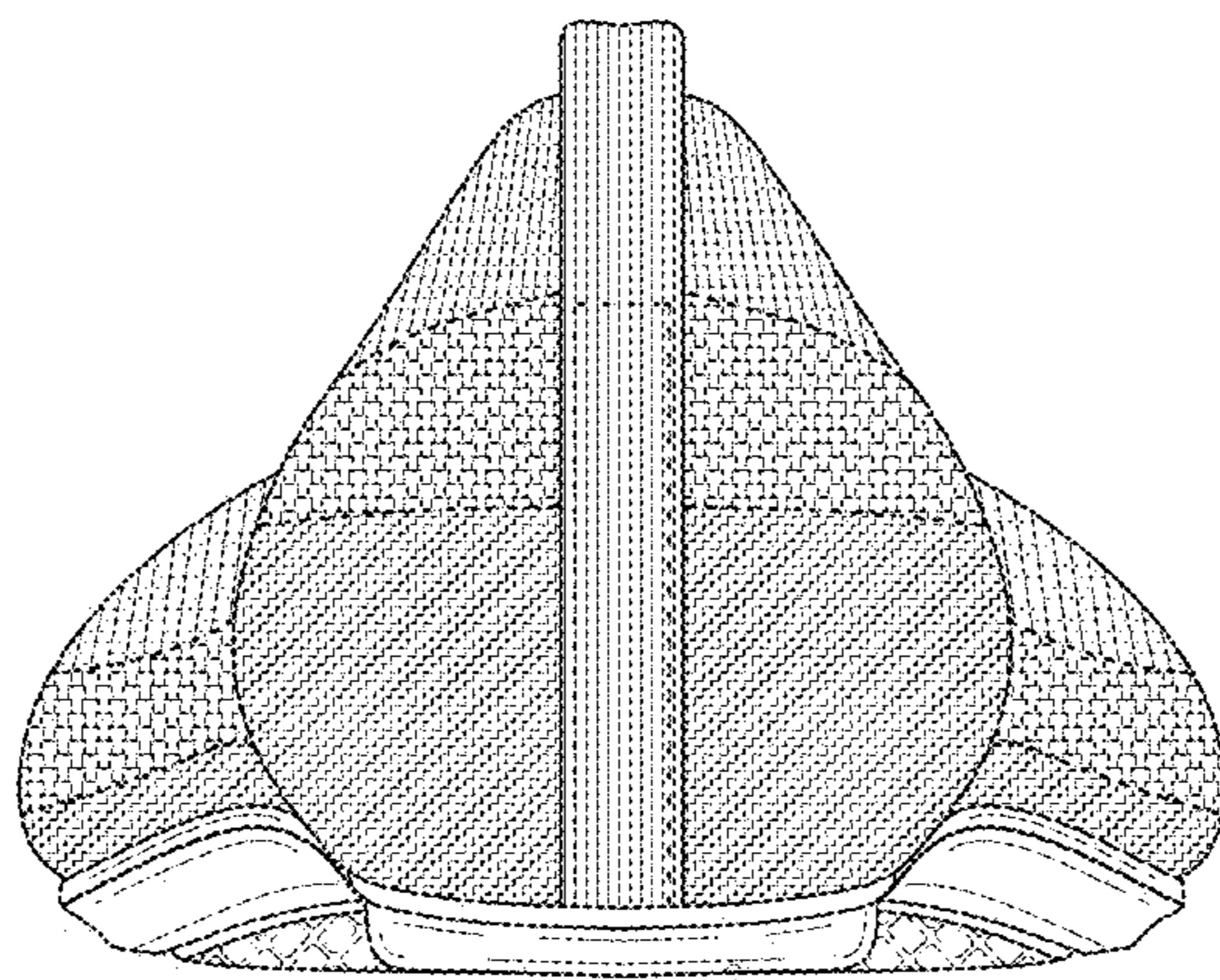

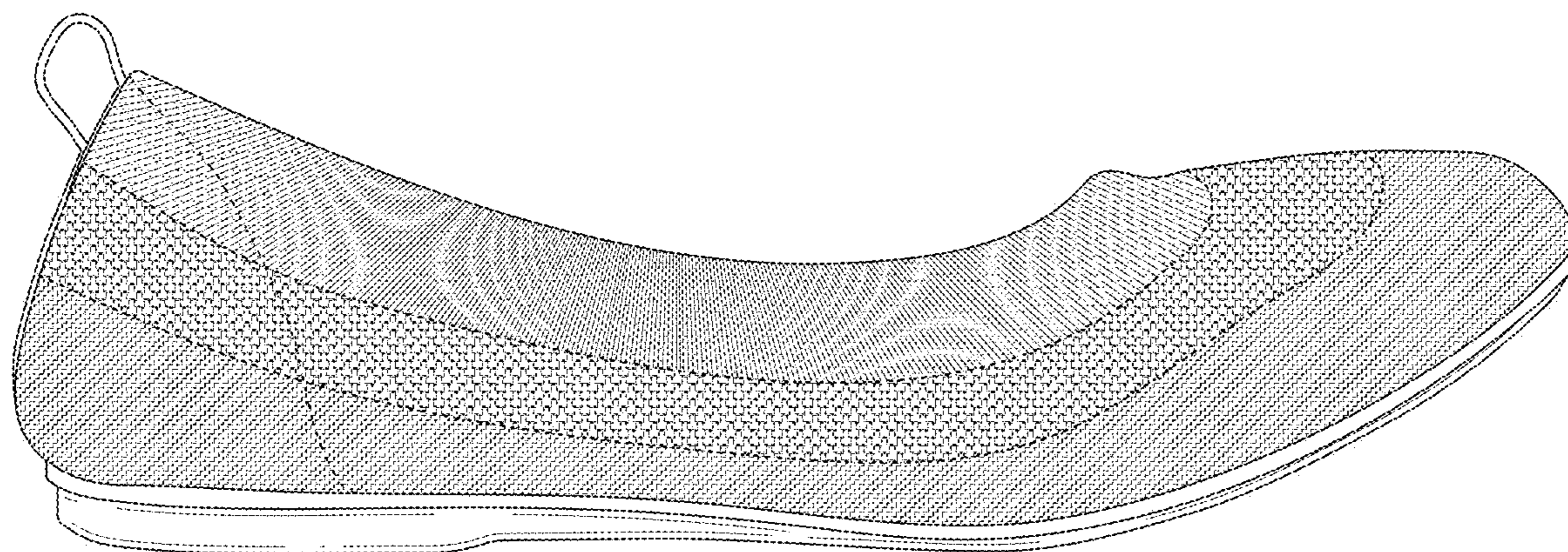

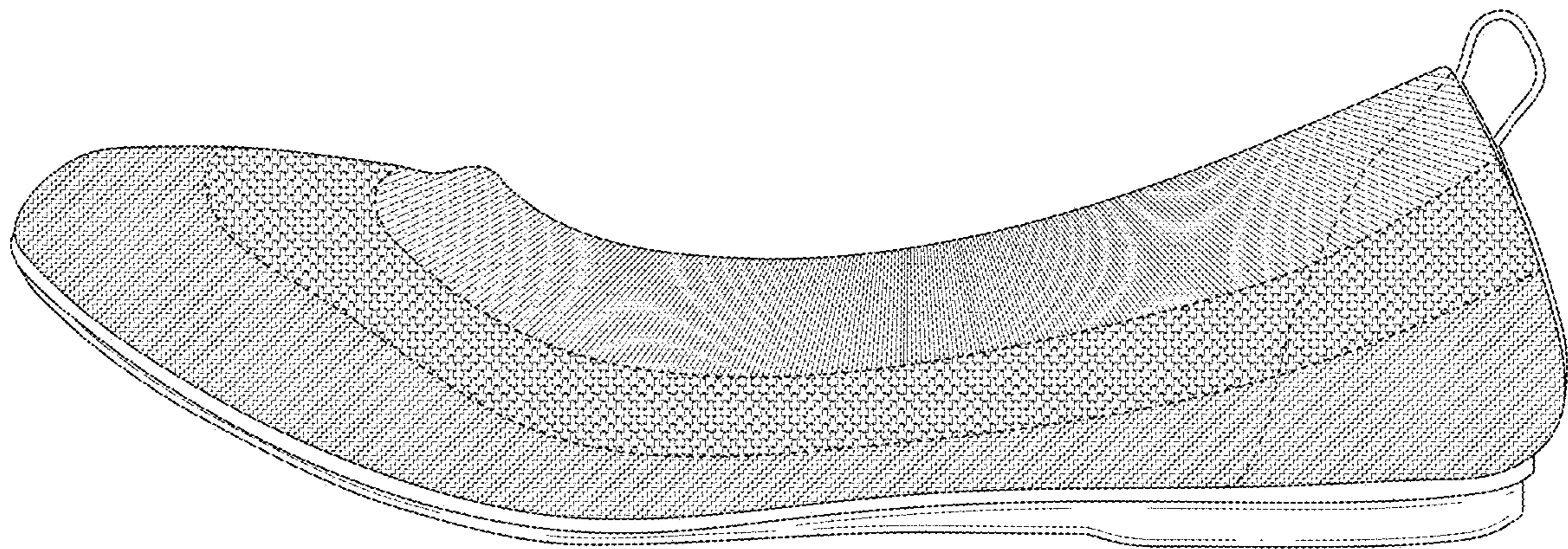

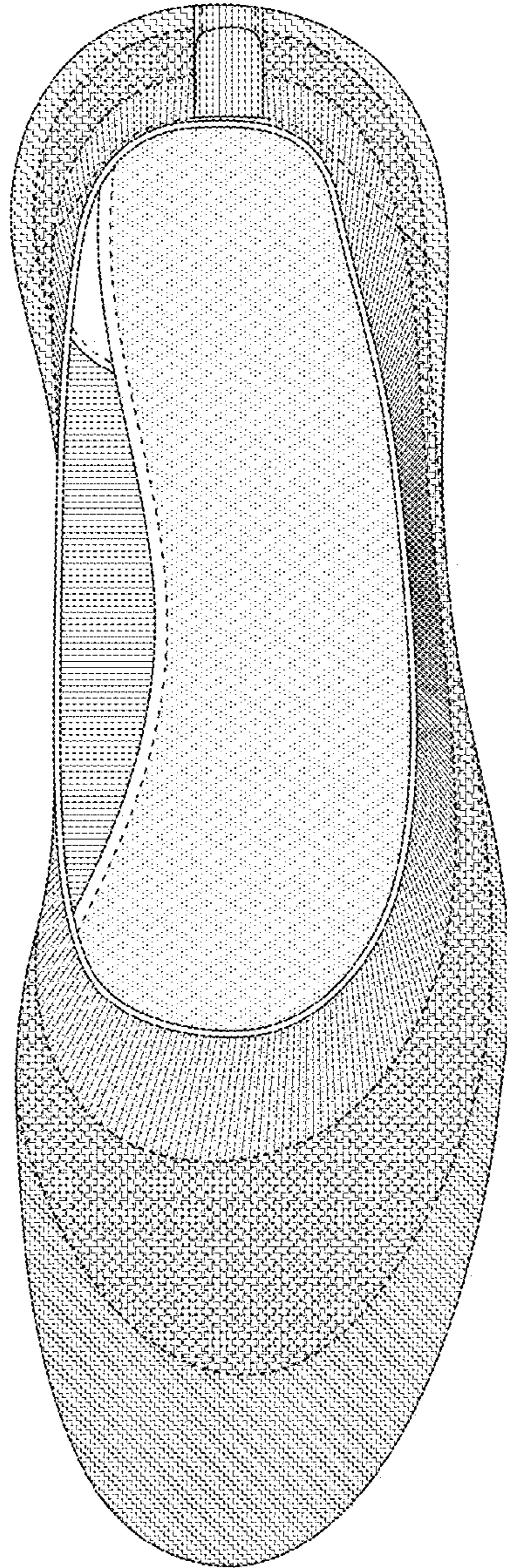

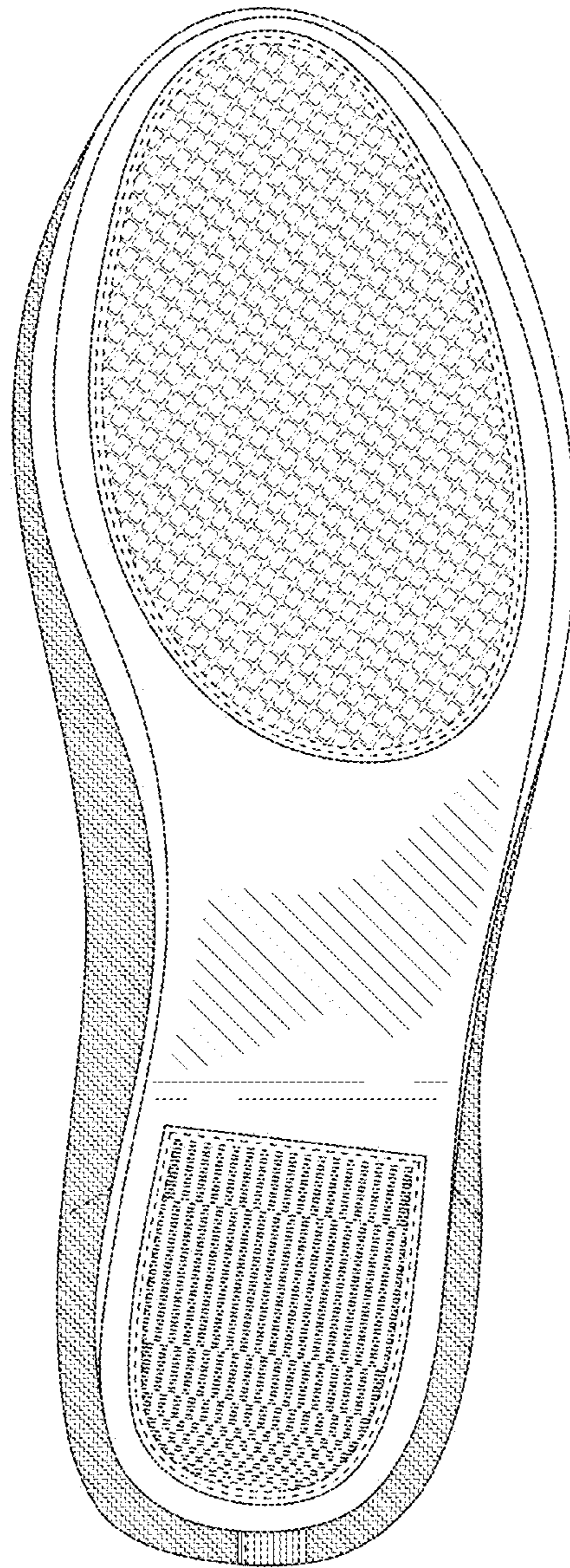
