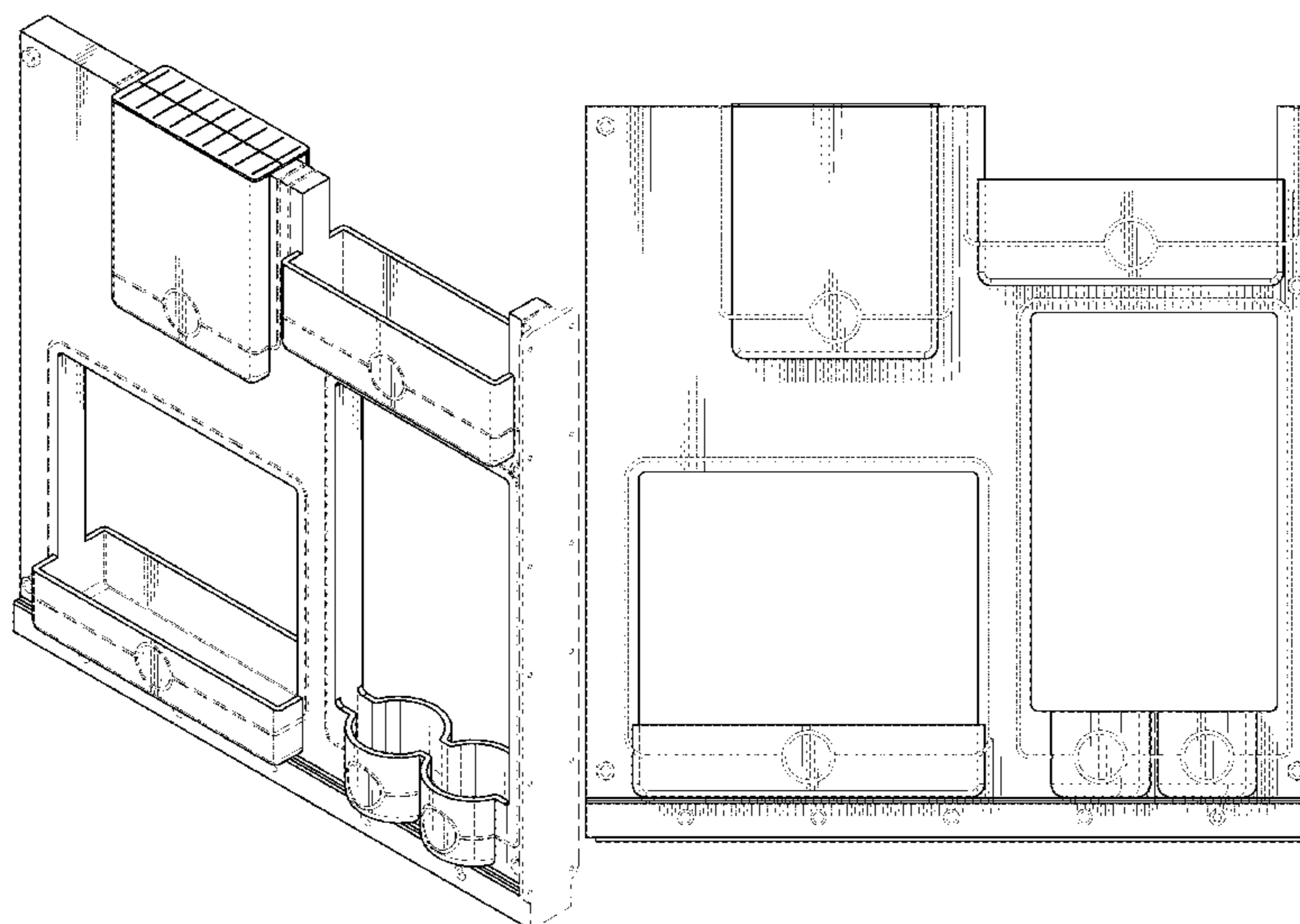
The ornamental design for a health and safety unit, as shown and described.

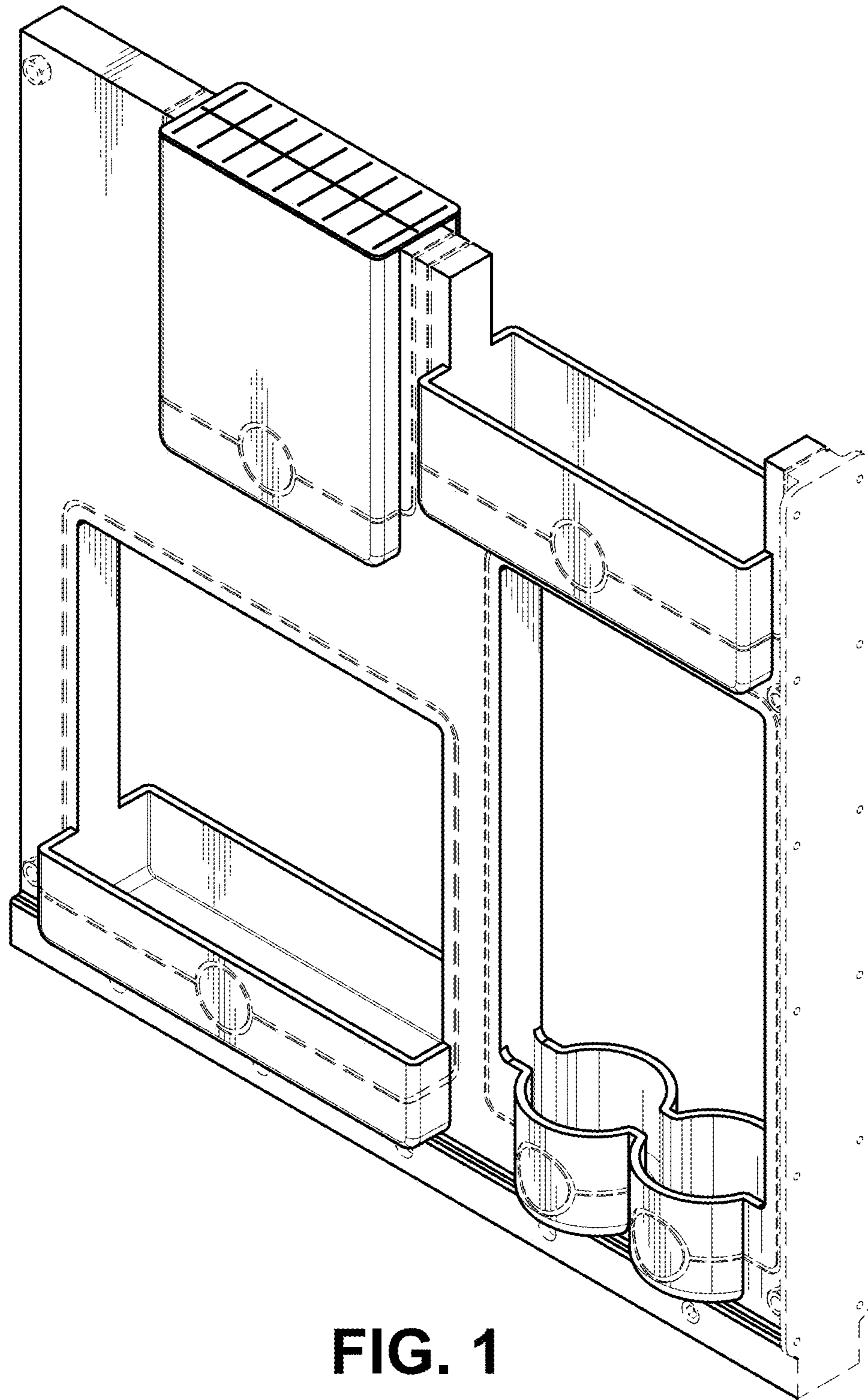

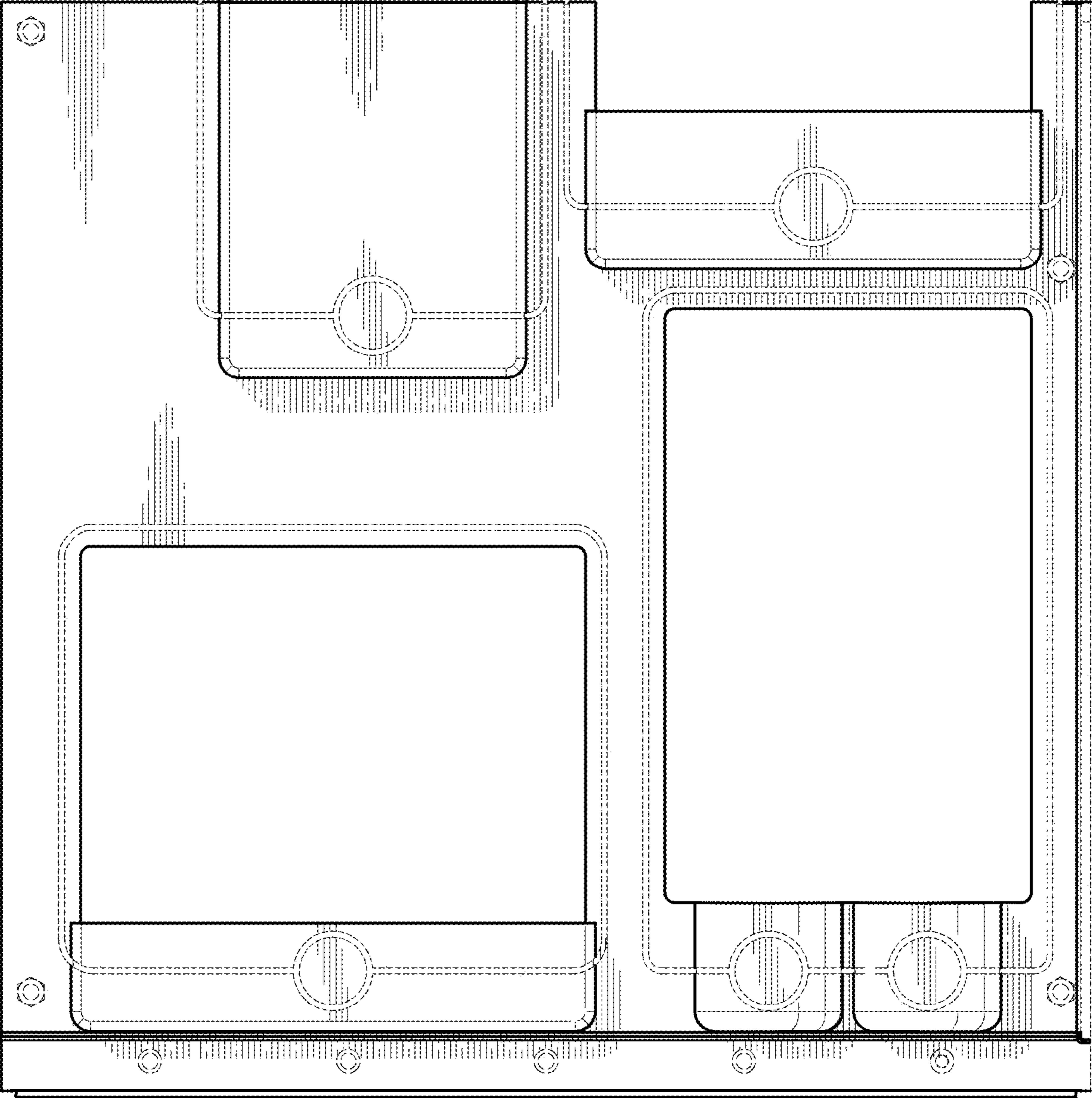

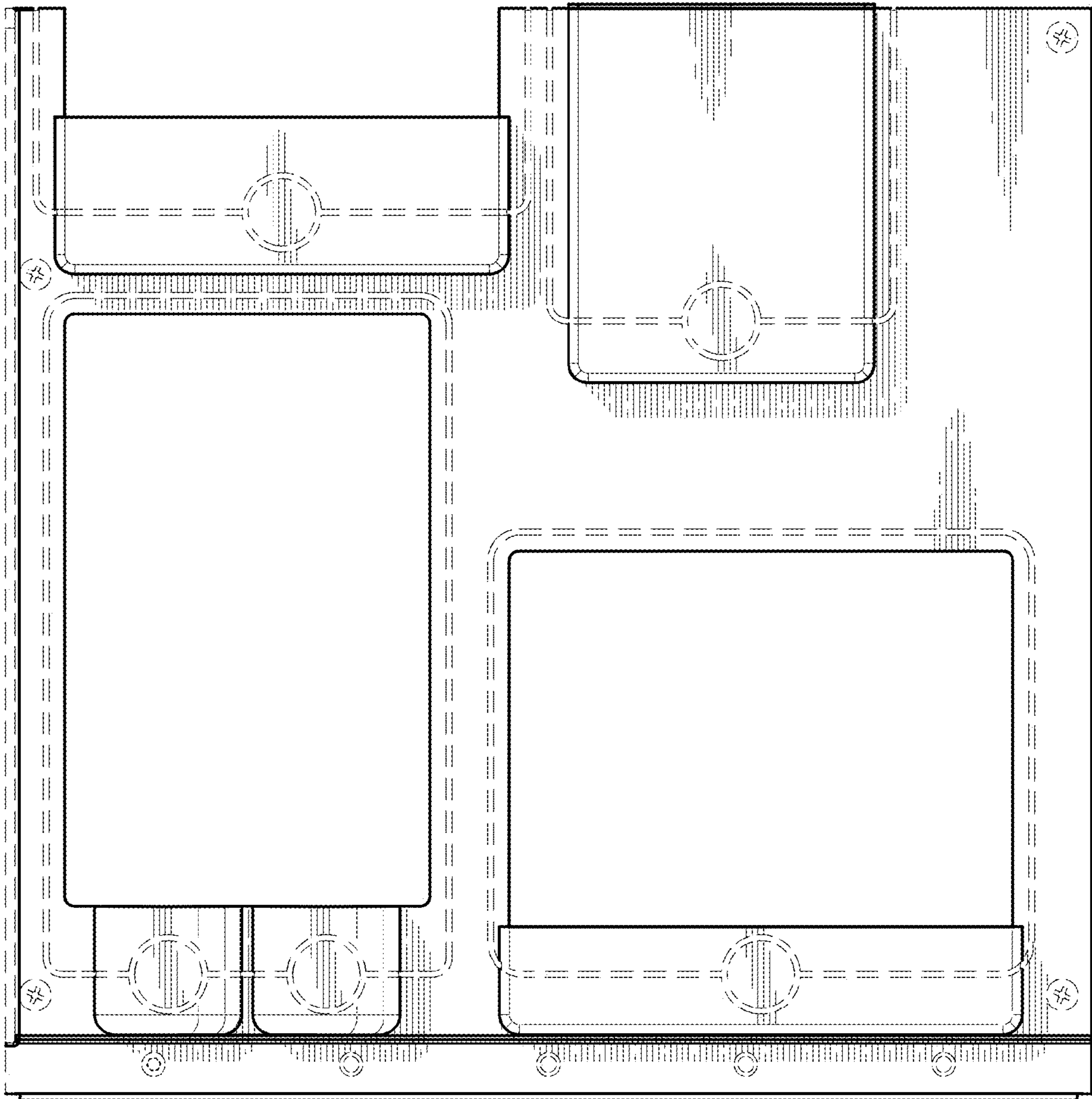

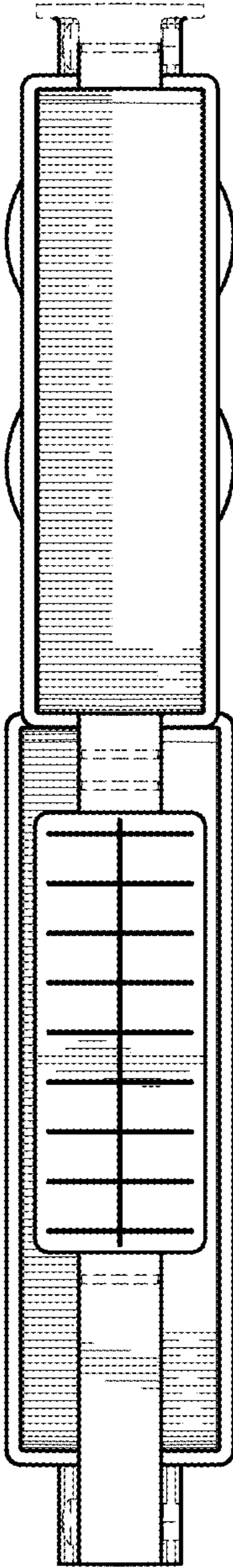

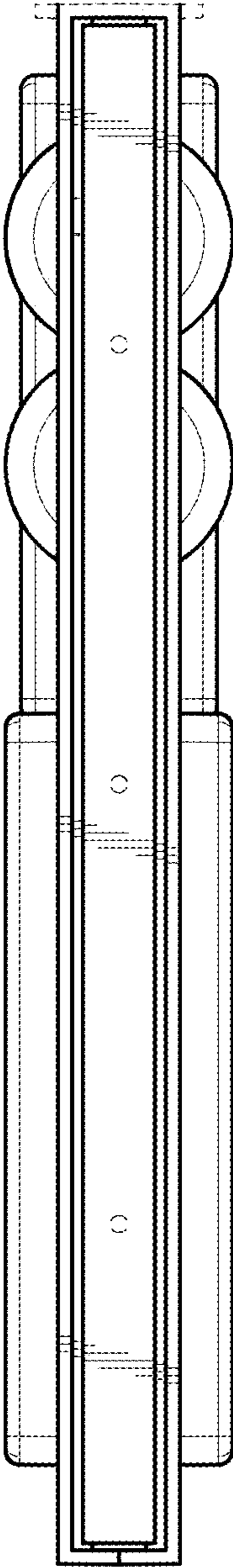

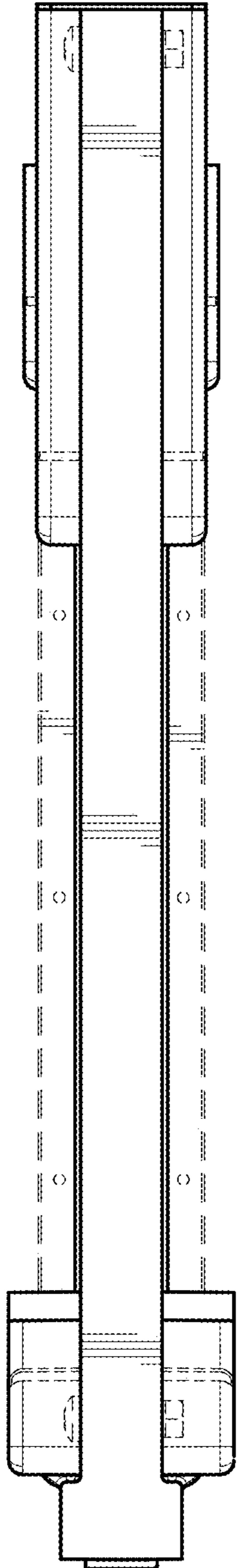

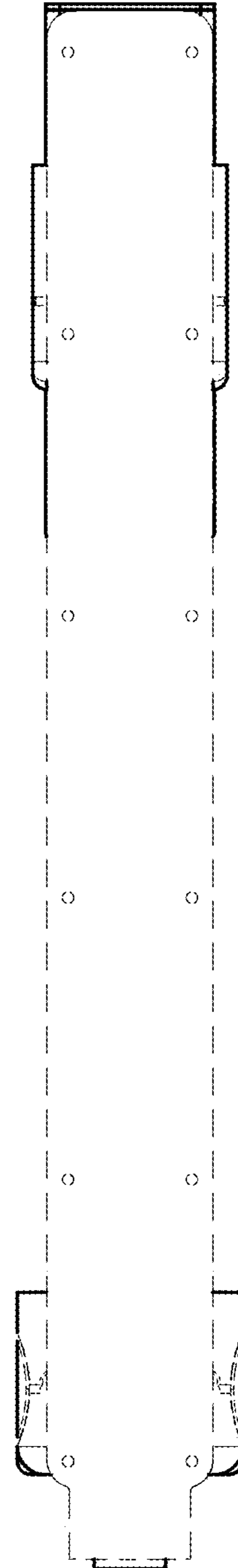
