(57) CLAIM

The ornamental design for a twist-up snack dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front-top perspective view of a twist-up snack dispenser in a closed configuration according to my new design;

FIG. 12 is a right-side view thereof;

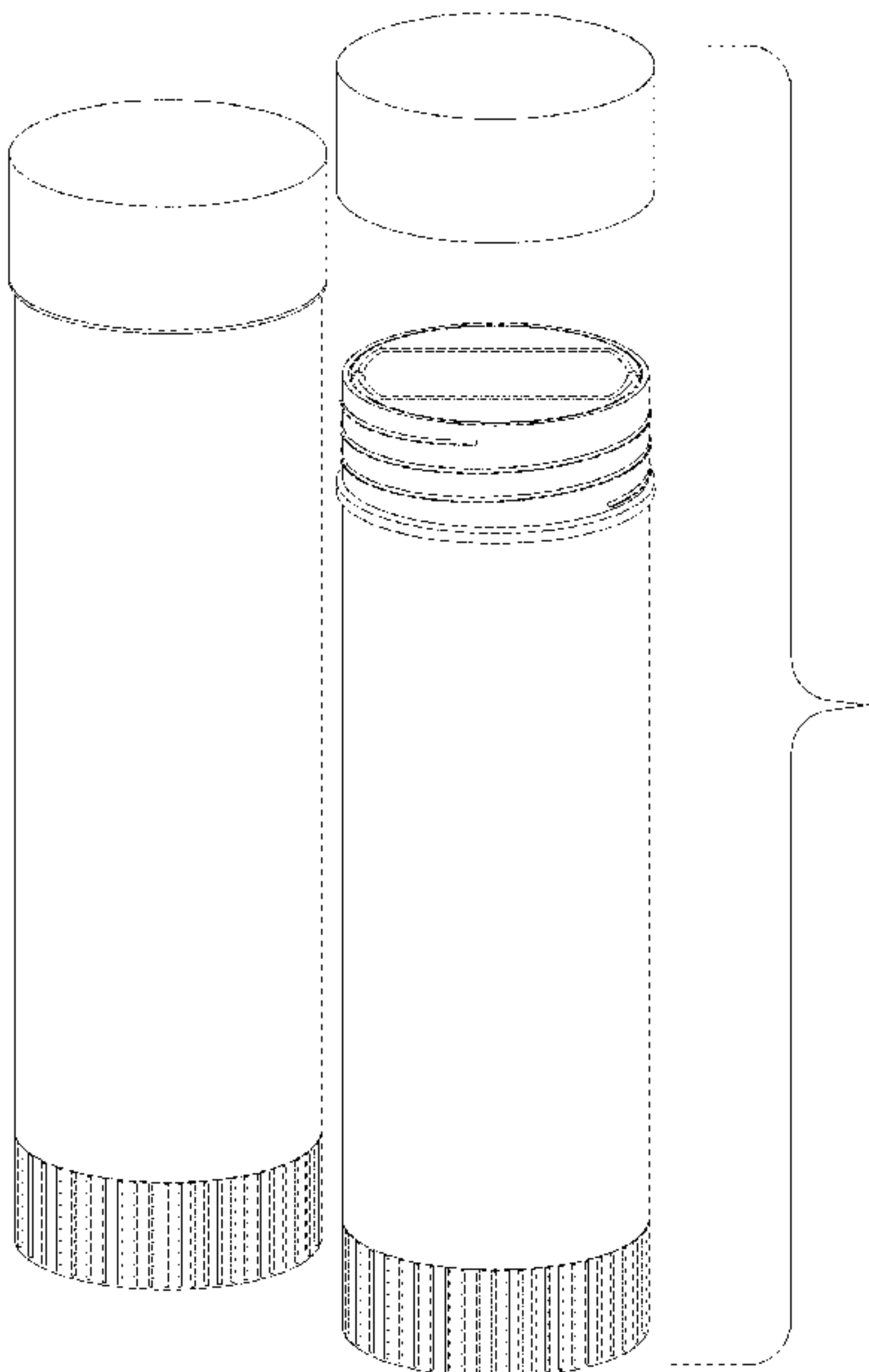
FIG. 13 is a left-side view thereof;

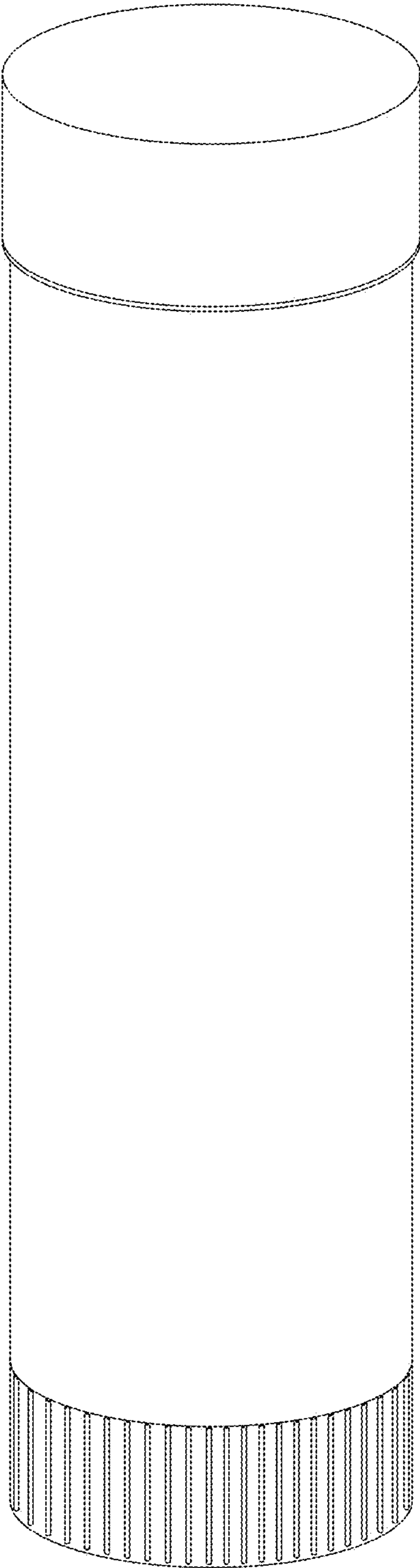

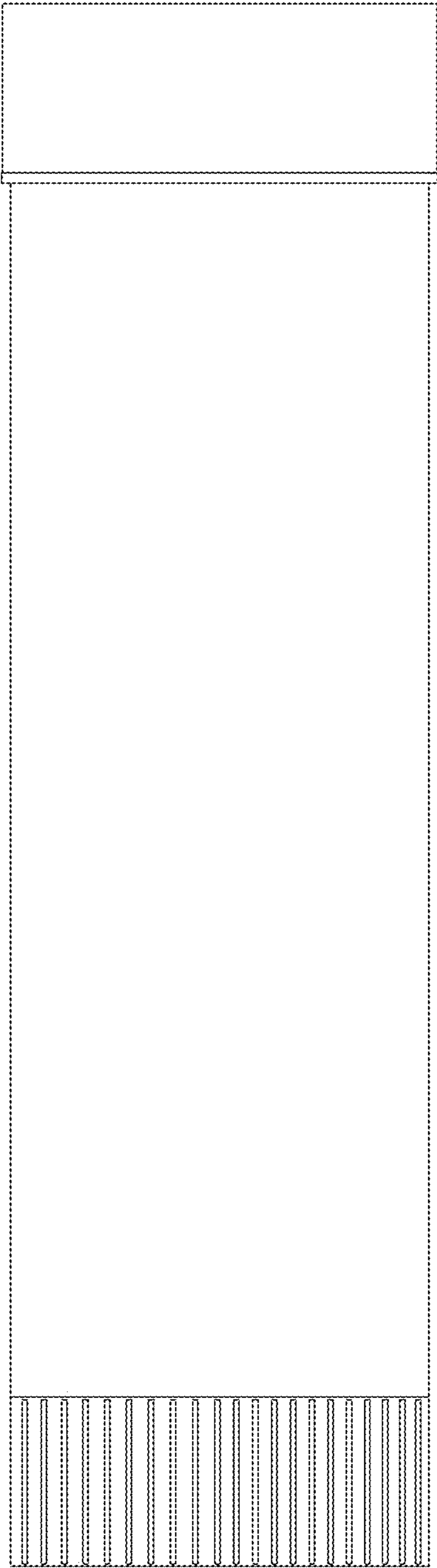

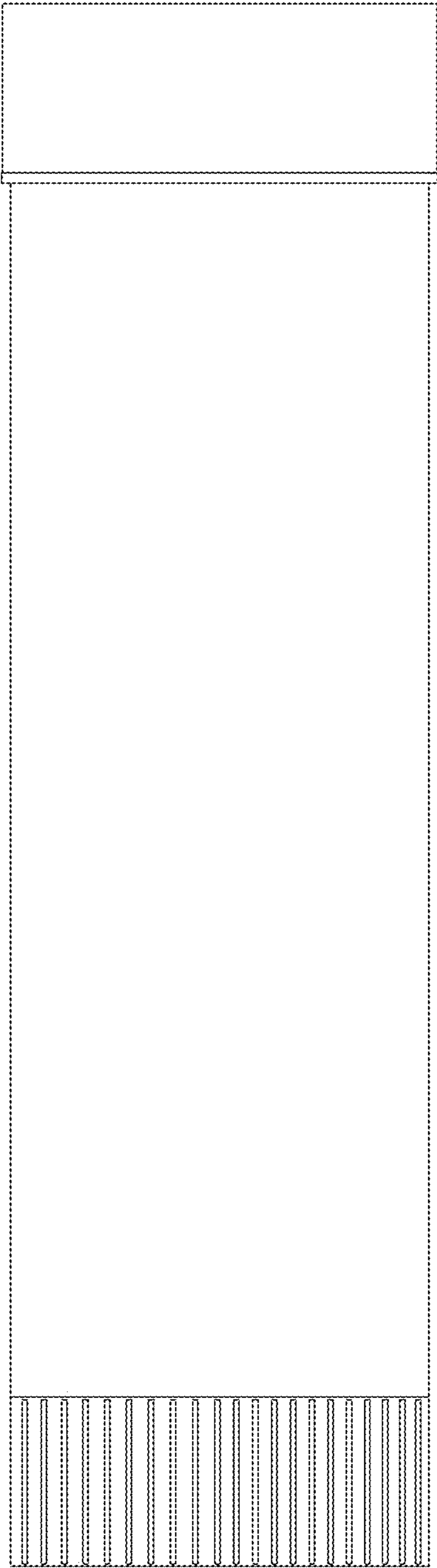

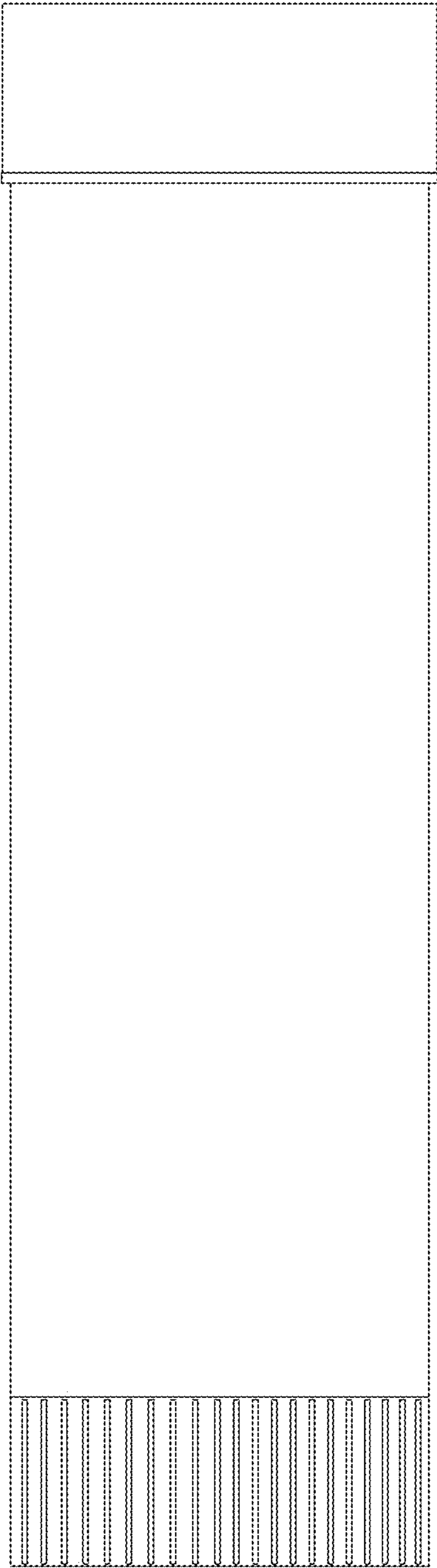

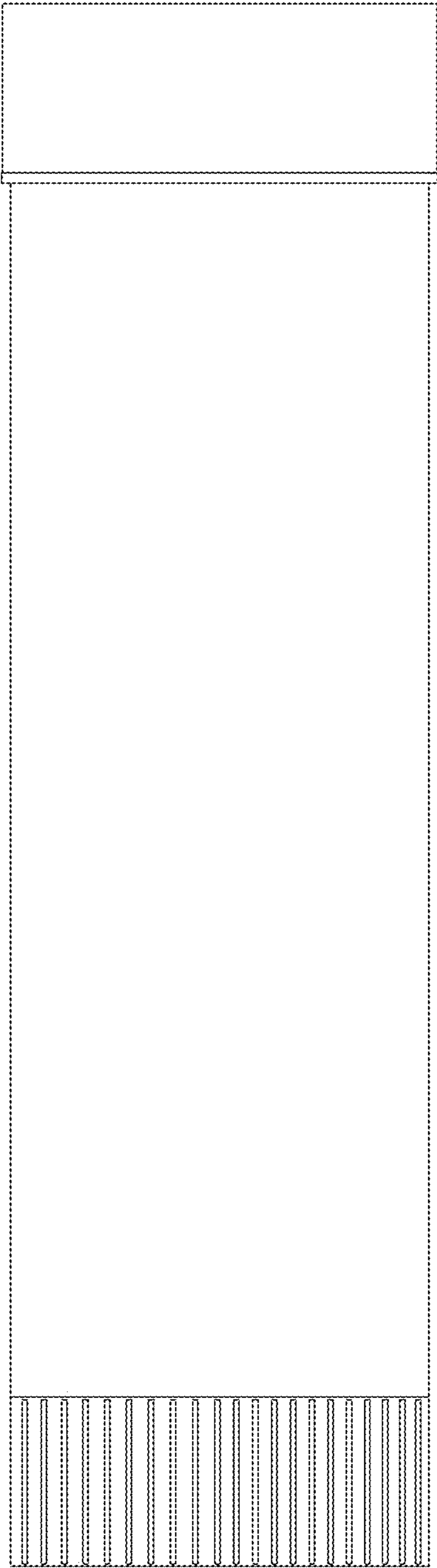

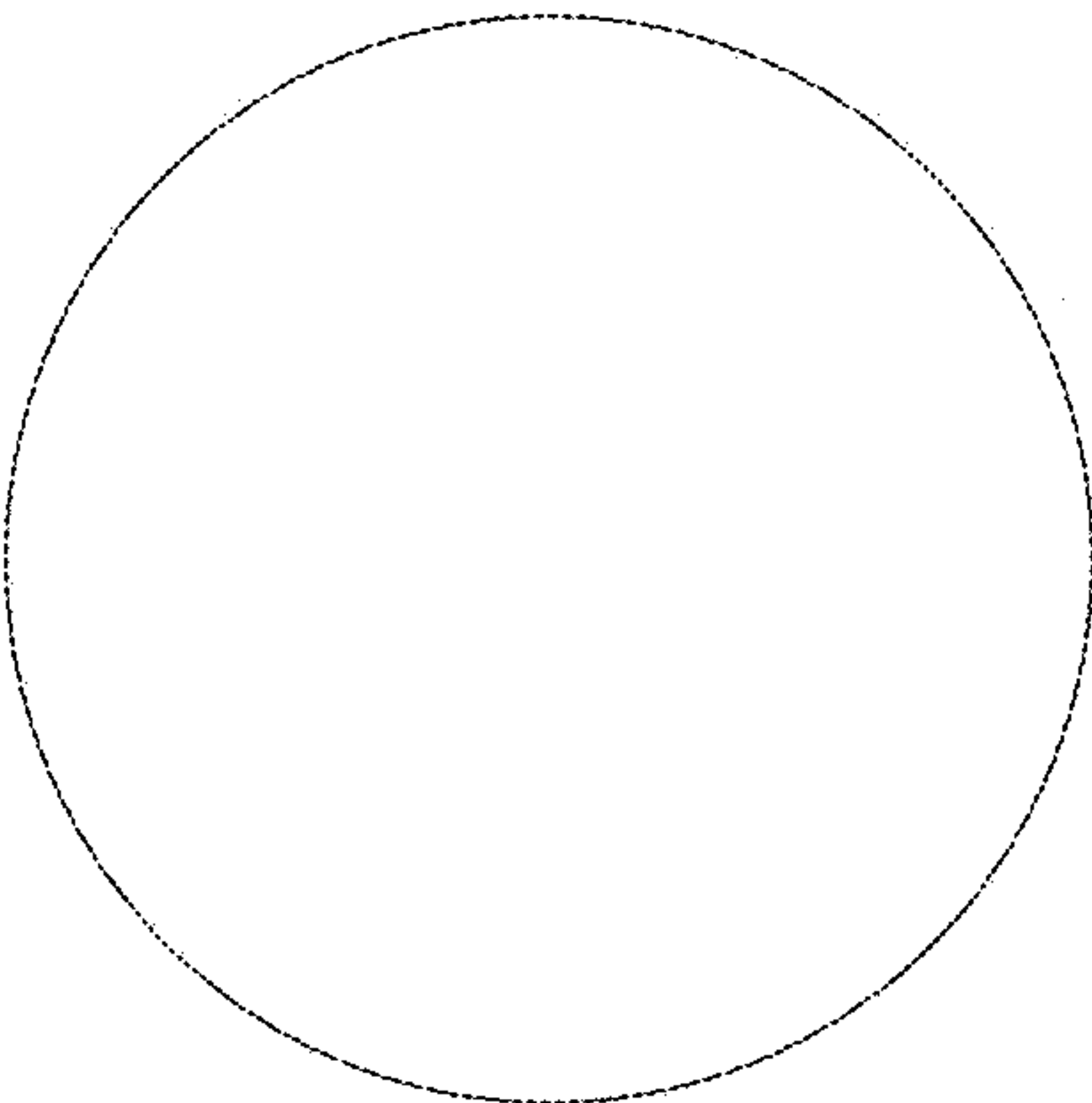

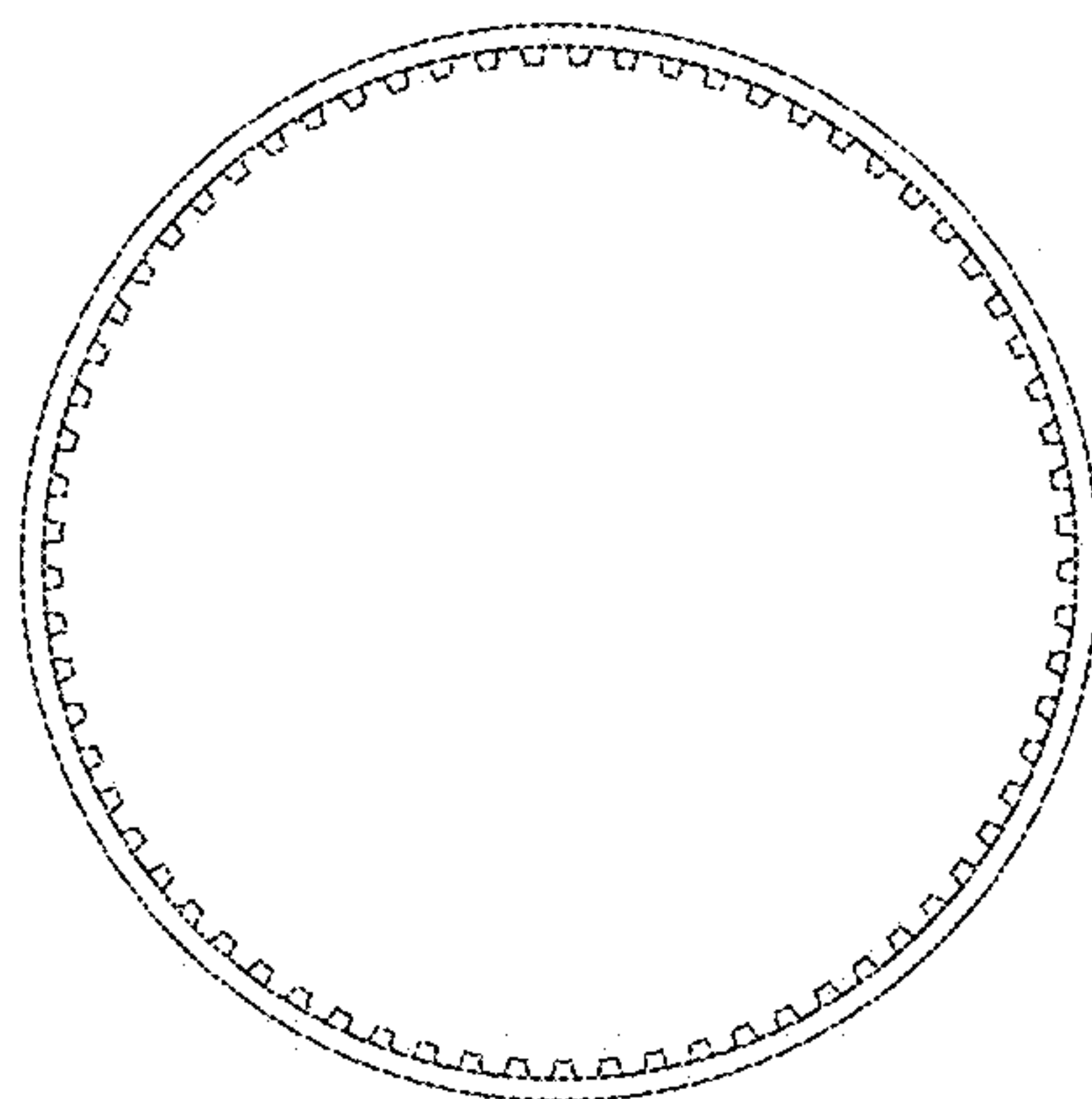

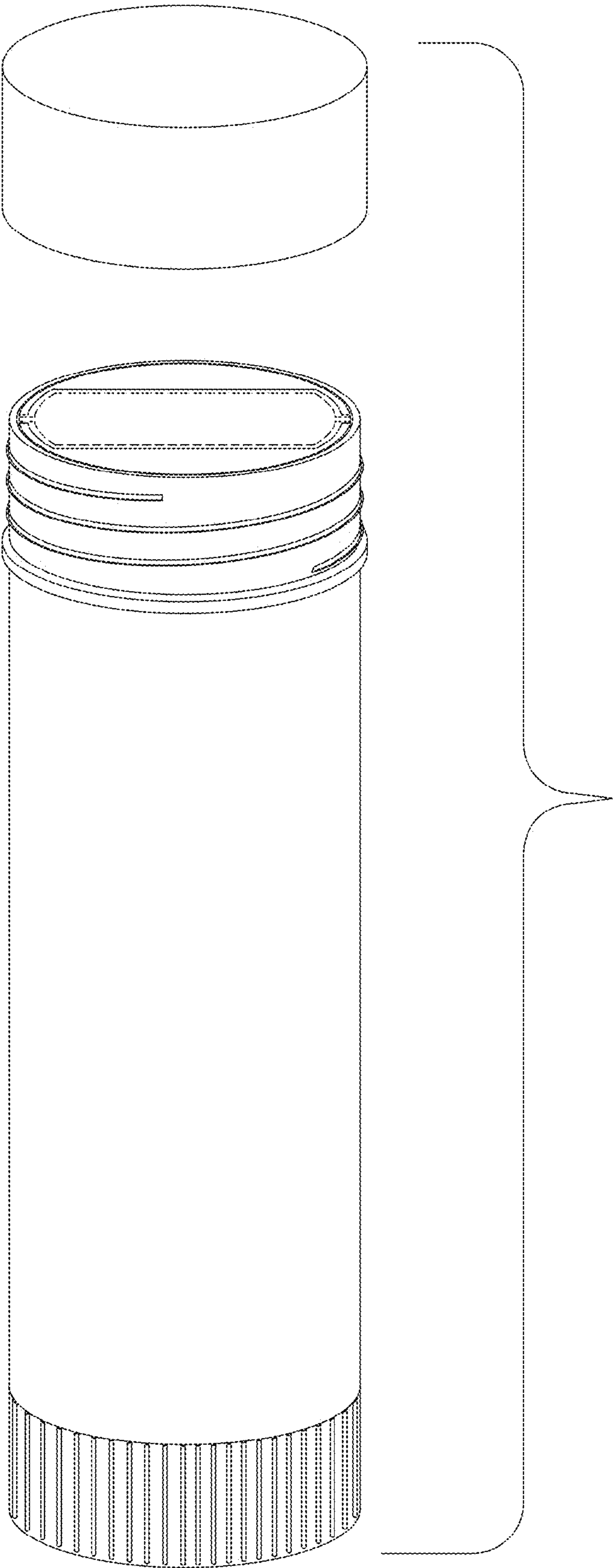

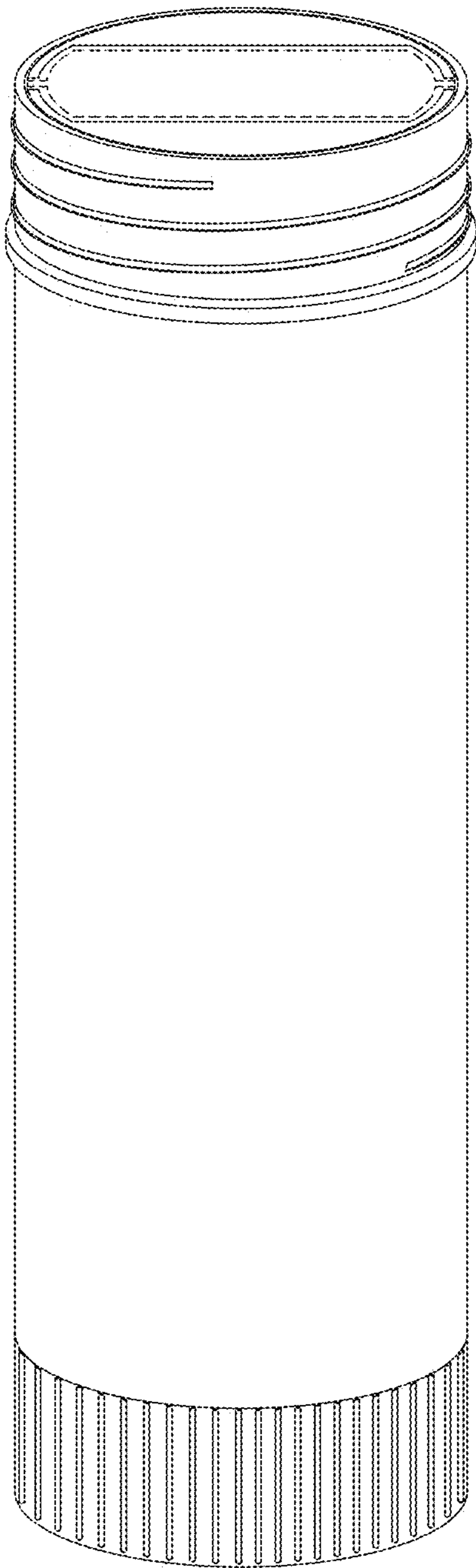

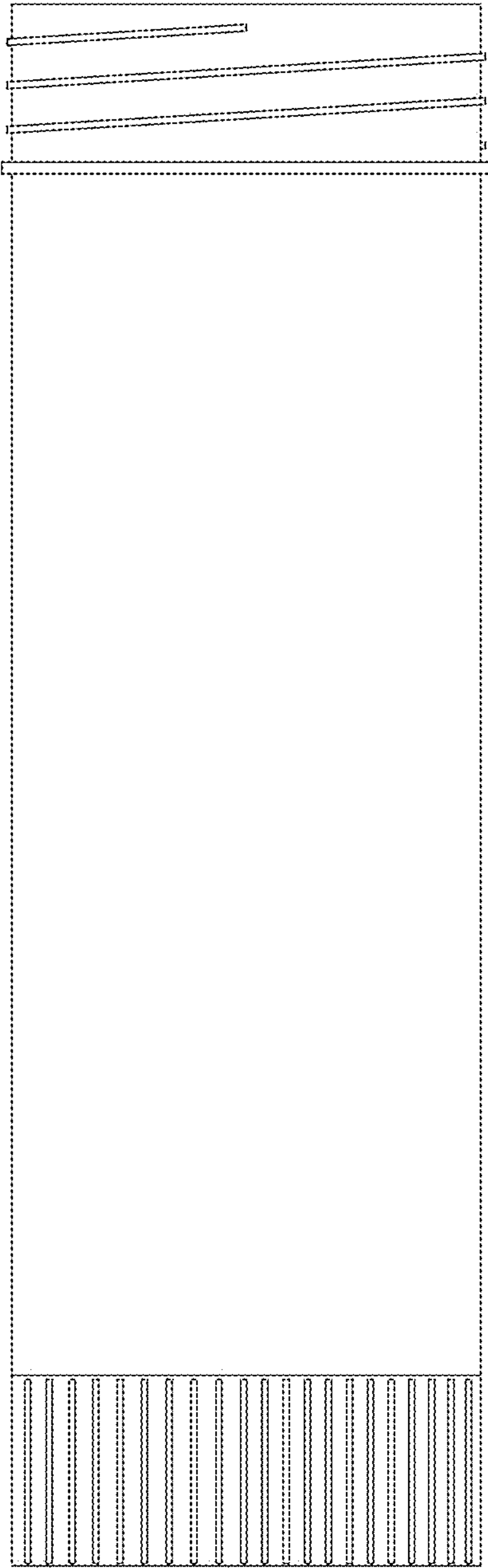

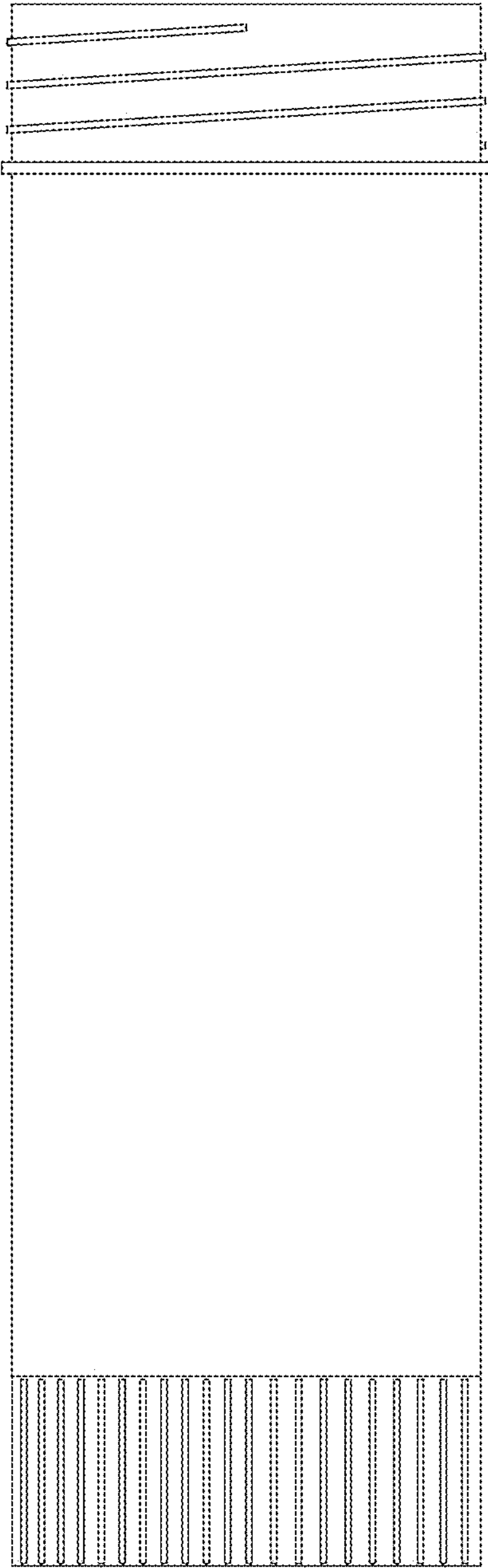

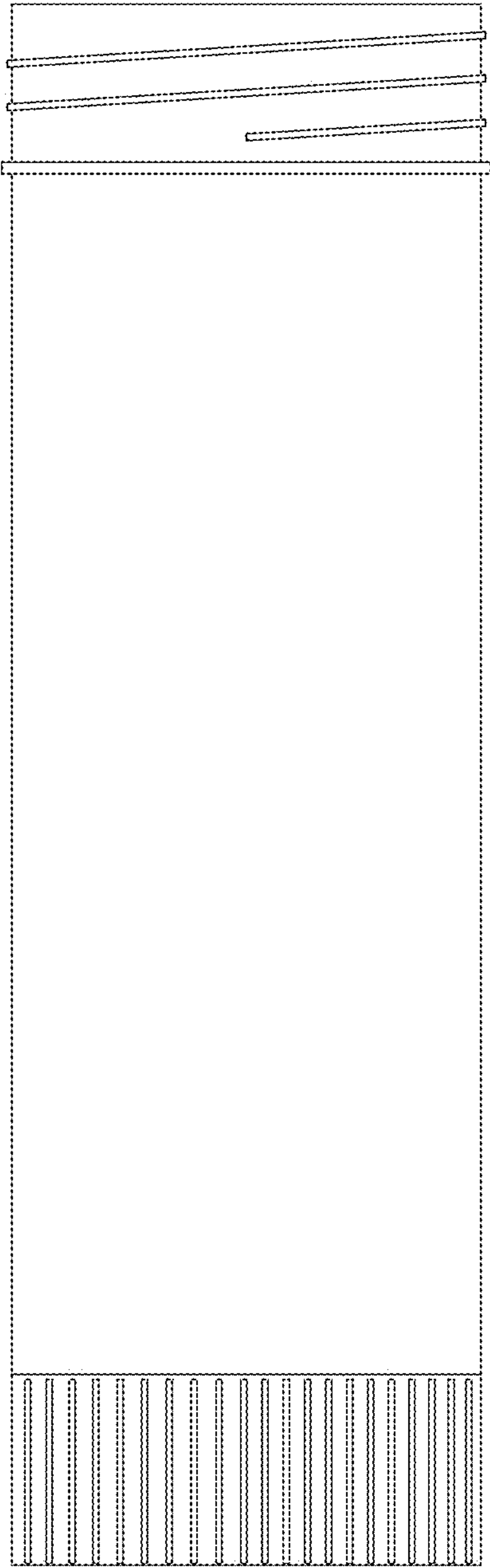

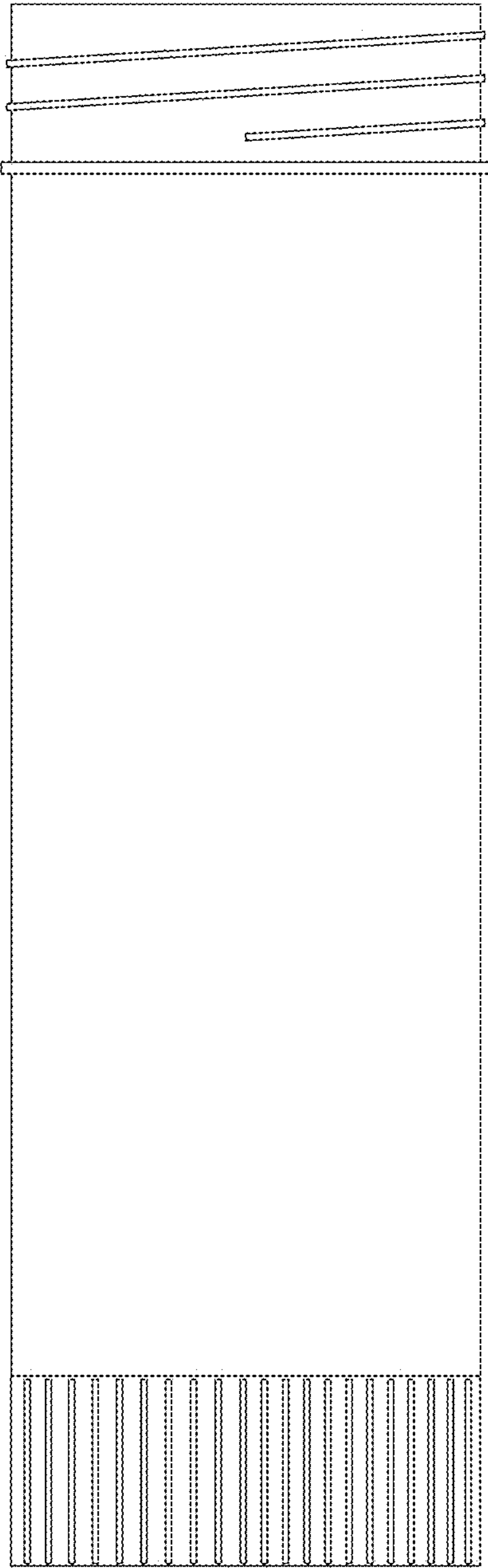

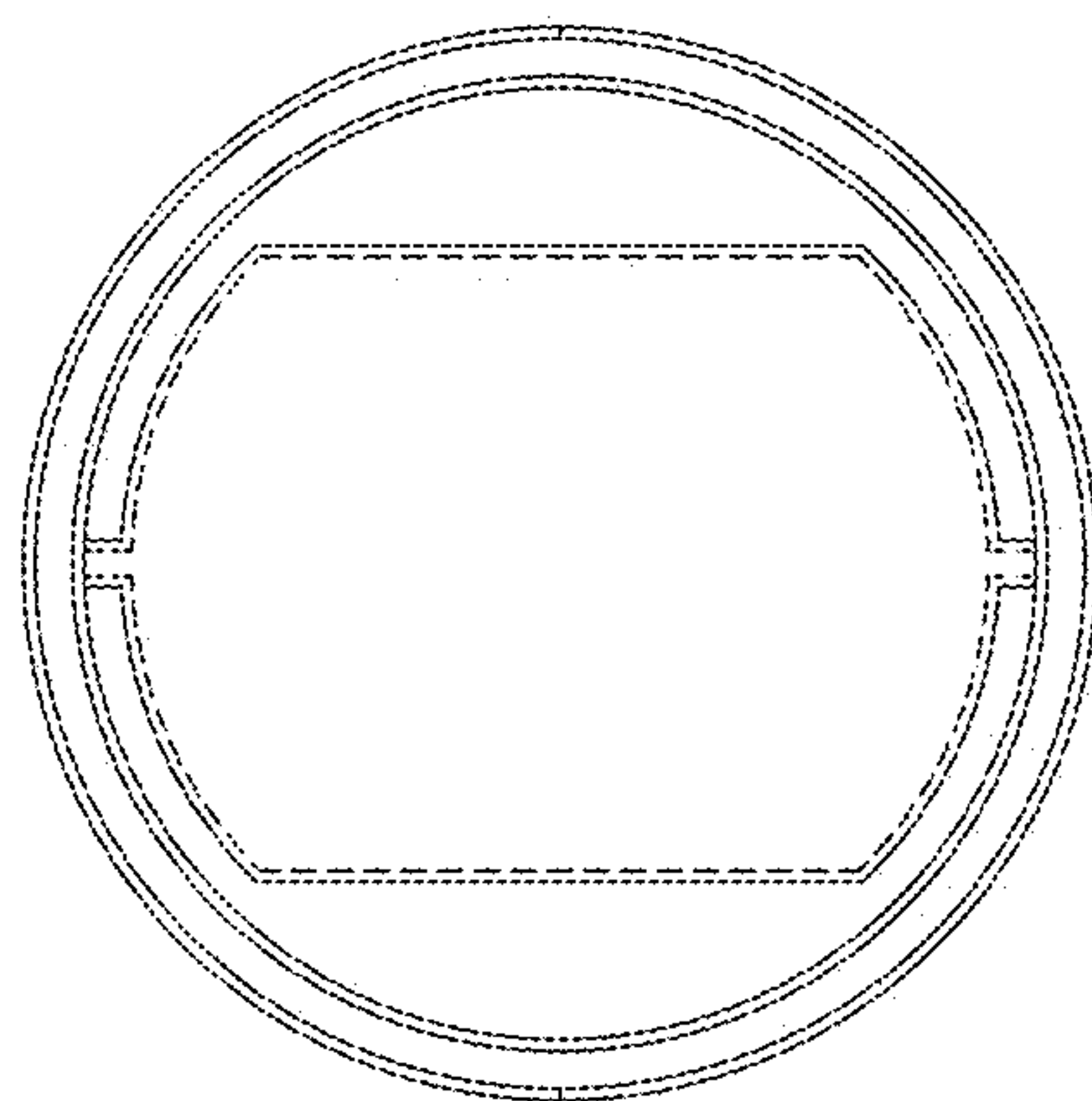

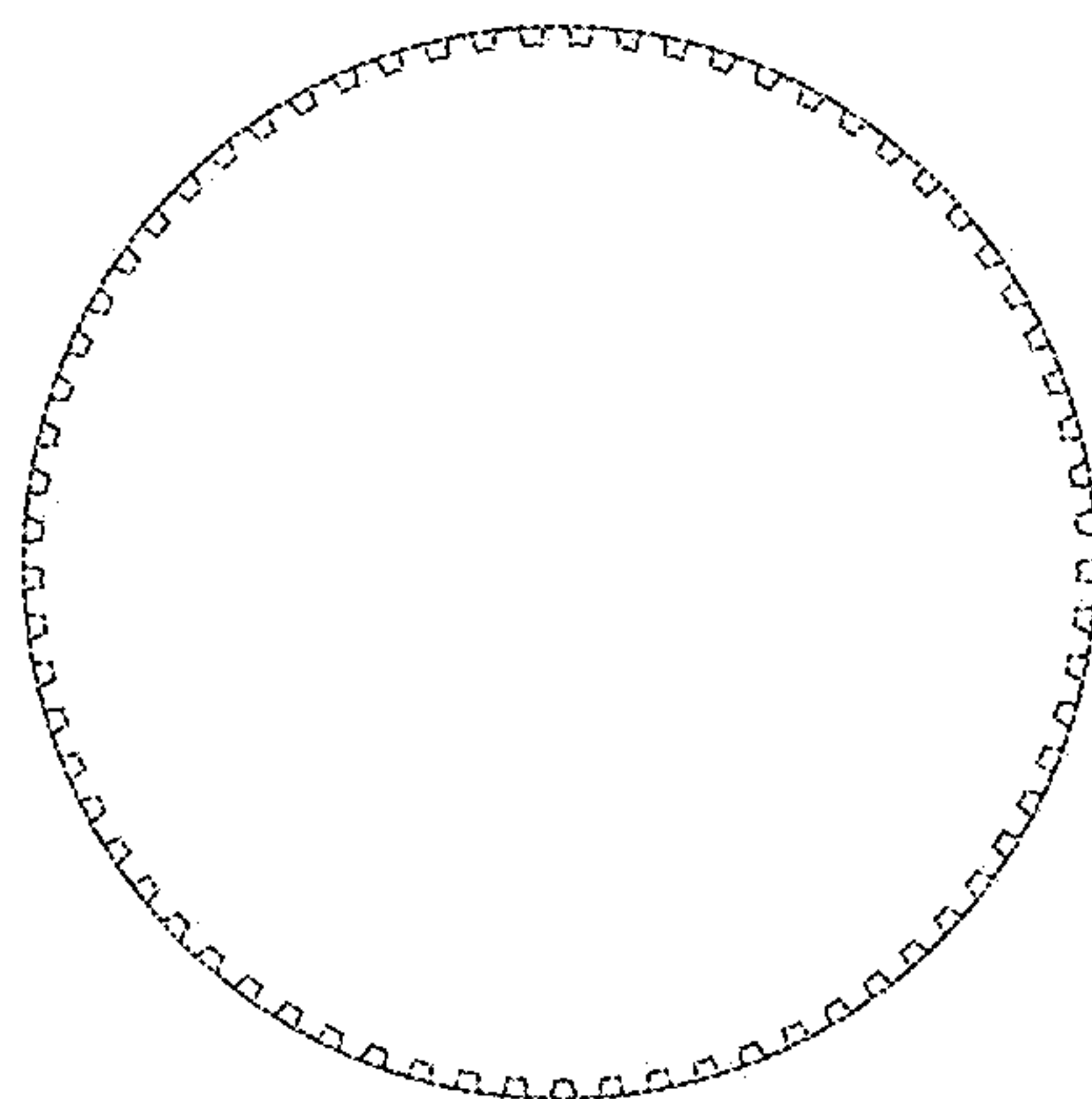
