(57) **CLAIM**

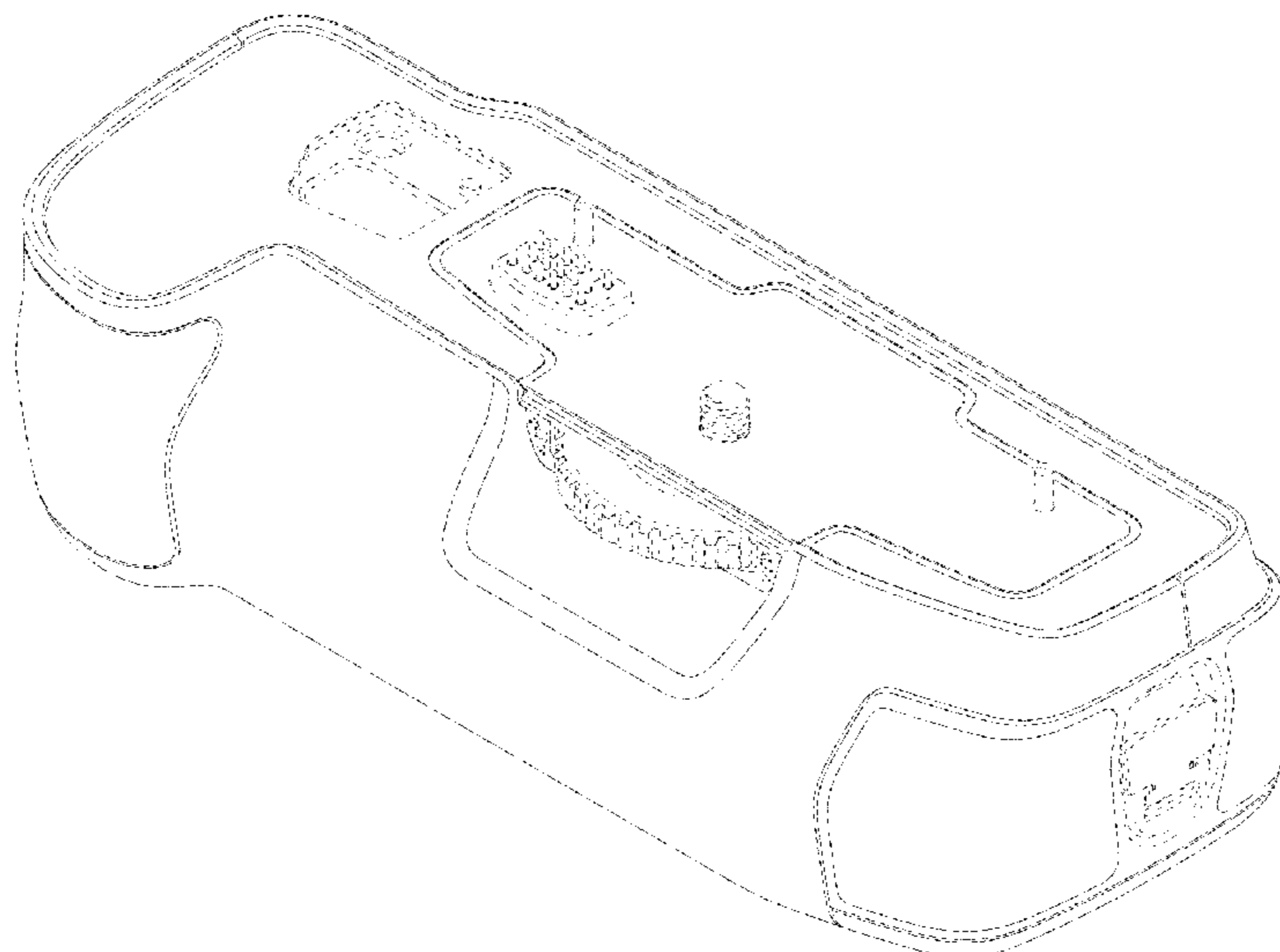
The ornamental design for a battery grip for camera, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a battery grip for camera showing our new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front view thereof;

FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;

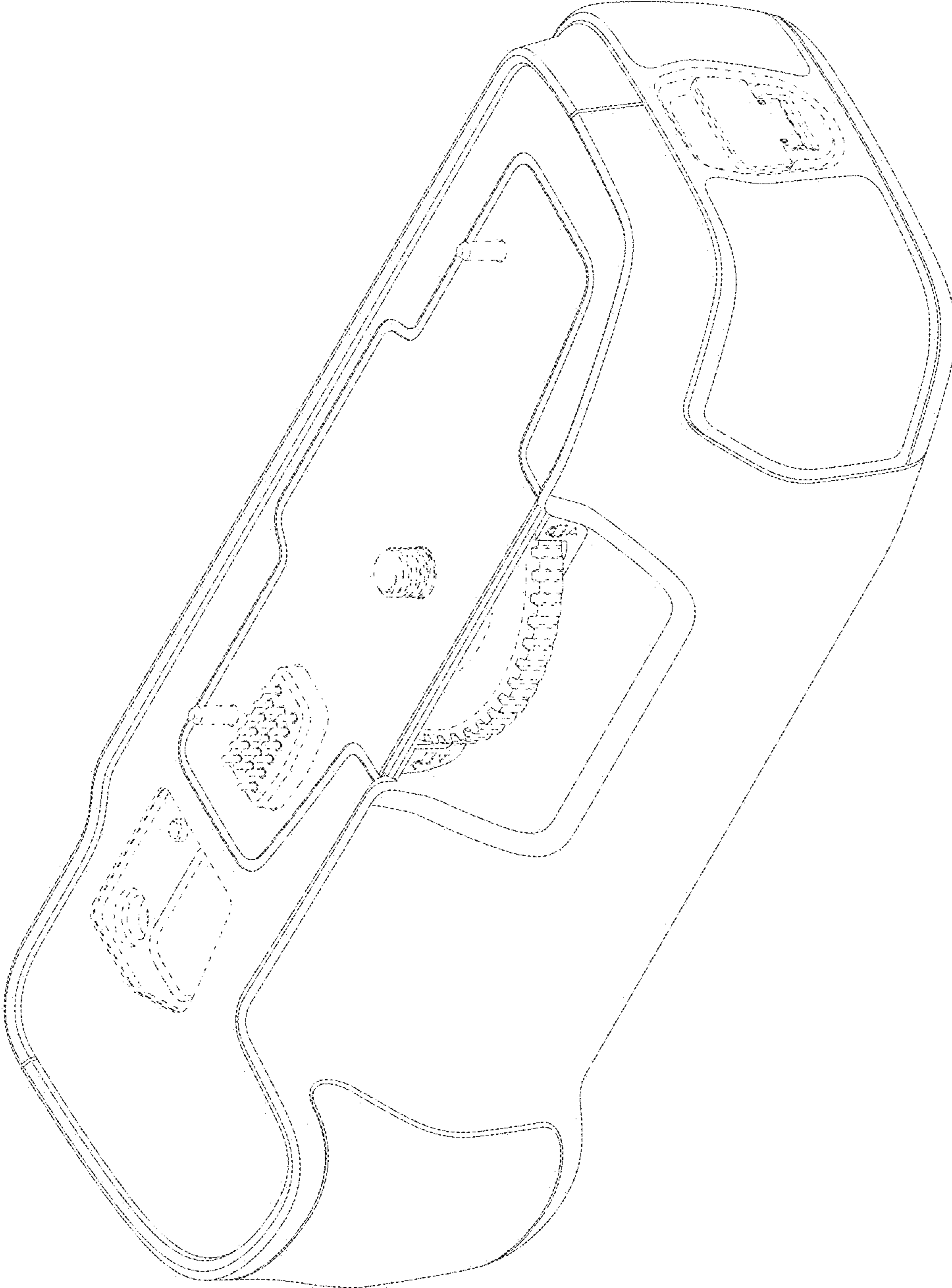

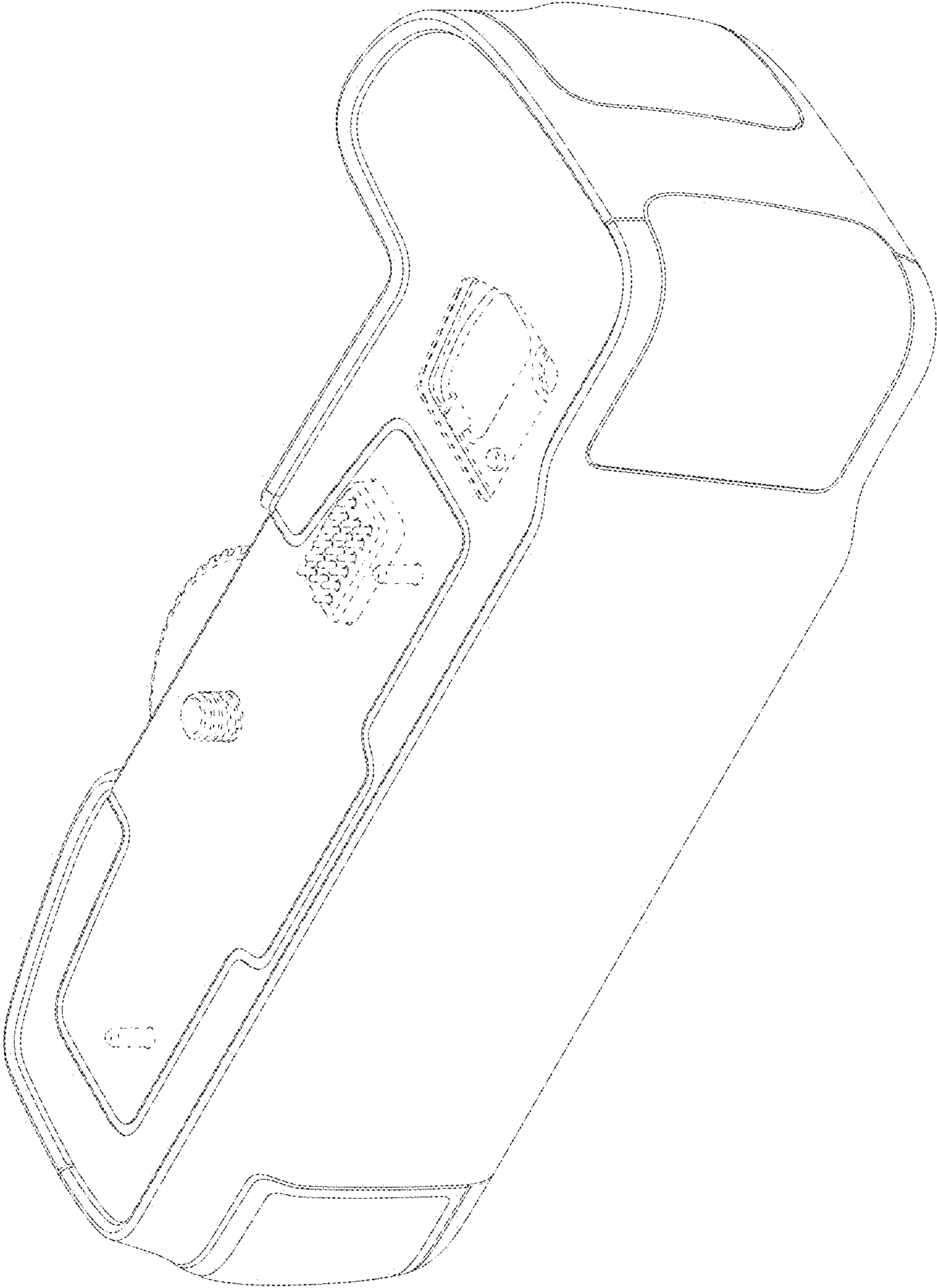

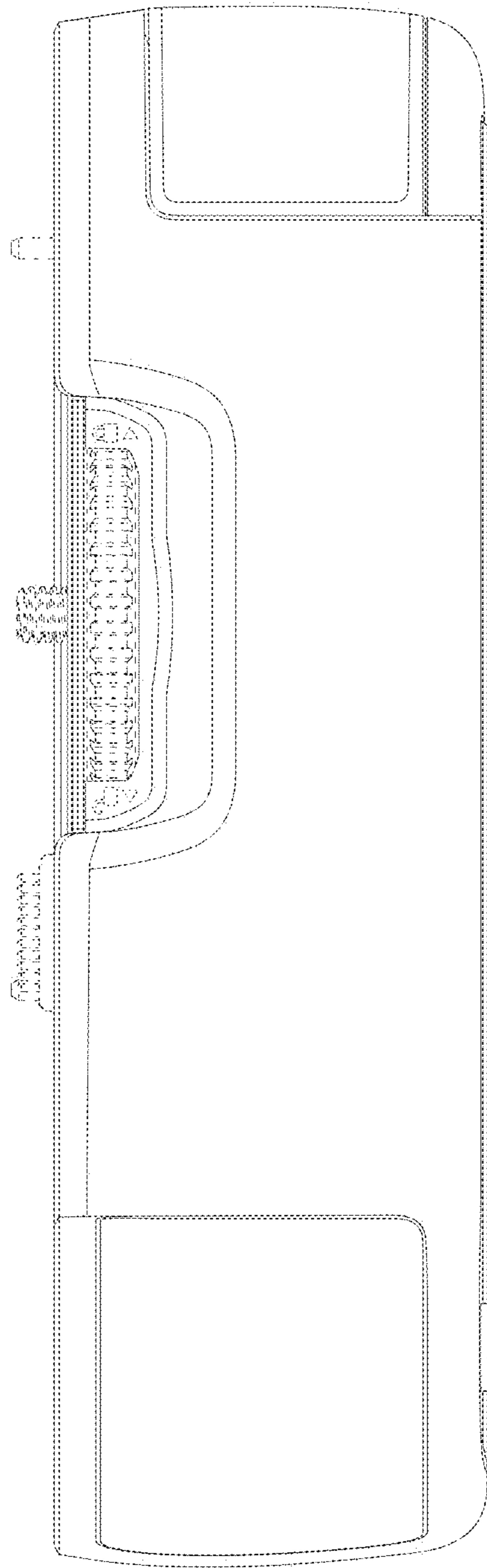

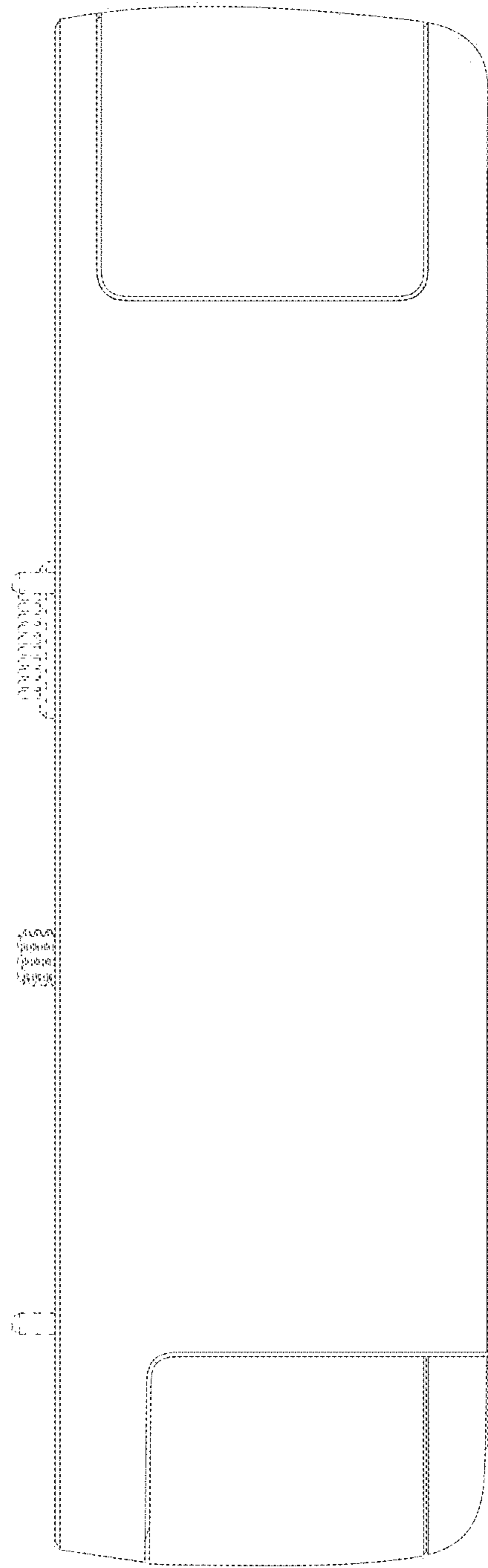

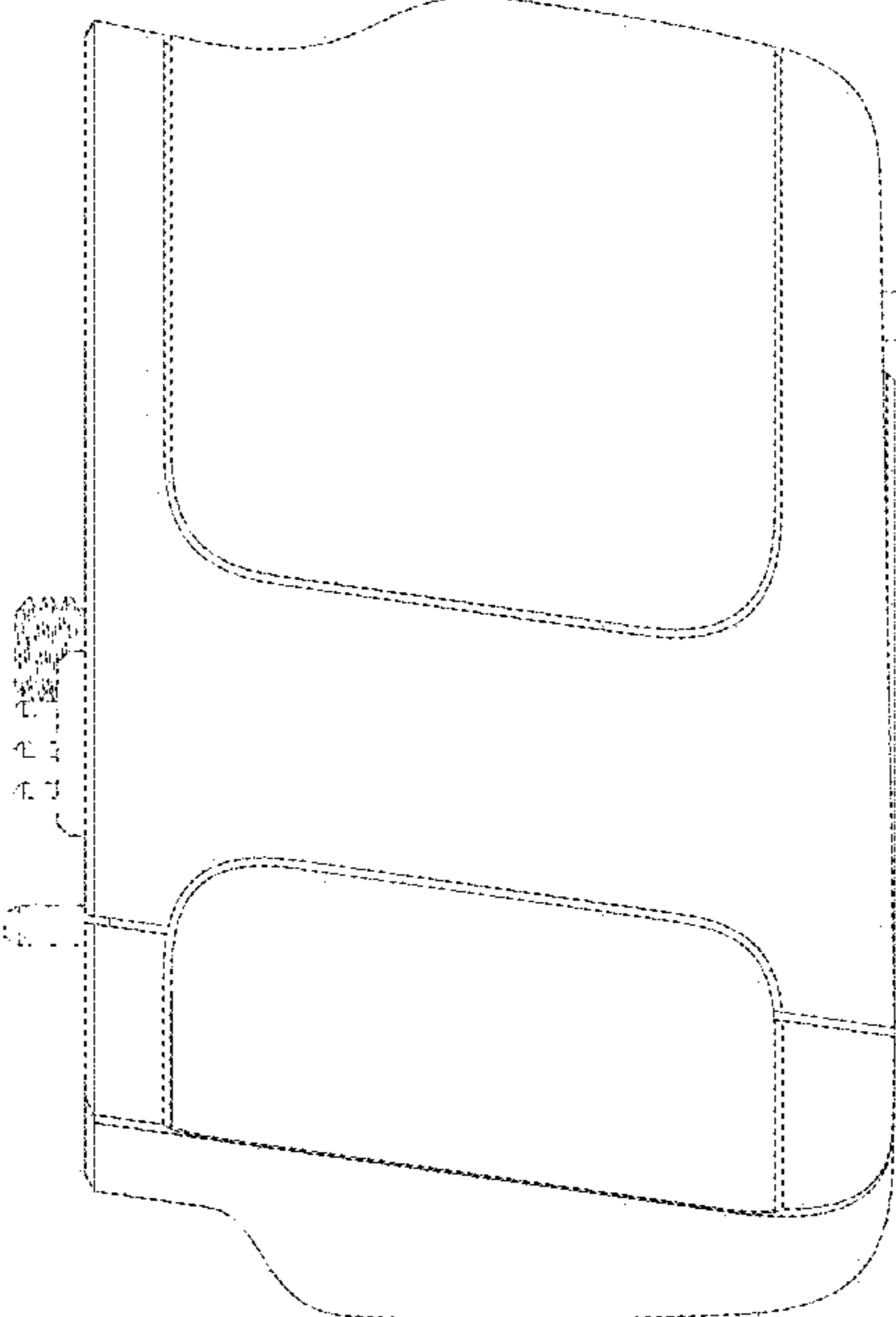

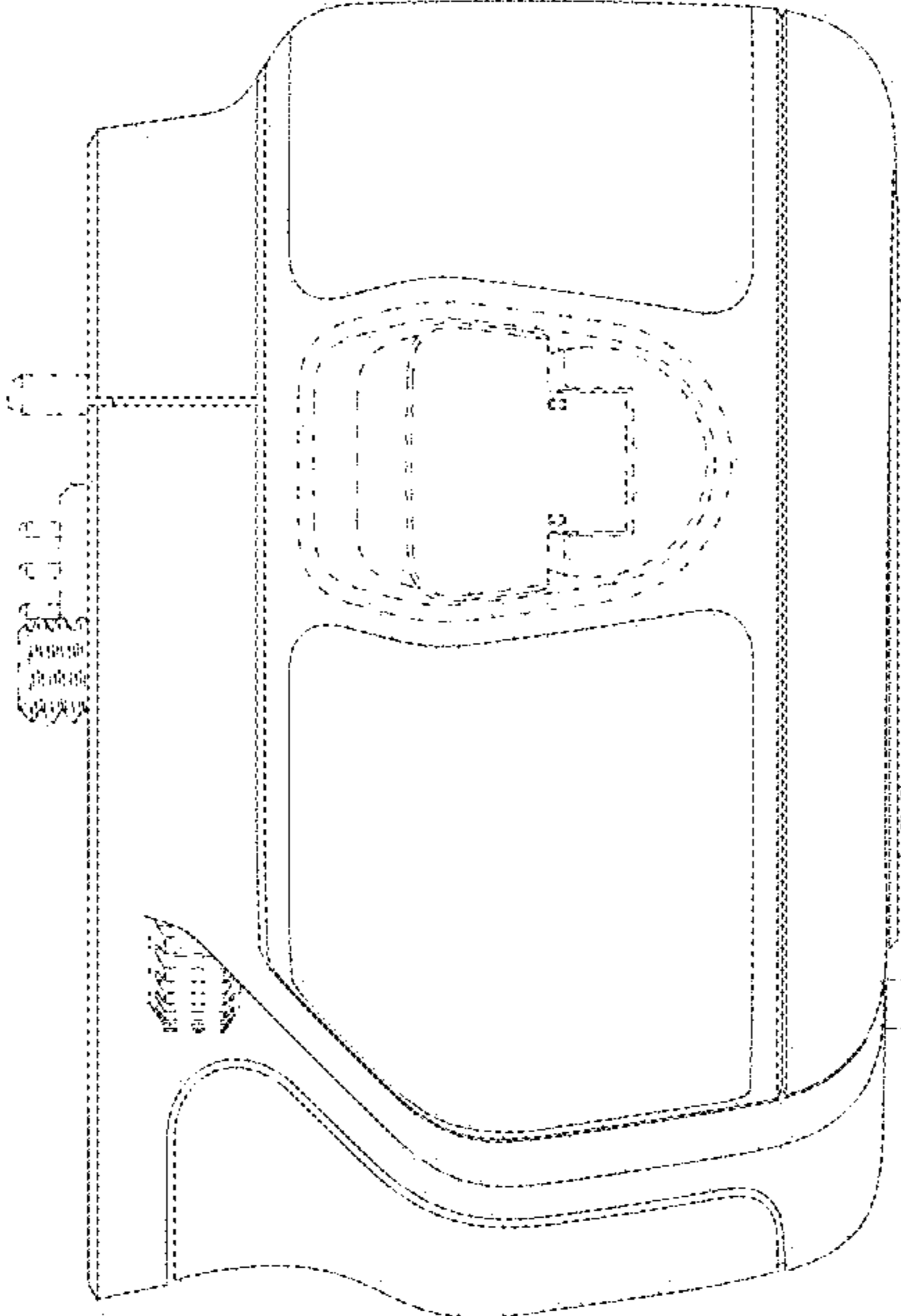

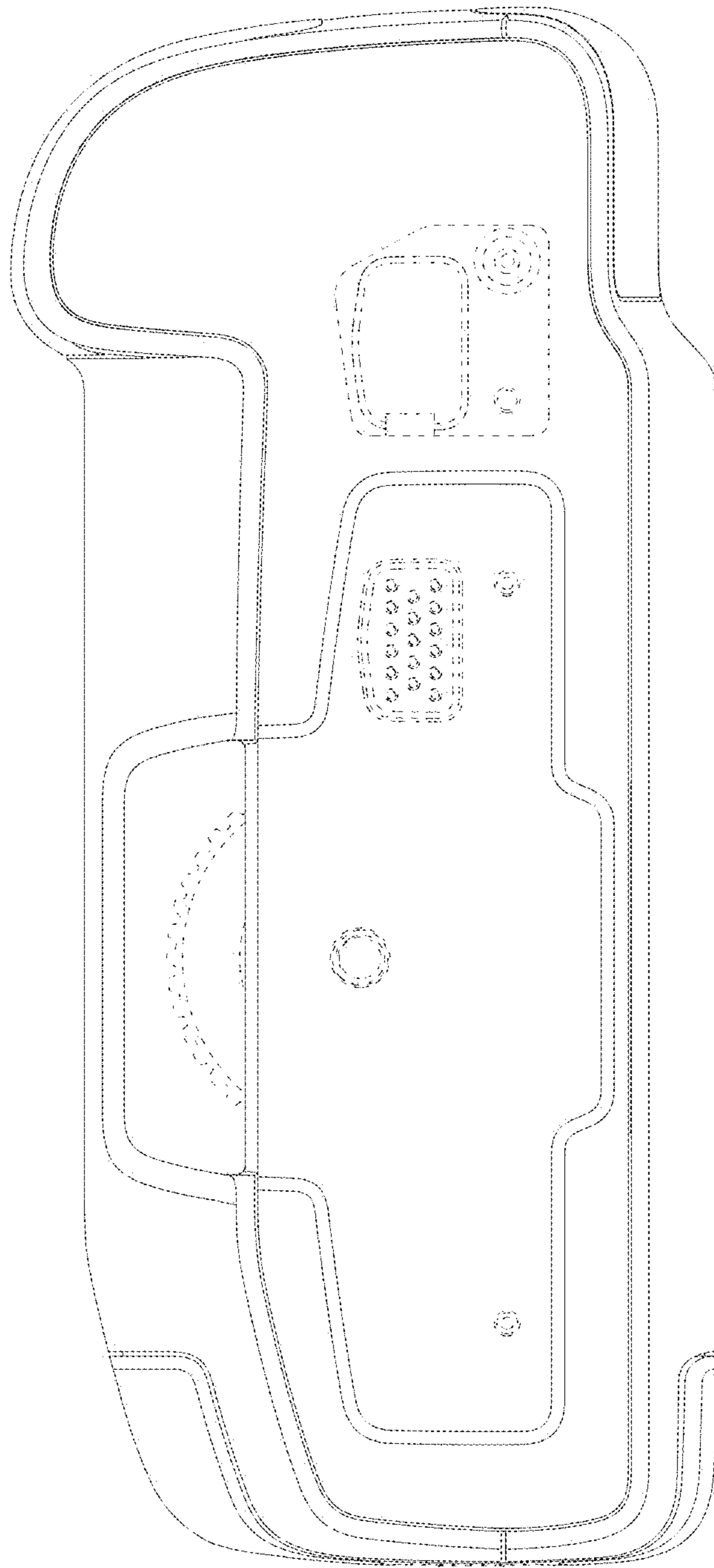

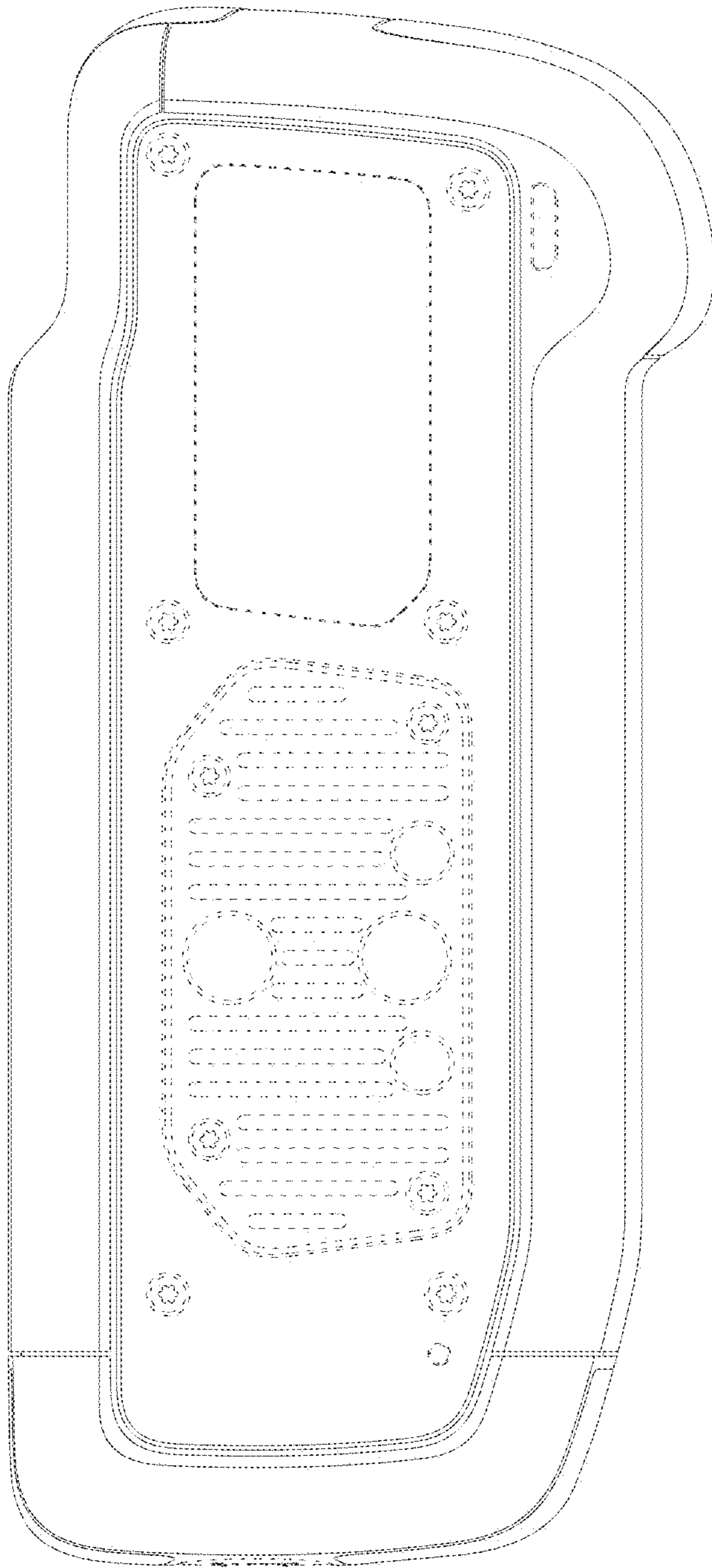
