1.3 : Back

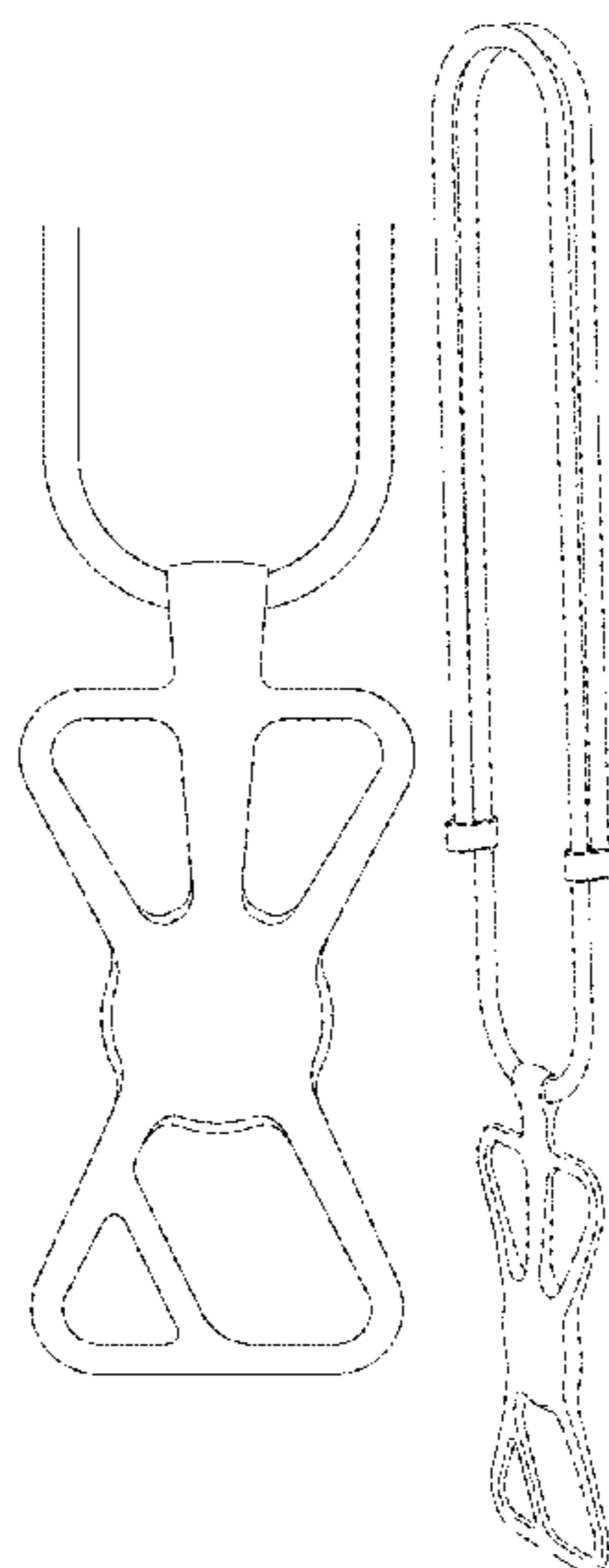
1.4 : Right

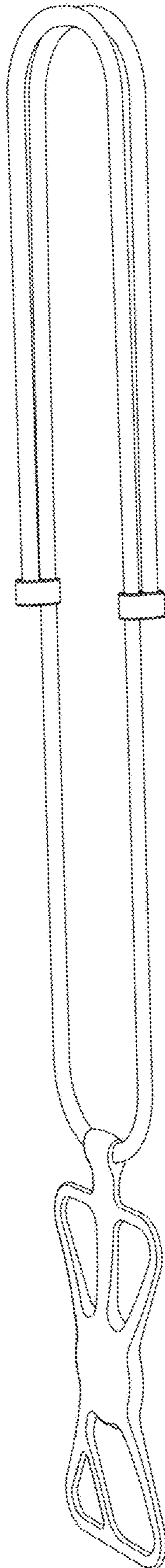

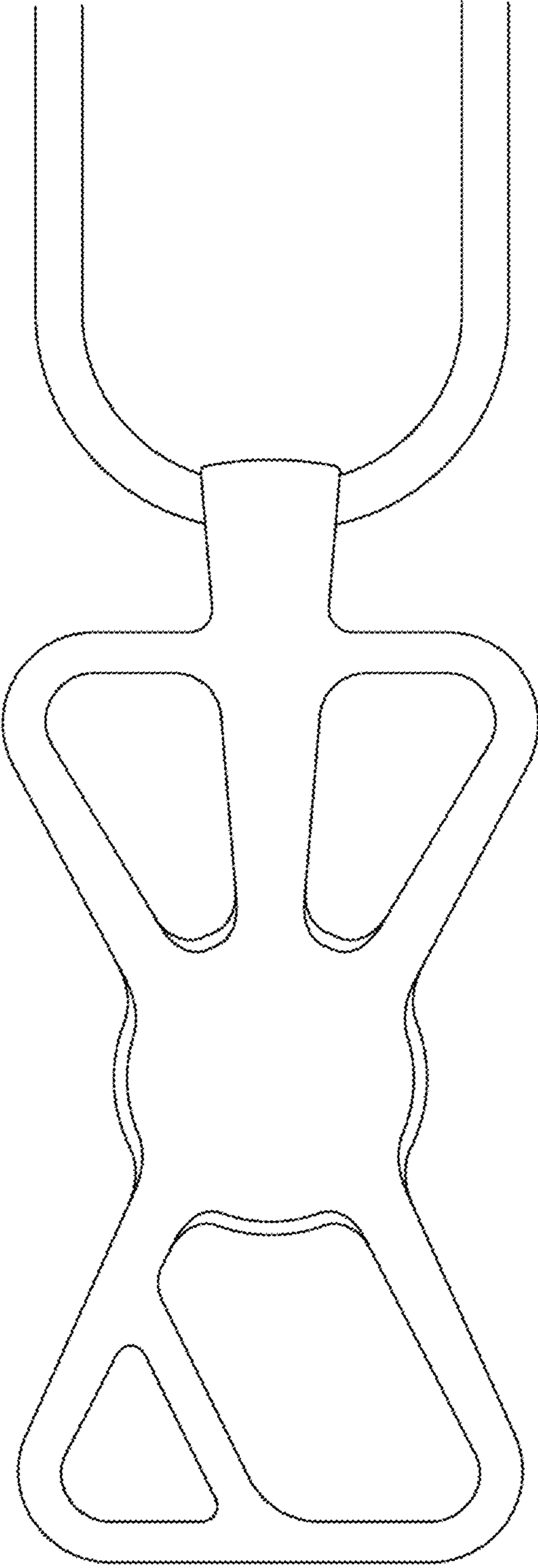

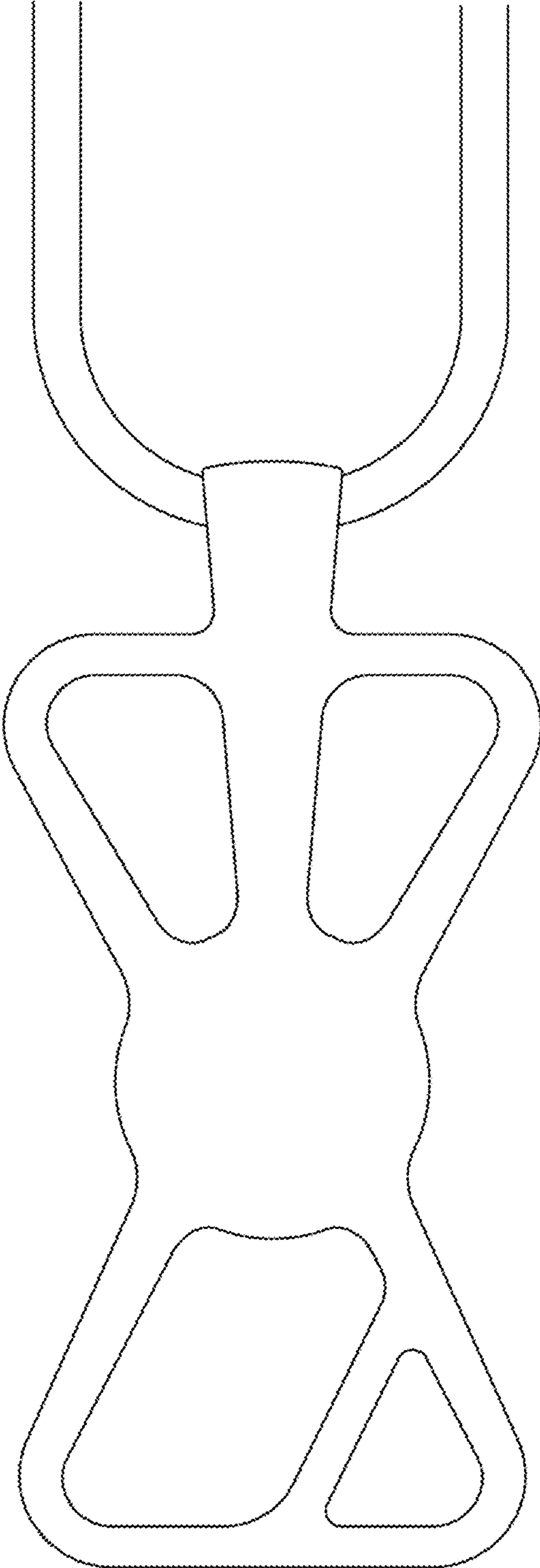

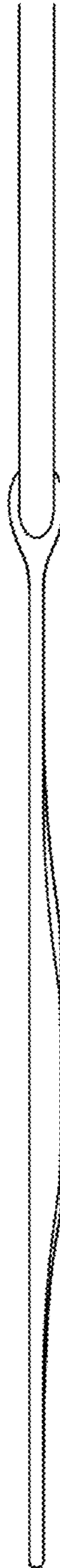

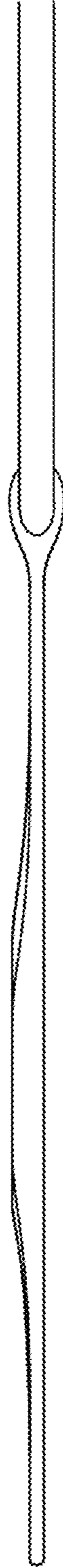
