DESCRIPTION

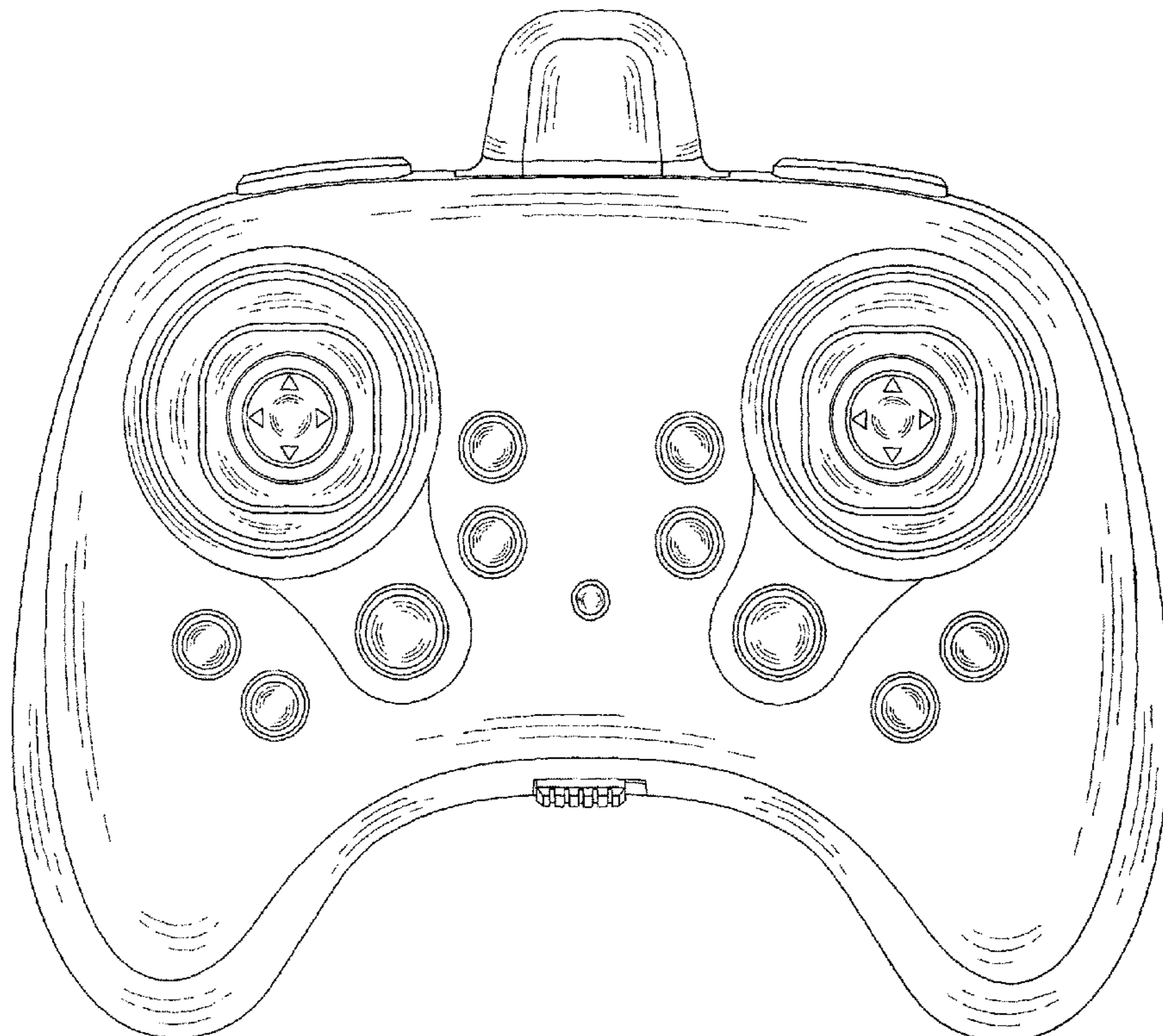
FIG. 1 is a perspective view of a remote controller showing my new design;

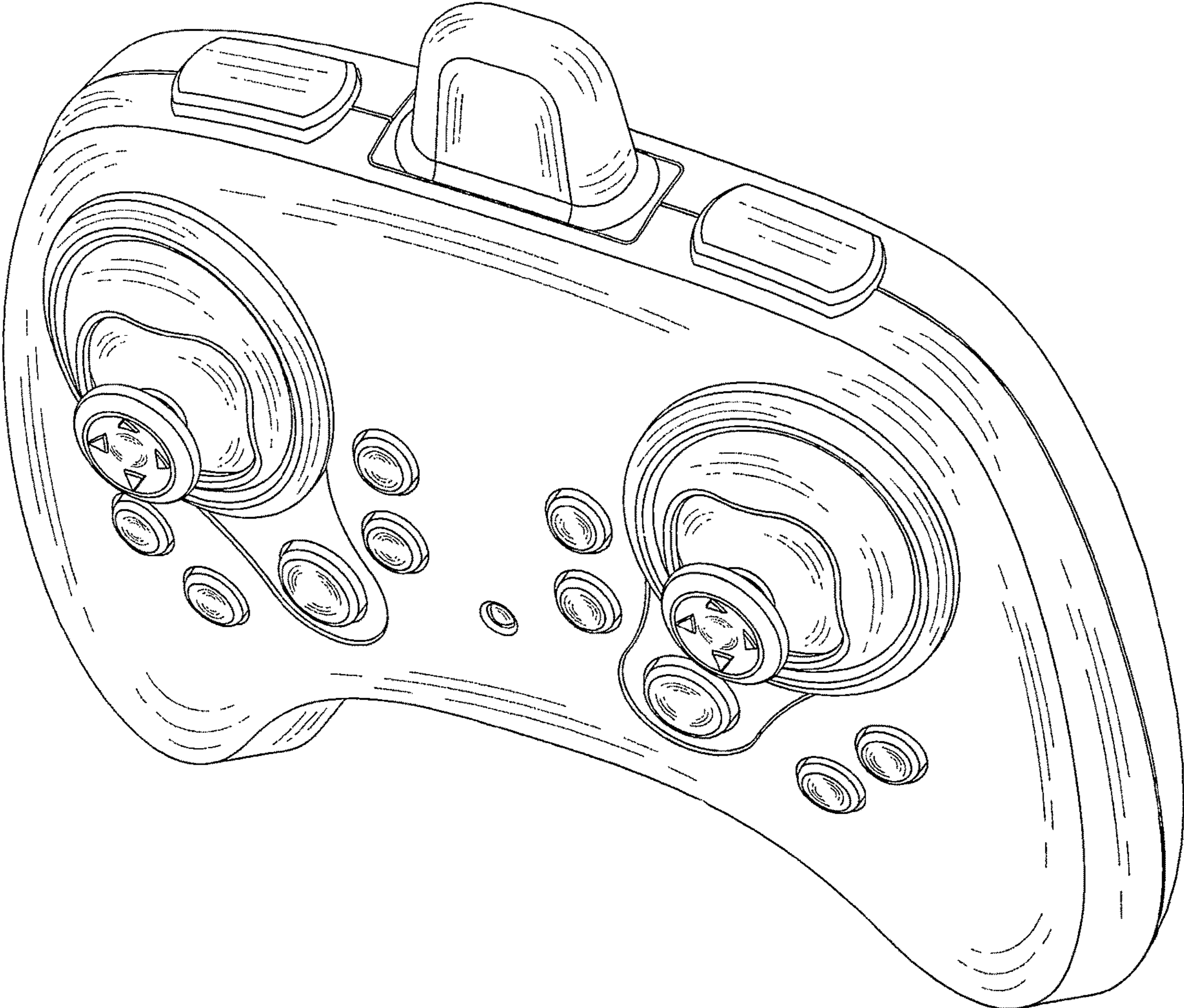

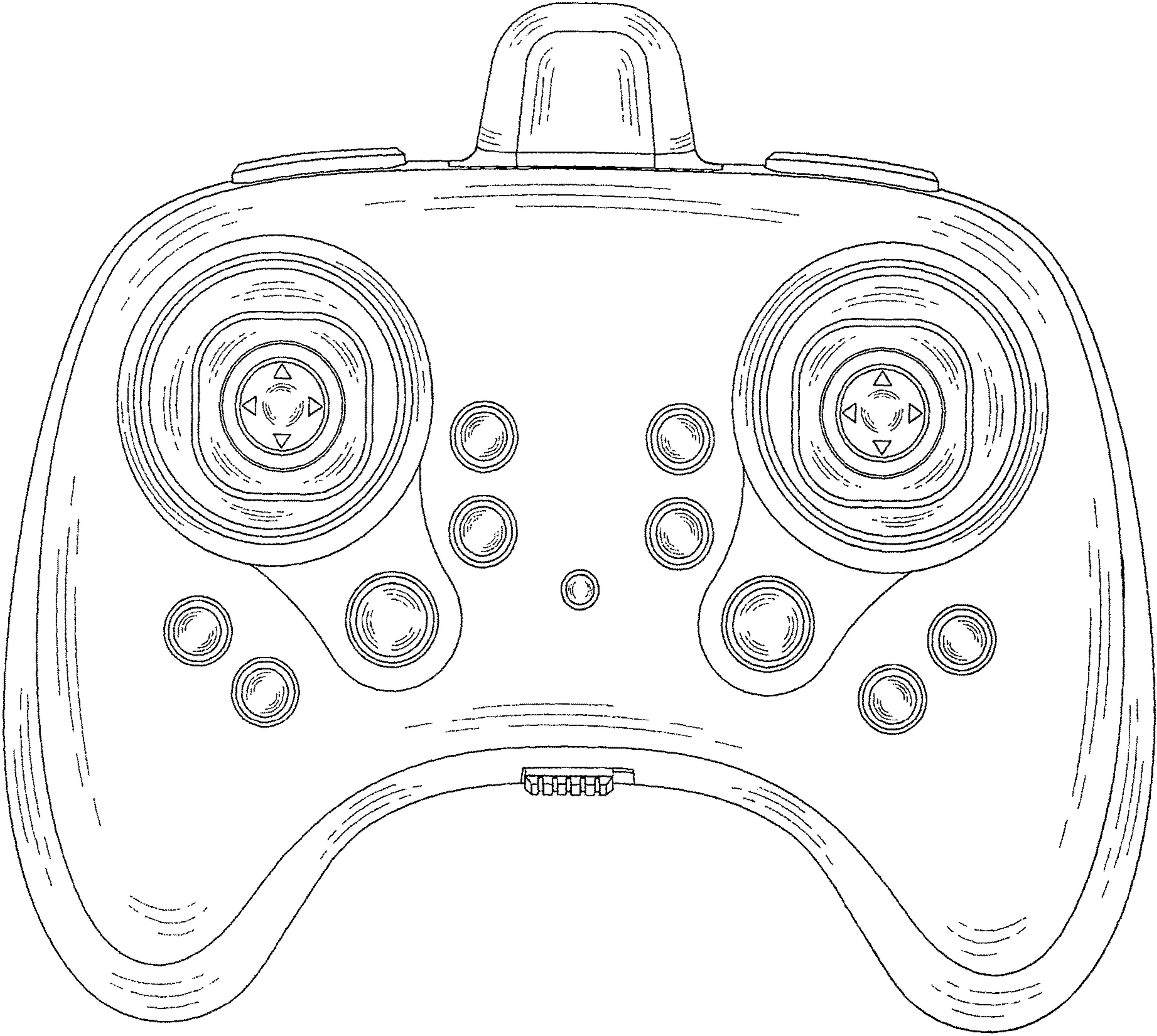

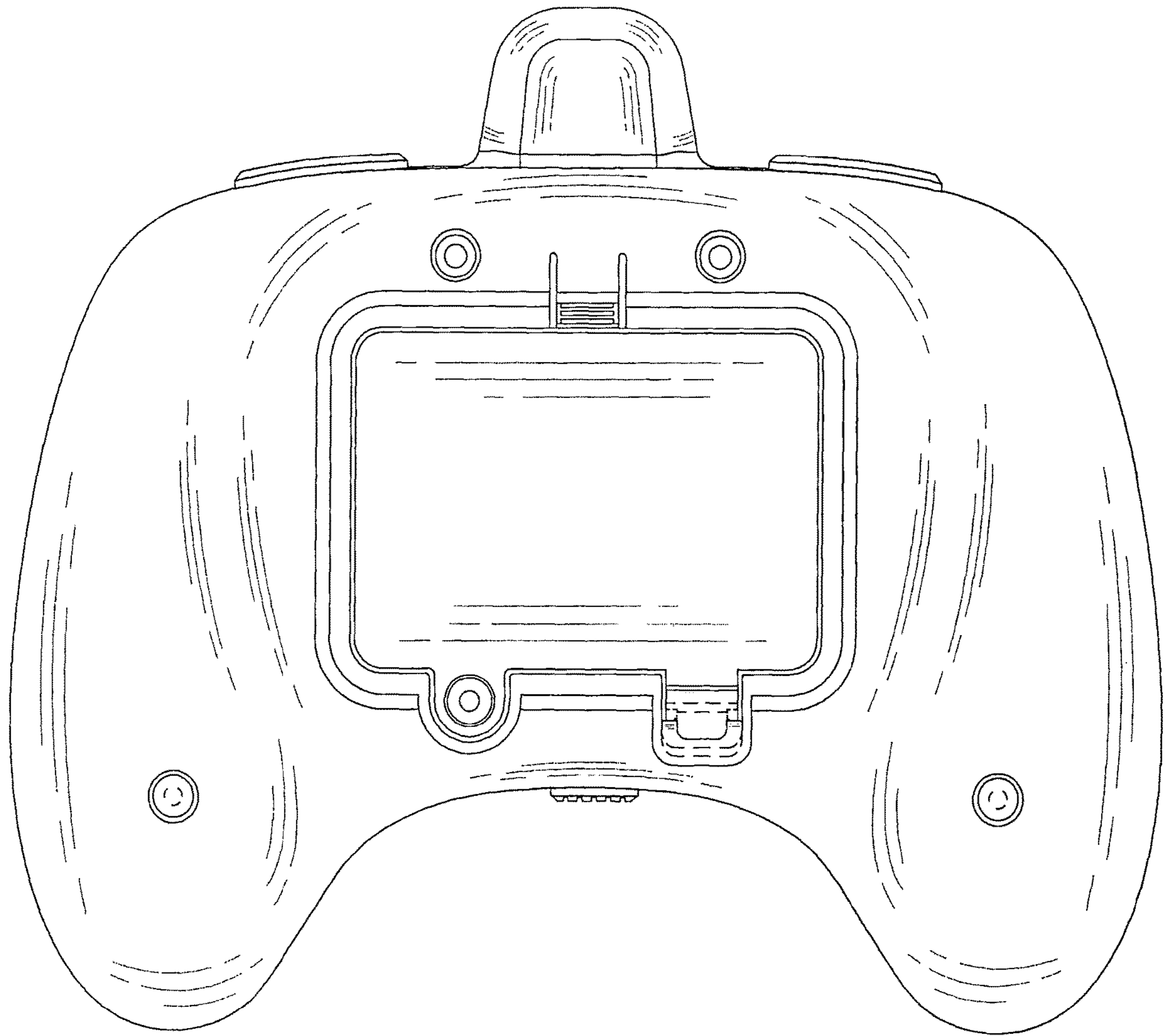

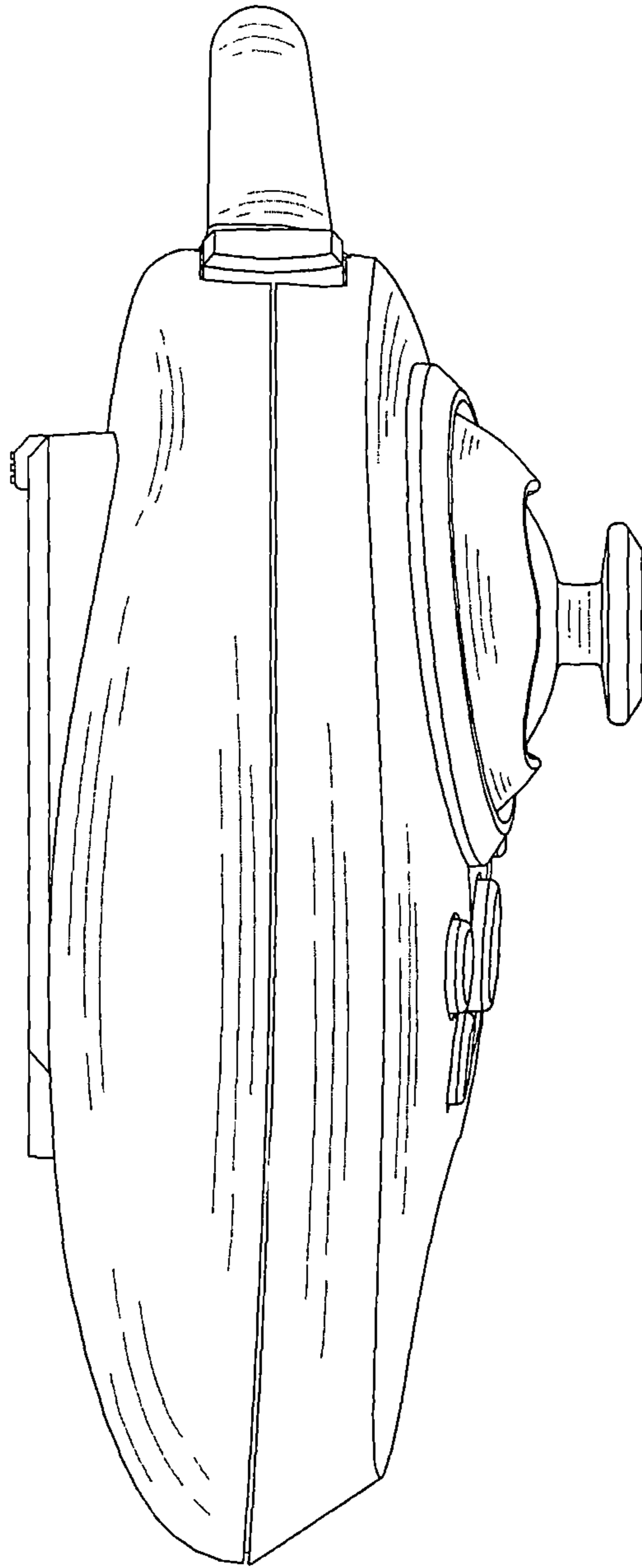

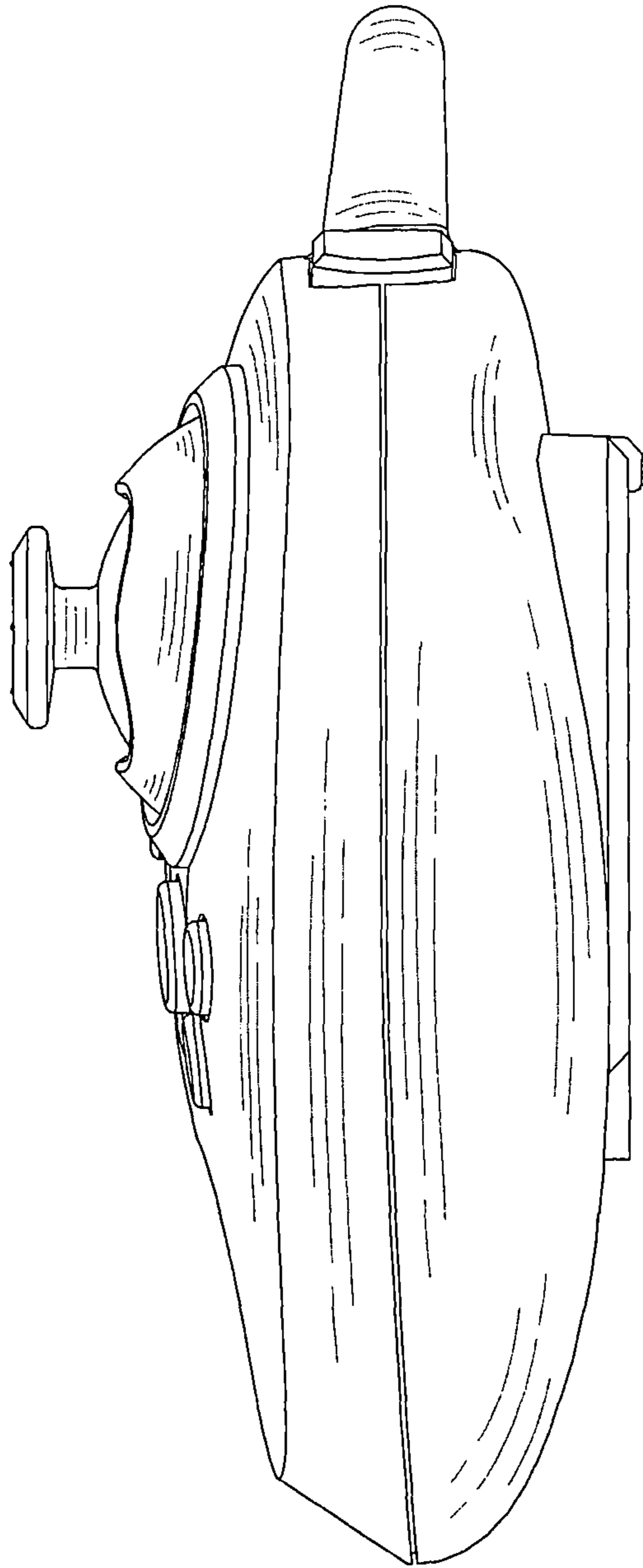

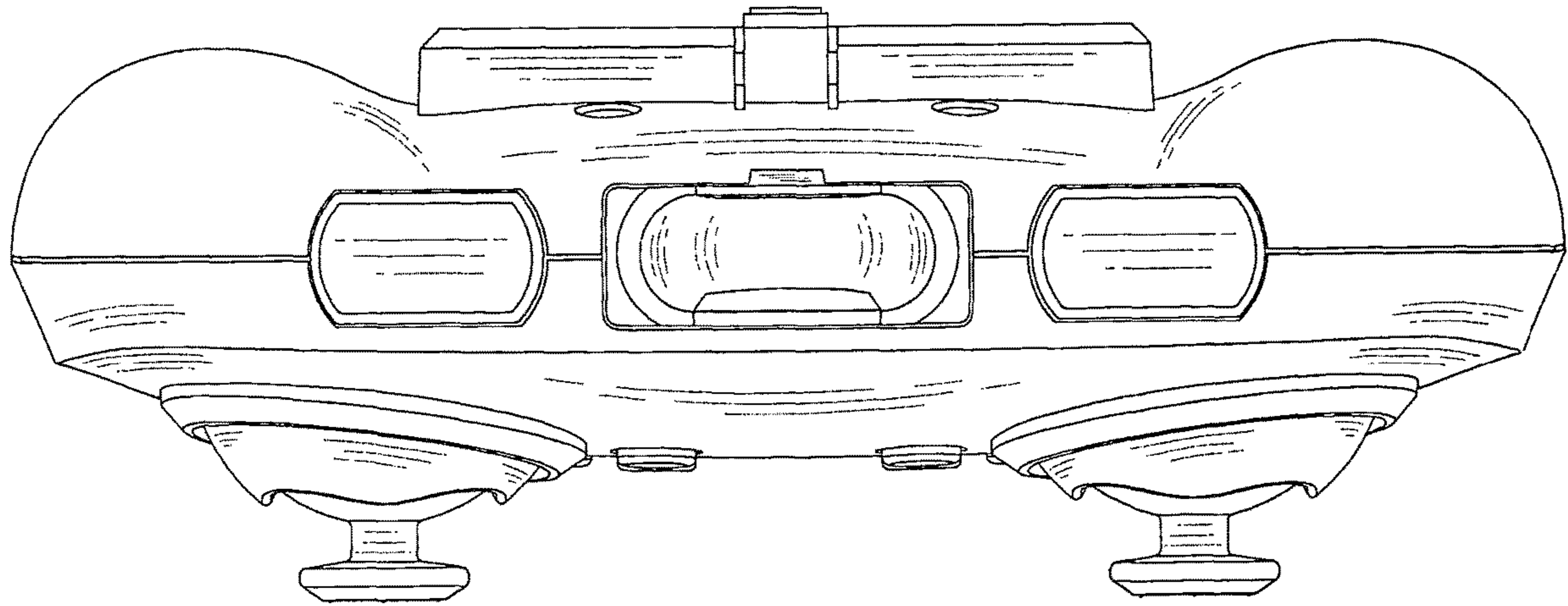

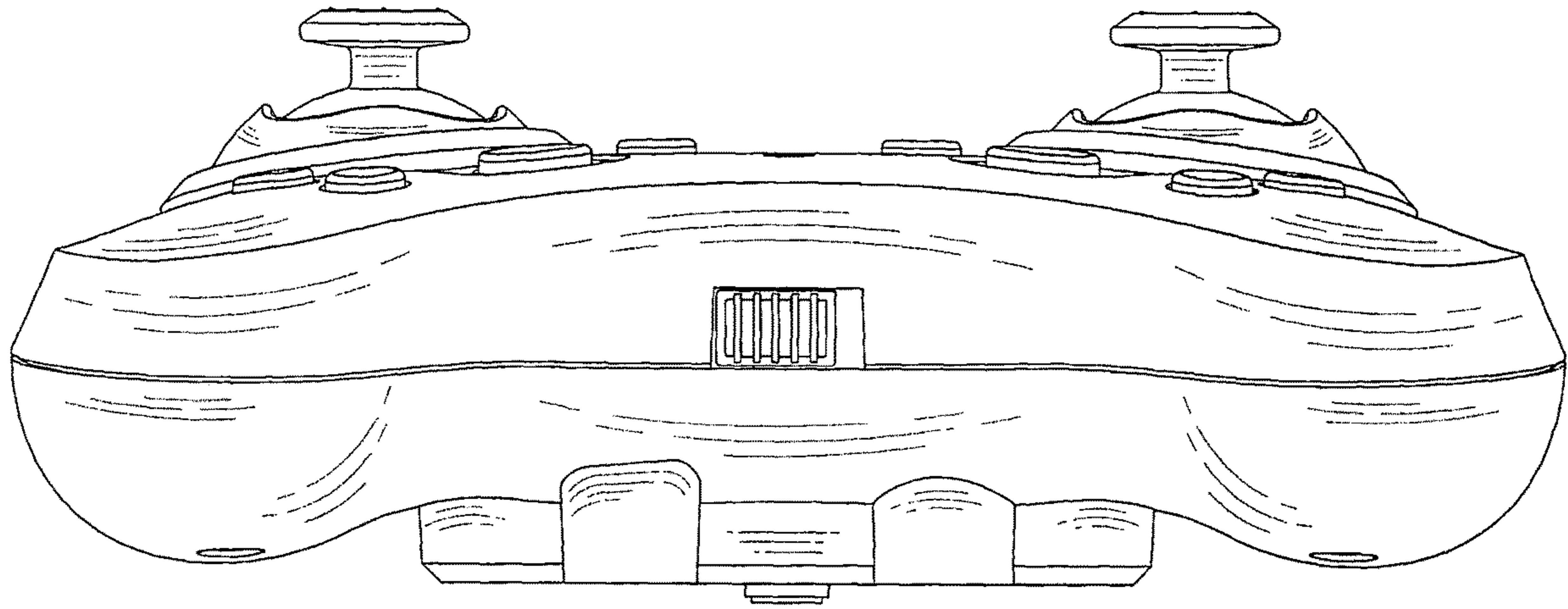

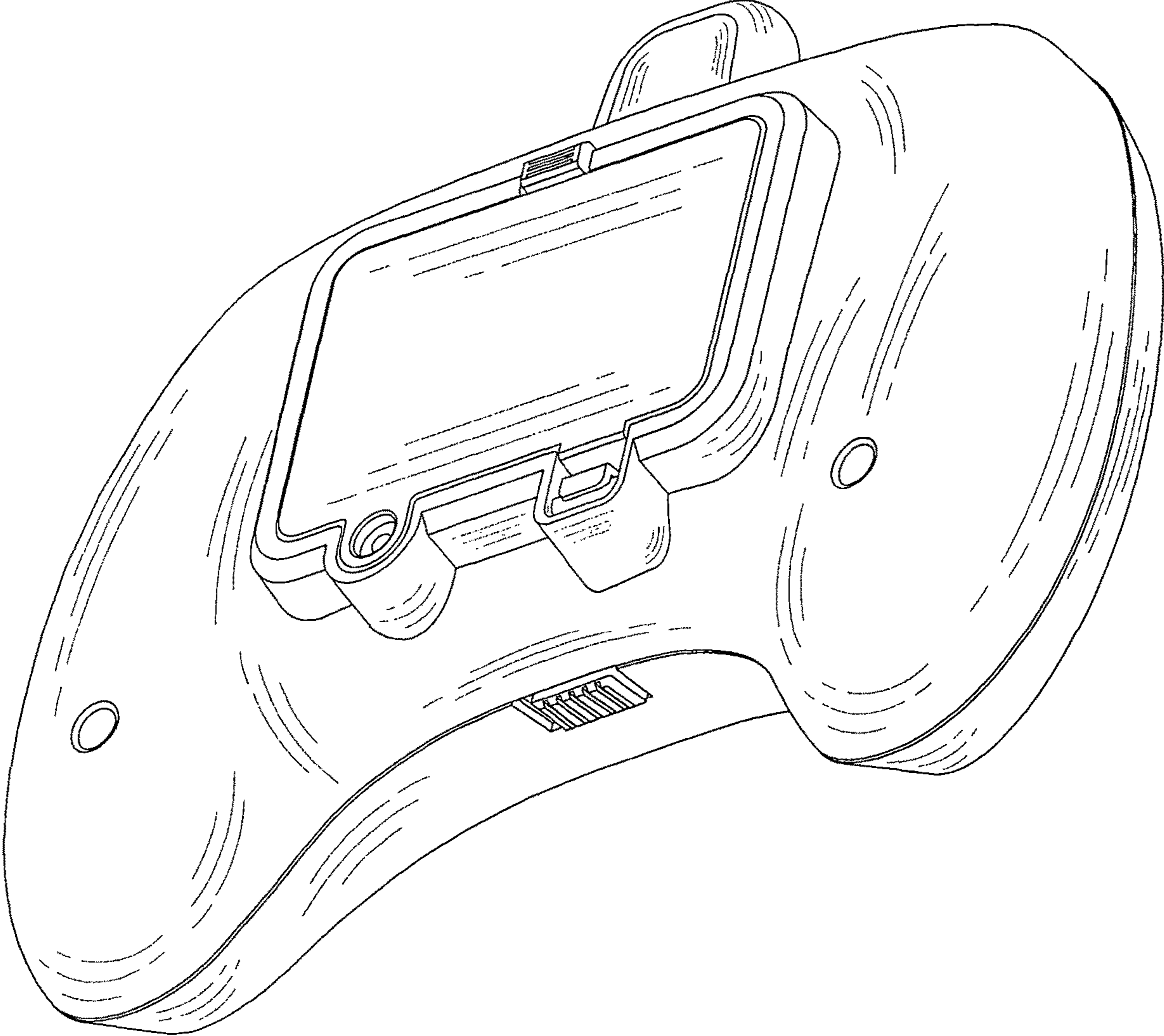
