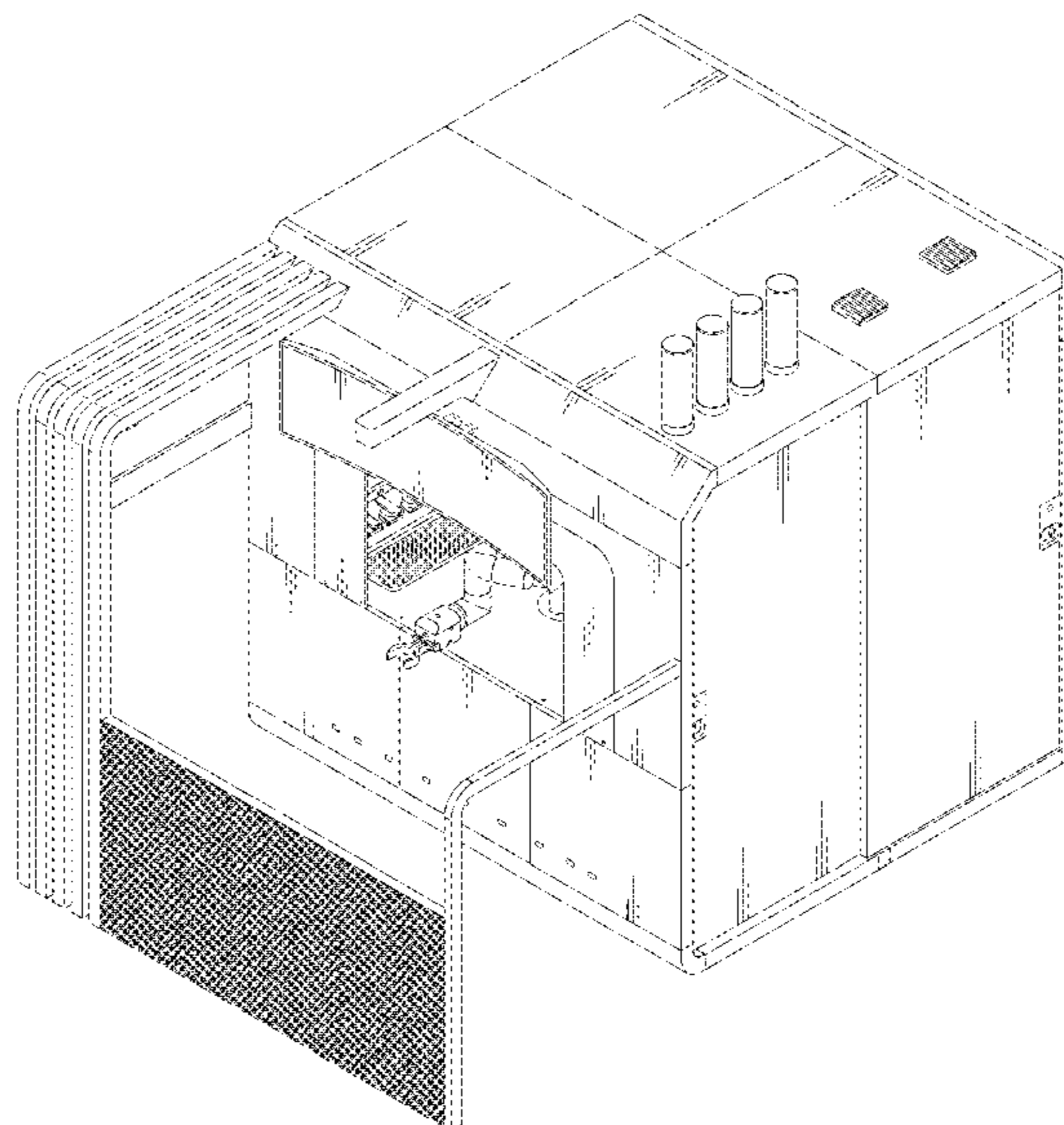

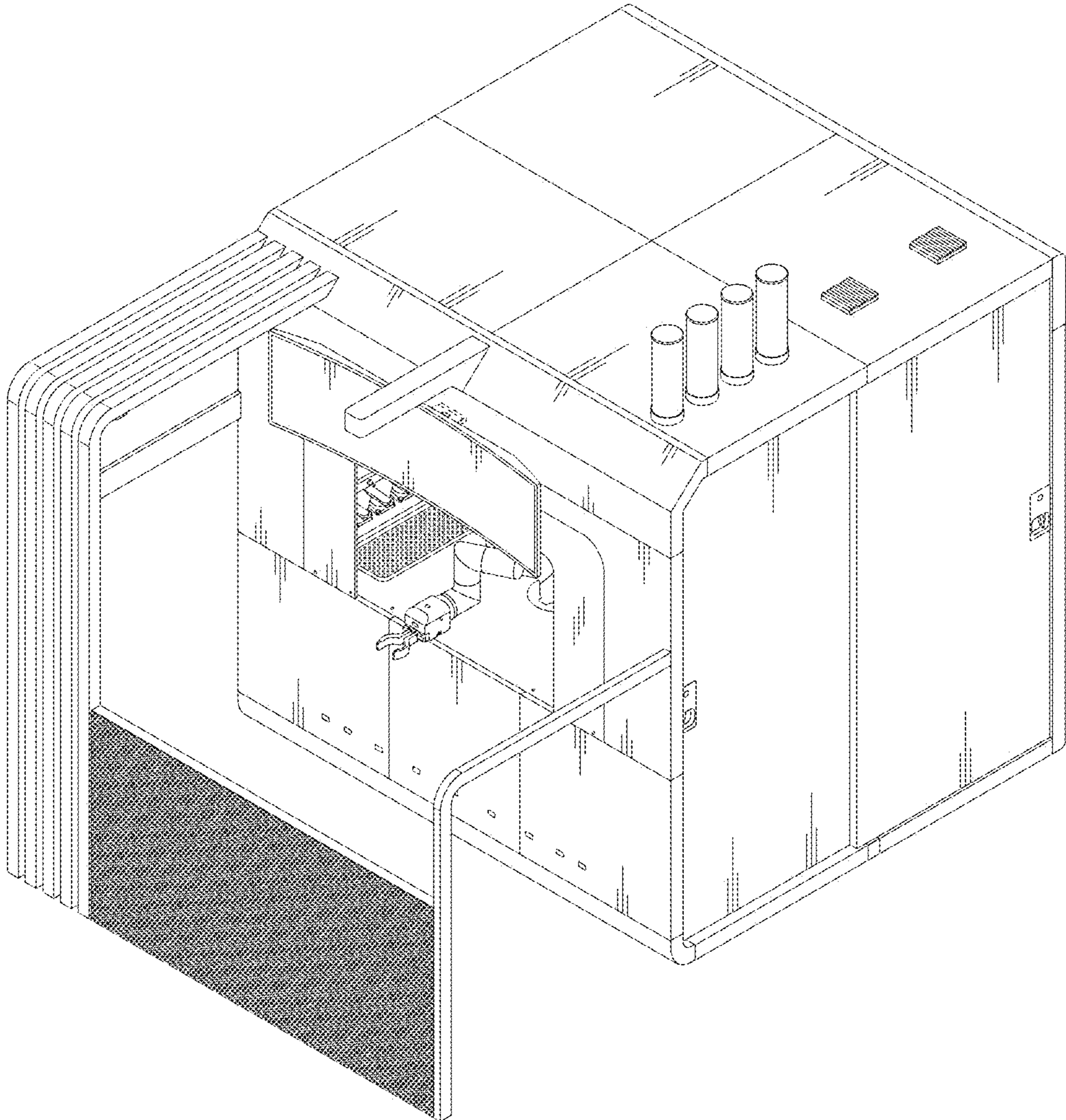

The broken lines in the drawings show portions of the beverage vending machine that form no part of the claimed design.

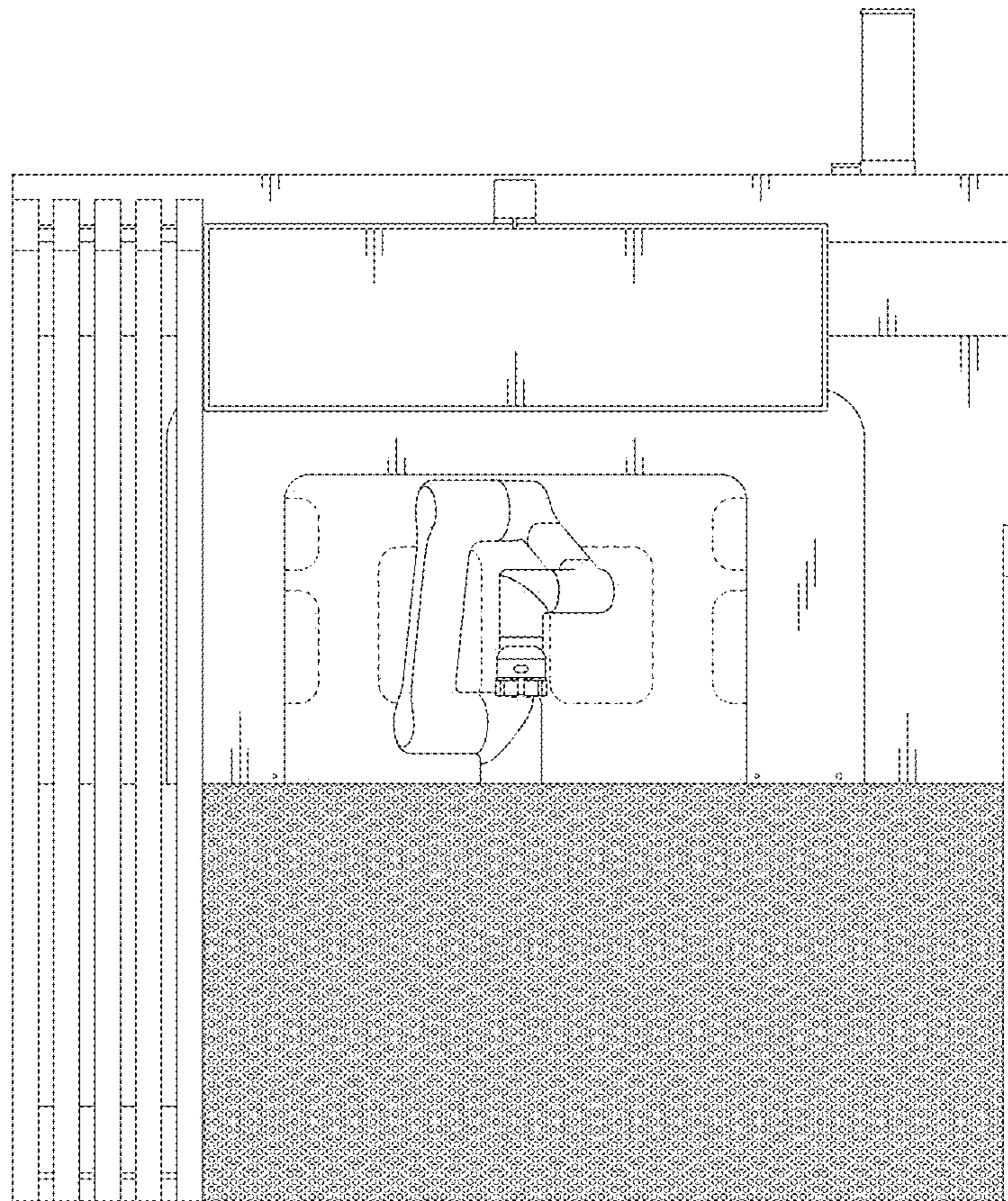

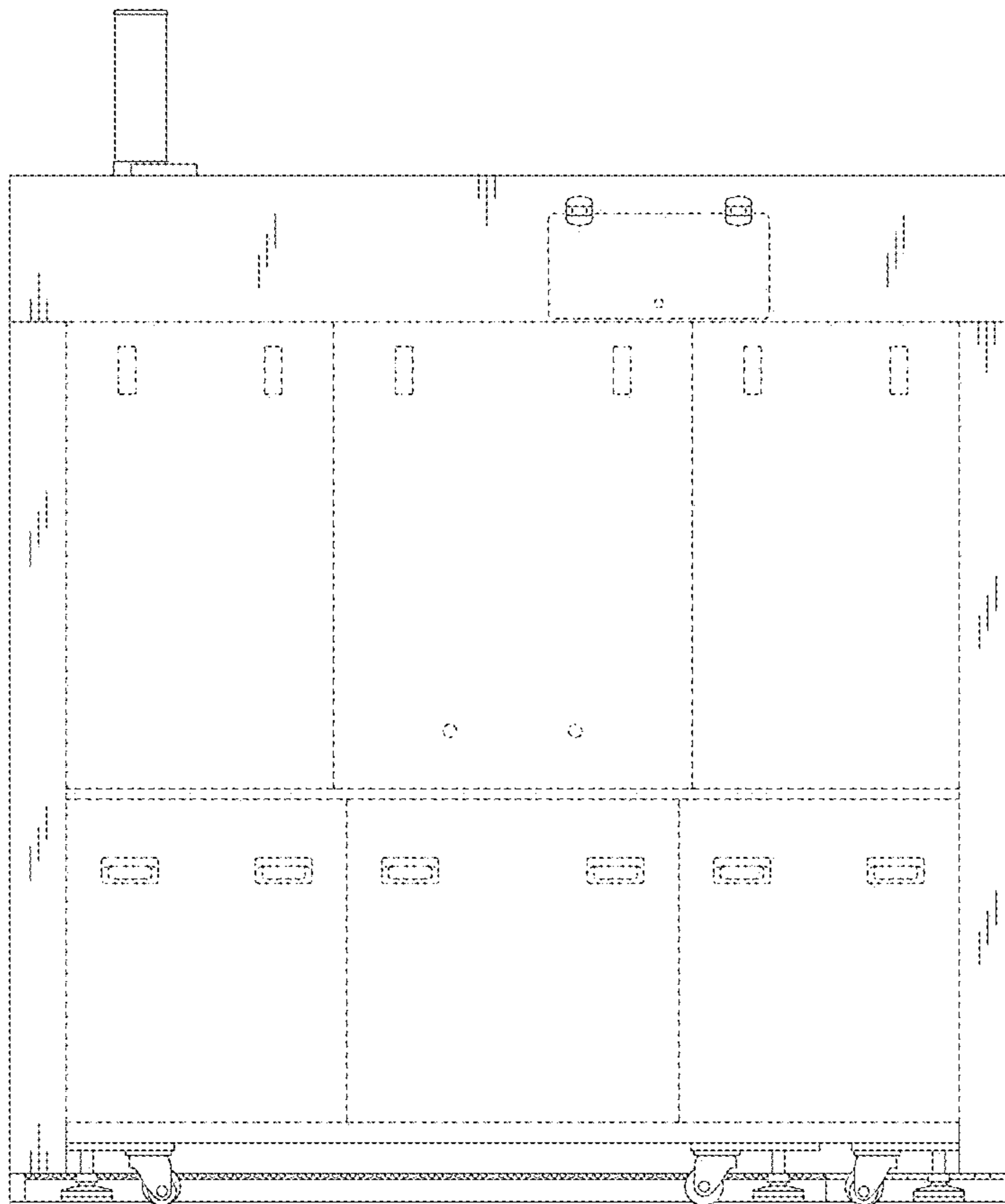

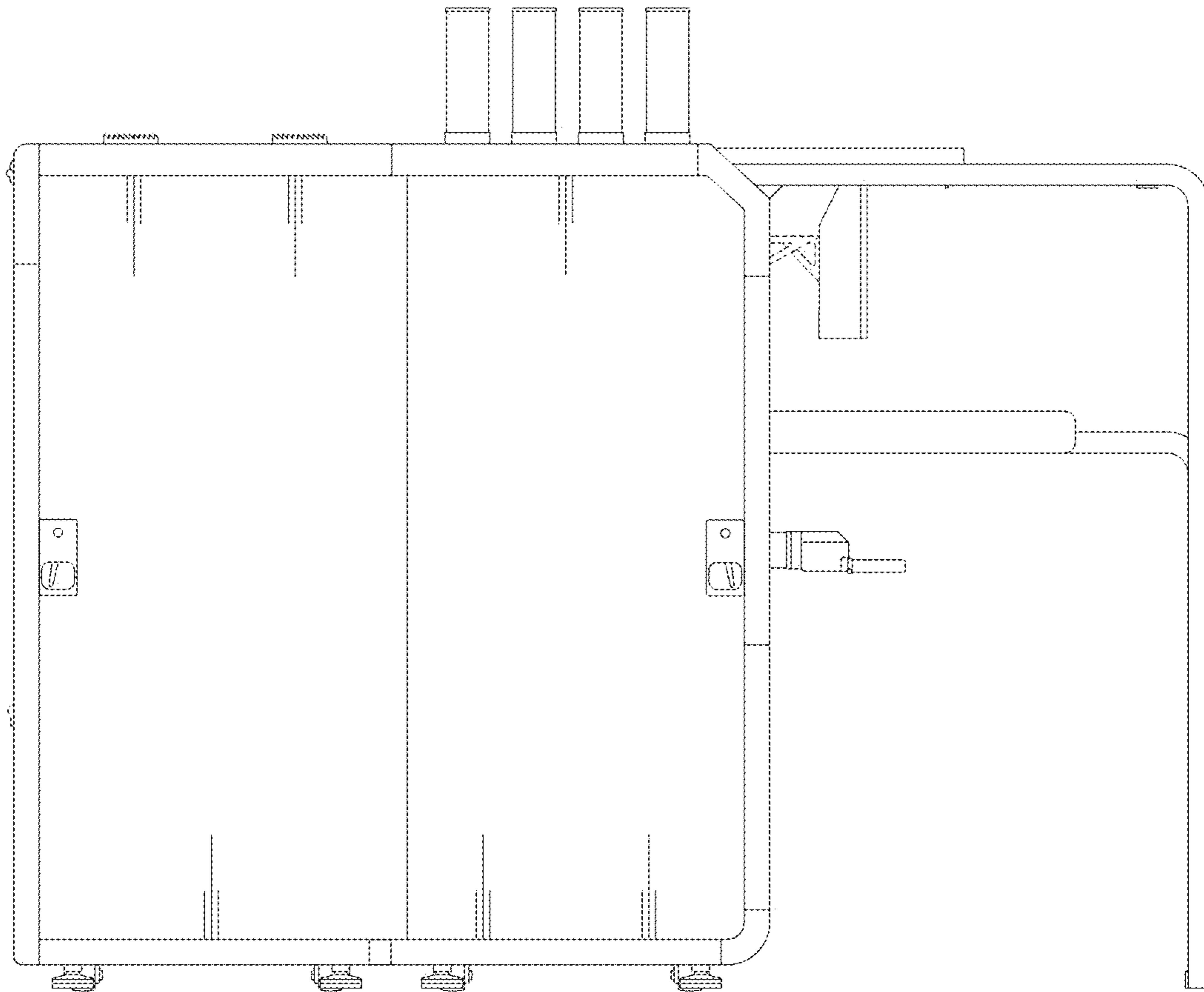

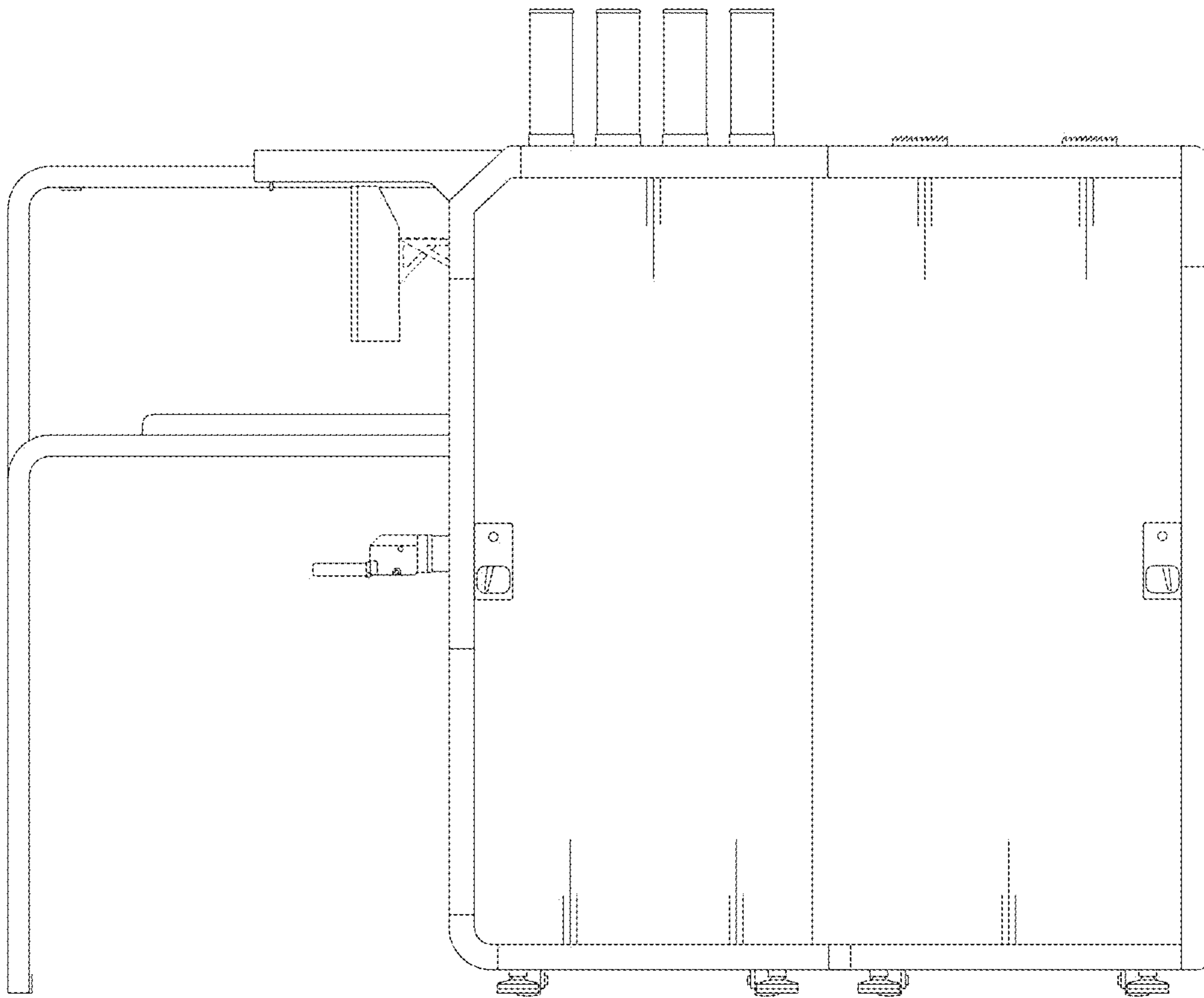

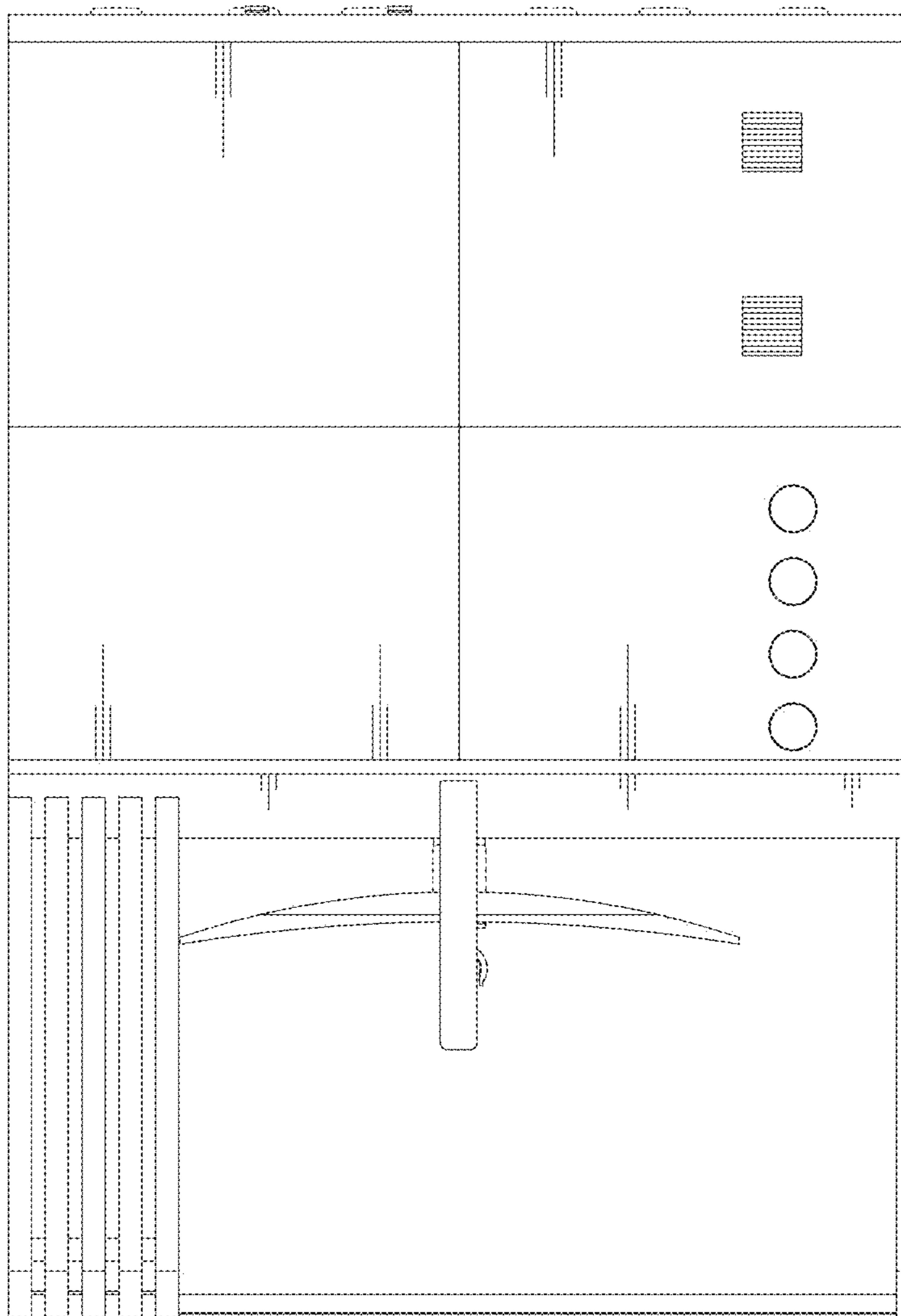
