(57) **CLAIM**

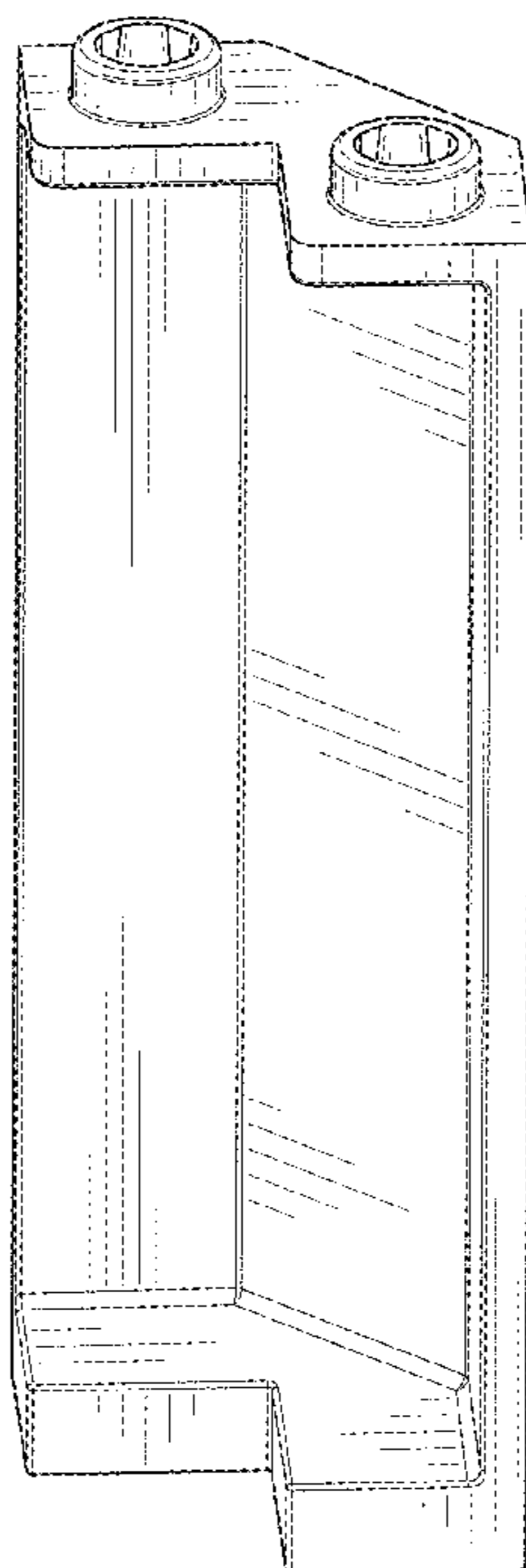
The ornamental design for a column element for a construction toy, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the column element for a construction toy showing my new design;

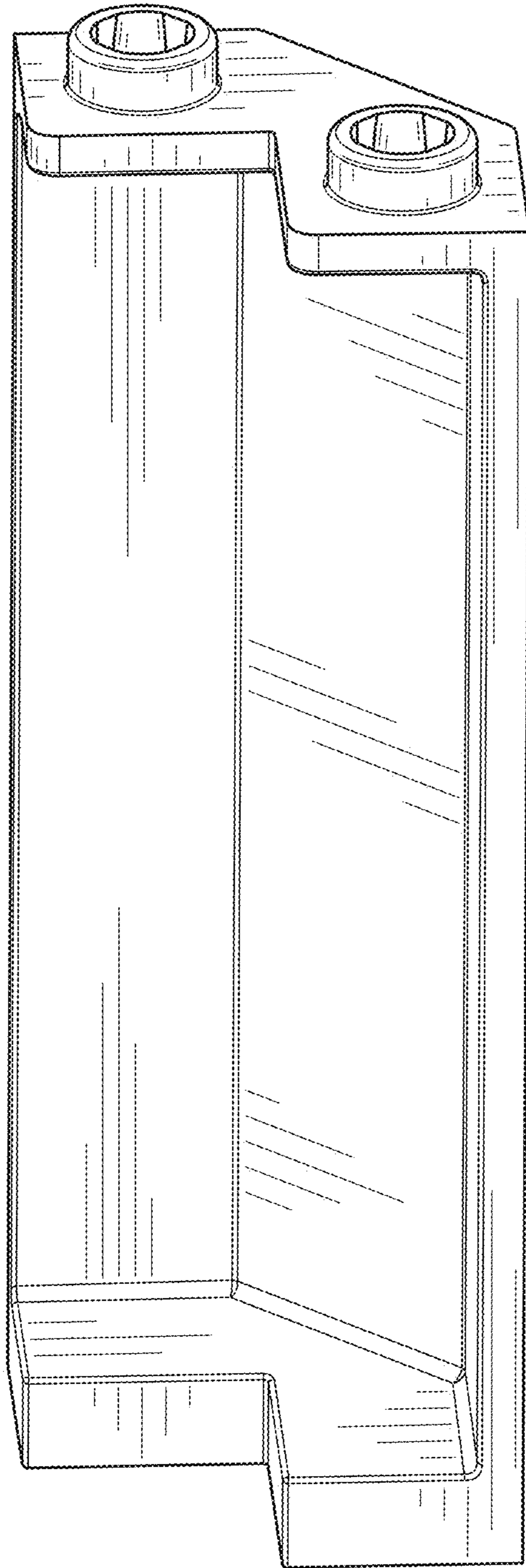

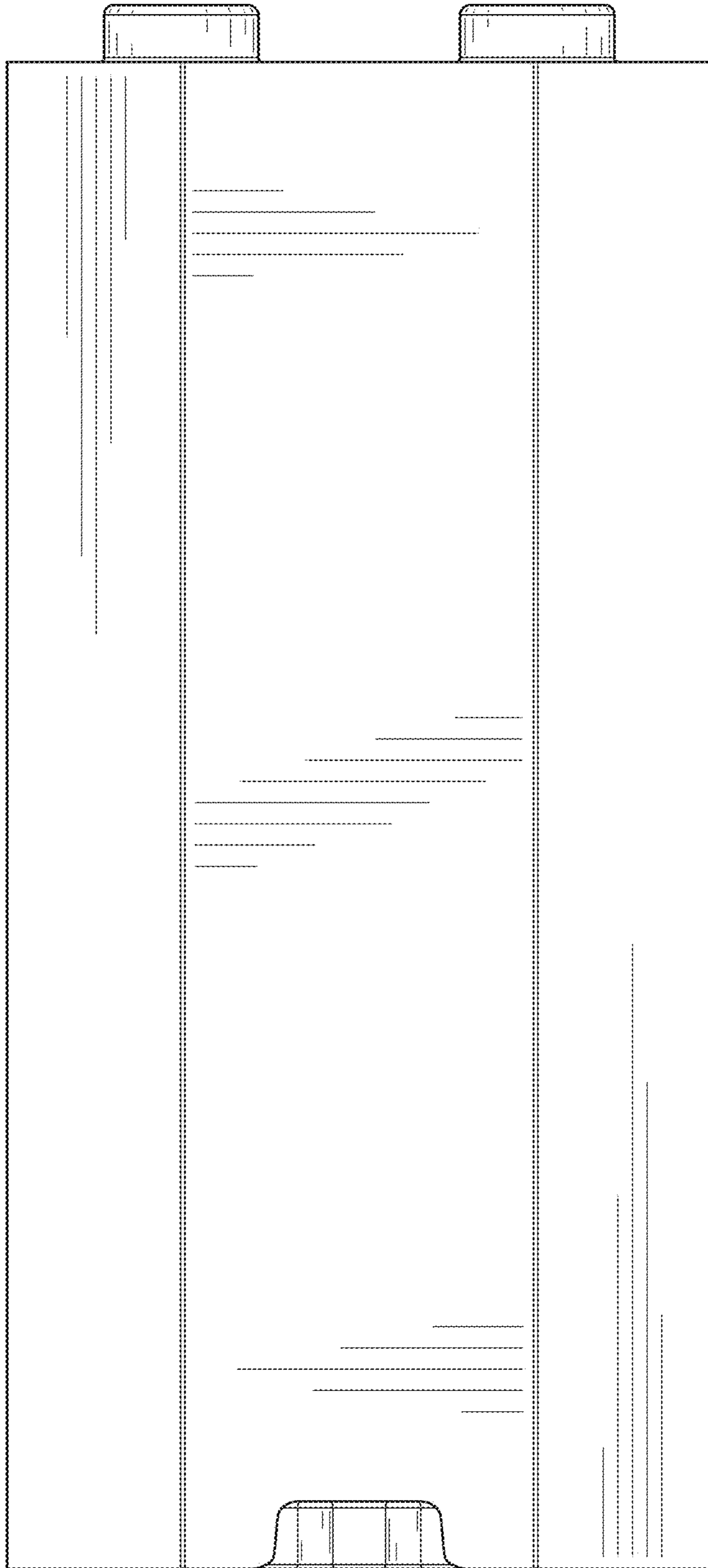

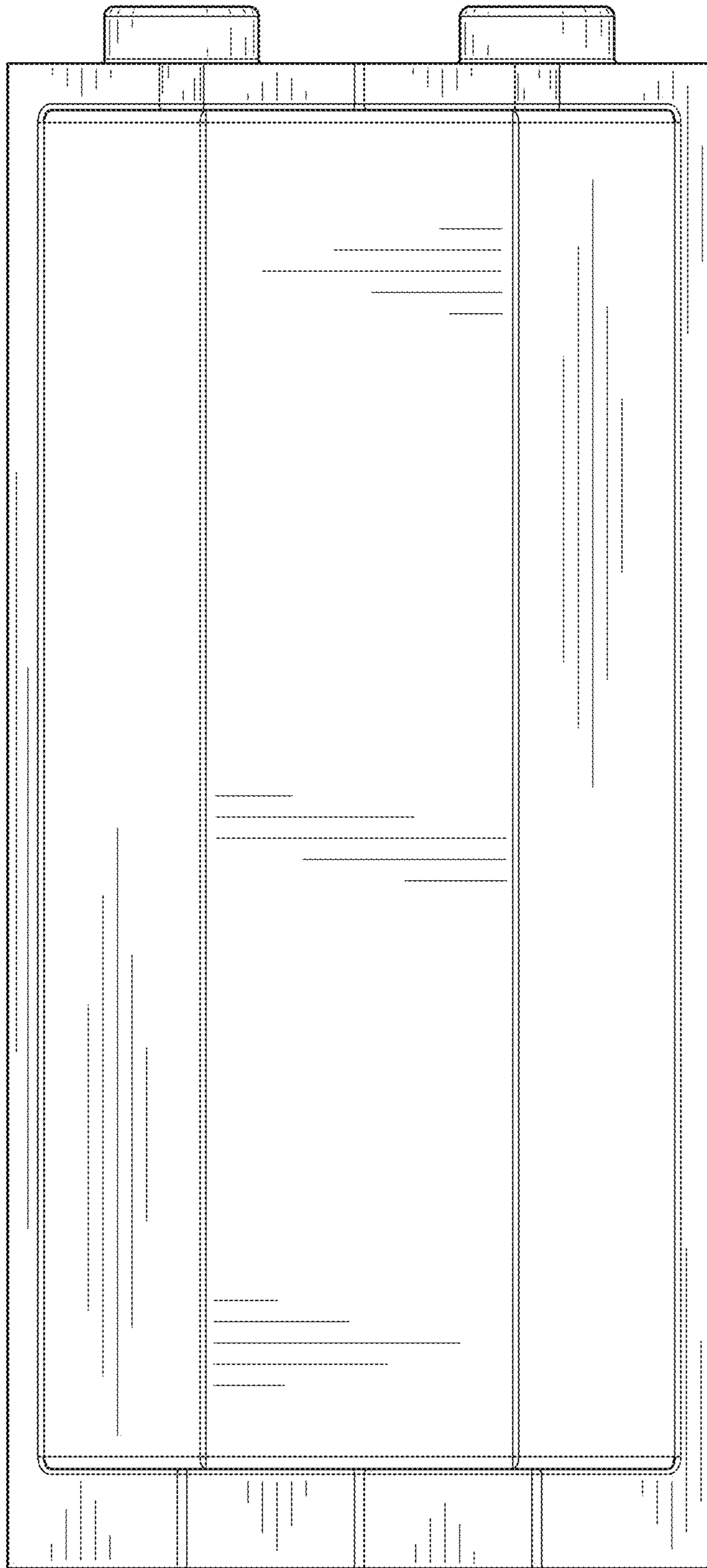

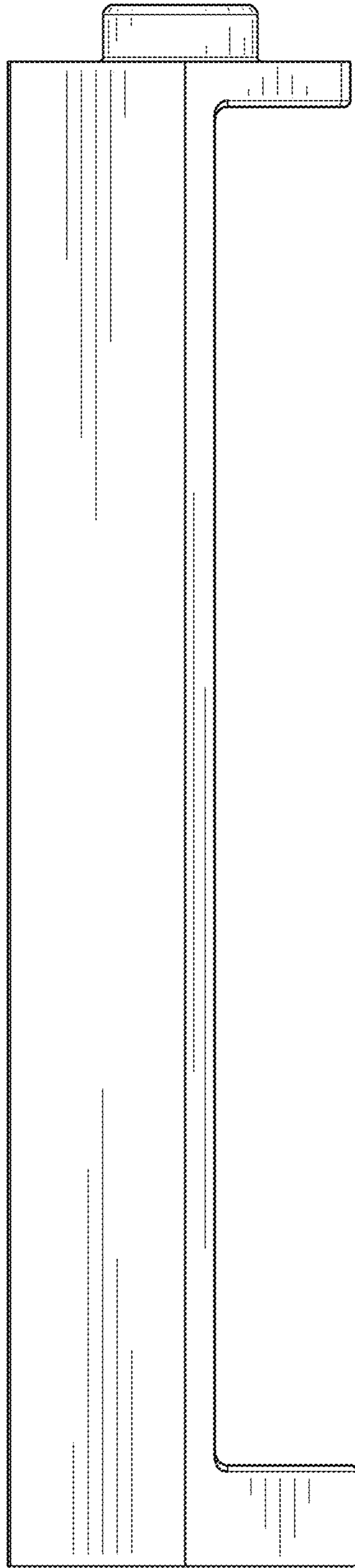

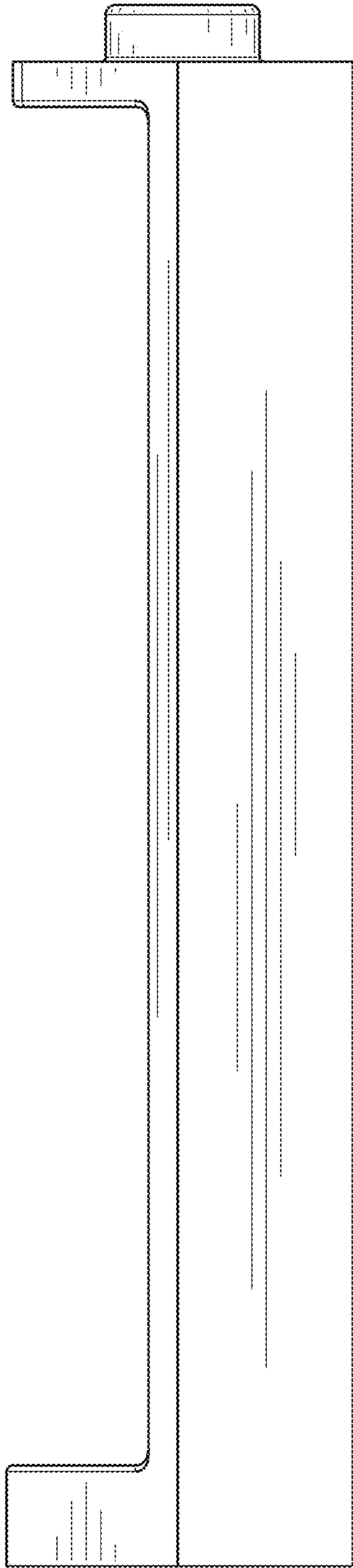

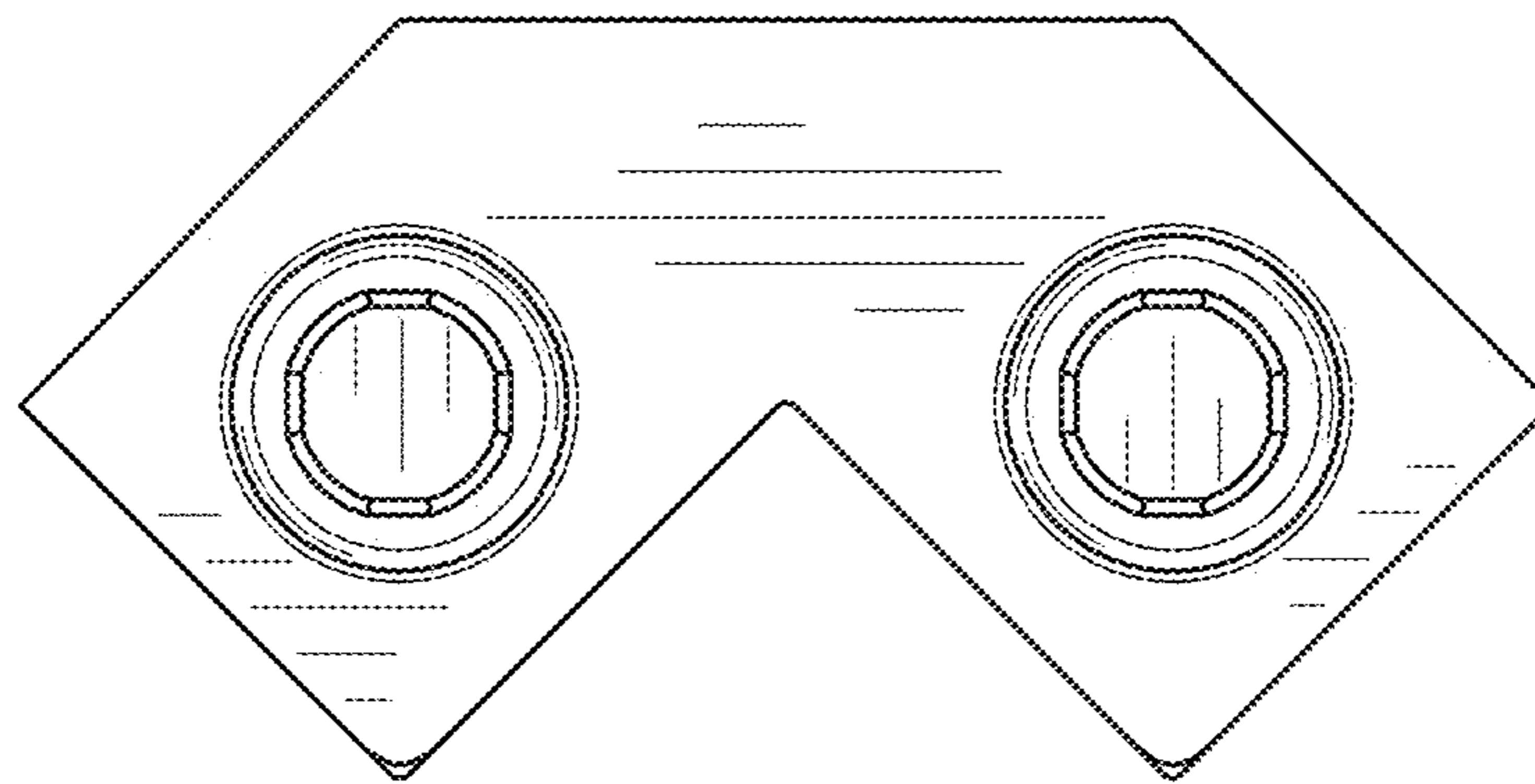

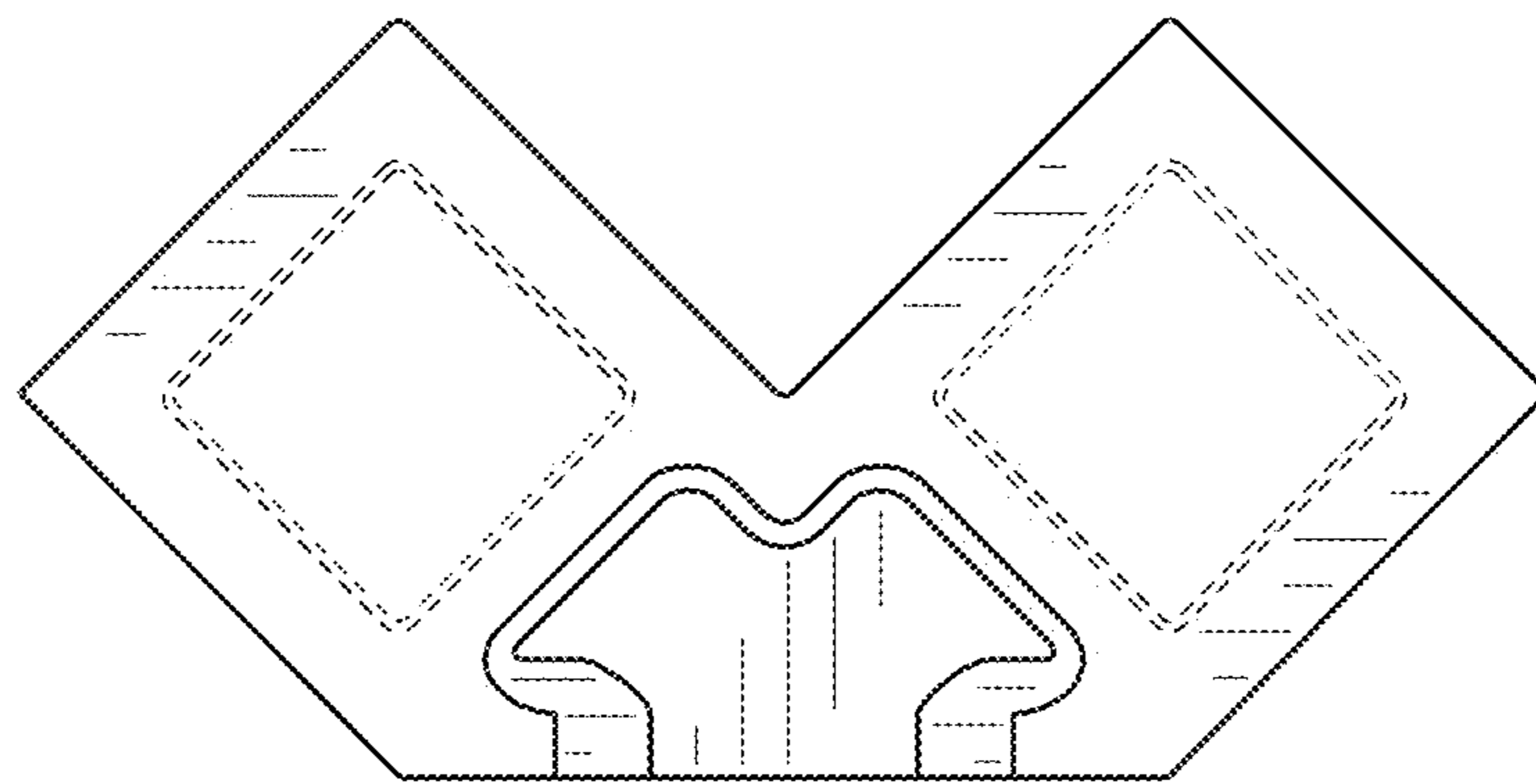
