**DESCRIPTION**

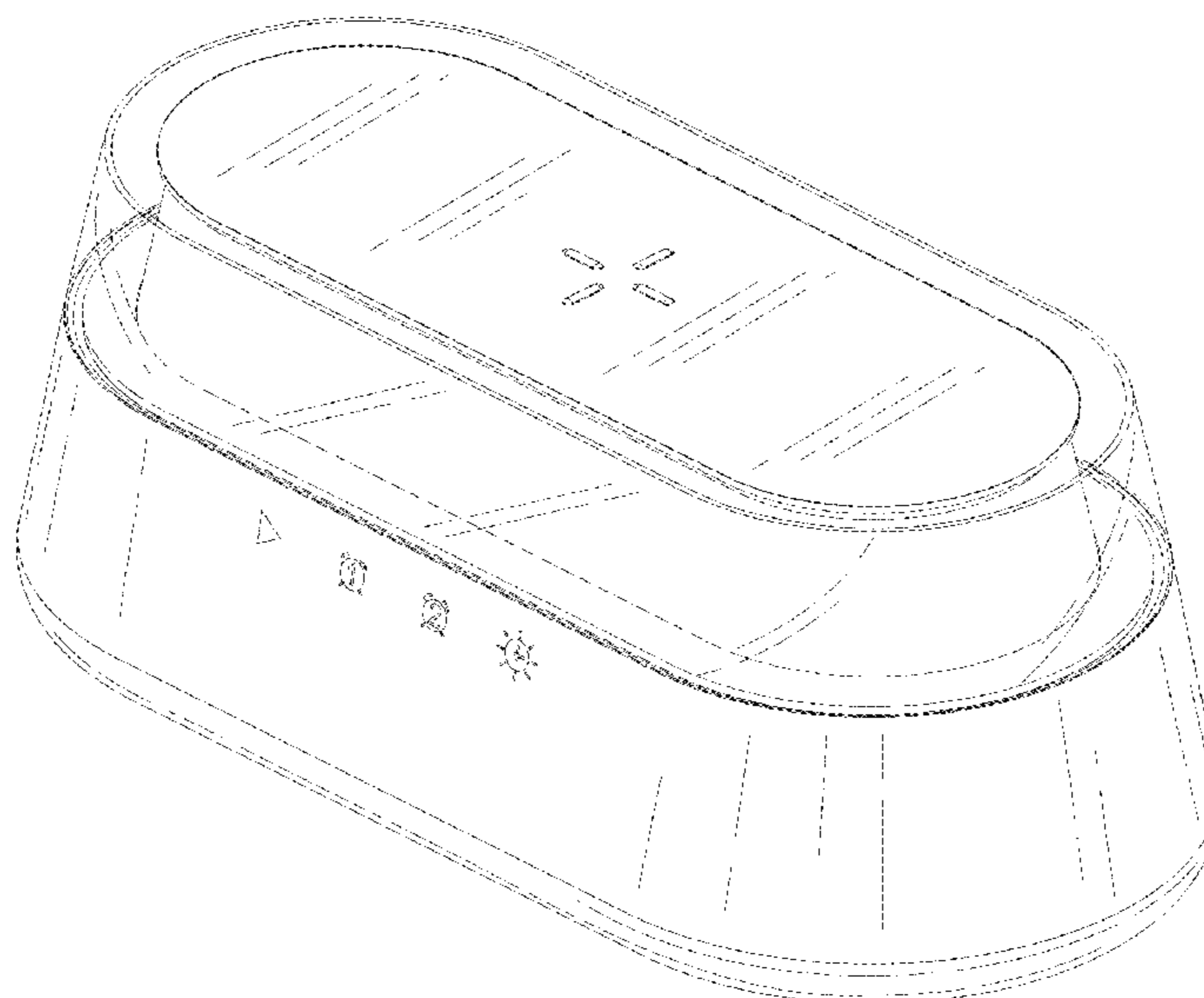
FIG. 1 is a front, right and top perspective view of a wireless charging lamp, showing my new design;

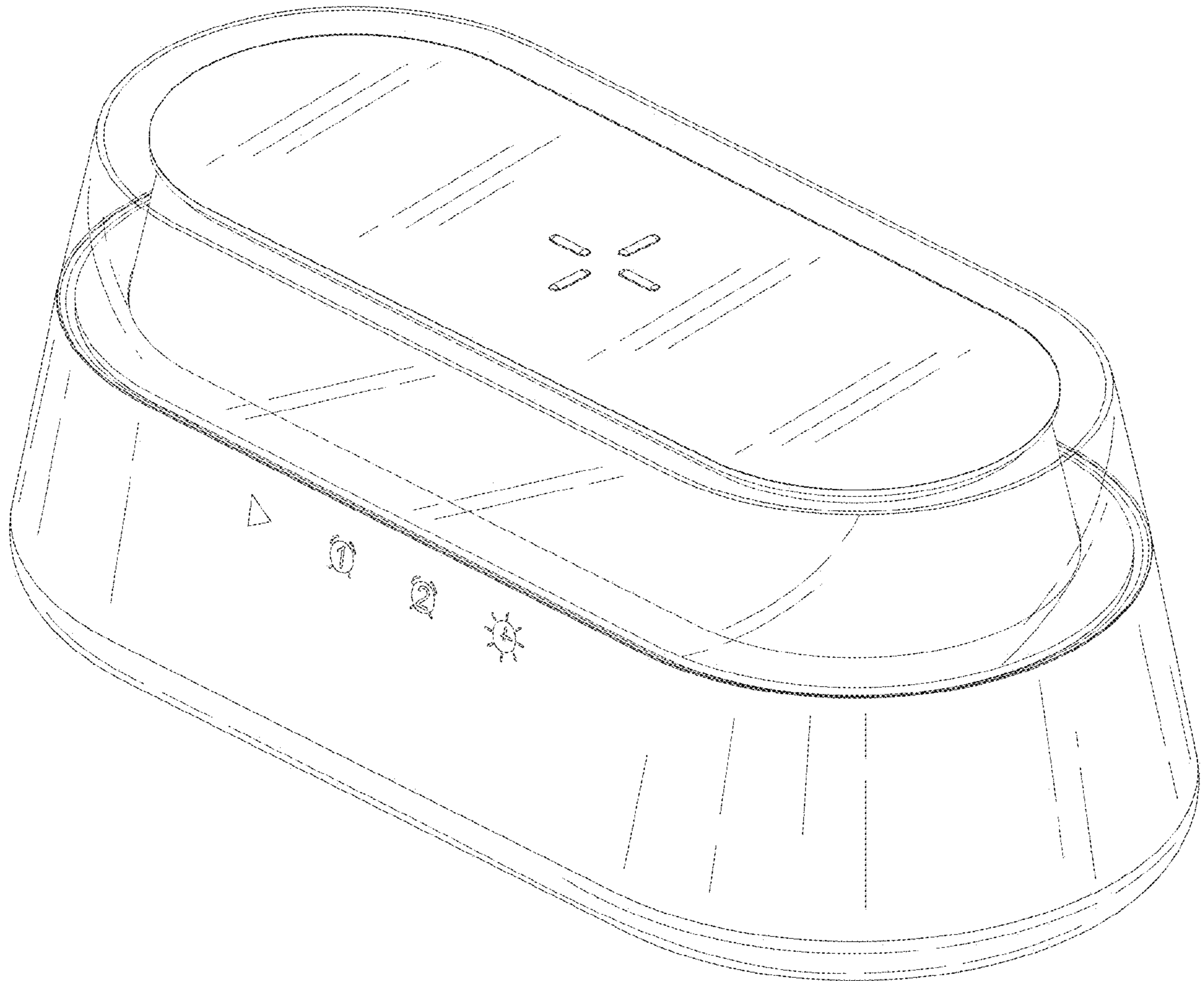

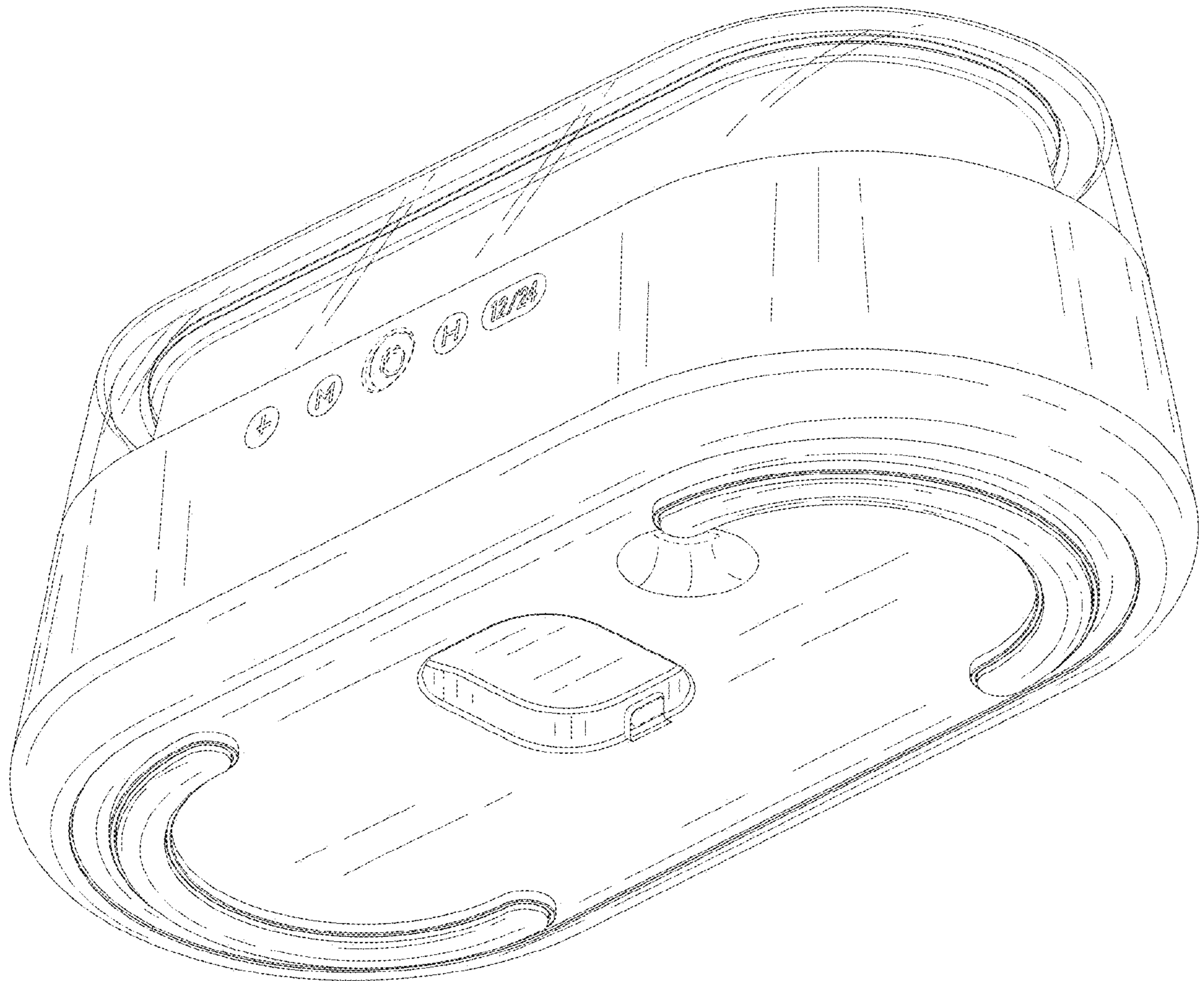

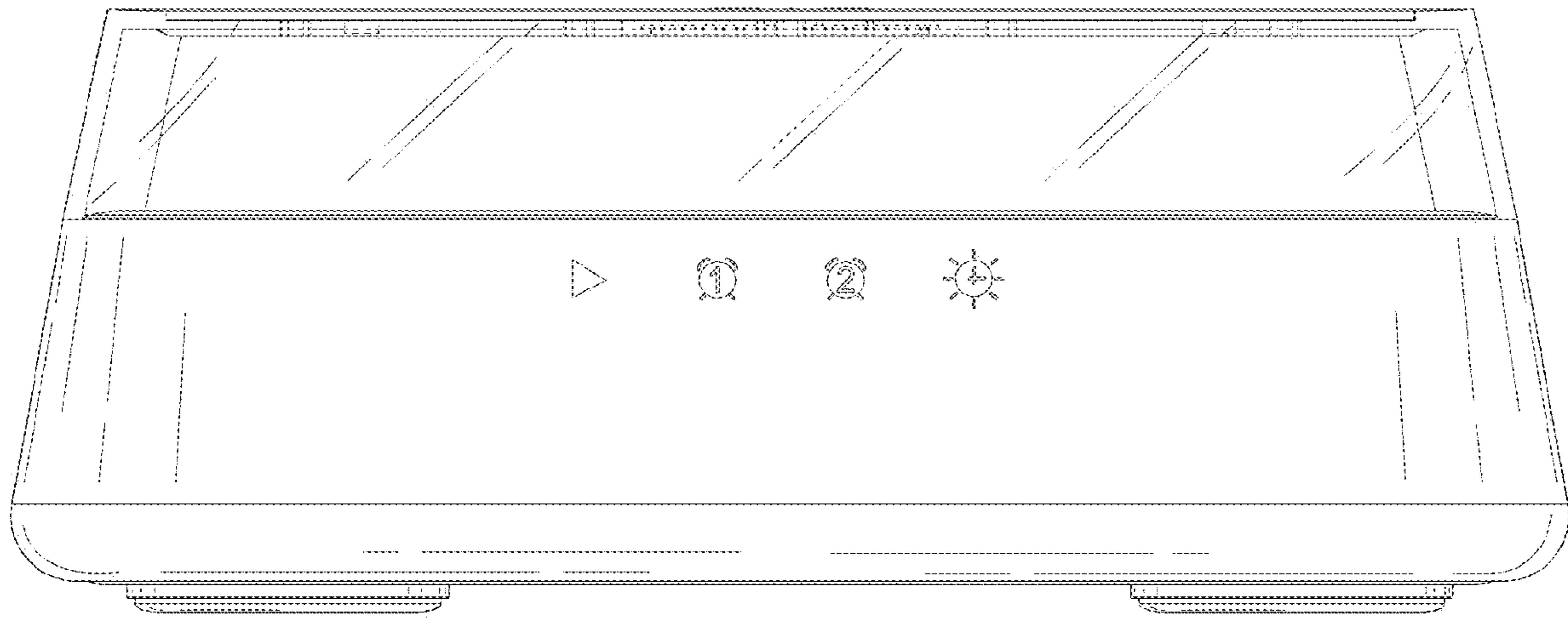

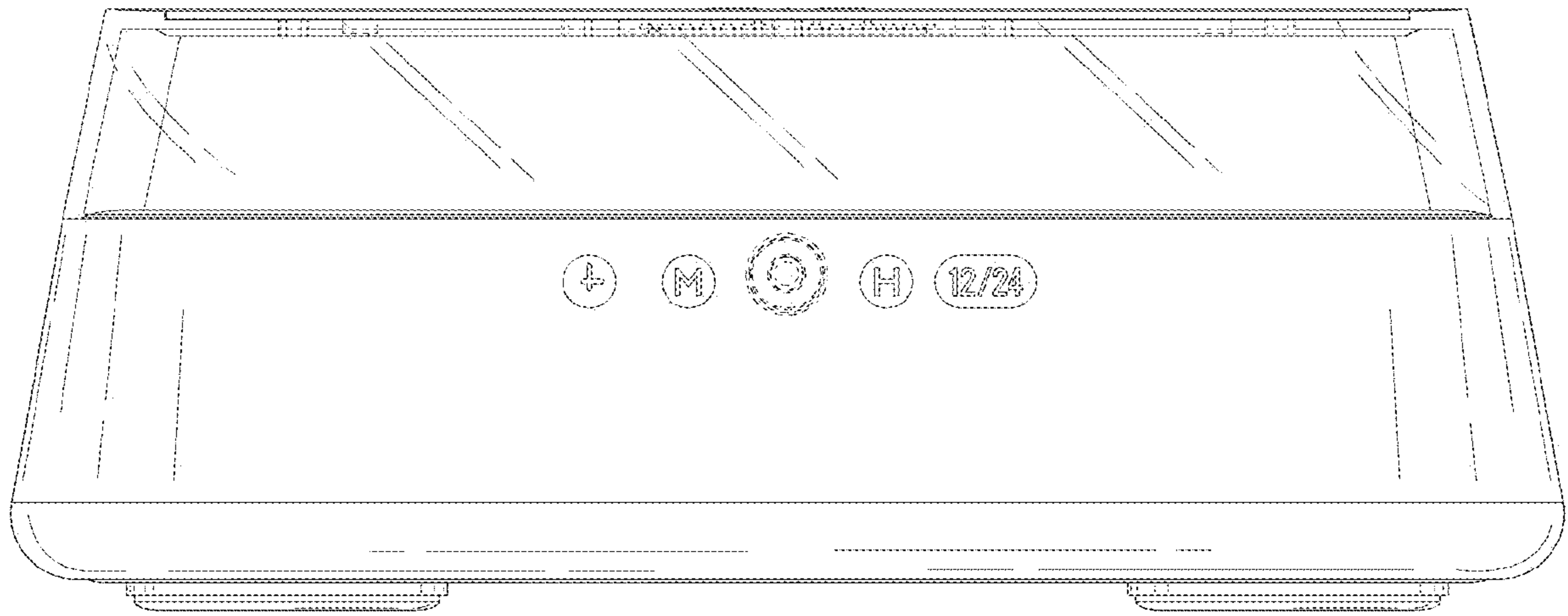

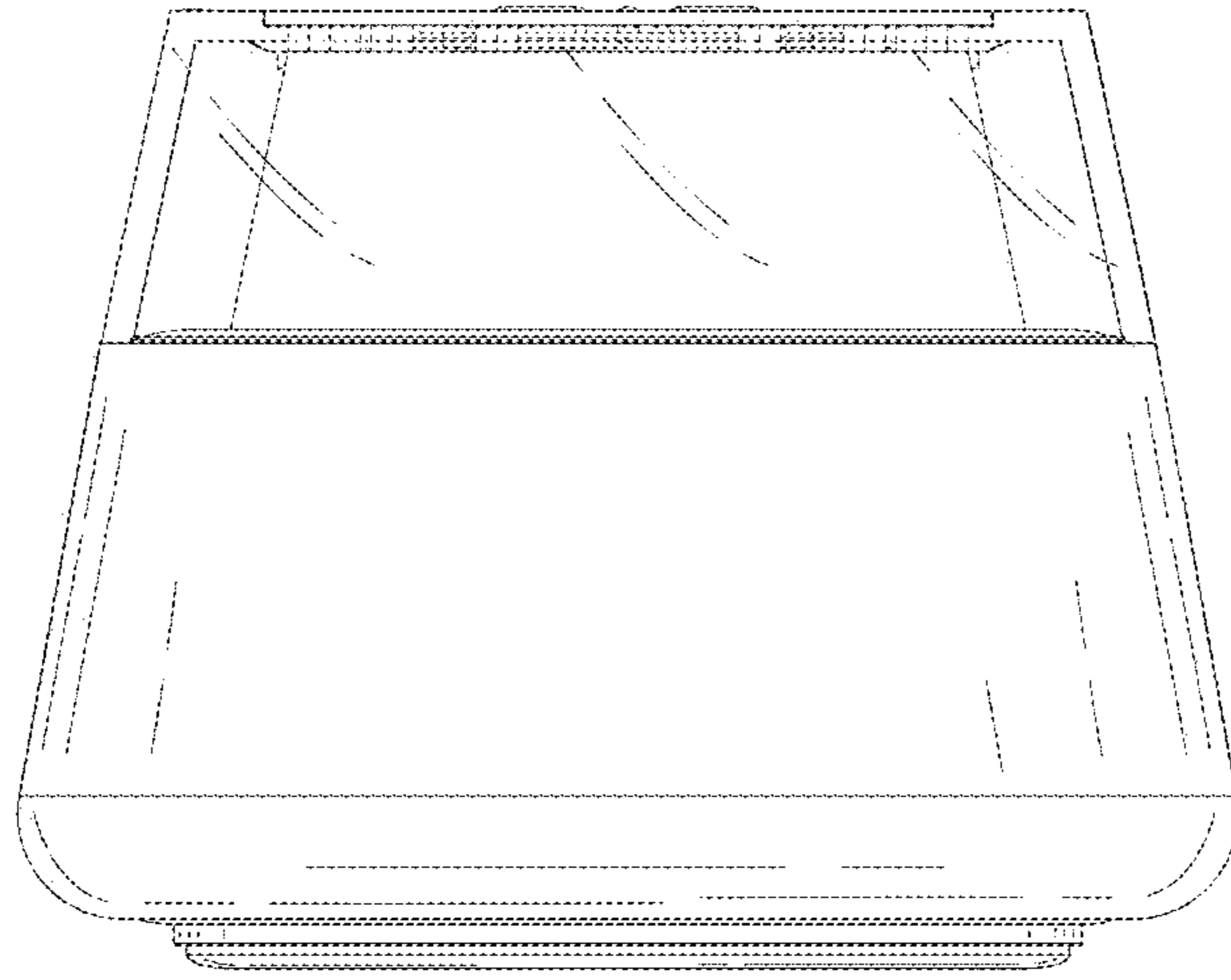

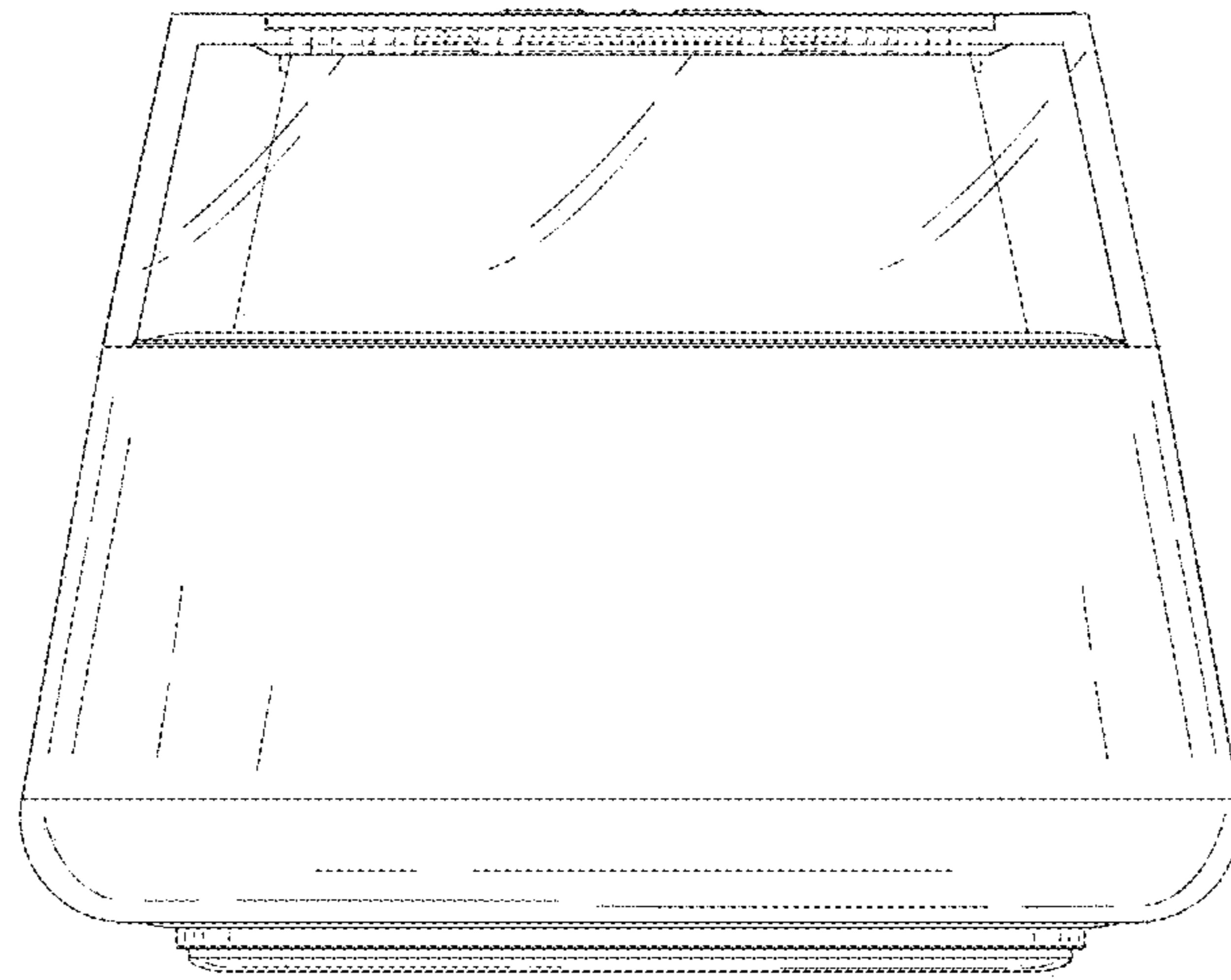

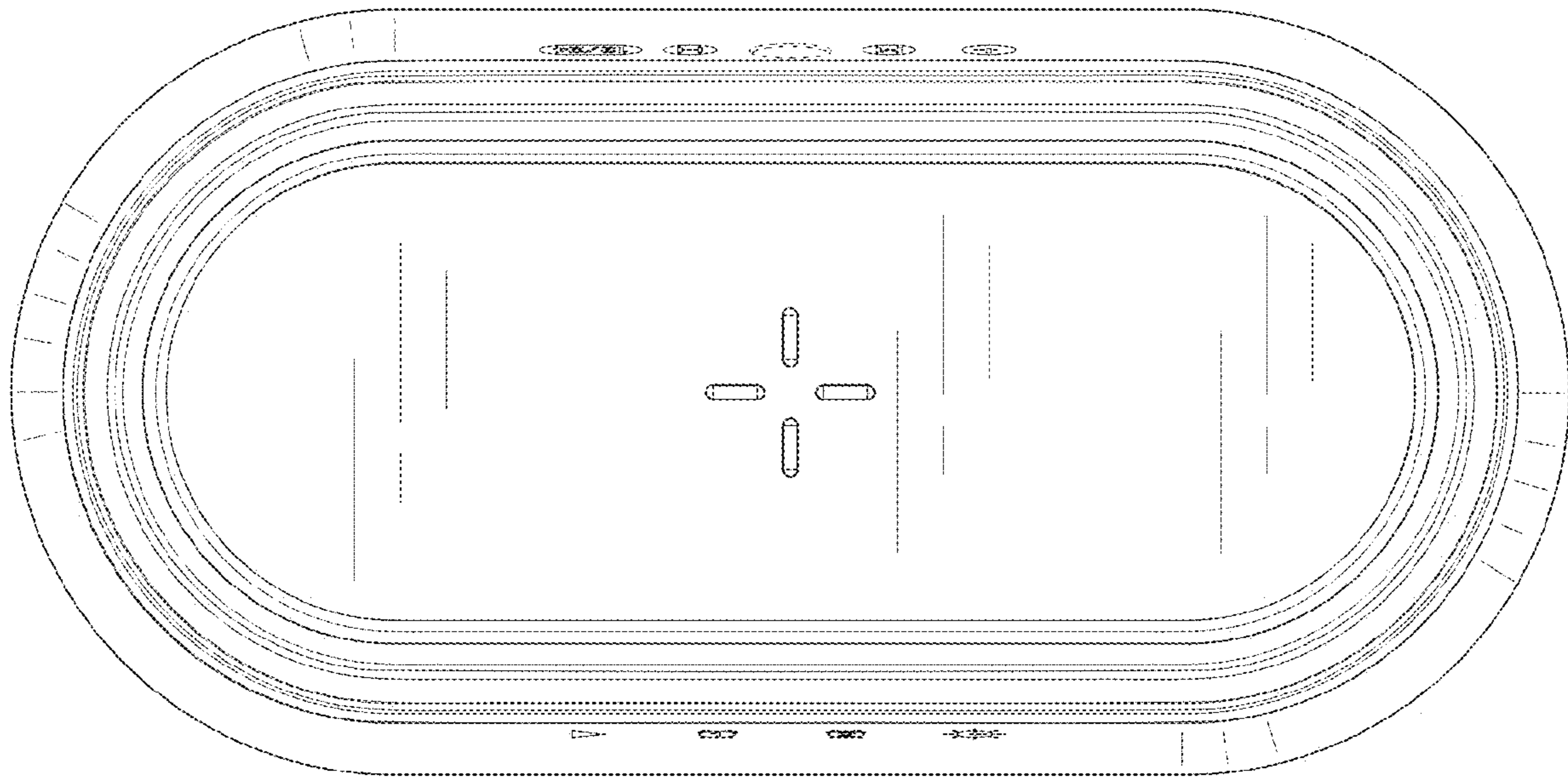

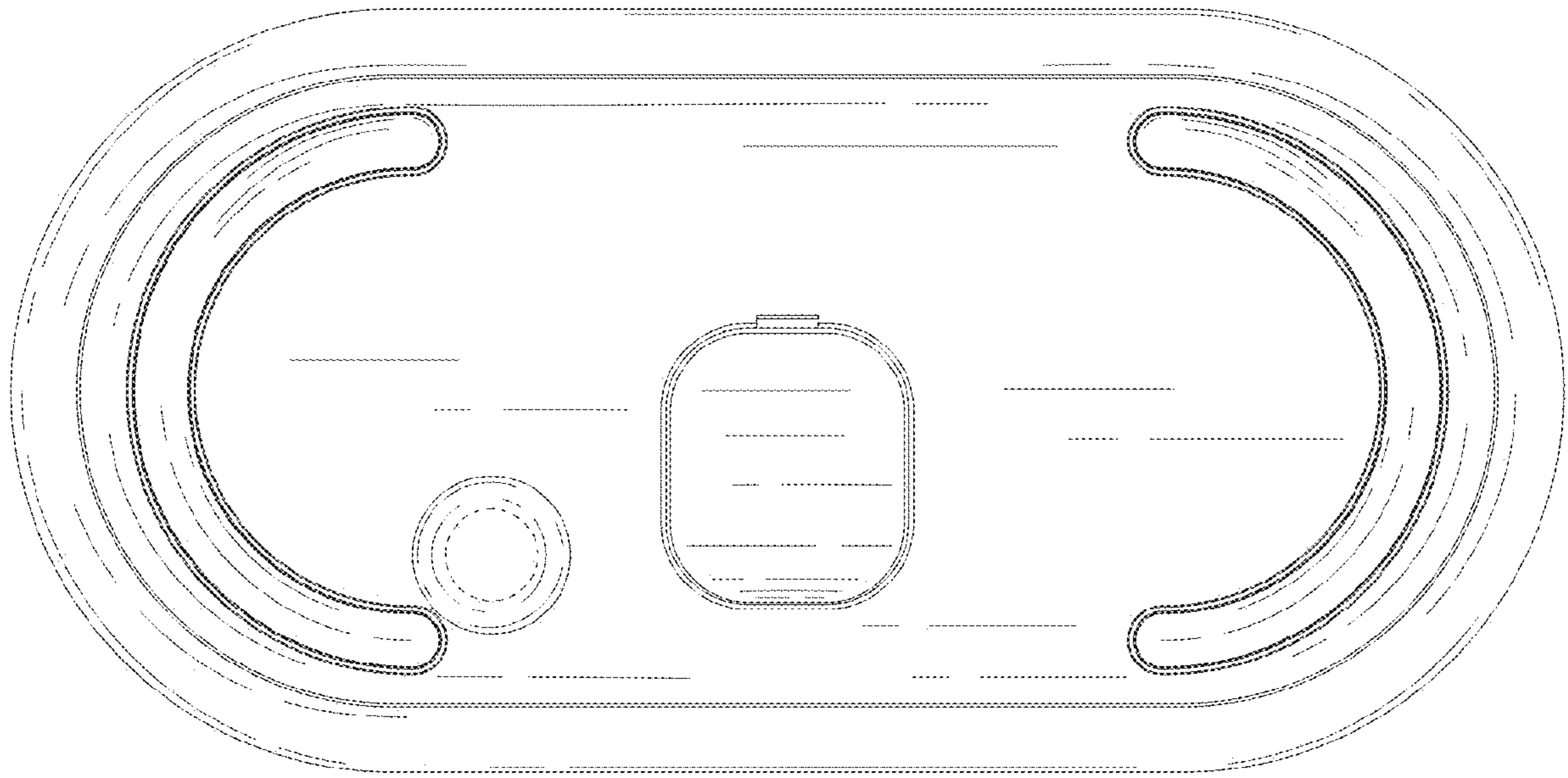
