(57) **CLAIM**

The ornamental design for a multi-function pore extractor, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front-left perspective view of a multi-function pore extractor showing our new design; FIG. 2 is a bottom-rear-right perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is an enlarged top plan view thereof; FIG. 6 is an enlarged bottom plan view thereof; FIG. 7 is a right elevational view thereof; and, FIG. 8 is a left elevational view thereof.

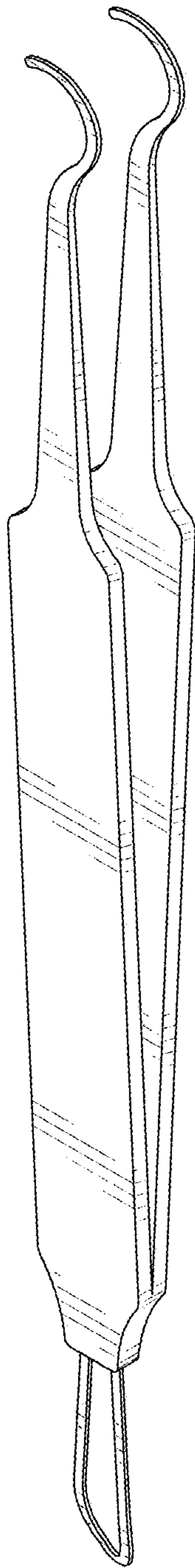

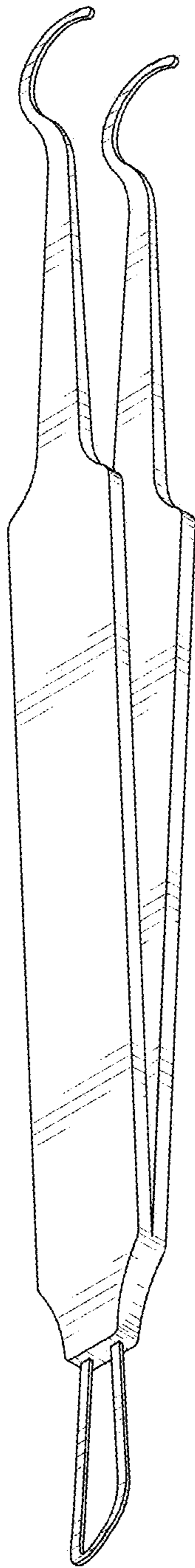

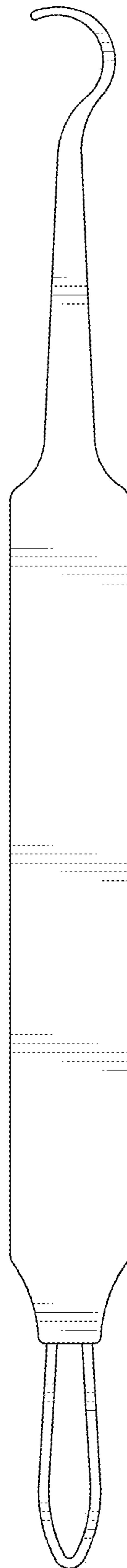

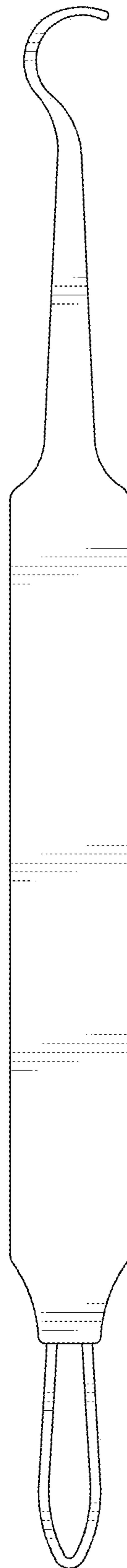

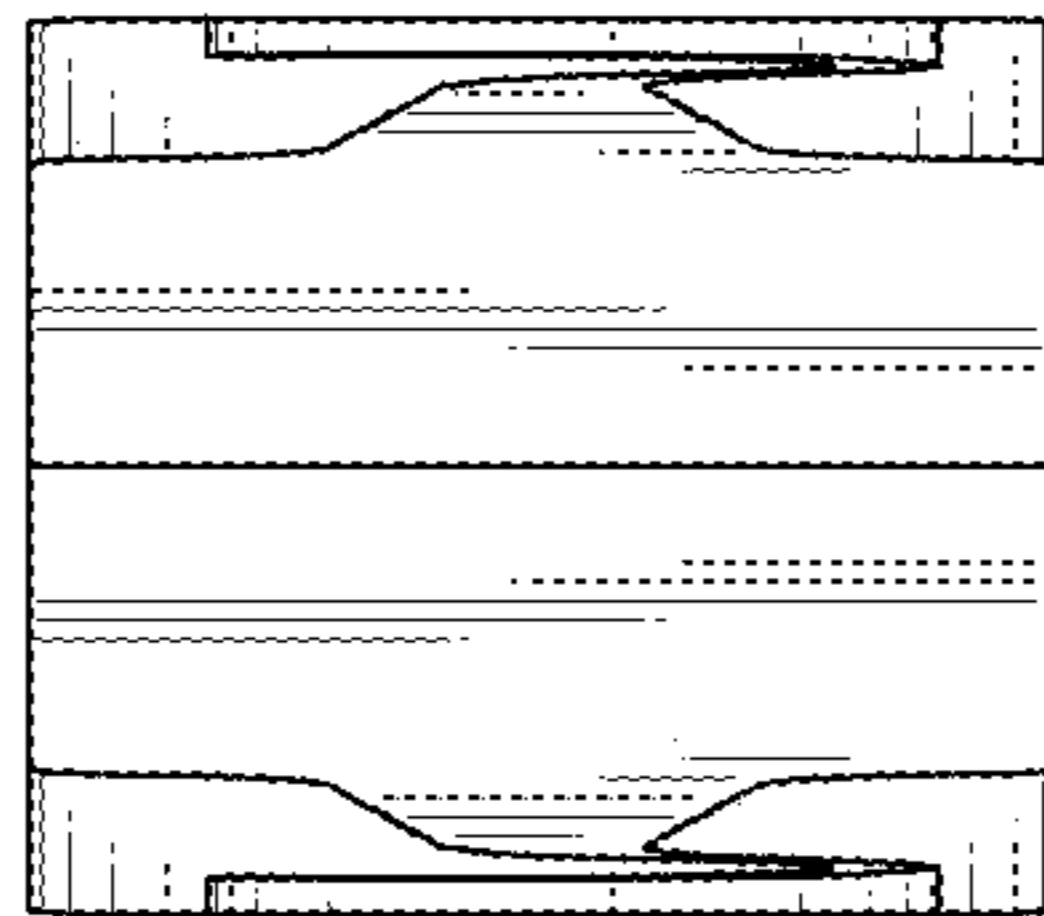

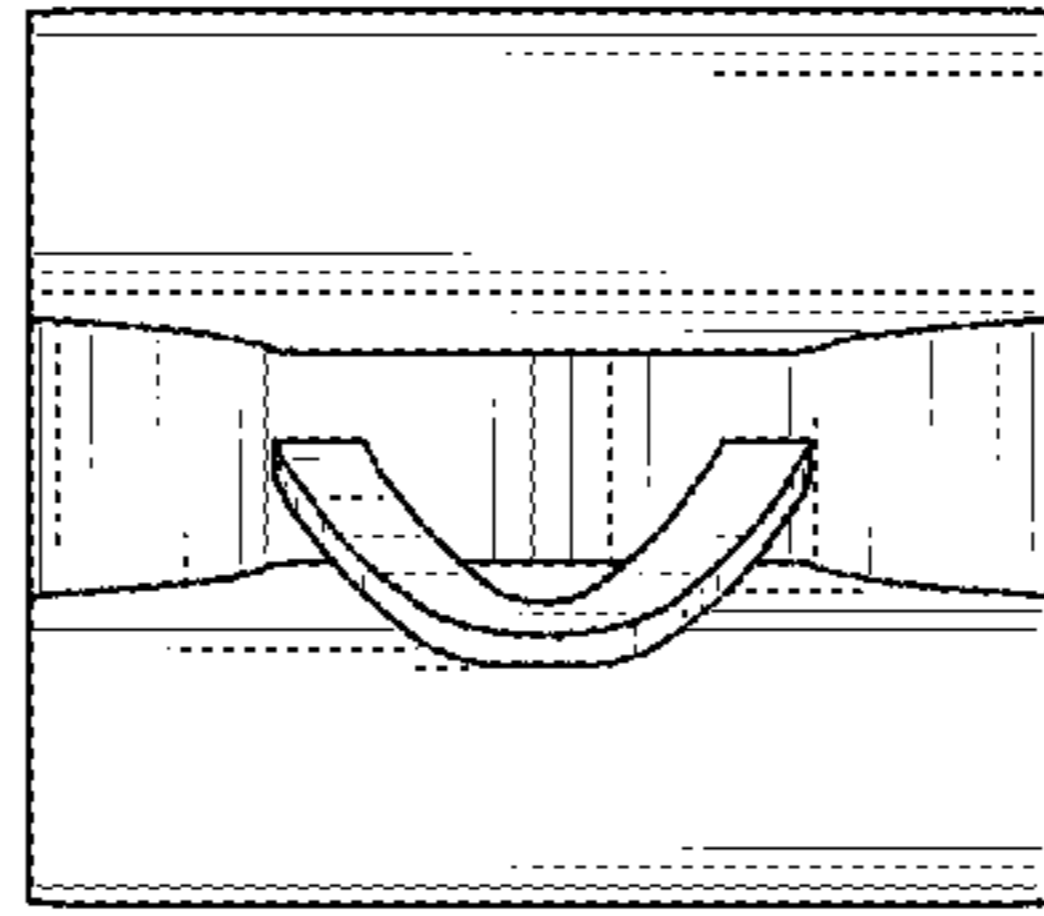

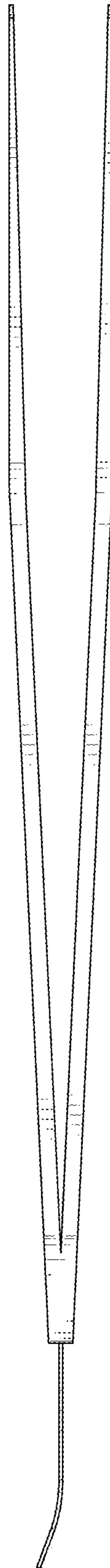

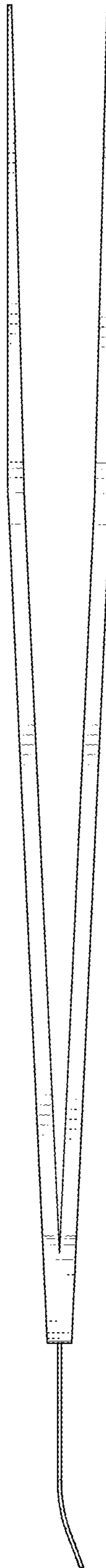
