The ornamental design for a carrying bag with closed top, as shown and described.

DESCRIPTION

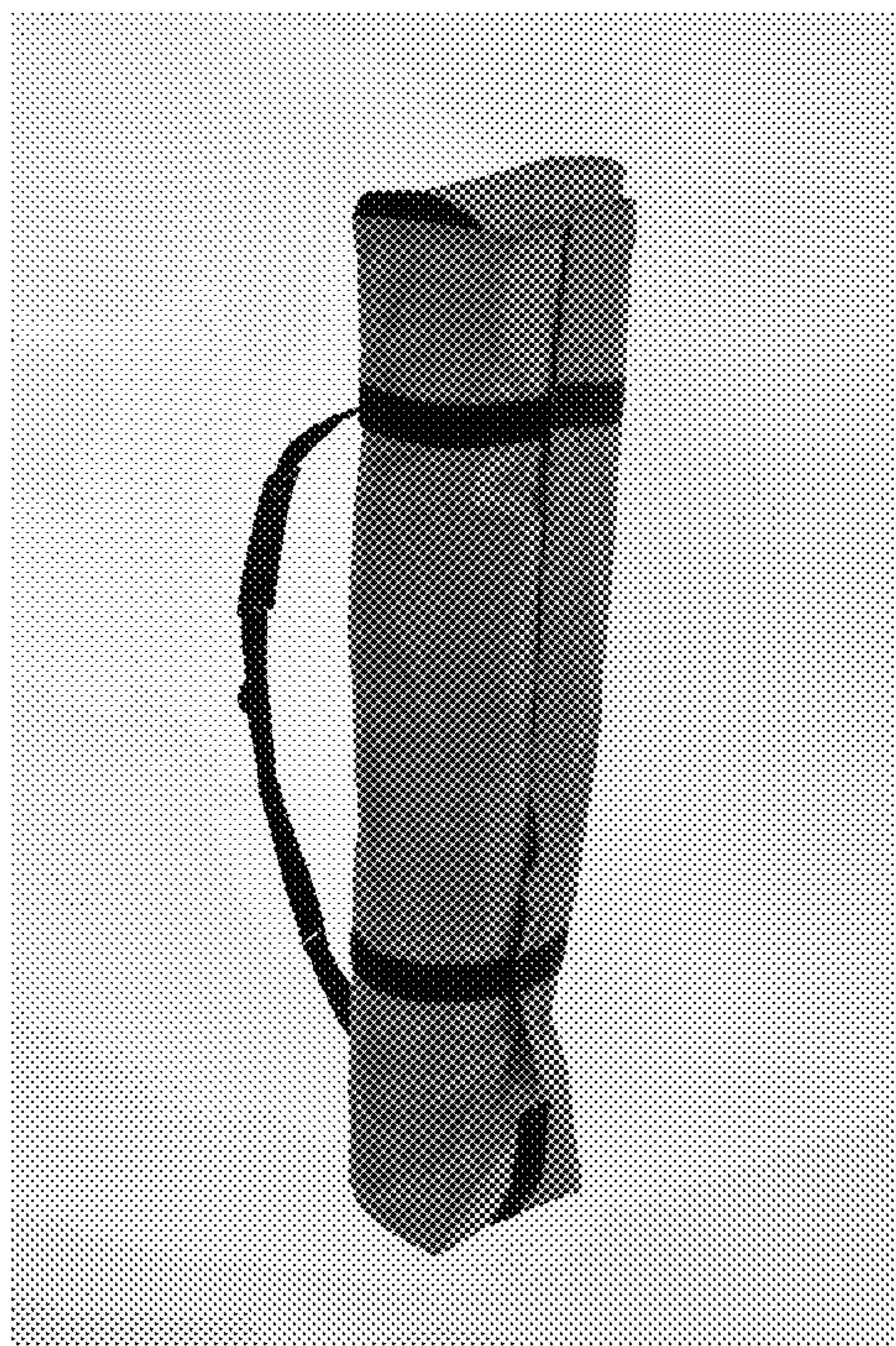

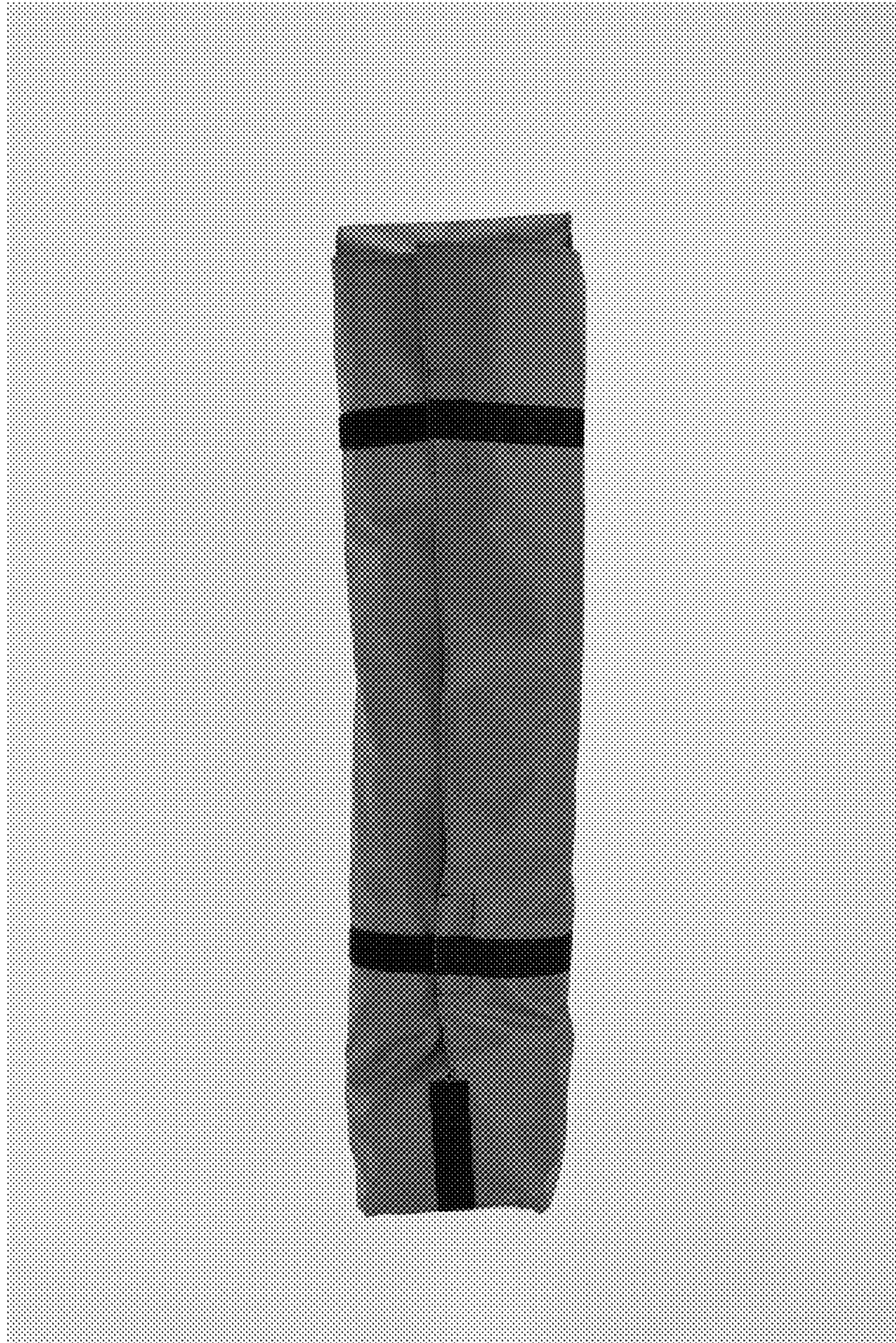

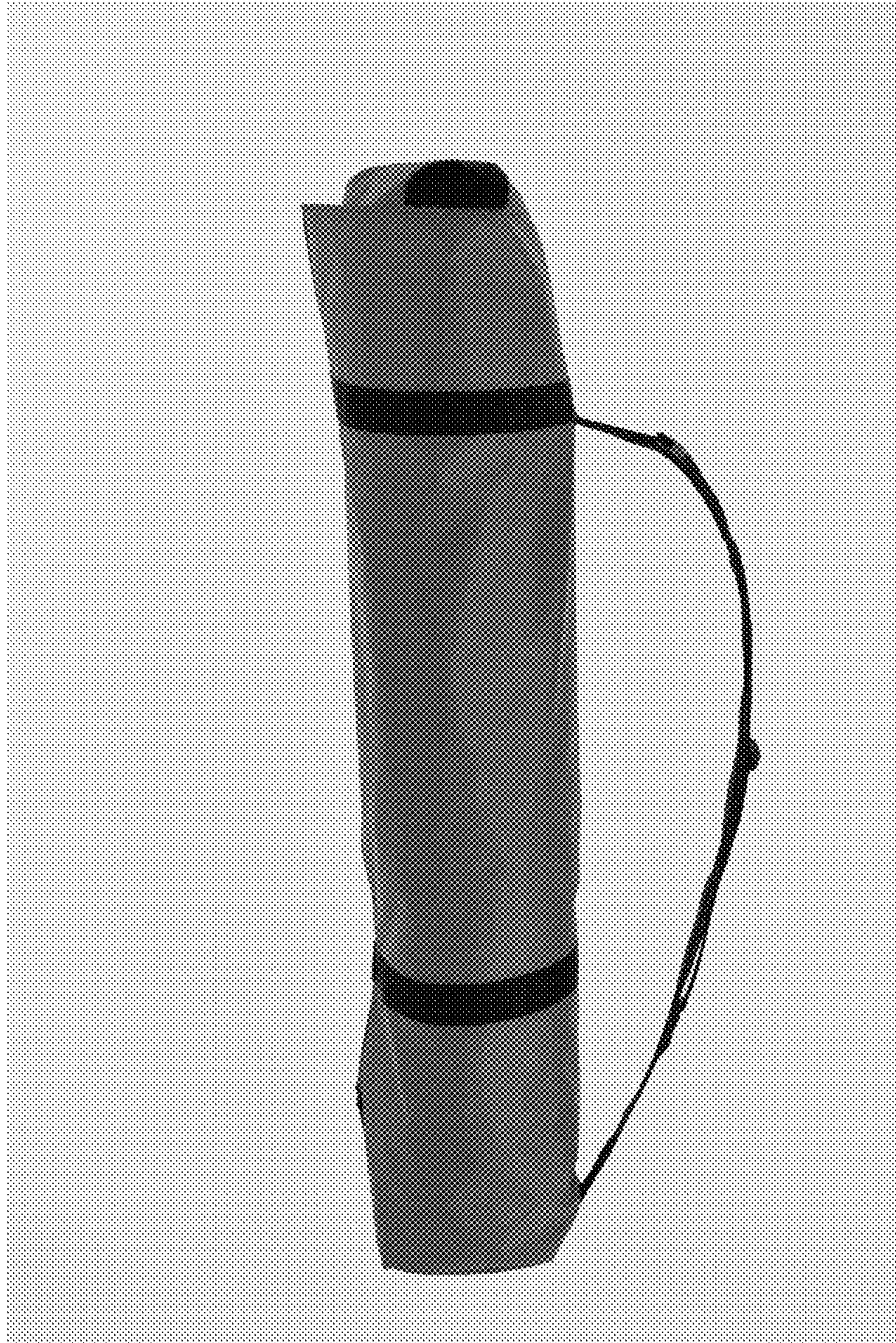

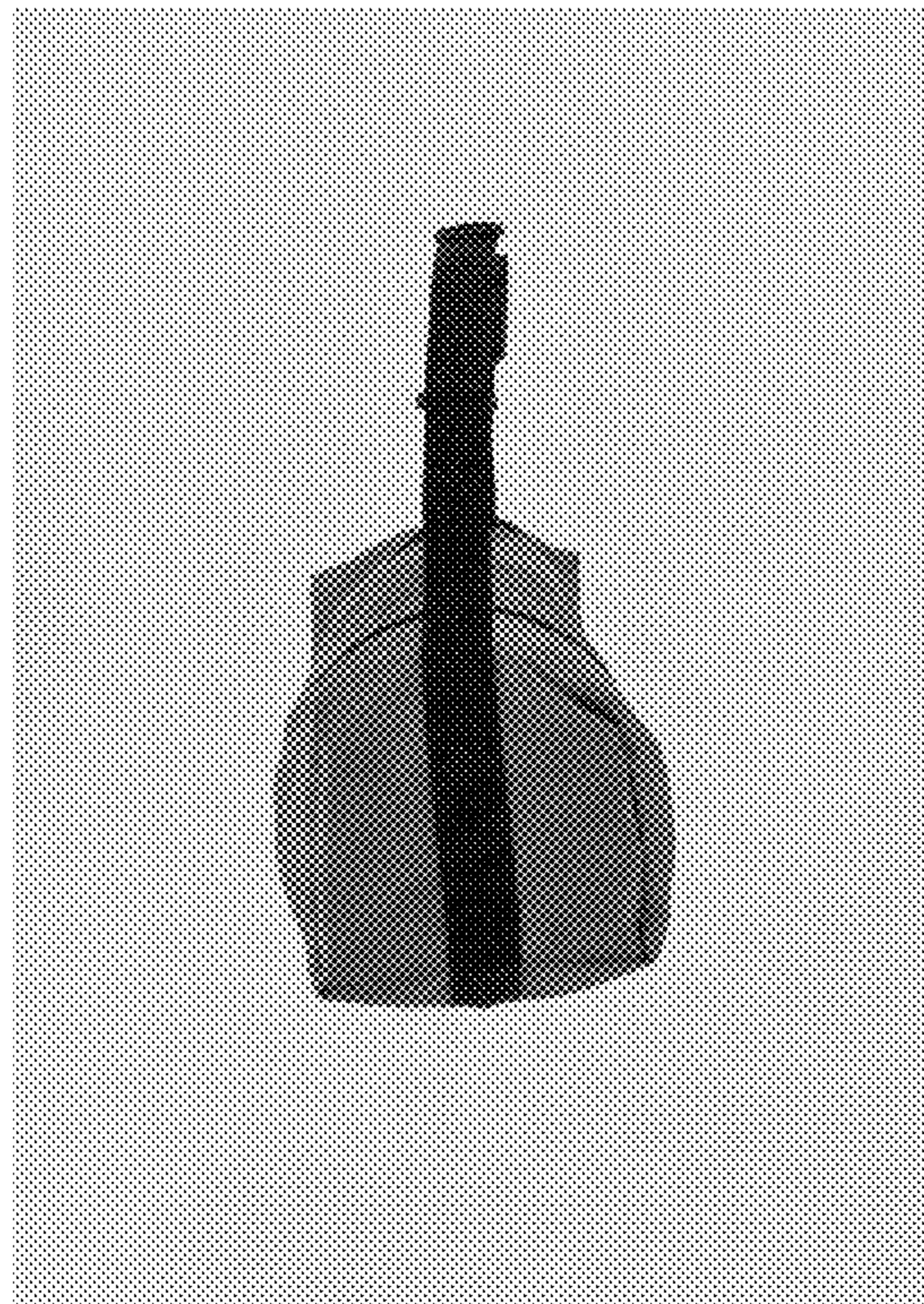

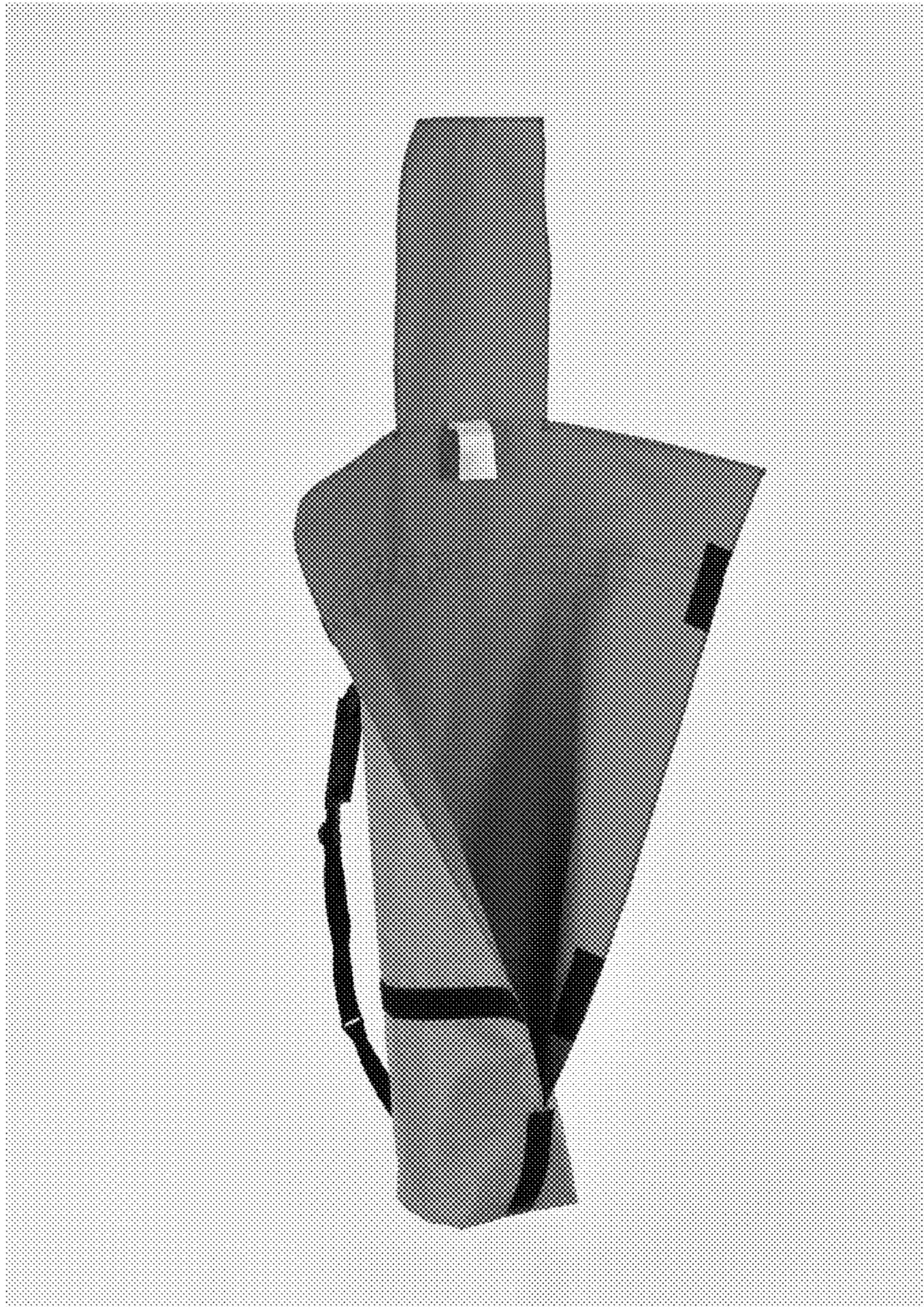

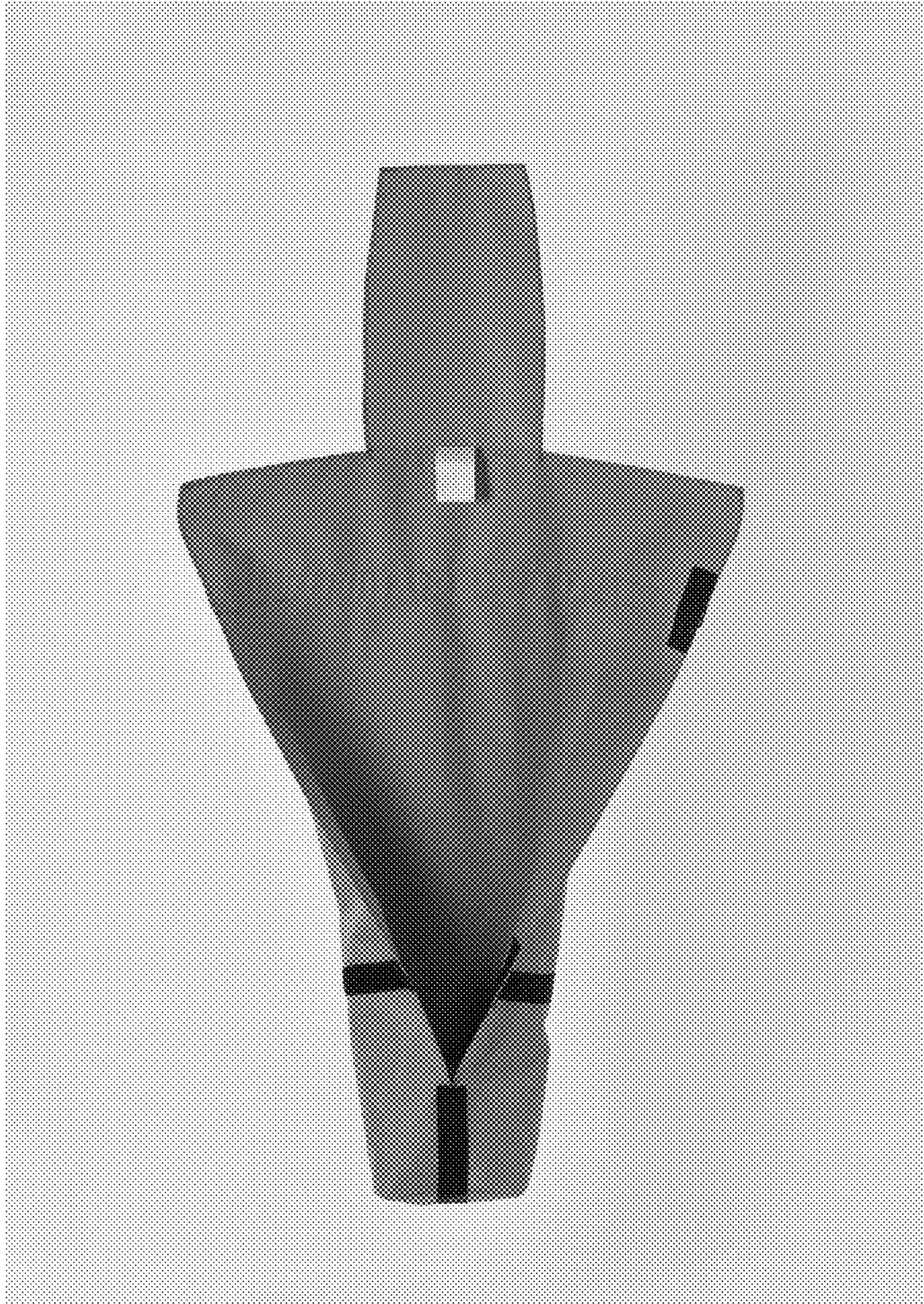

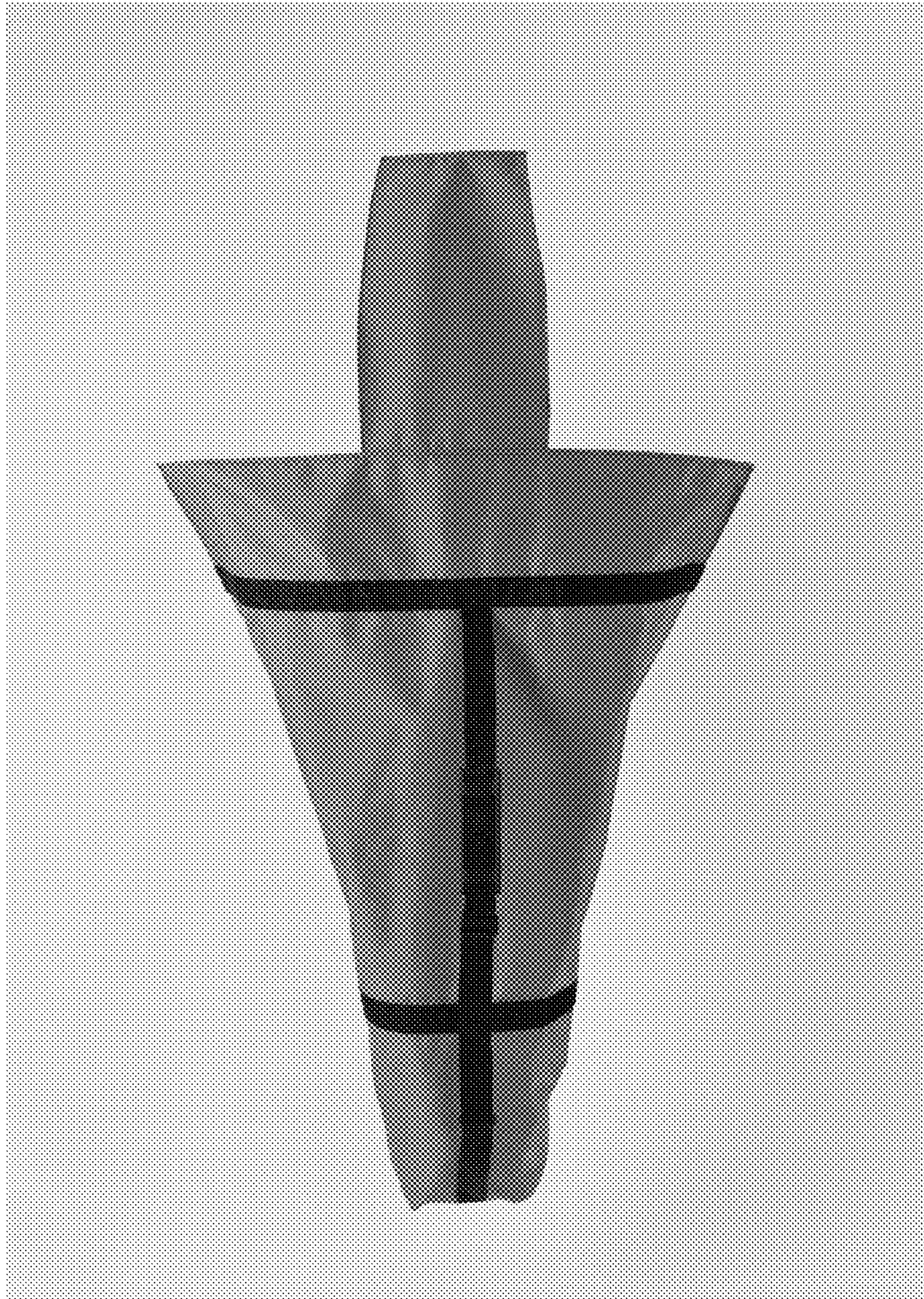

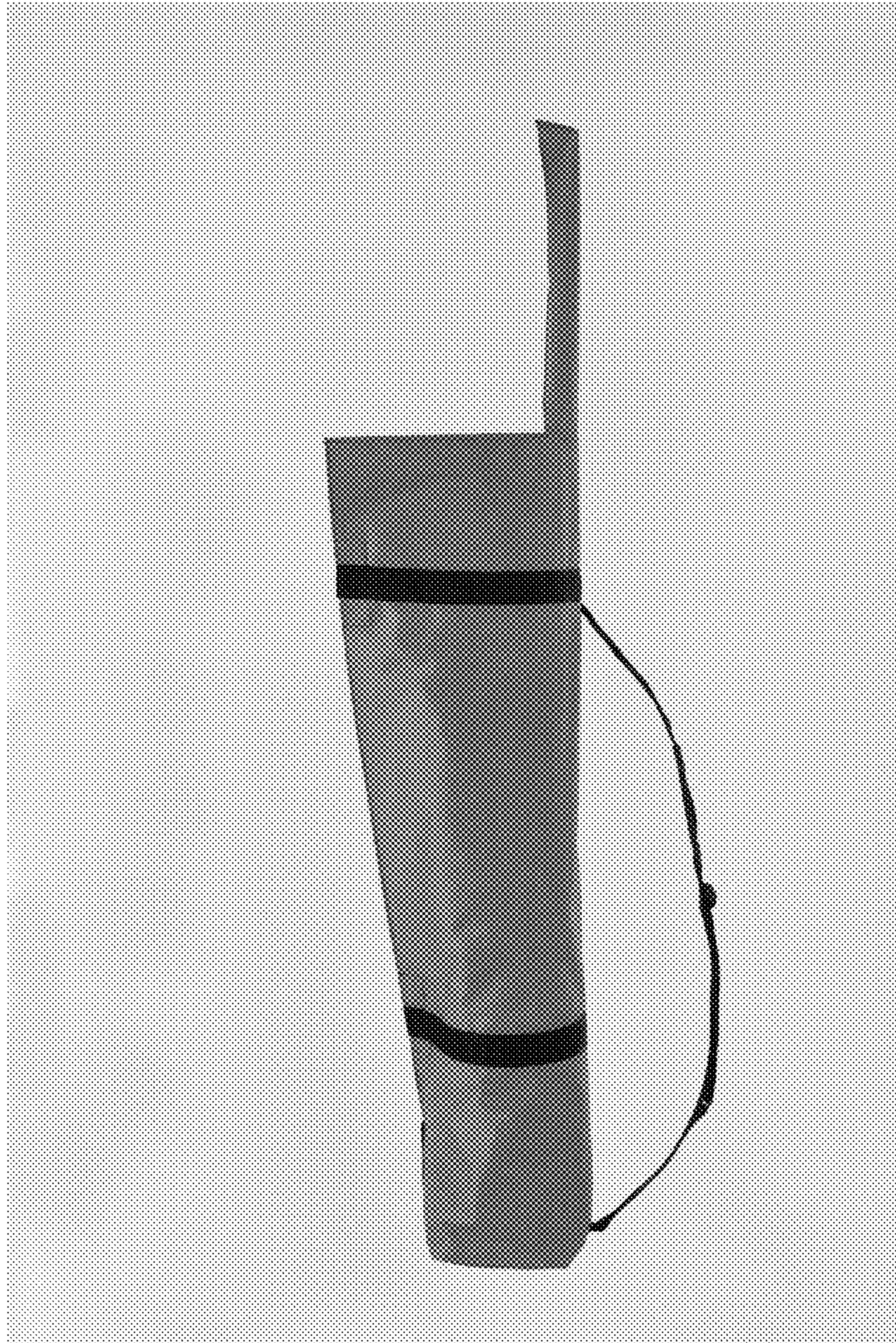

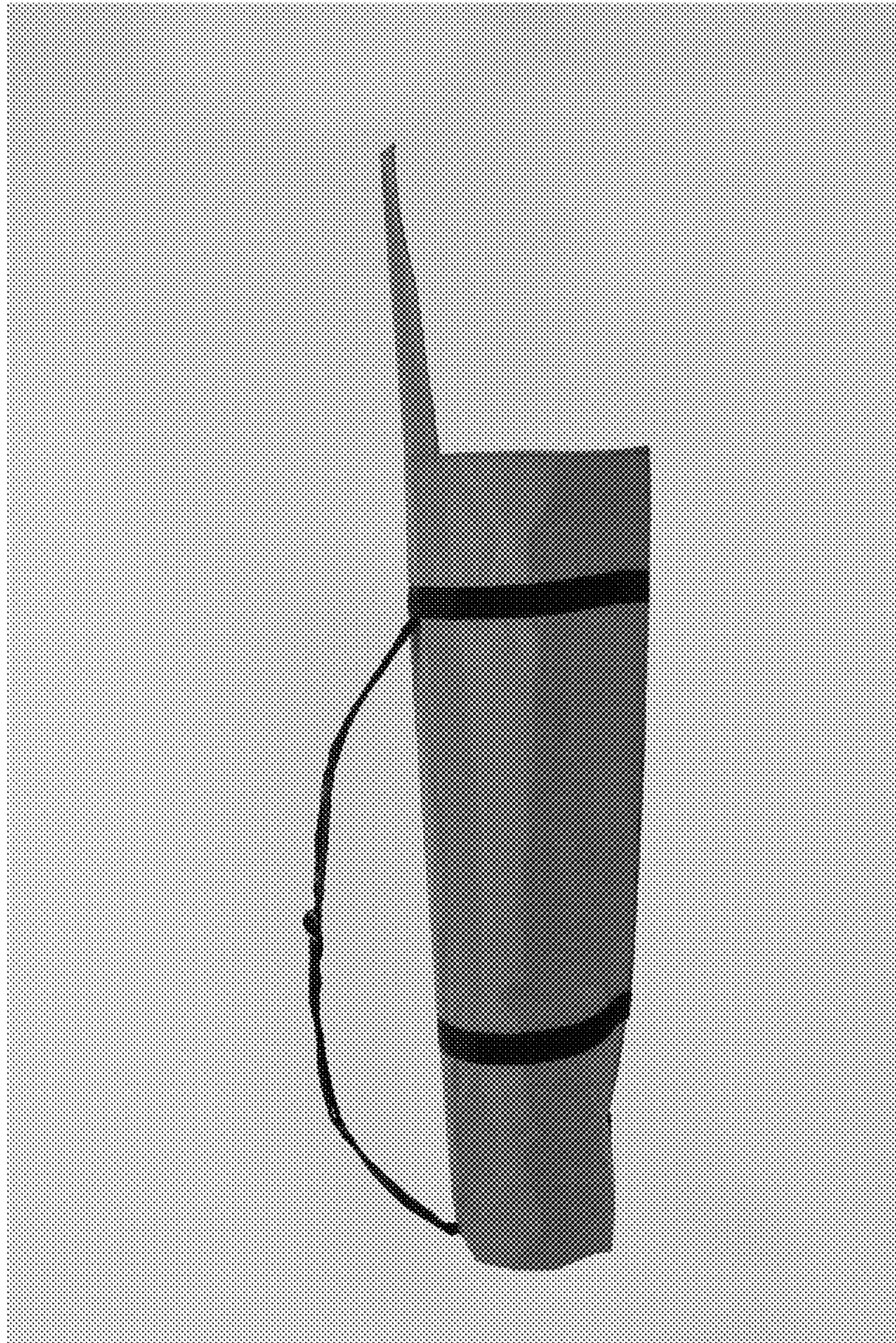
