DESCRIPTION

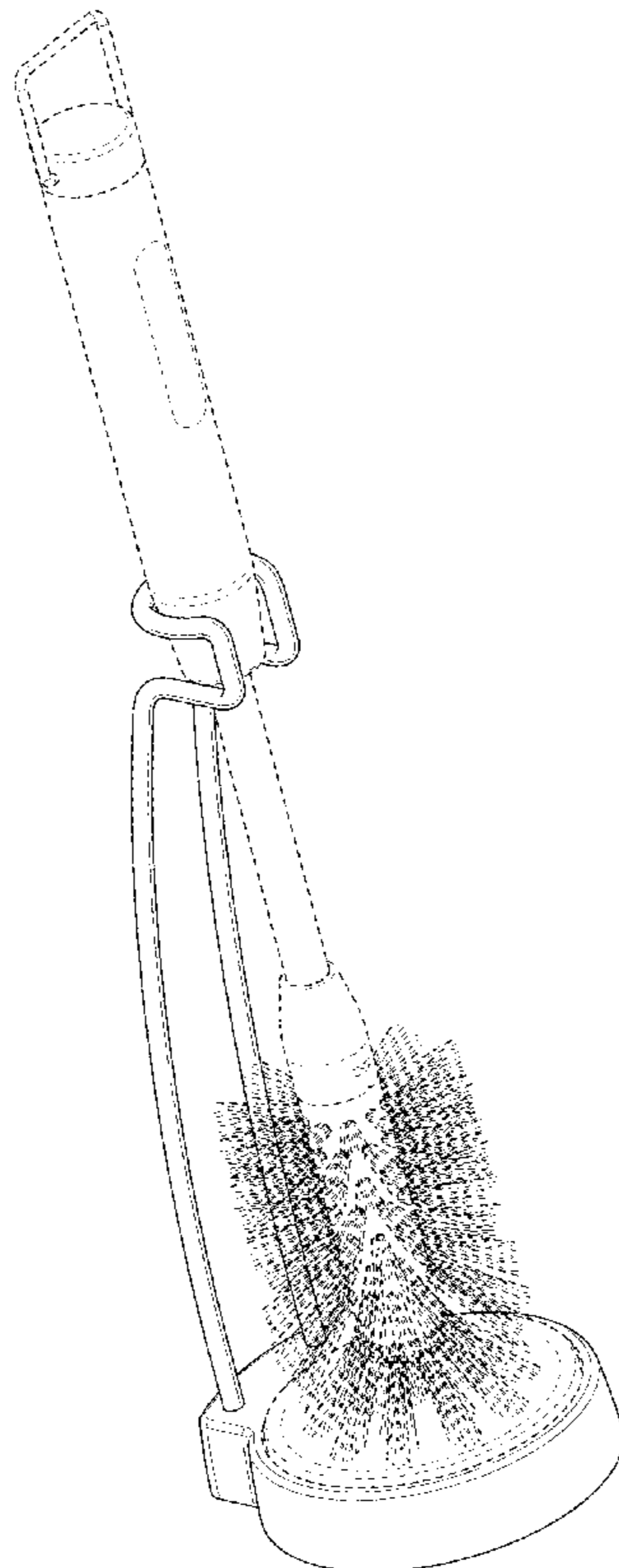
FIG. 1 is a top front perspective view of a brush stand showing the claimed design;

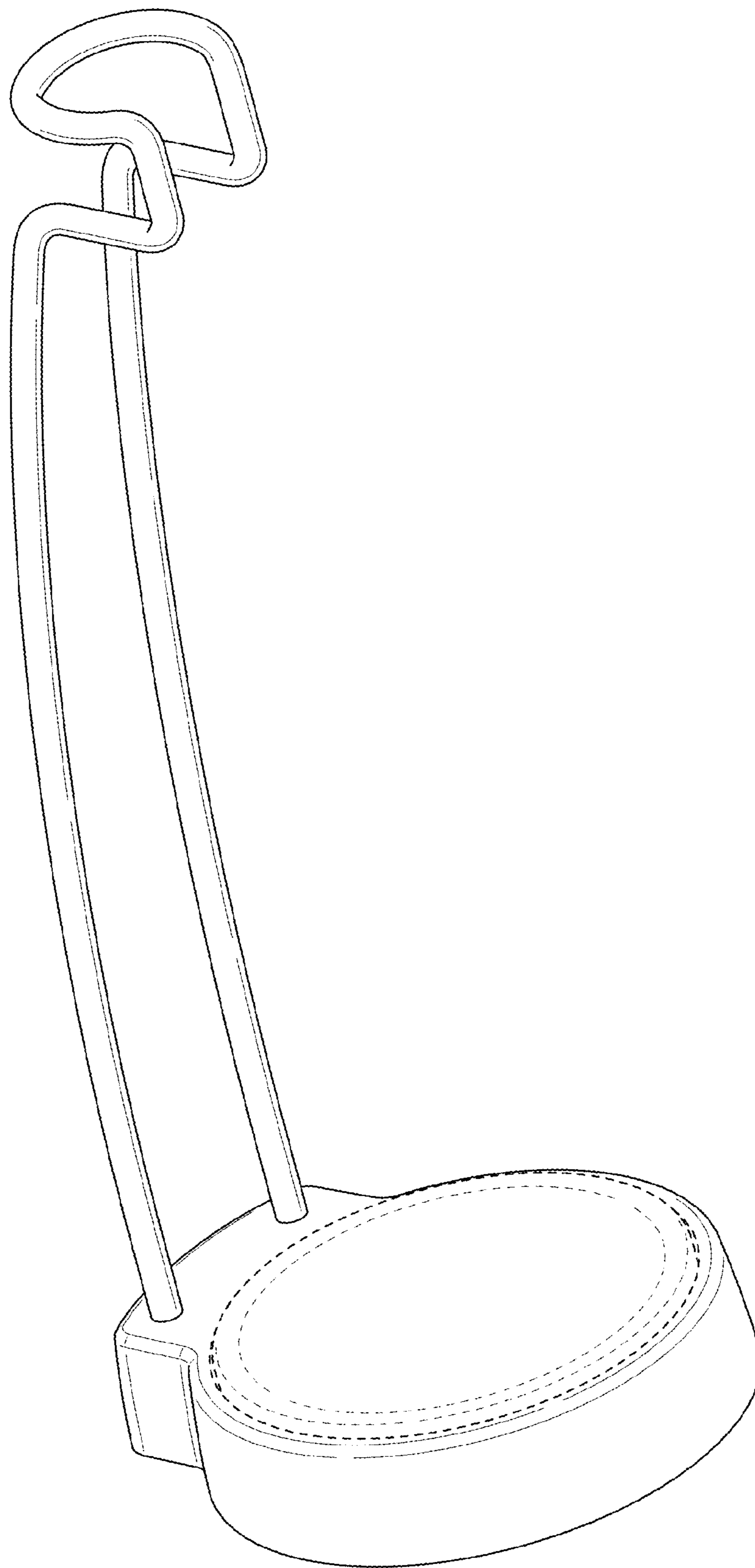

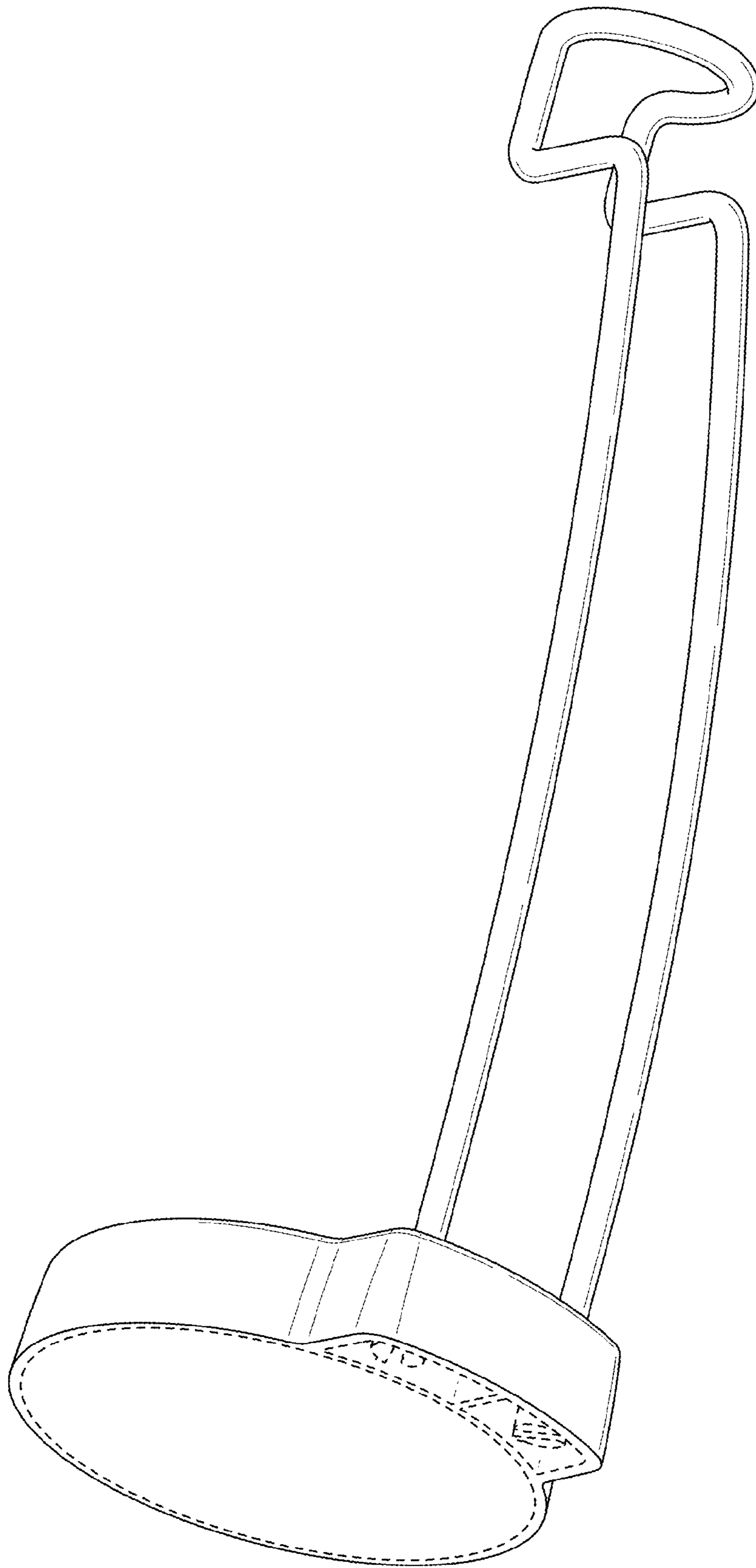

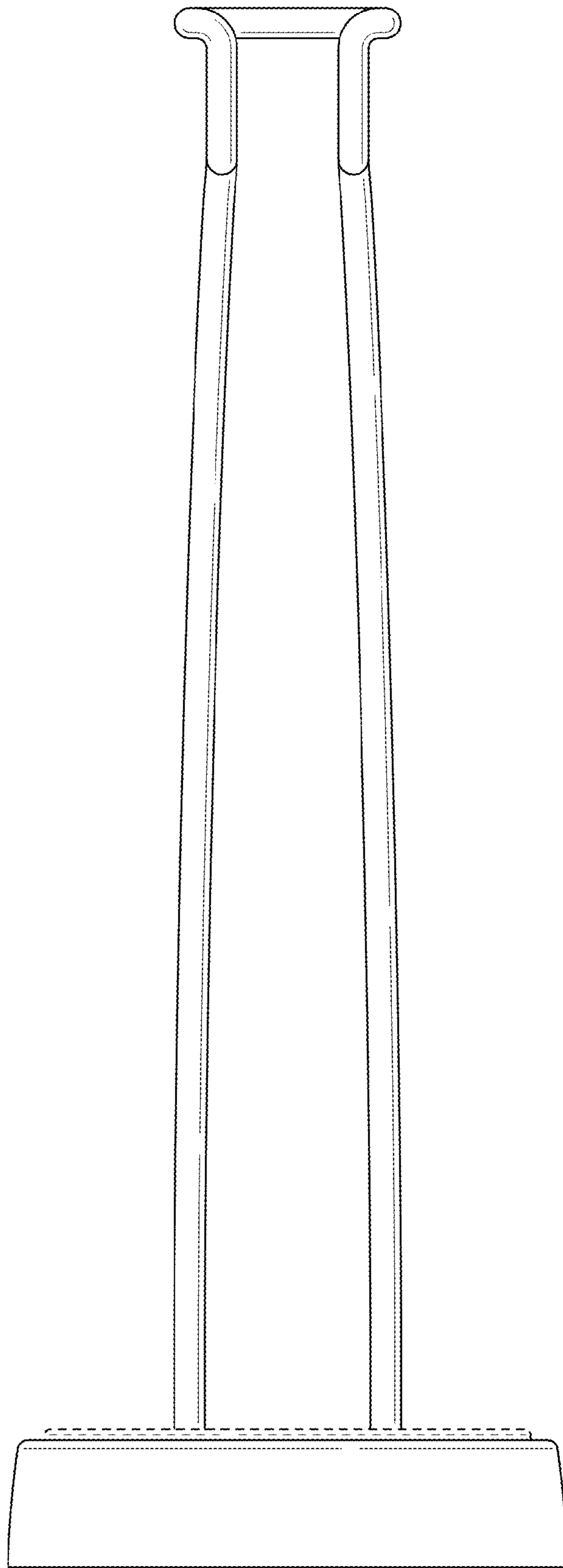

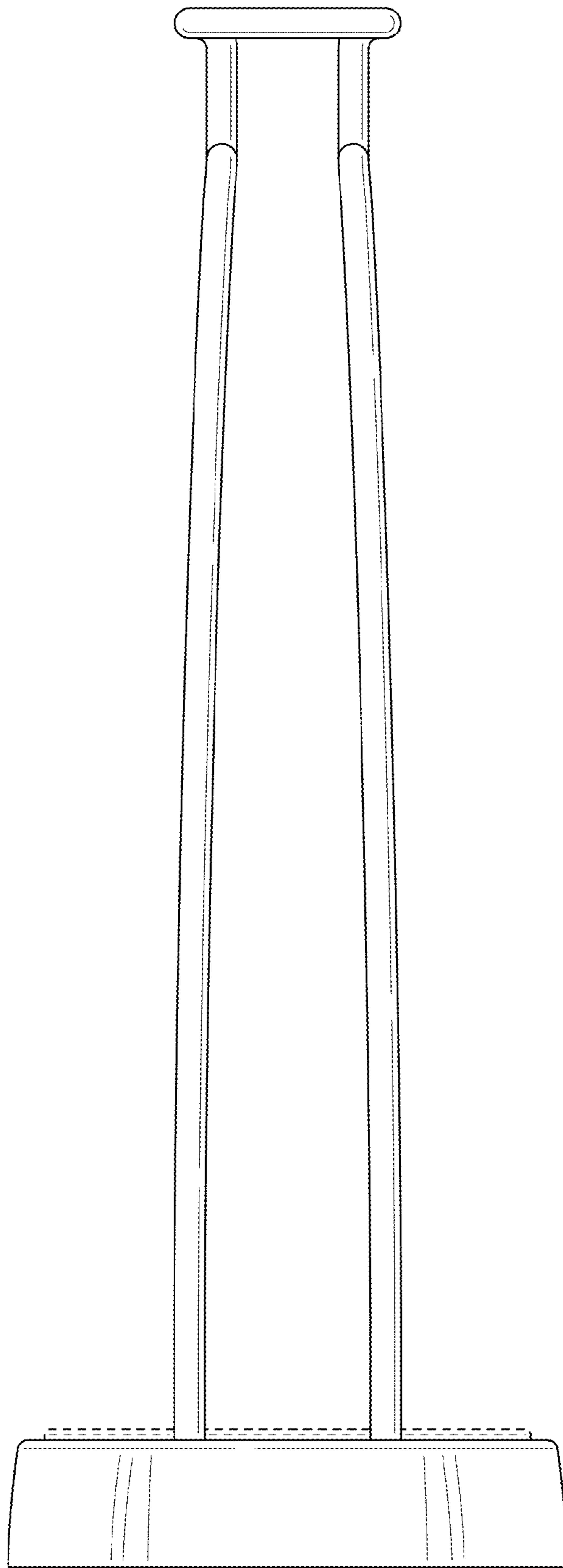

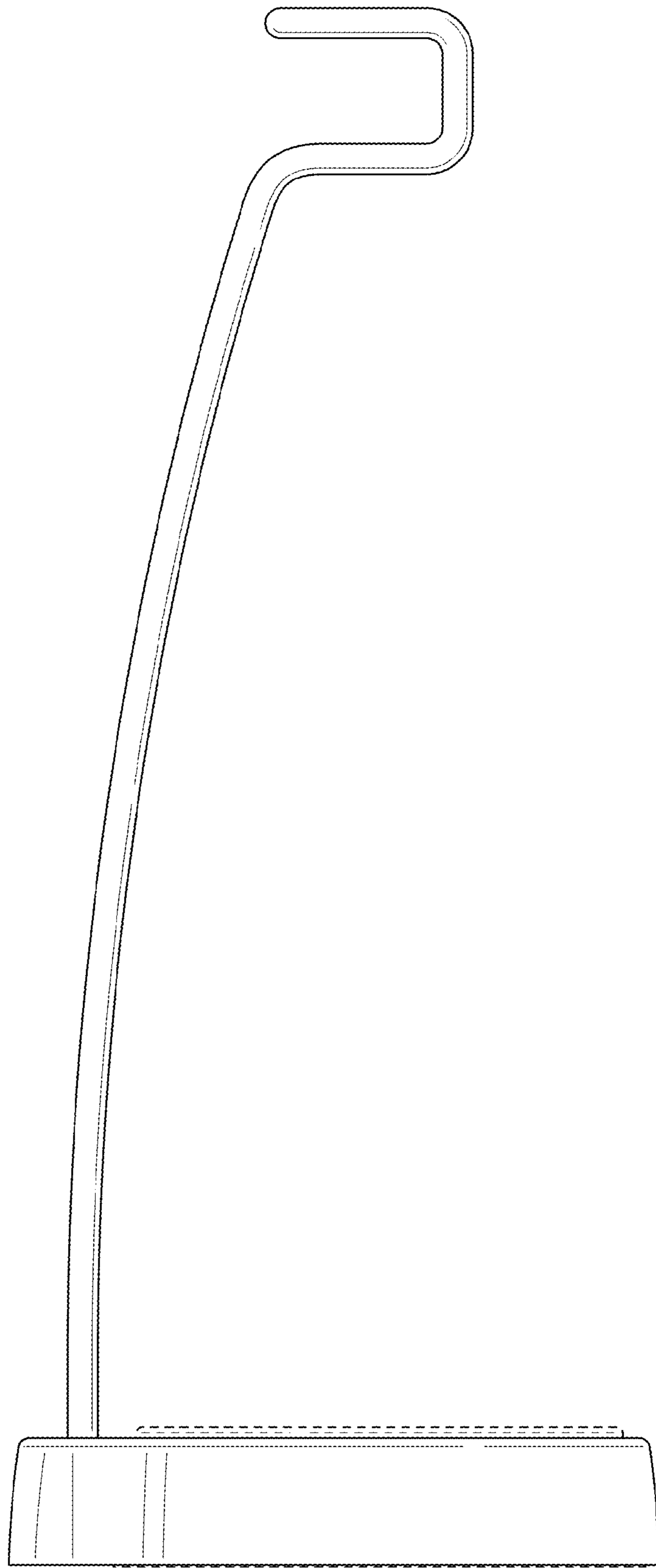

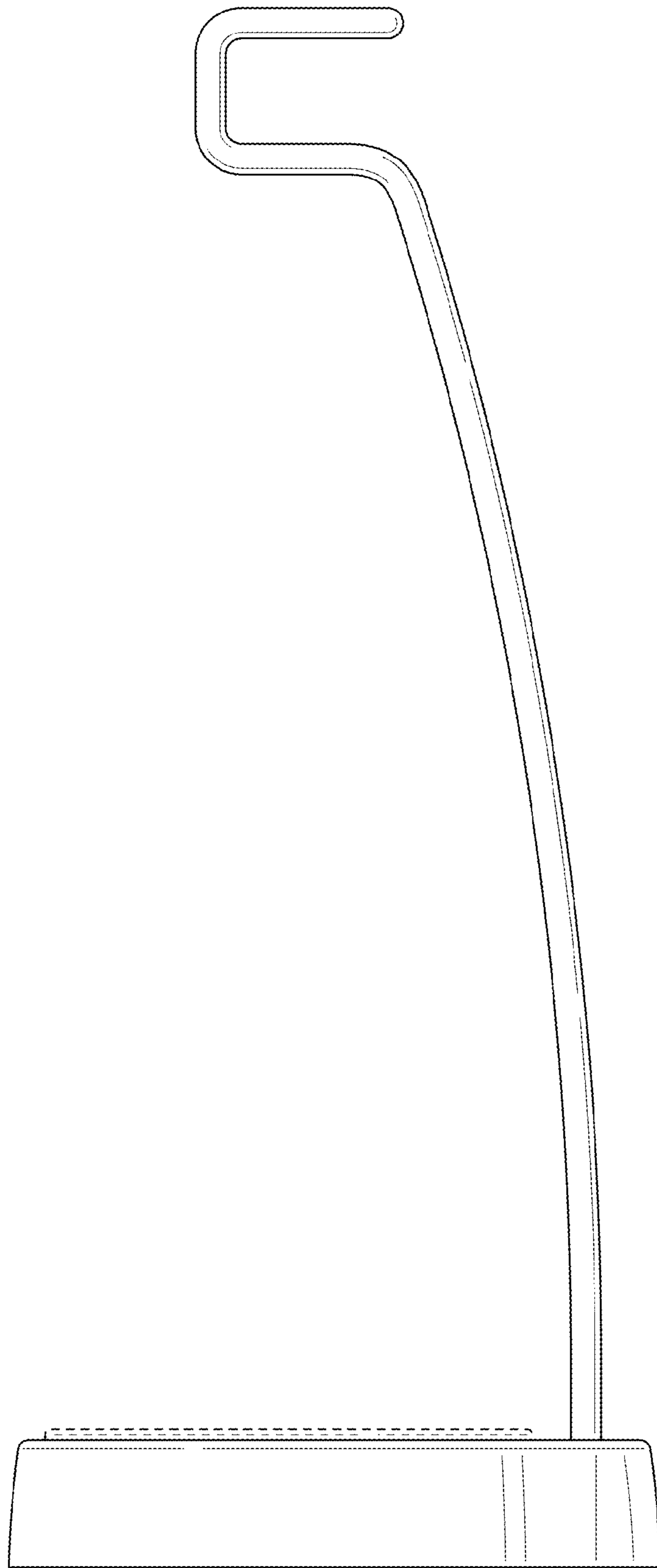

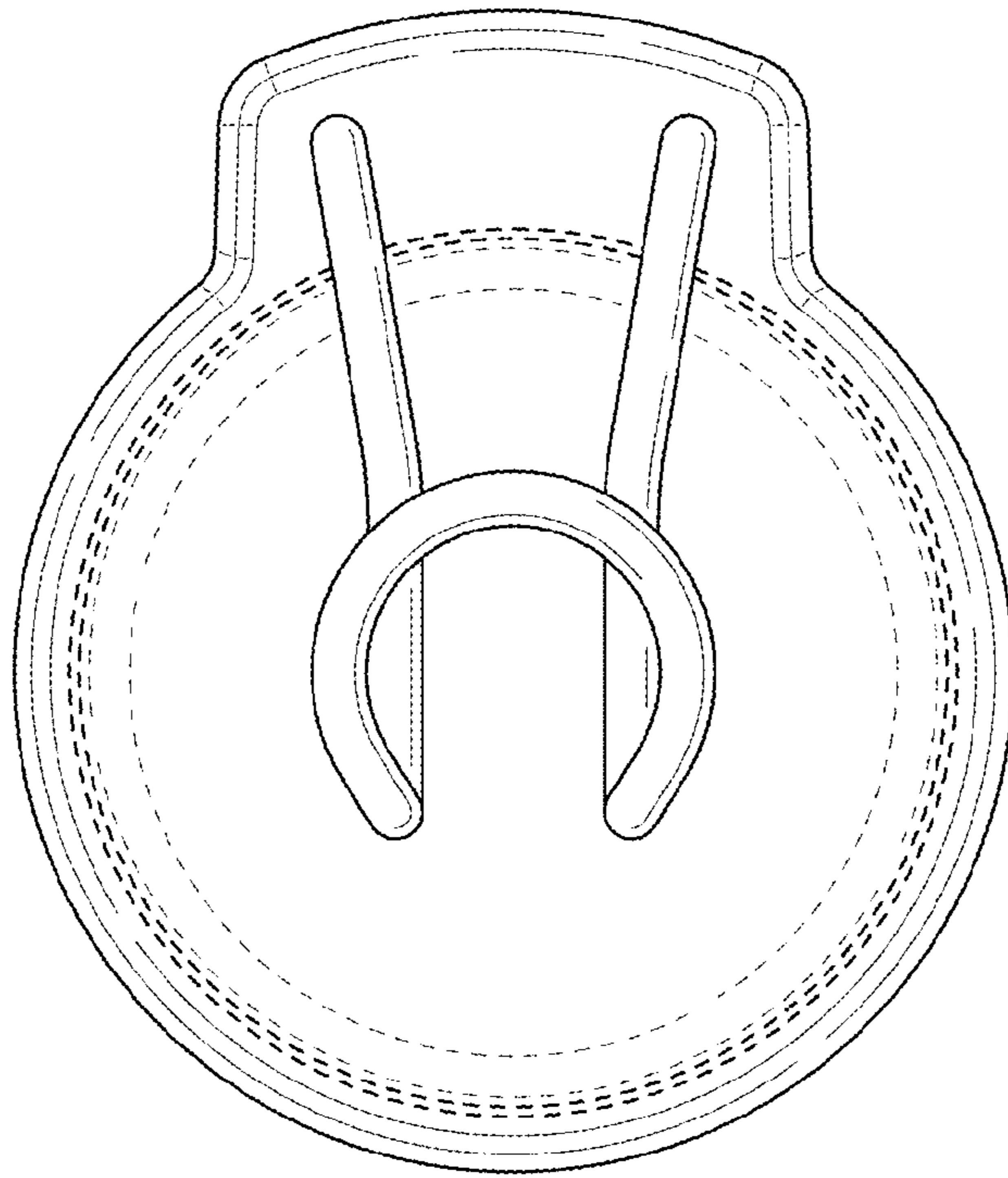

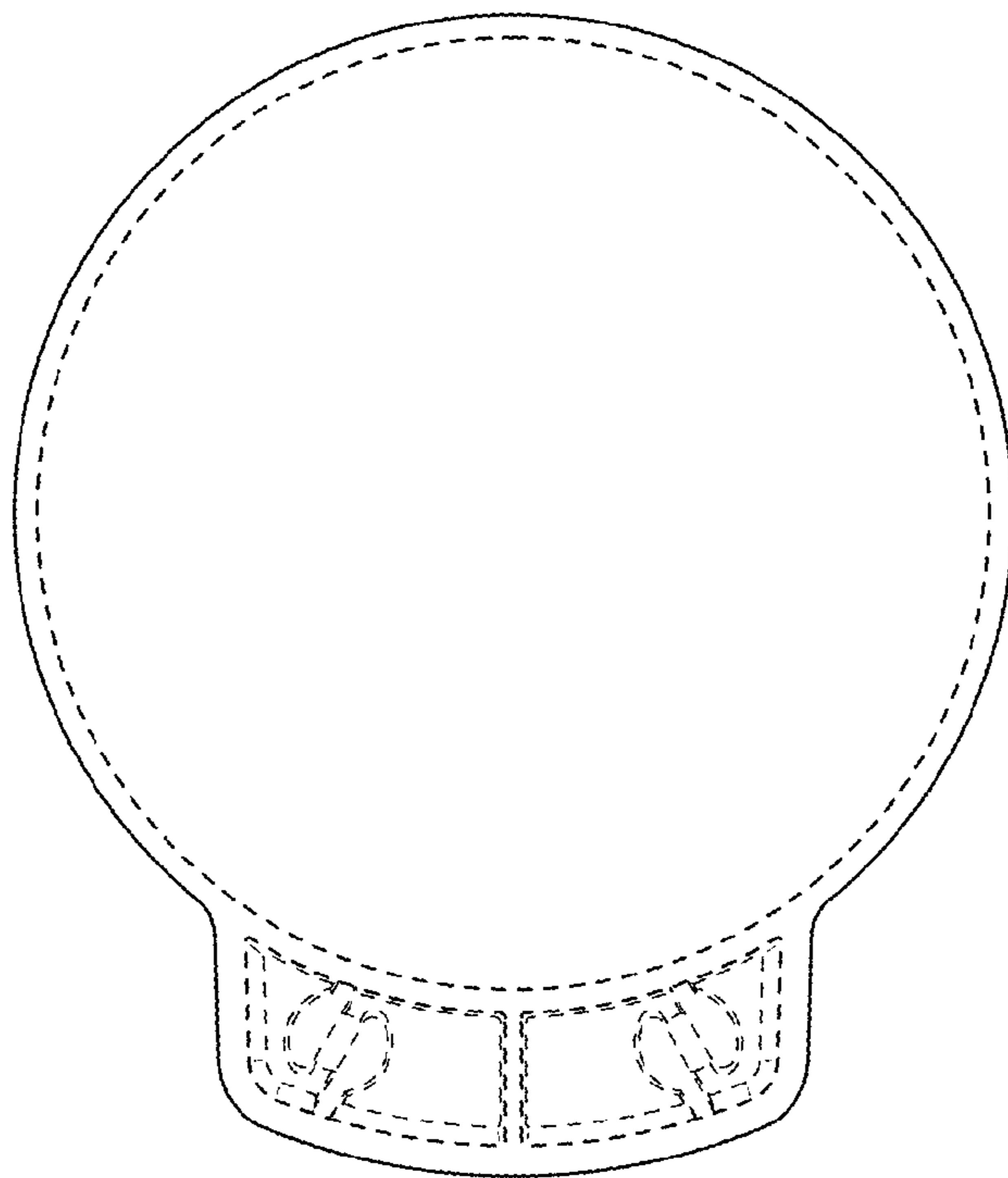

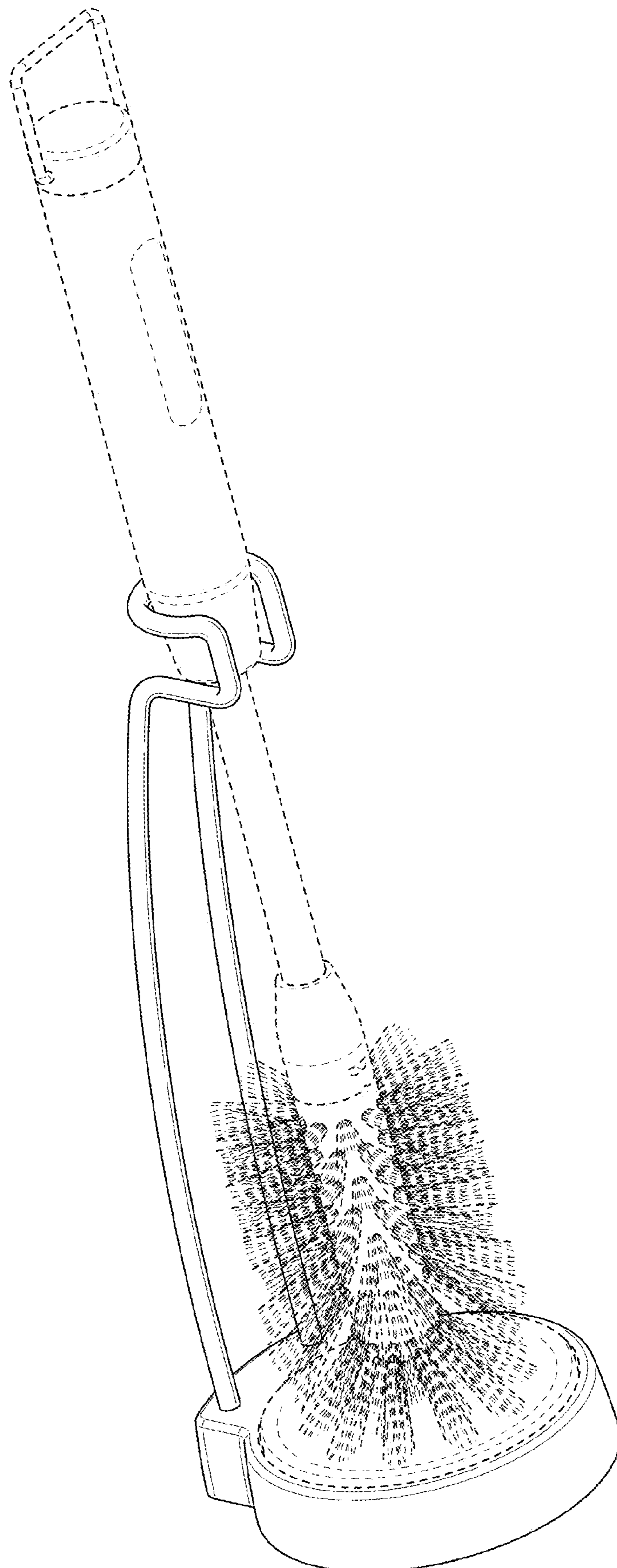
