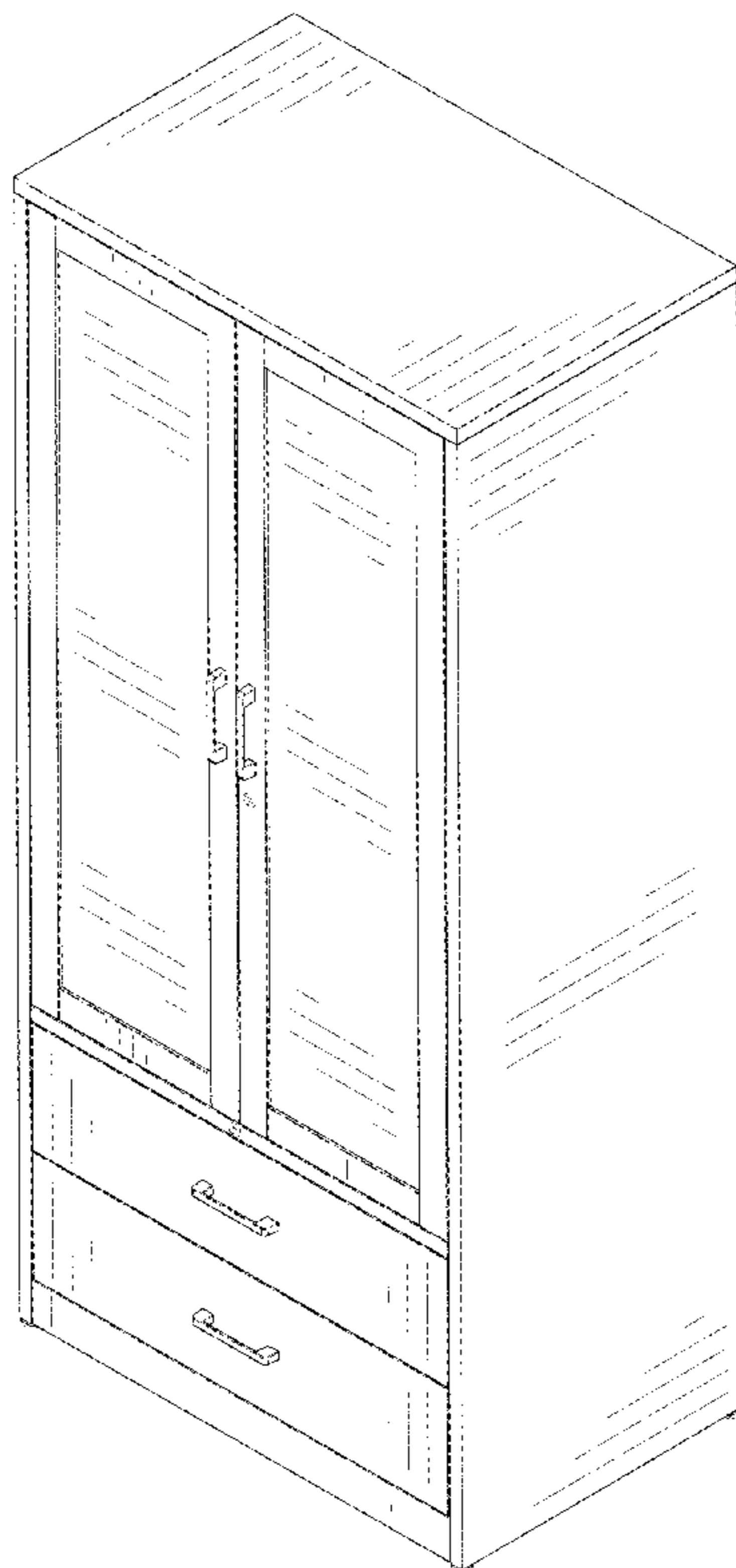
(57) **CLAIM**

The ornamental design for a cabinet with drawers, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a cabinet with drawers showing my new design;

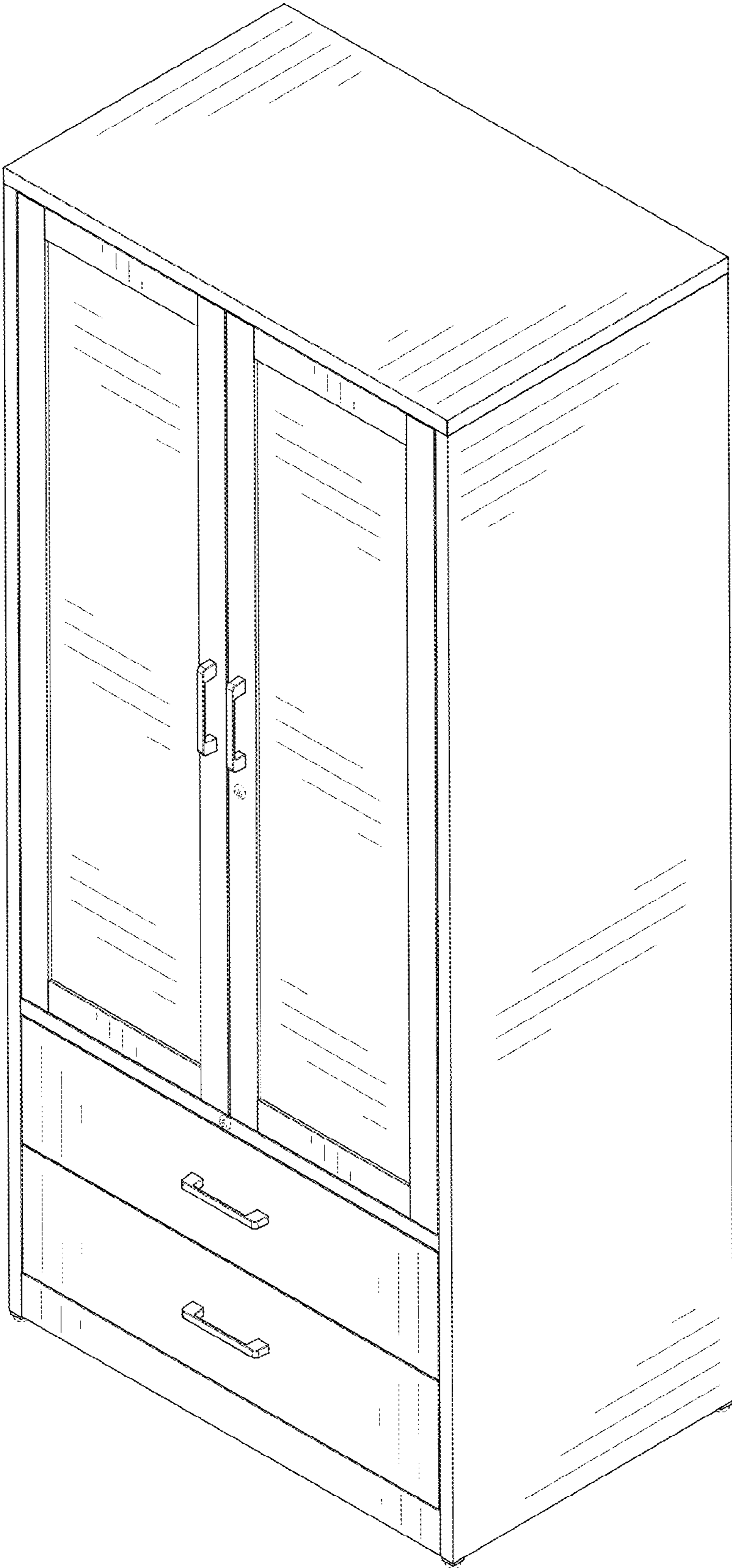

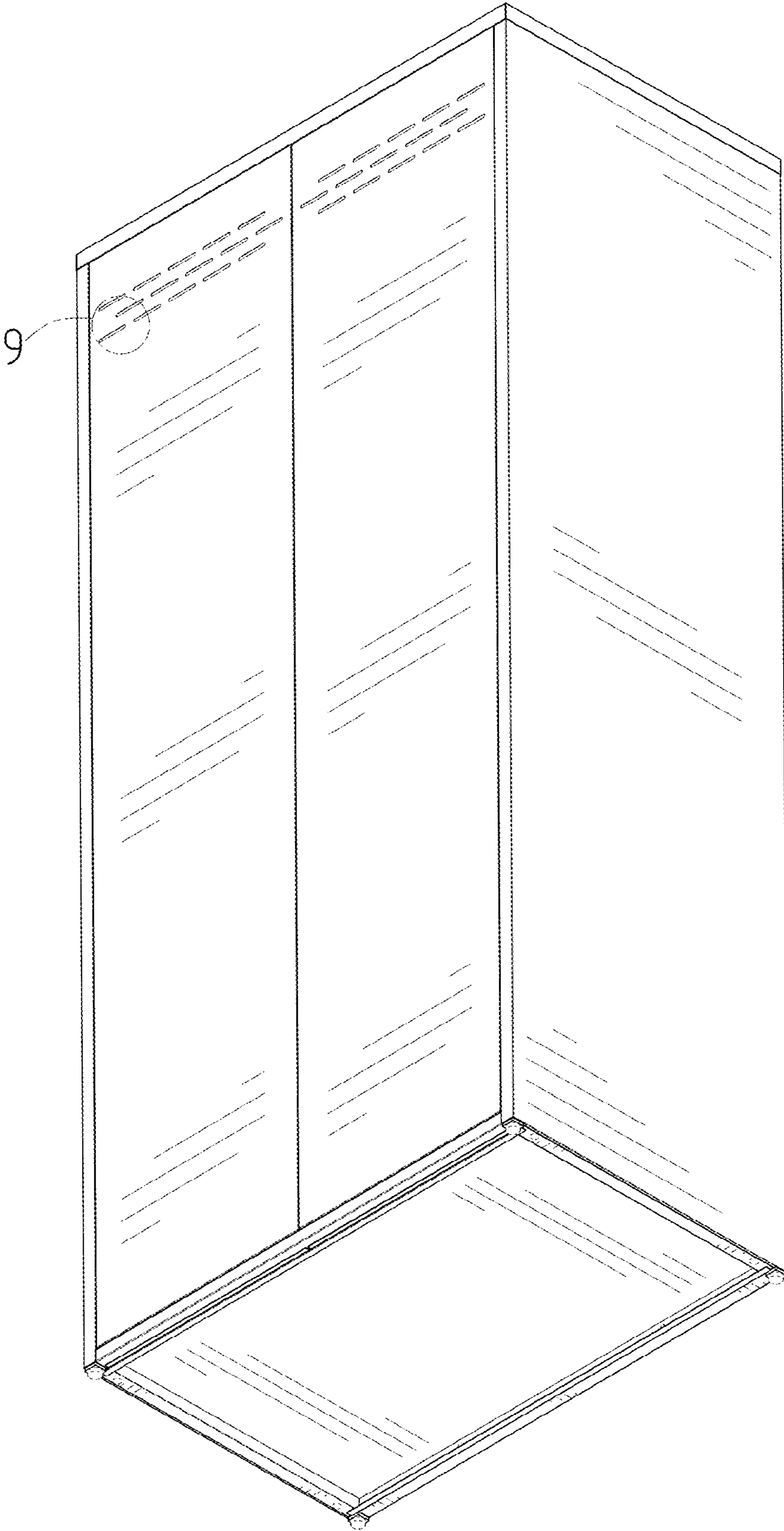

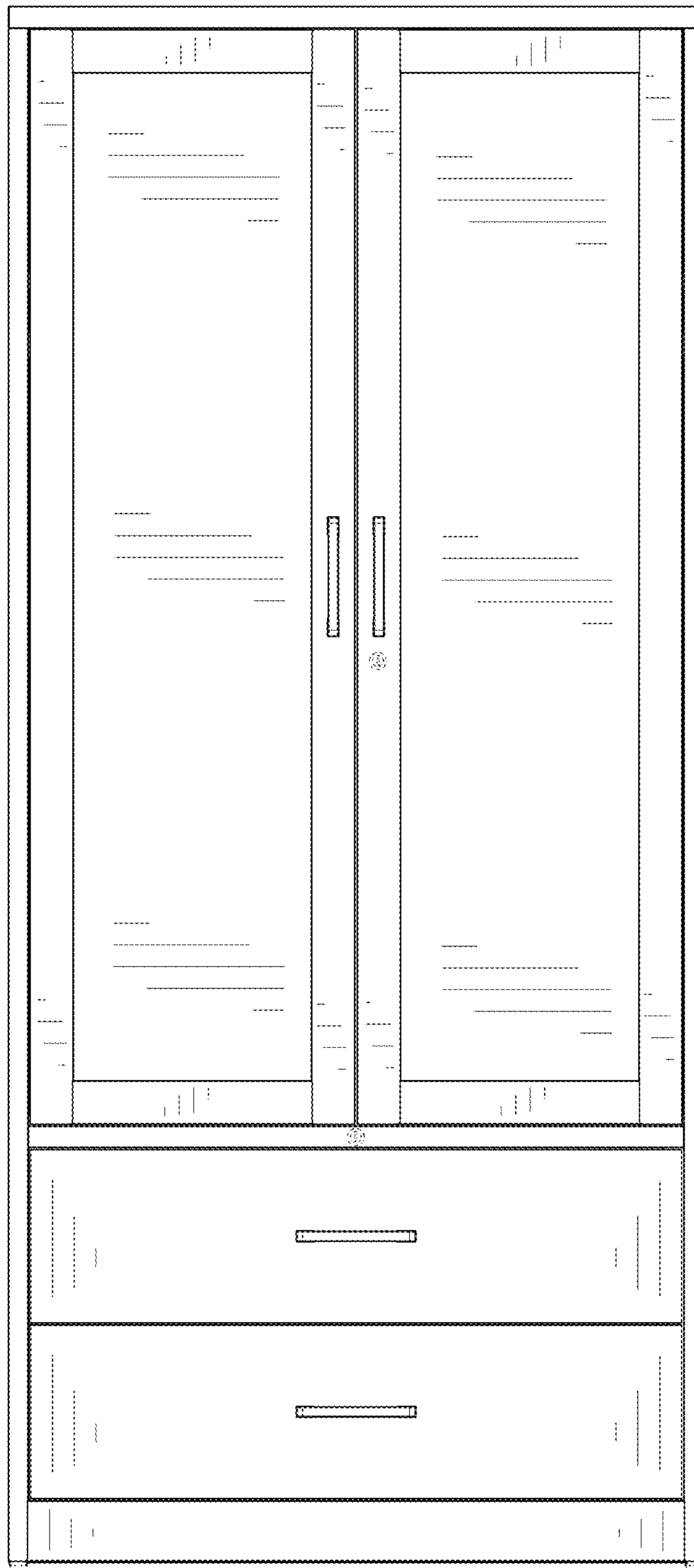

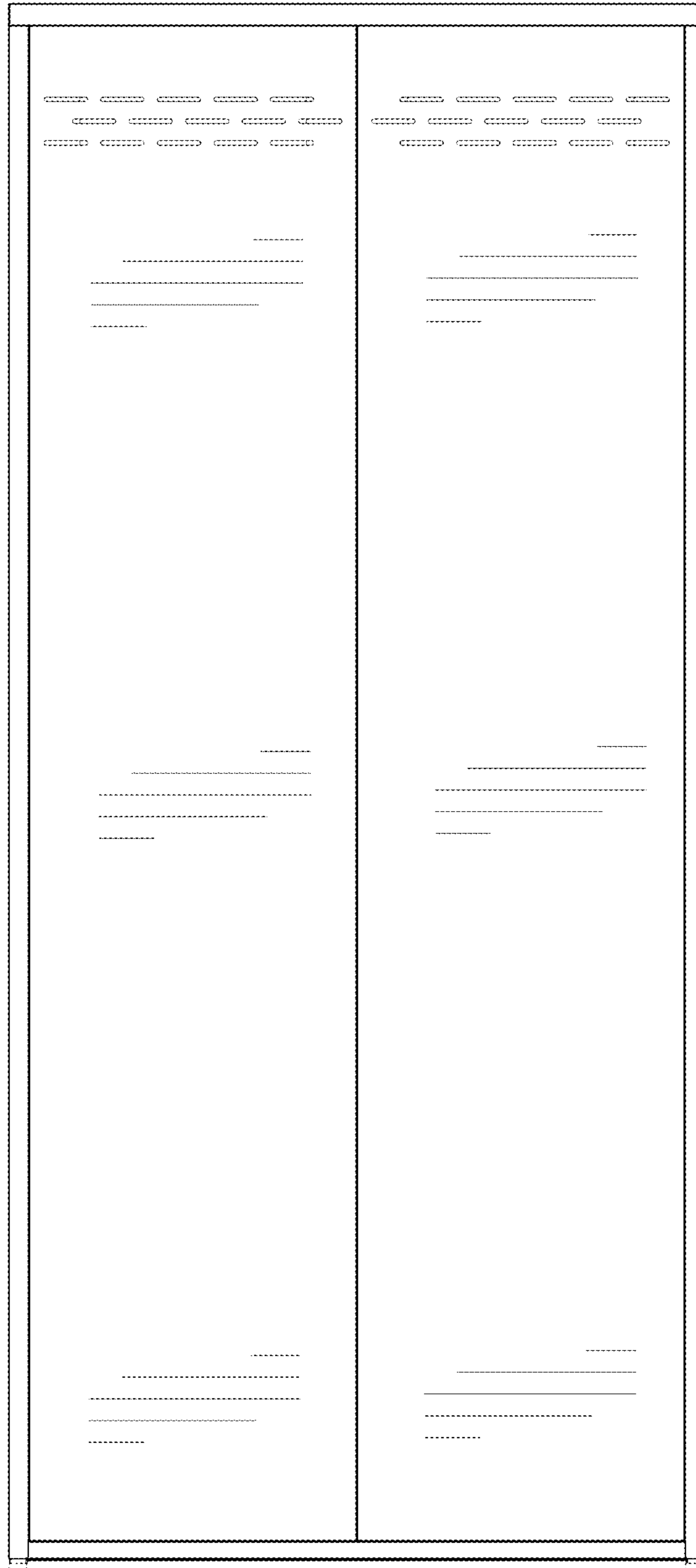

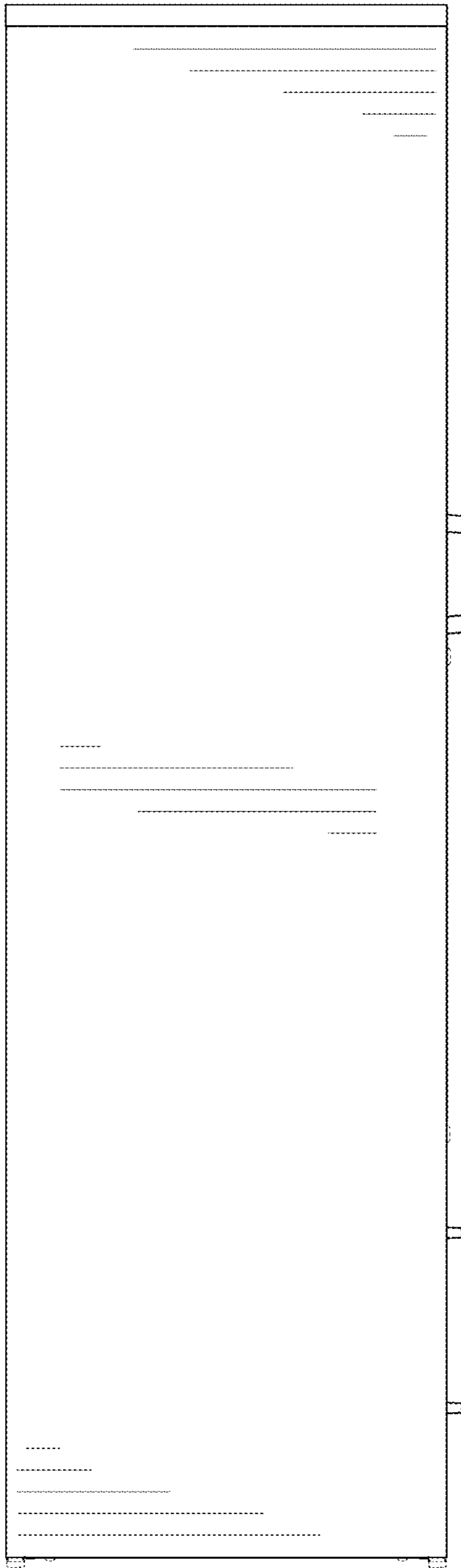

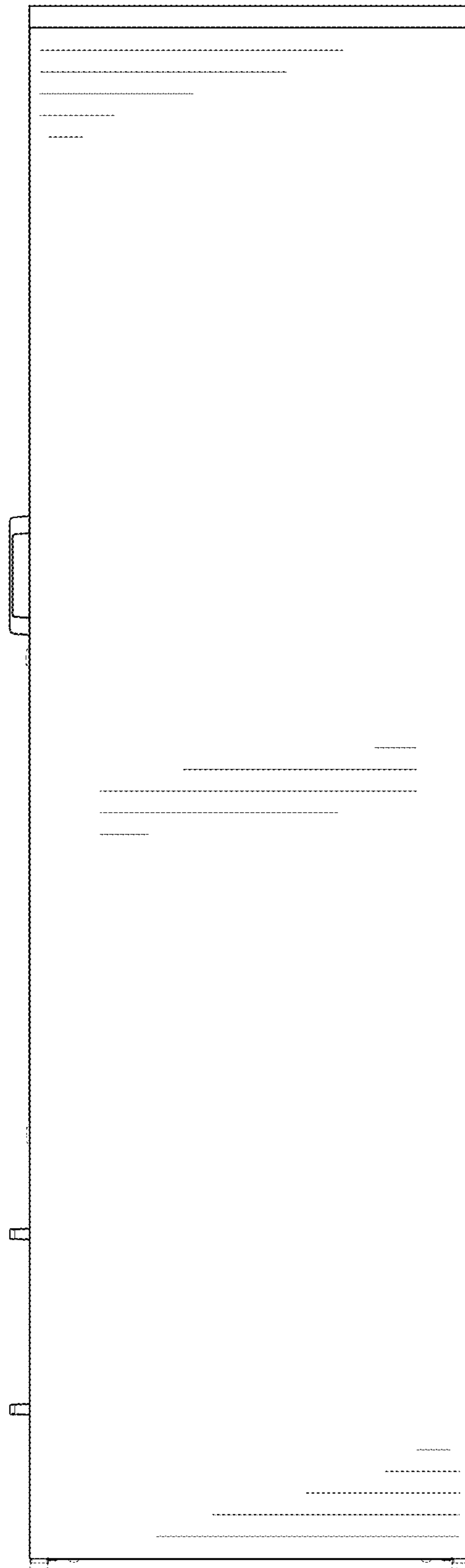

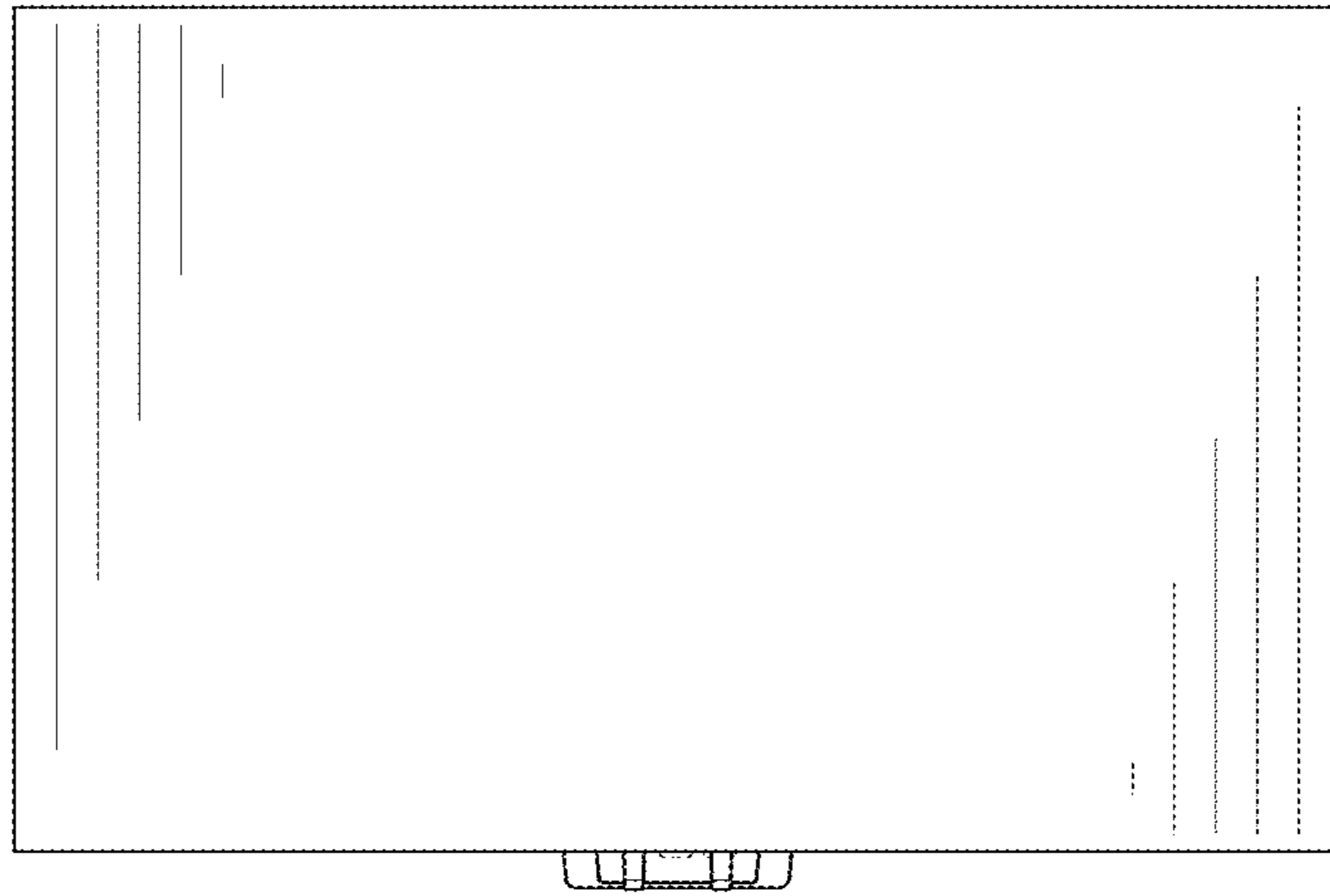

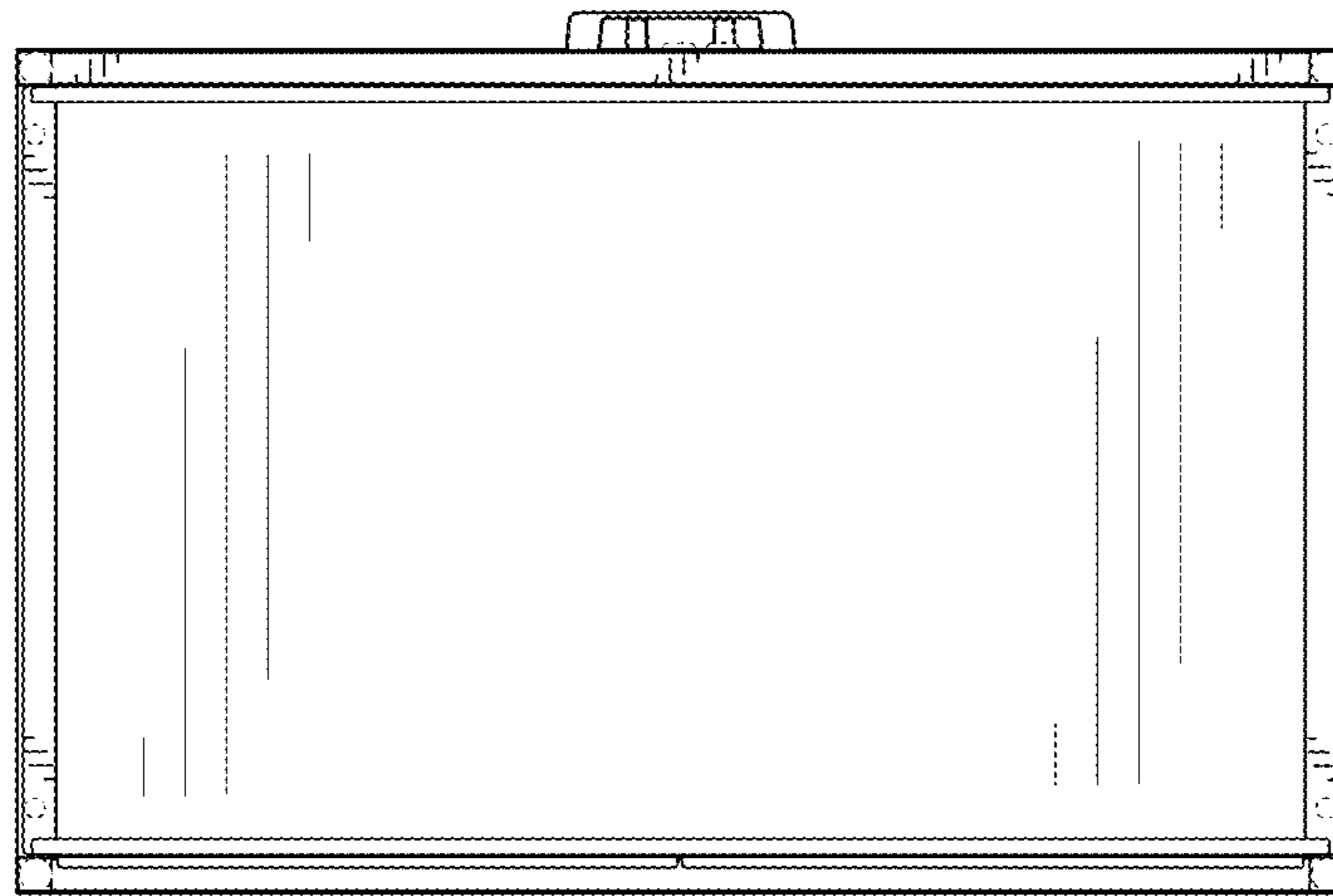

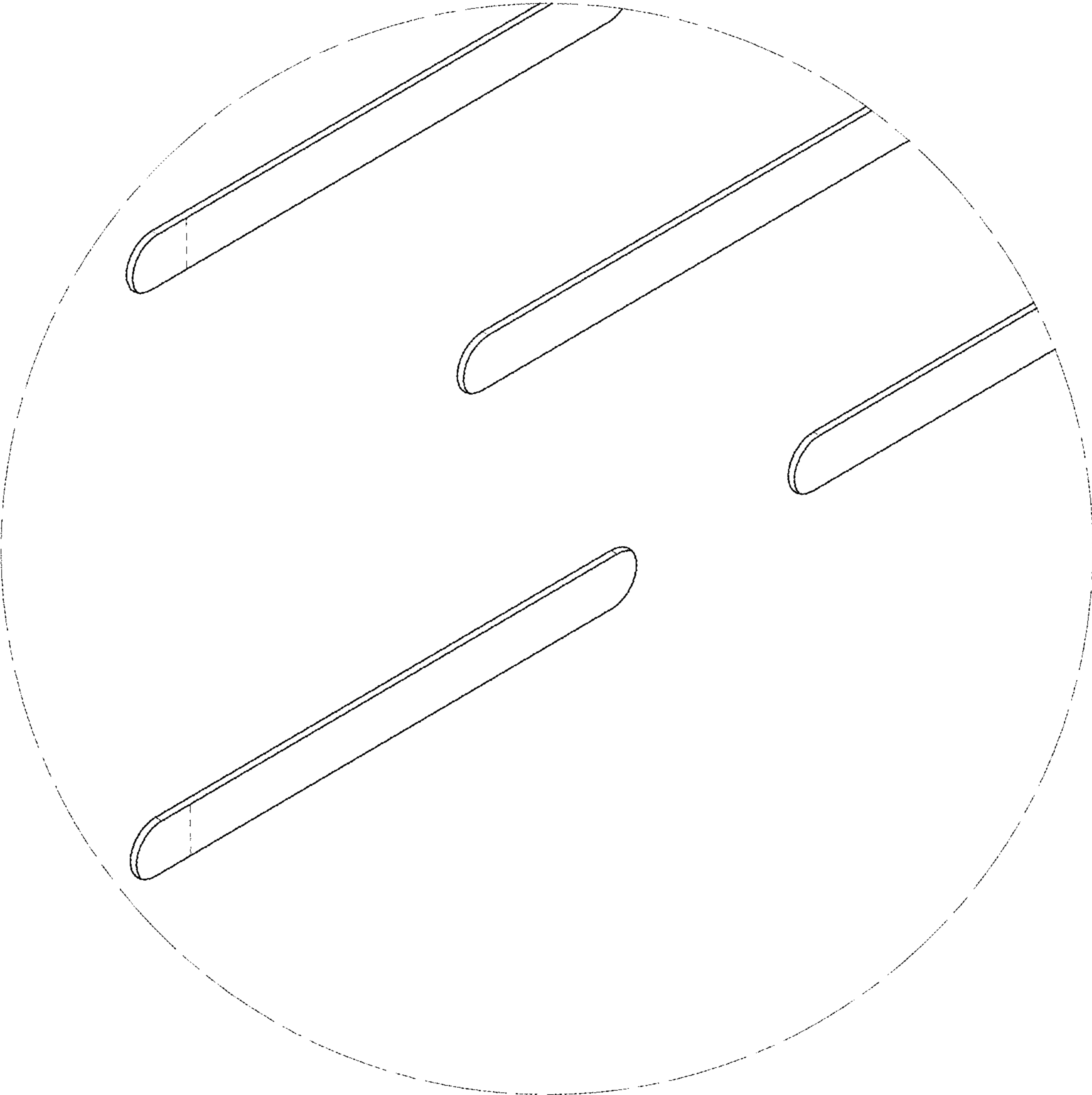
