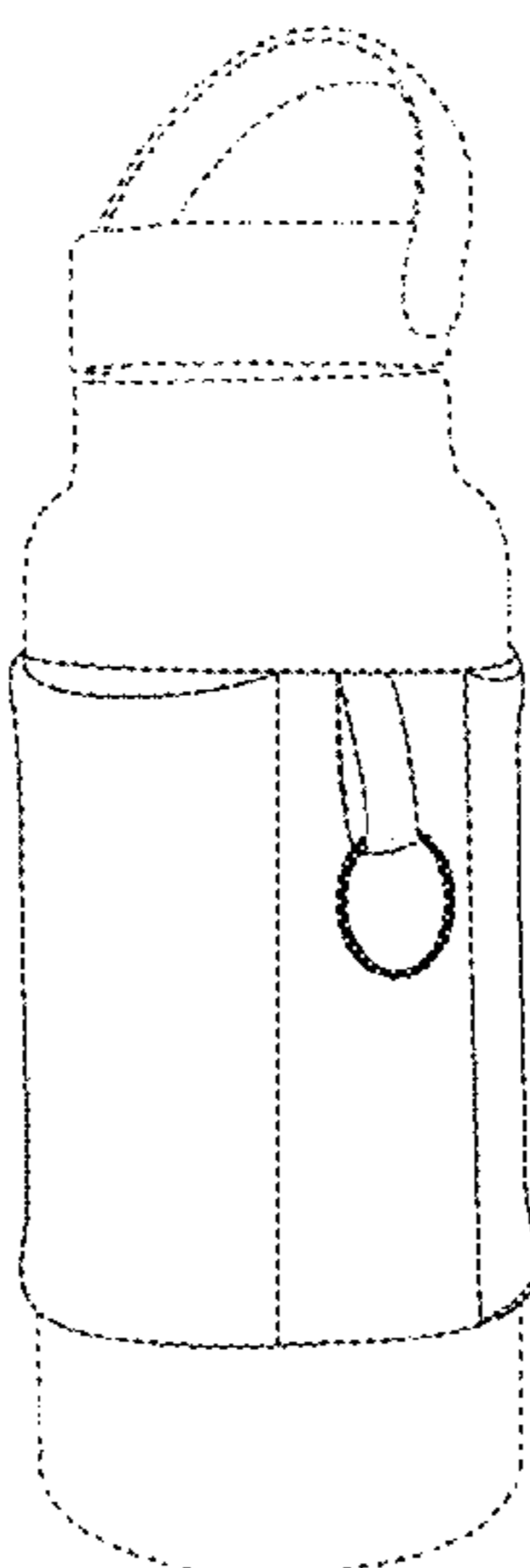
(57) **CLAIM**

I claim the ornamental design for the beverage sleeve with pockets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage sleeve with pockets in accordance with the present design;
FIG. 2 is a front view of the beverage sleeve with pockets shown in FIG. 1;
FIG. 3 is a right side view of the beverage sleeve with pockets shown in FIG. 1;
FIG. 4 is a back view of the beverage sleeve with pockets shown in FIG. 1; and,
FIG. 5 is a left side view of the beverage sleeve with pockets shown in FIG. 1.

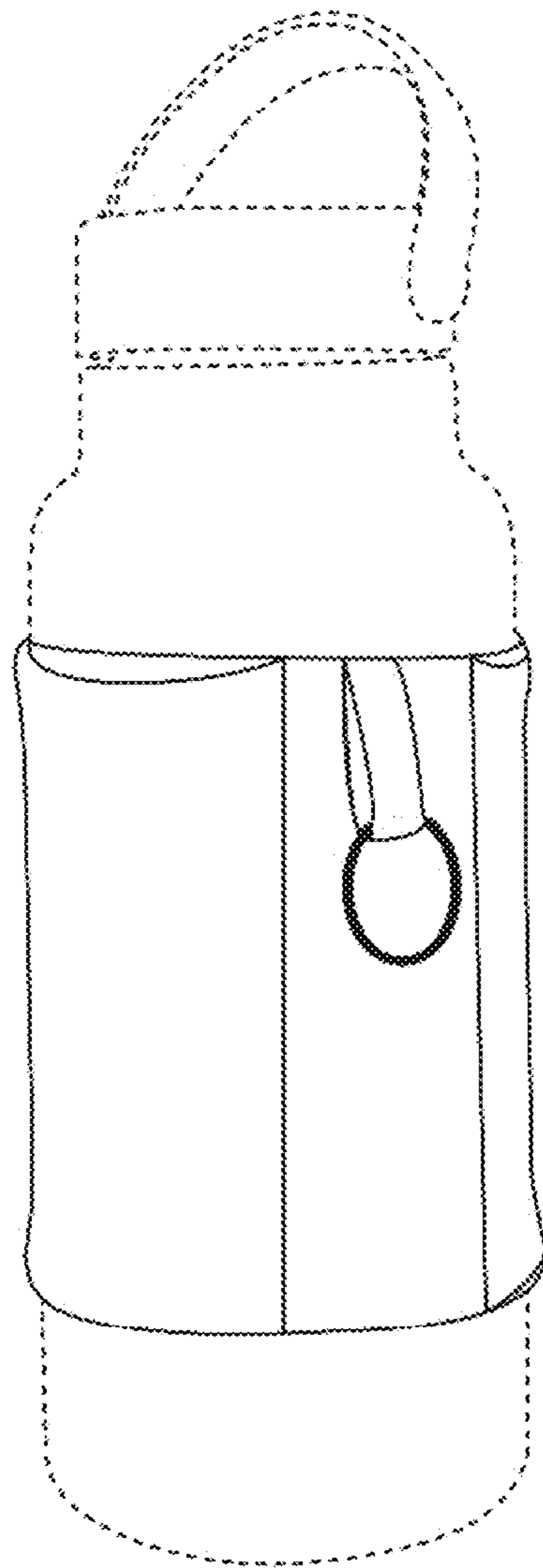

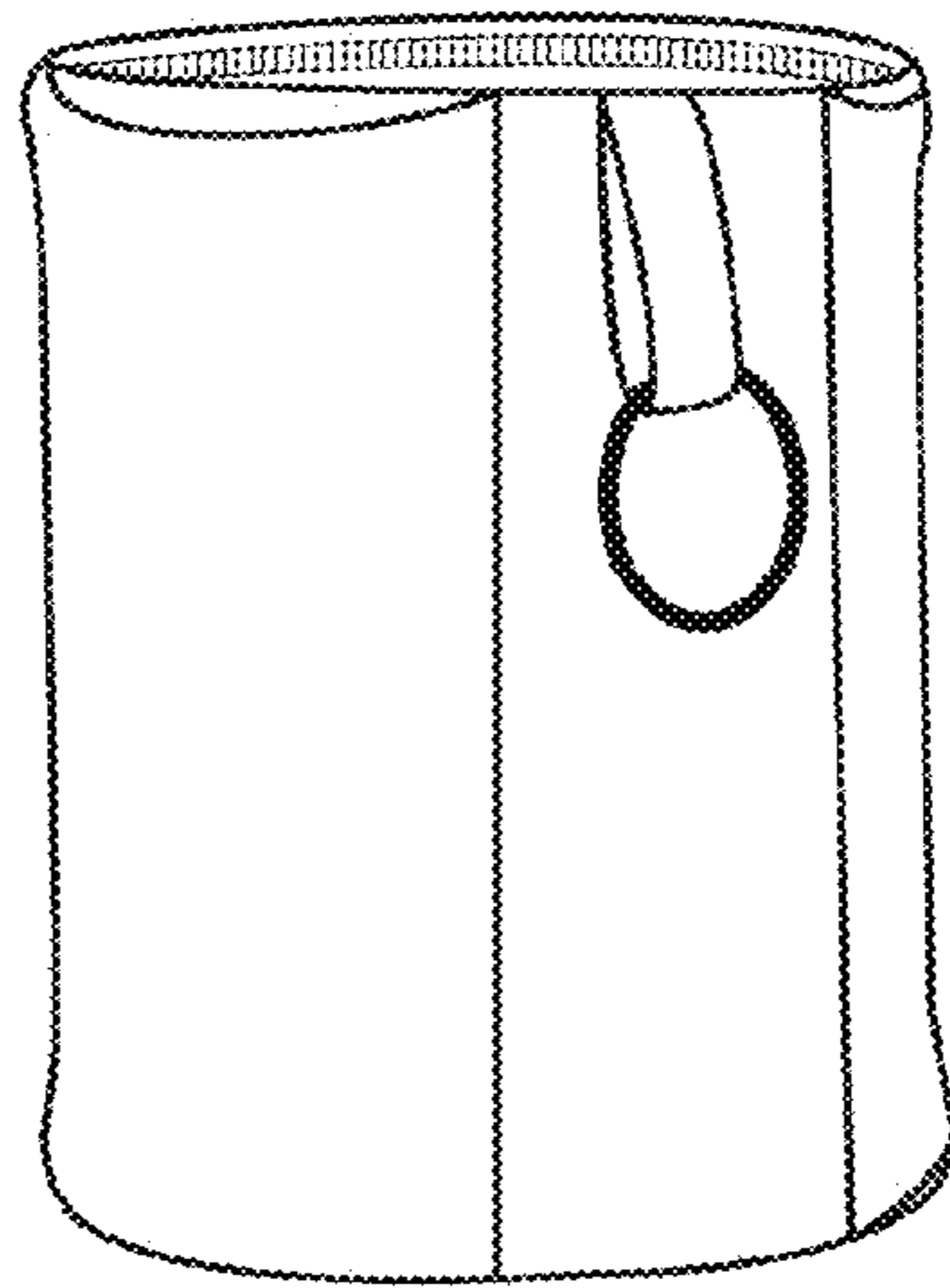

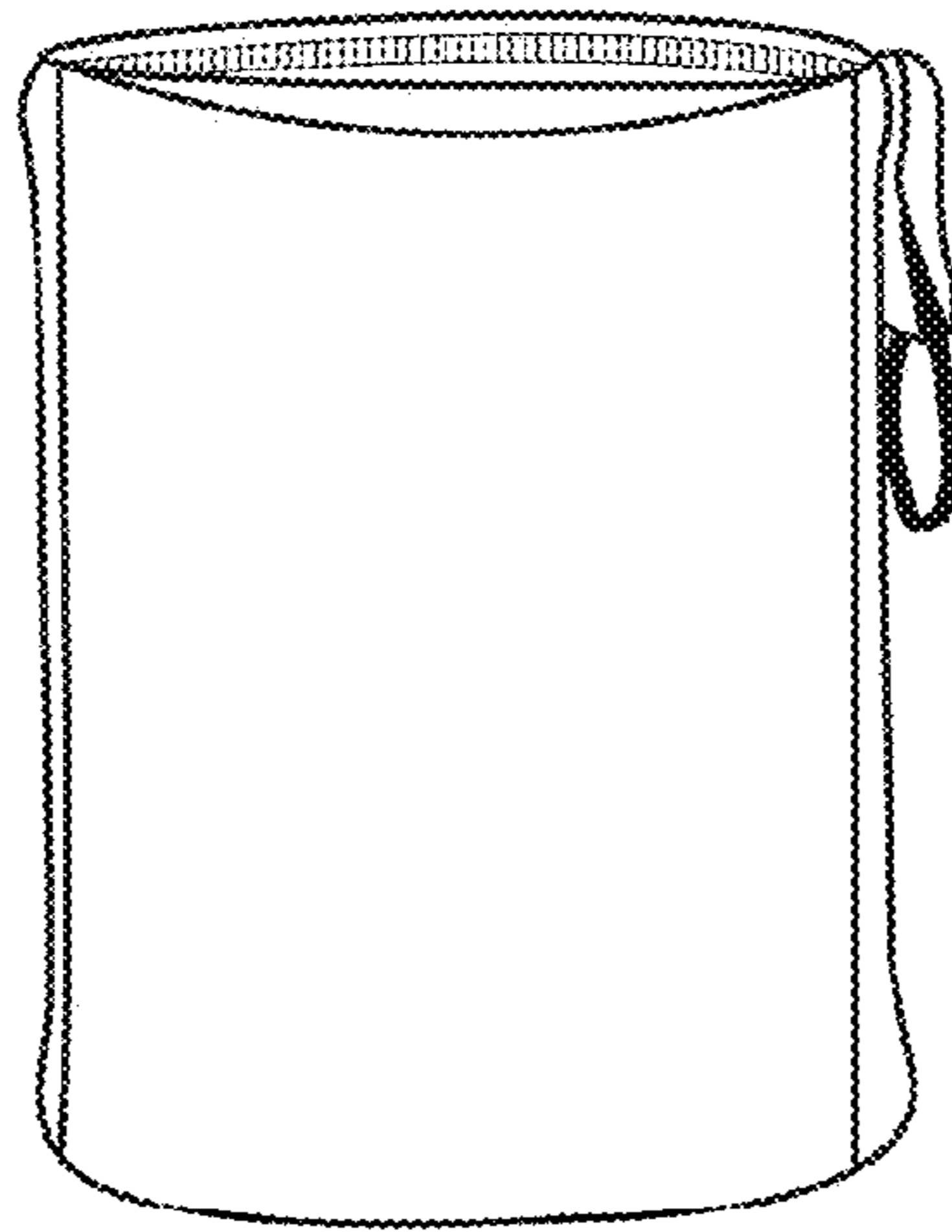

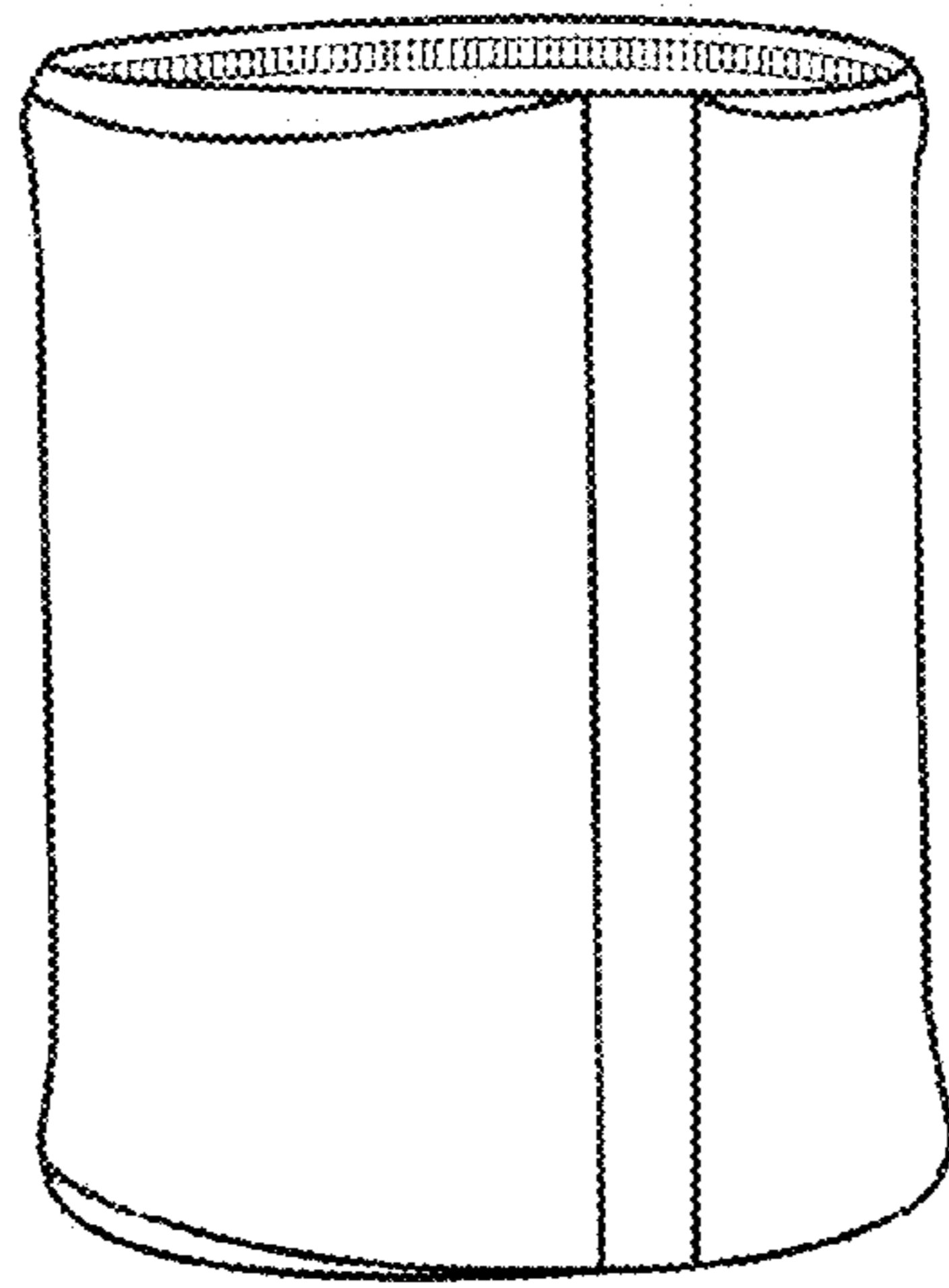

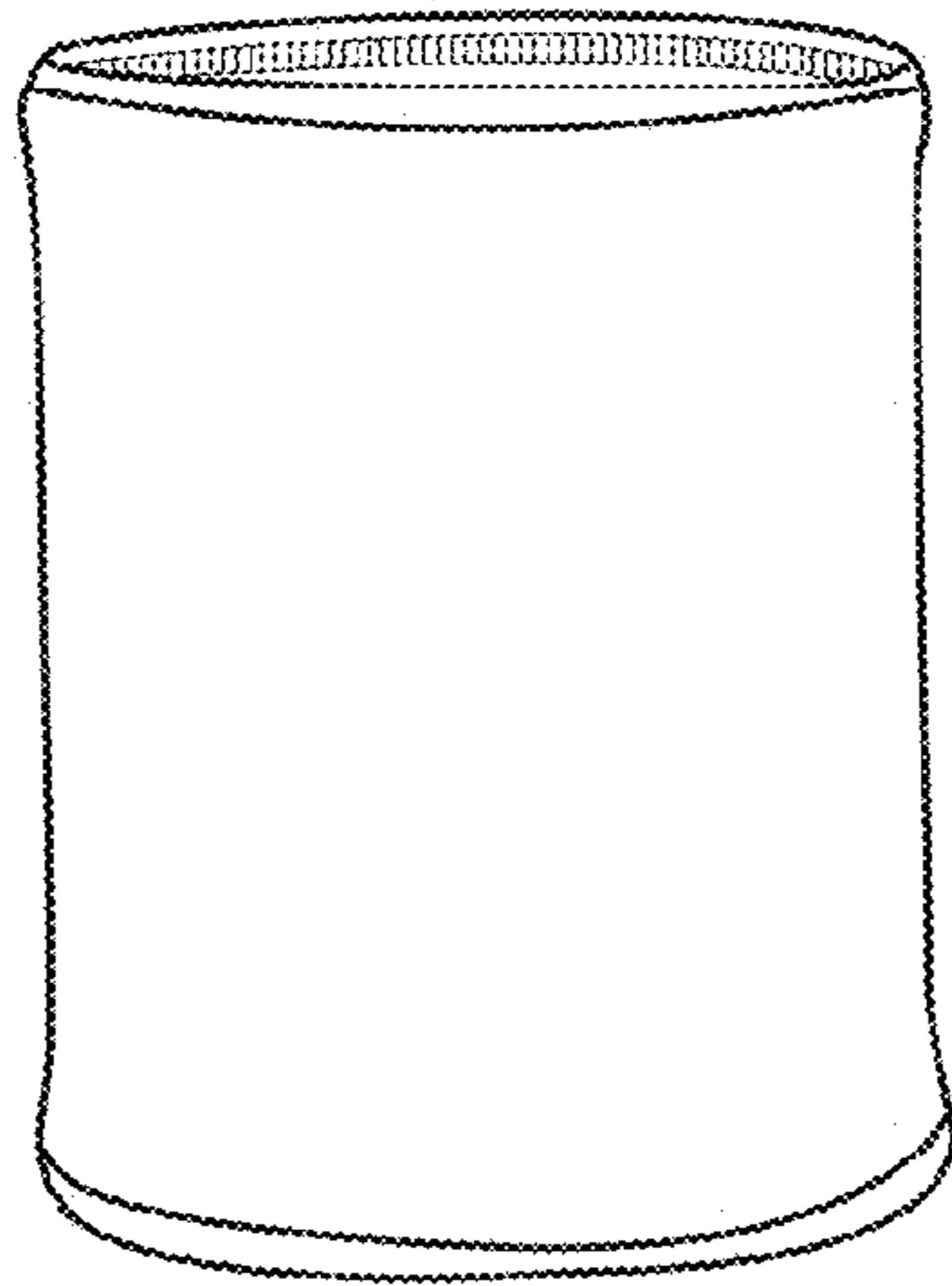
