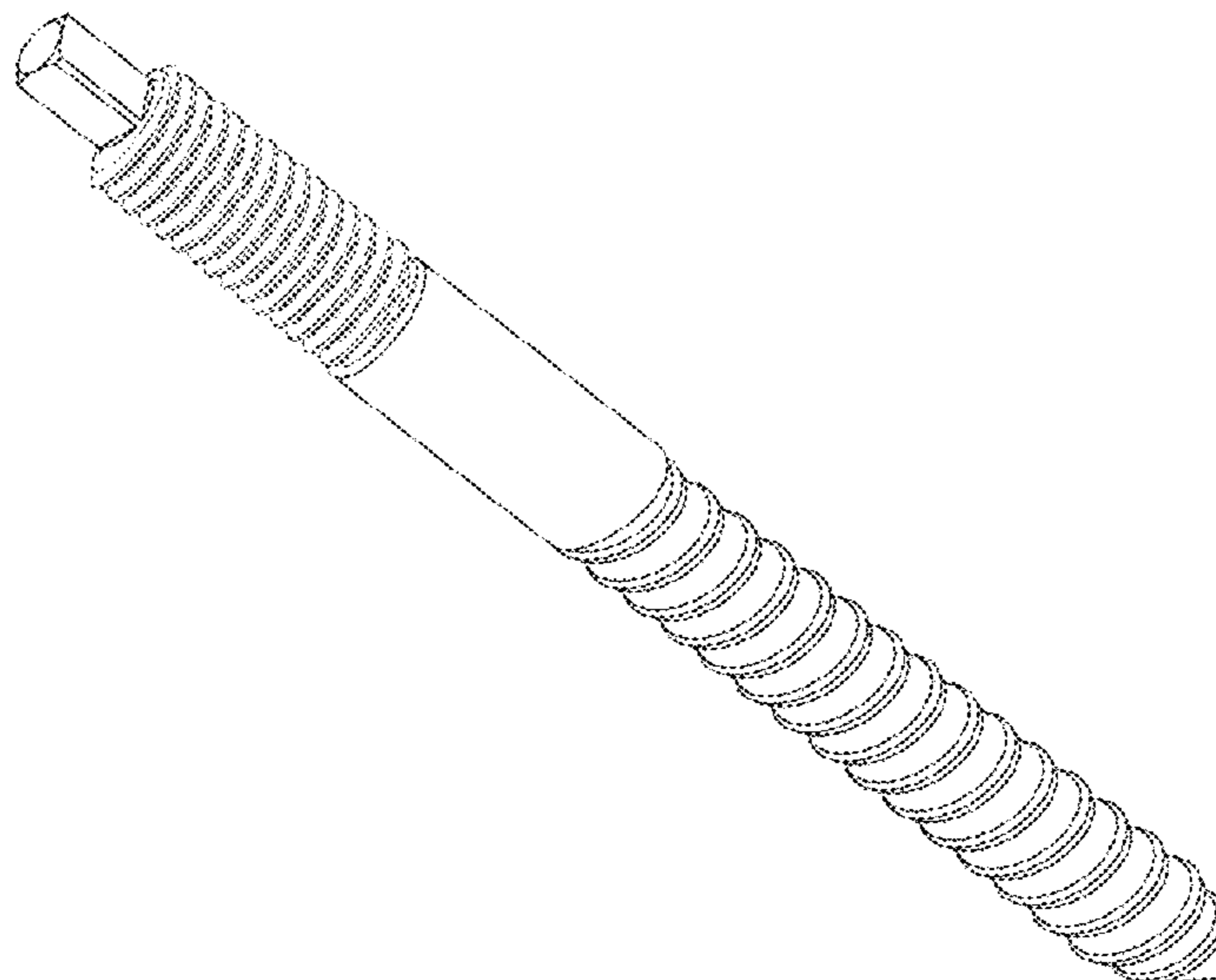
(57) **CLAIM**

The ornamental design for an anchor bolt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an anchor bolt according to my new design;
FIG. 2 is a side elevation view thereof;
FIG. 3 is an enlarged top plan view thereof;
FIG. 4 is an enlarged bottom plan view thereof;
FIG. 5 is an enlarged partial view of the anchor bolt shown in FIG. 1; and,
FIG. 6 is an enlarged partial view of the anchor bolt shown in FIG. 1.

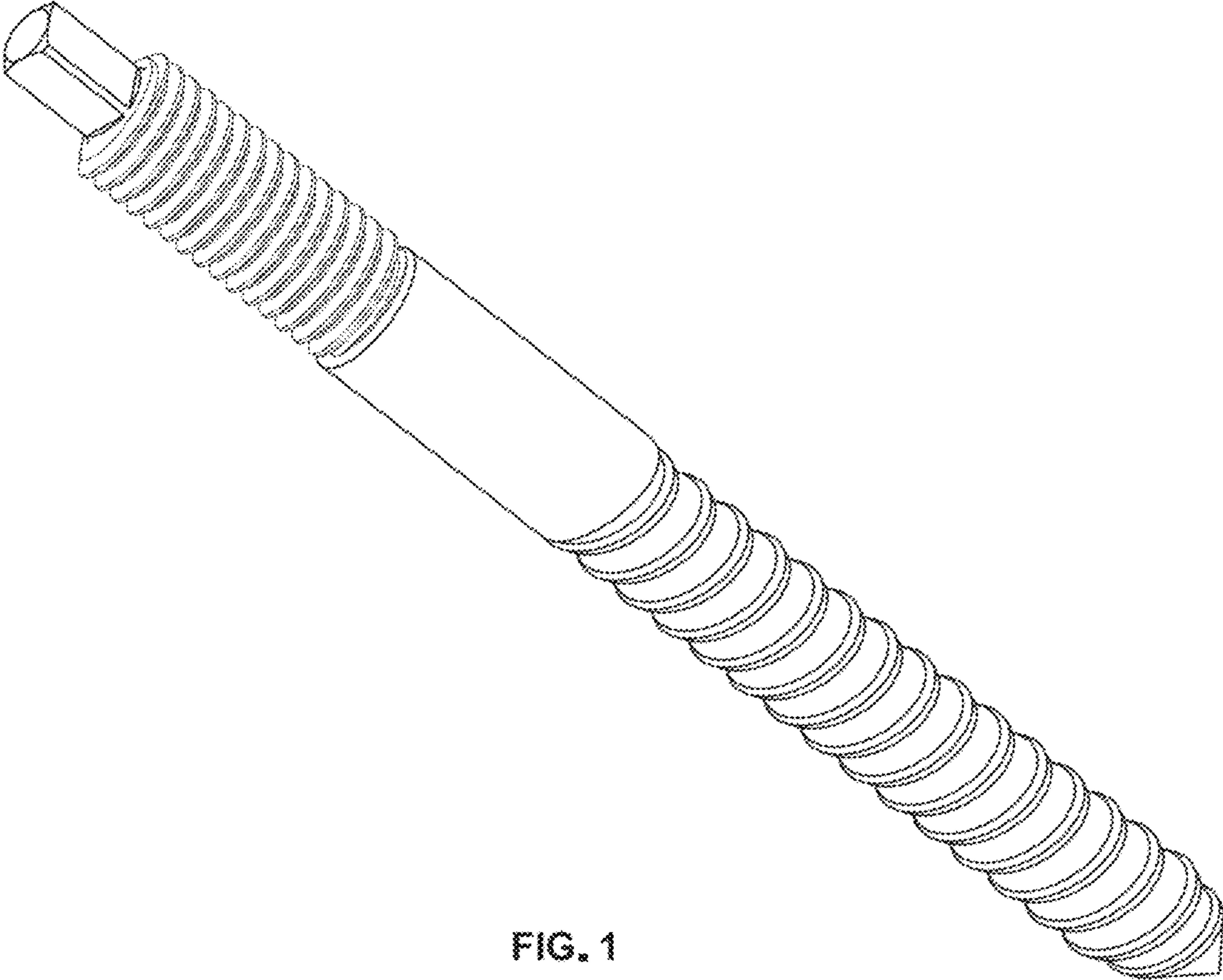

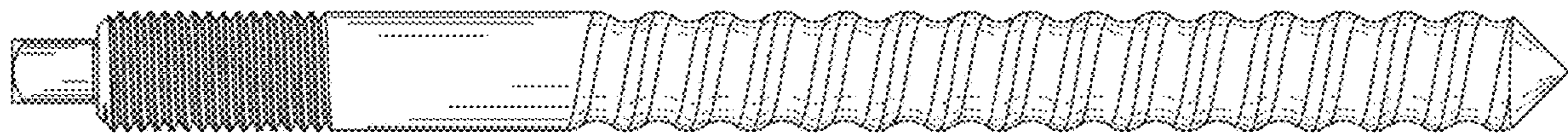

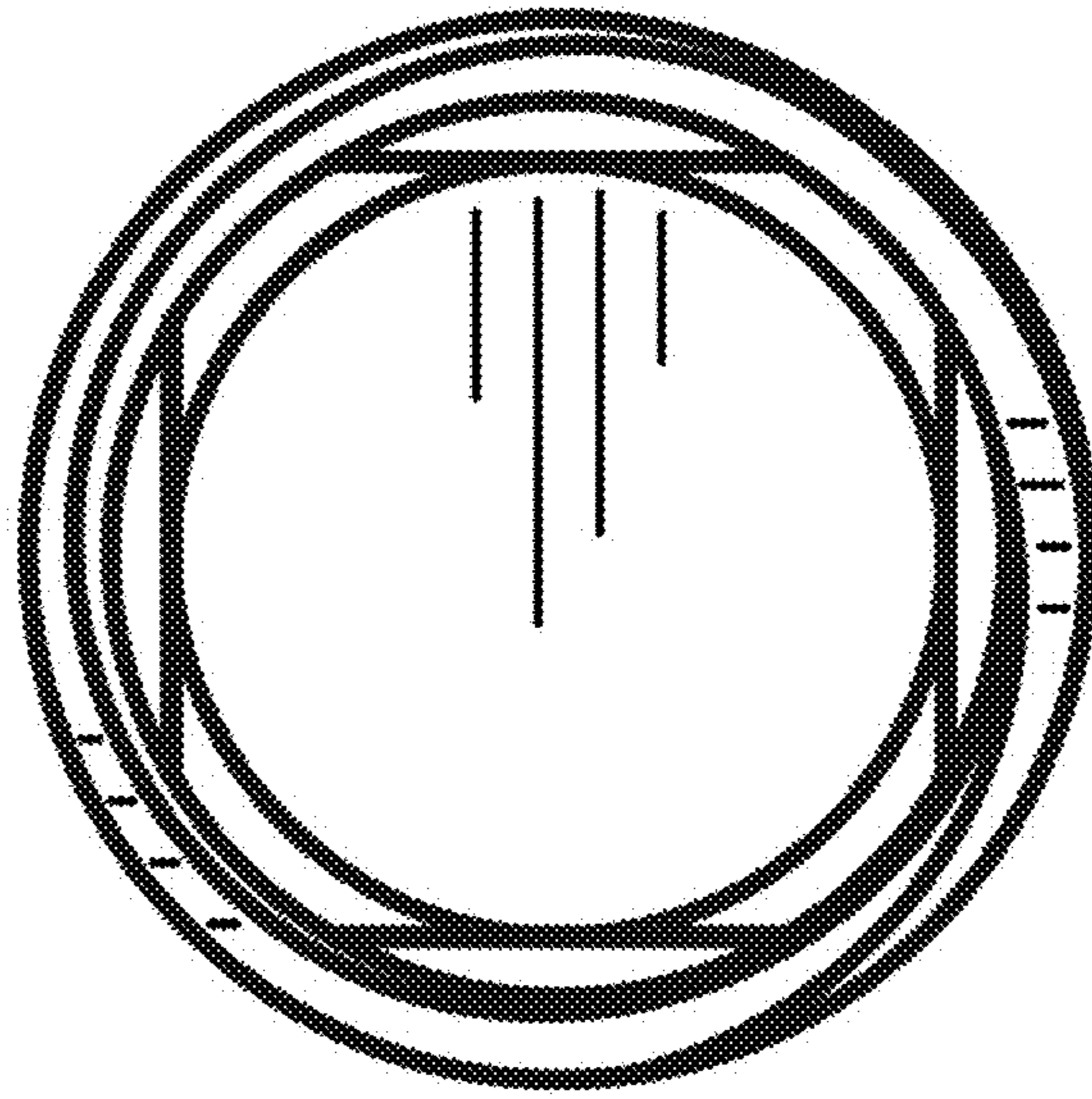

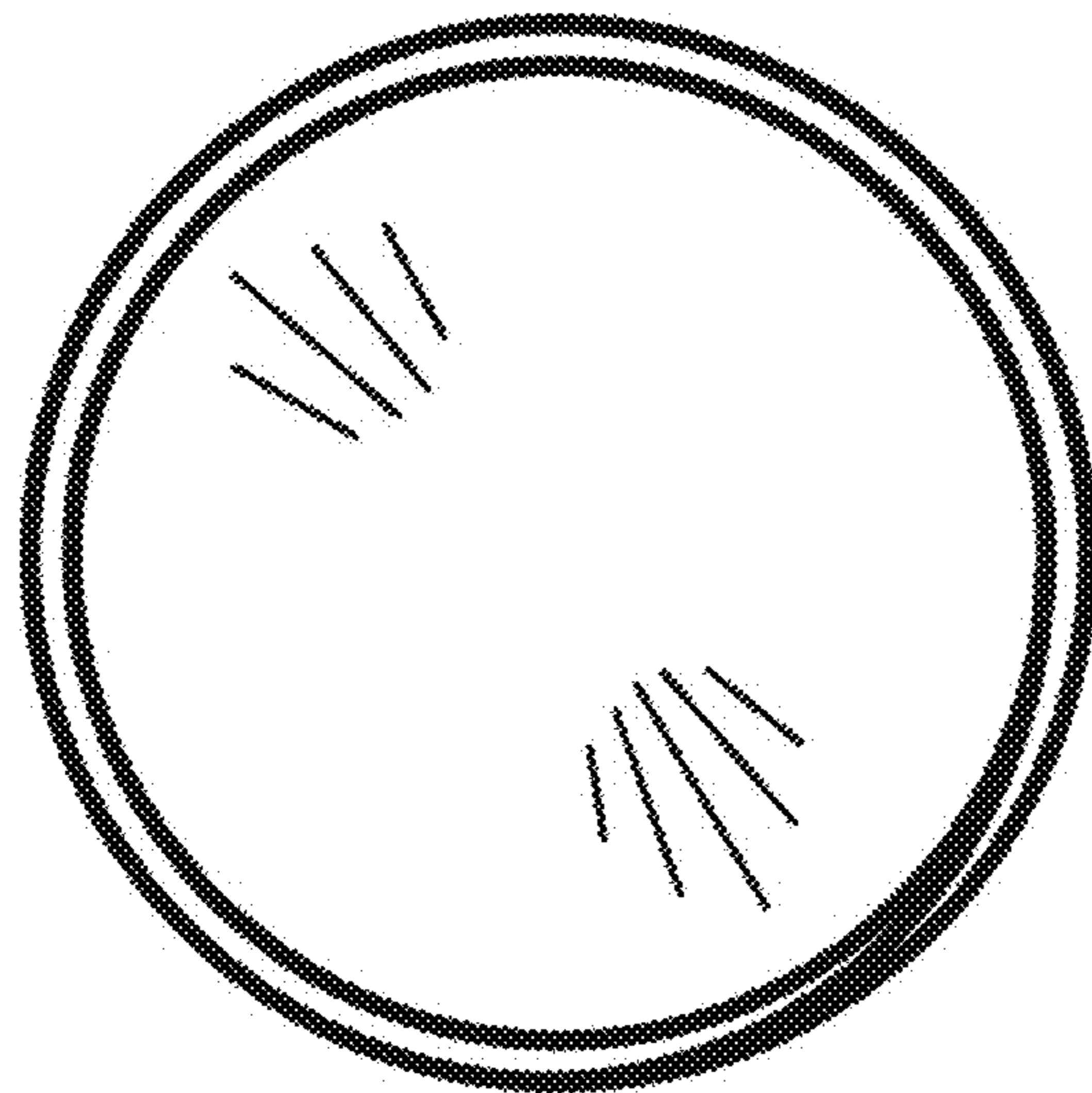

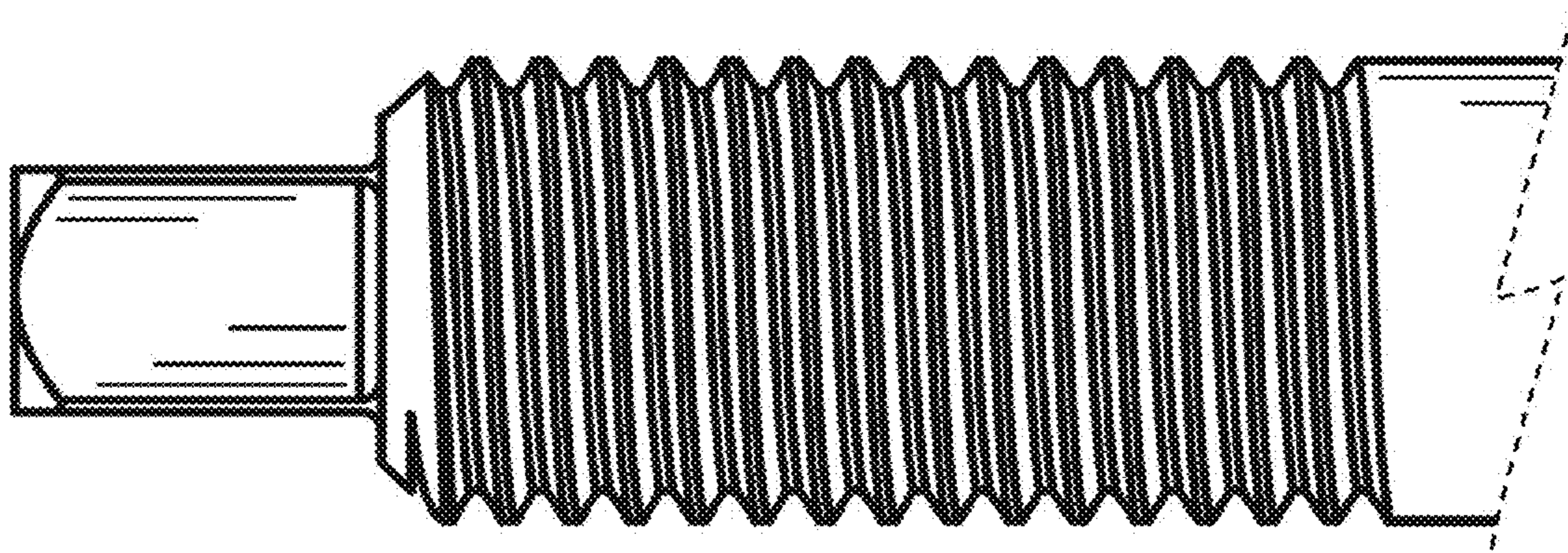

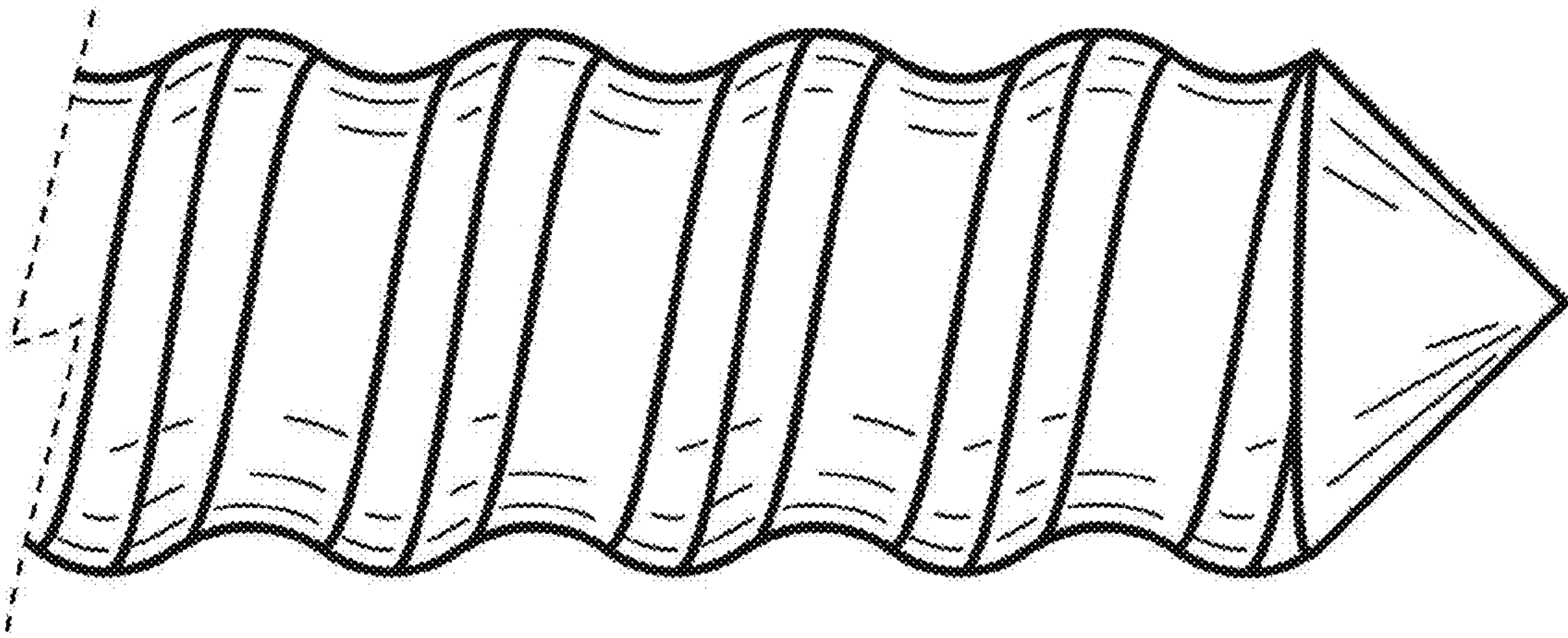
