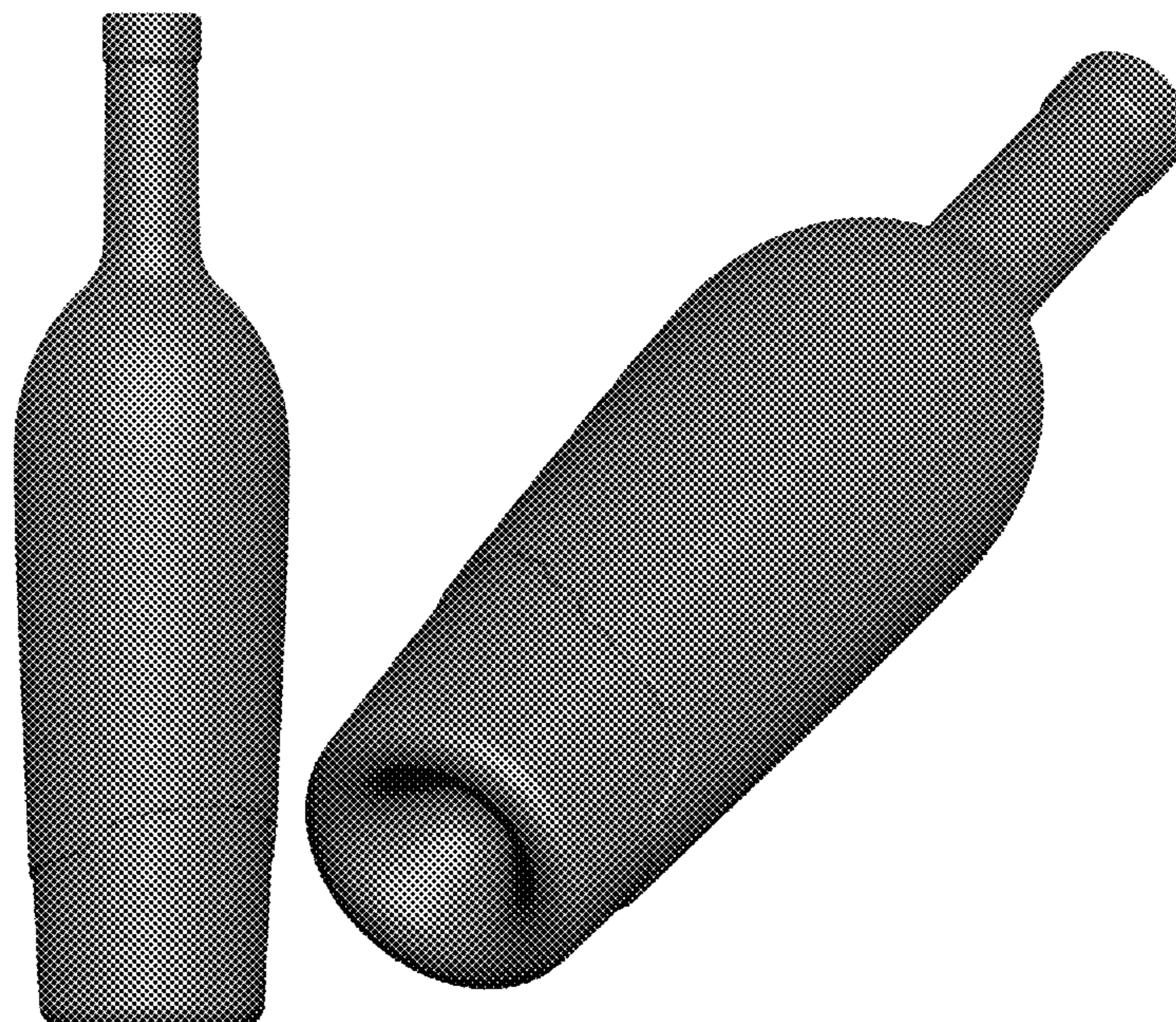
The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

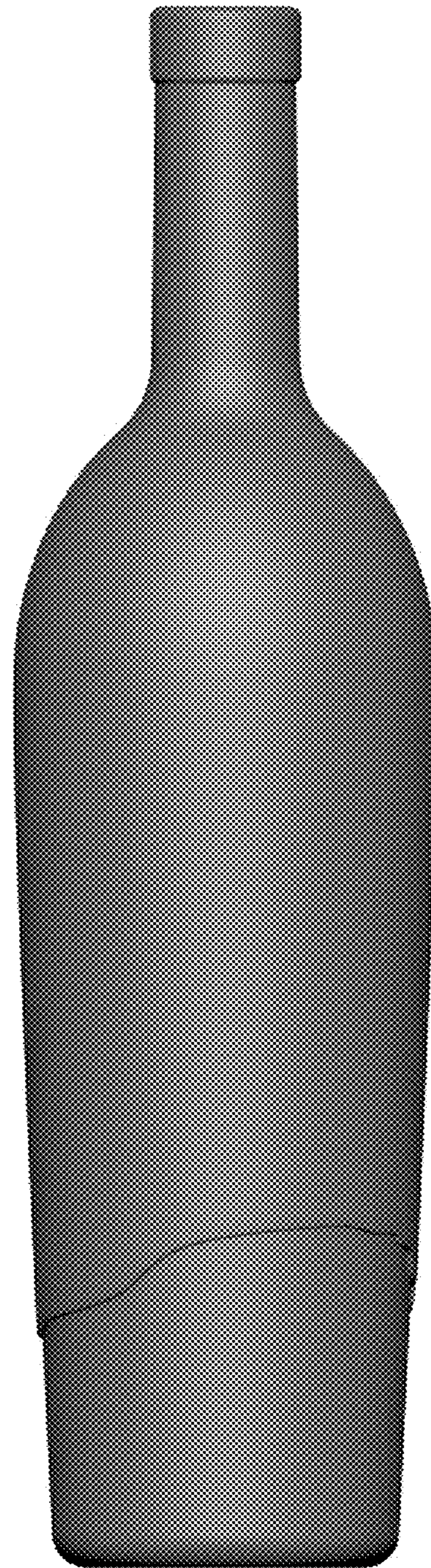
- 1. Bottle

- 1.3 : Front
- 1.4 : Right
- 1.5 : Perspective
- 1.6 : Perspective
- 1.7 : Top
- 1.8 : Bottom

The design consists of the shape of a bottle appearing as obtained through the glass casting of a lower and an upper half having different diameter one another, and where the casting line presents as an irregular, jagged line running around the surface of the bottle body.

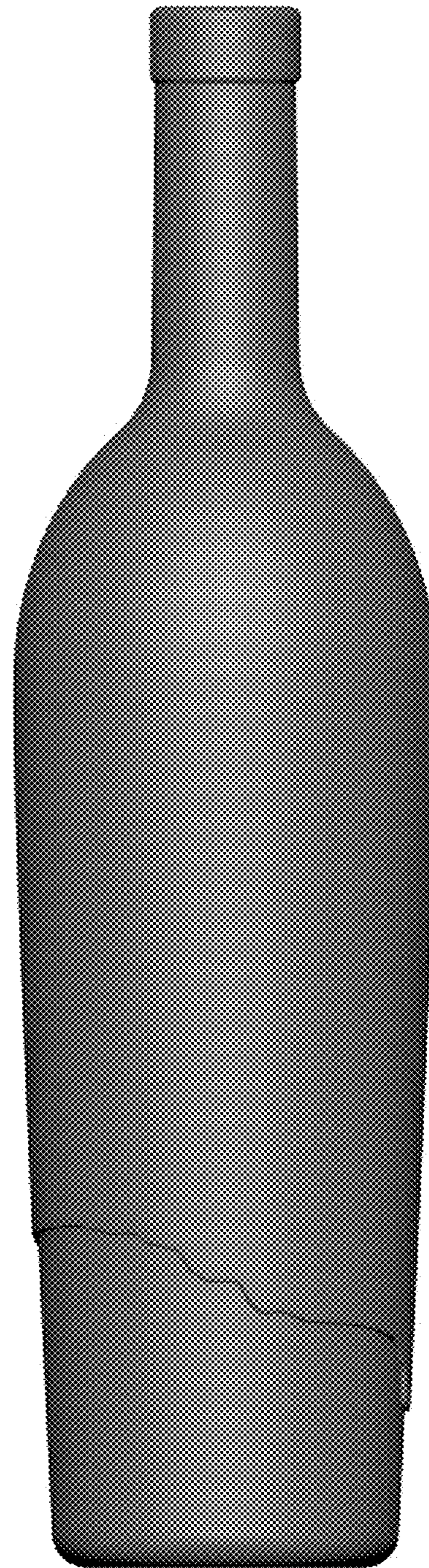

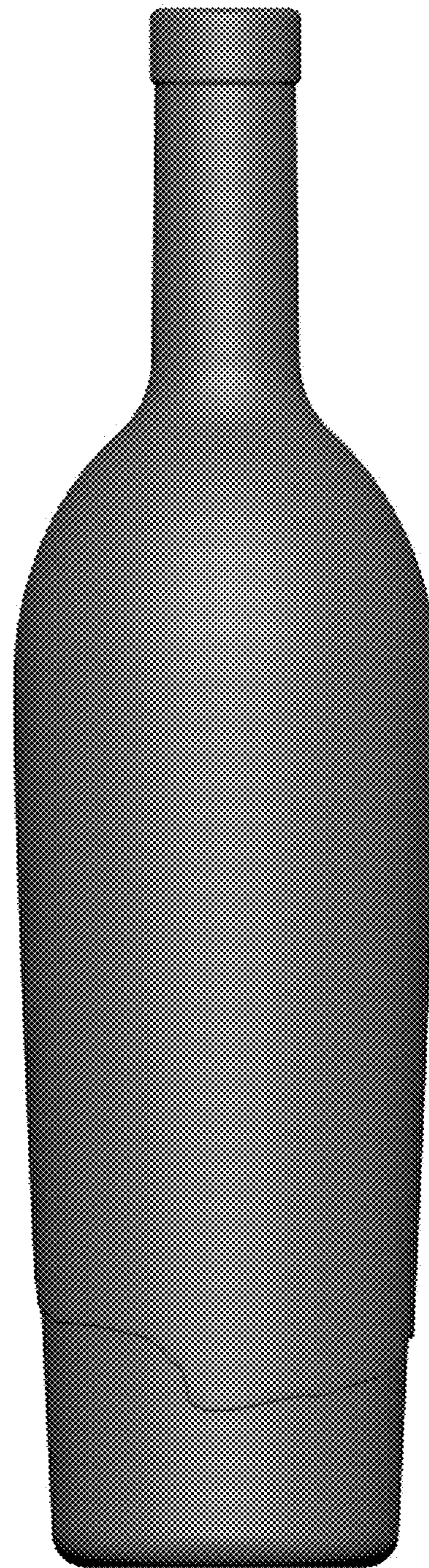

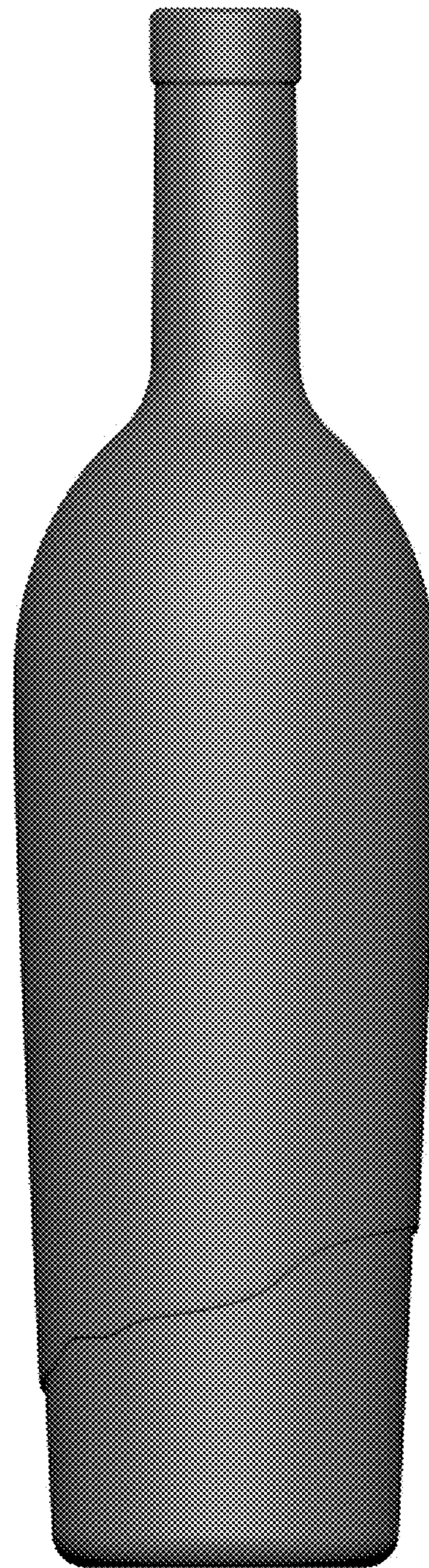

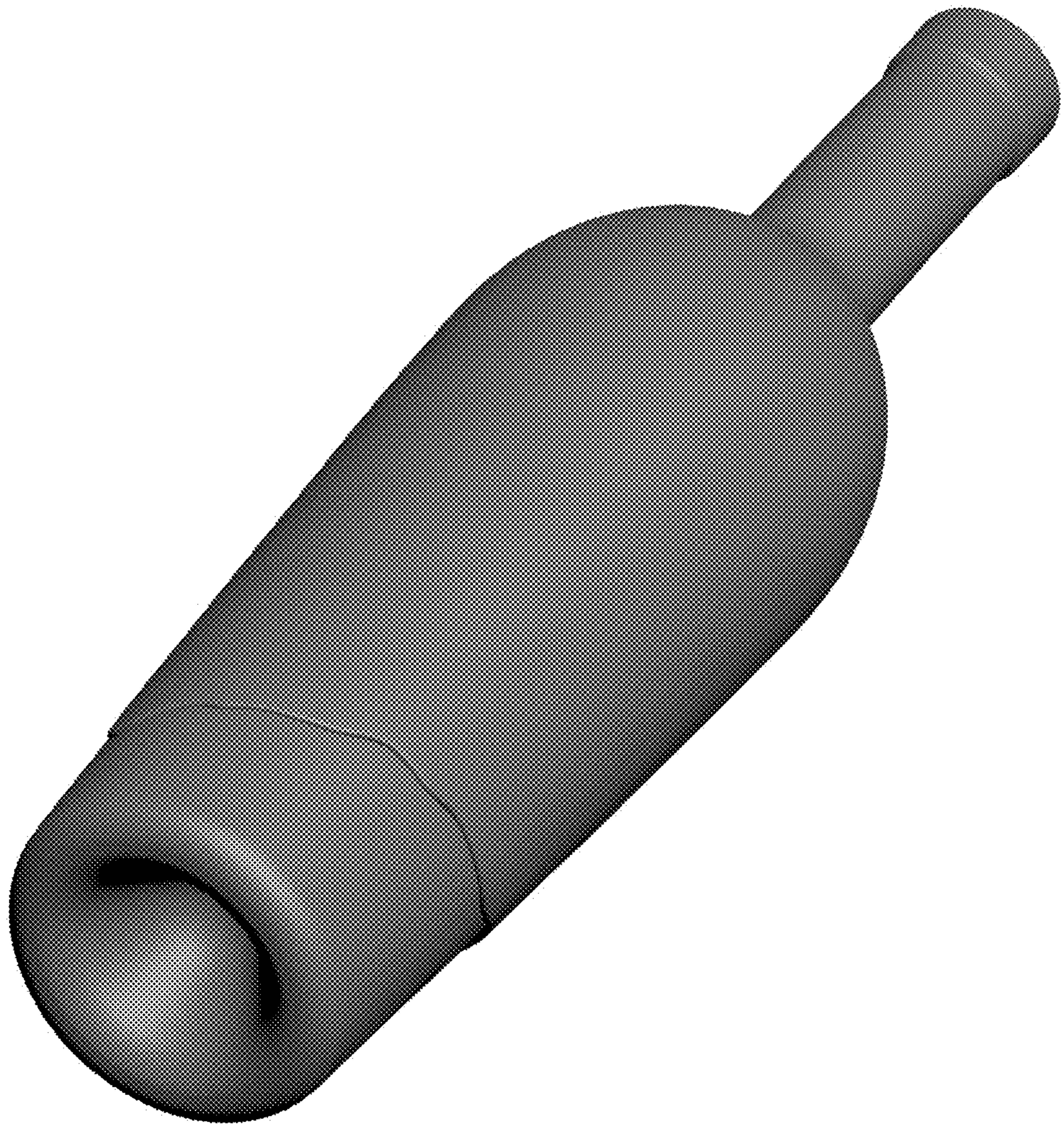

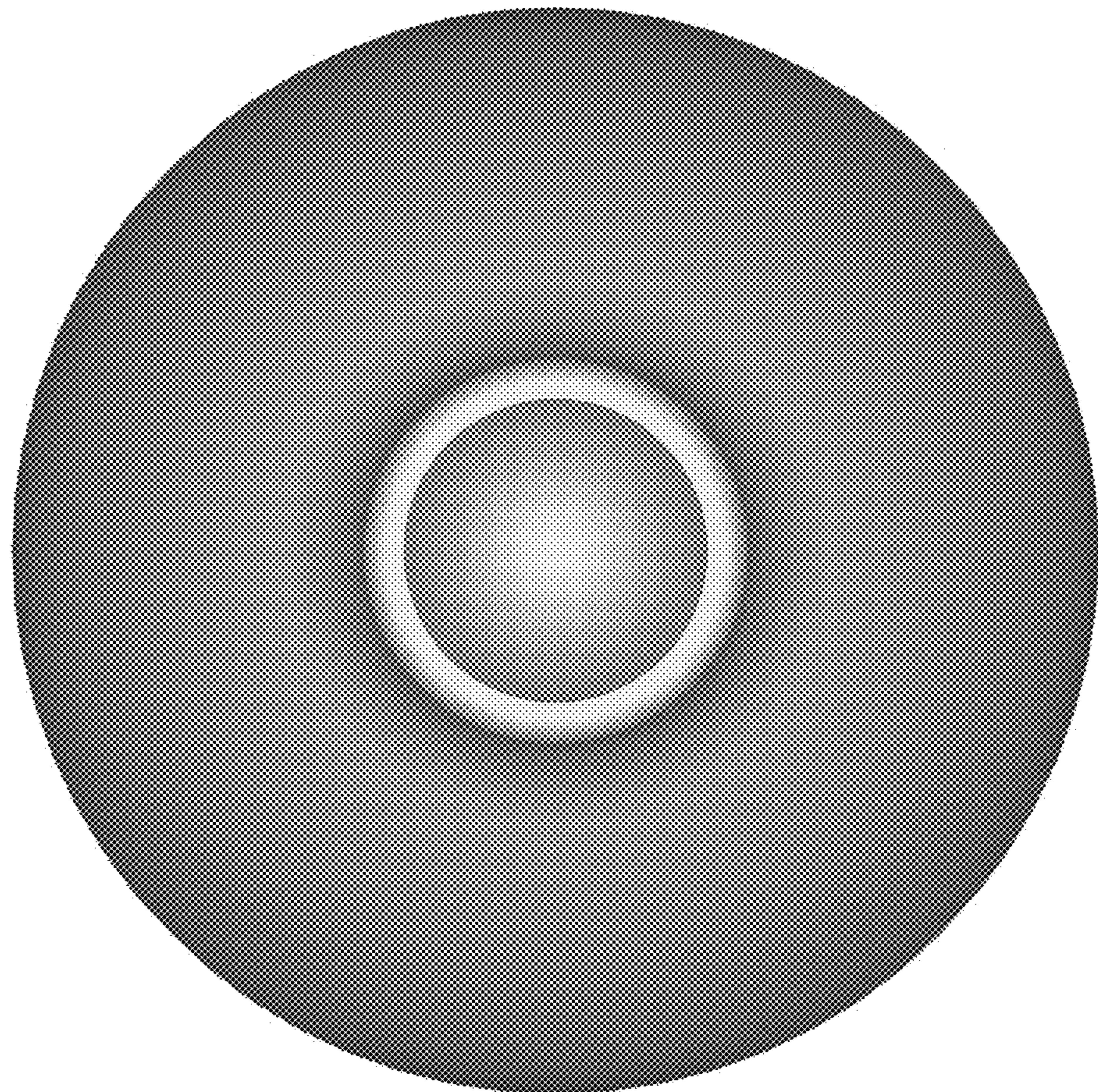
