The ornamental design for a baby bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view a transparent embodiment of a baby bottle incorporating the word BABY.

FIG. 2 is a left side view of the bottle shown in FIG. 1.

FIG. 3 is a right side view of the bottle shown in FIG. 1.

FIG. 4 is a rear view of the bottle shown in FIG. 1.

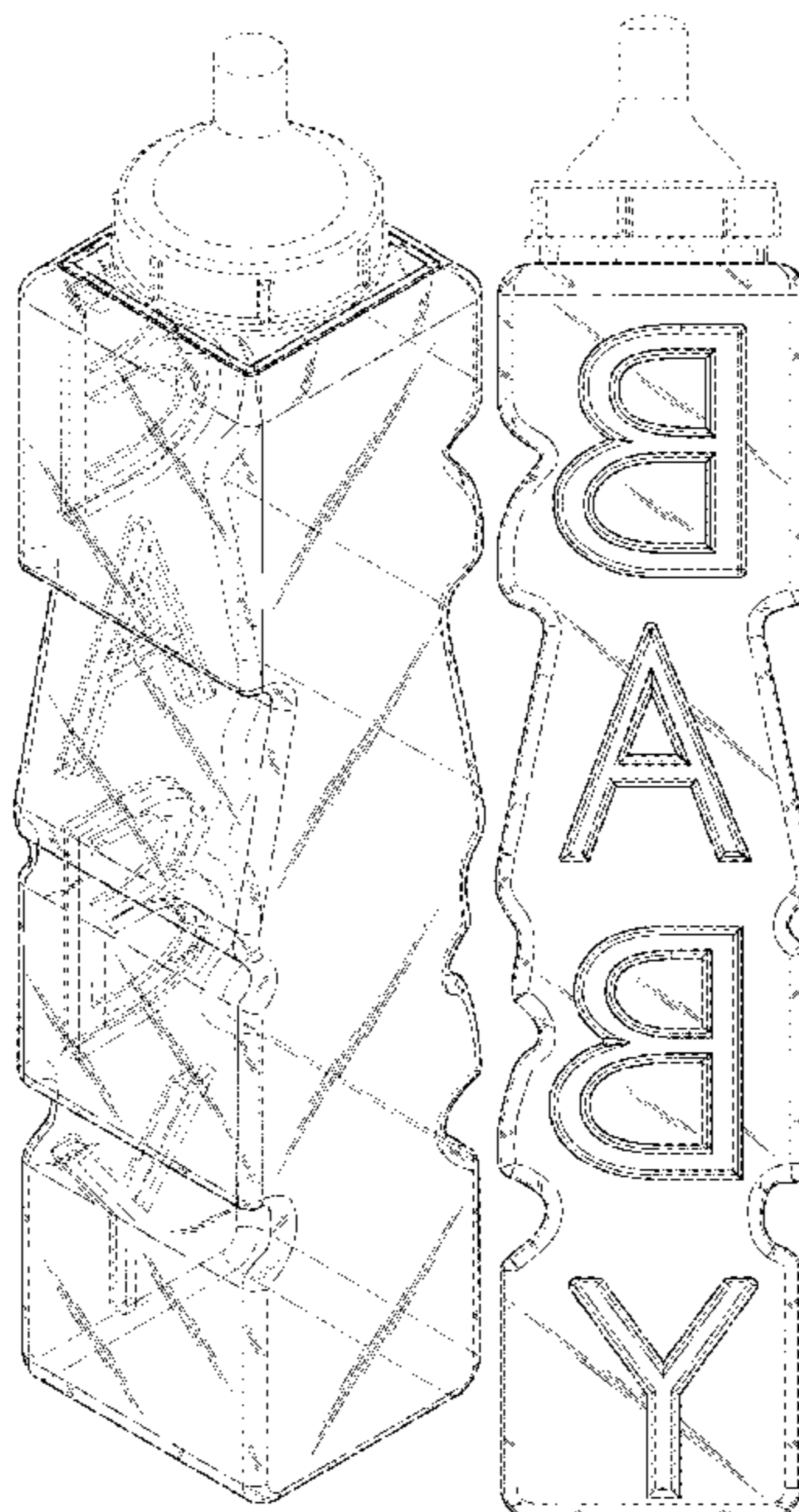
FIG. 5 is a front view of the bottle shown in FIG. 1.

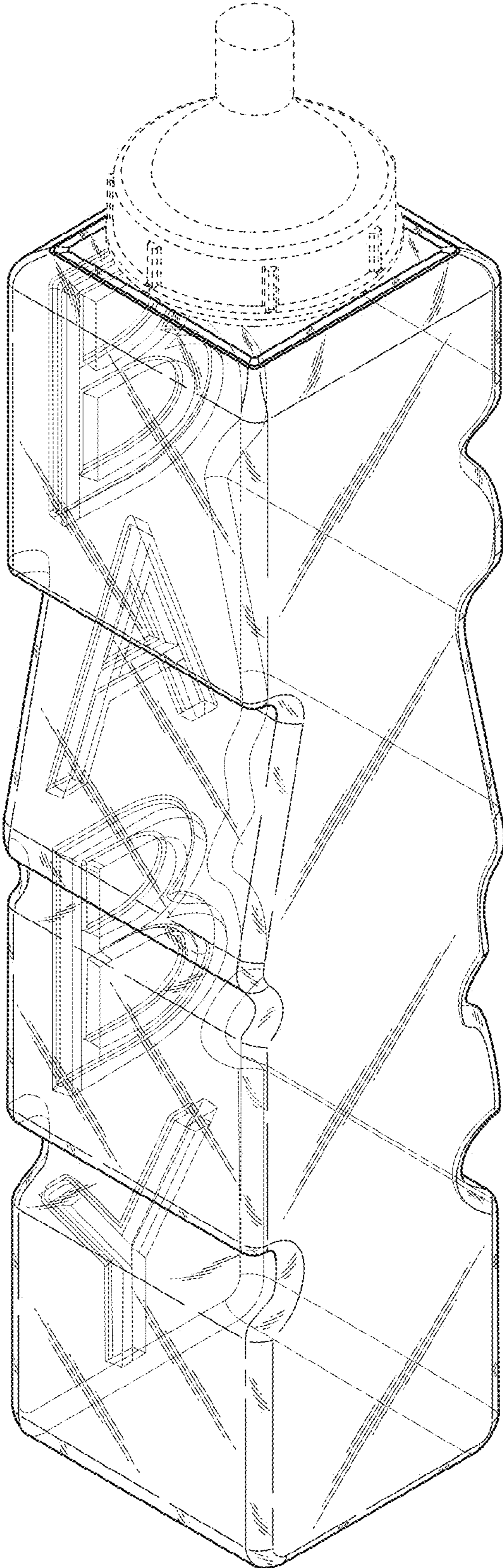

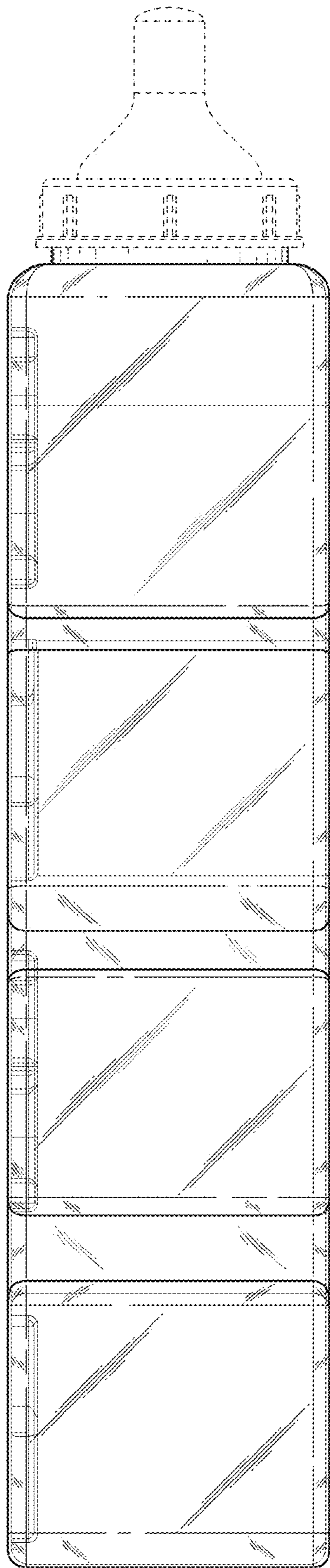

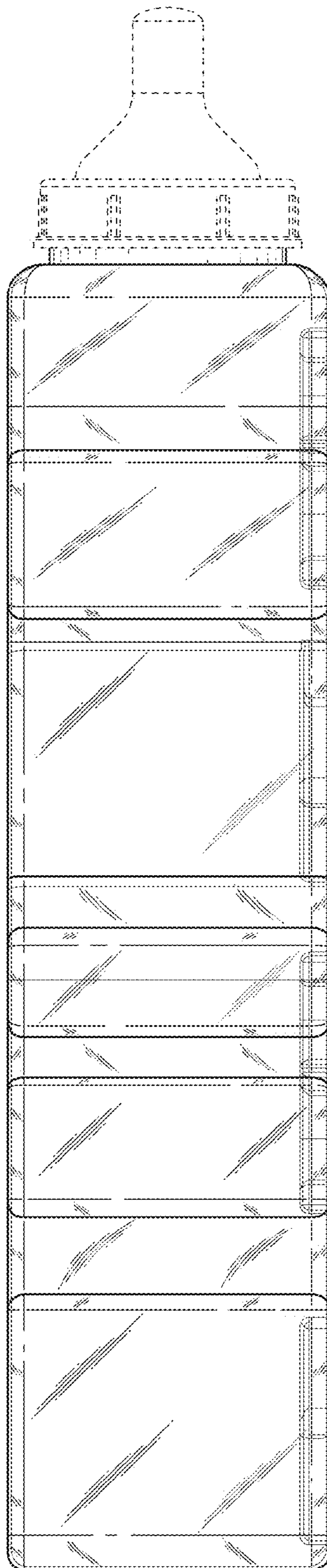

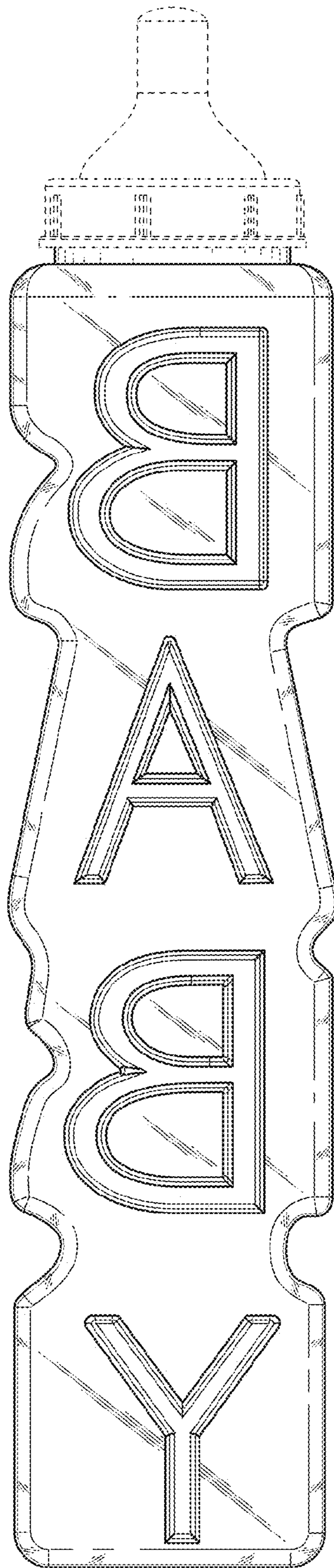

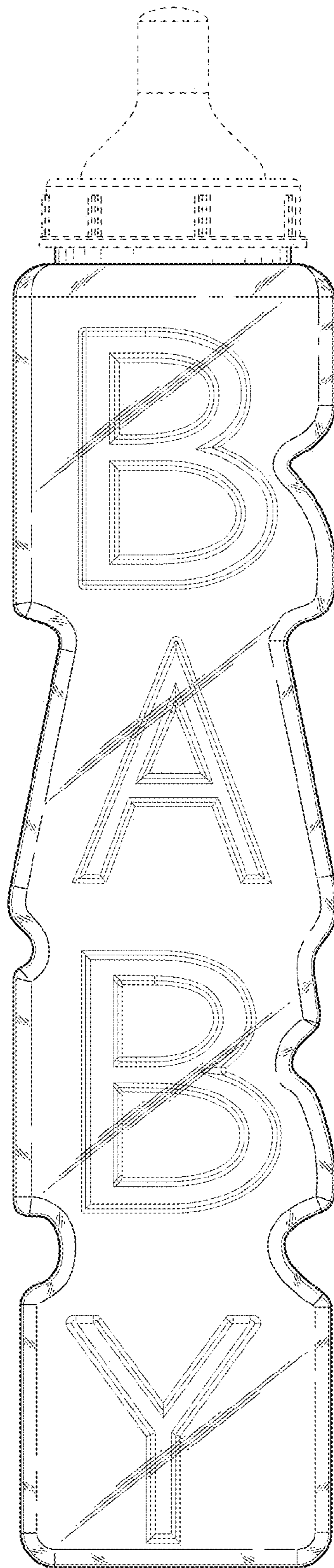

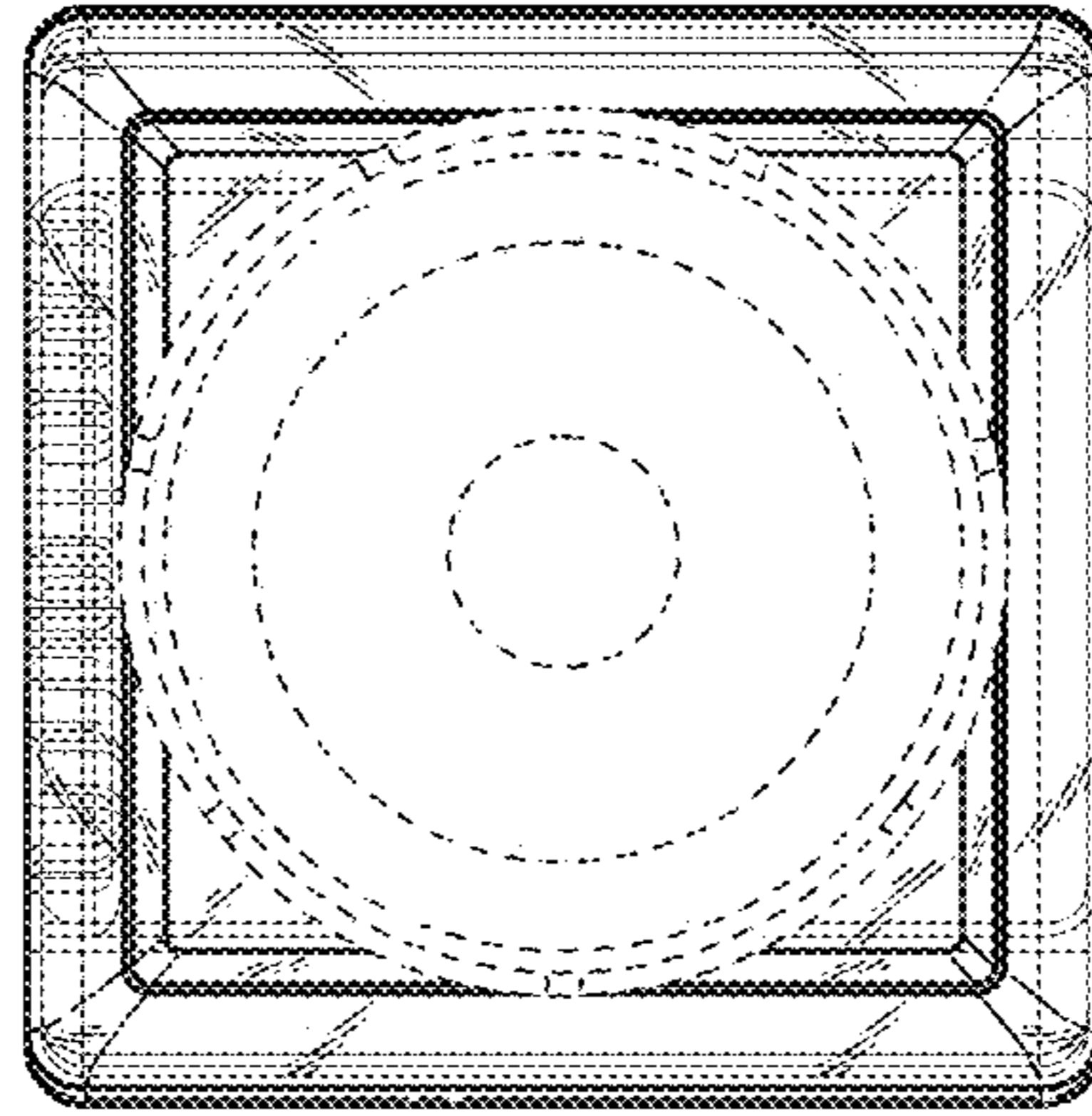

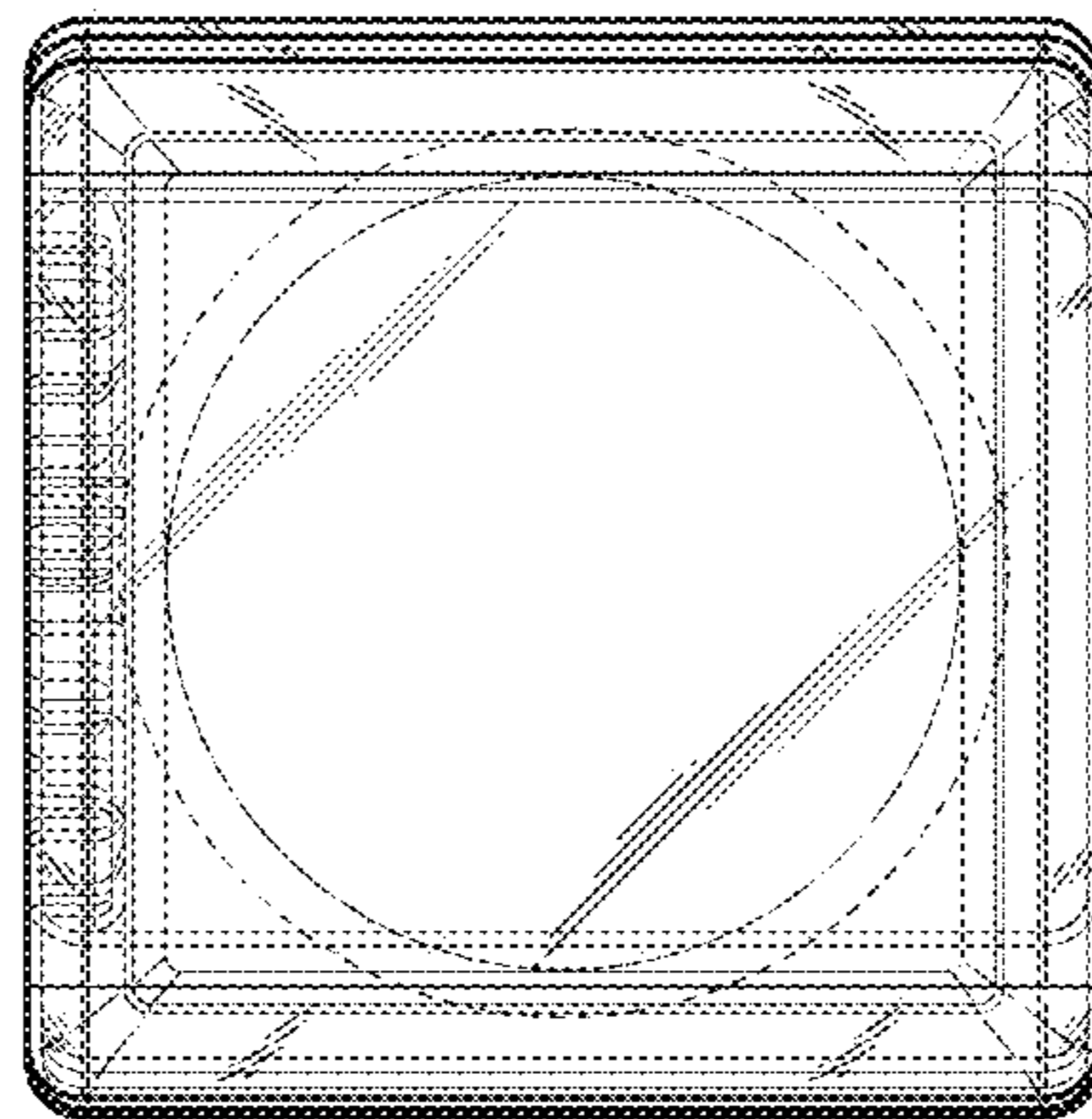
