DESCRIPTION

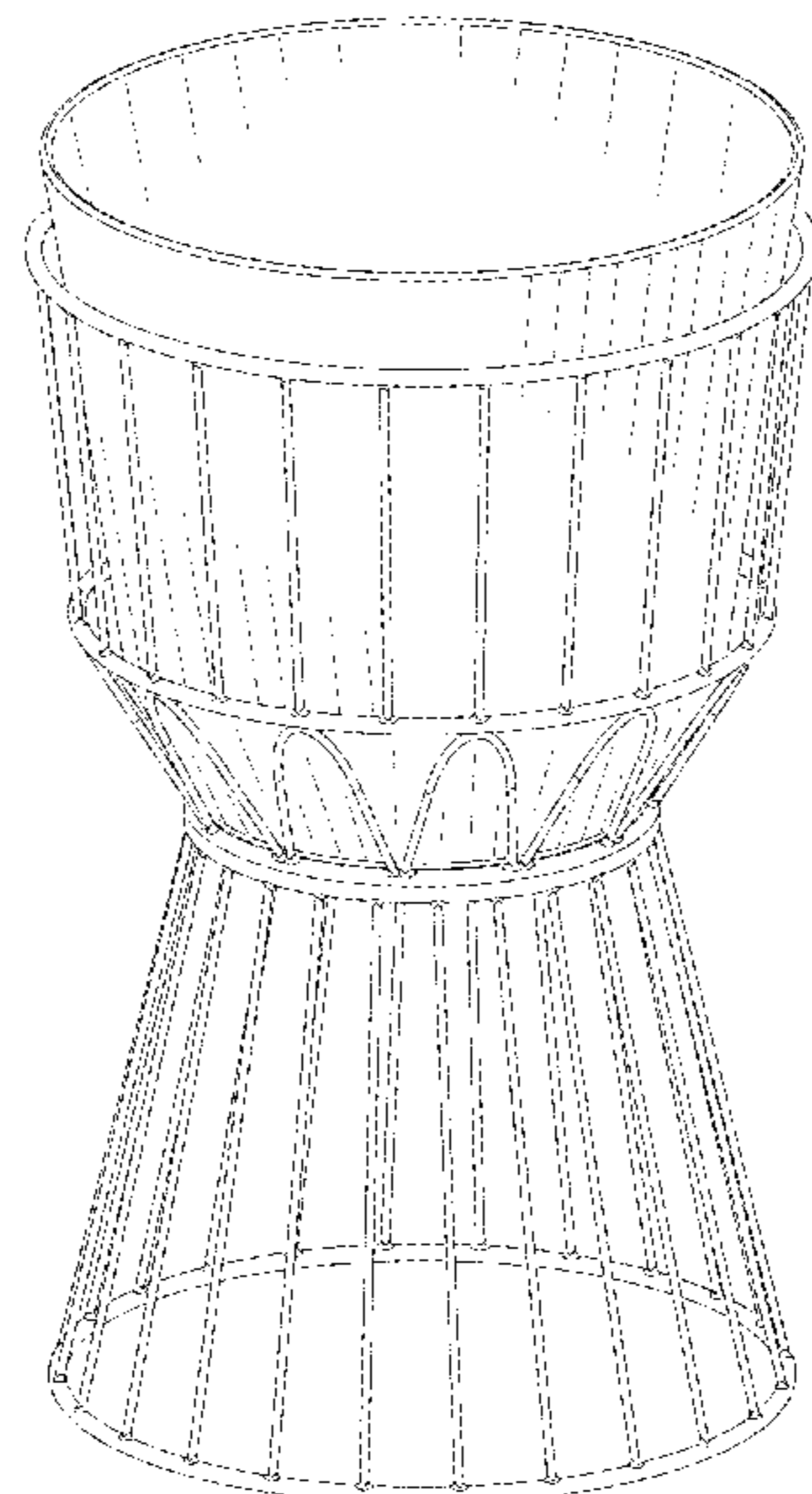
FIG. 1 is a perspective view of a planter with stand showing my new design;

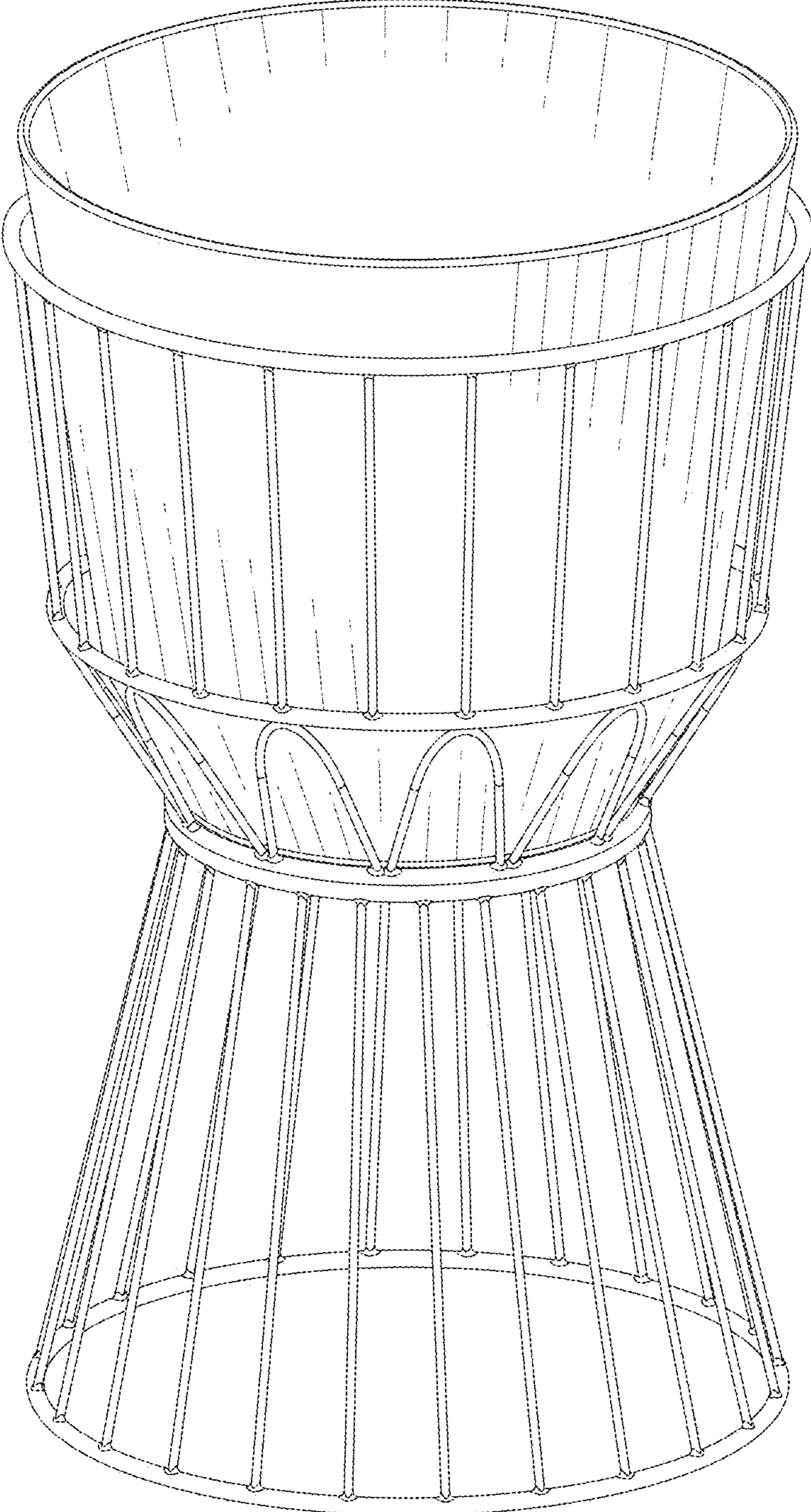

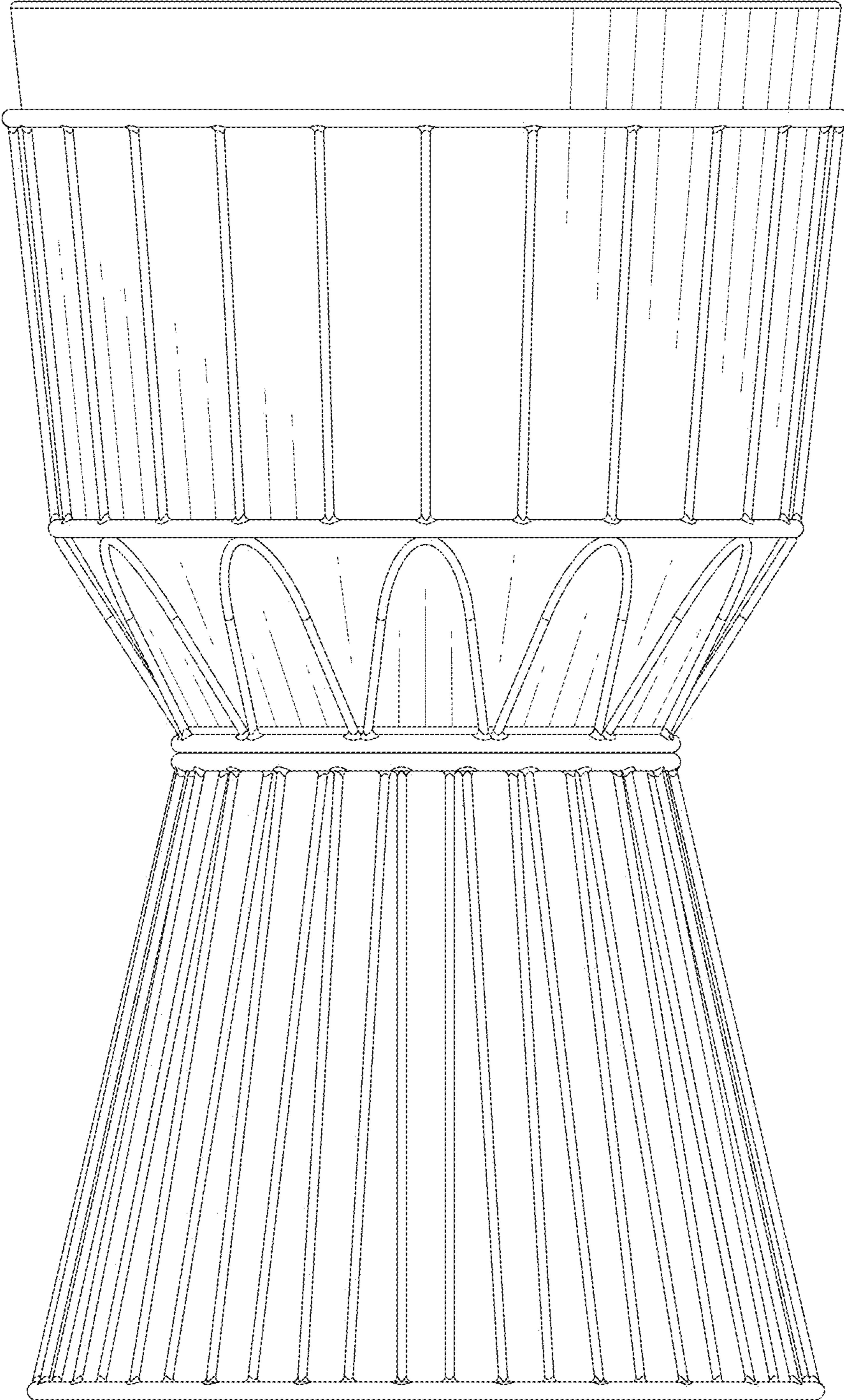

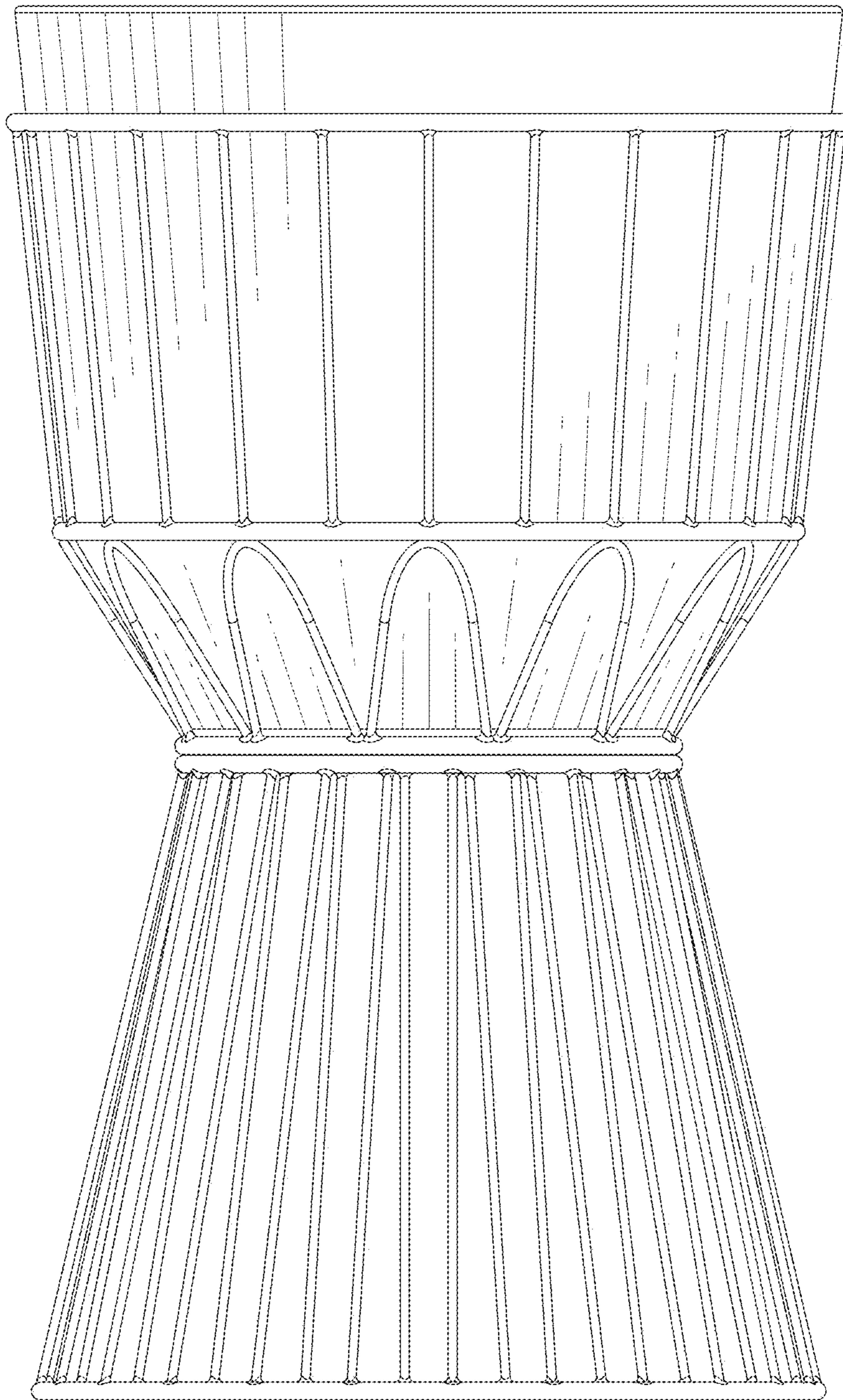

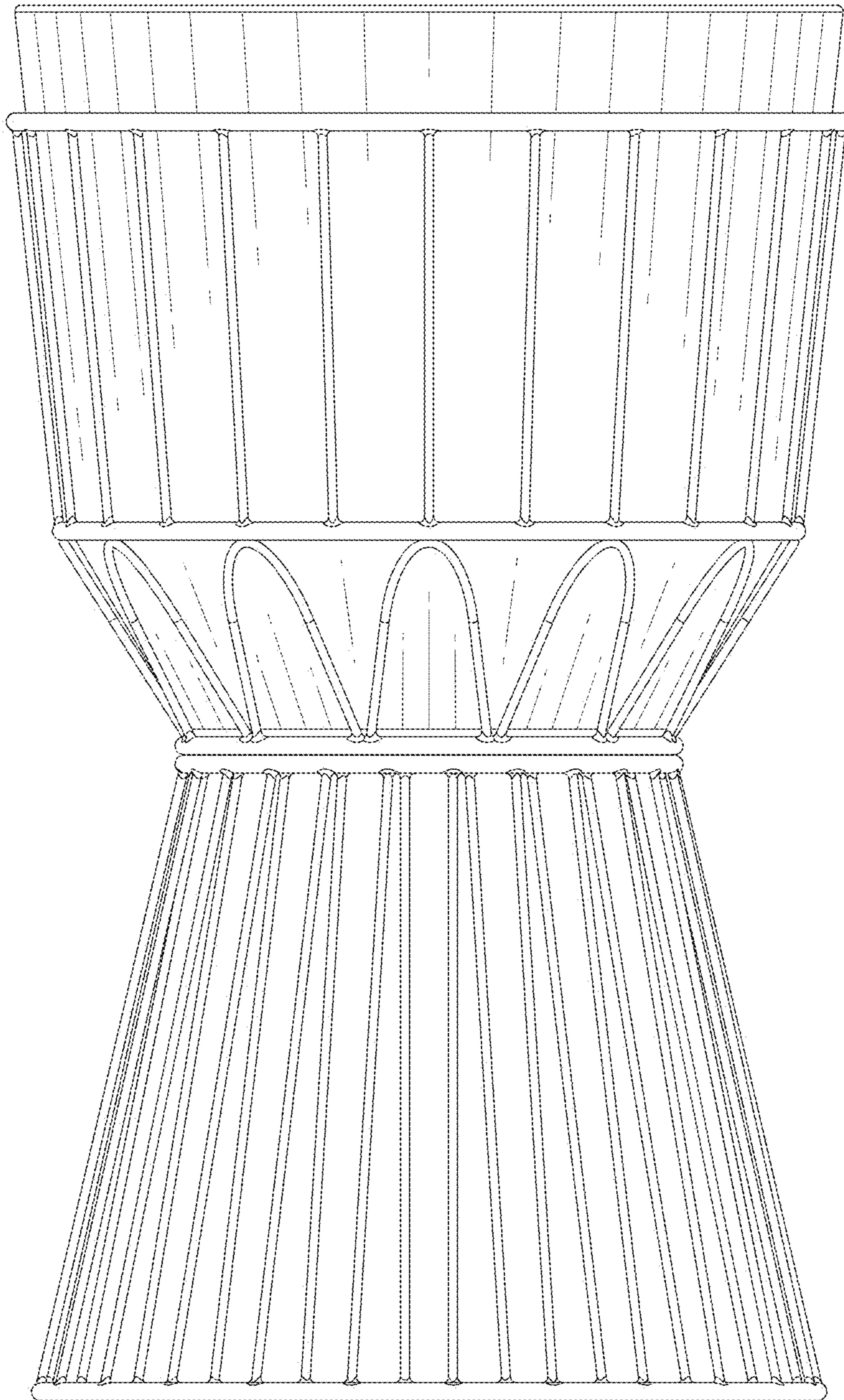

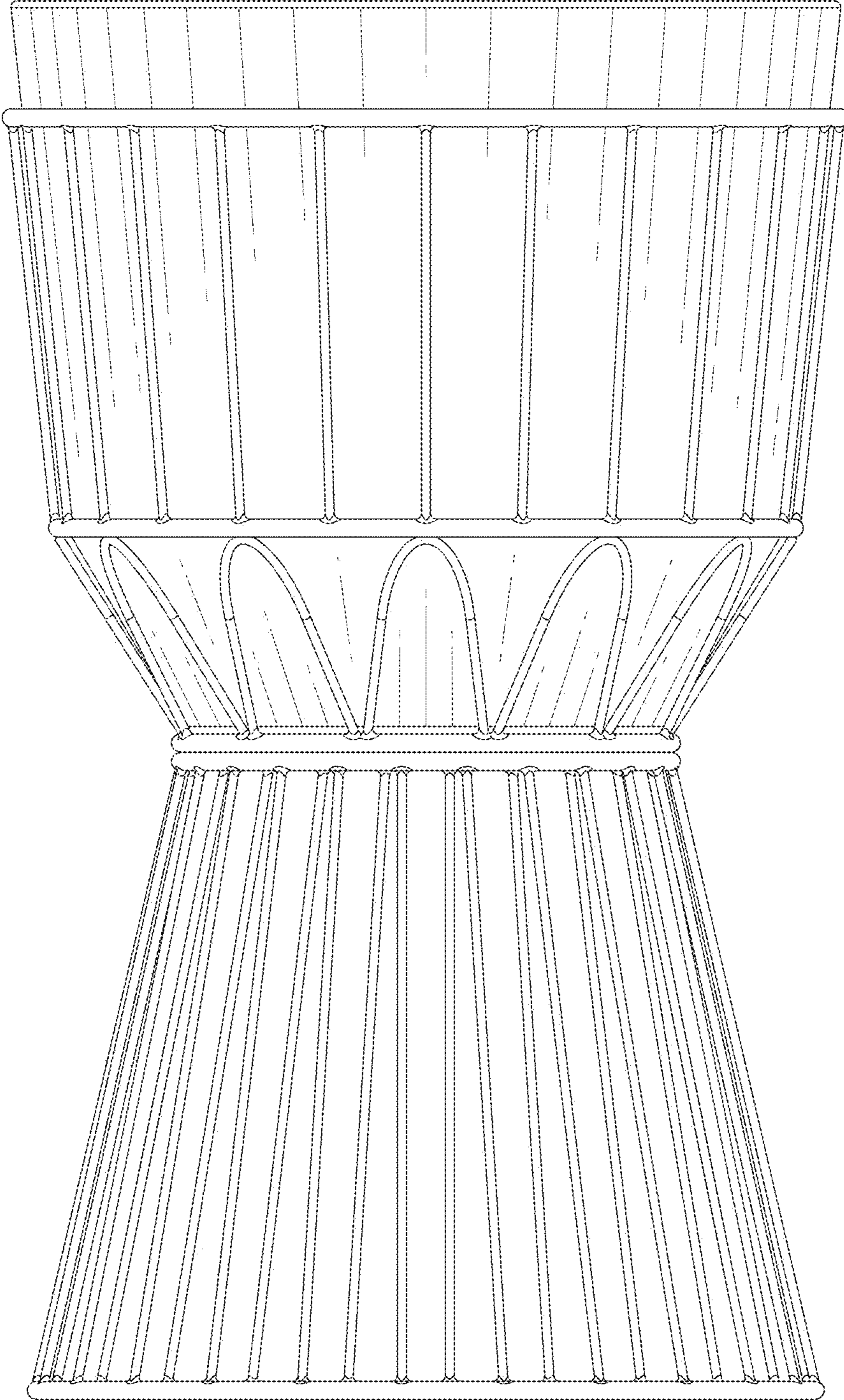

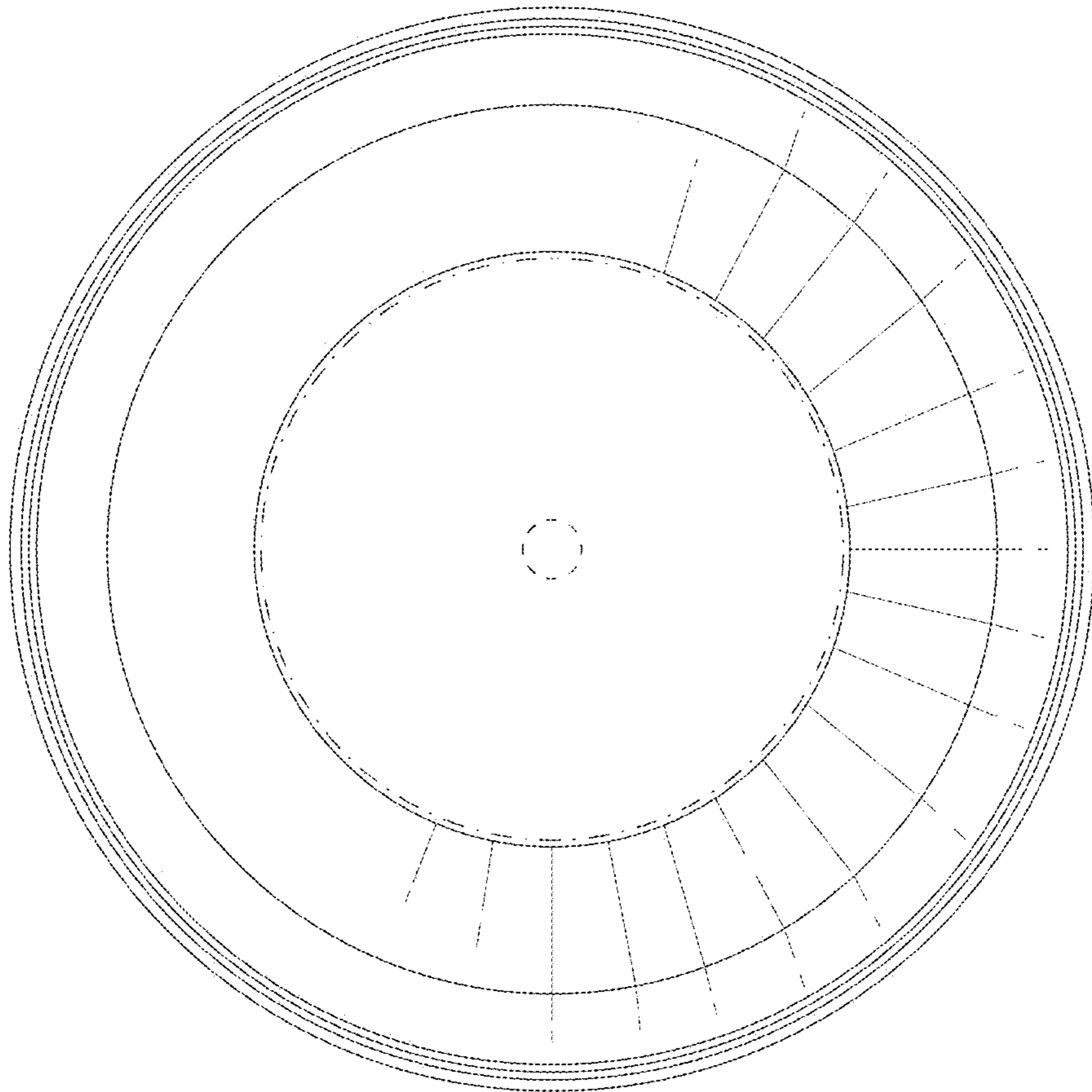

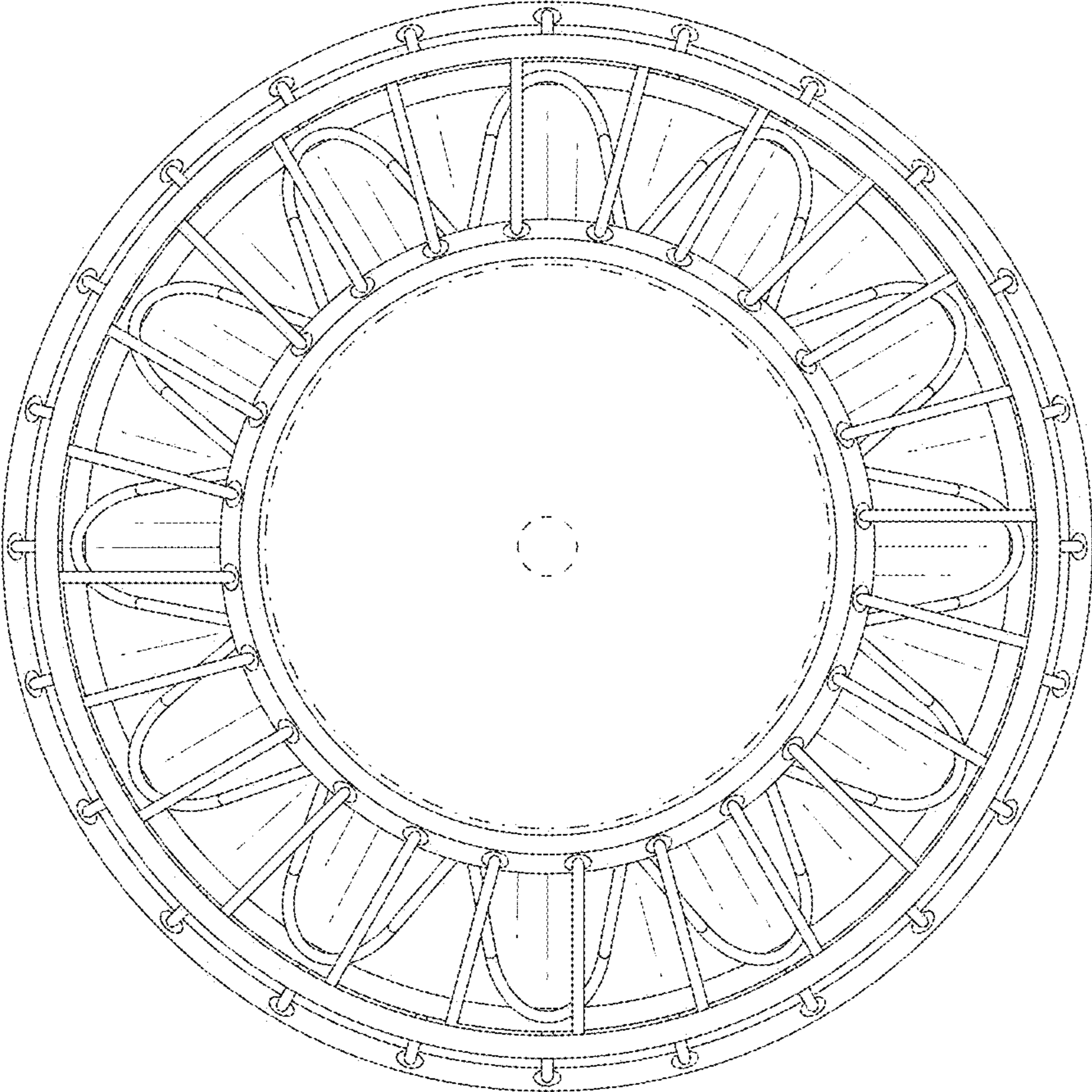
