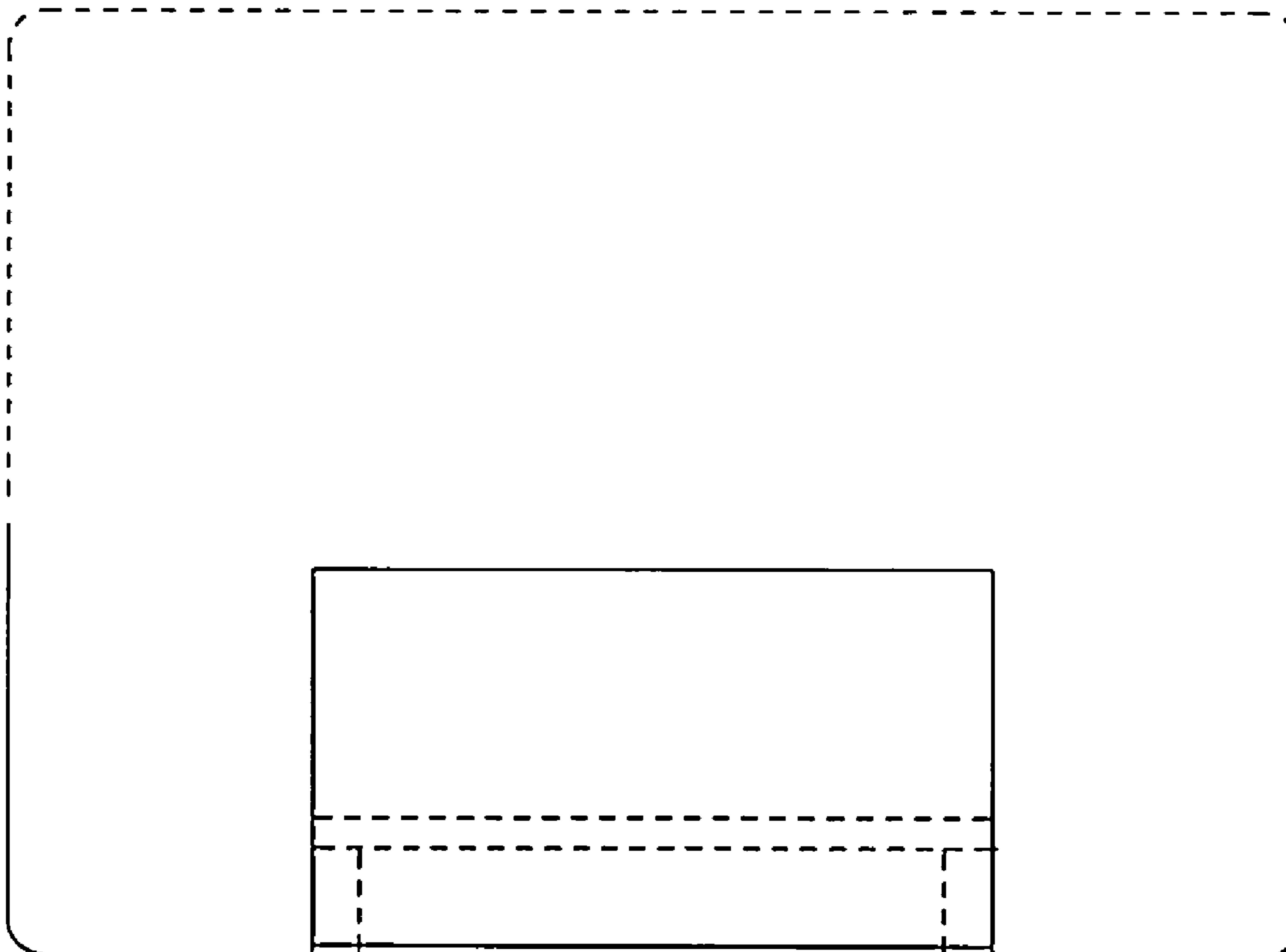
The ornamental design for a travel trailer front portion, as shown and described.

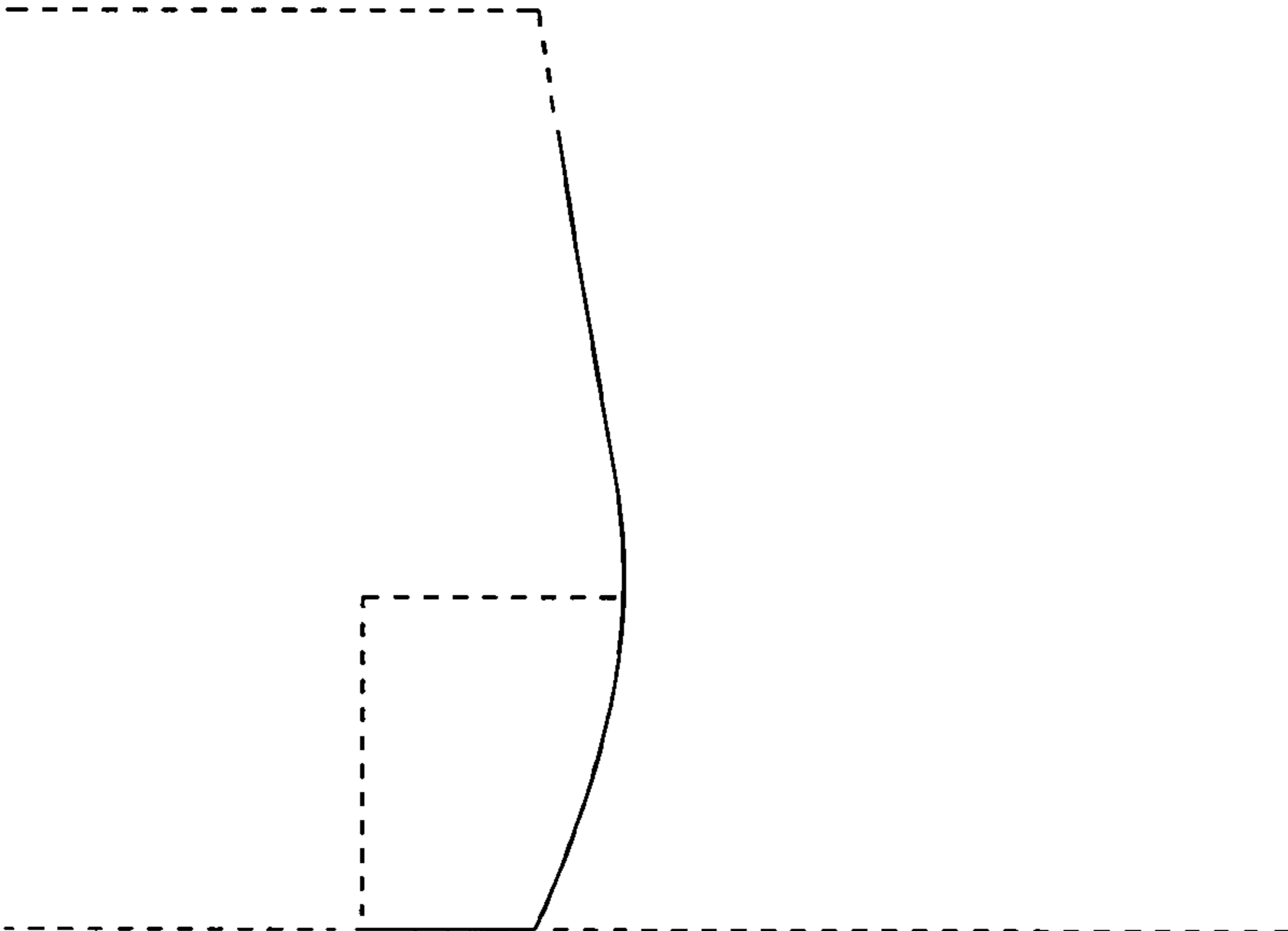
**DESCRIPTION**

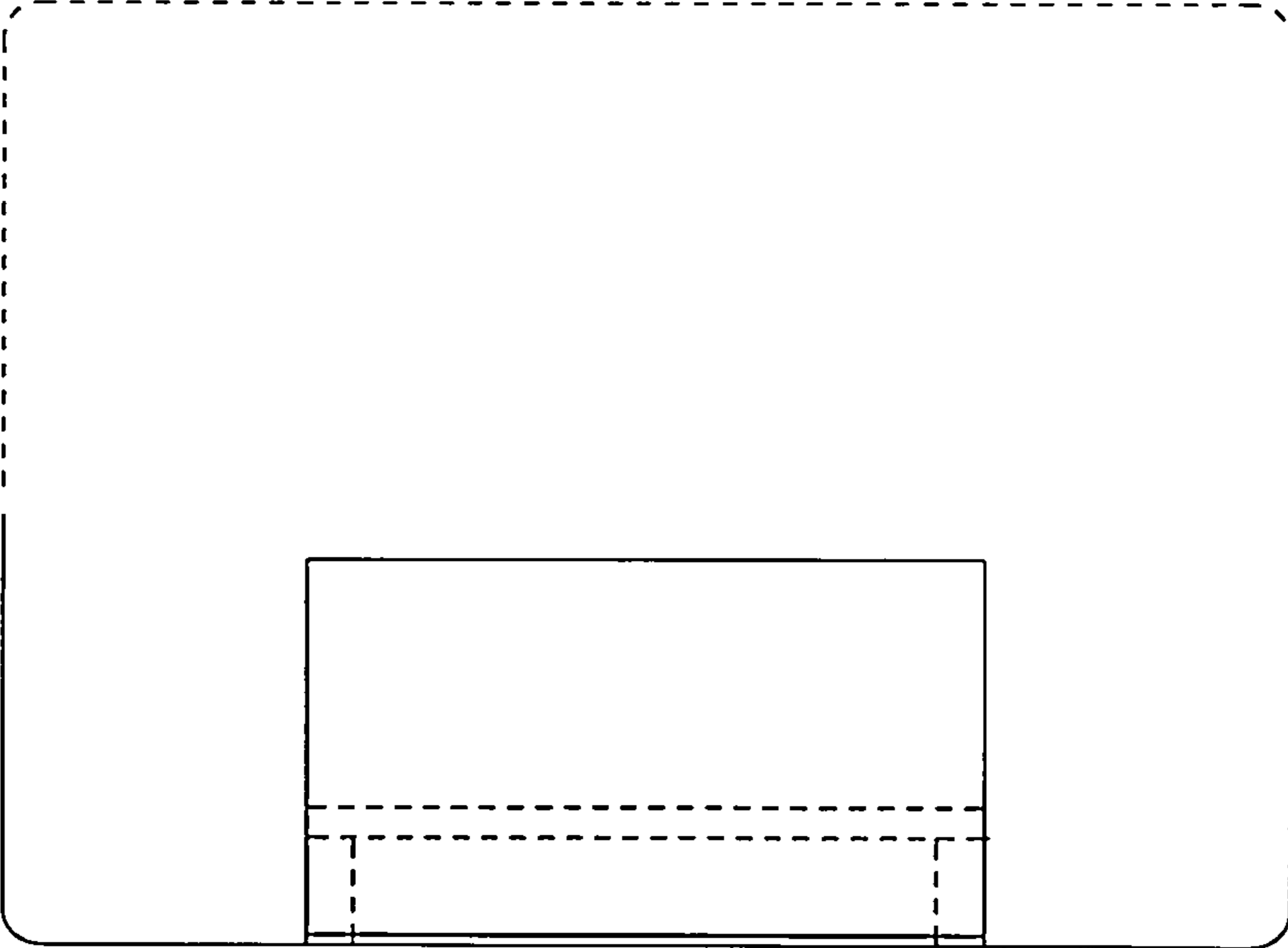
The dashed lines illustrate features of the travel trailer which are not part of the claimed invention.
