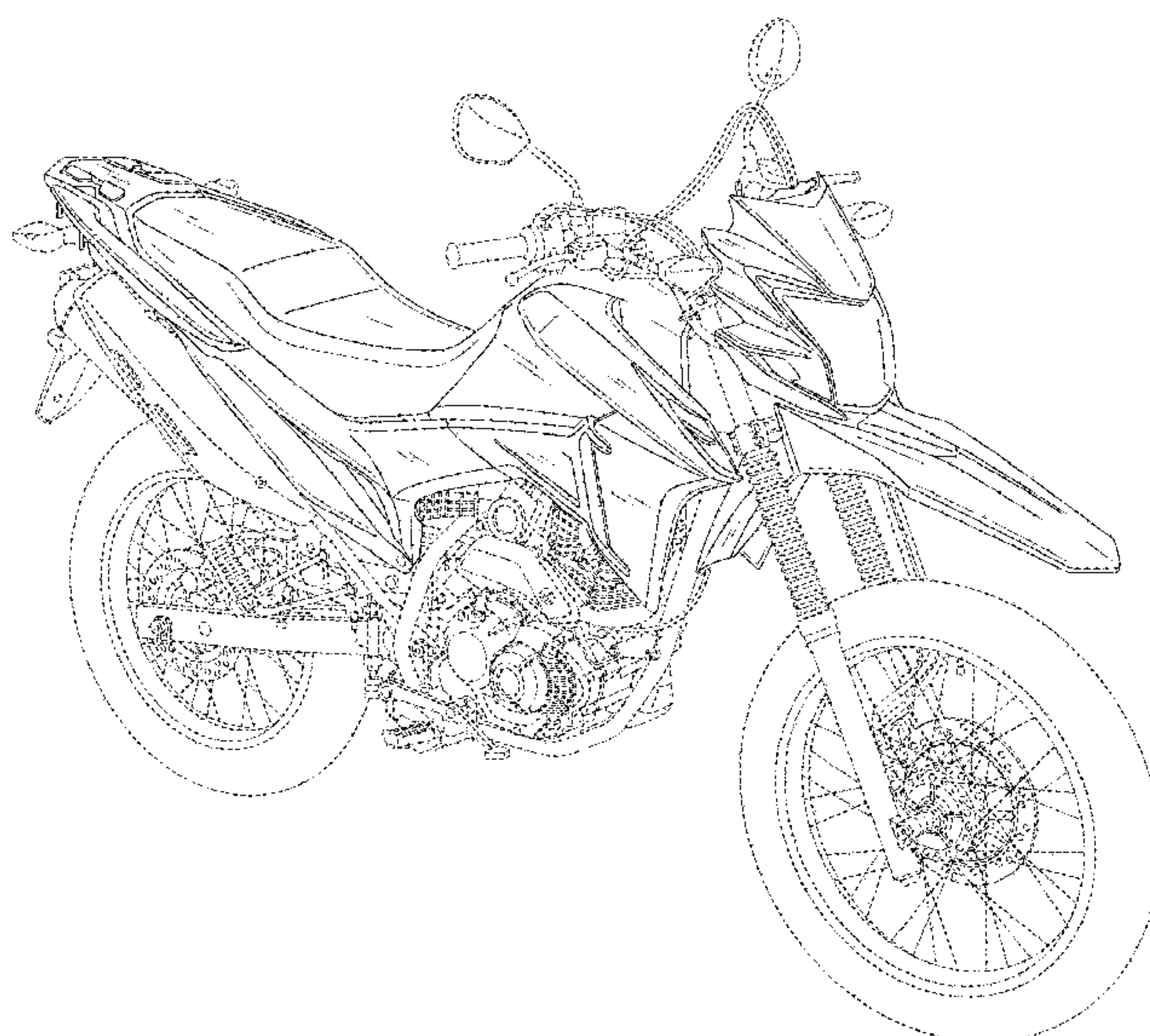
(57) **CLAIM**

The ornamental design for a motorcycle and/or replica thereof, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a motorcycle and/or replica thereof, showing my new design;
FIG. 2 is a second perspective view thereof;

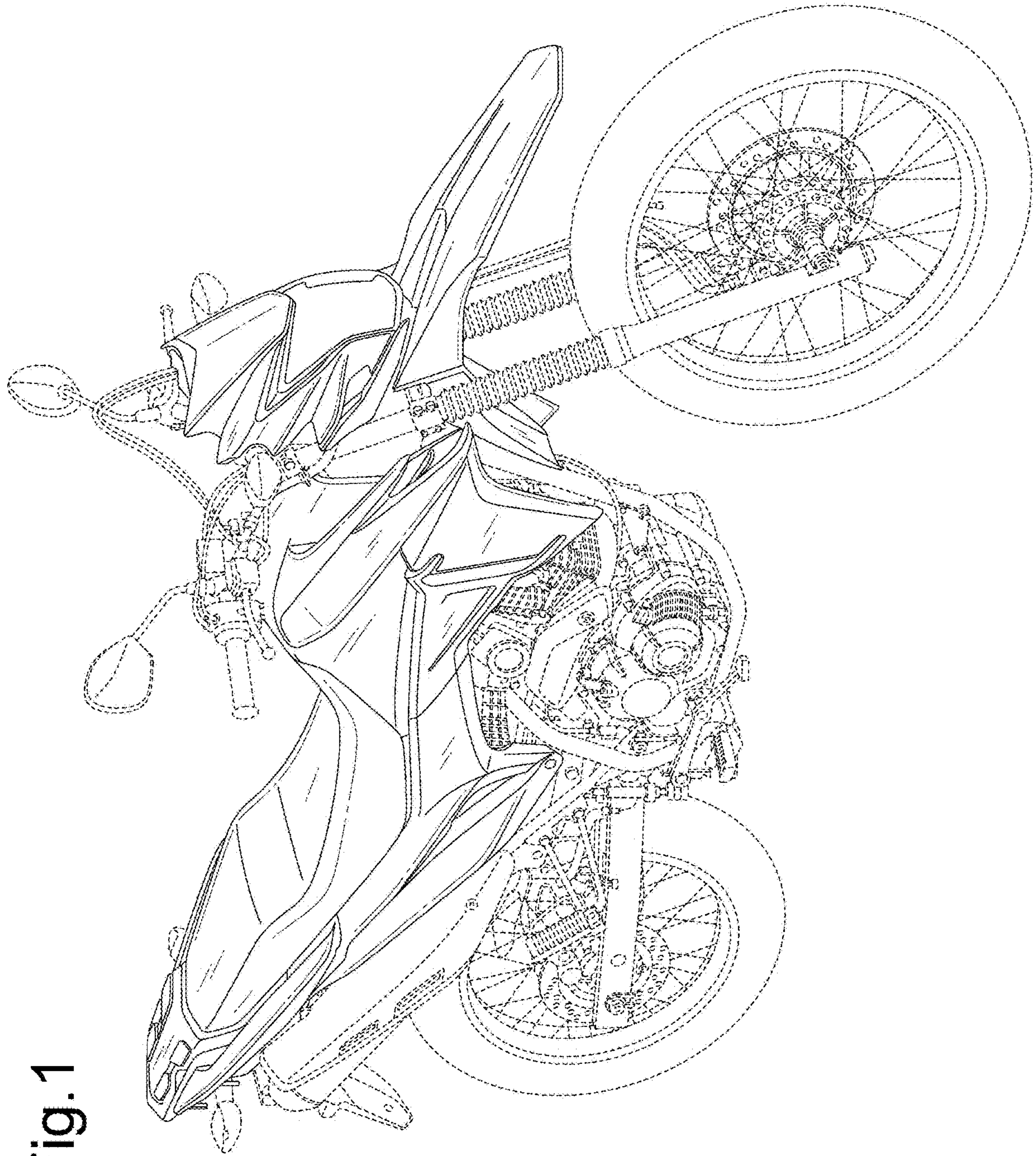

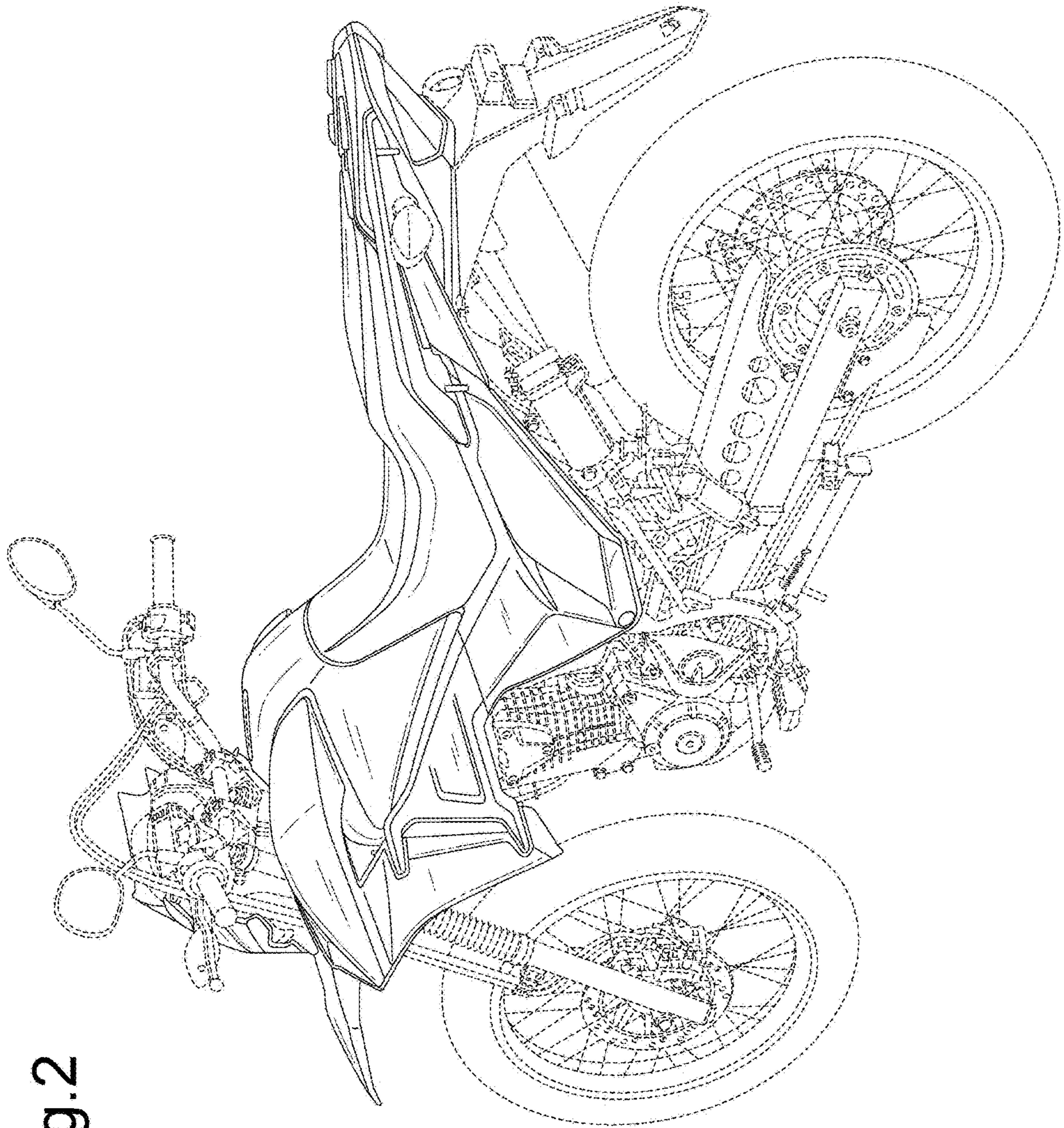

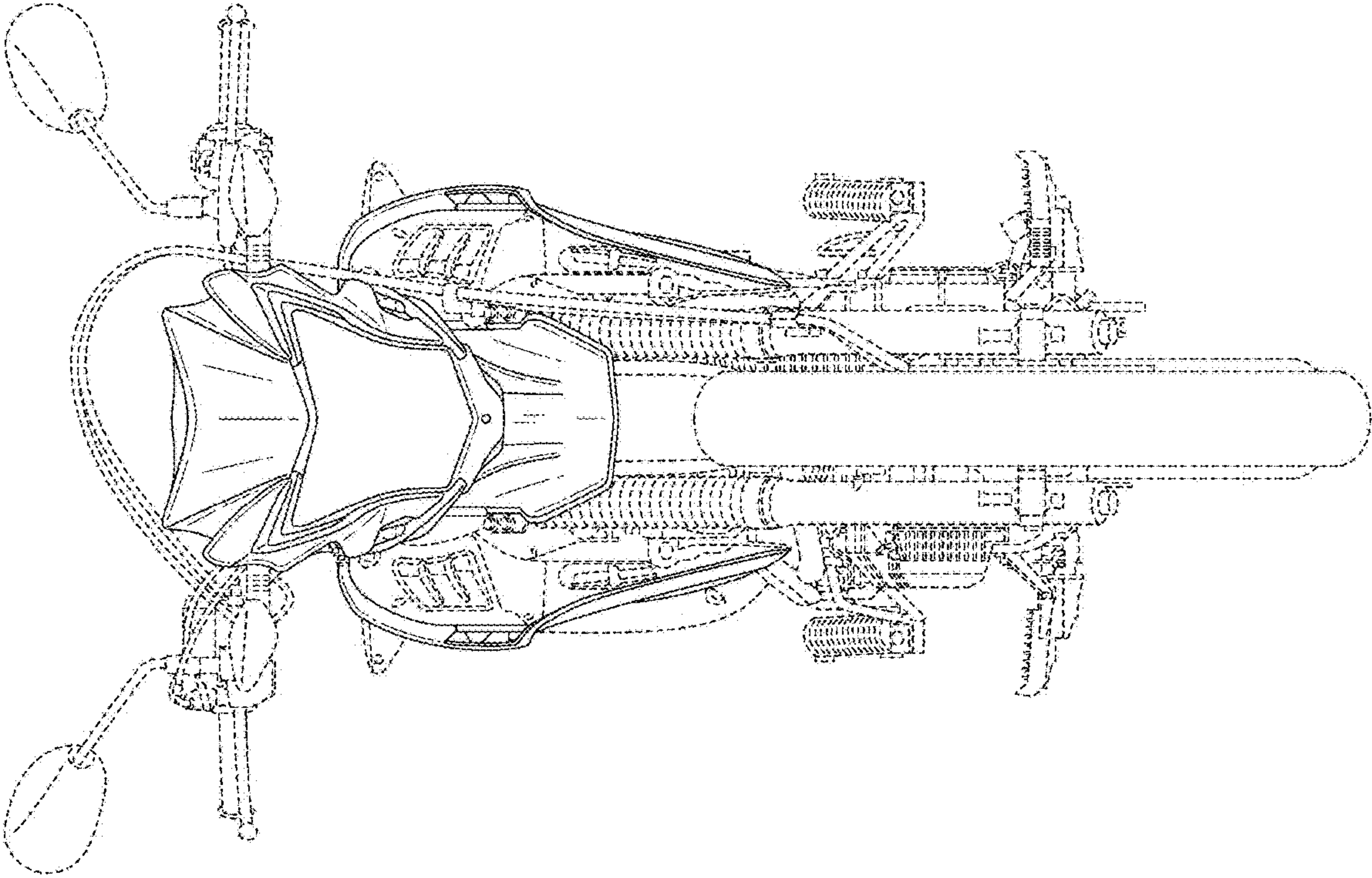

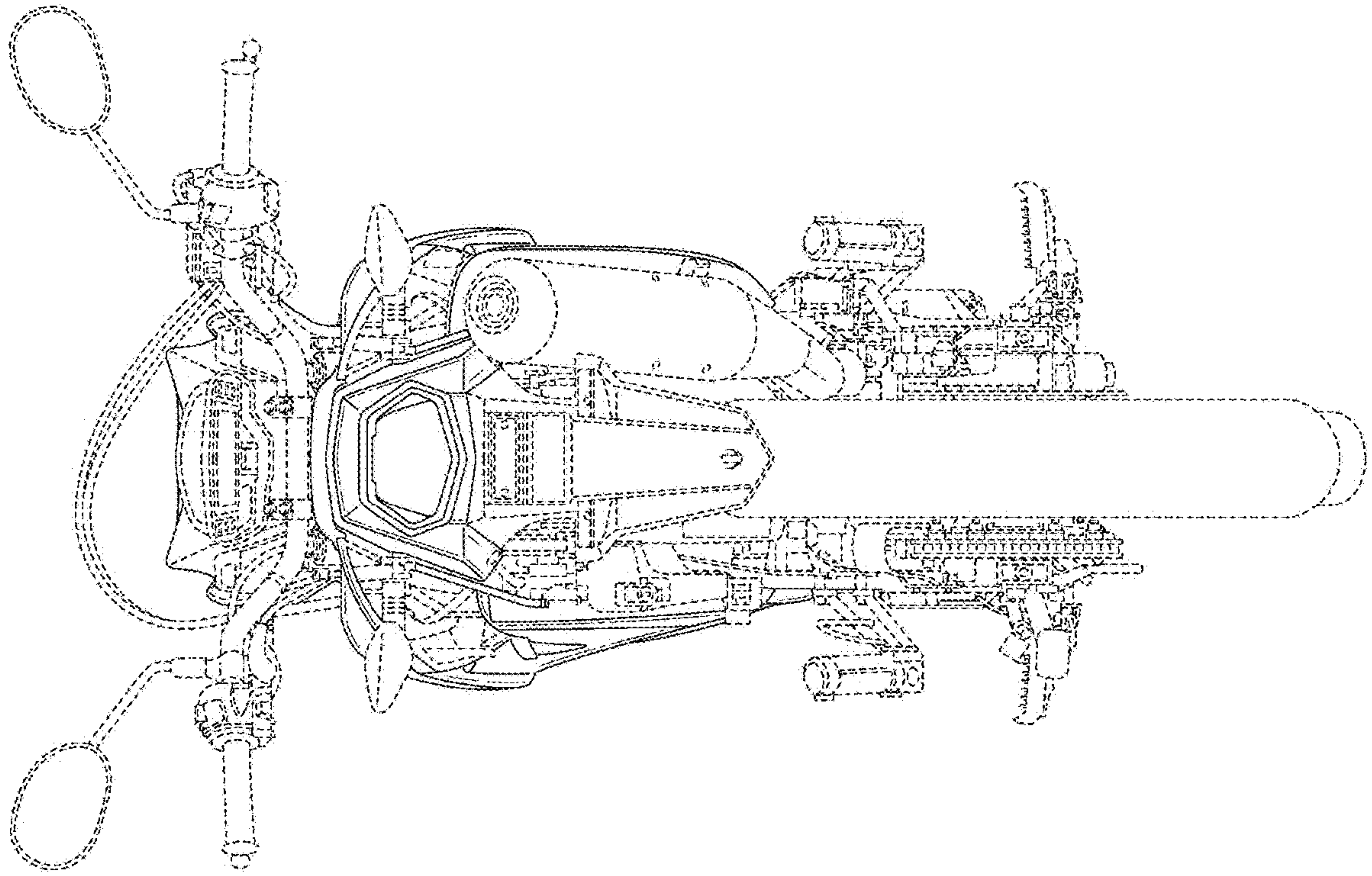

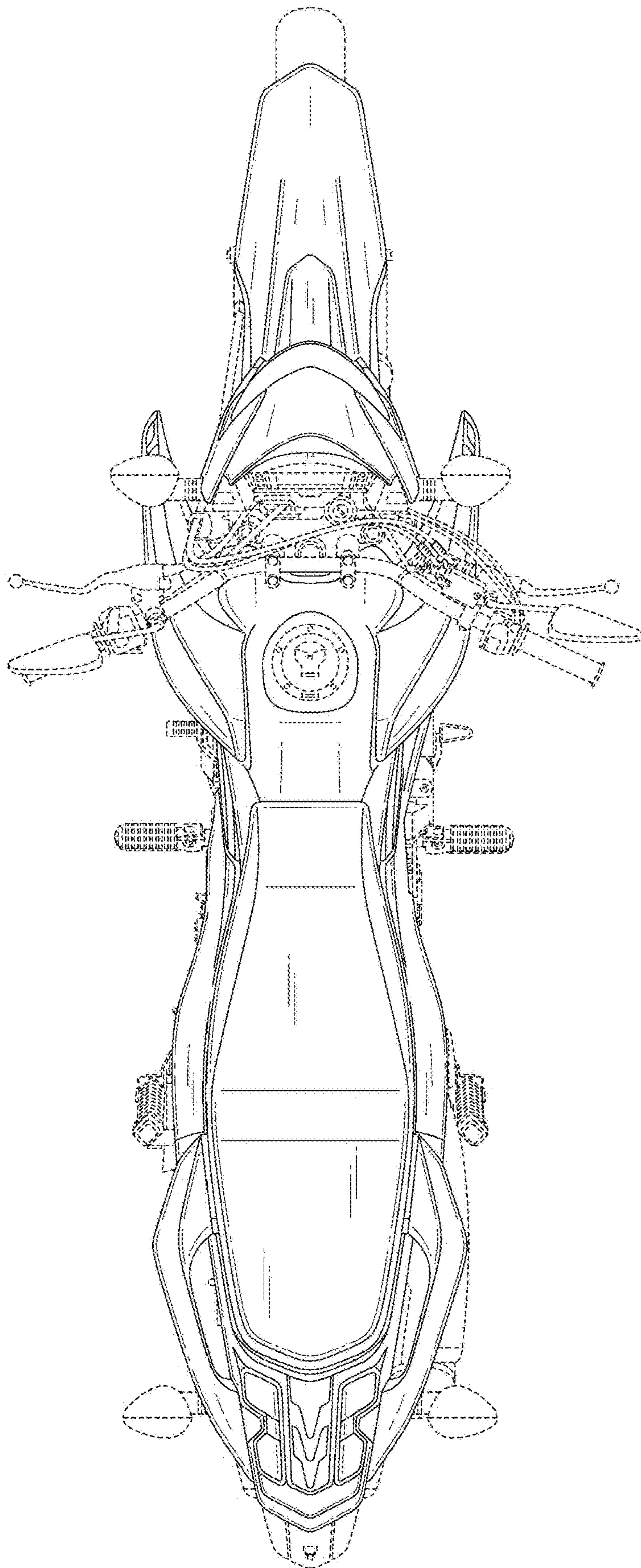

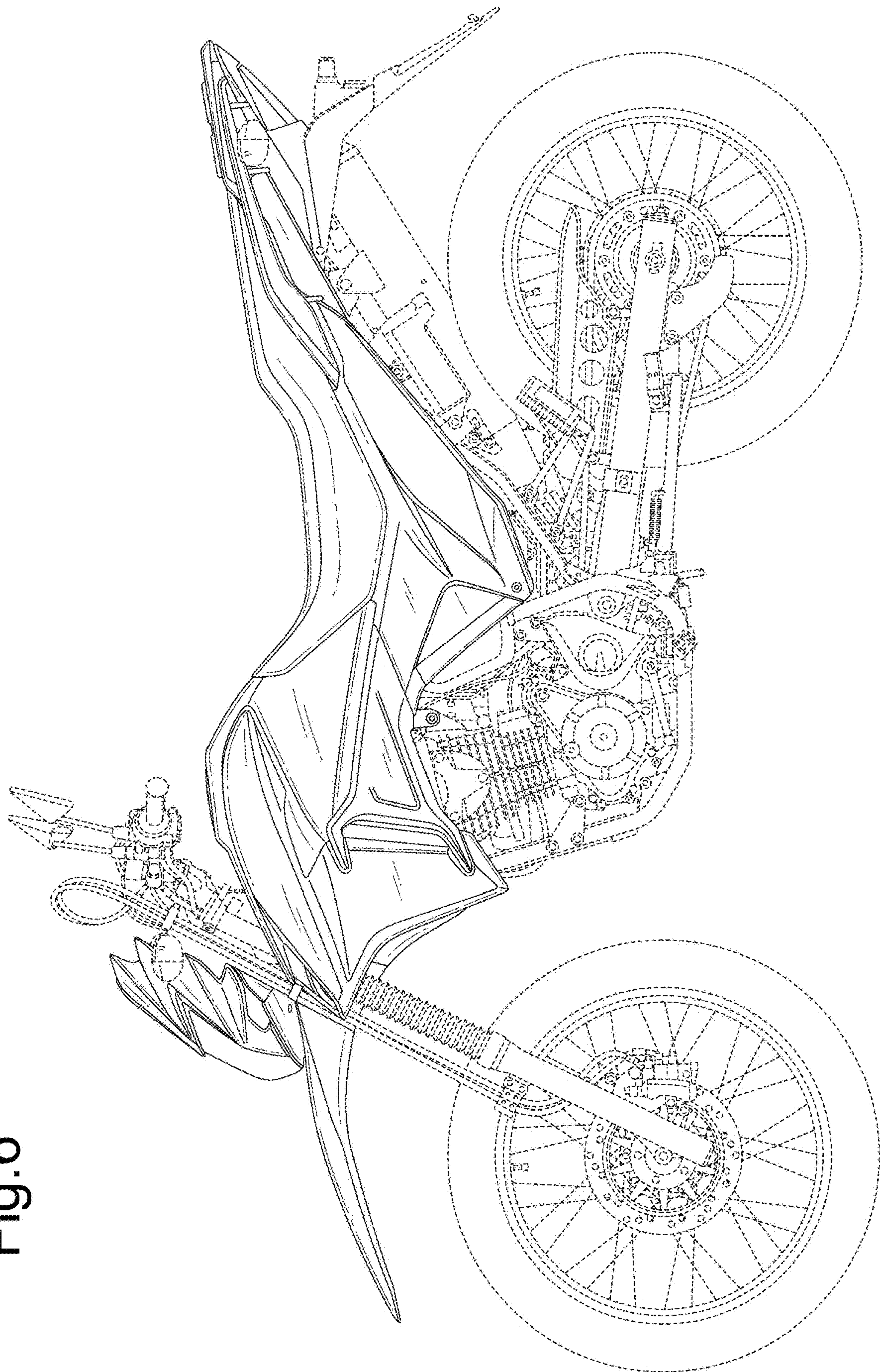

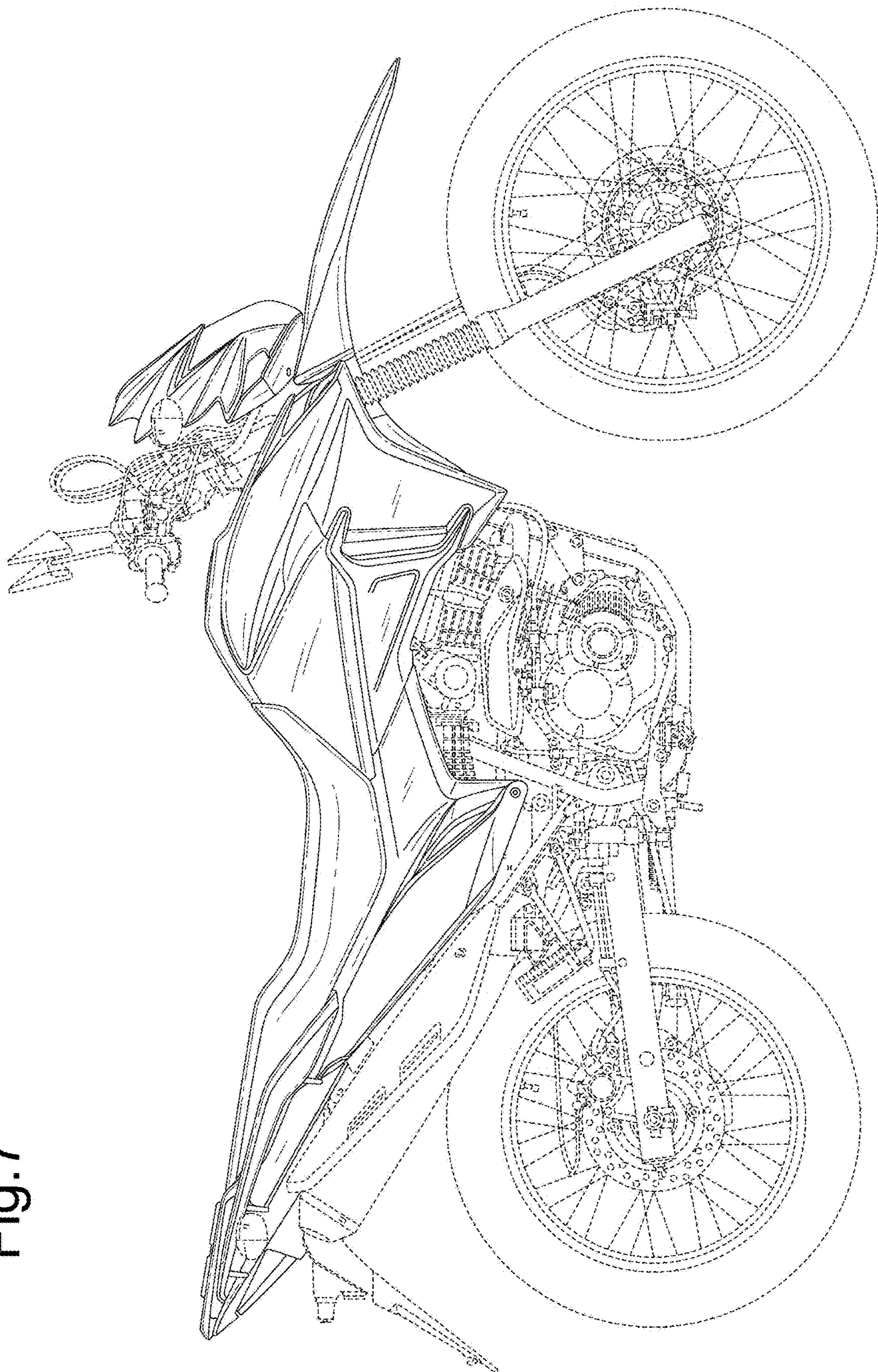
