(57) **CLAIM**

The ornamental design for a front grille for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a front grille for automobile, showing our new design.

FIG. 2 is a front elevation view thereof.

FIG. 3 is a rear elevation view thereof.

FIG. 4 is a top plan view thereof.

FIG. 5 is a bottom plan view thereof.

FIG. 6 is a left side elevation view thereof; and,

FIG. 7 is a right side elevation view thereof.

The claimed design is indicated by the relatively dark portion, while the relatively light portions are environmental and form no part of the claimed design.

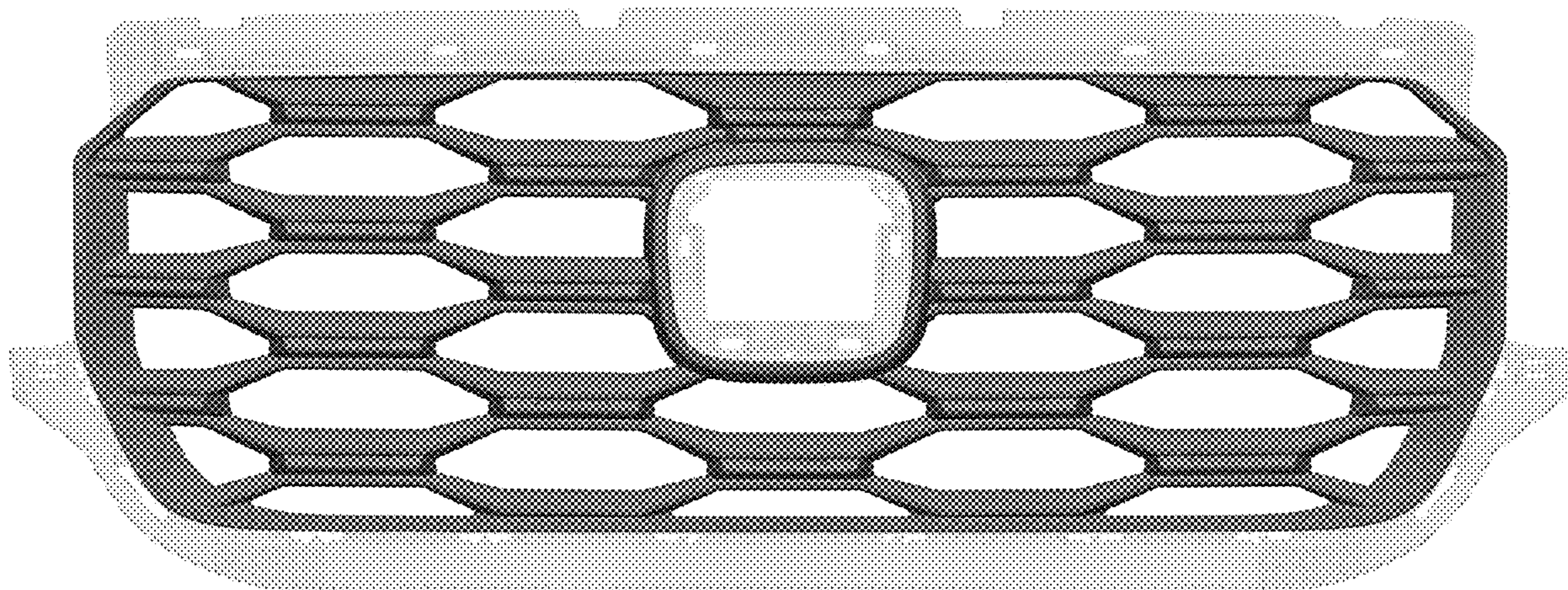

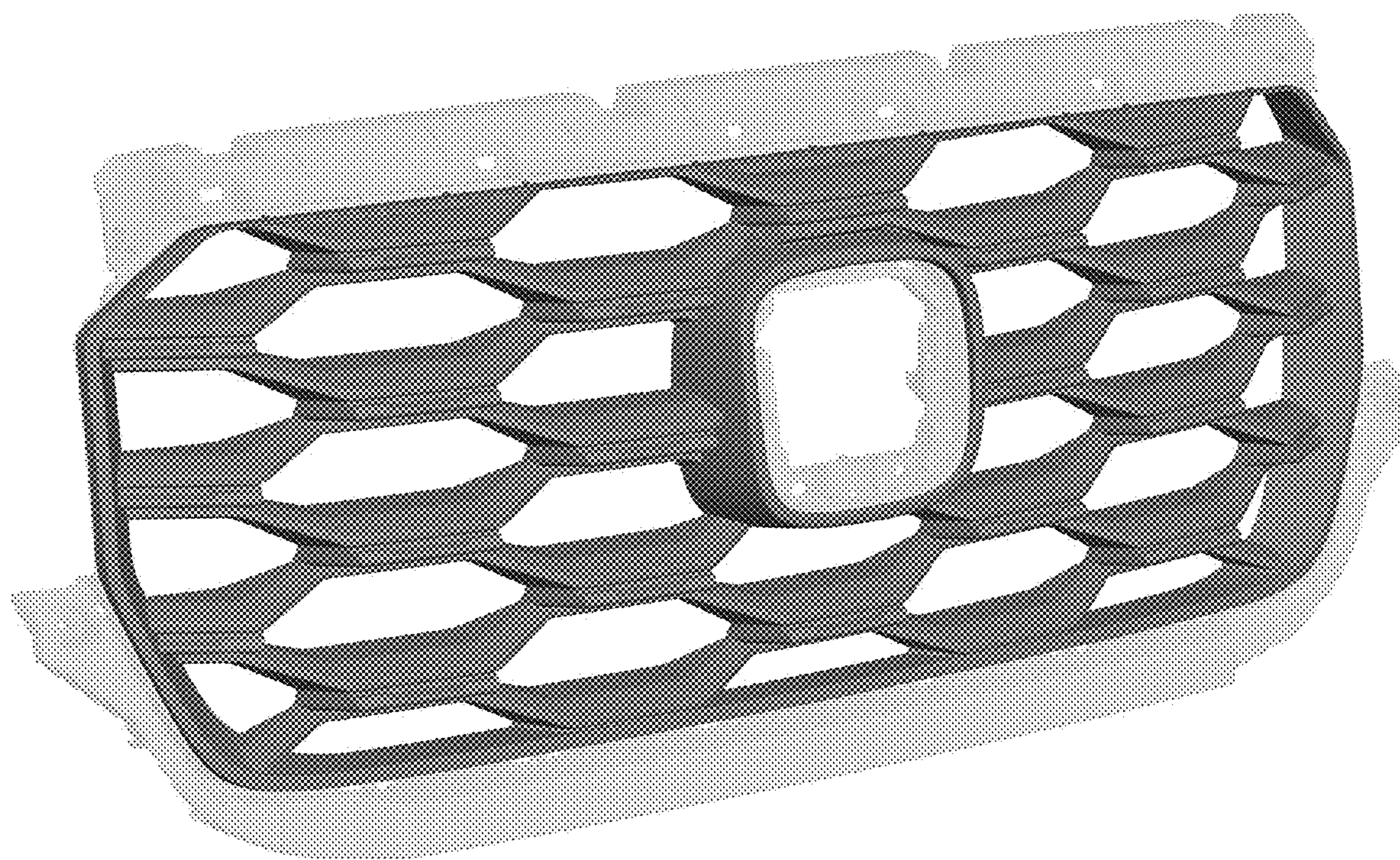

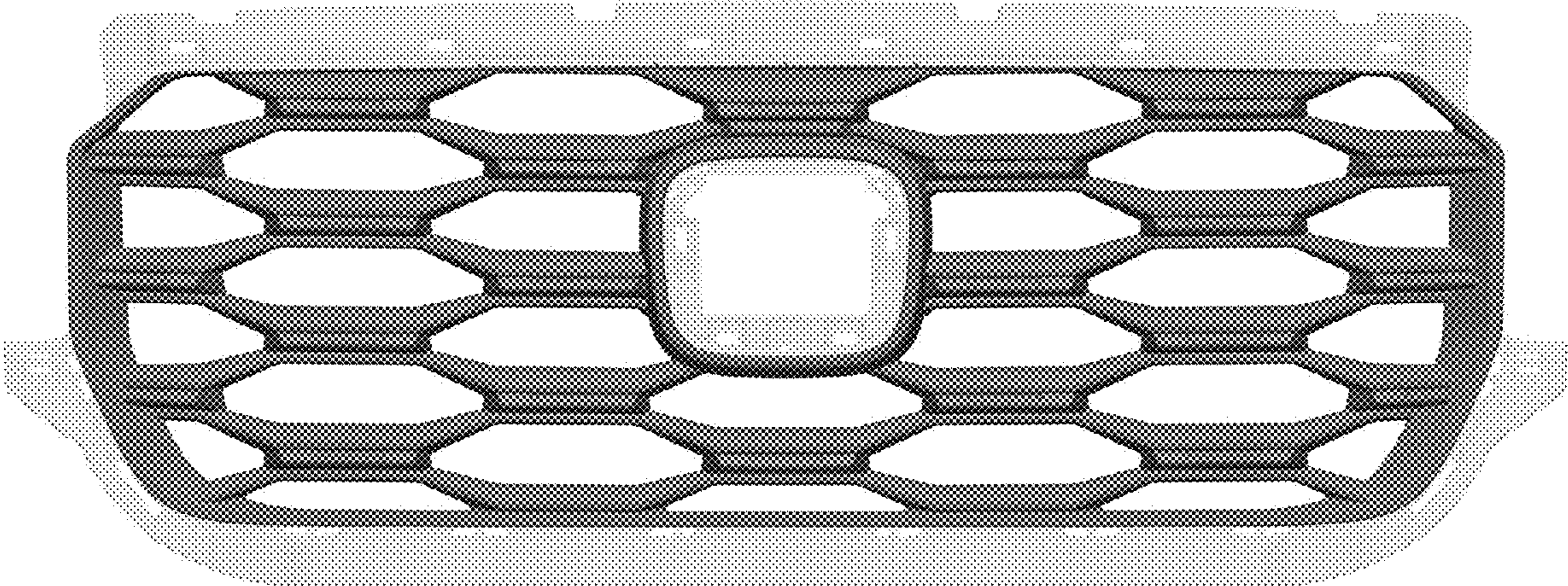

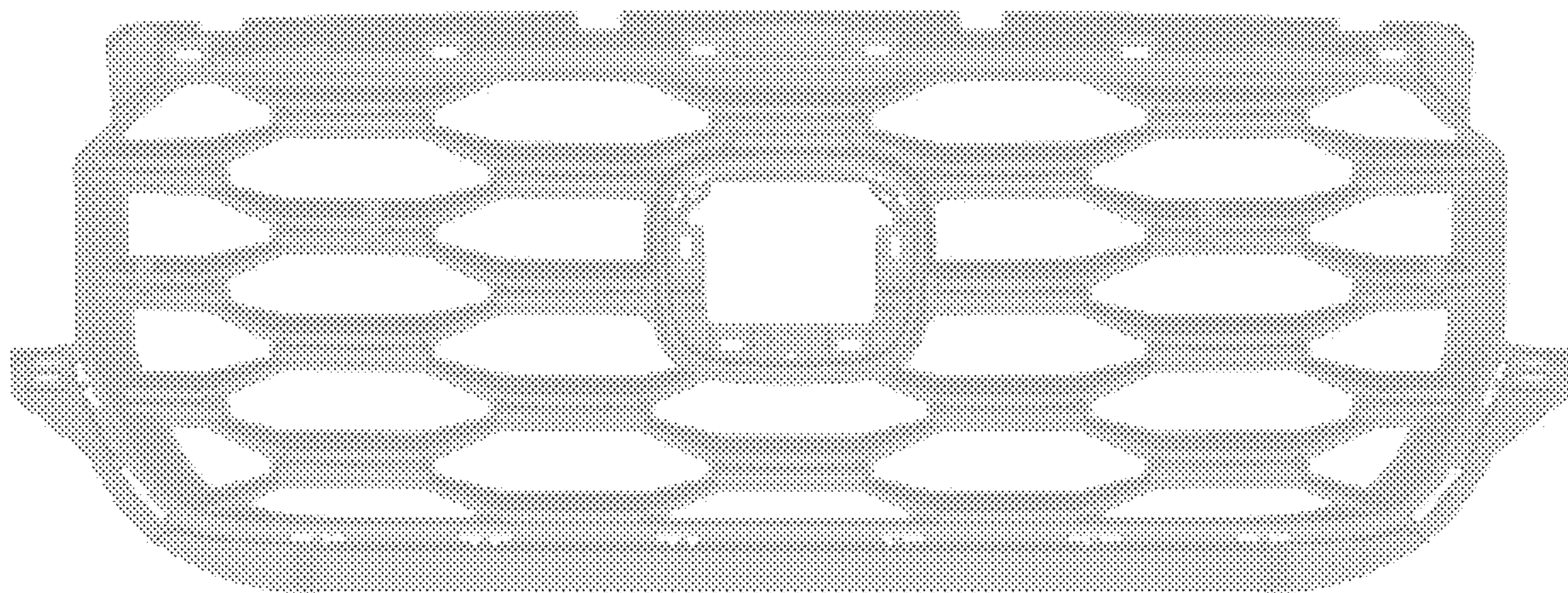

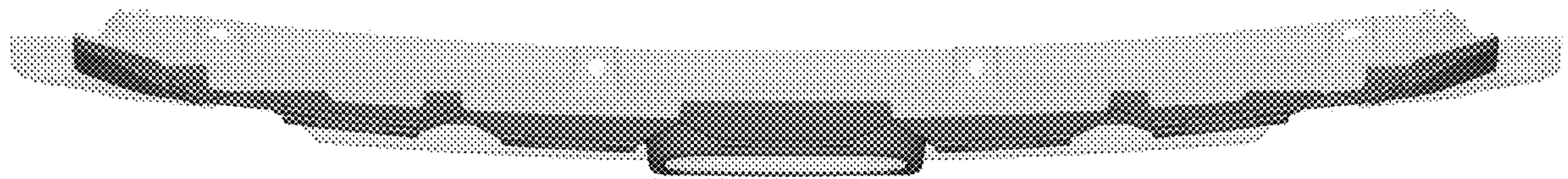

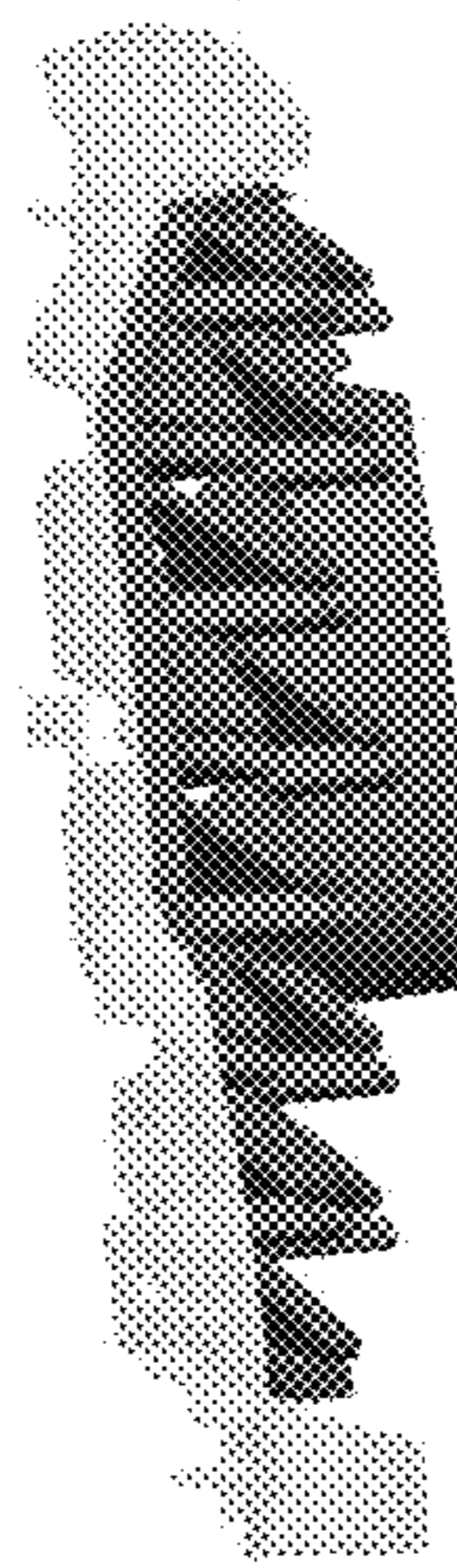
