DESCRIPTION

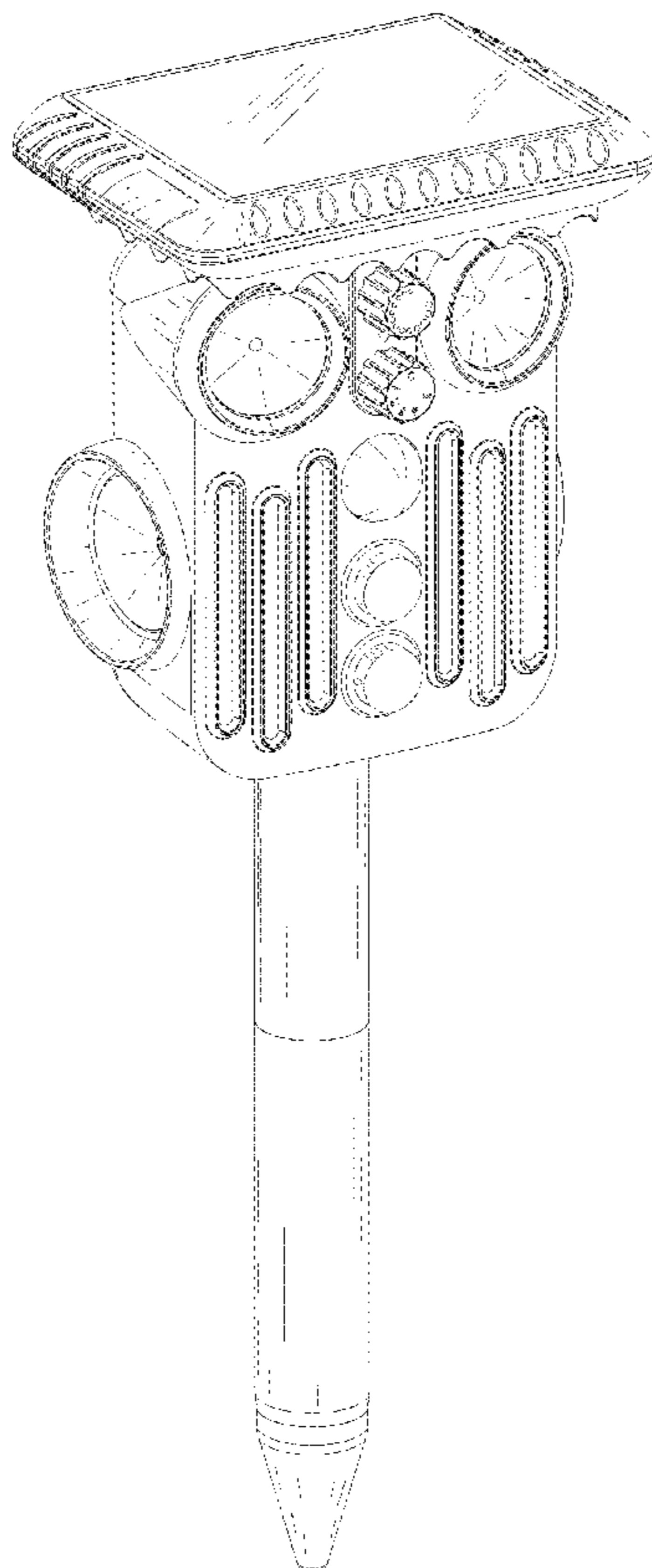
FIG. 1 is a front elevational view of a solar animal repeller showing my new design;

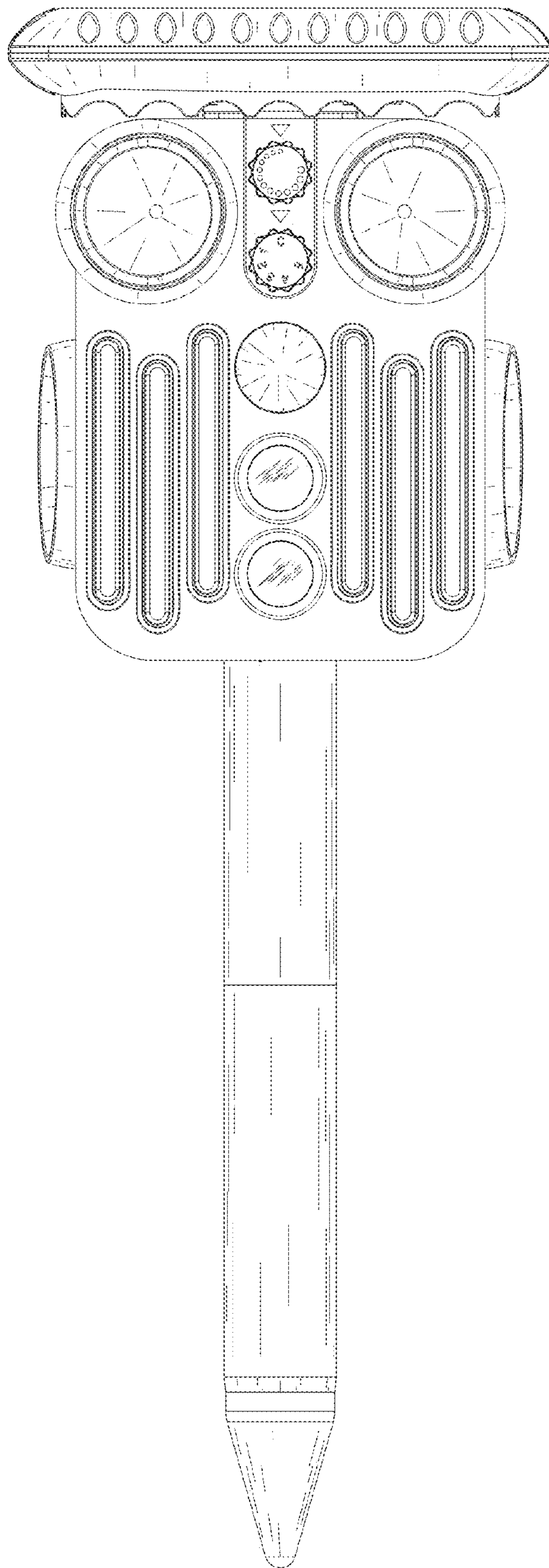

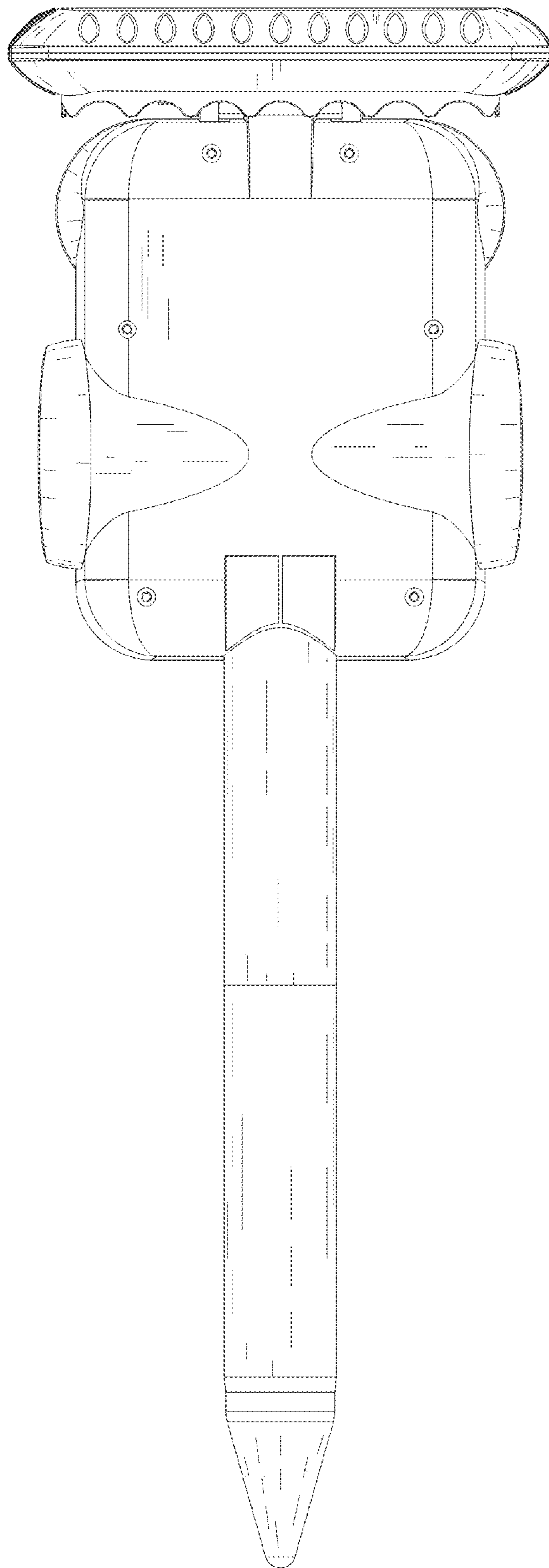

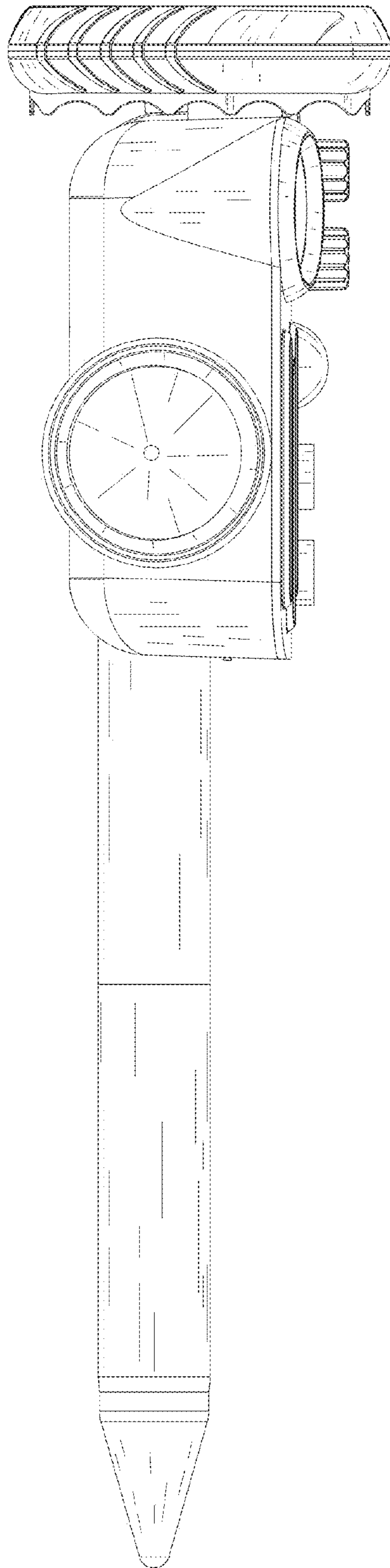

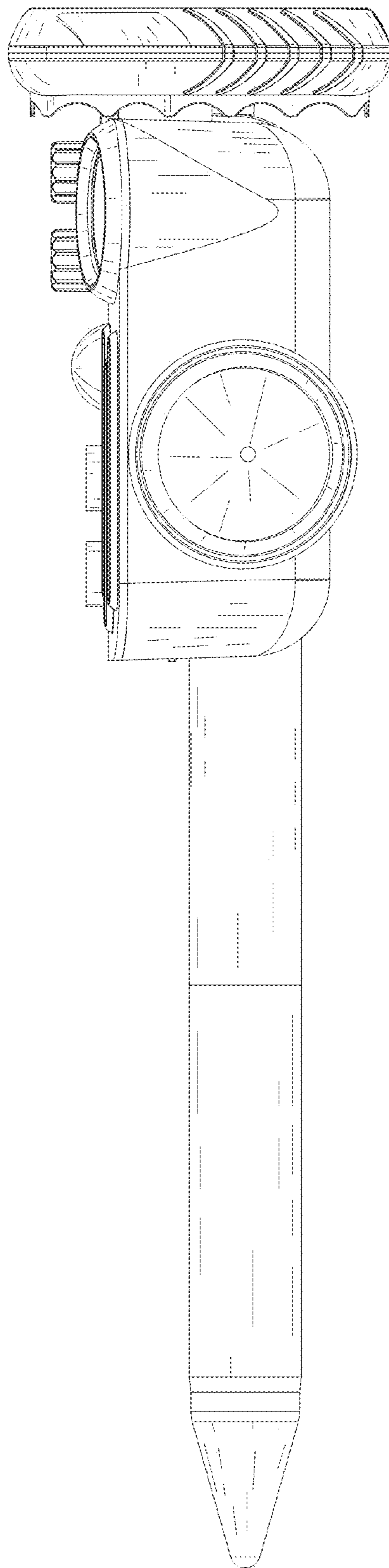

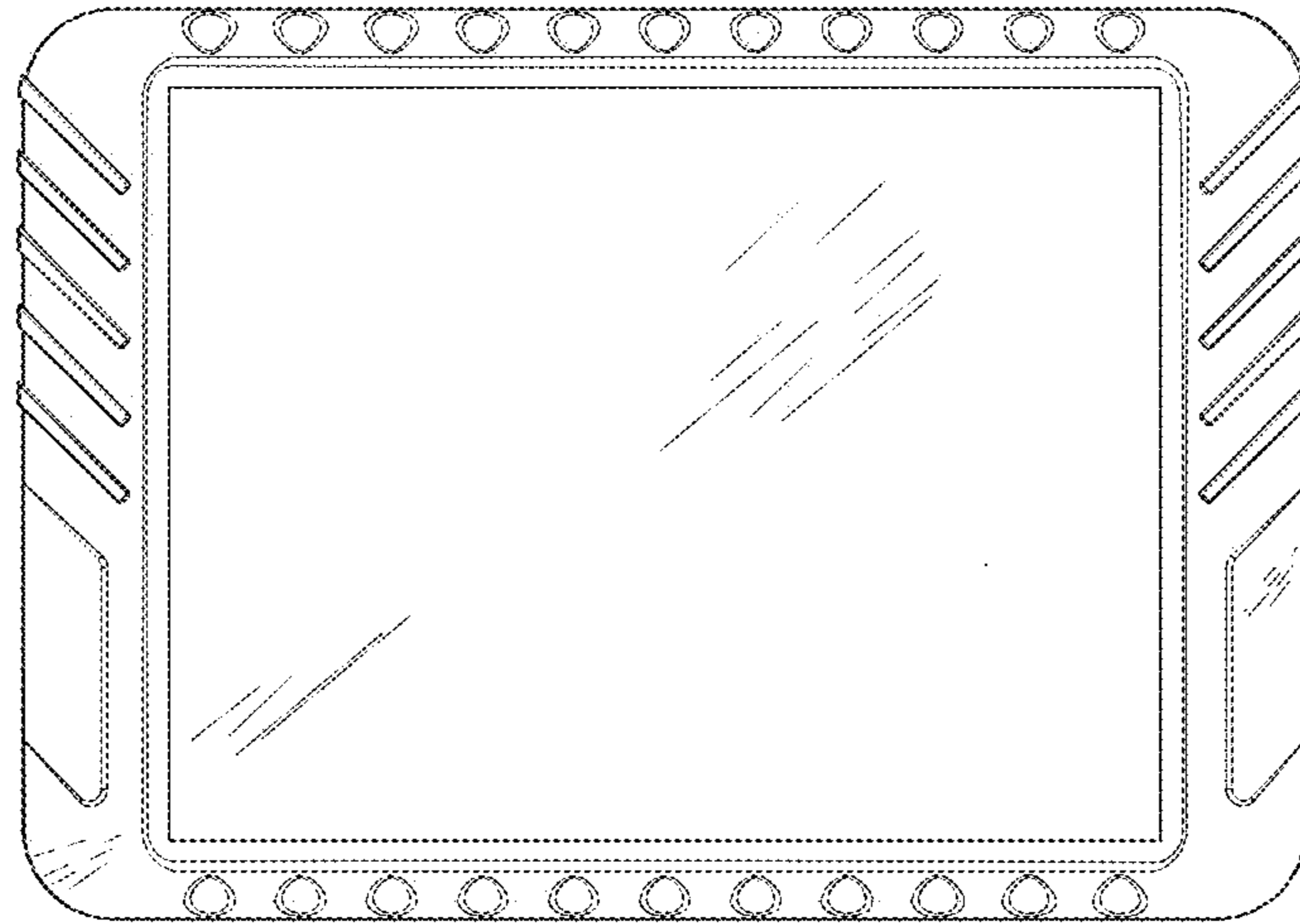

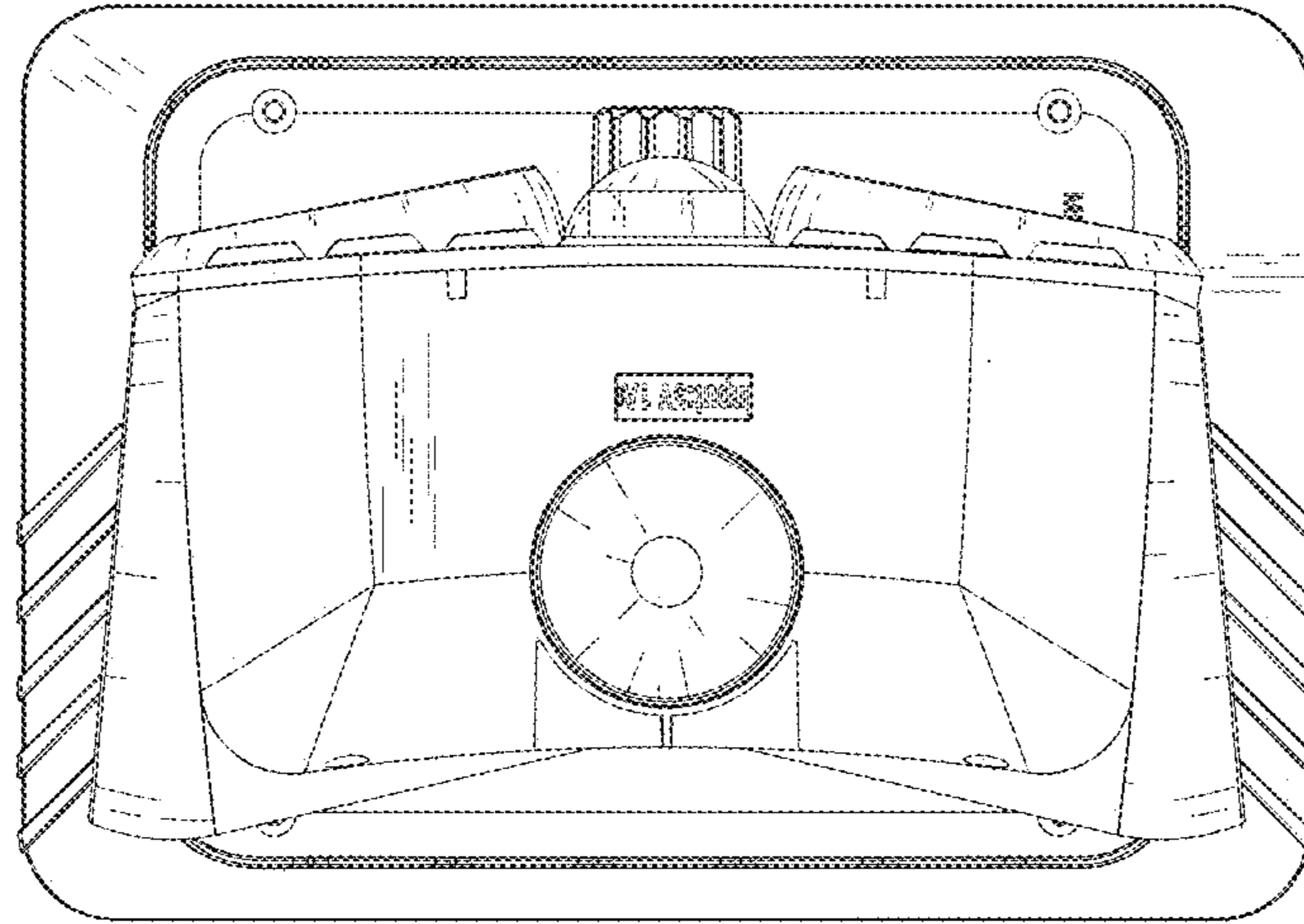

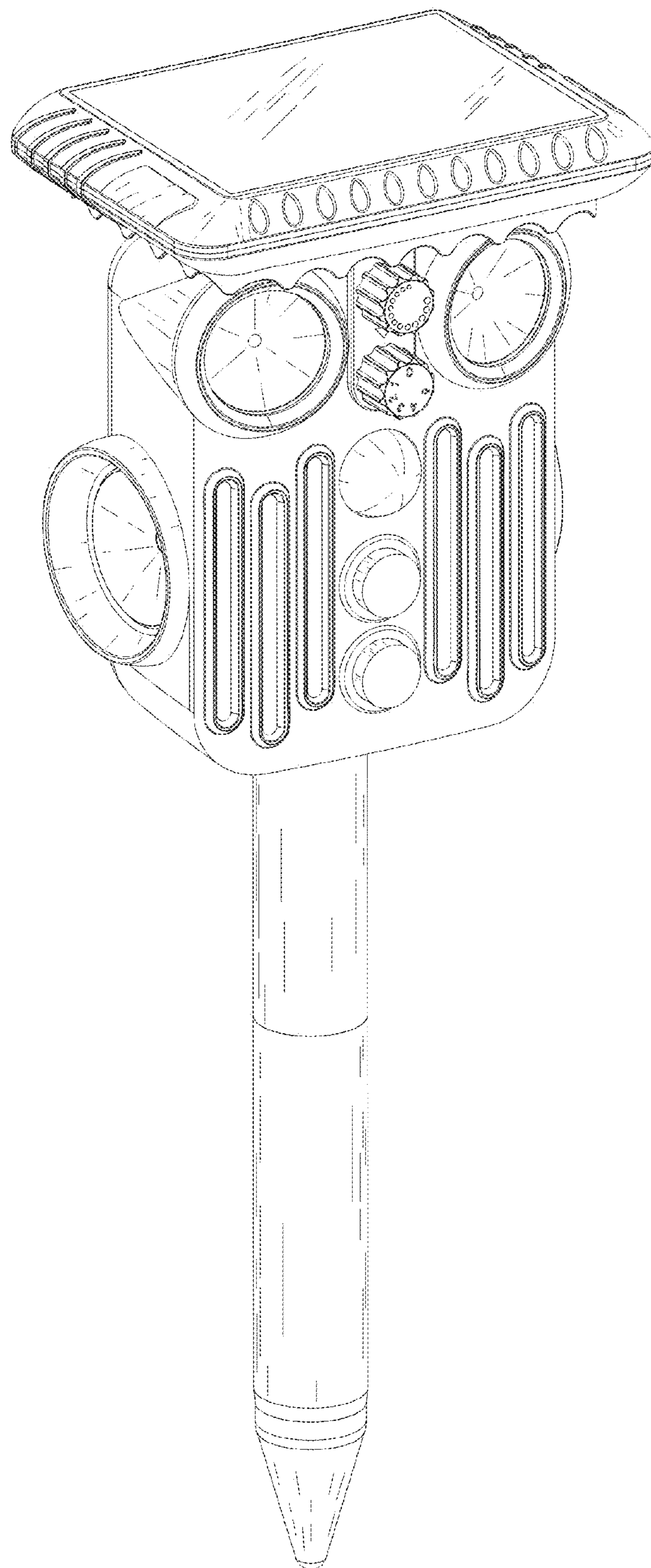
