FIG. 10 is a fourth image thereof;

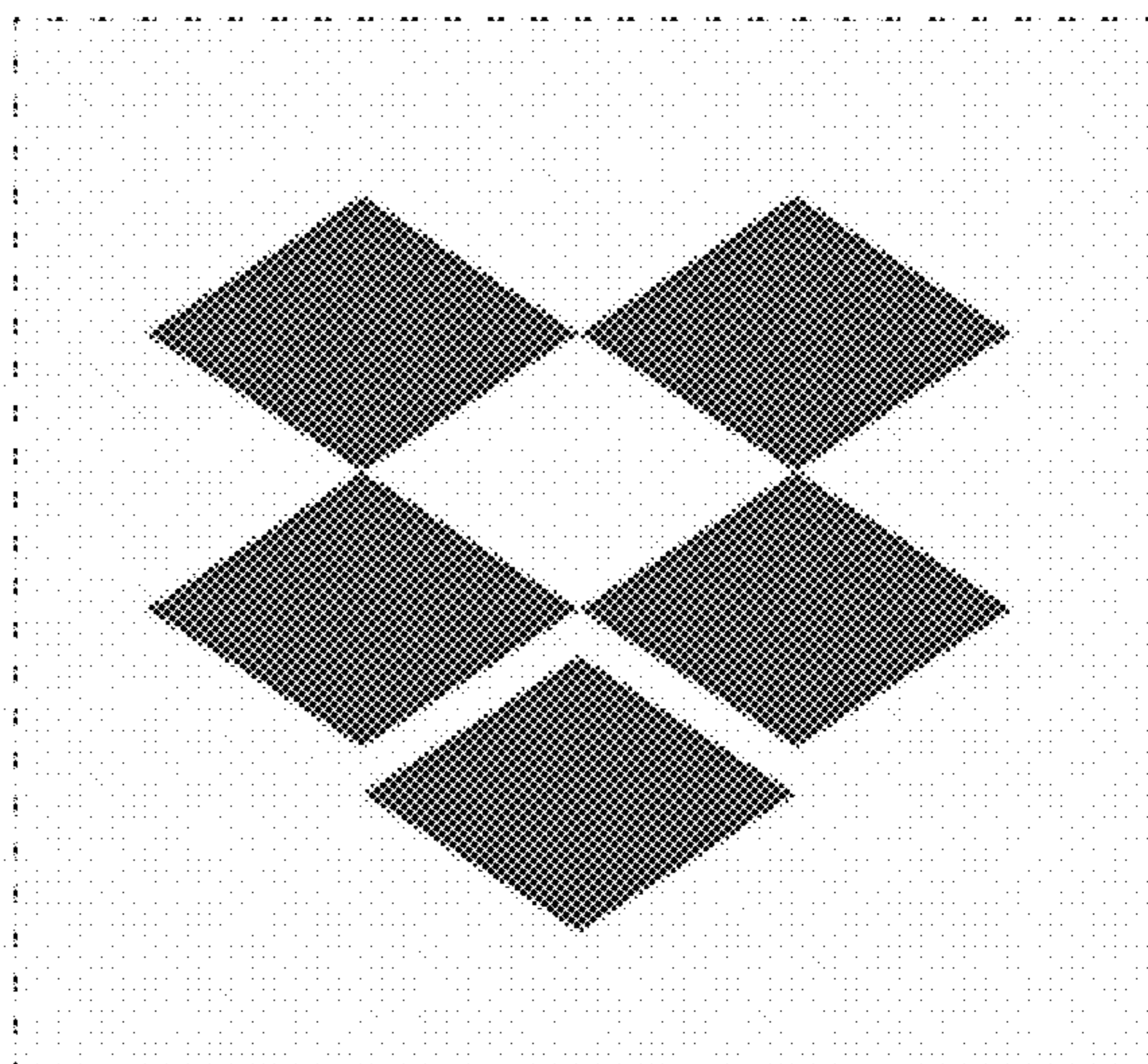
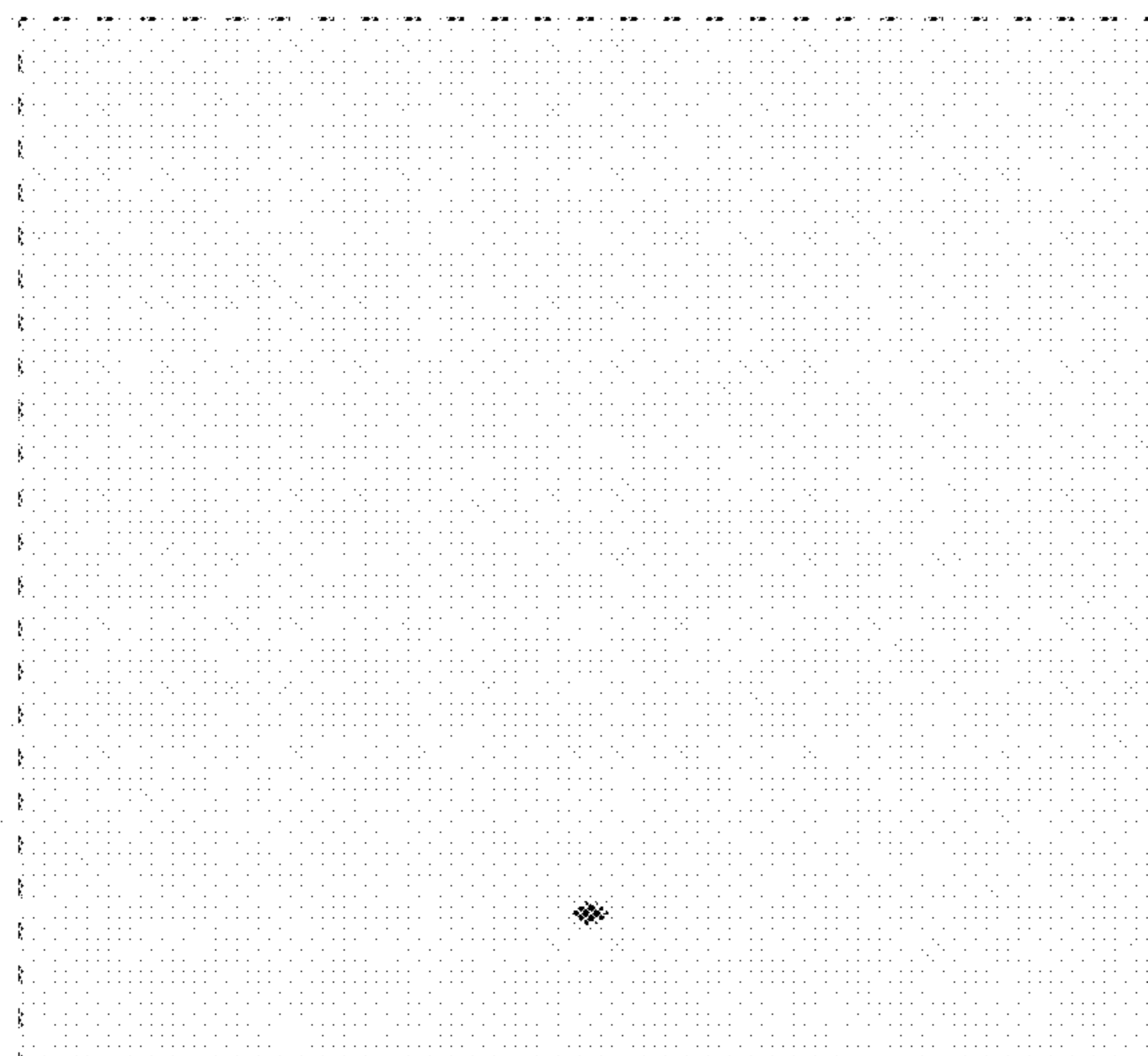
FIG. 11 is a fifth image thereof; and,

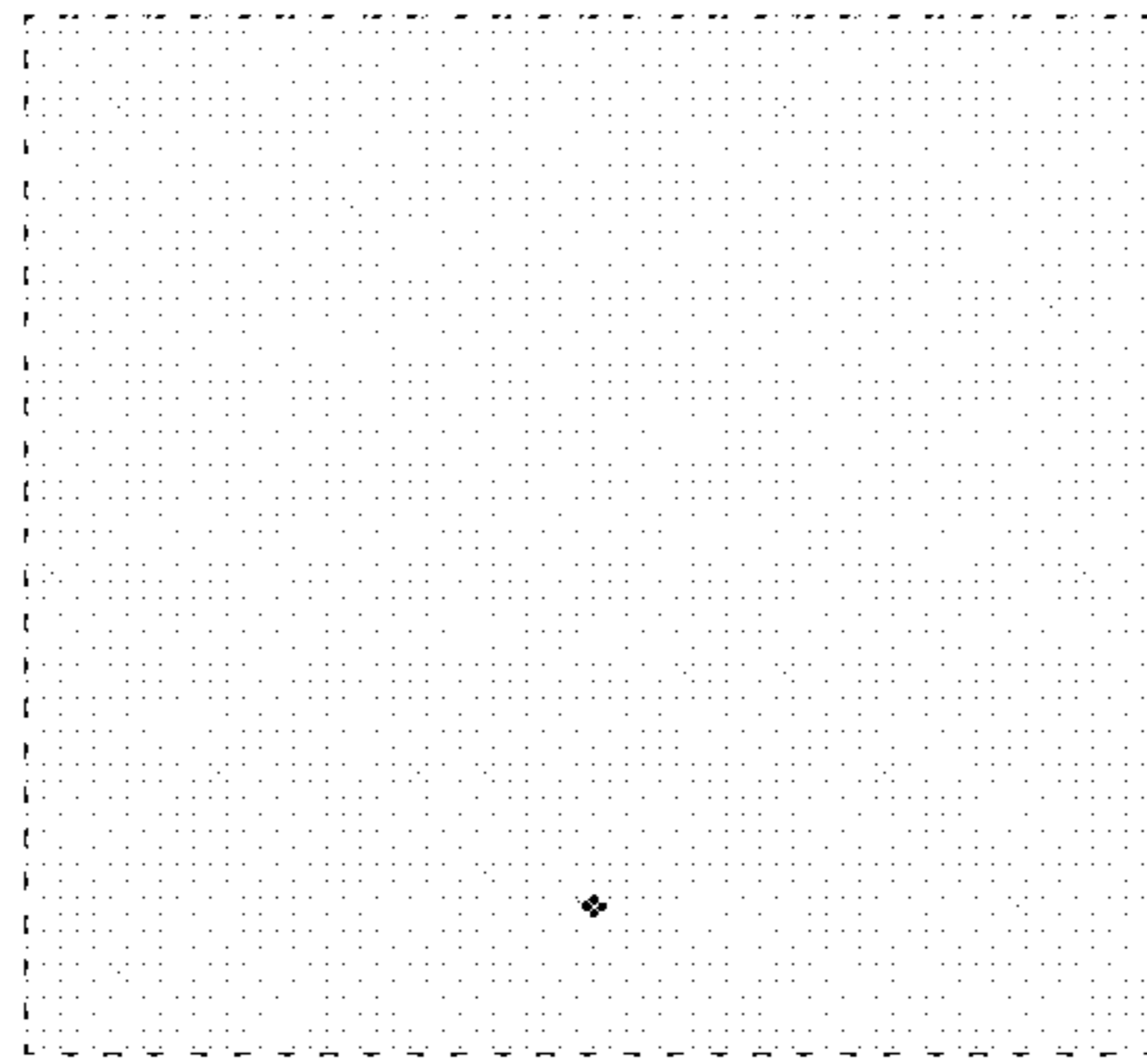

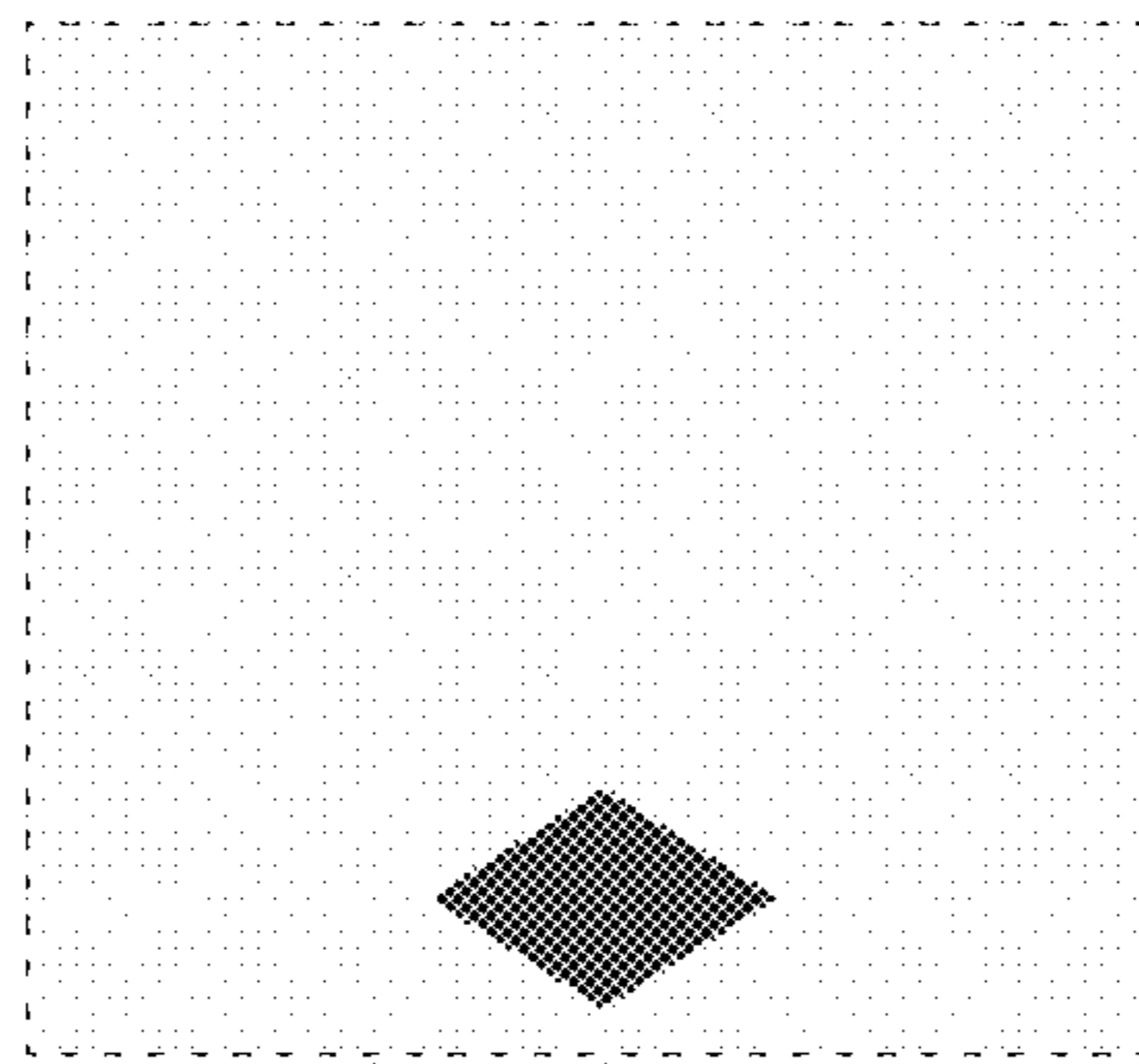

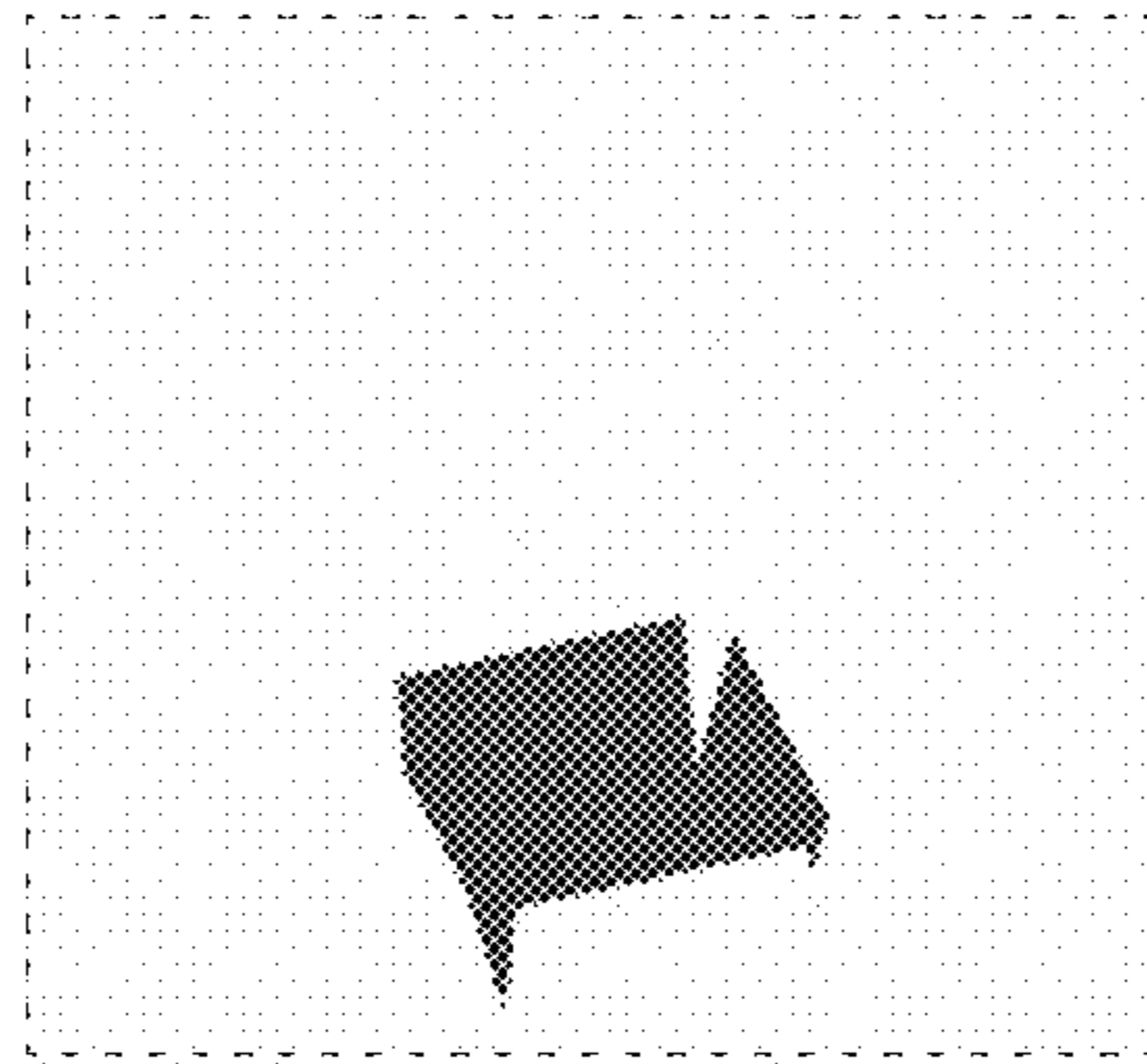

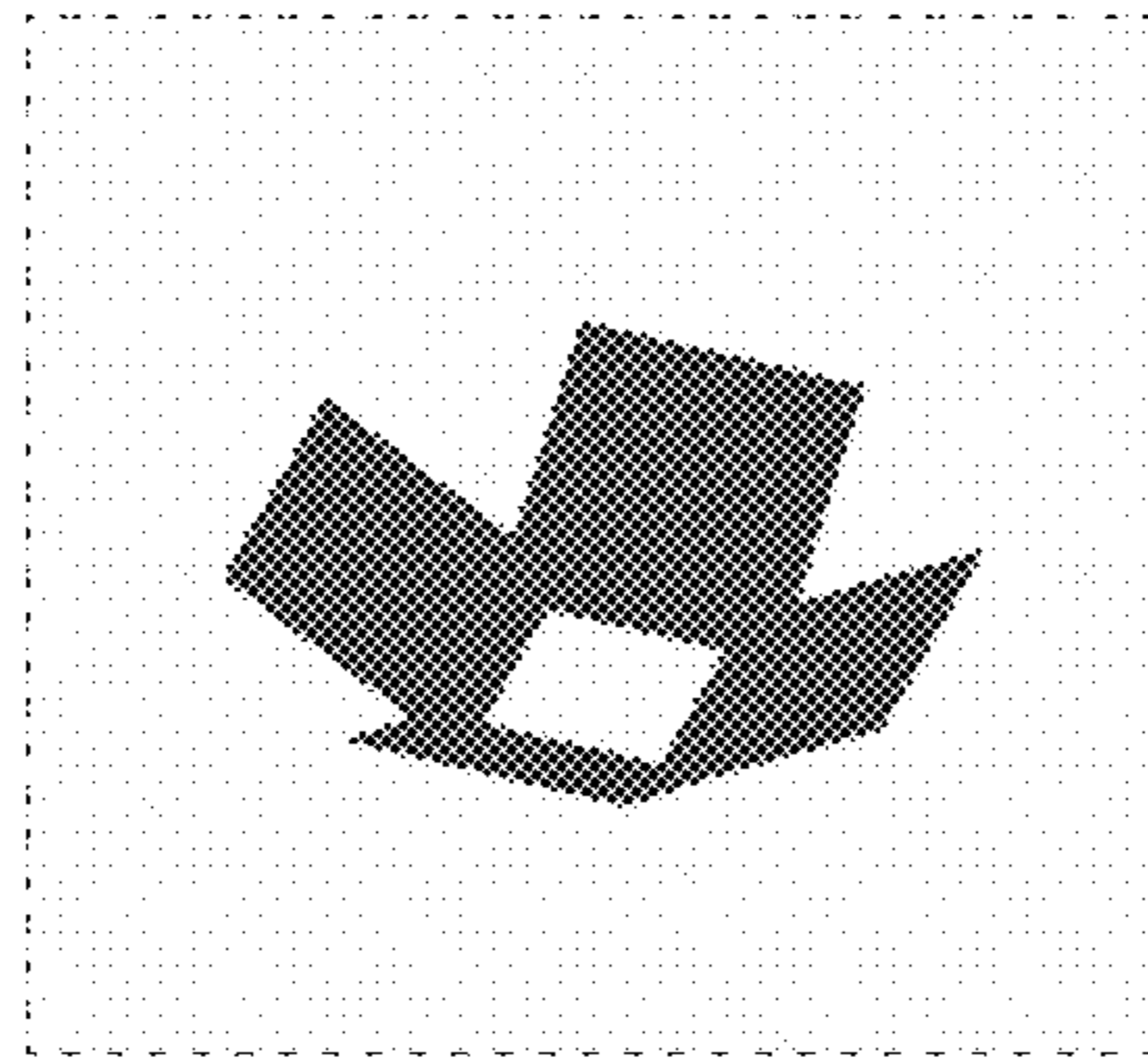

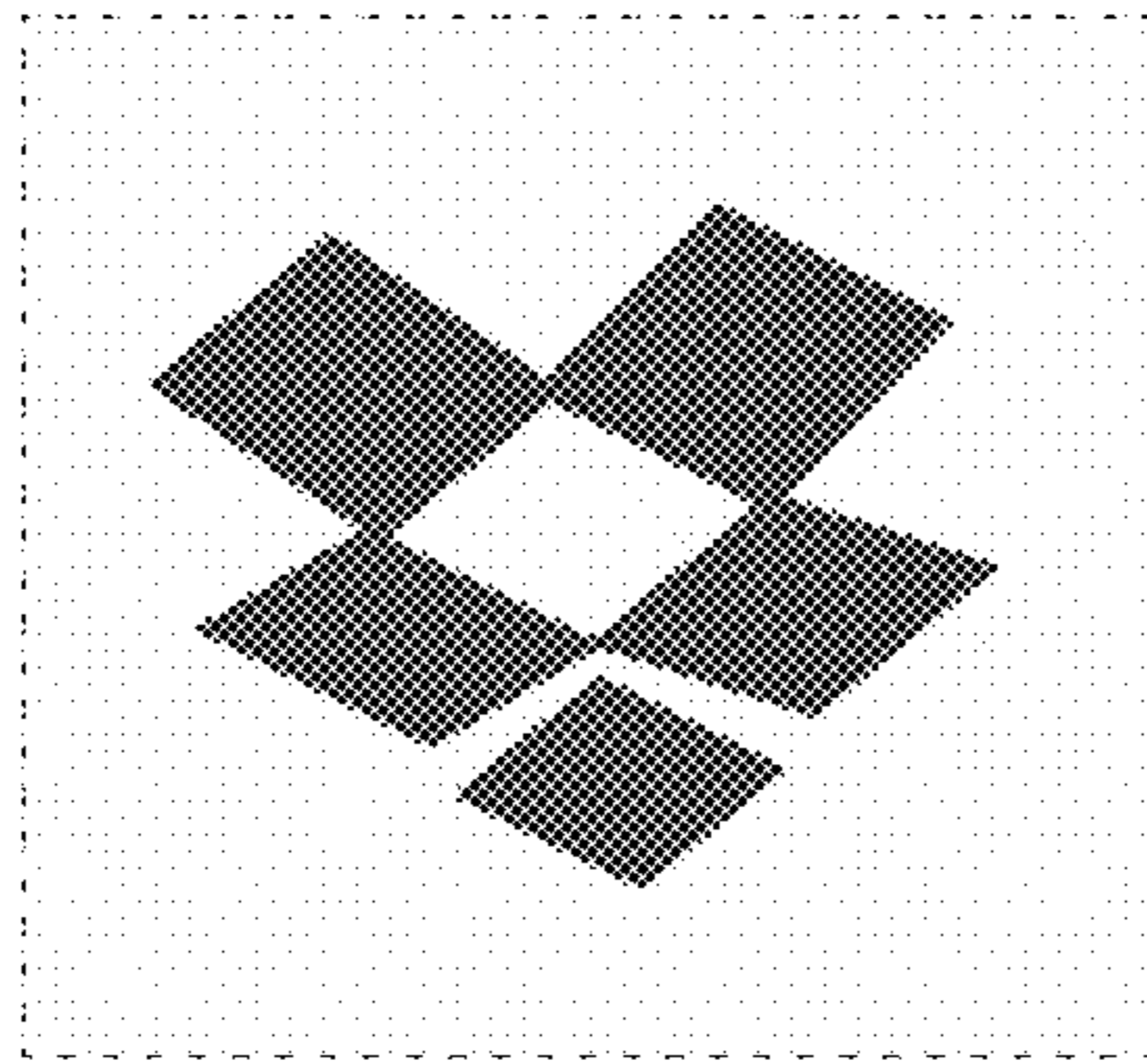

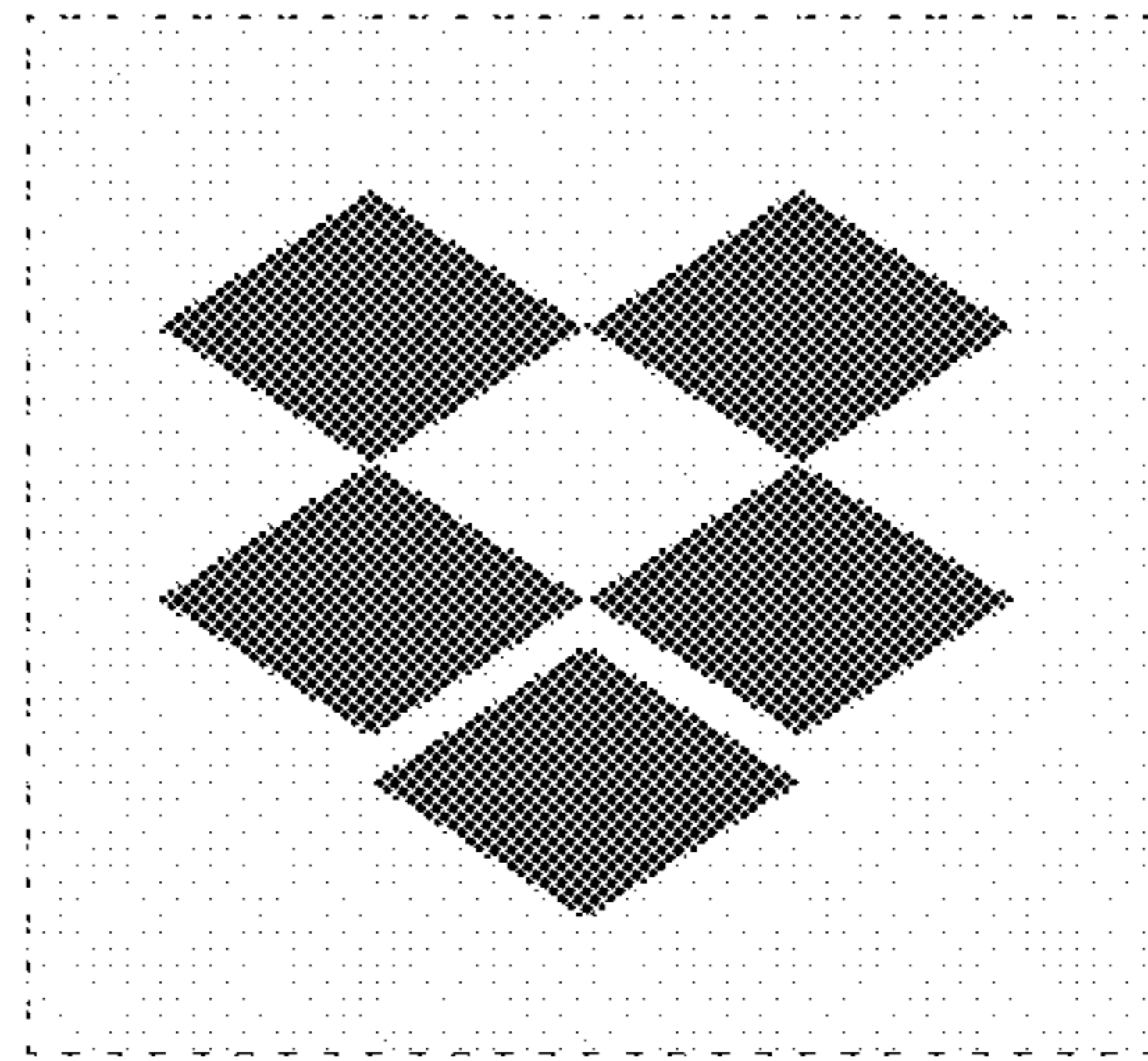

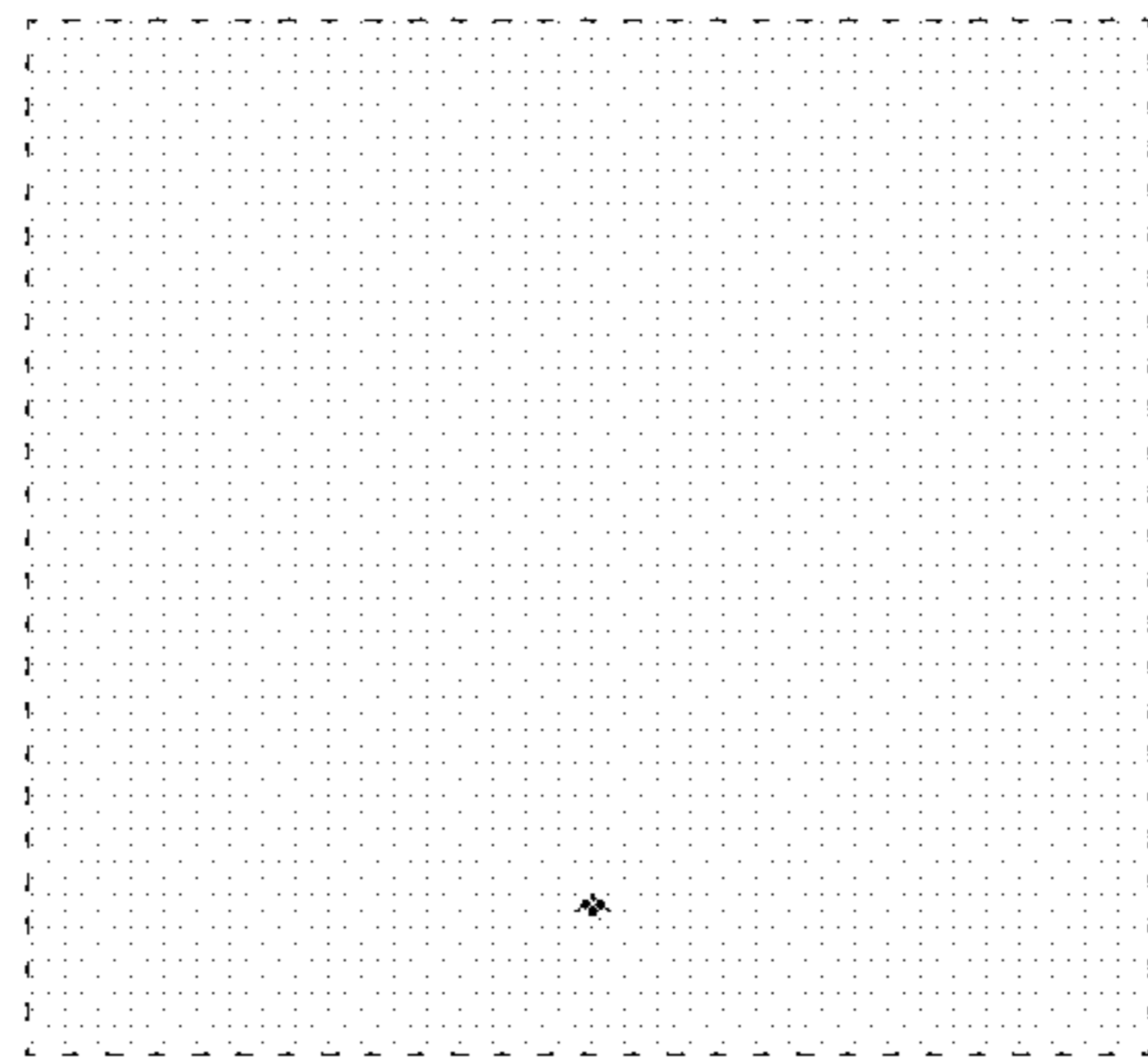

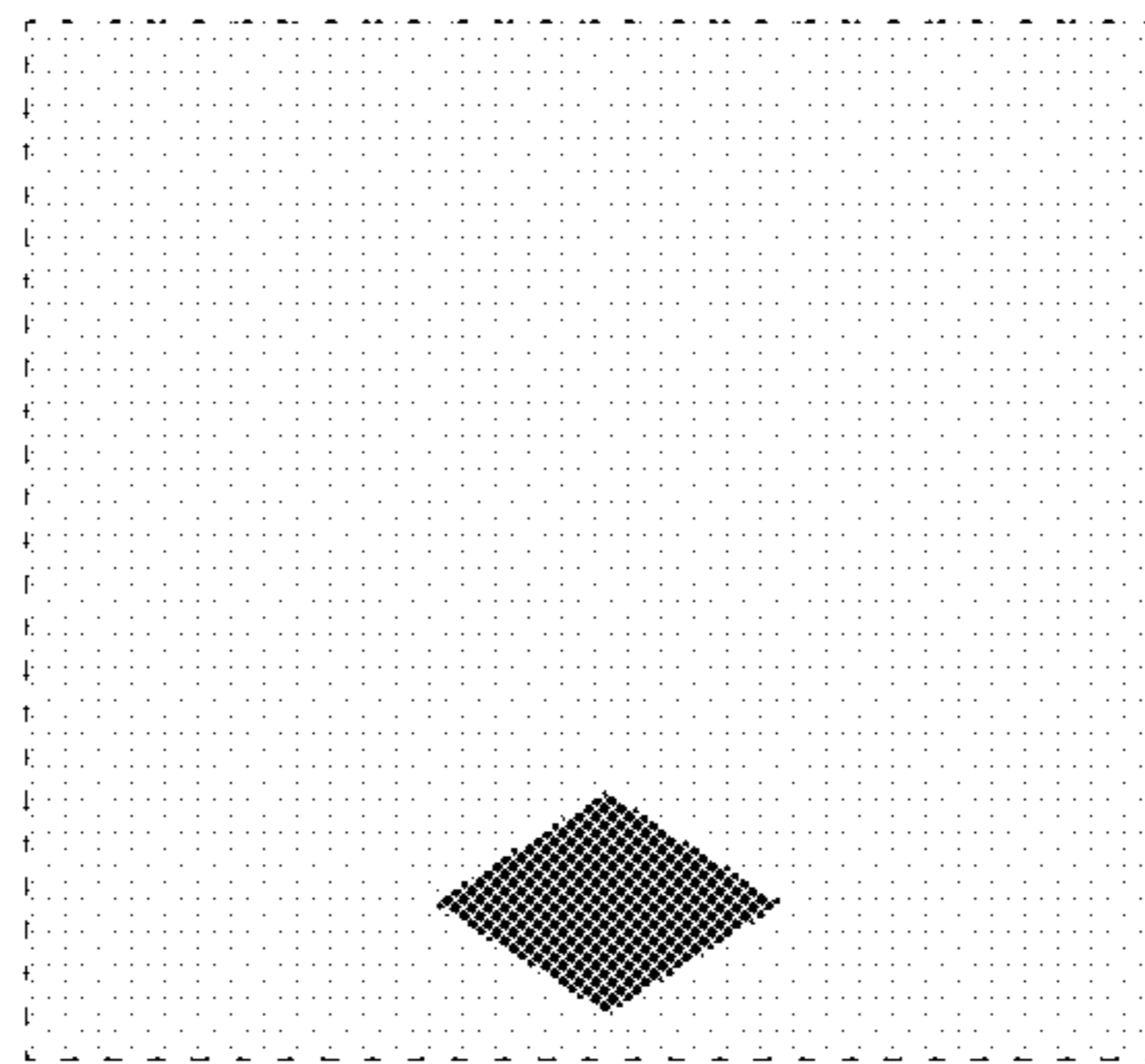

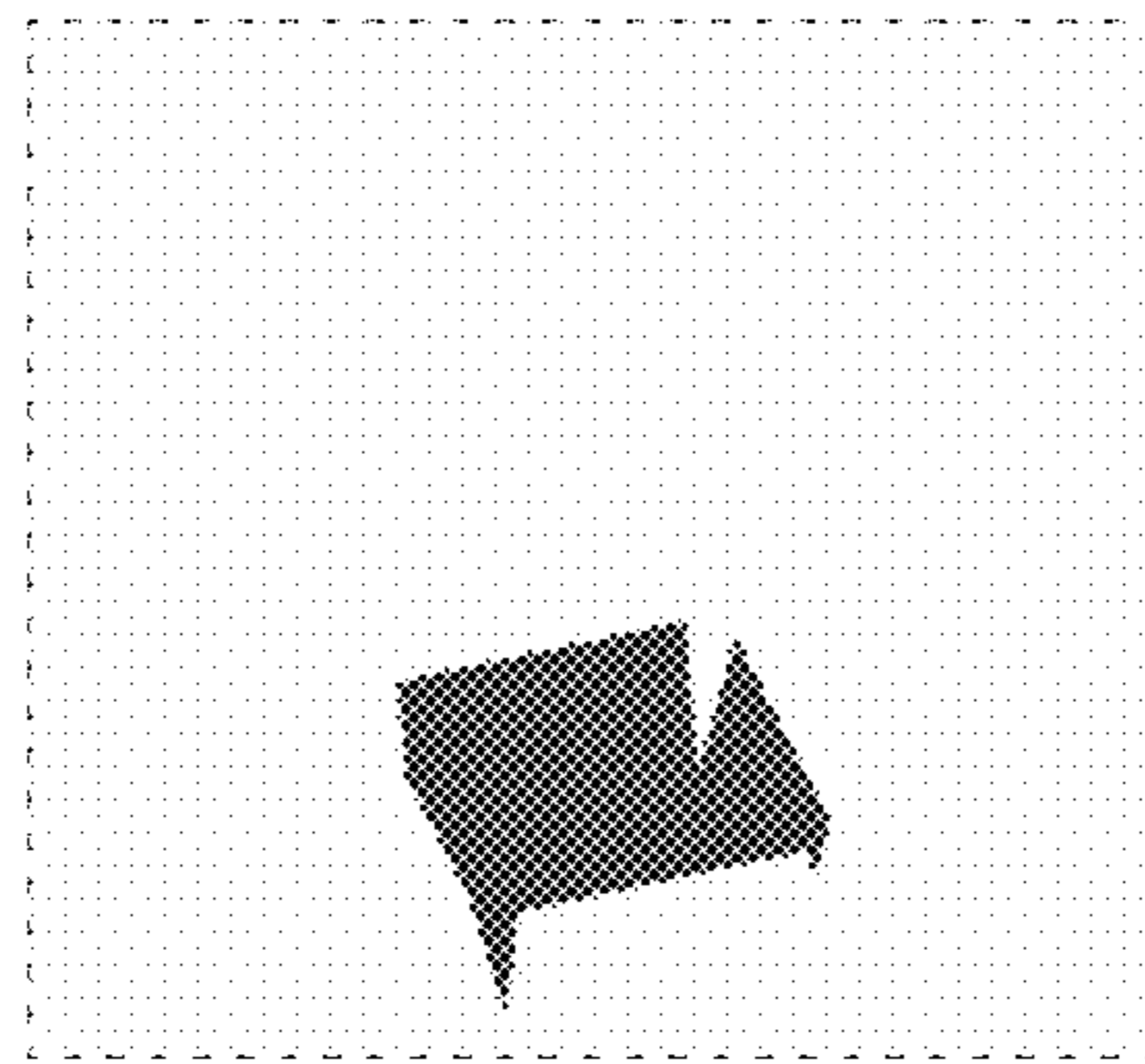

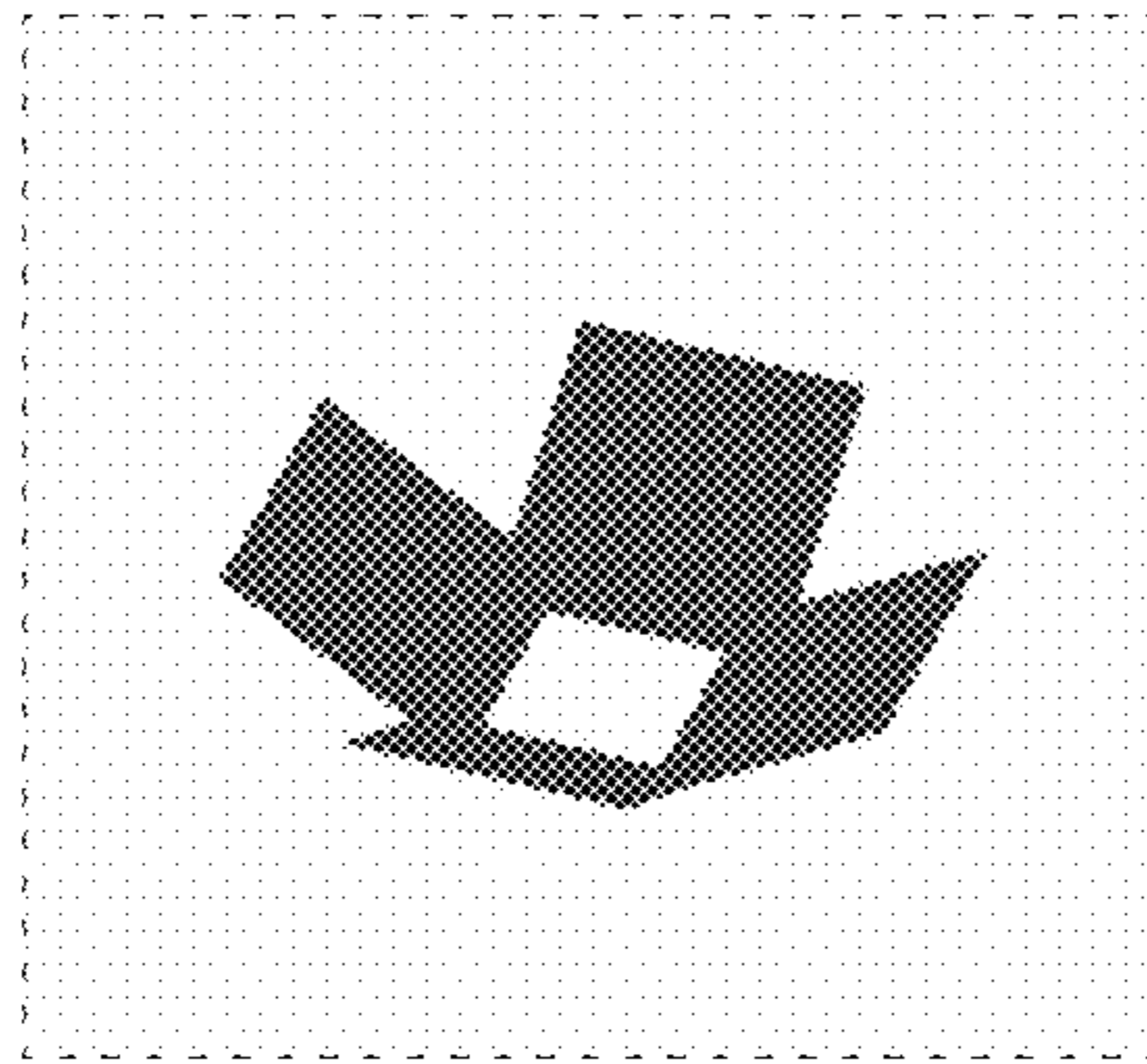

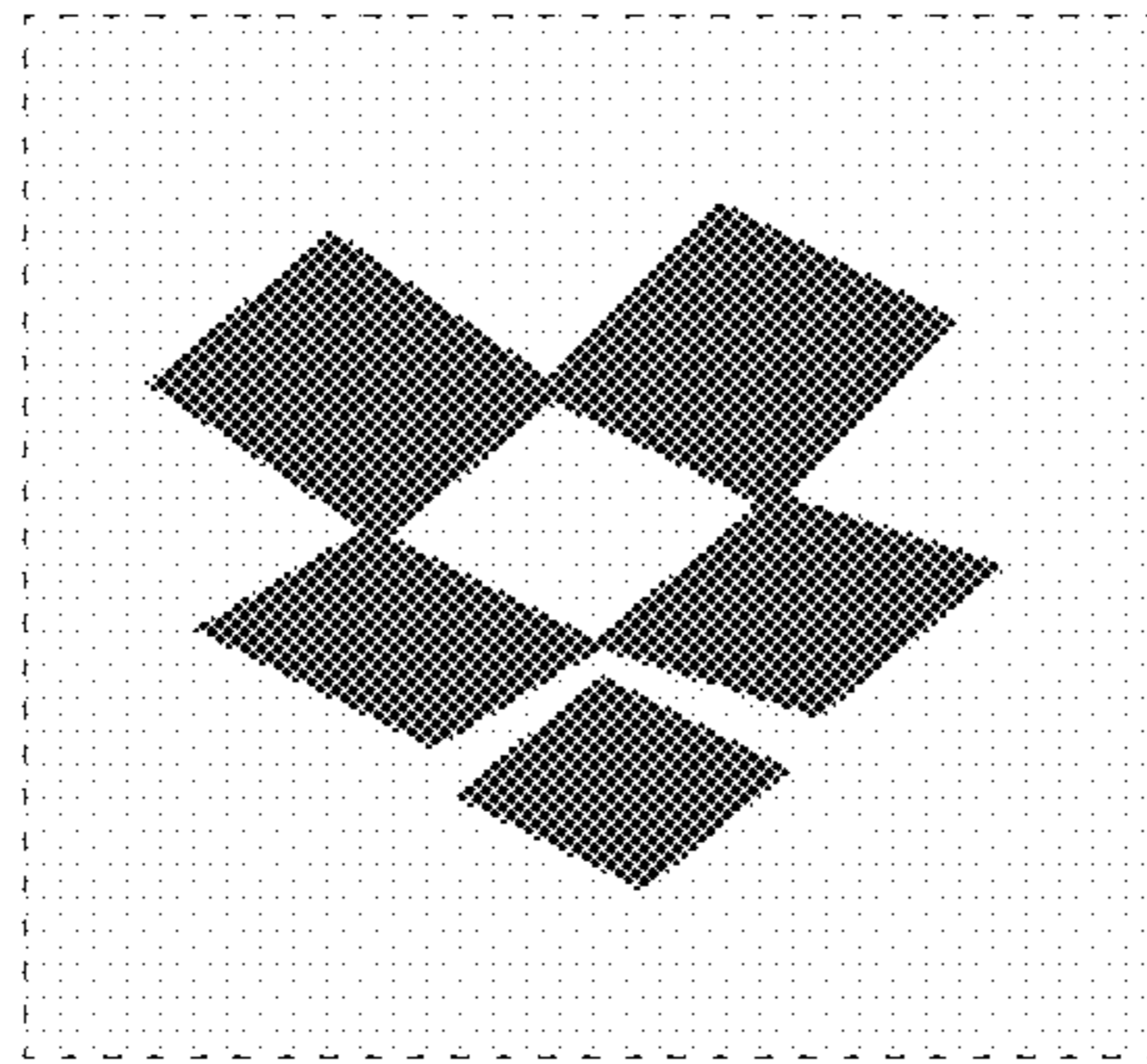

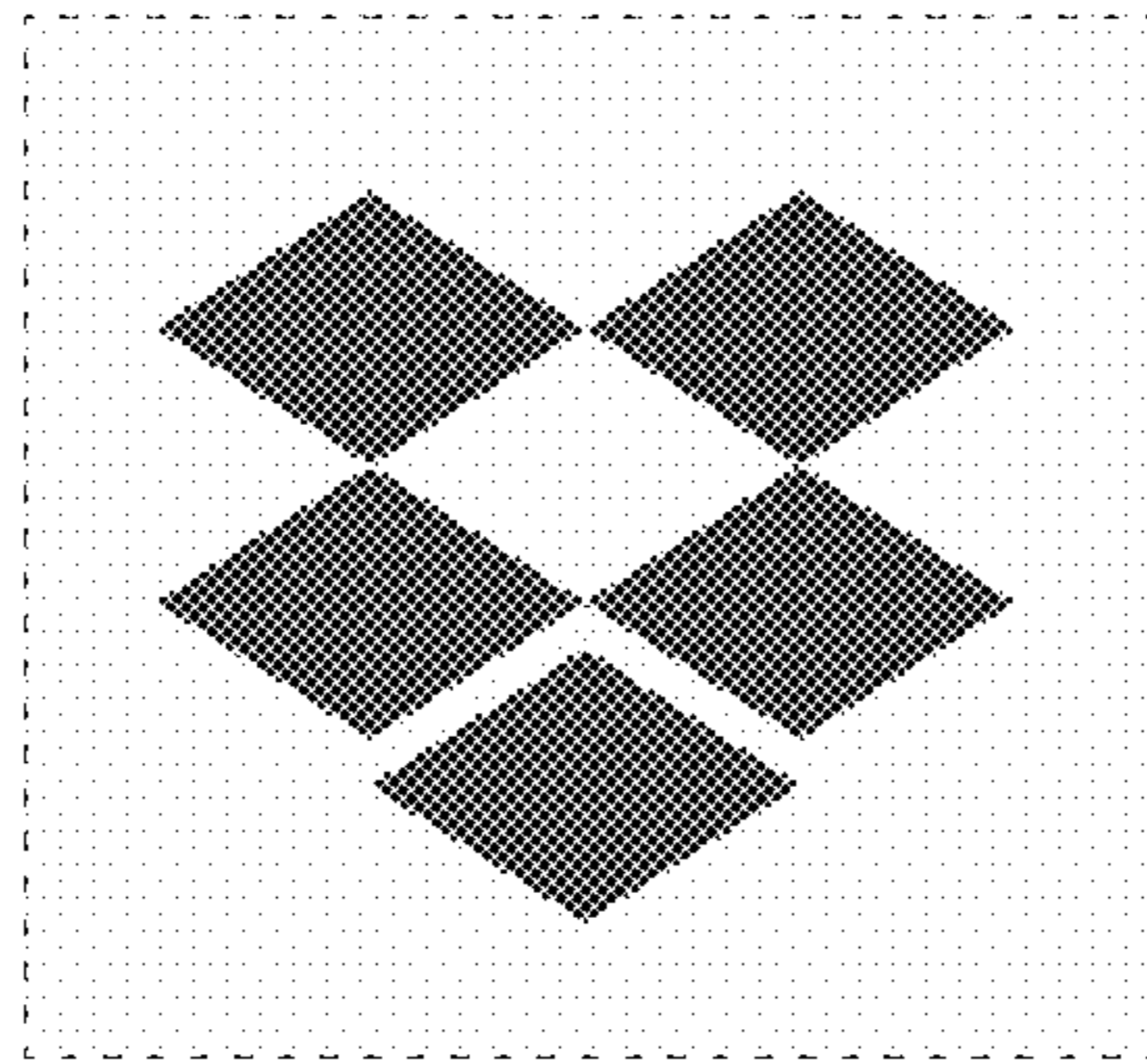
