(57) **CLAIM**

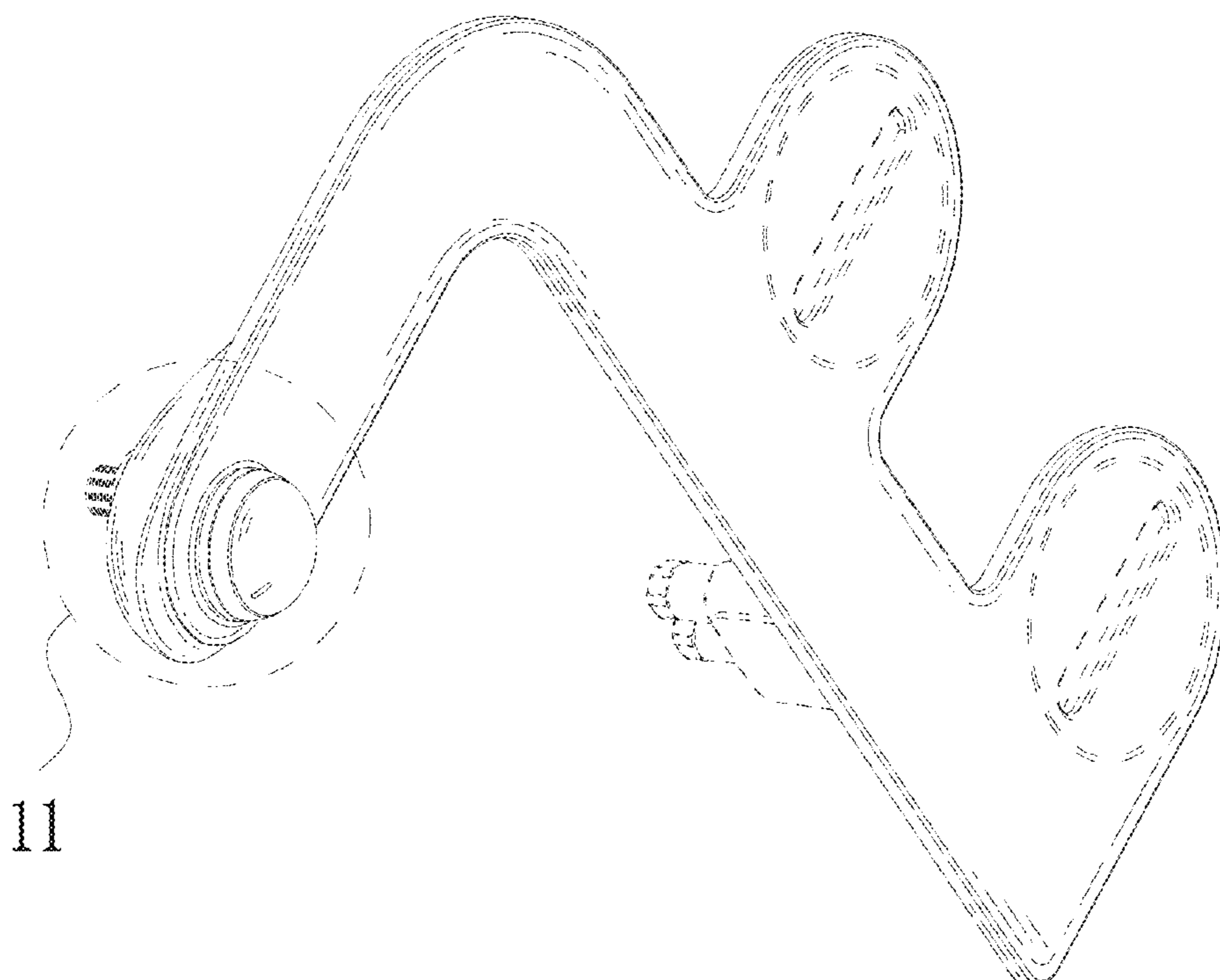
The ornamental design for a bidet apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bidet apparatus showing the new design;

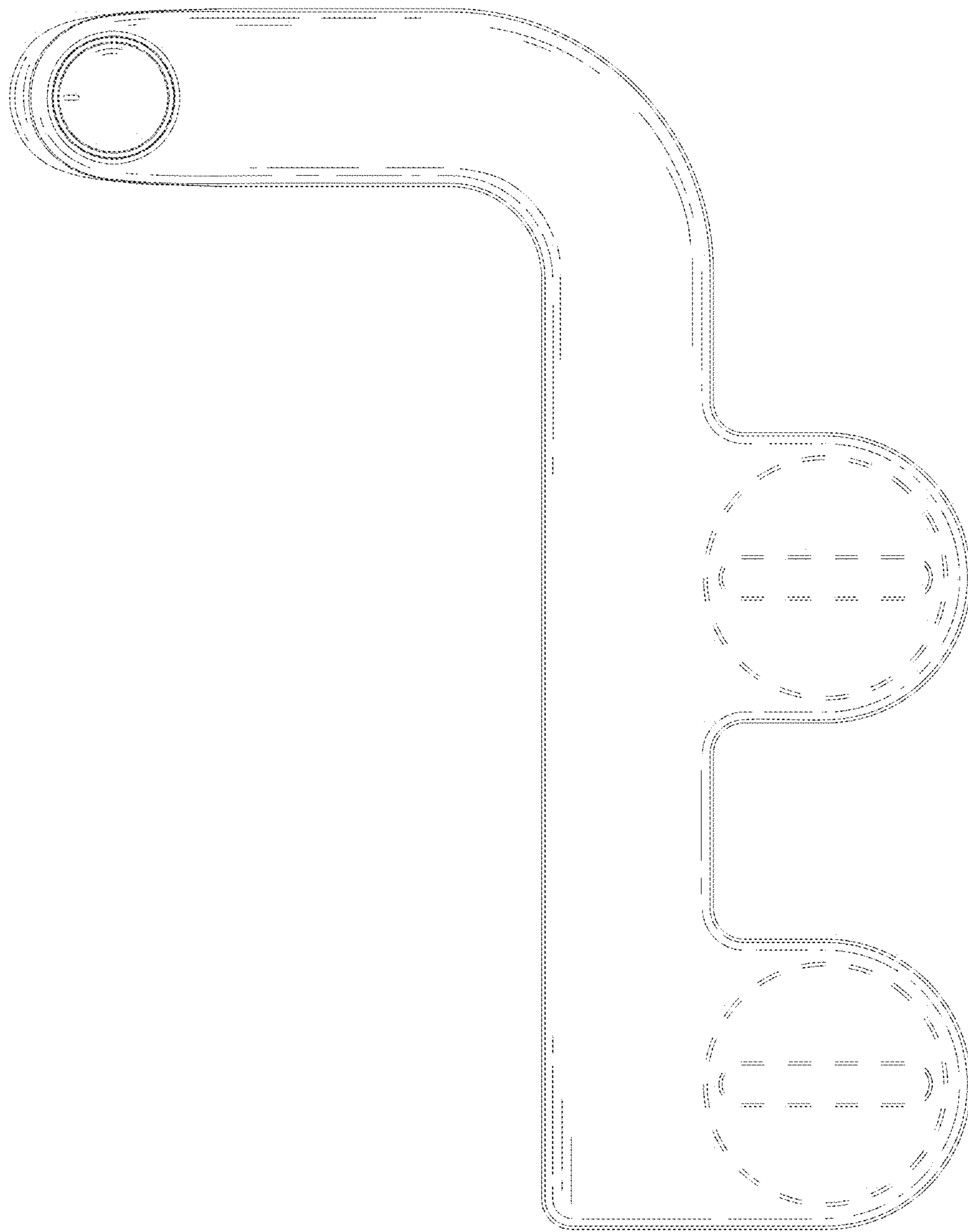

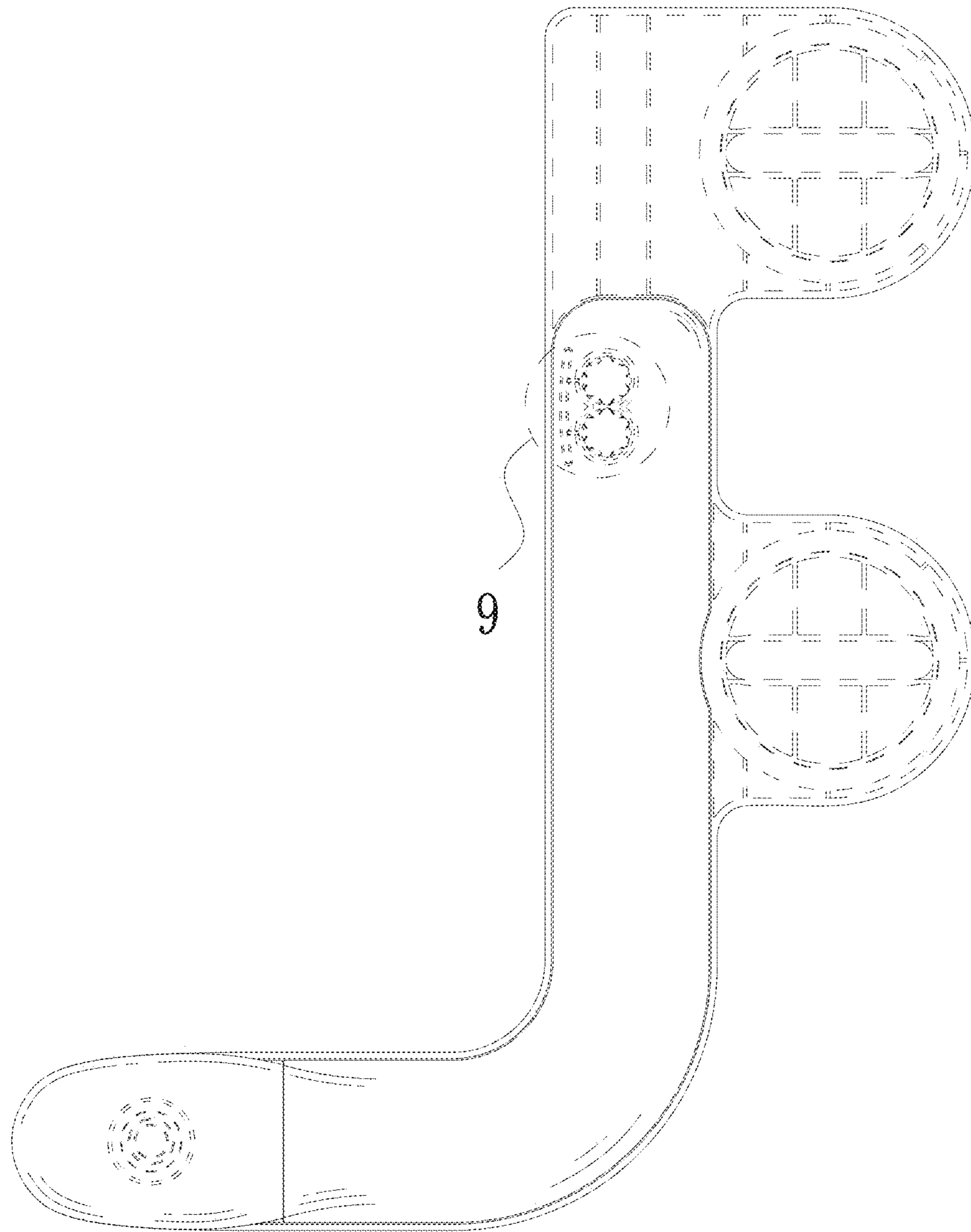

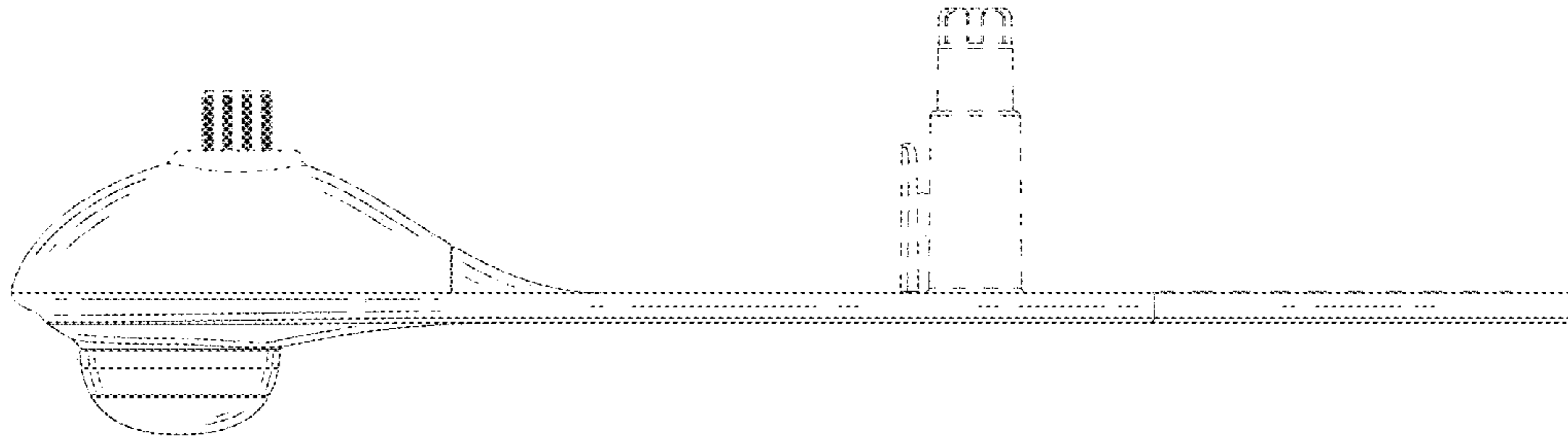

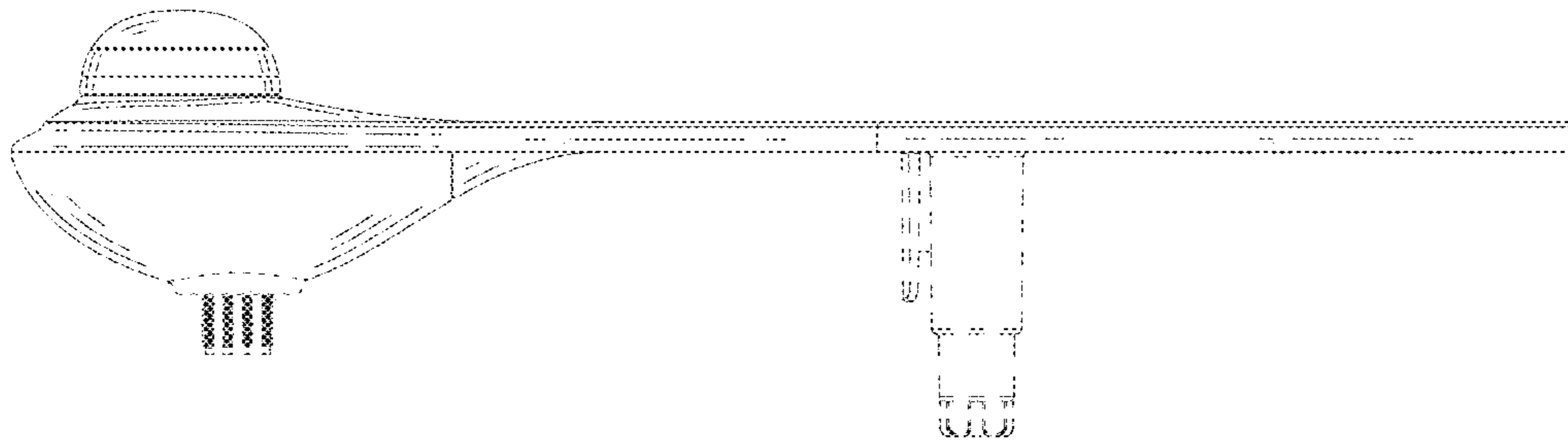

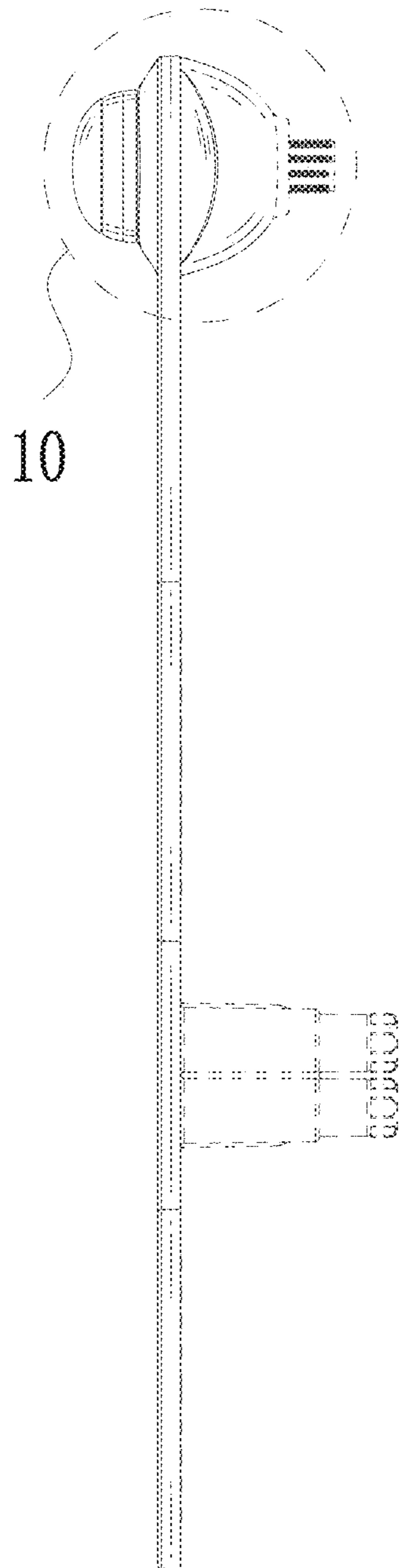

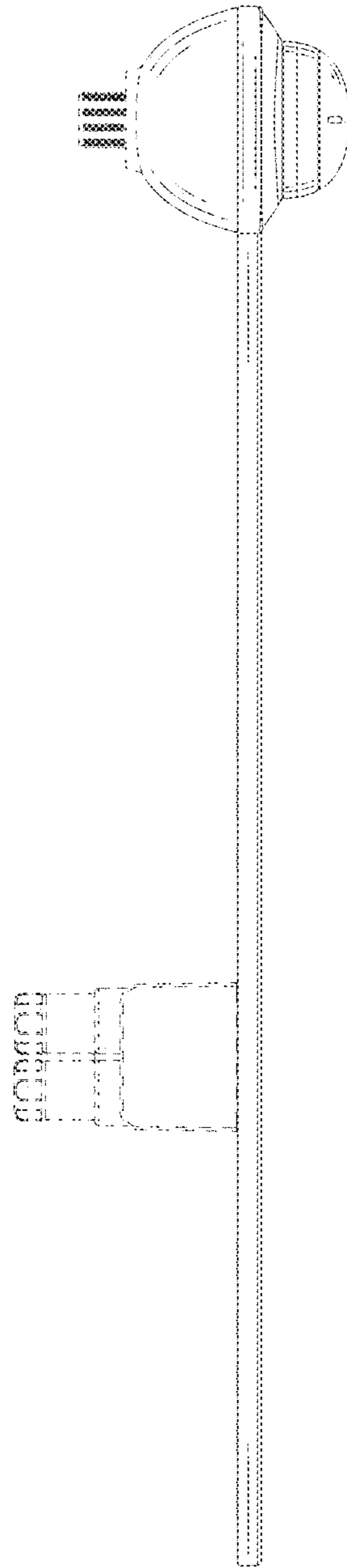

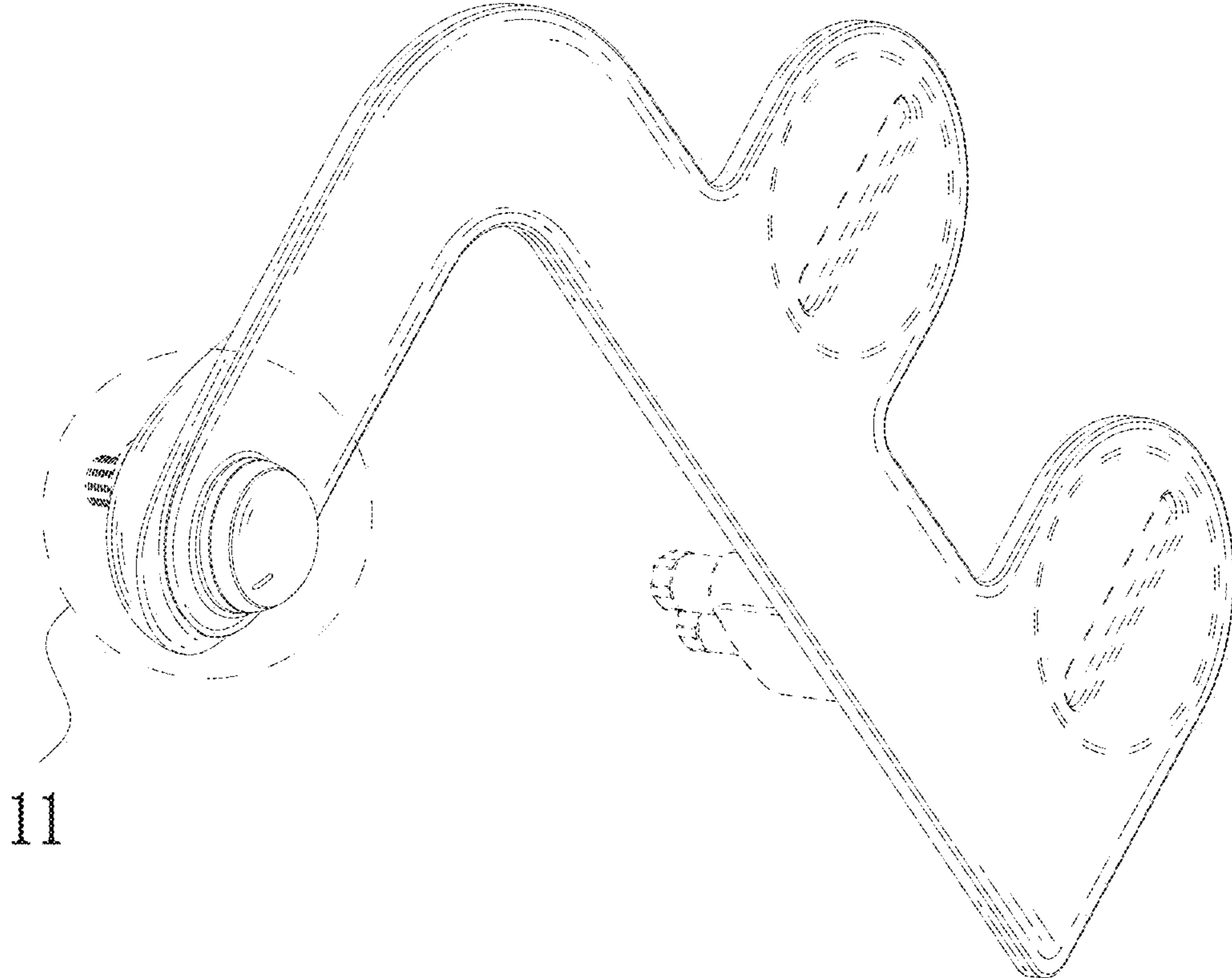

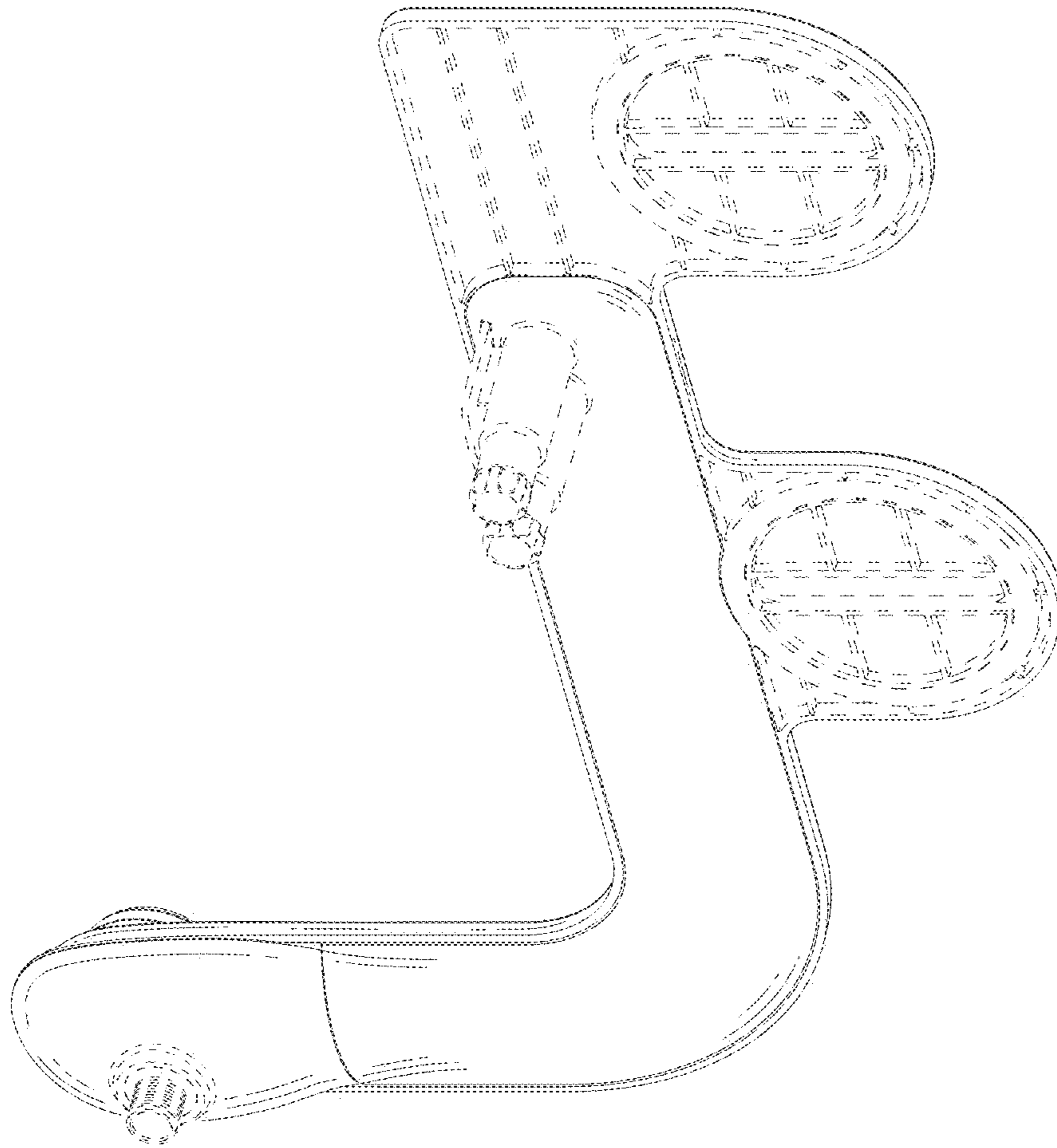

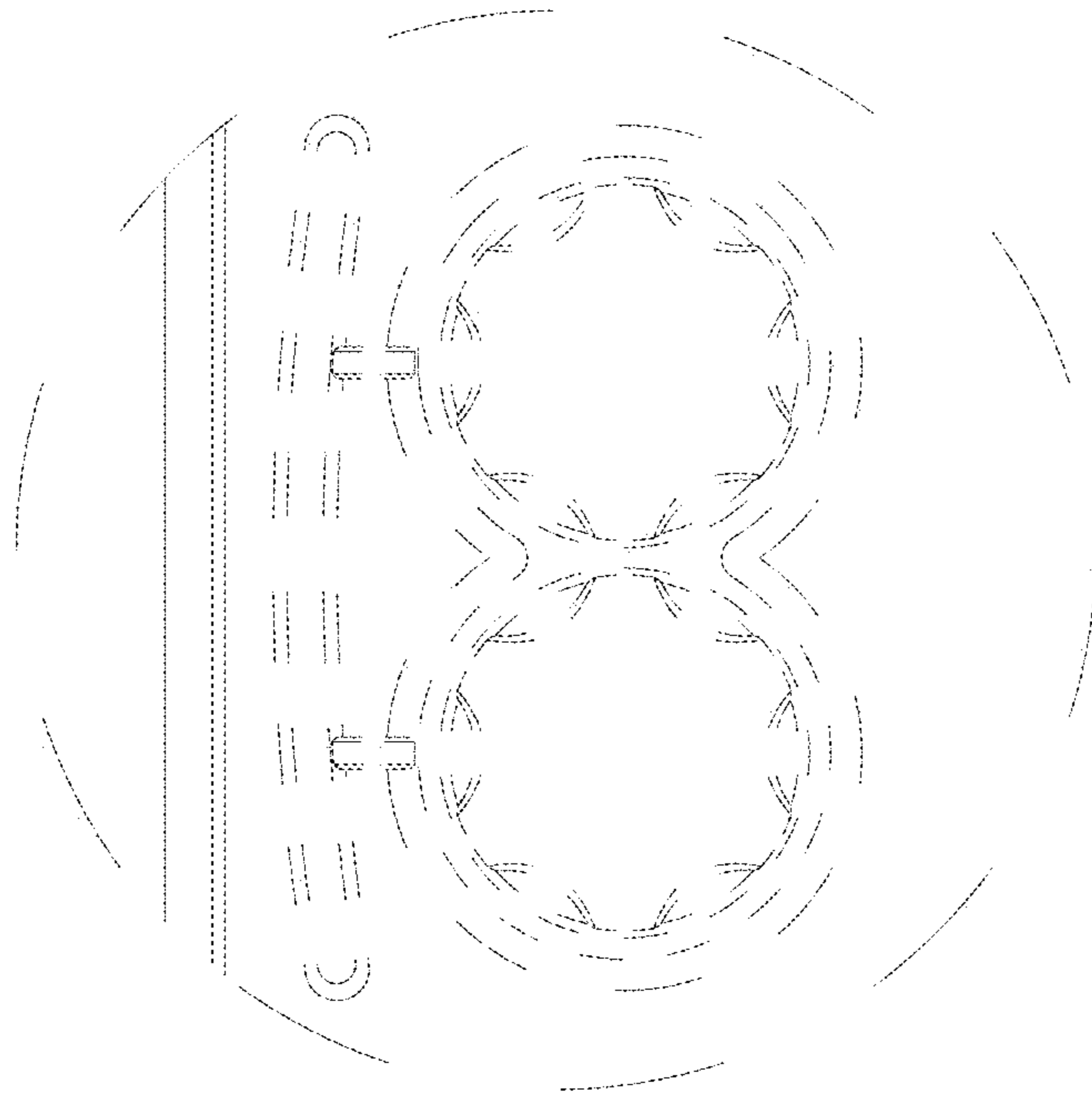

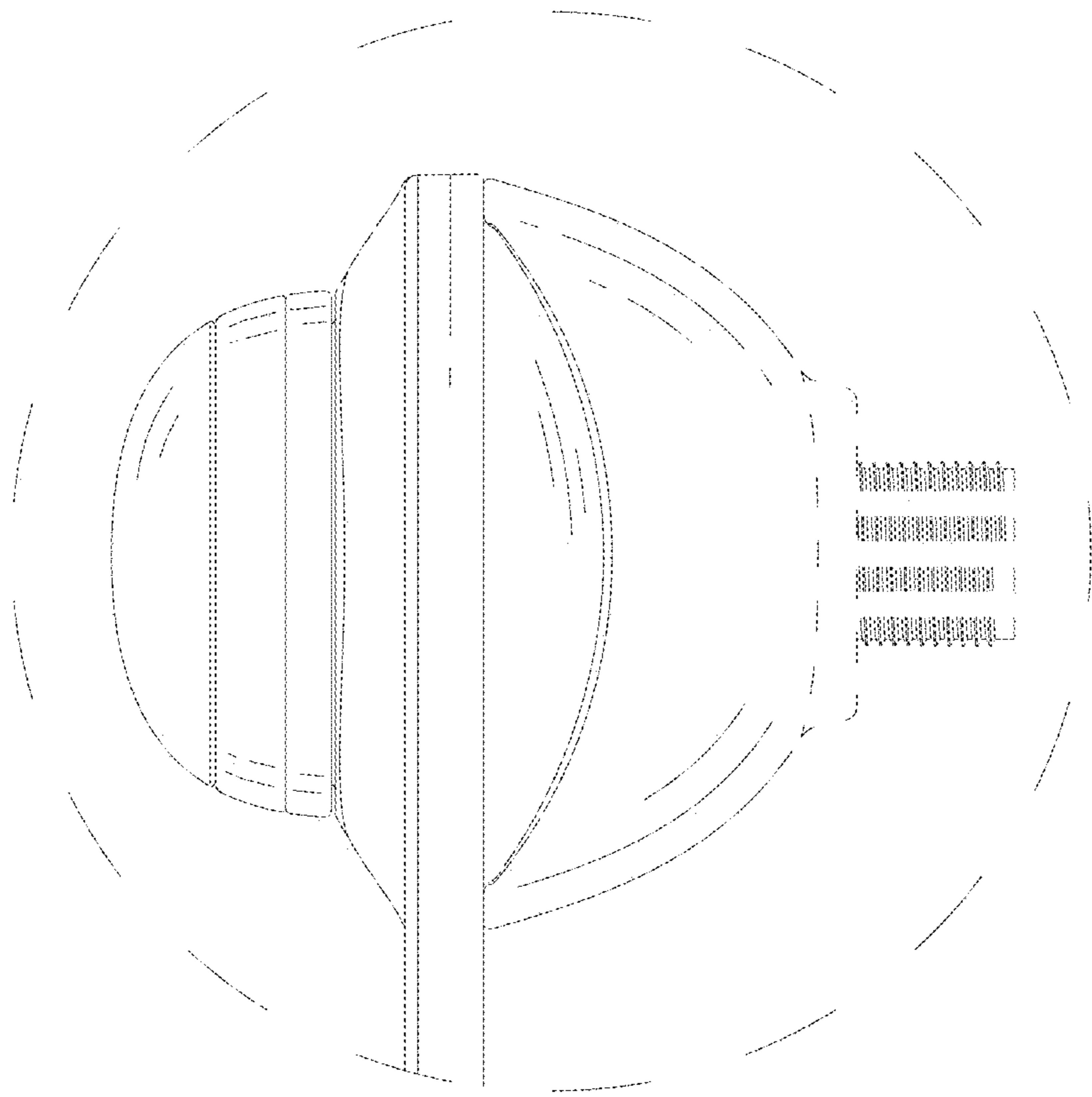

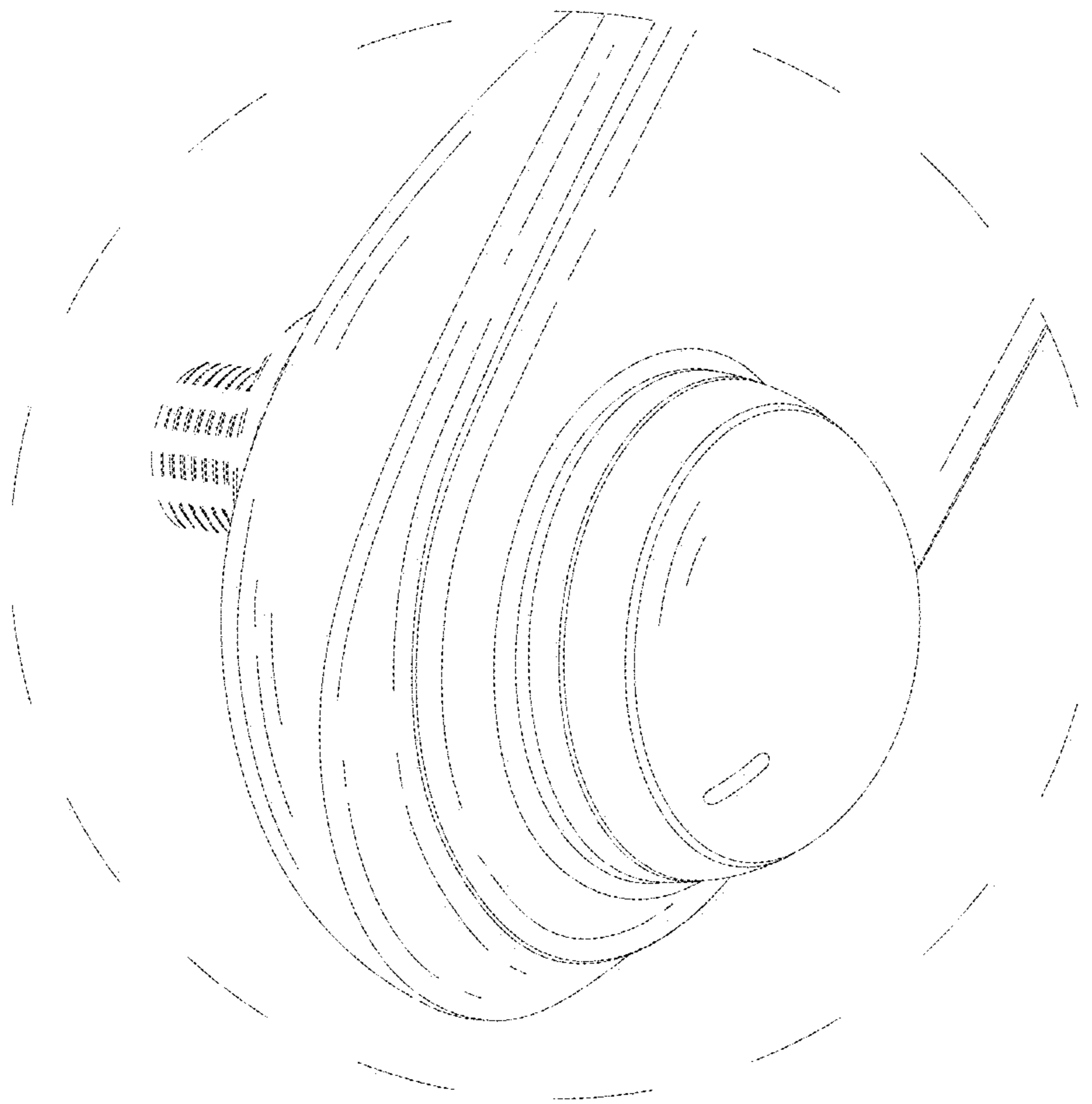
