(57) **CLAIM**

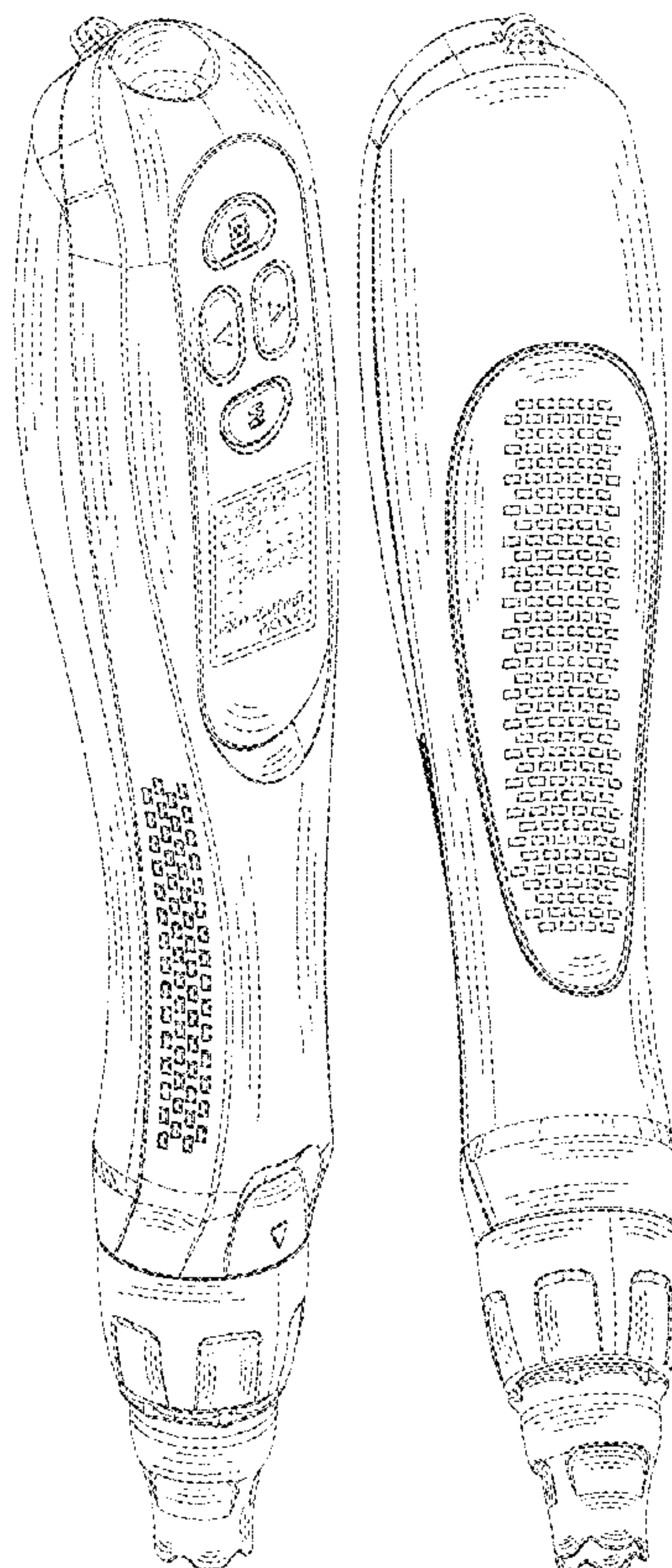
The ornamental design for a skin care device, as shown and described.

DESCRIPTION

FIG. 1 is a front, left and top perspective view of a skin care device showing my new design;

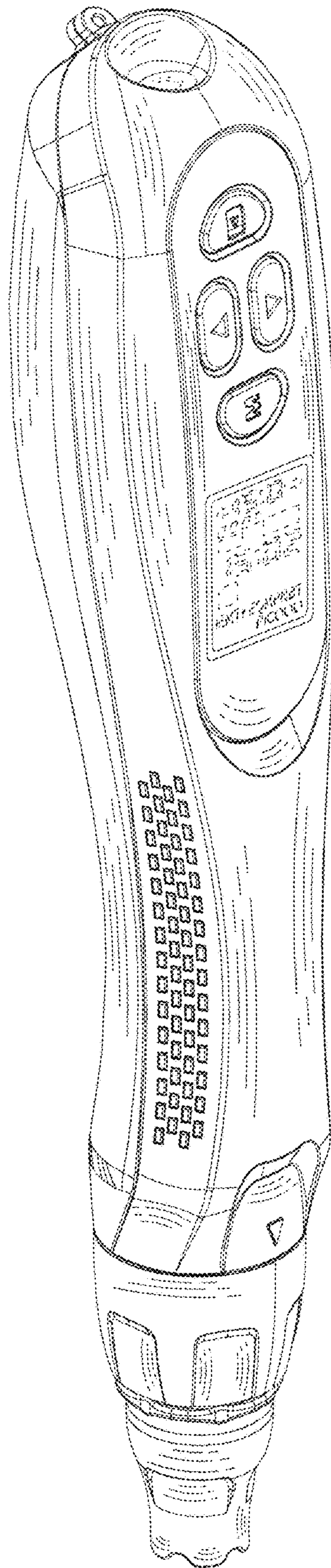

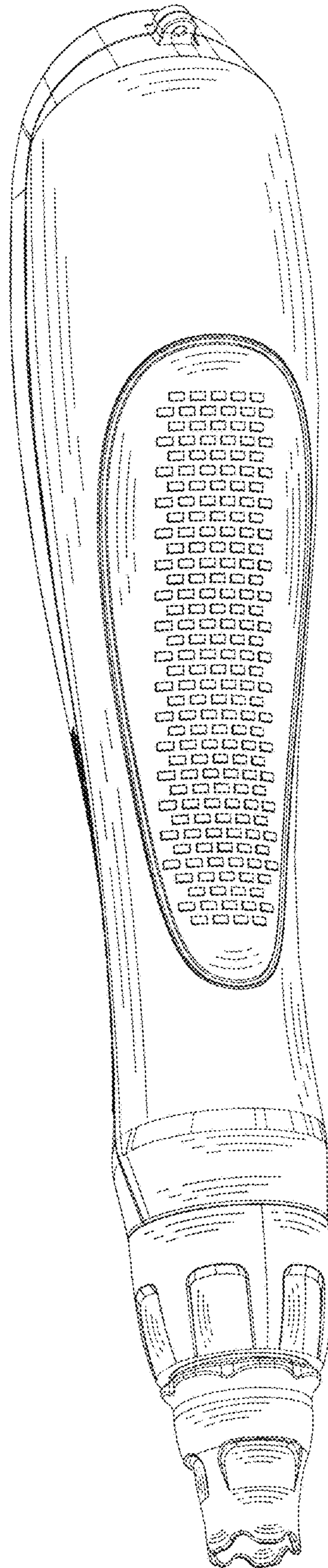

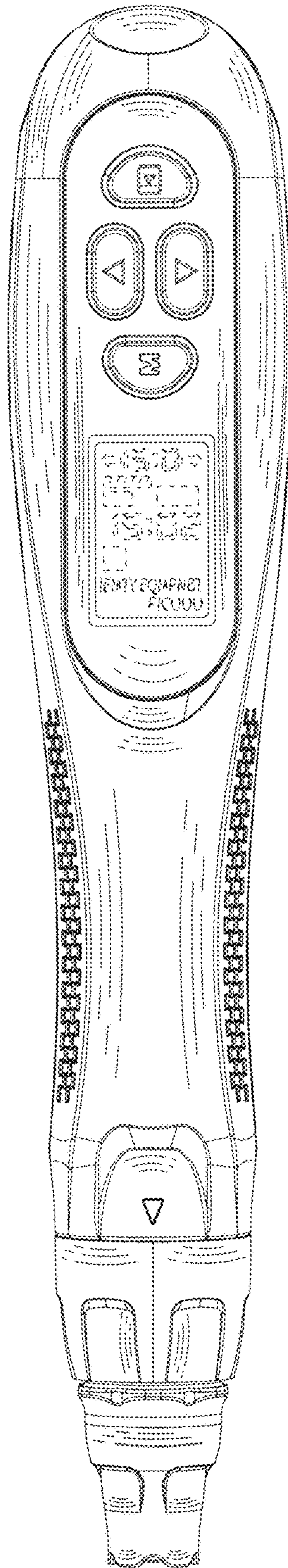

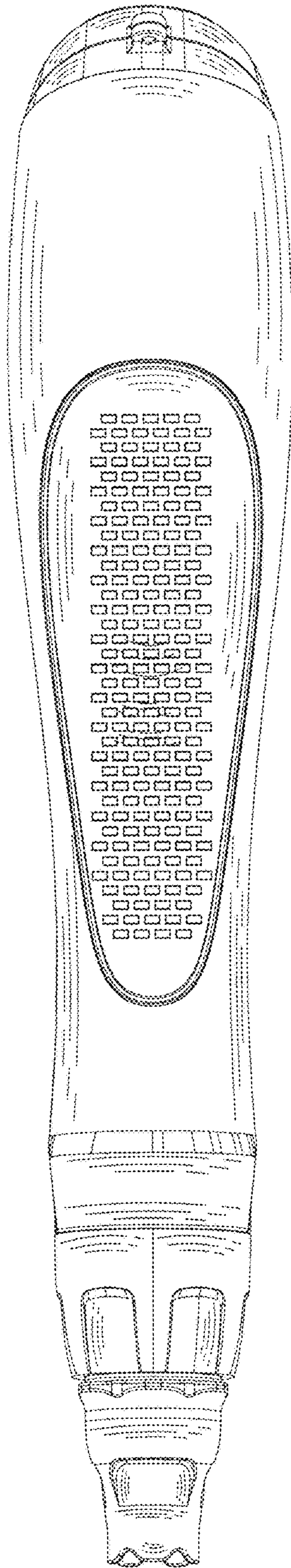

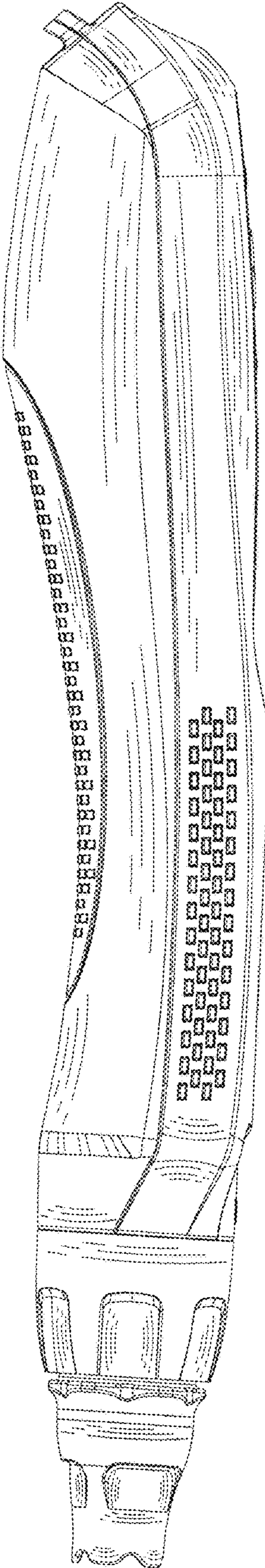

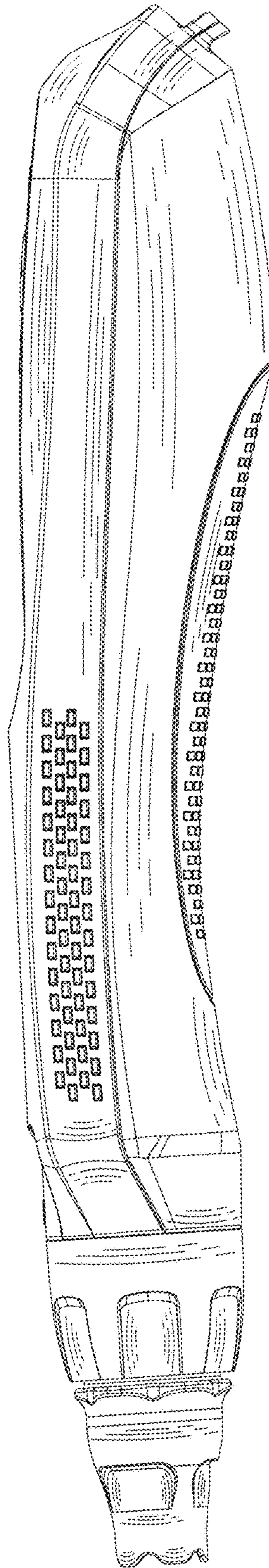

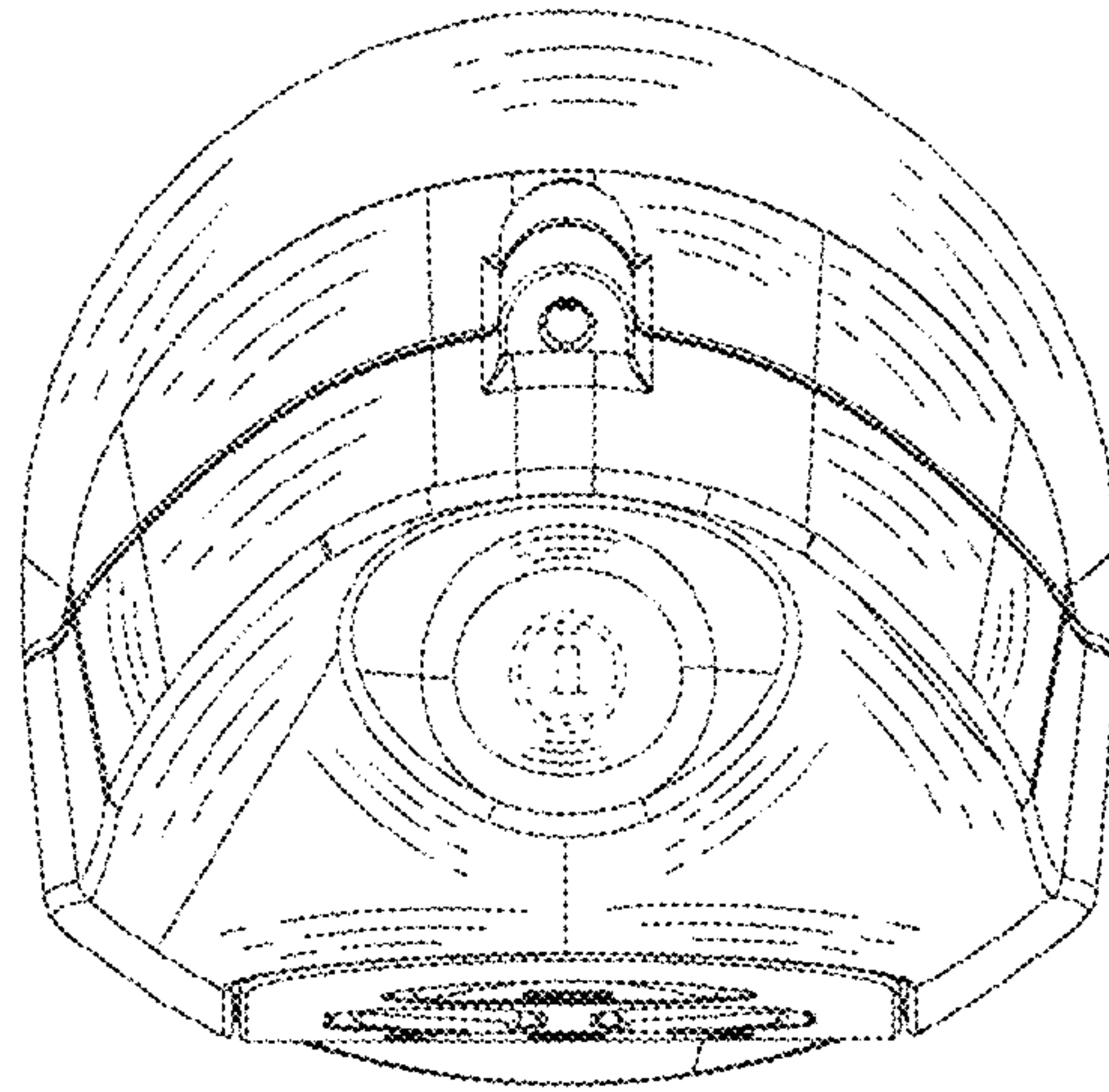

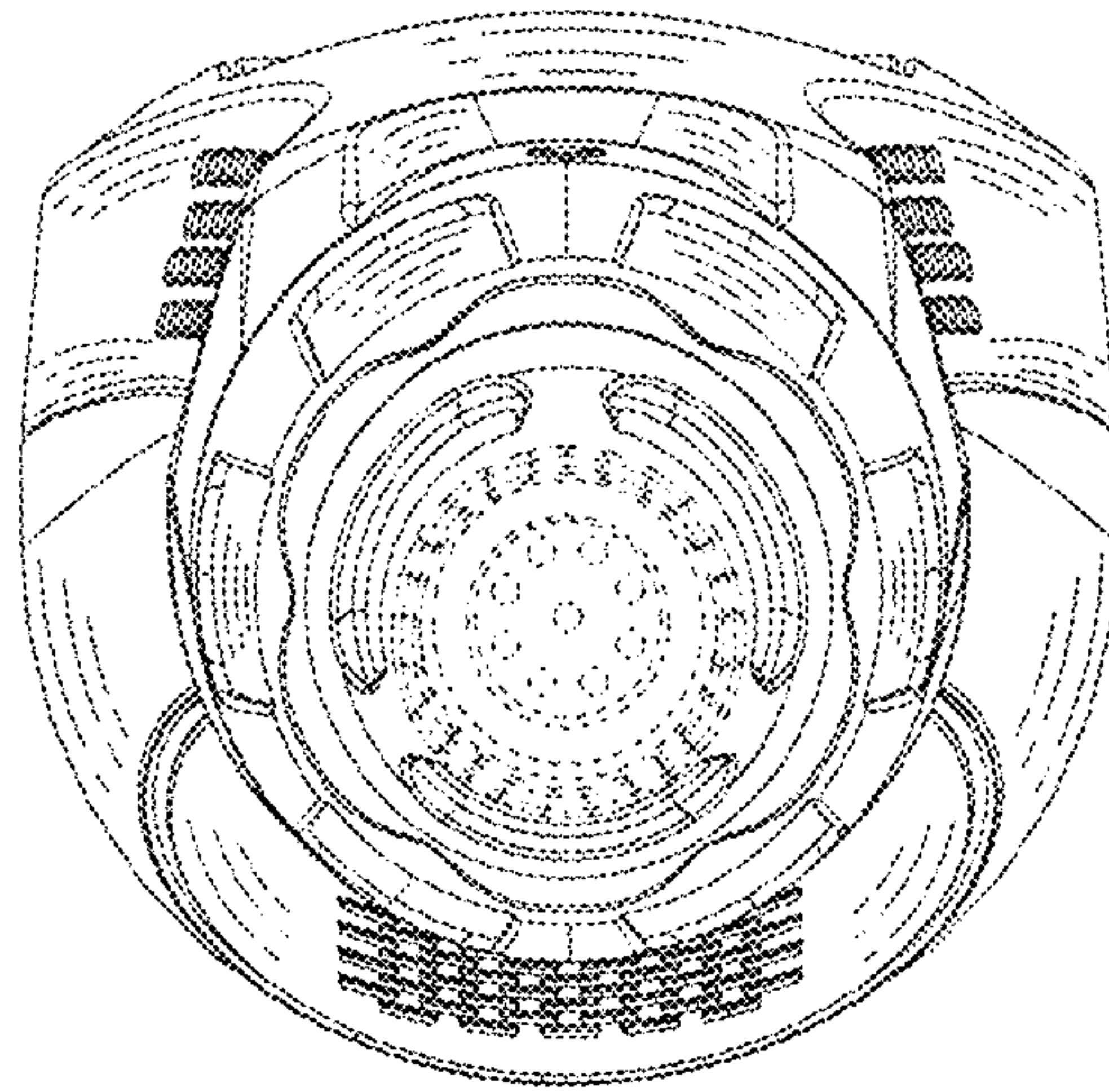

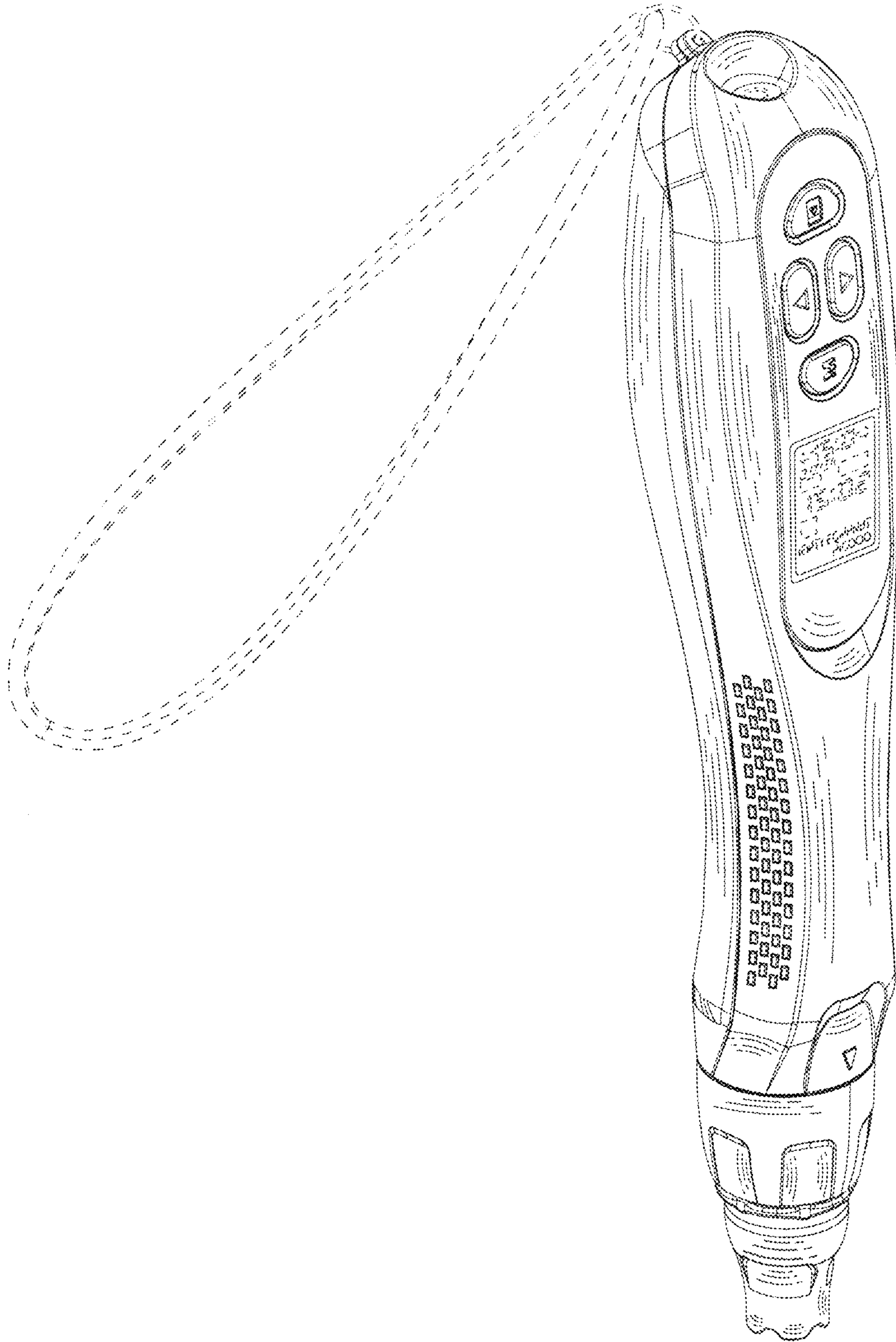
