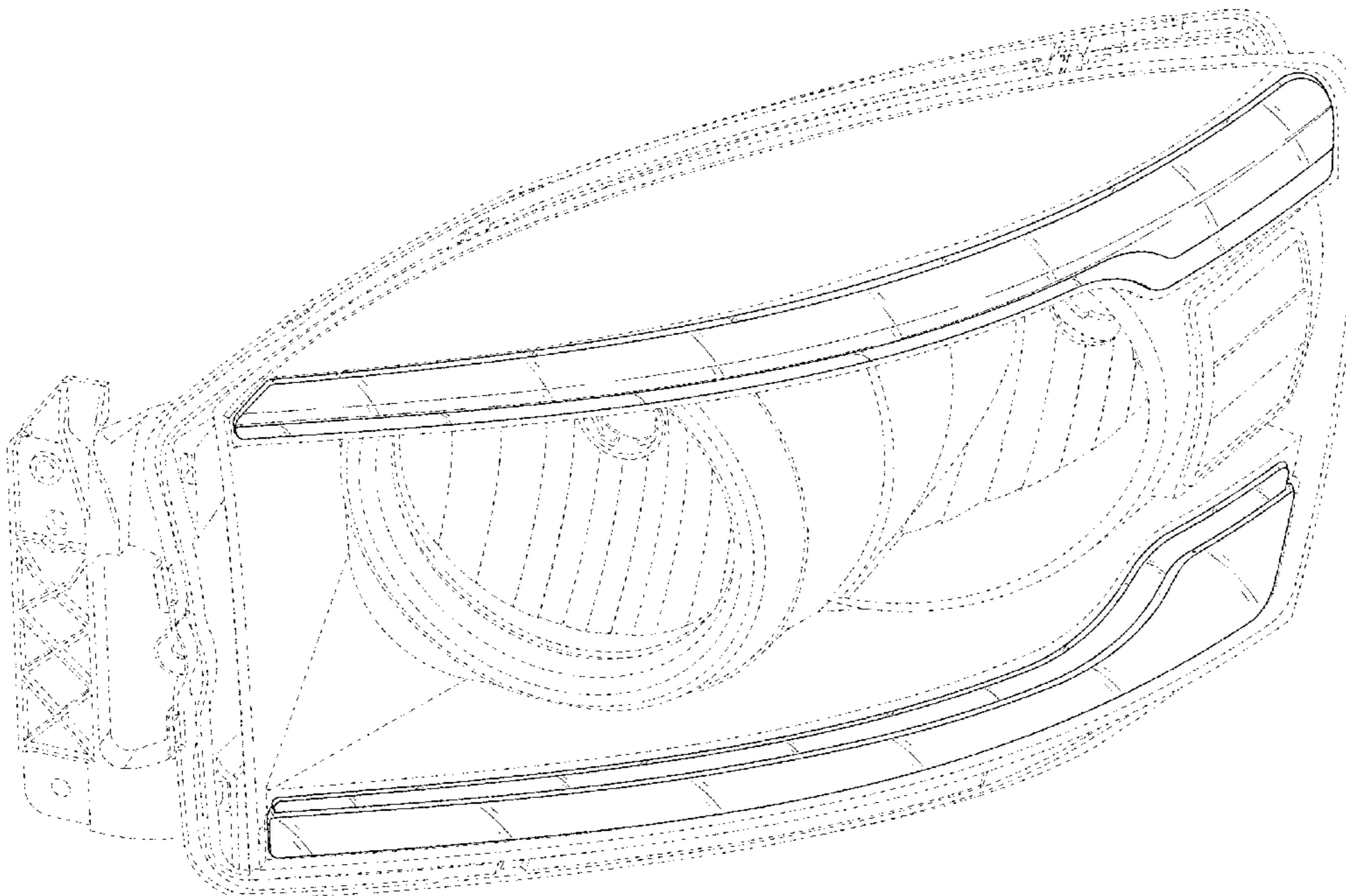
The ornamental design for a vehicle light, as shown and described.

**DESCRIPTION**

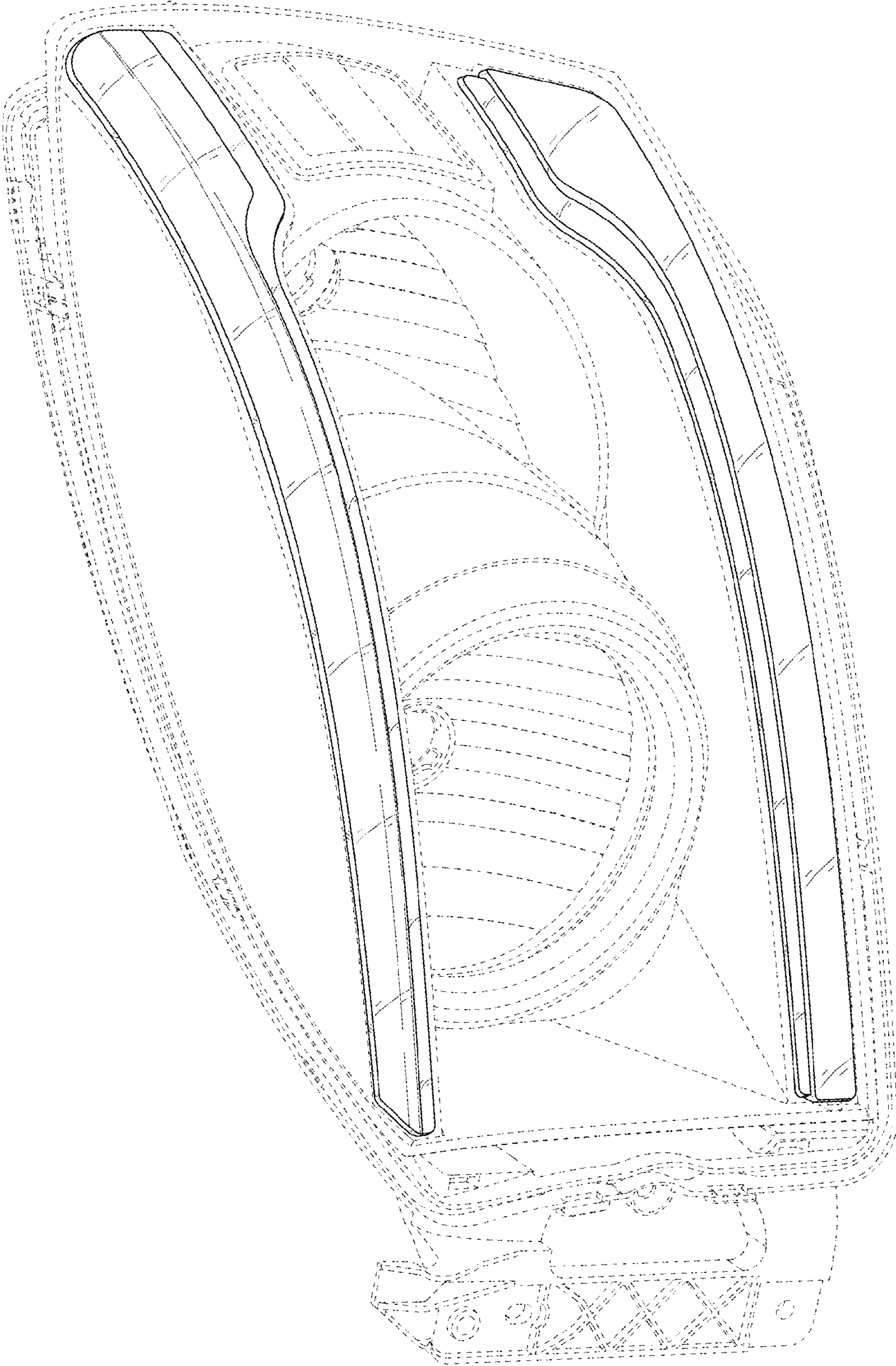

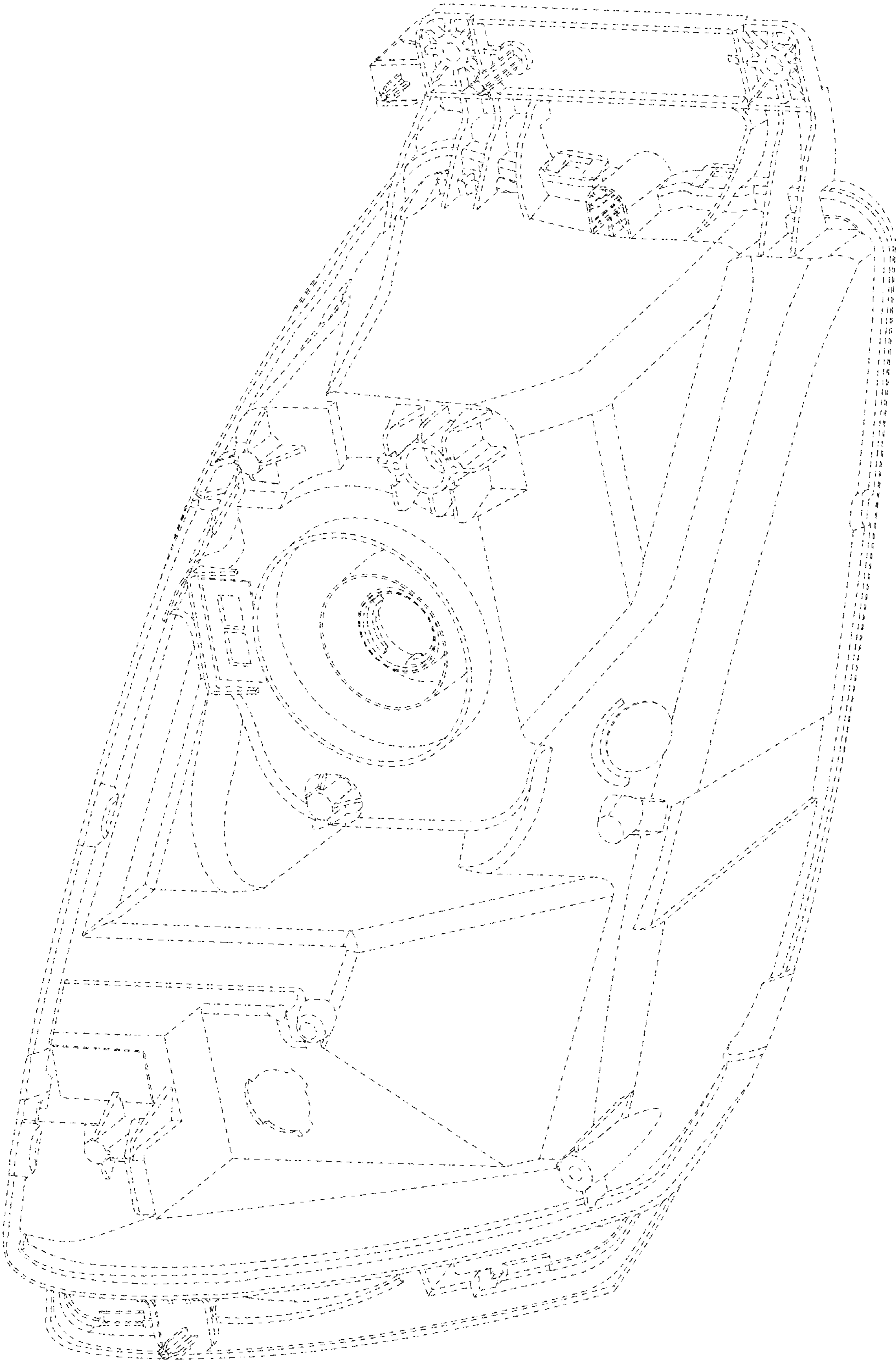

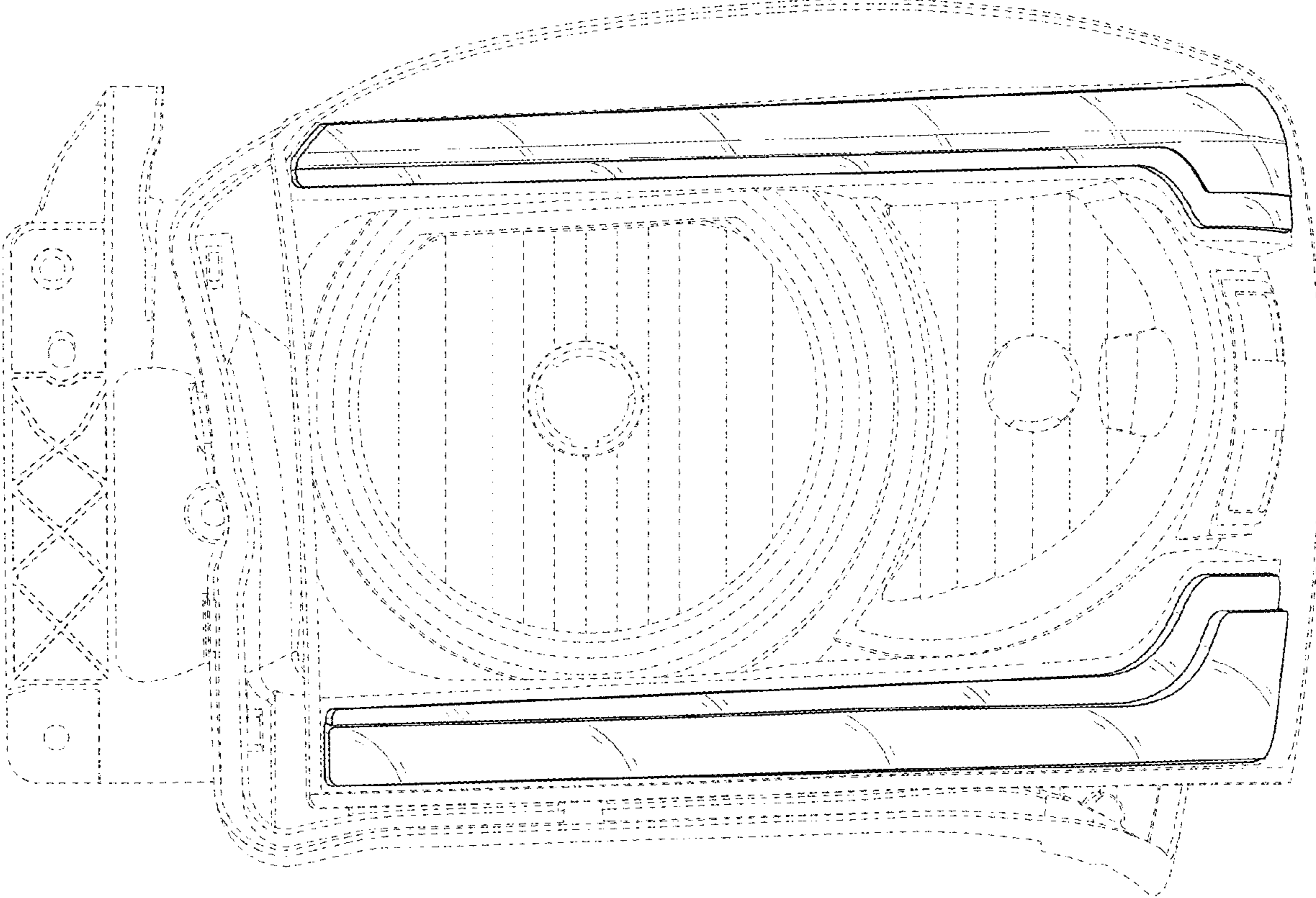

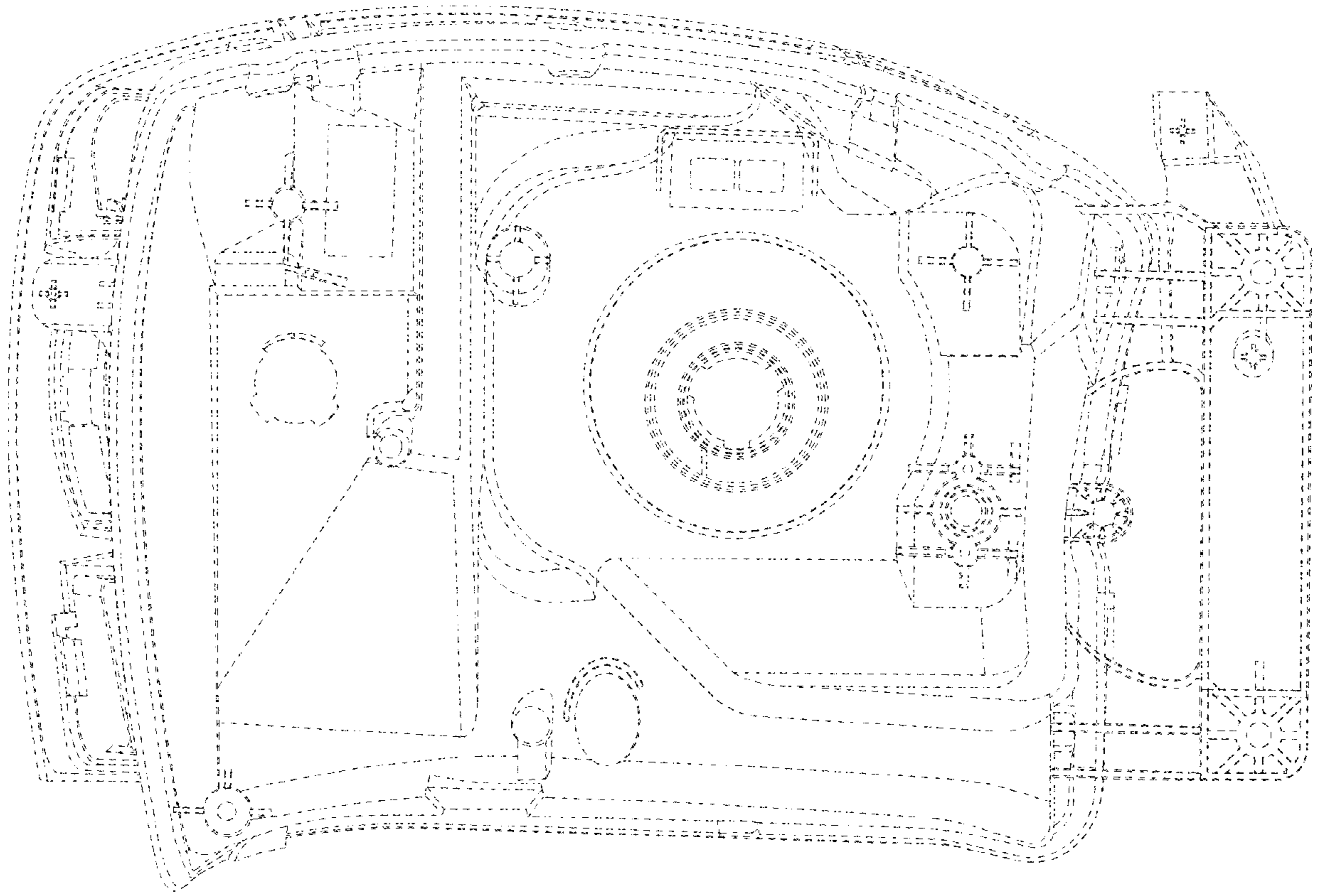

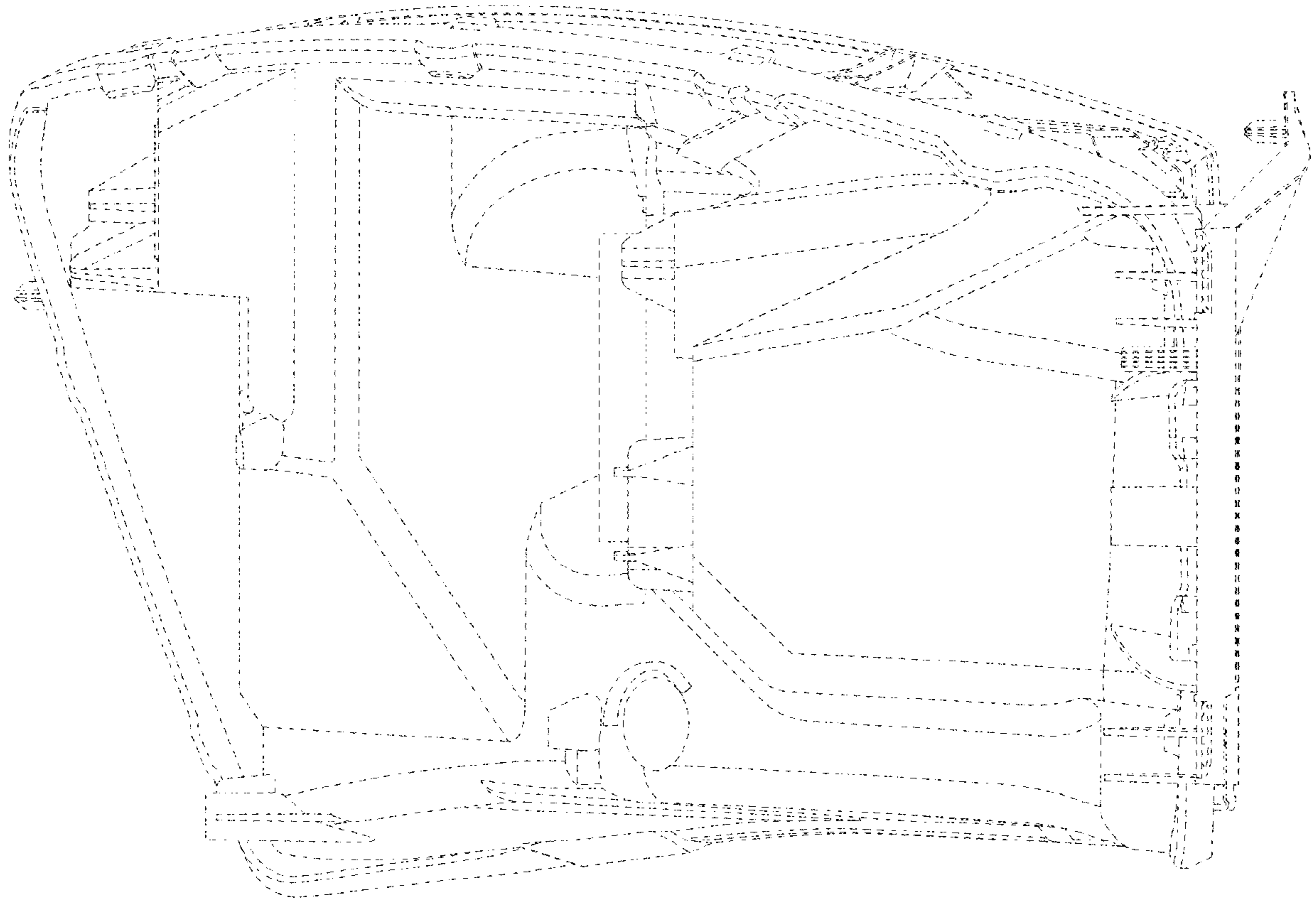

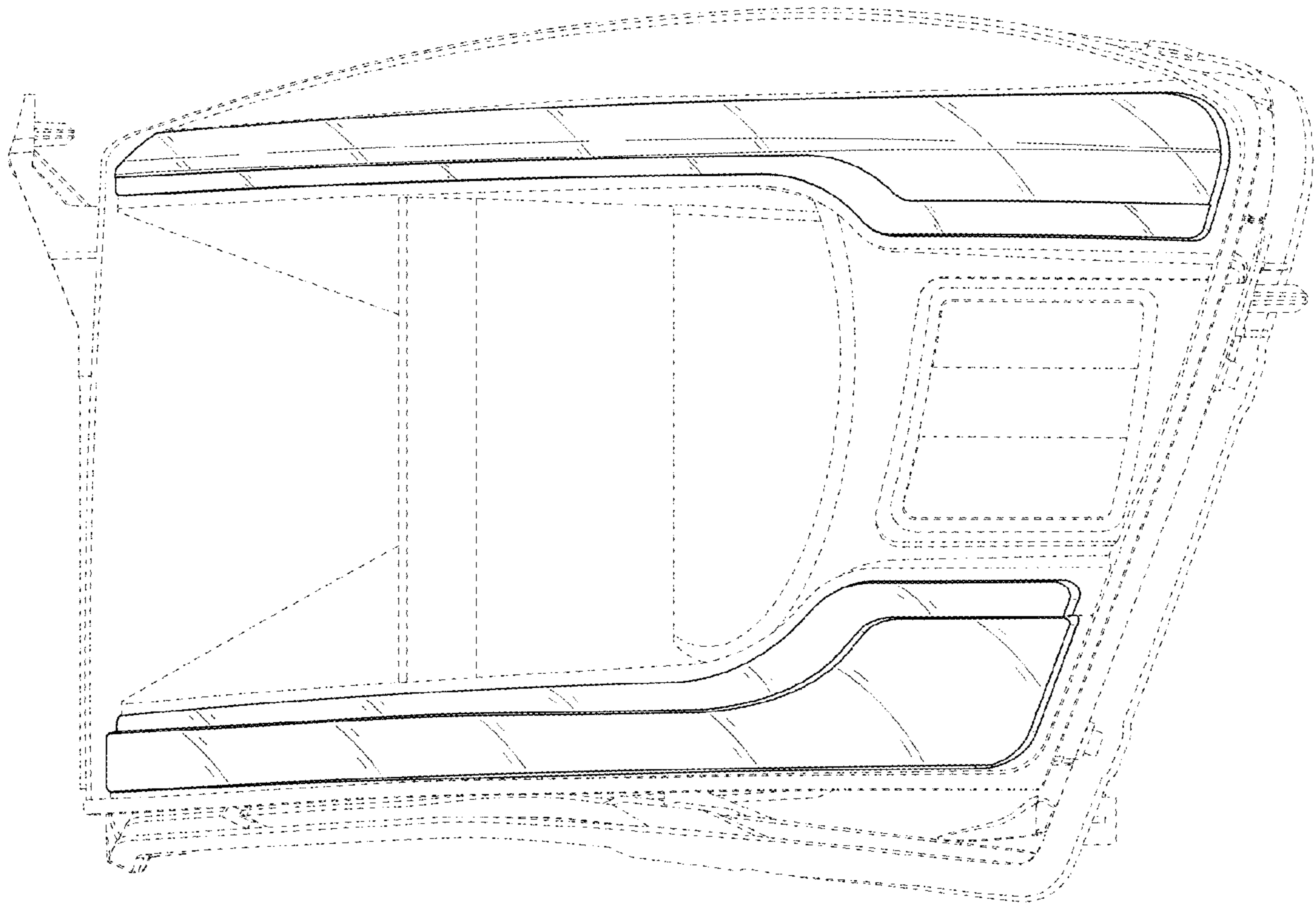

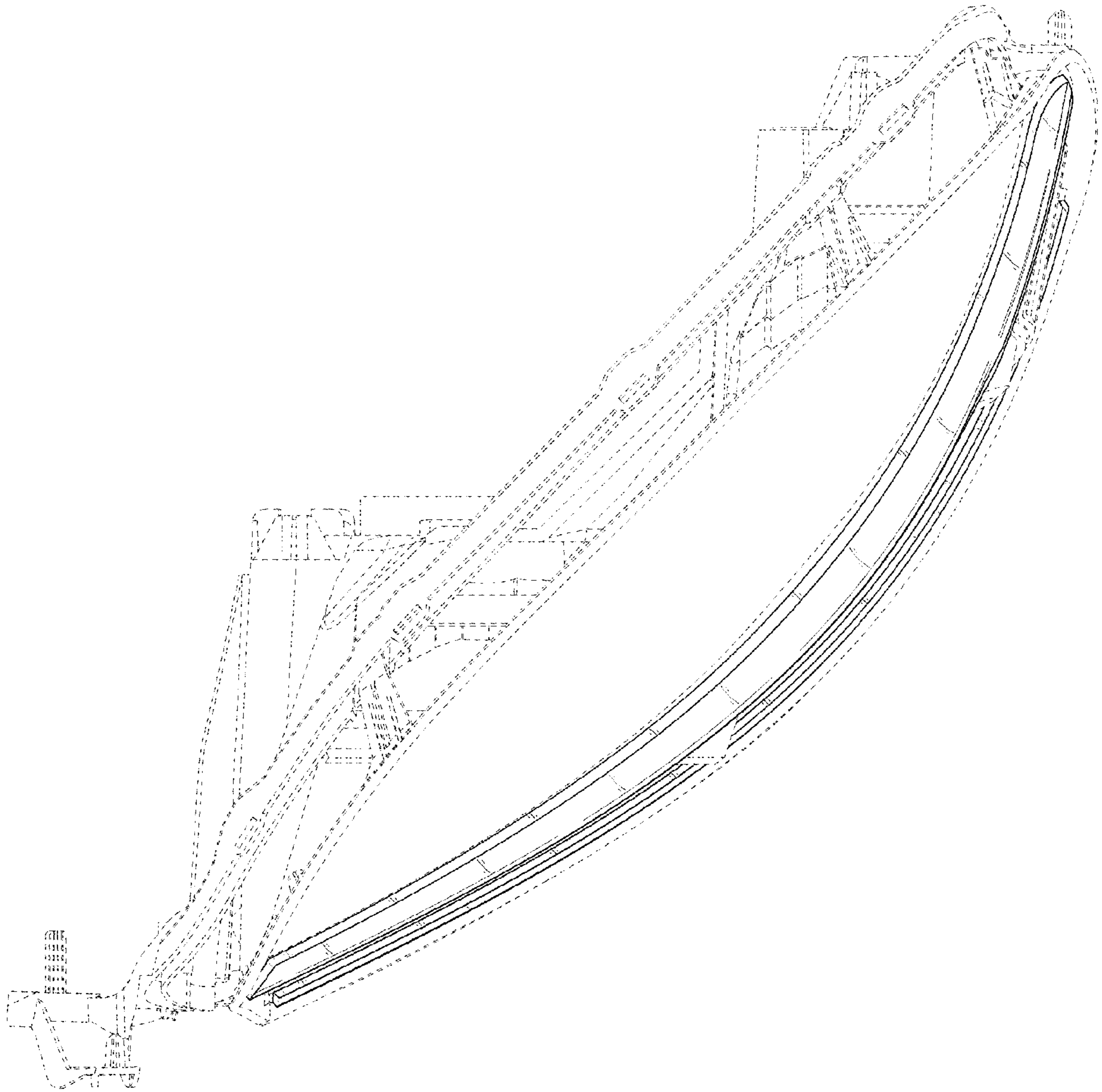

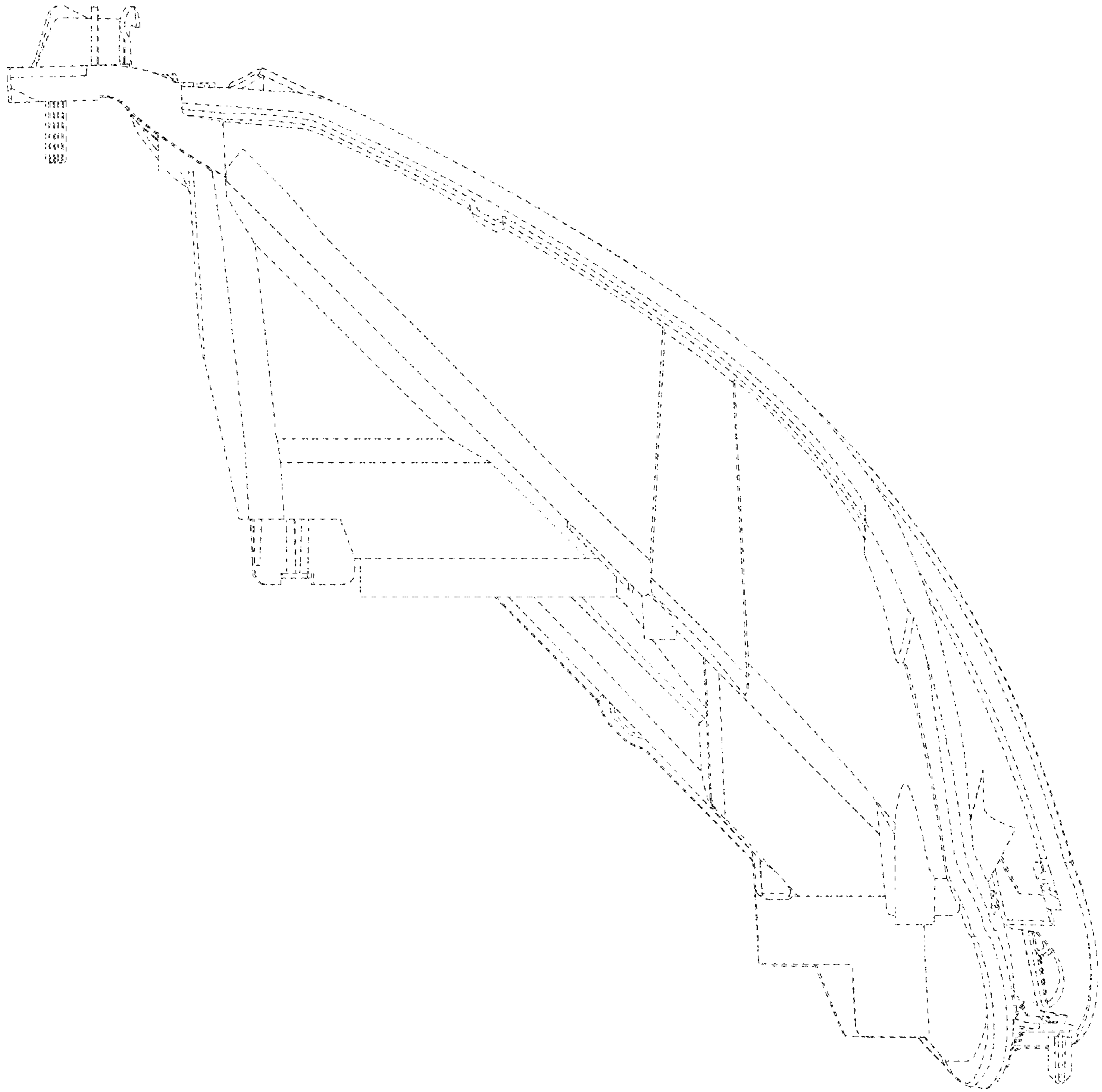

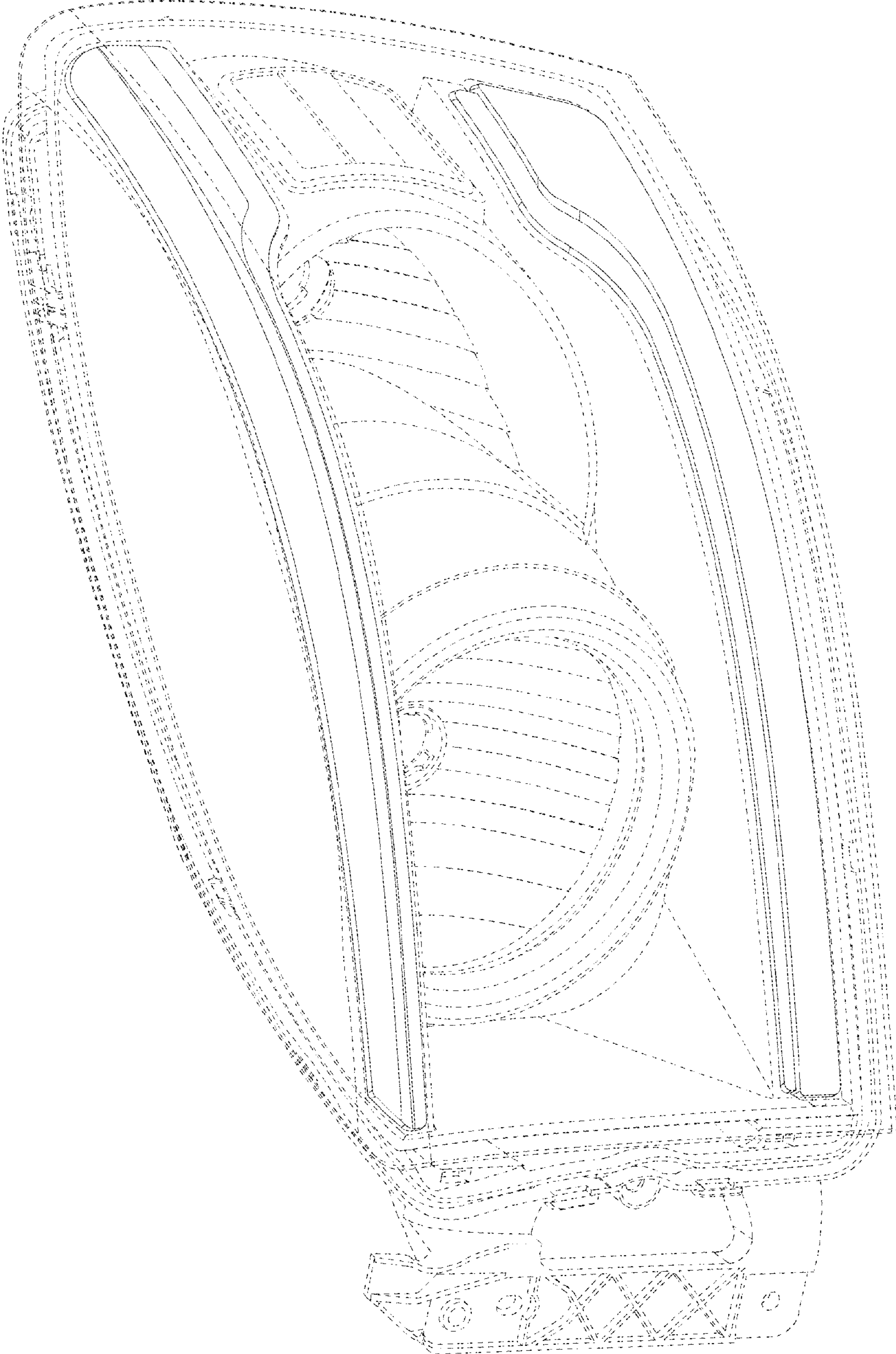

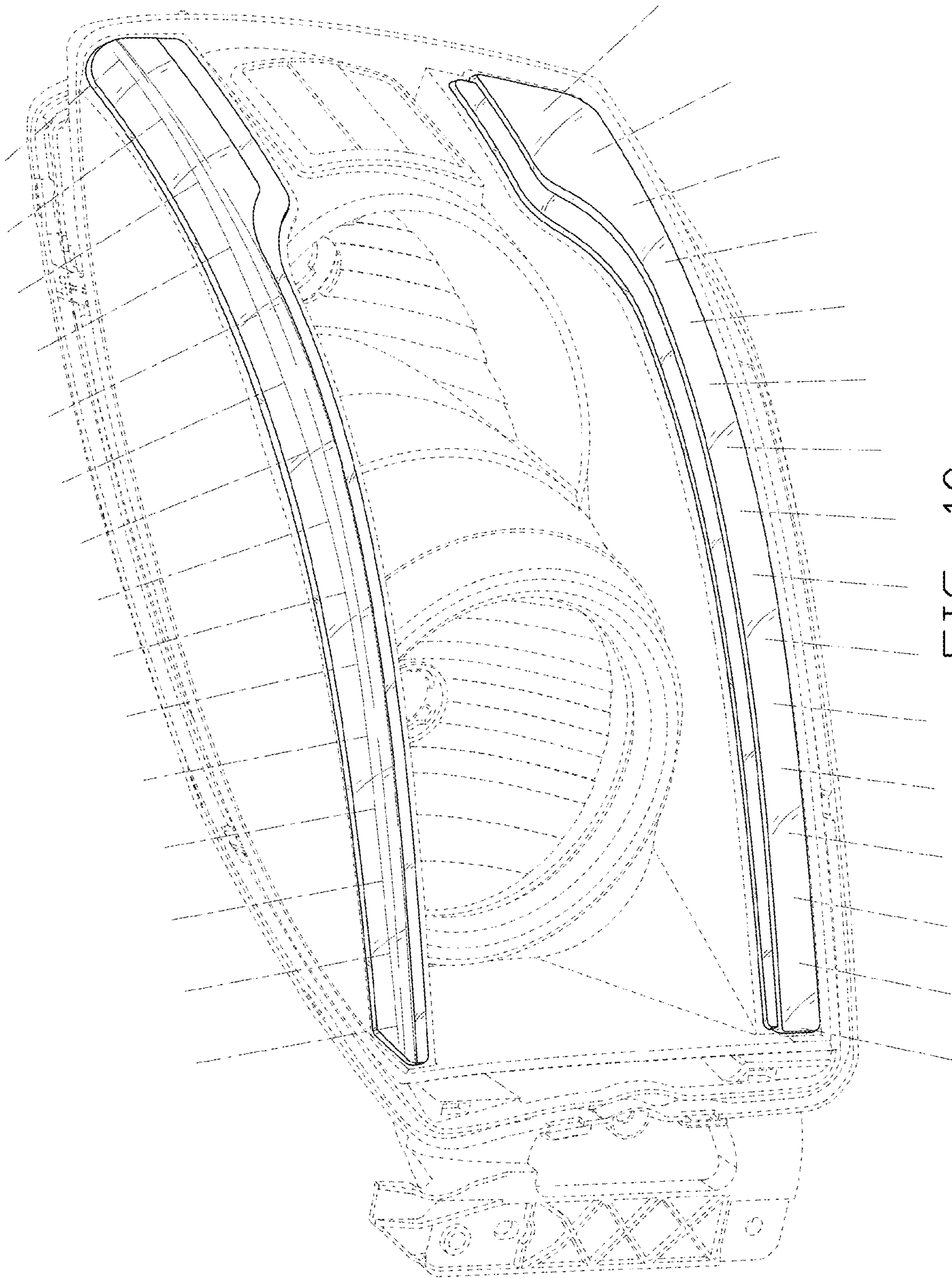
