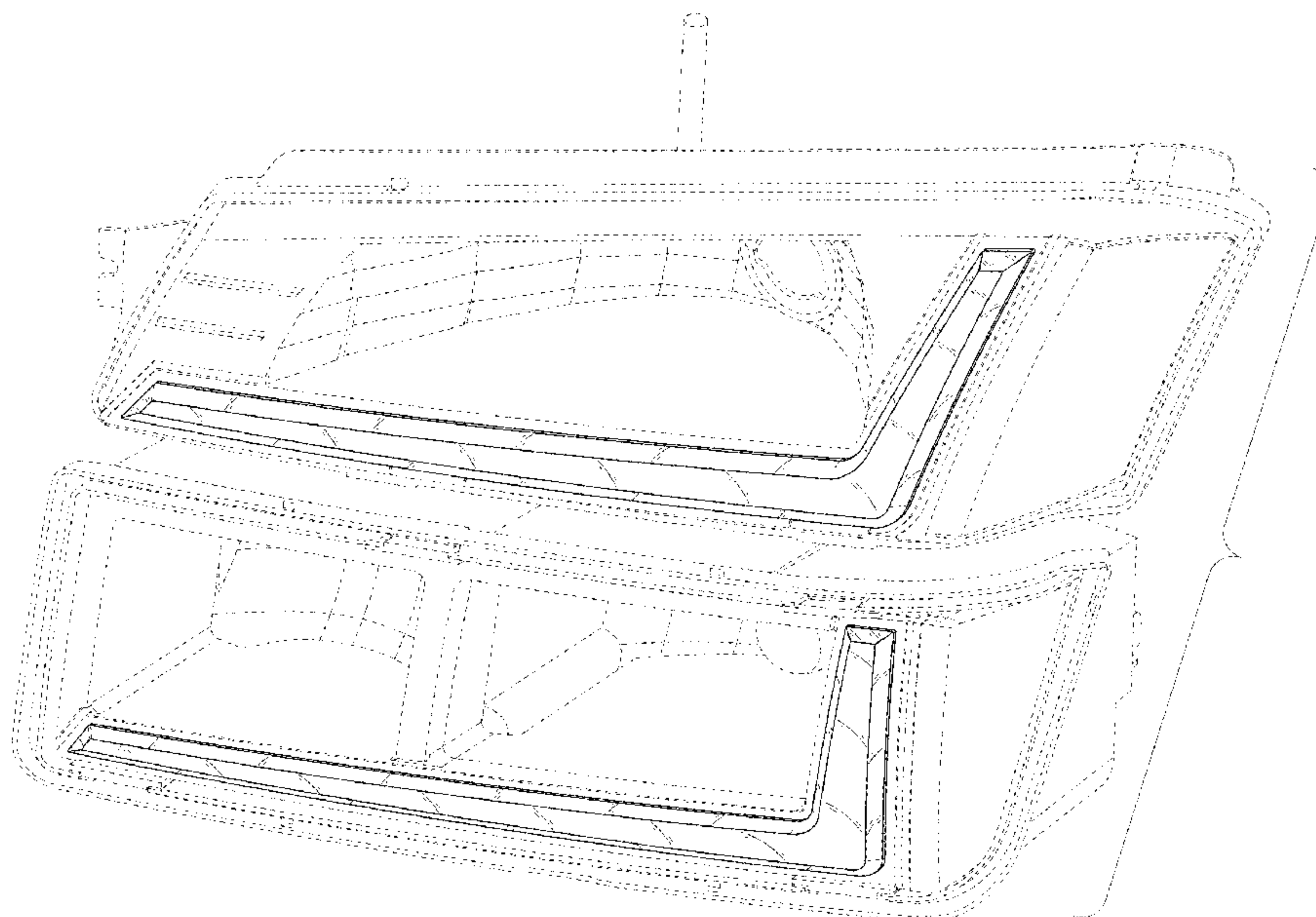
(57) **CLAIM**

The ornamental design for a vehicle light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle light showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a perspective view of the vehicle light where the vehicle light is shown in an environment of use.
The dash-dash broken lines in the drawings depict portions of the vehicle light that form no part of the claimed design. The dash-dot broken lines shown in FIG. 9 depict the vehicle light in a state of use that illustrate environmental subject matter only and form no part of the claimed design.

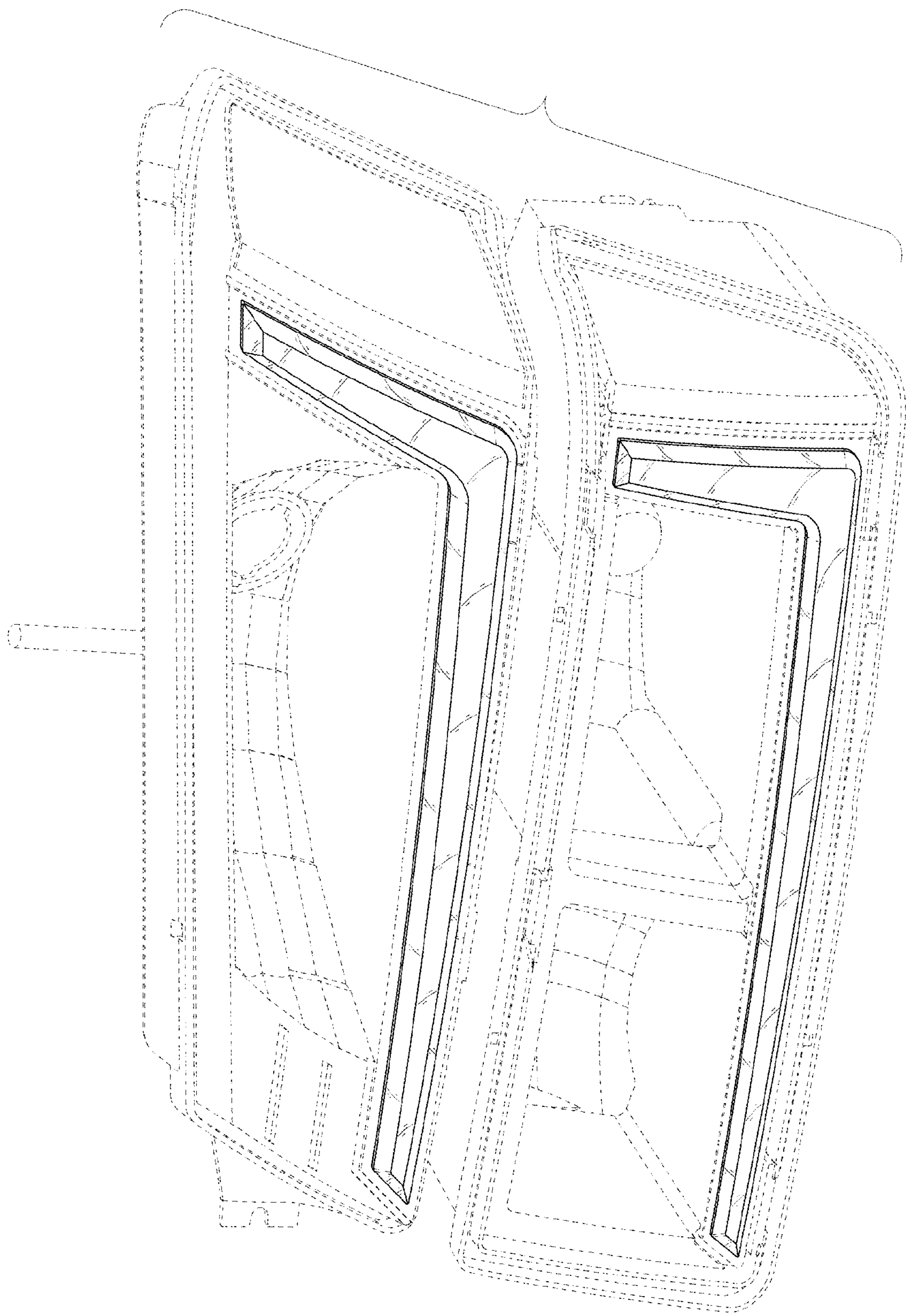

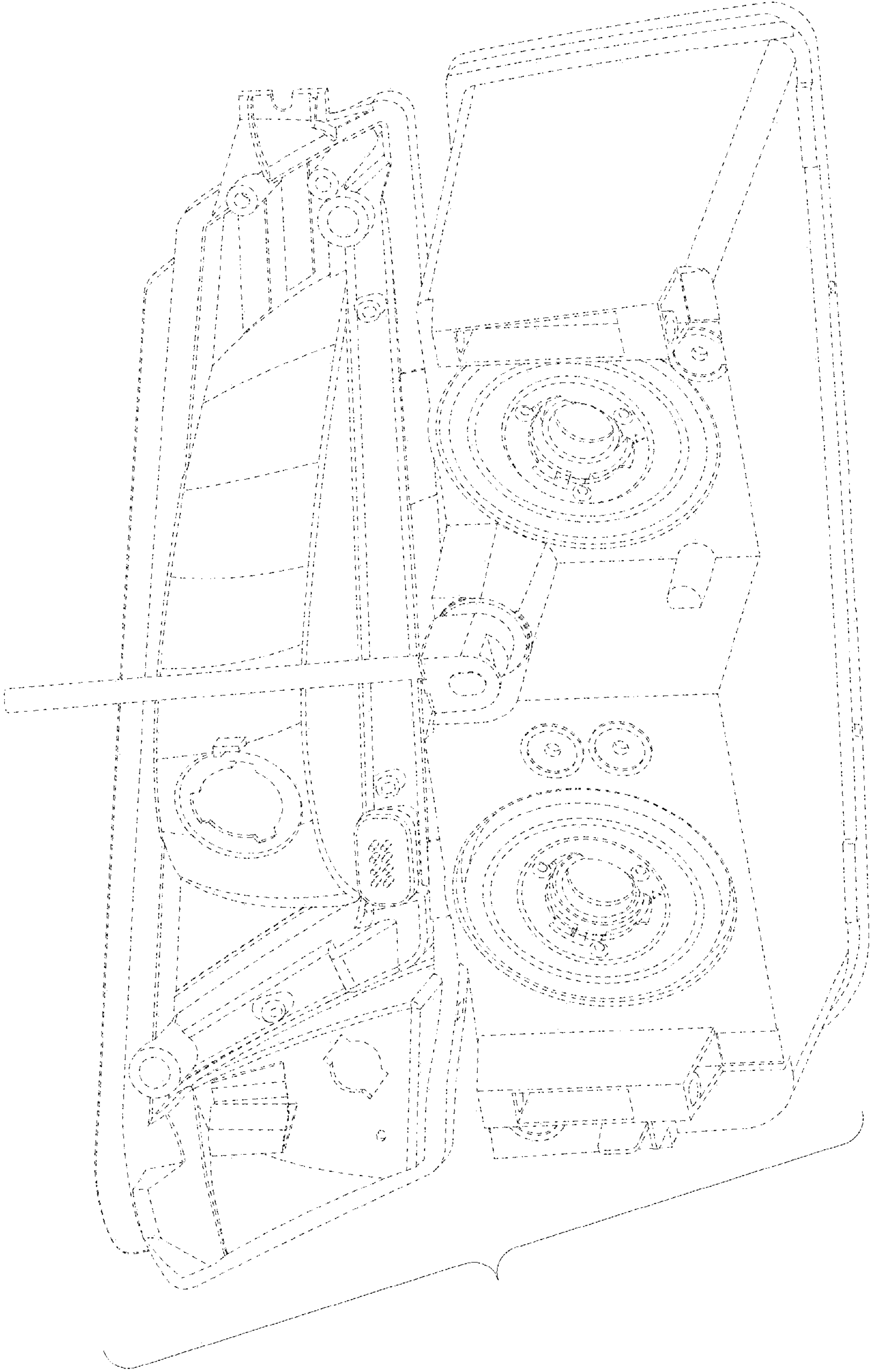

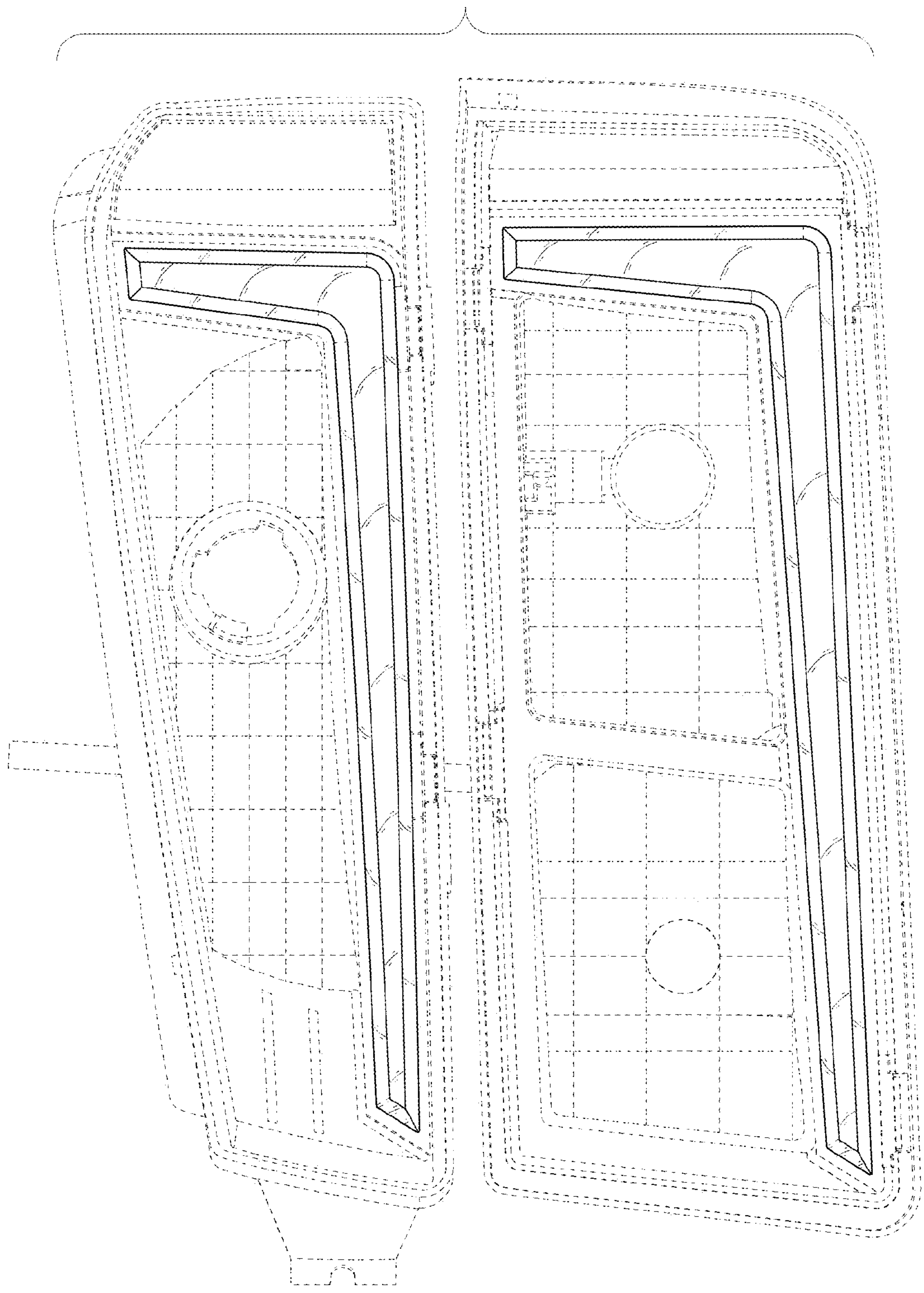

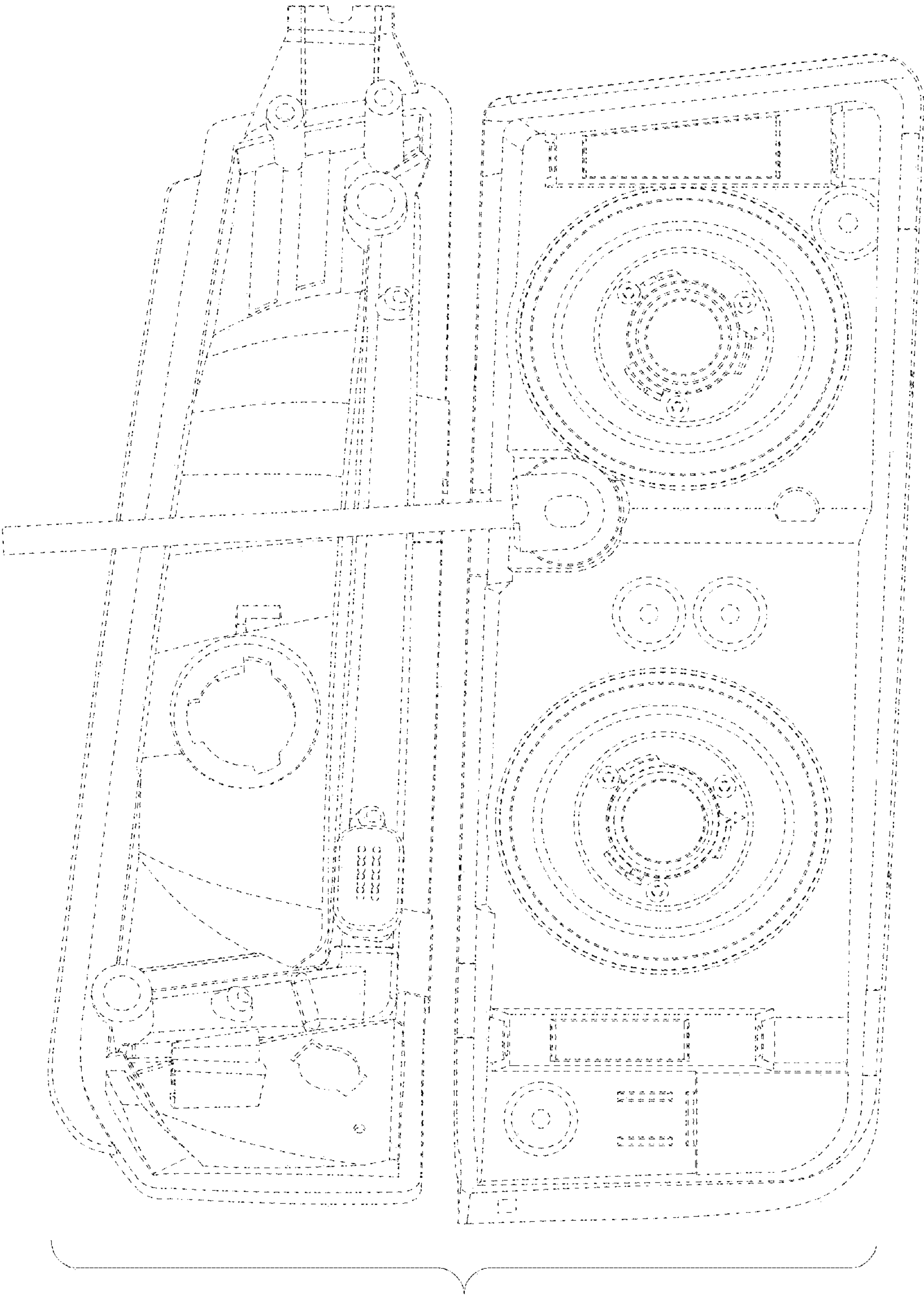

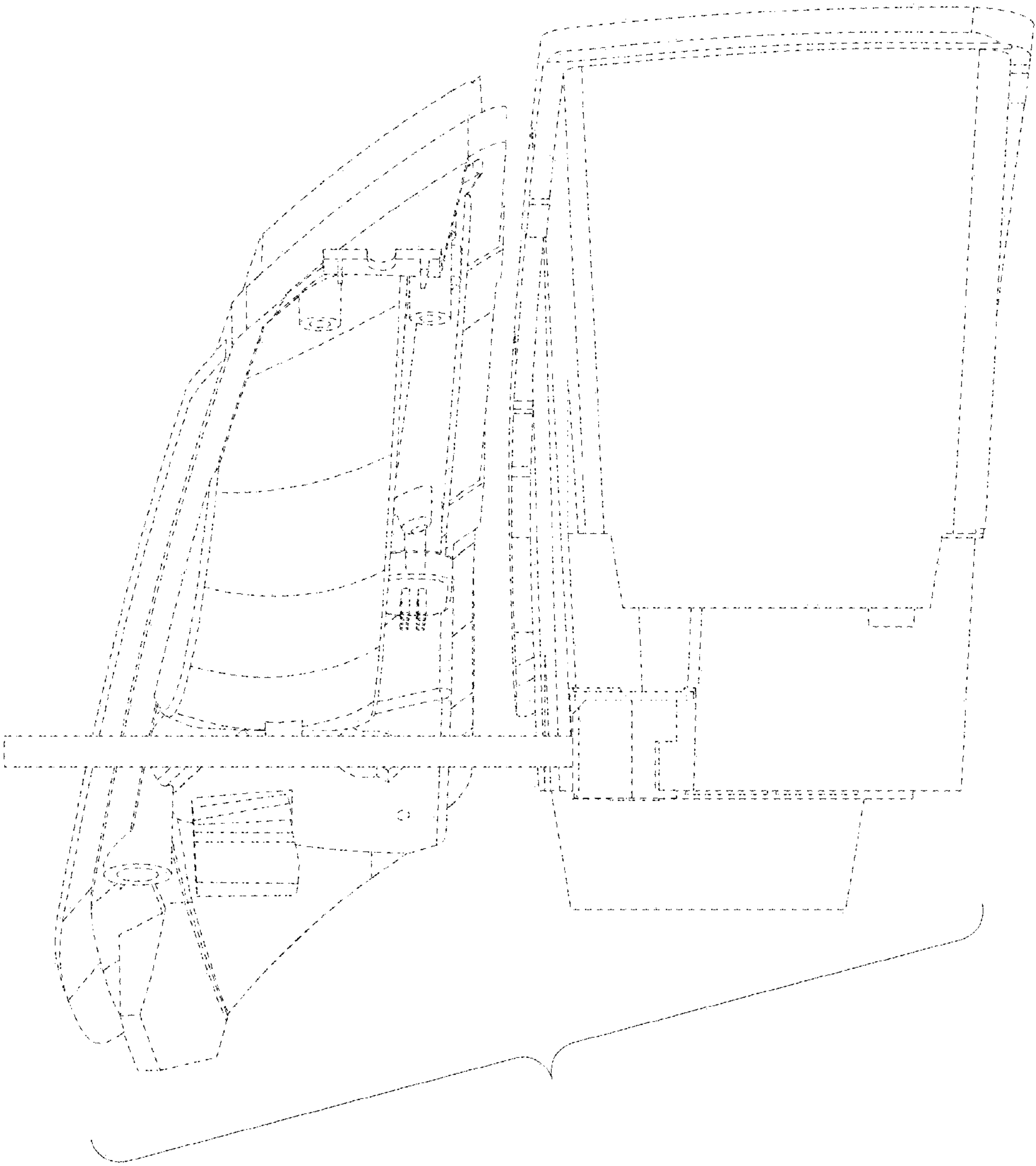

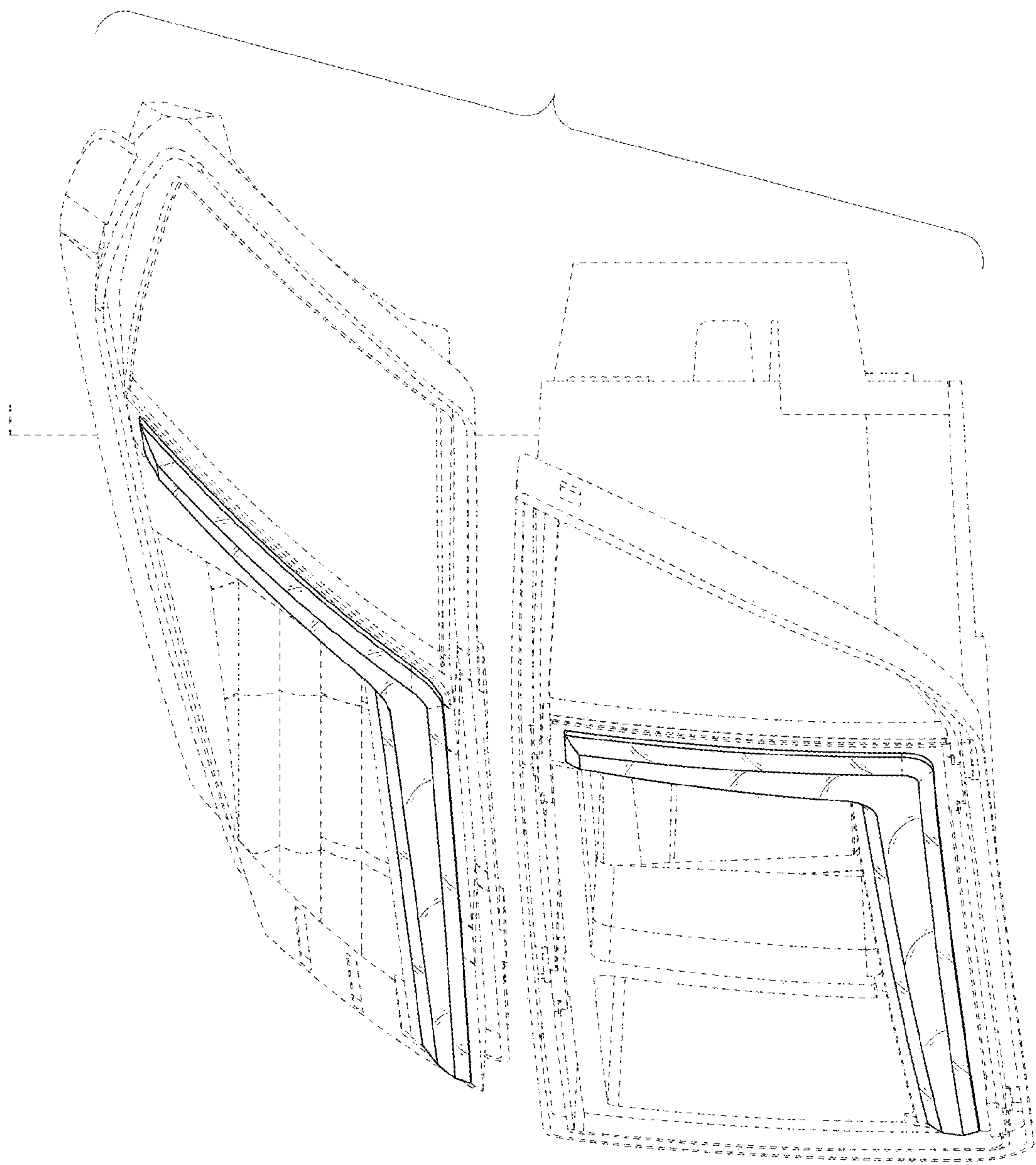

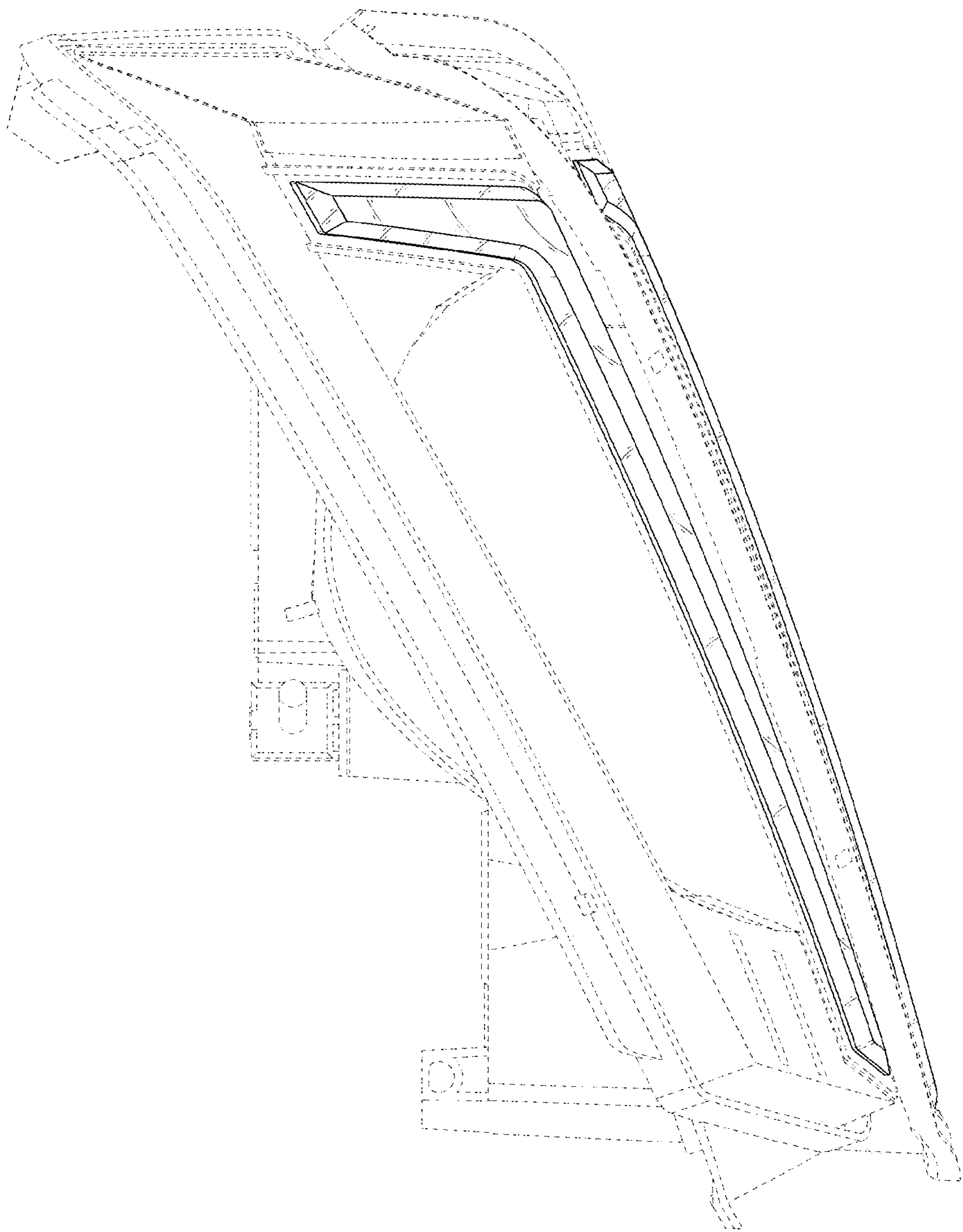

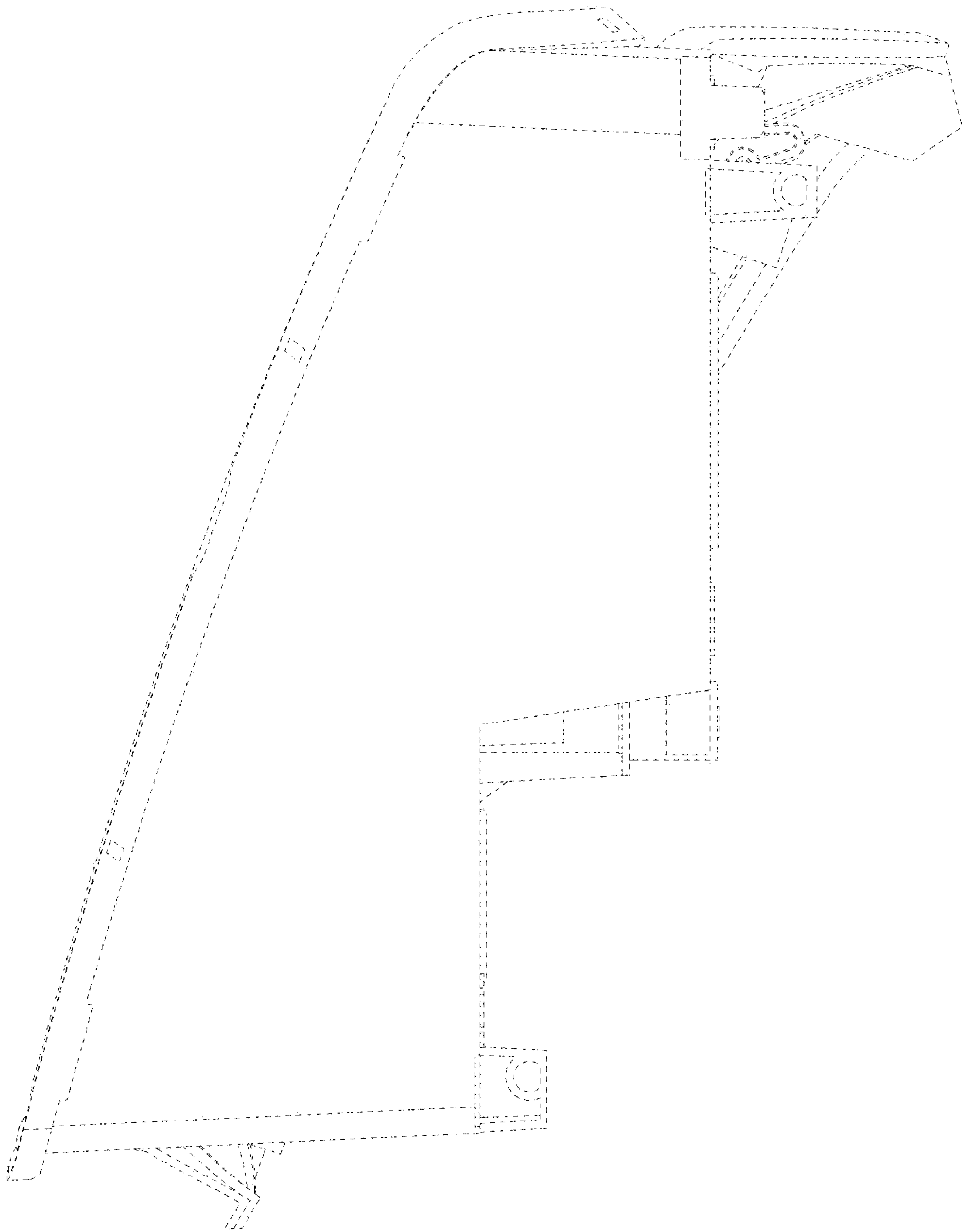

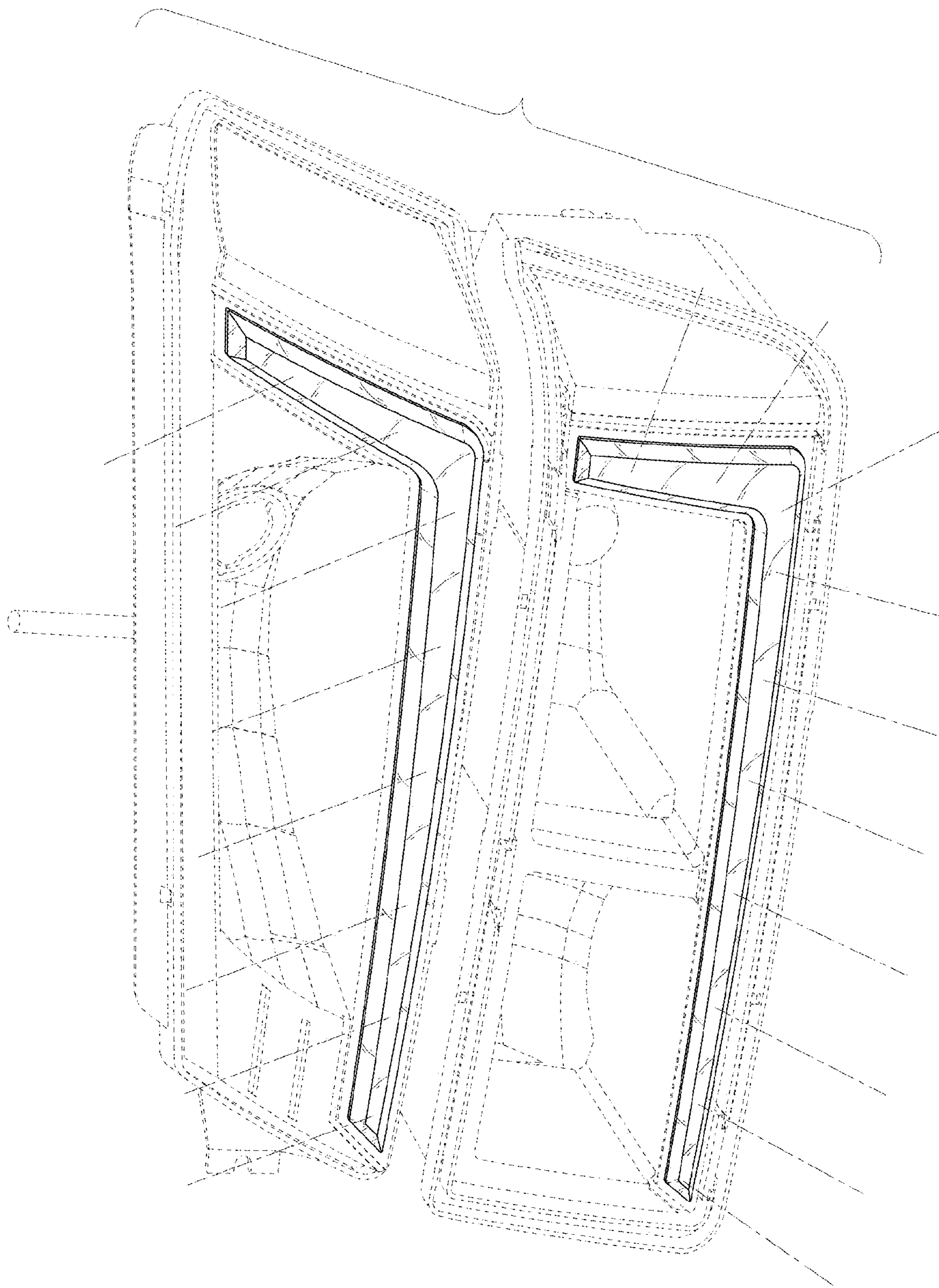
