FIG. 11 is another perspective view thereof with the helmet attachment extended.

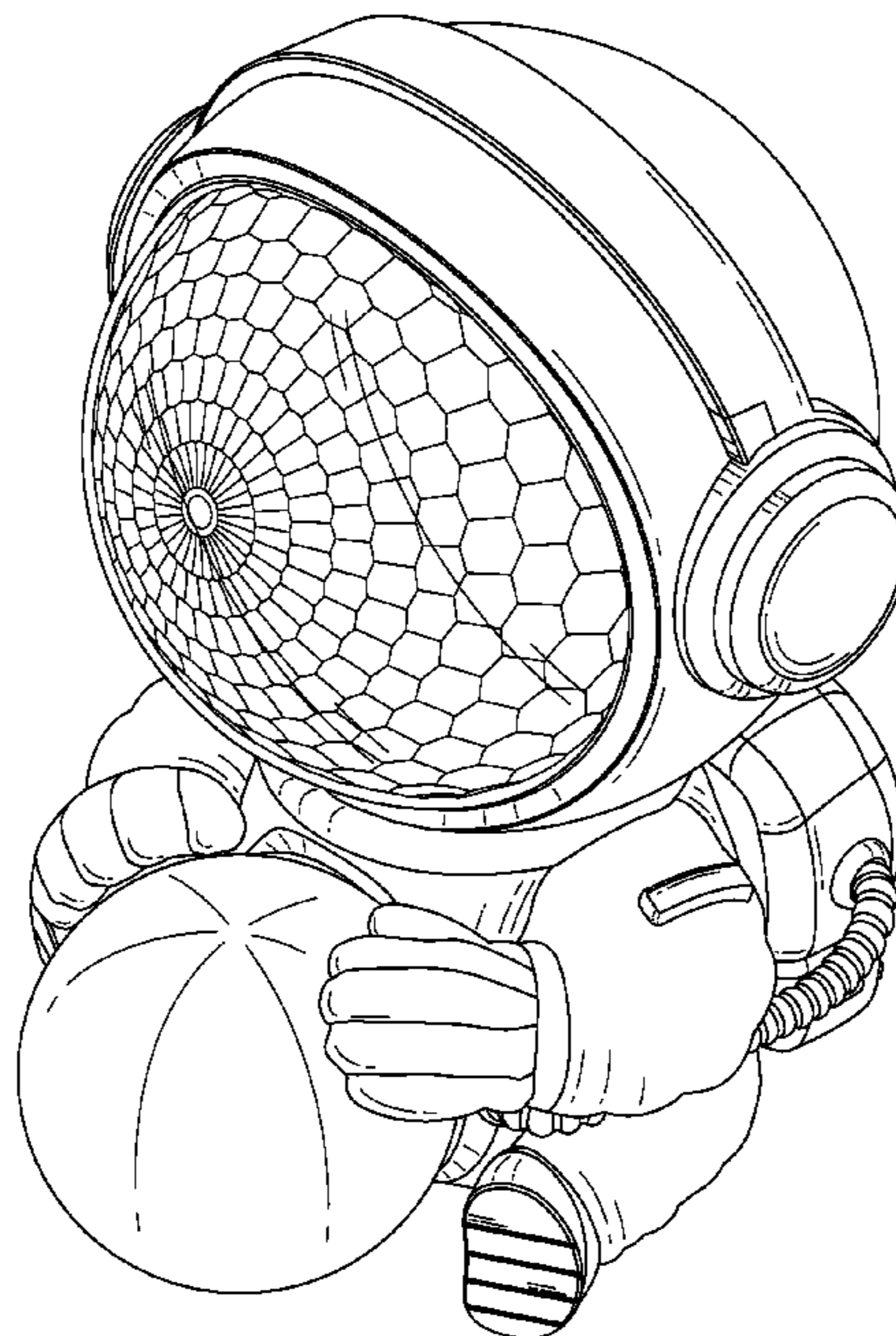

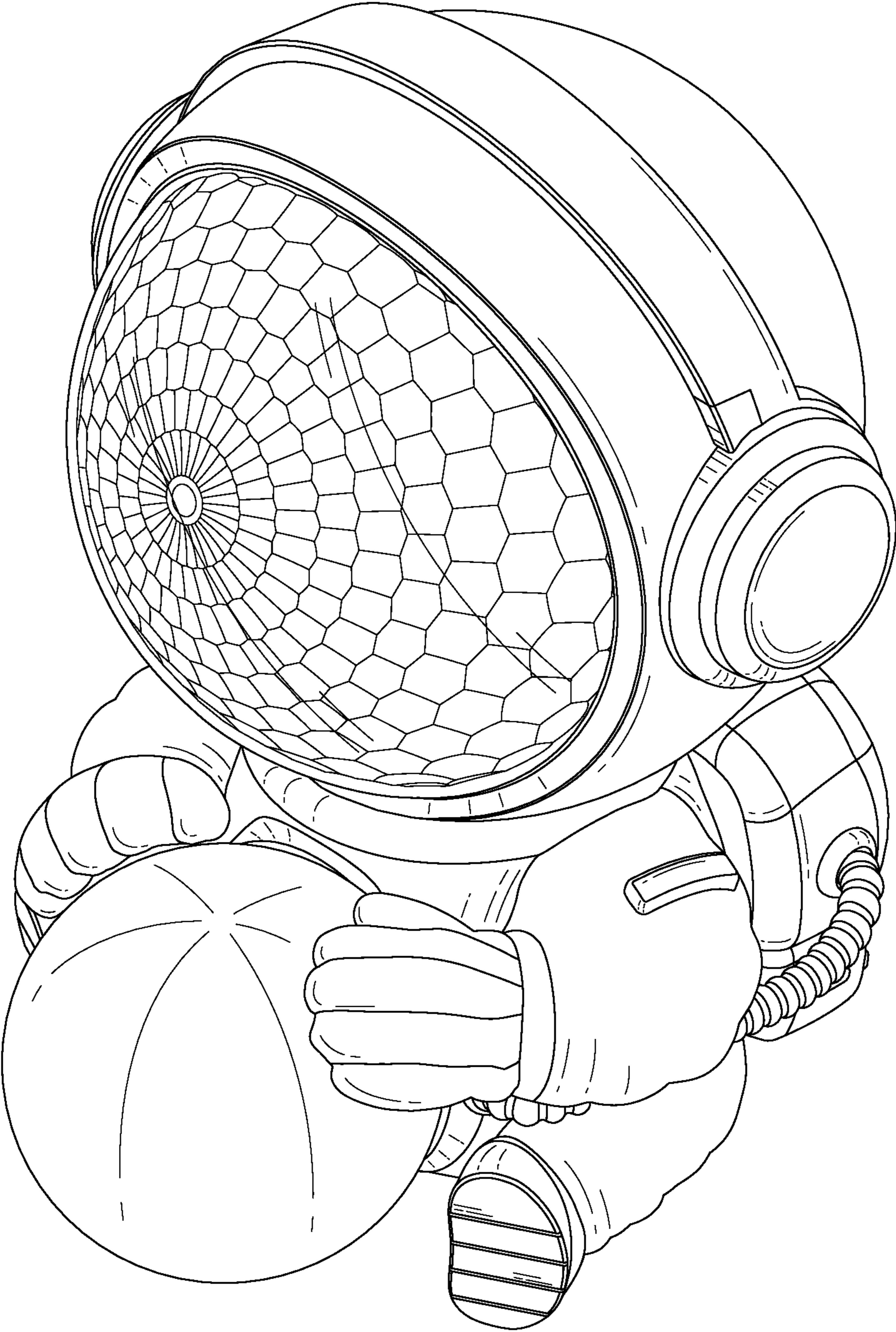

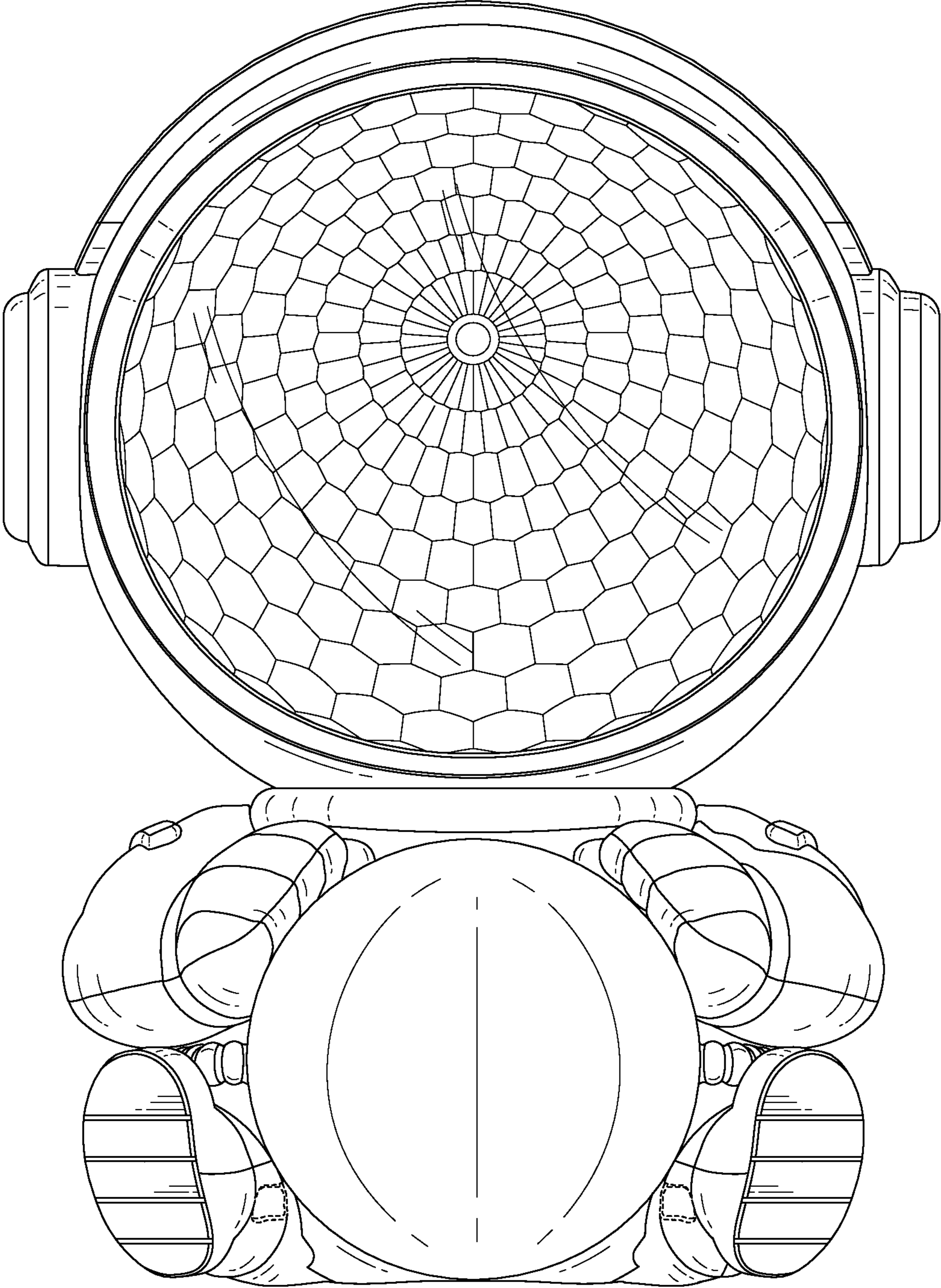

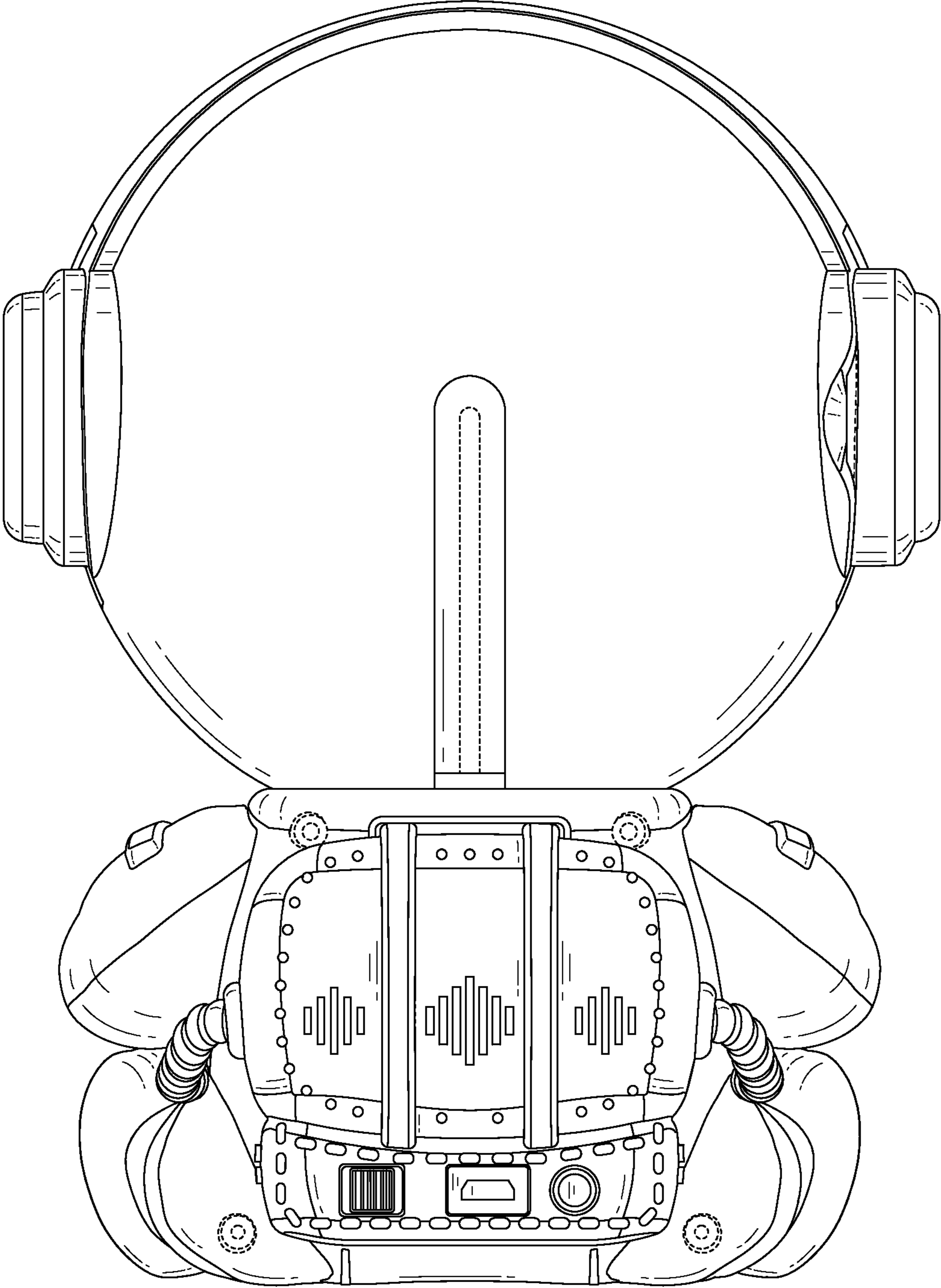

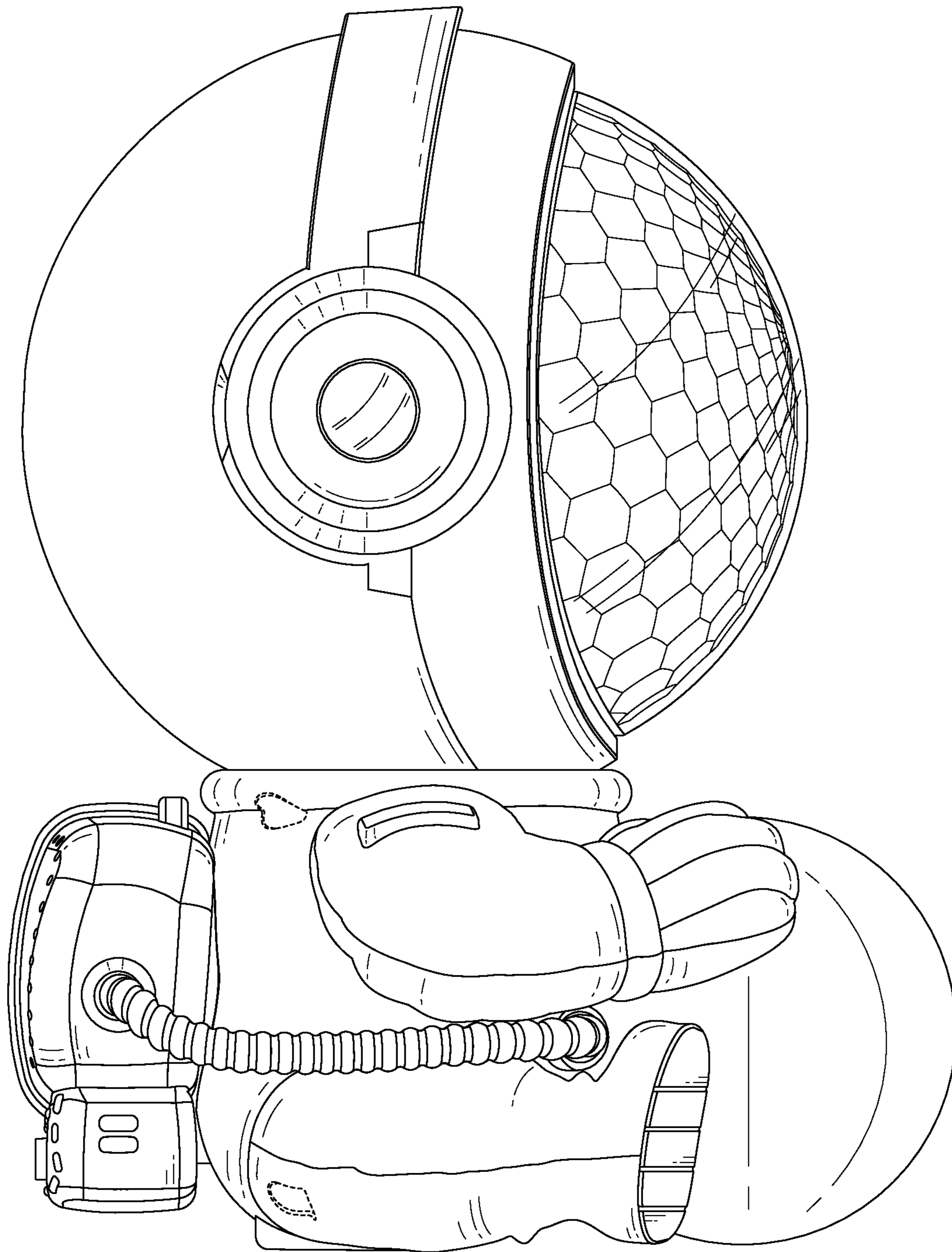

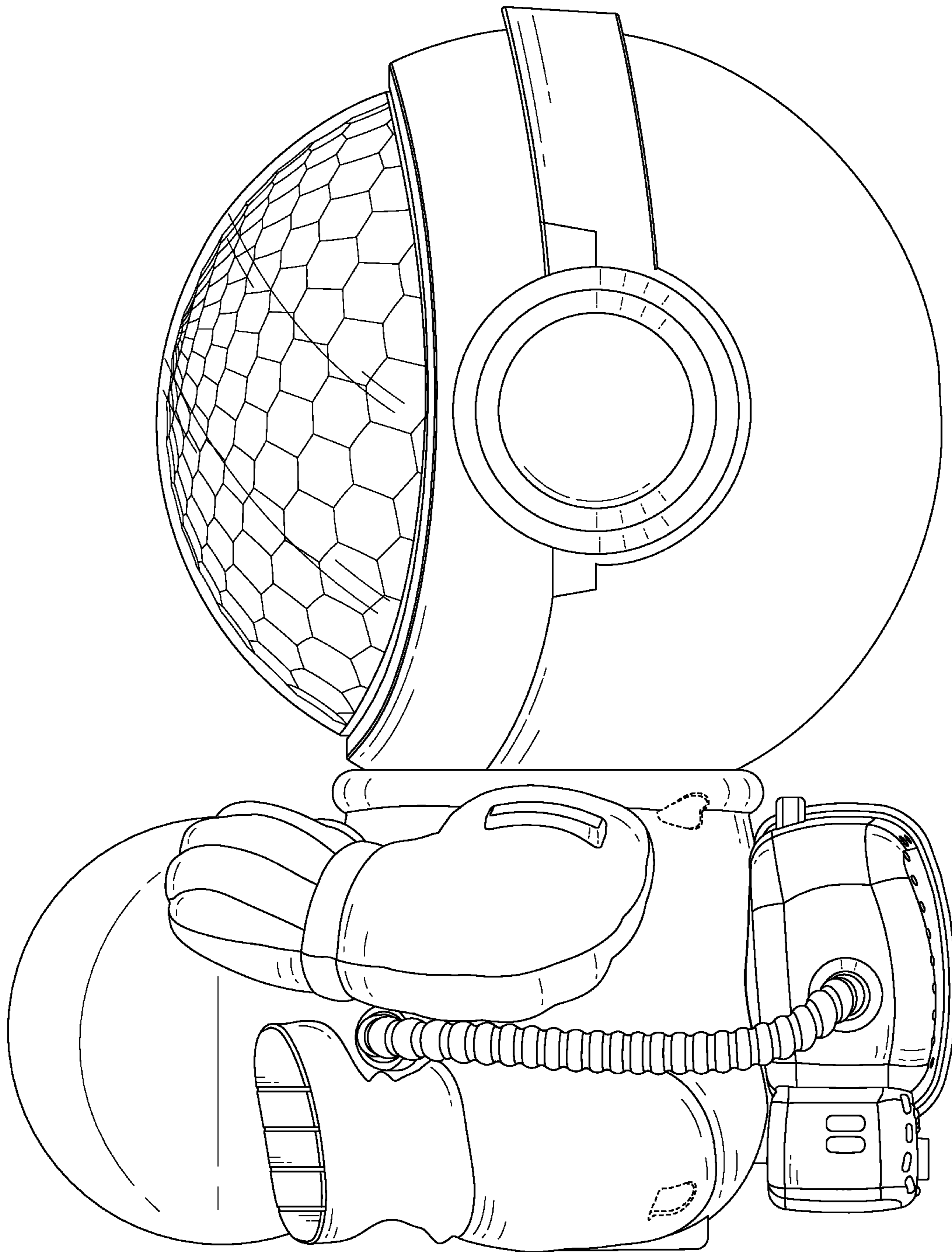

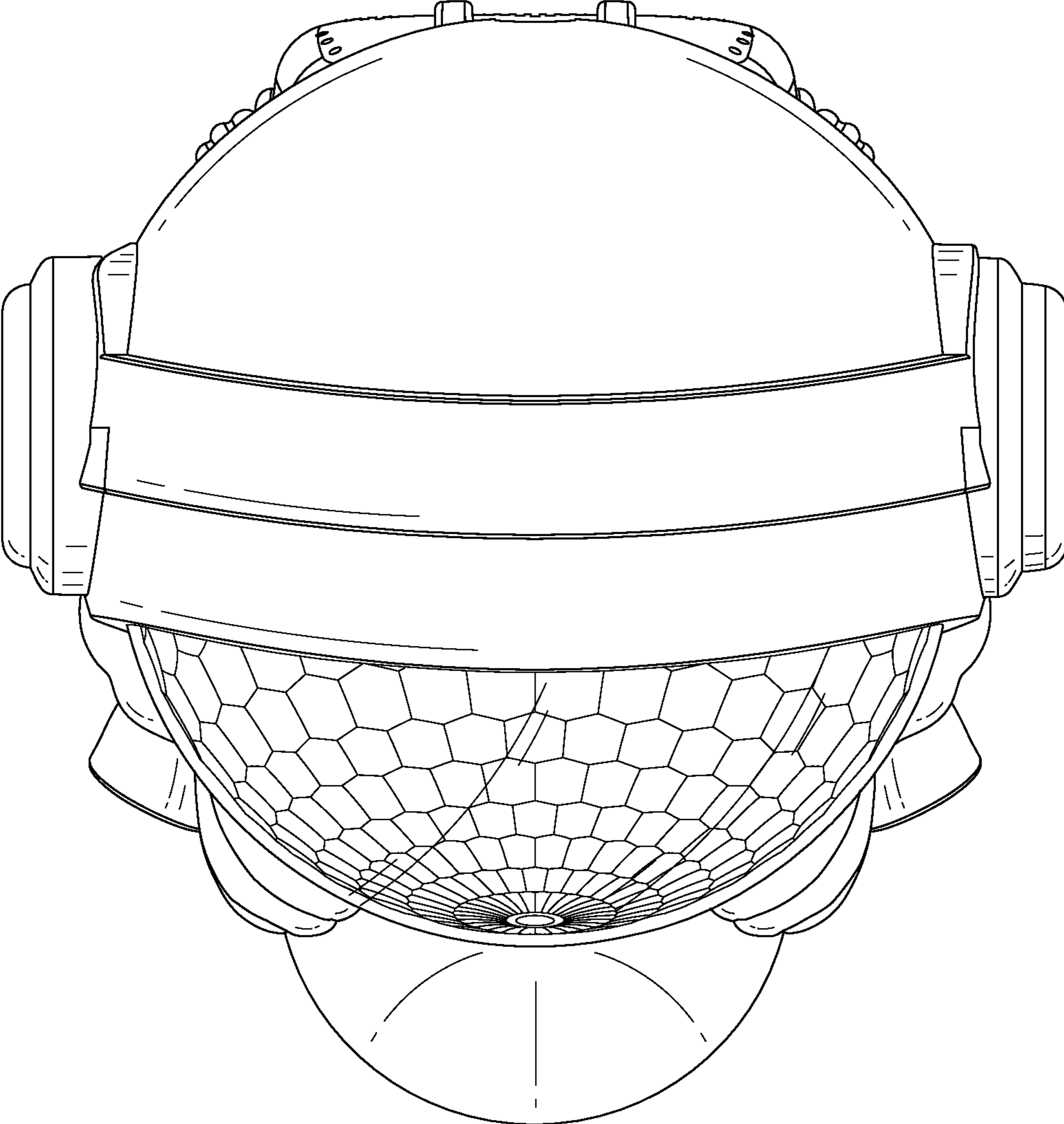

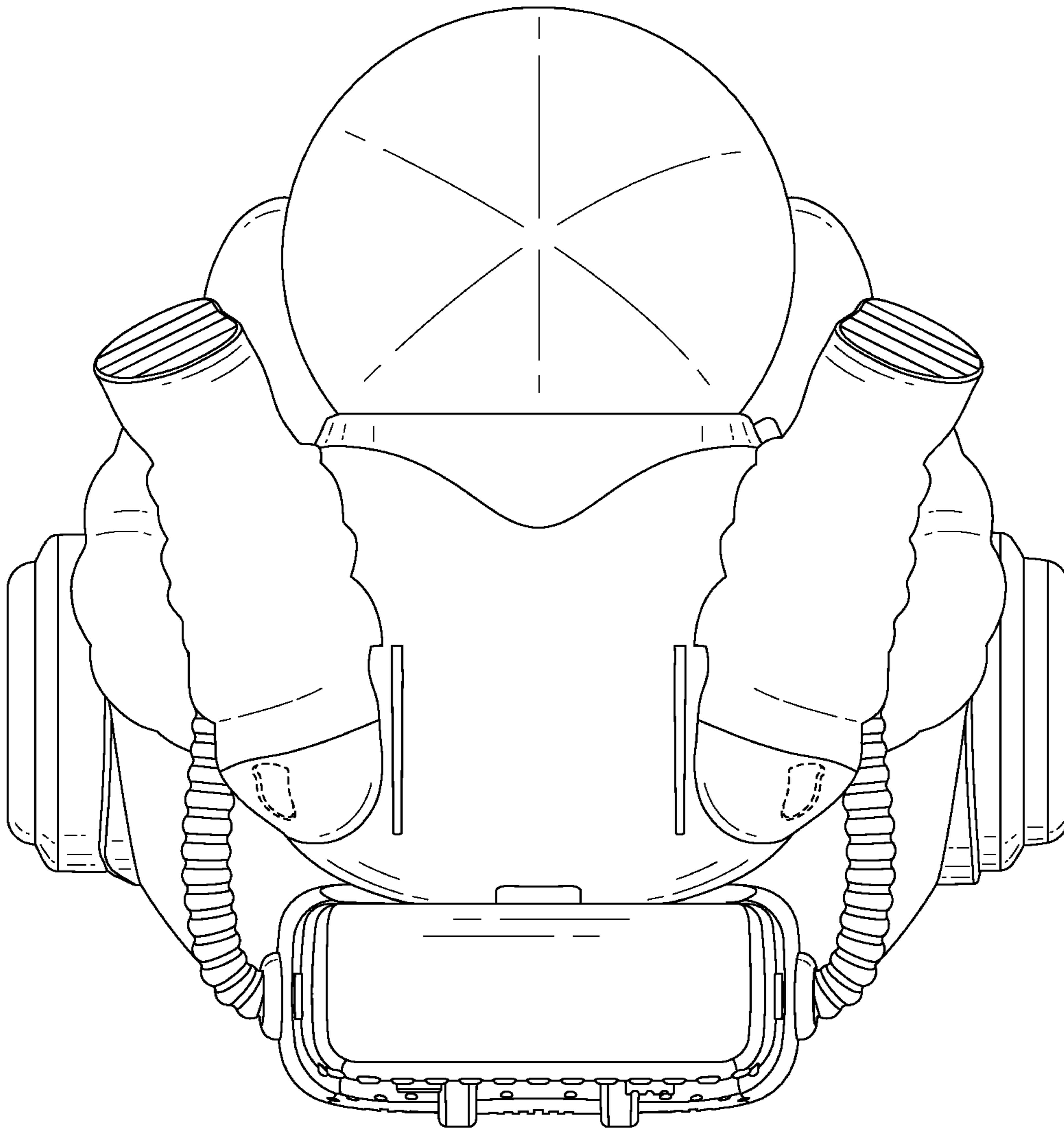

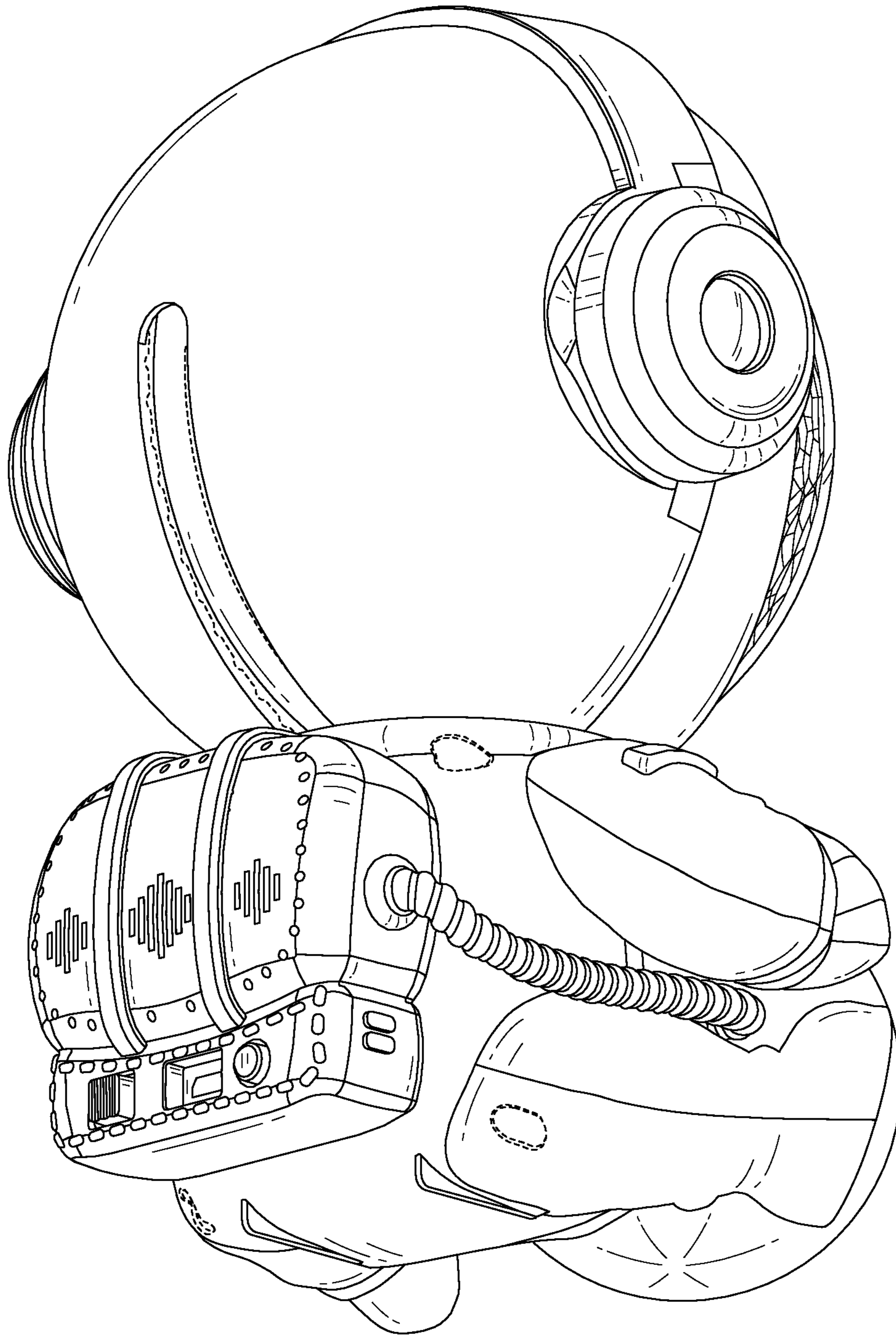

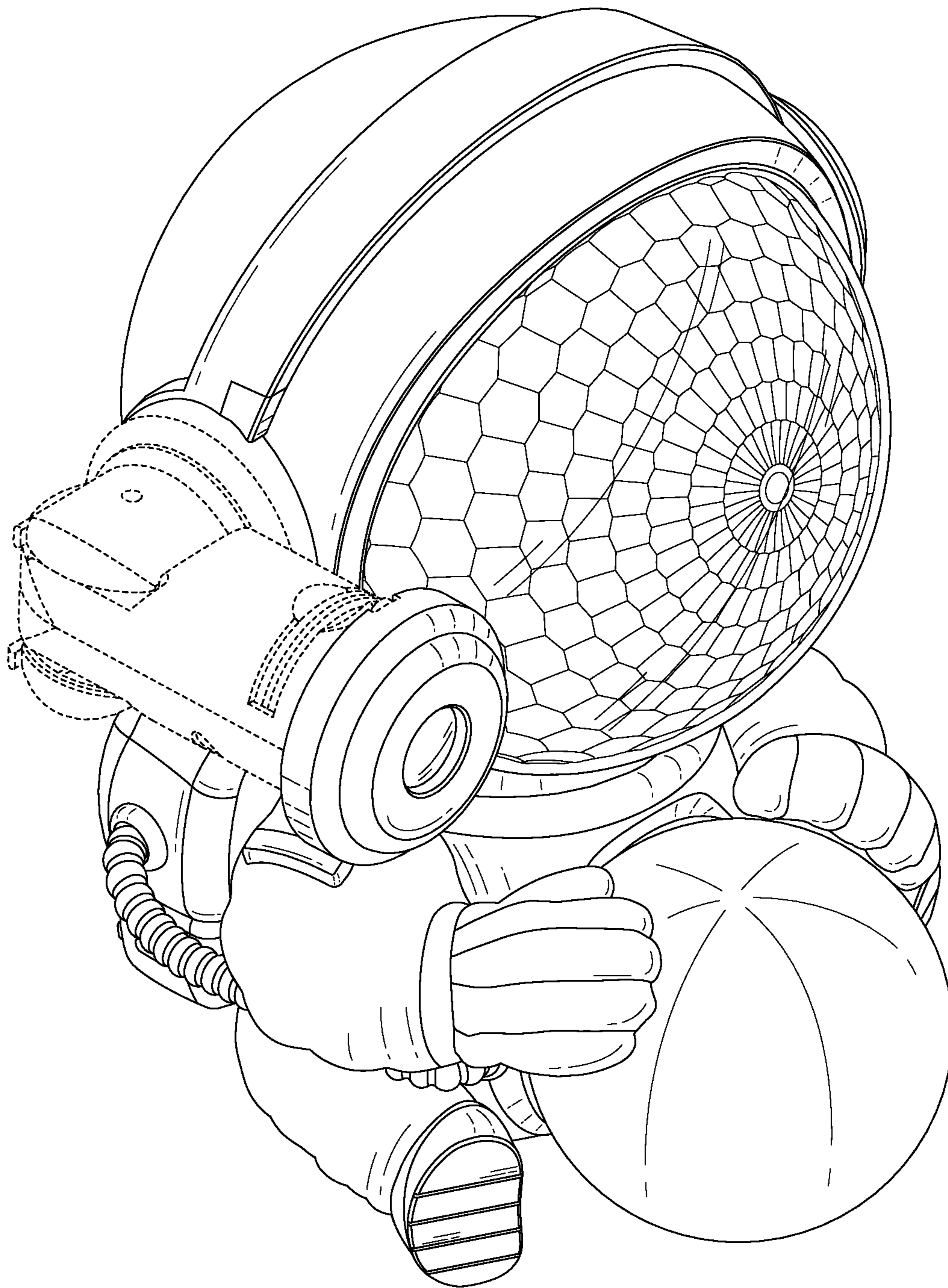

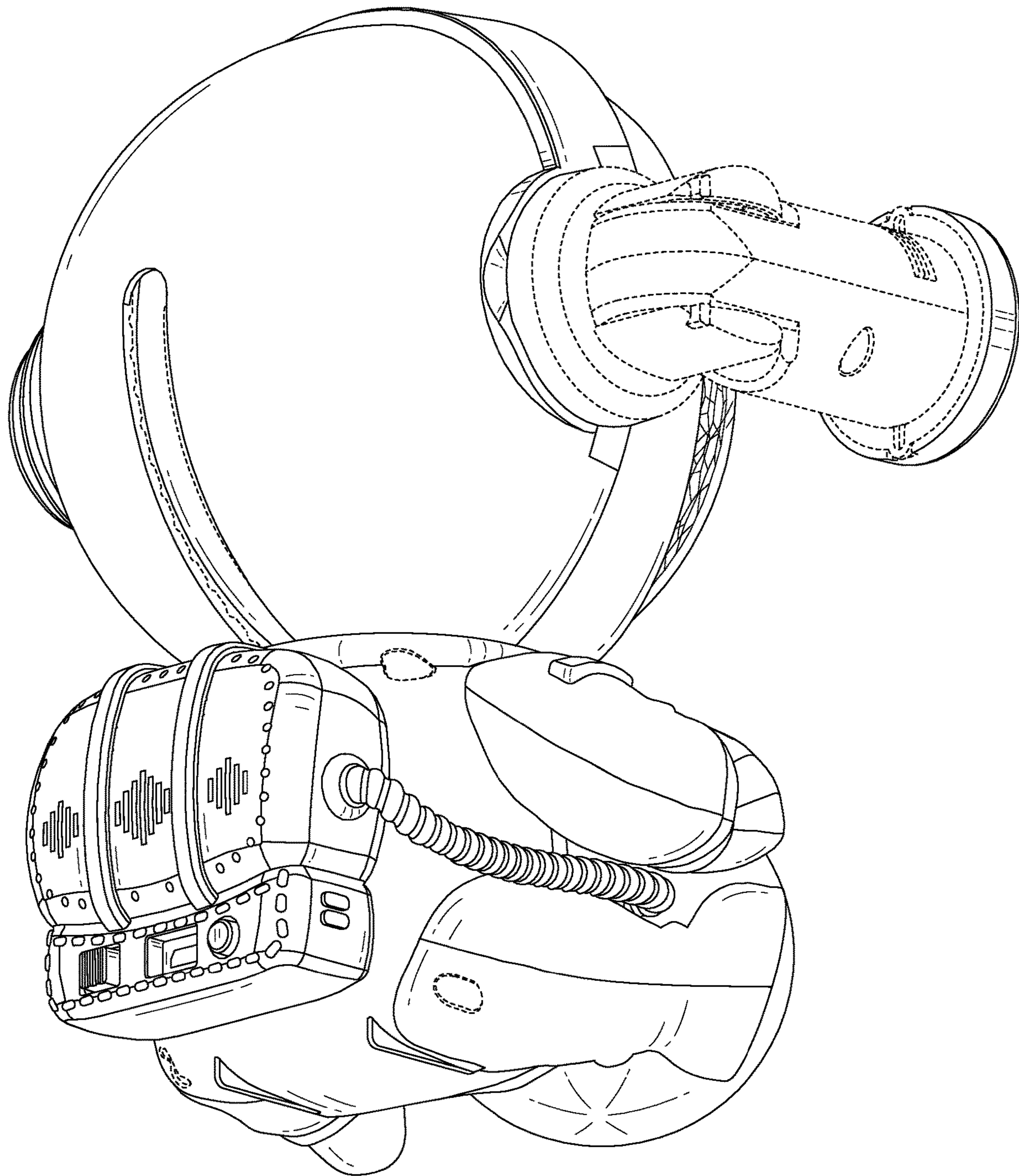

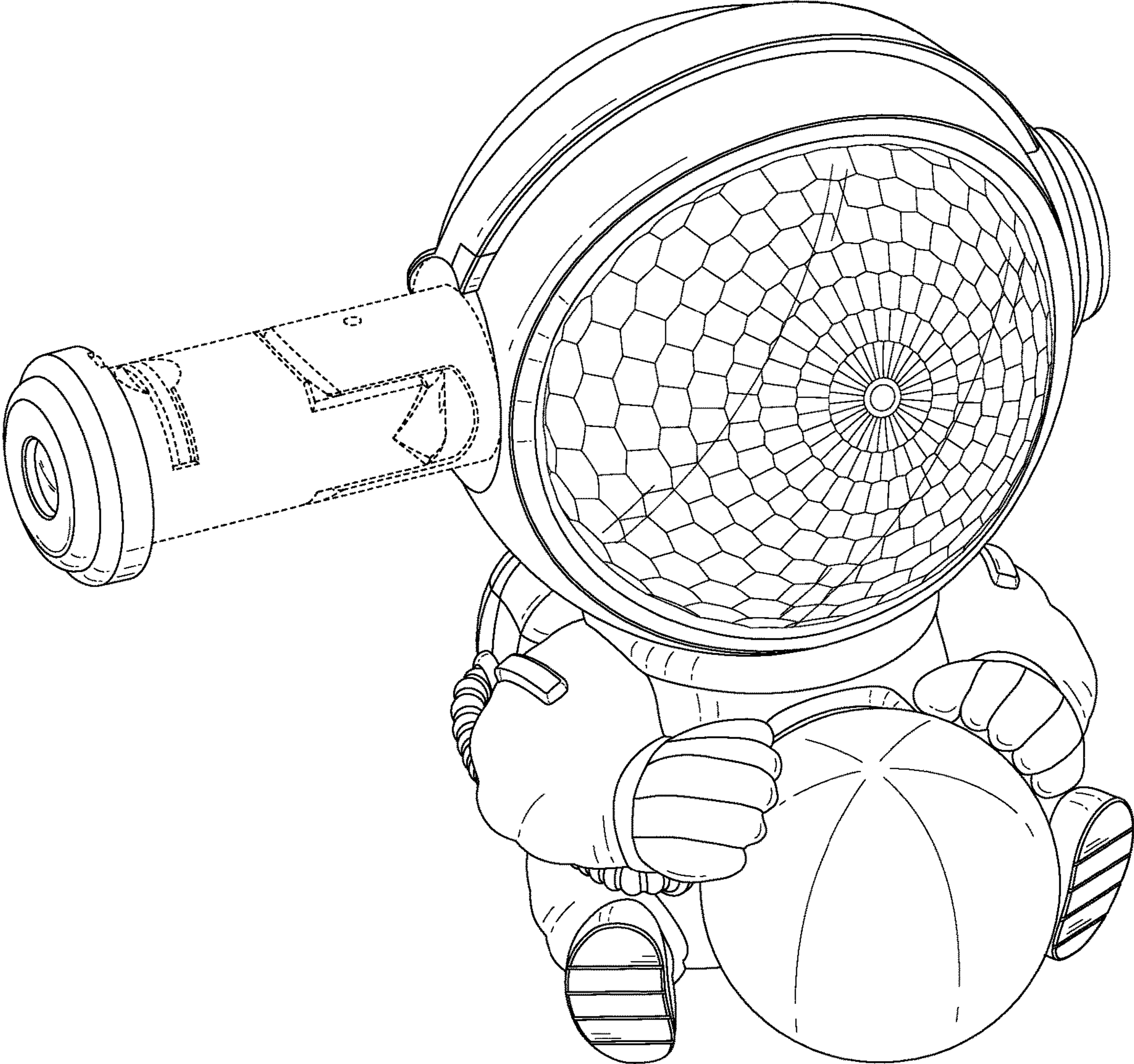
