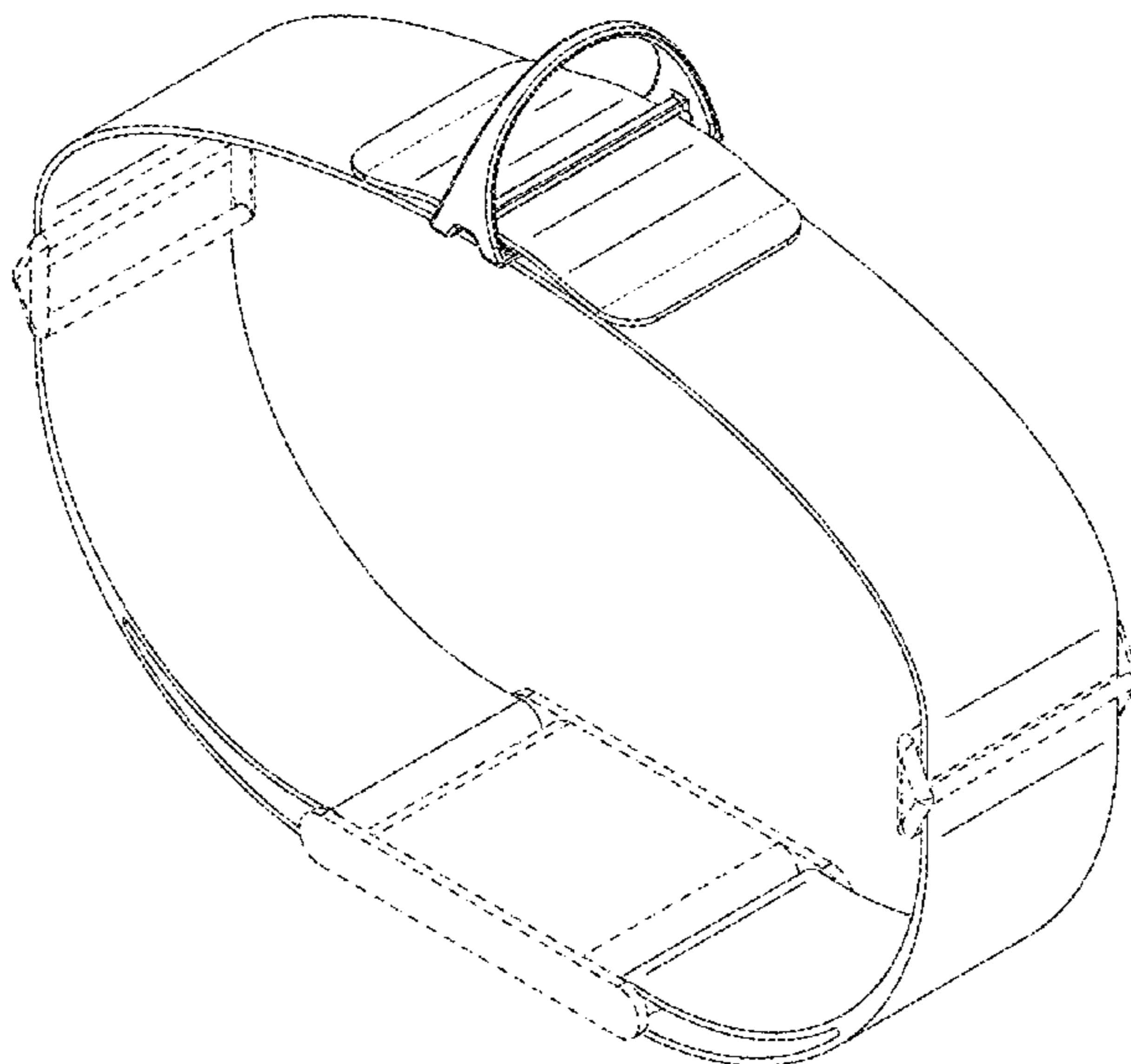
(57) **CLAIM**

I claim the ornamental design for a dog collar with fixed D-ring, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a dog collar with fixed D-ring showing my new design;  
FIG. 2 is a rear isometric view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken lines showing collar adjusters and a fastener is for the purpose of illustrating portions of the article that form no part of the claimed design.

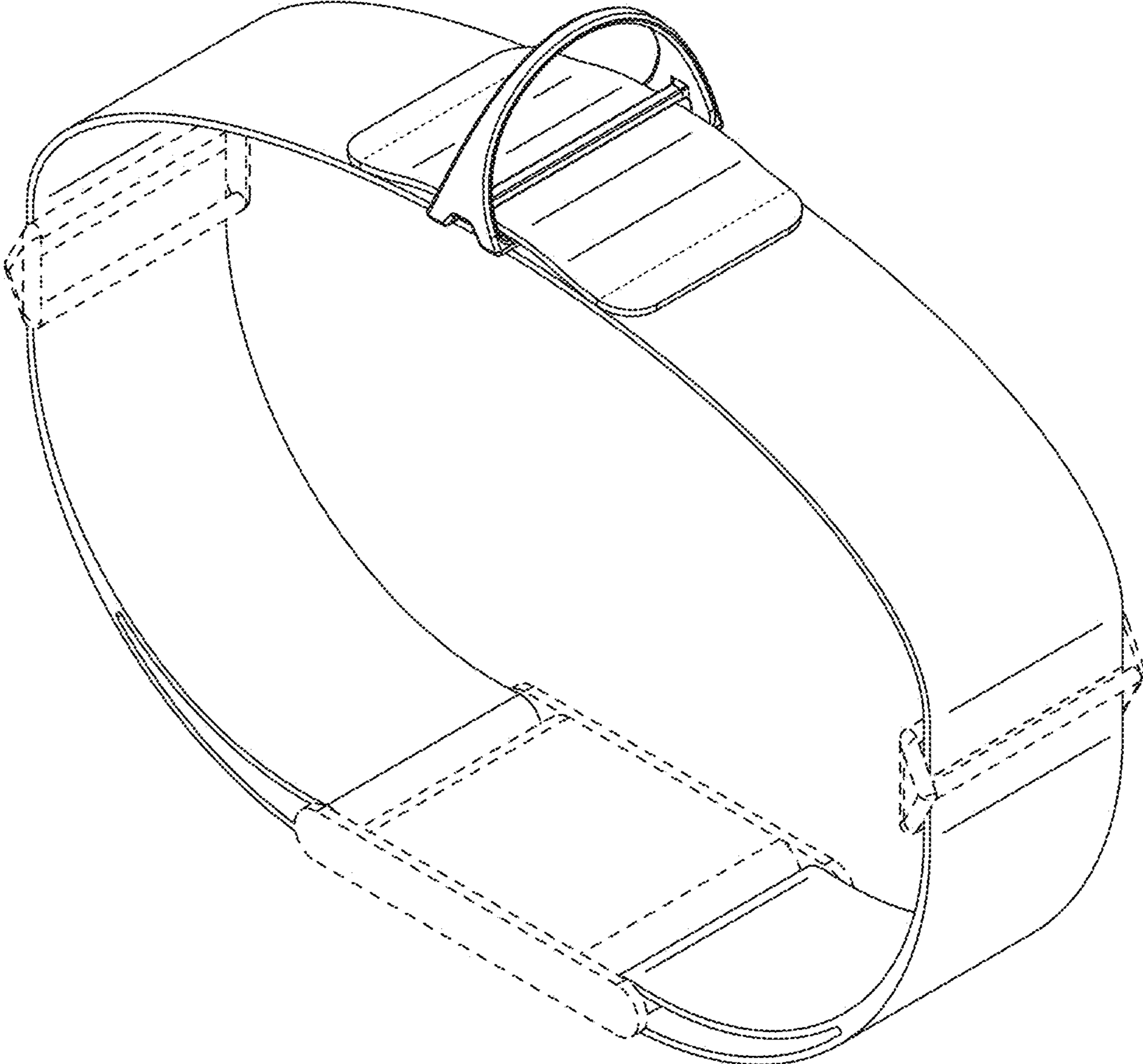

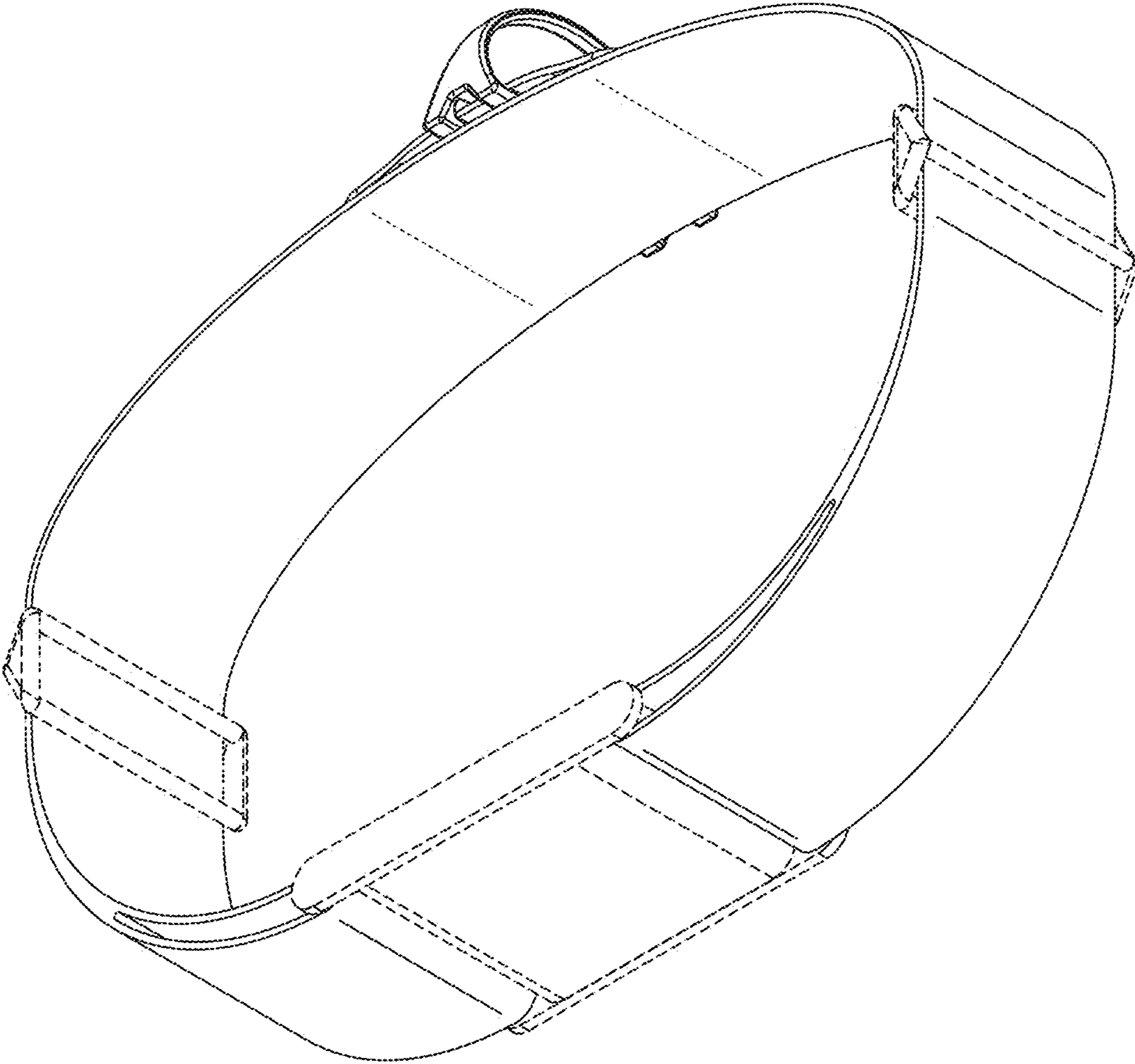

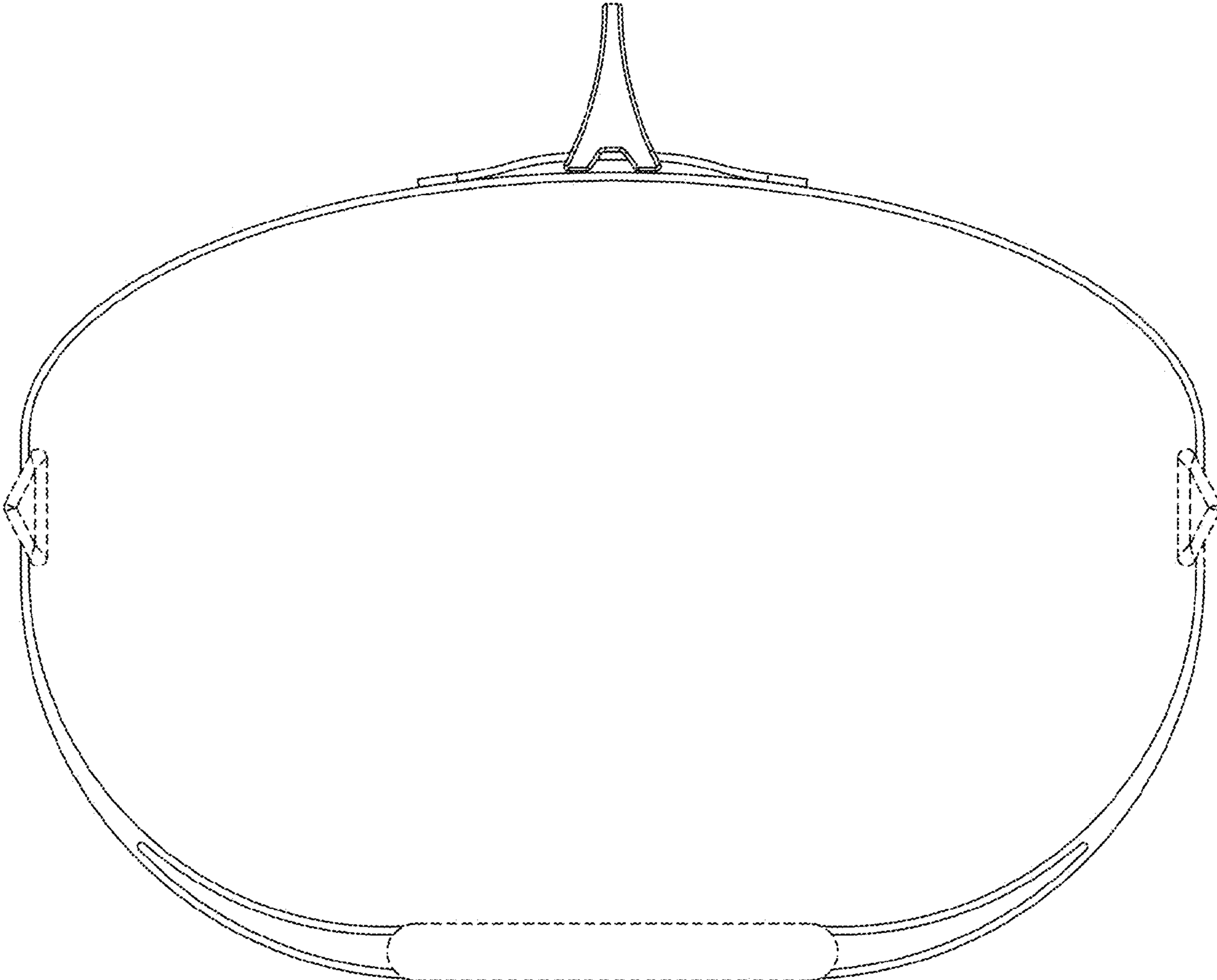

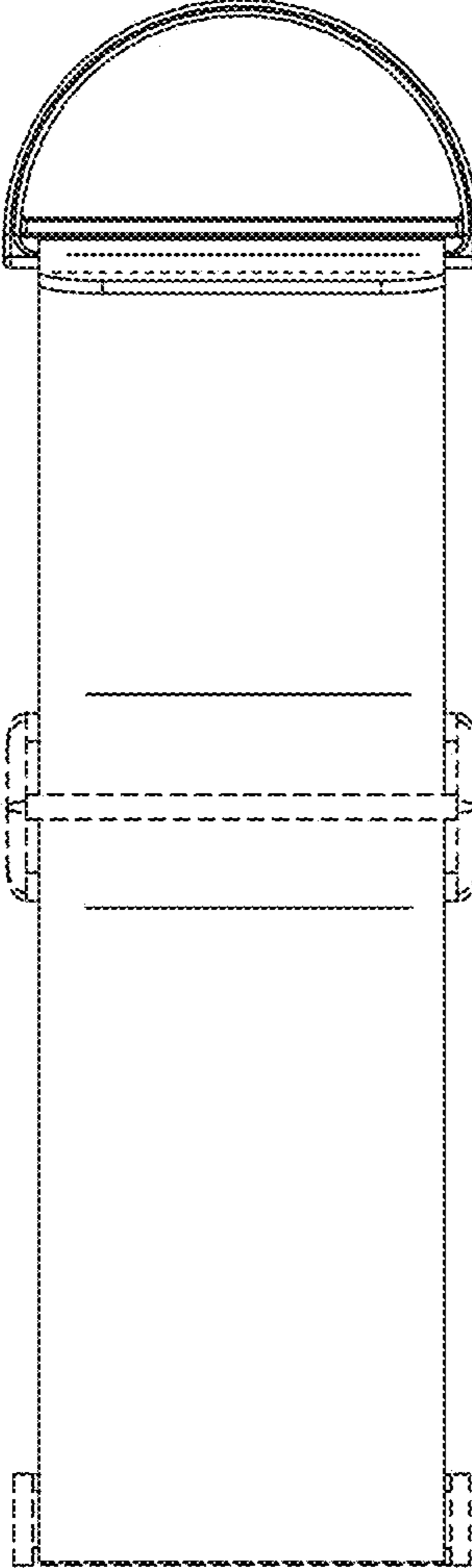

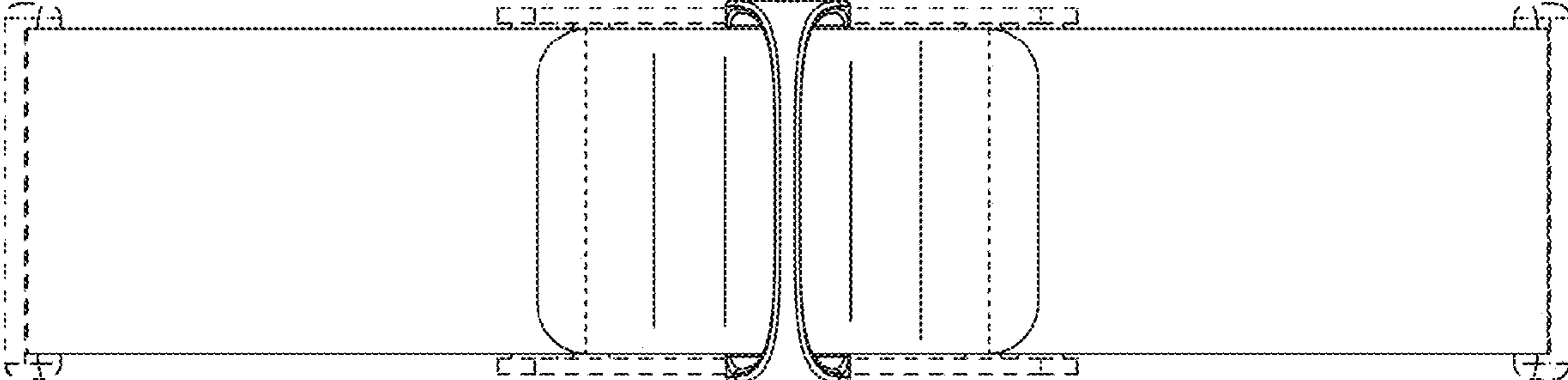

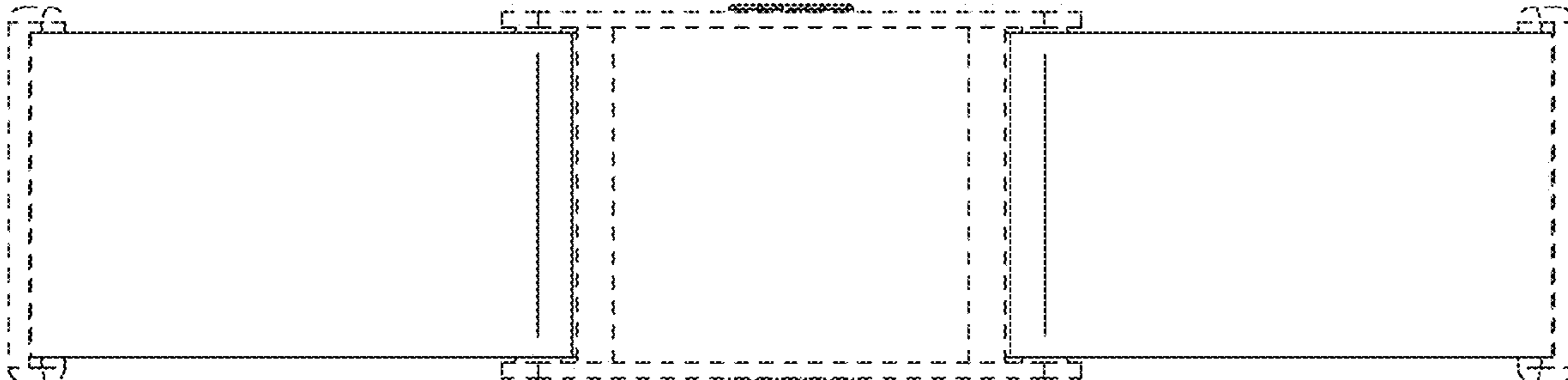
