DESCRIPTION

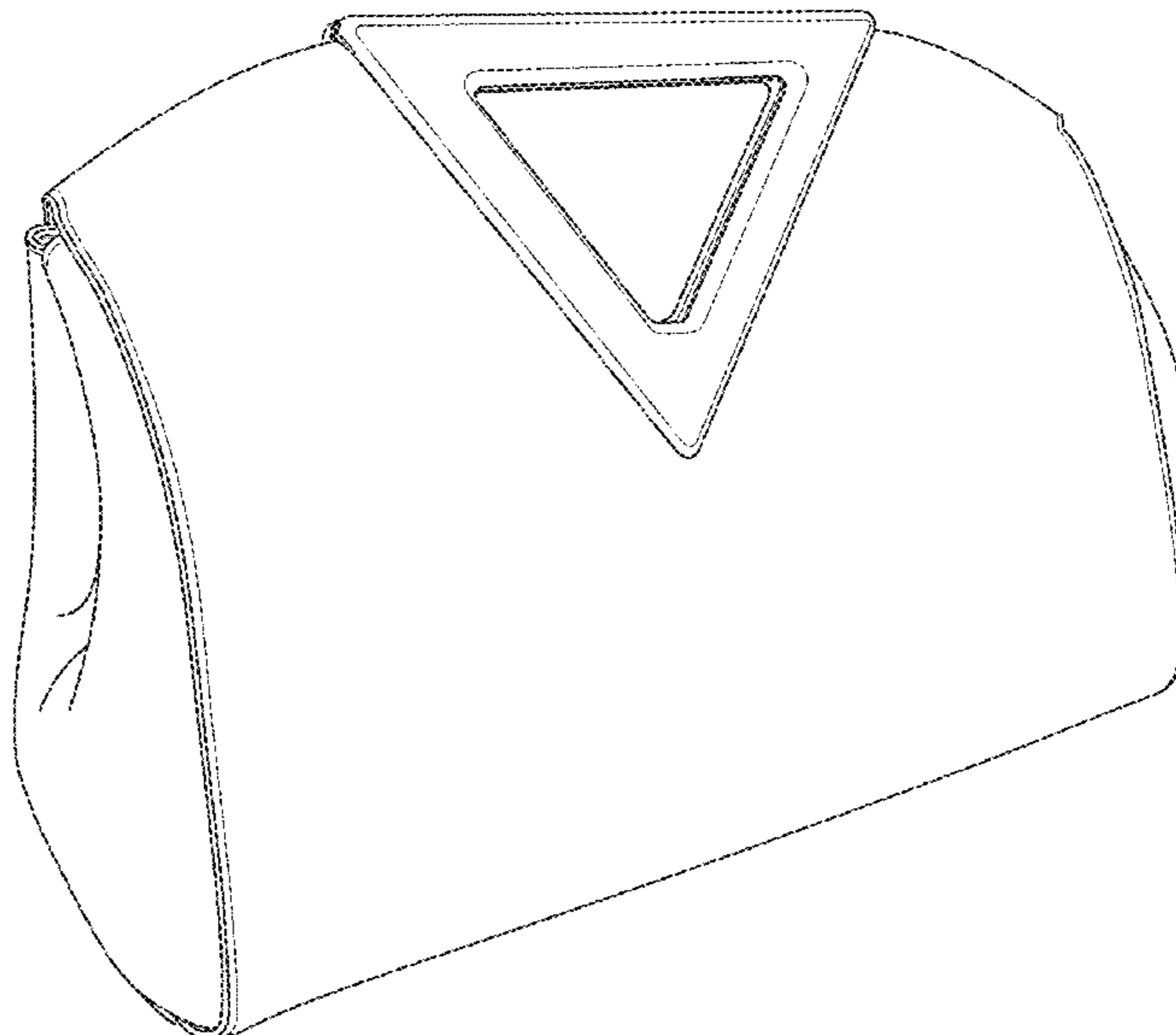
FIG. 1 is a perspective view of a handbag showing my new design;

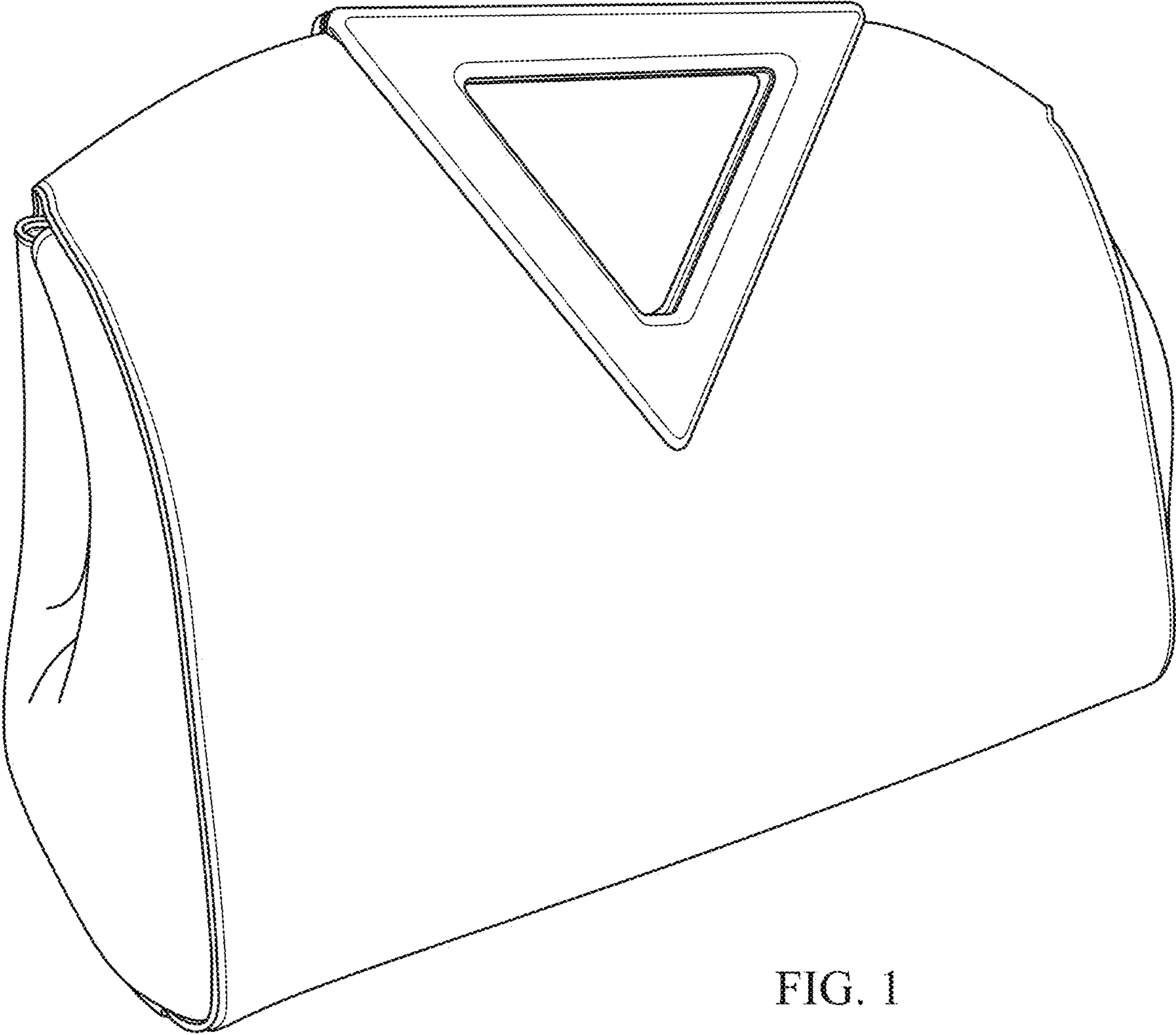

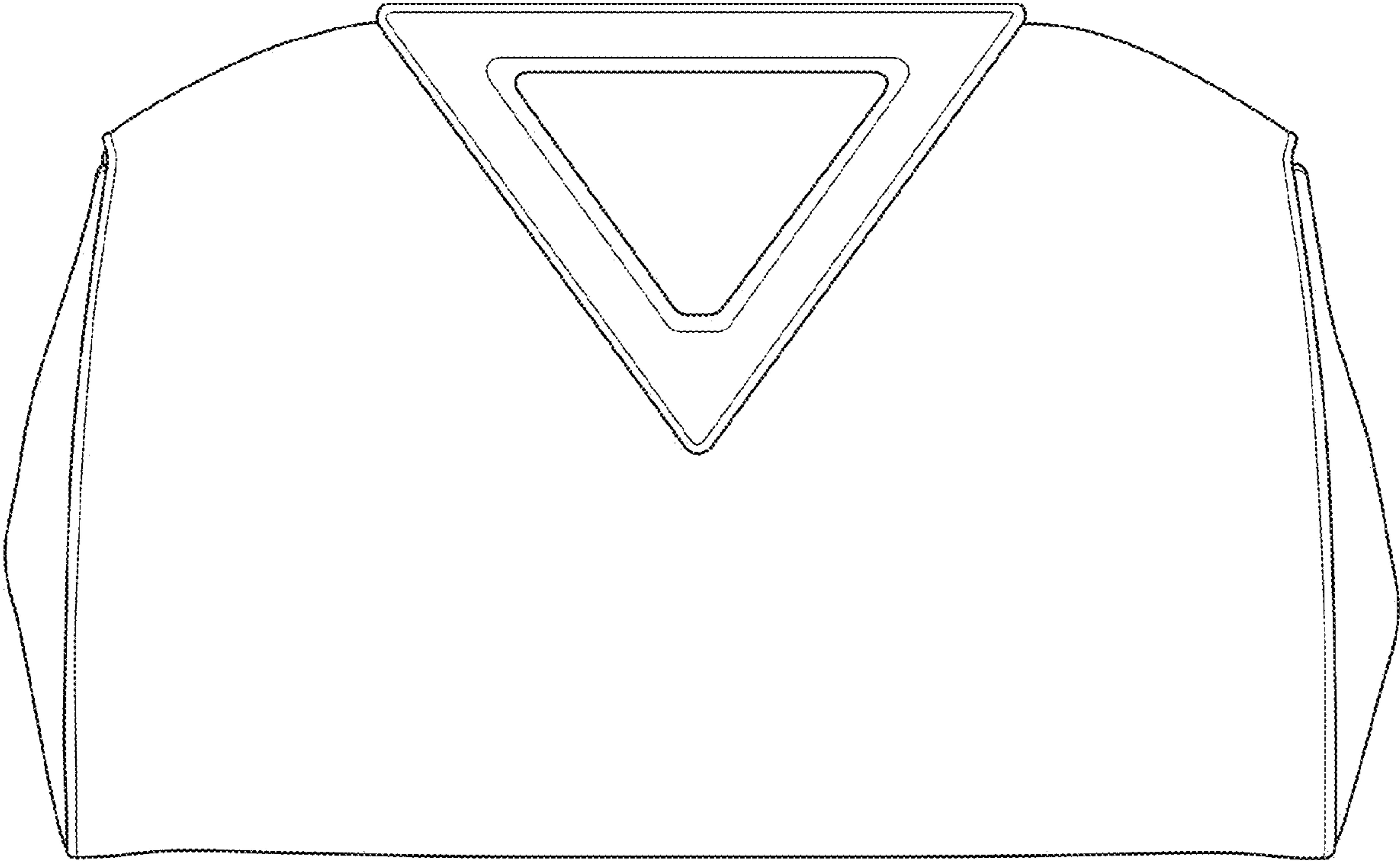

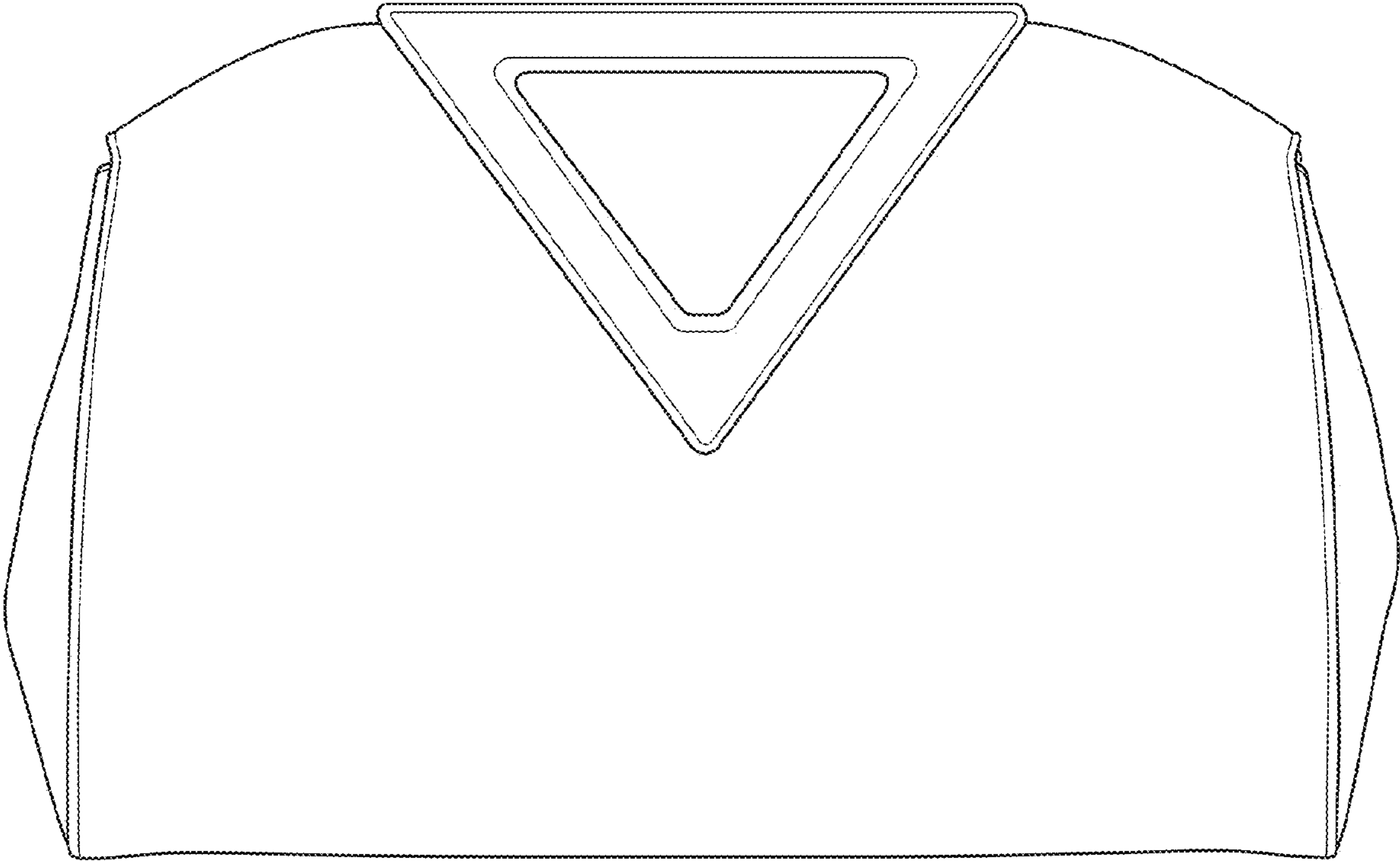

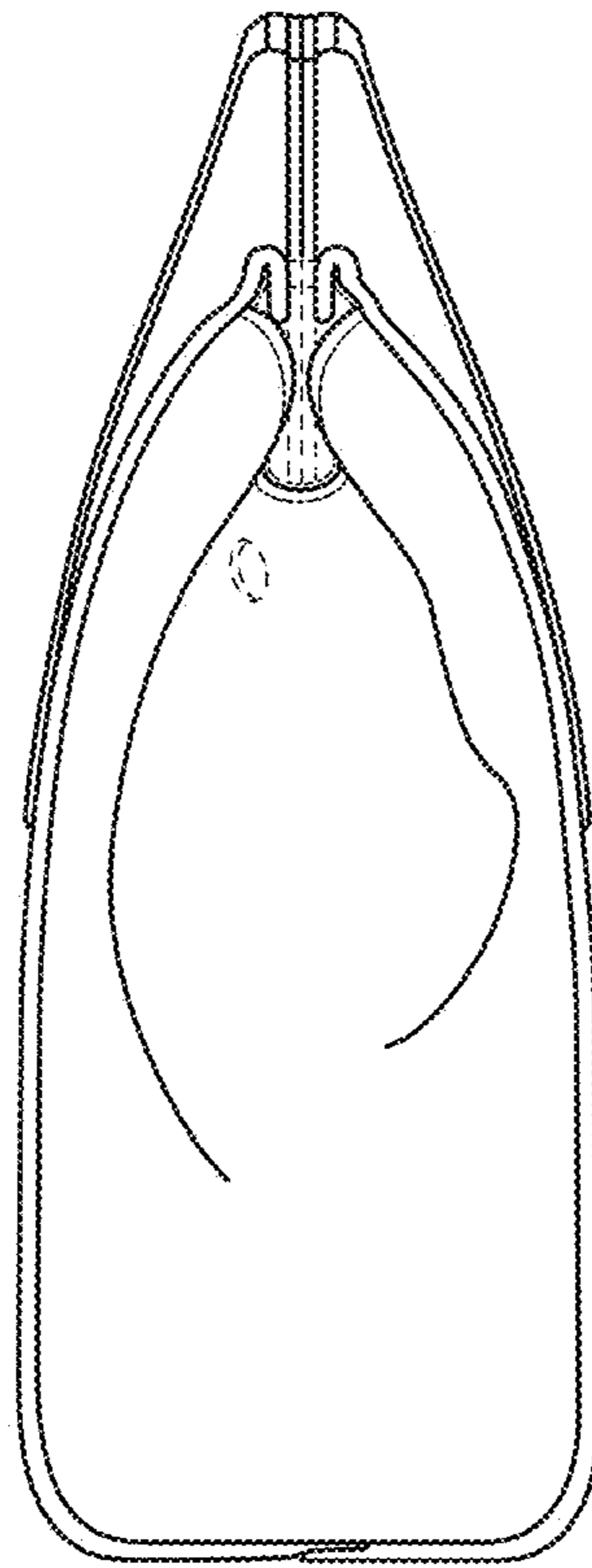

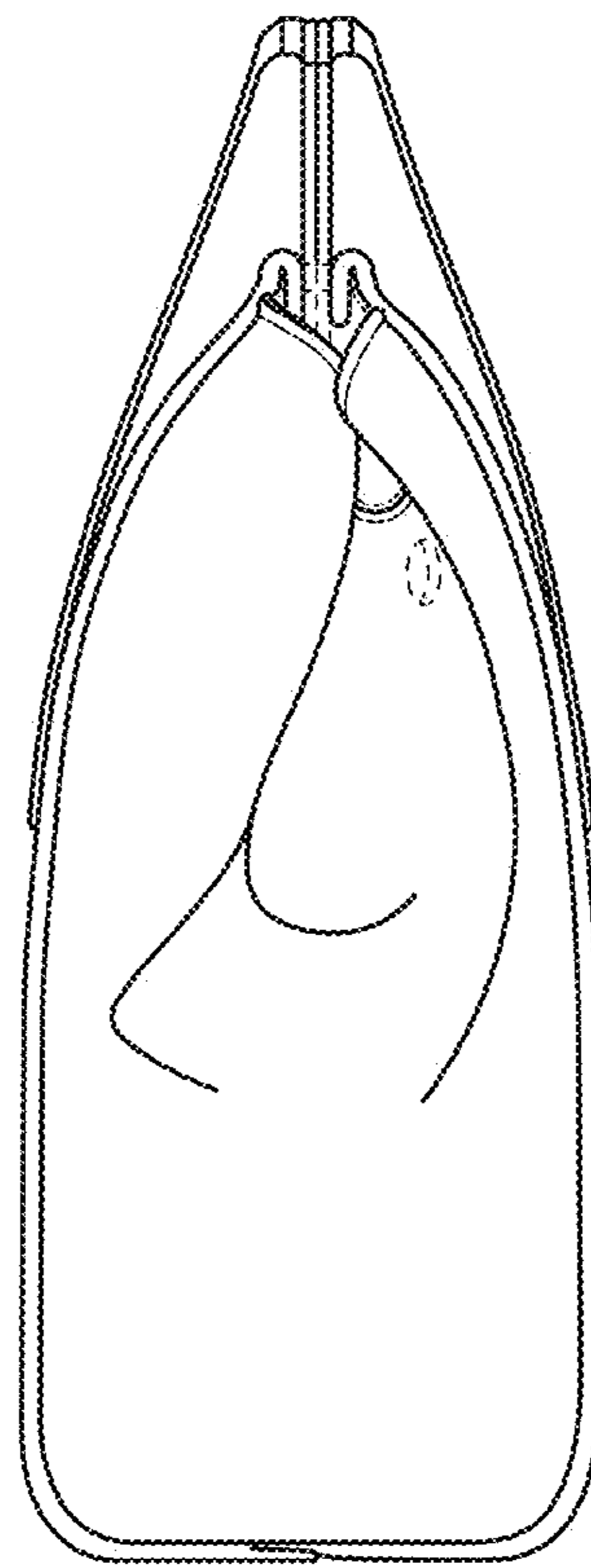

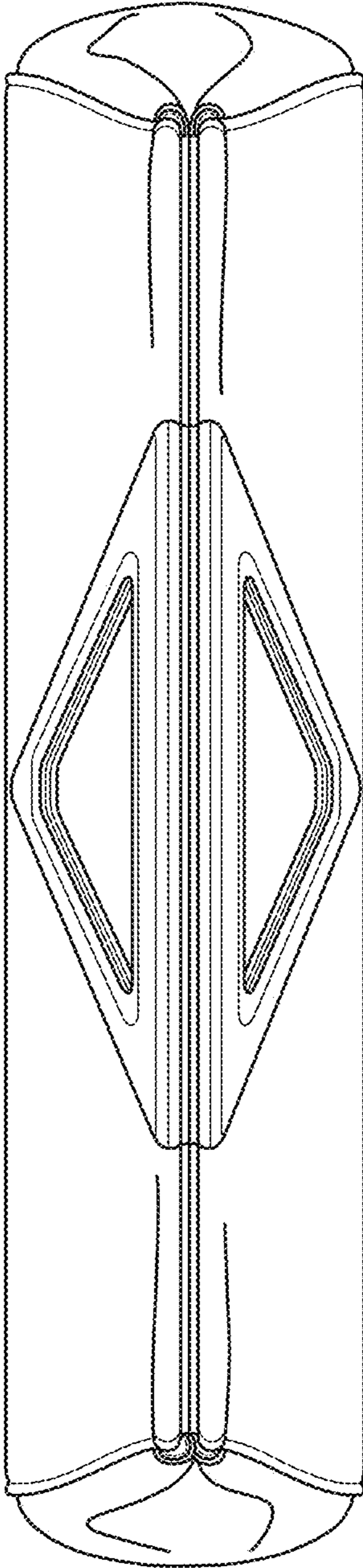

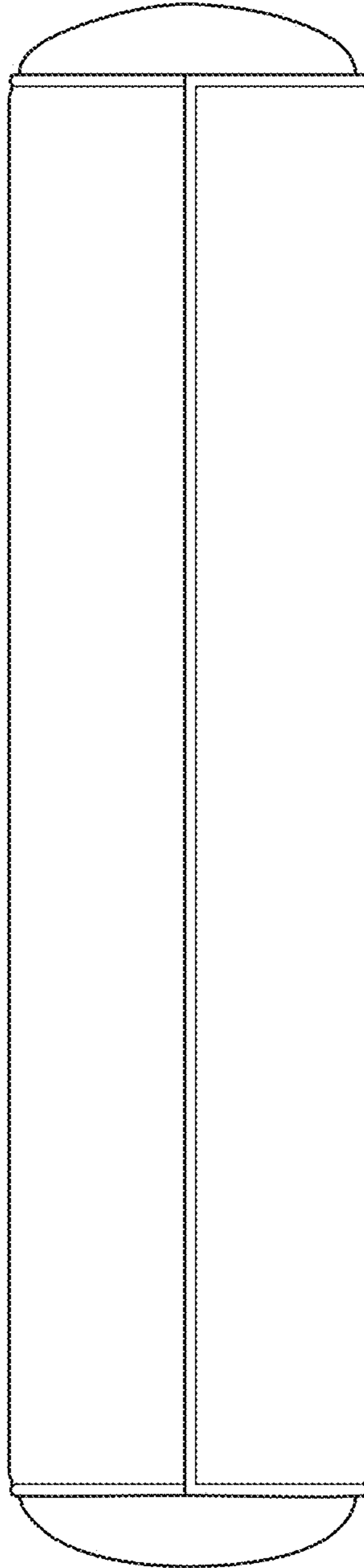
