DESCRIPTION

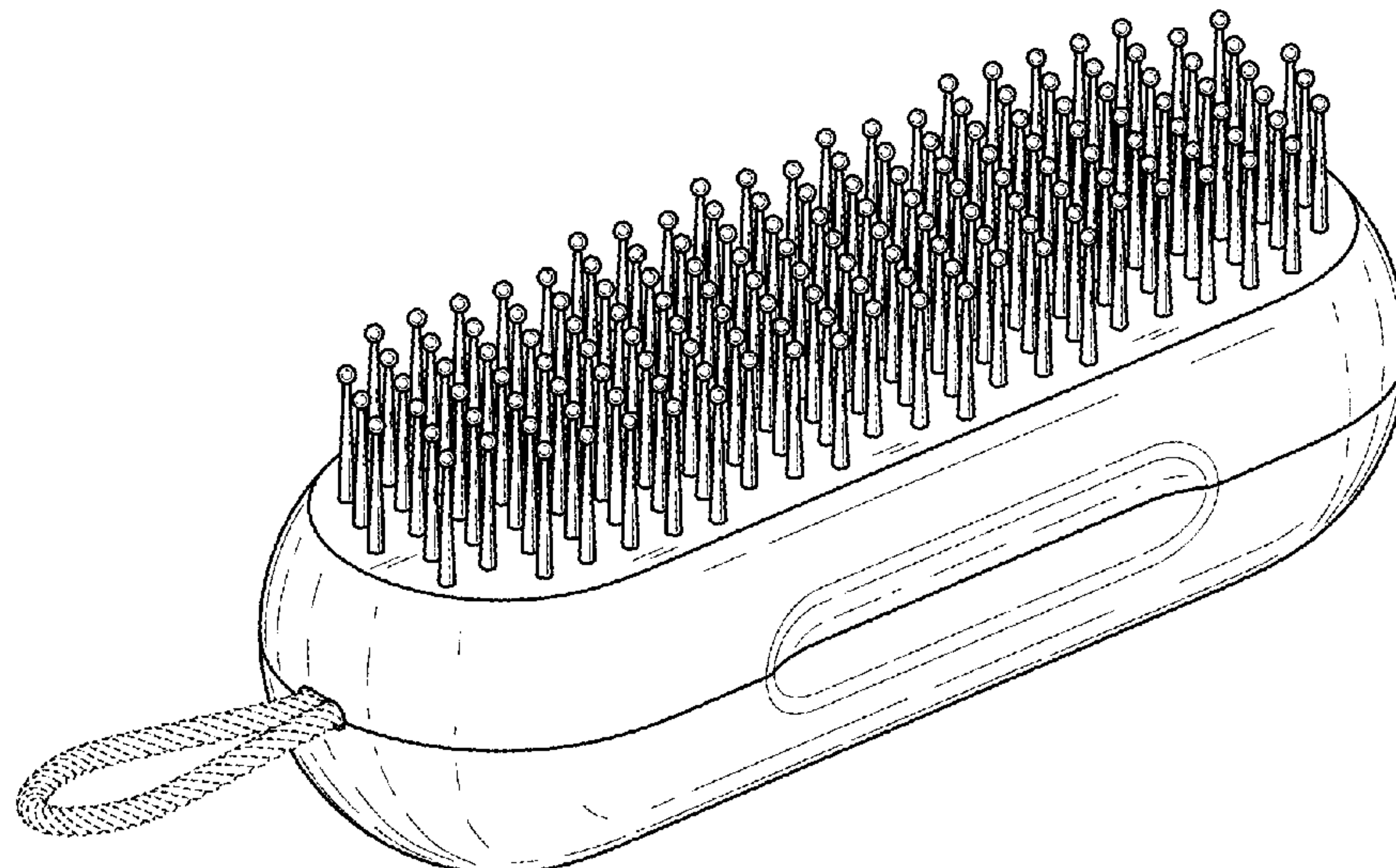
FIG. 1 is a perspective view of a brush showing my new design;

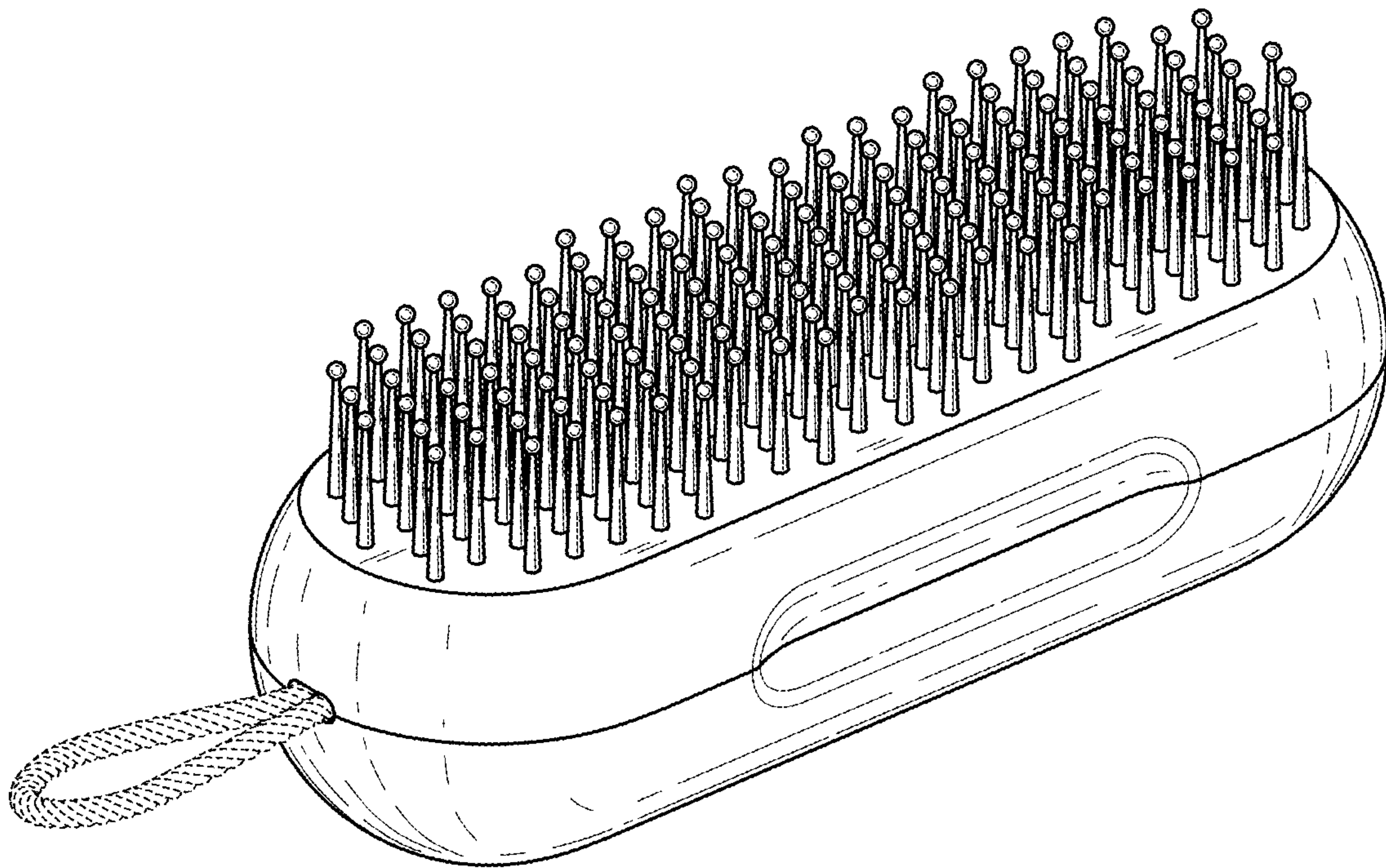

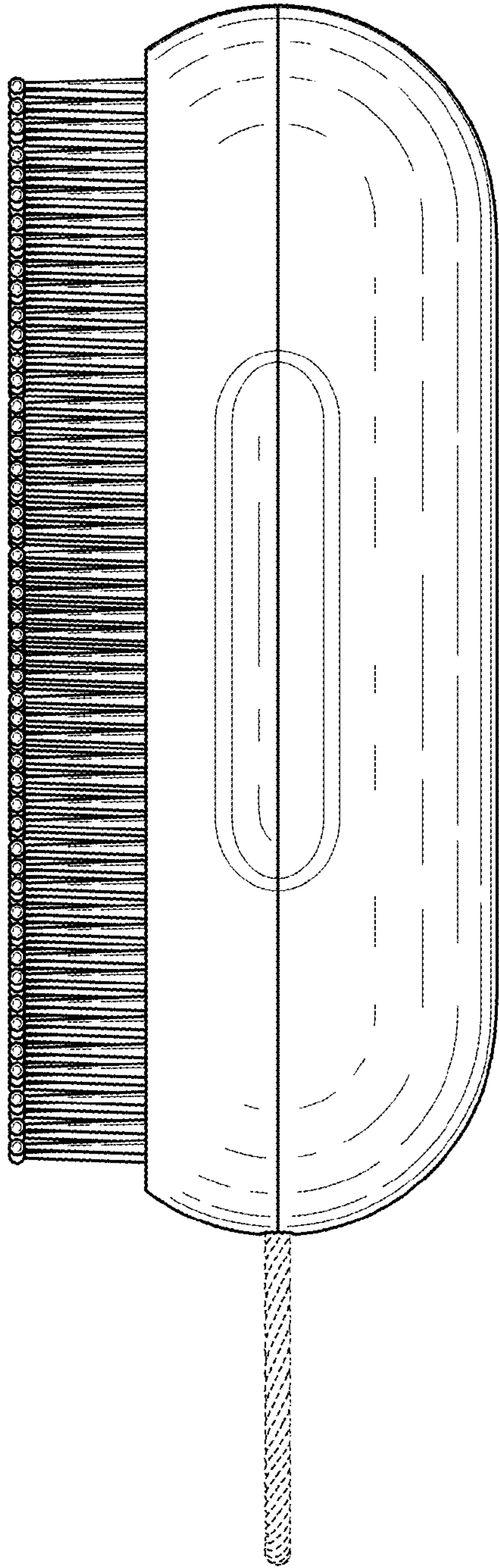

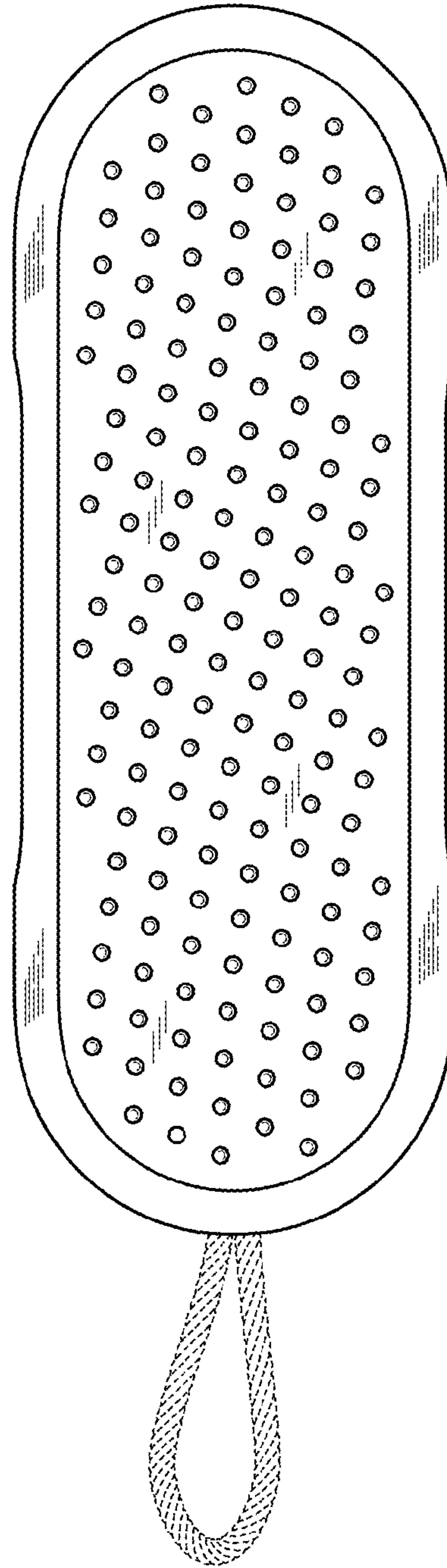

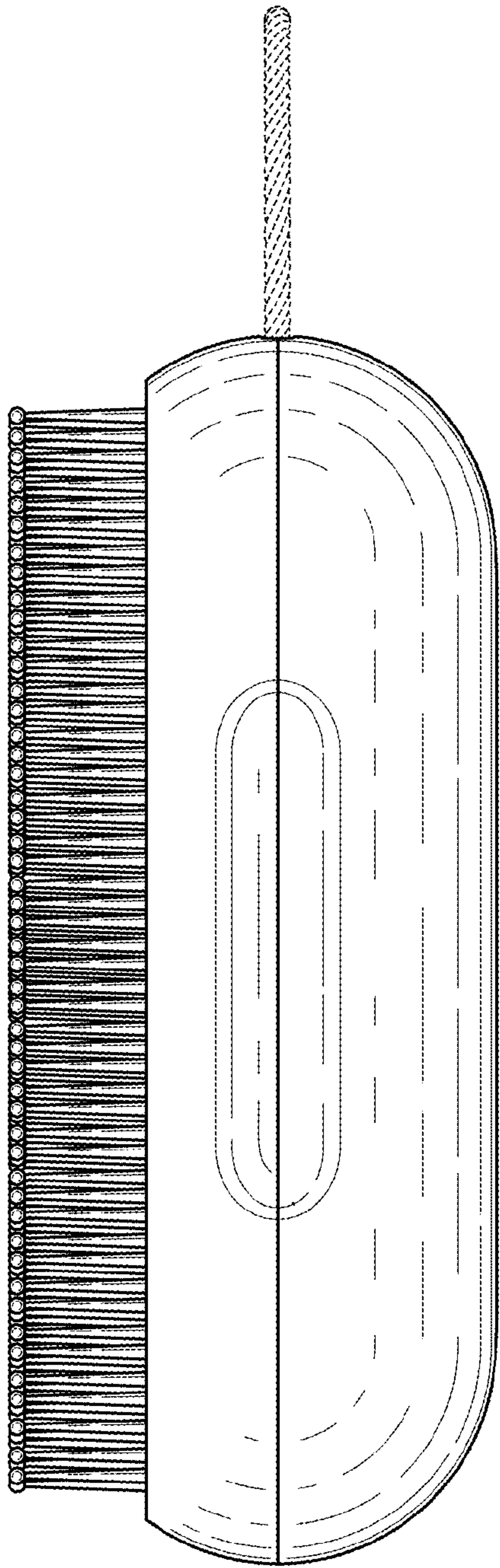

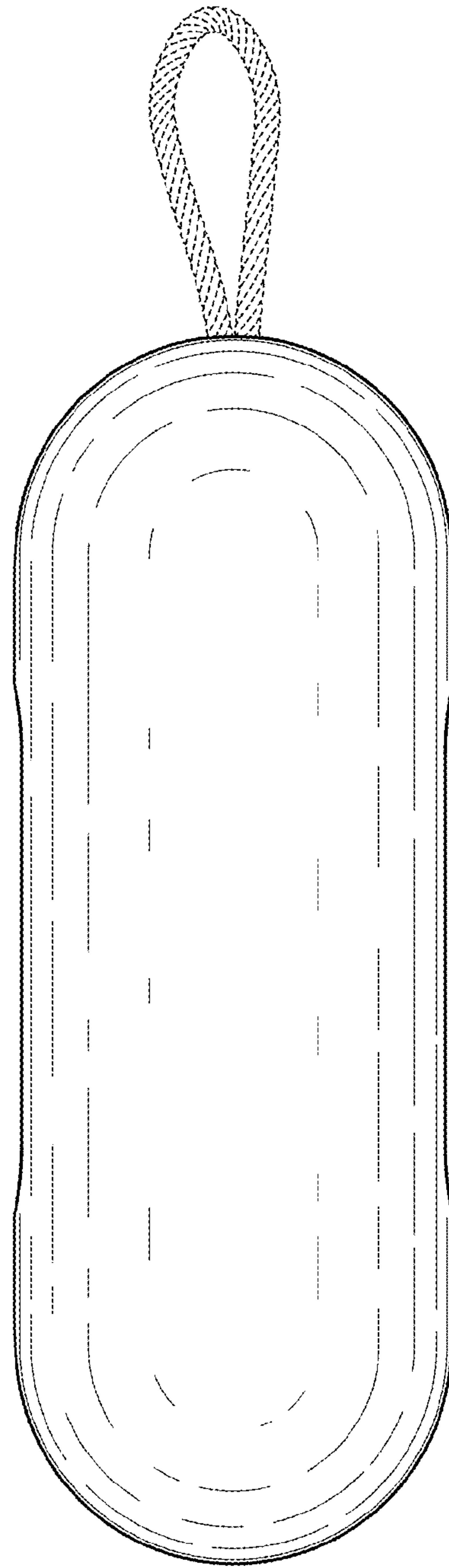

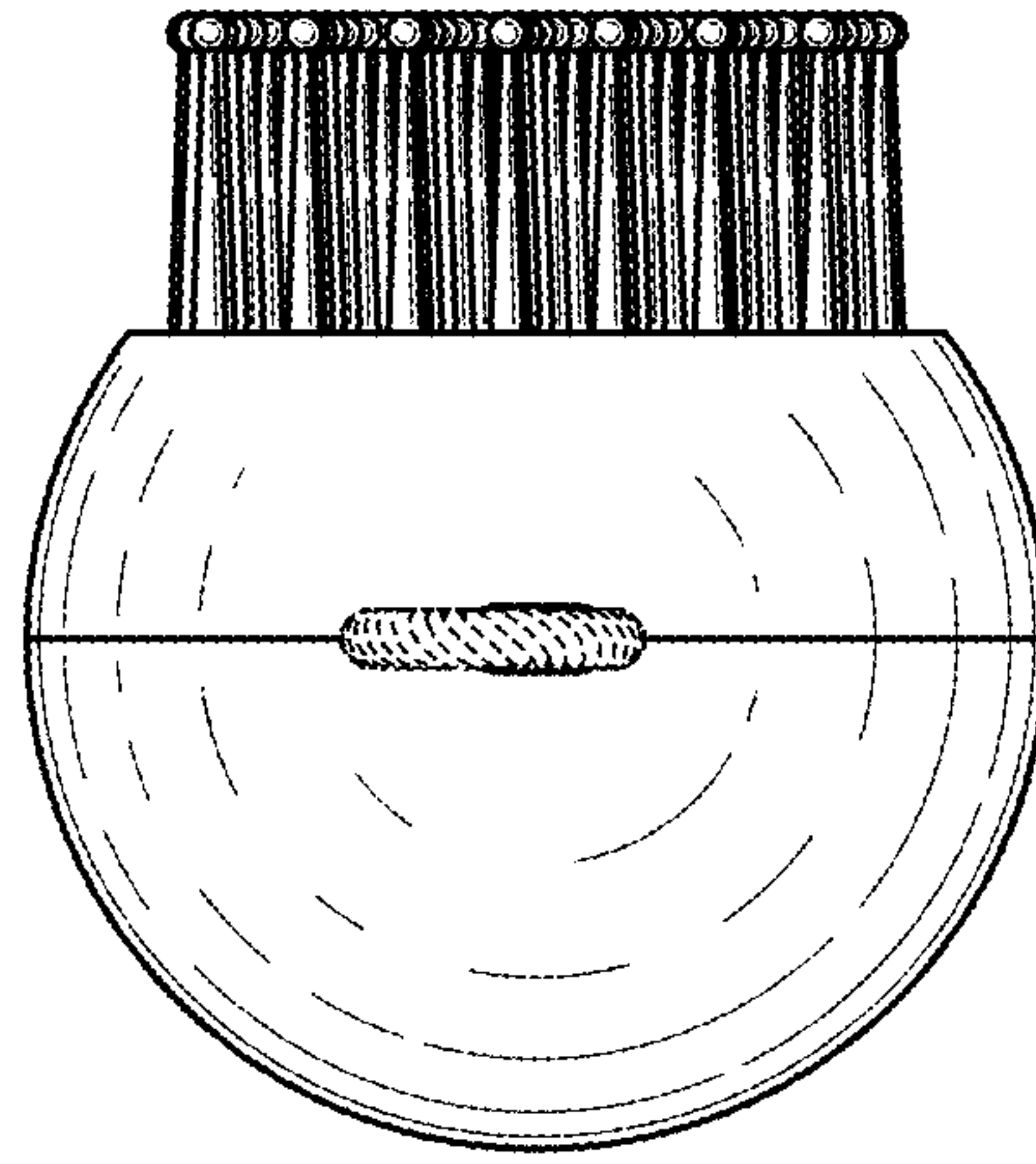

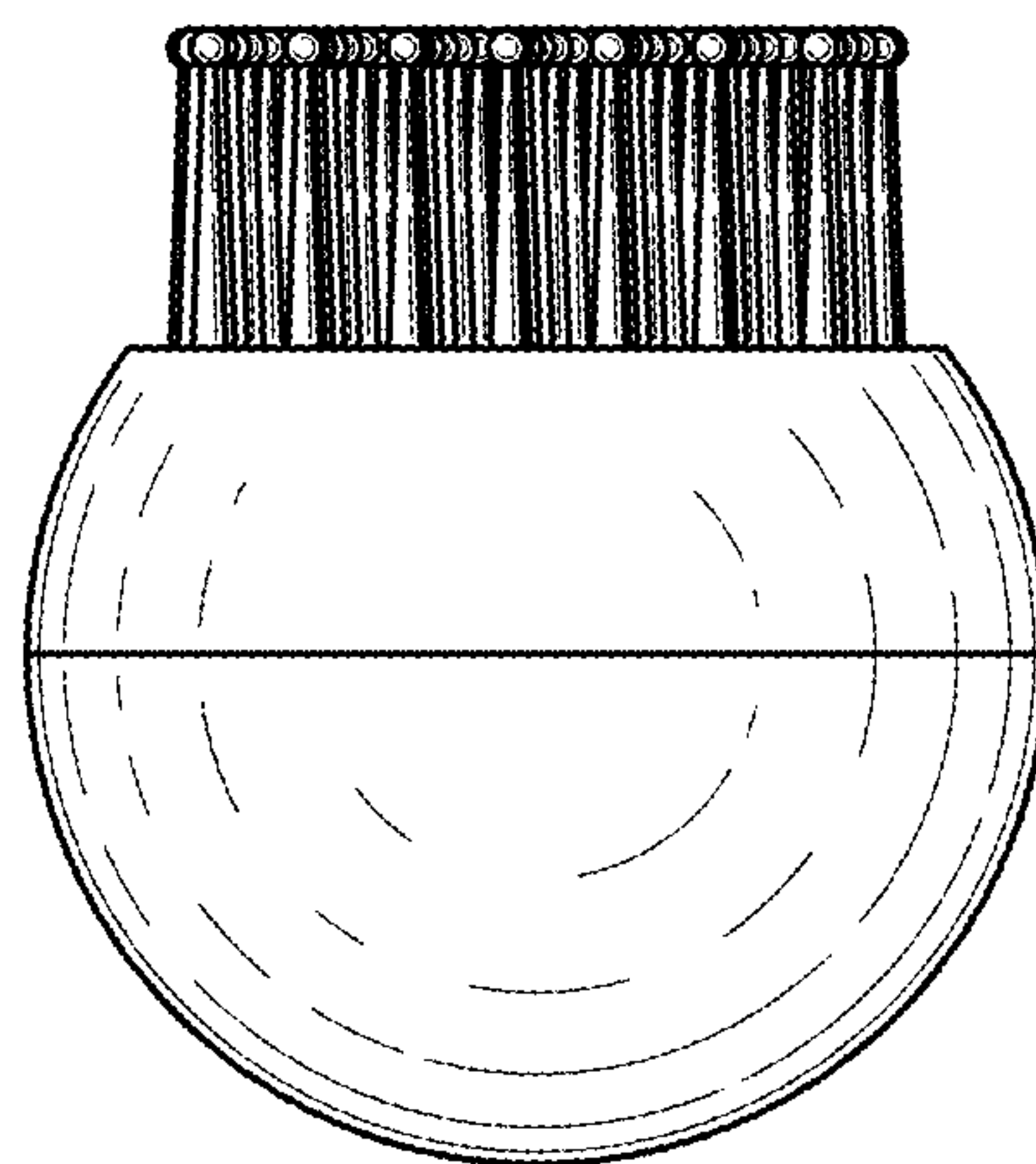
