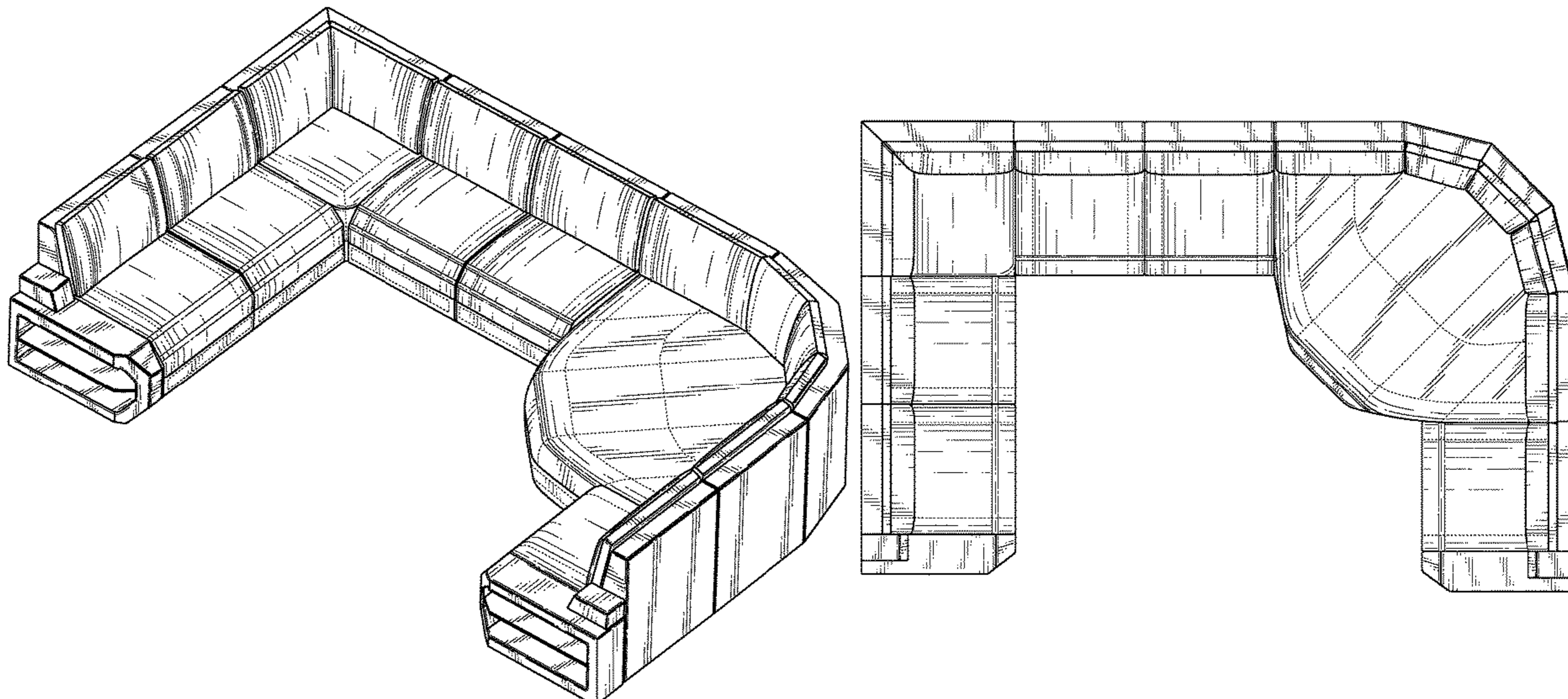
(57) **CLAIM**

The ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-right perspective view of a sofa showing my new design;
FIG. 2 is a bottom-rear-left perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;

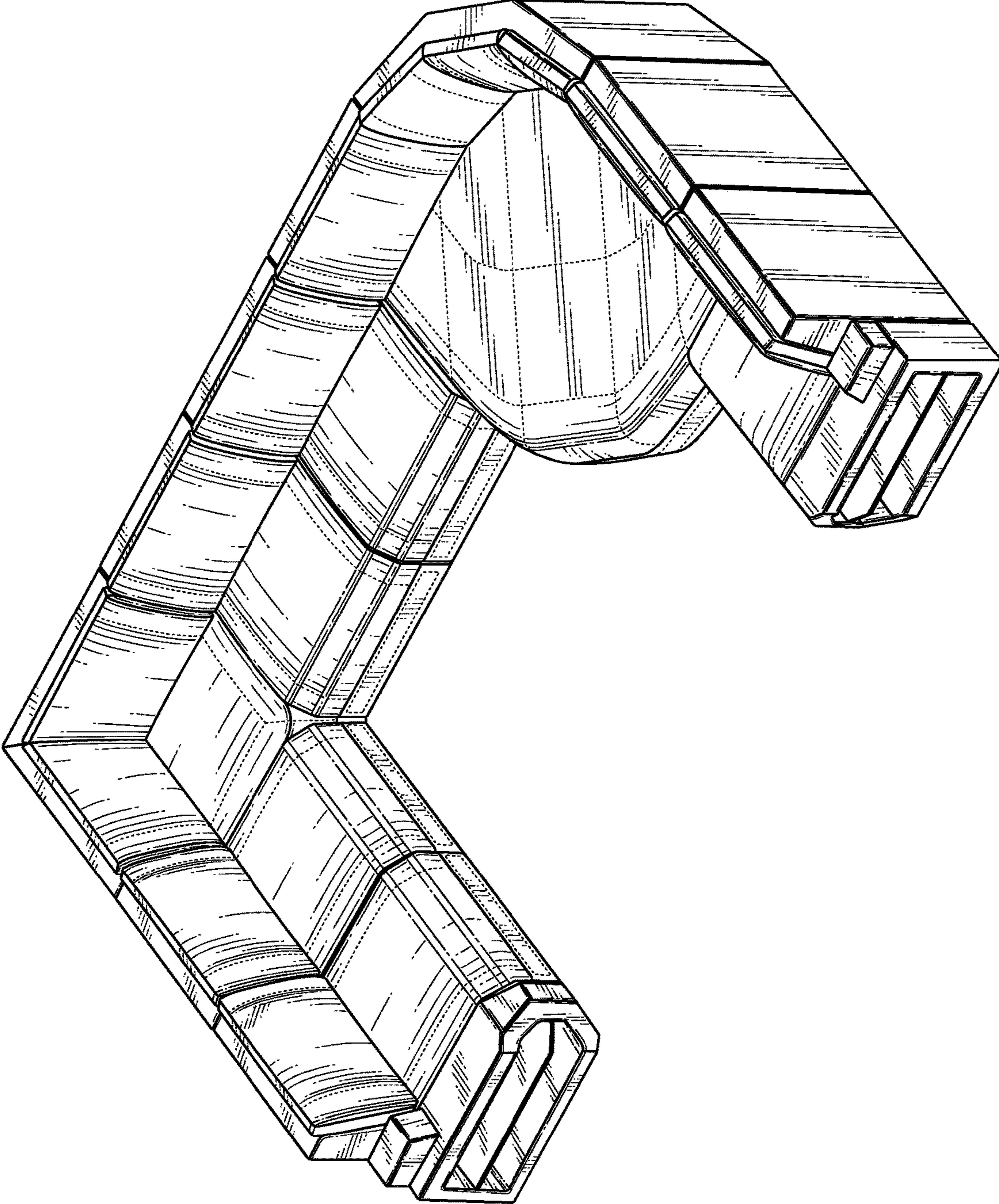

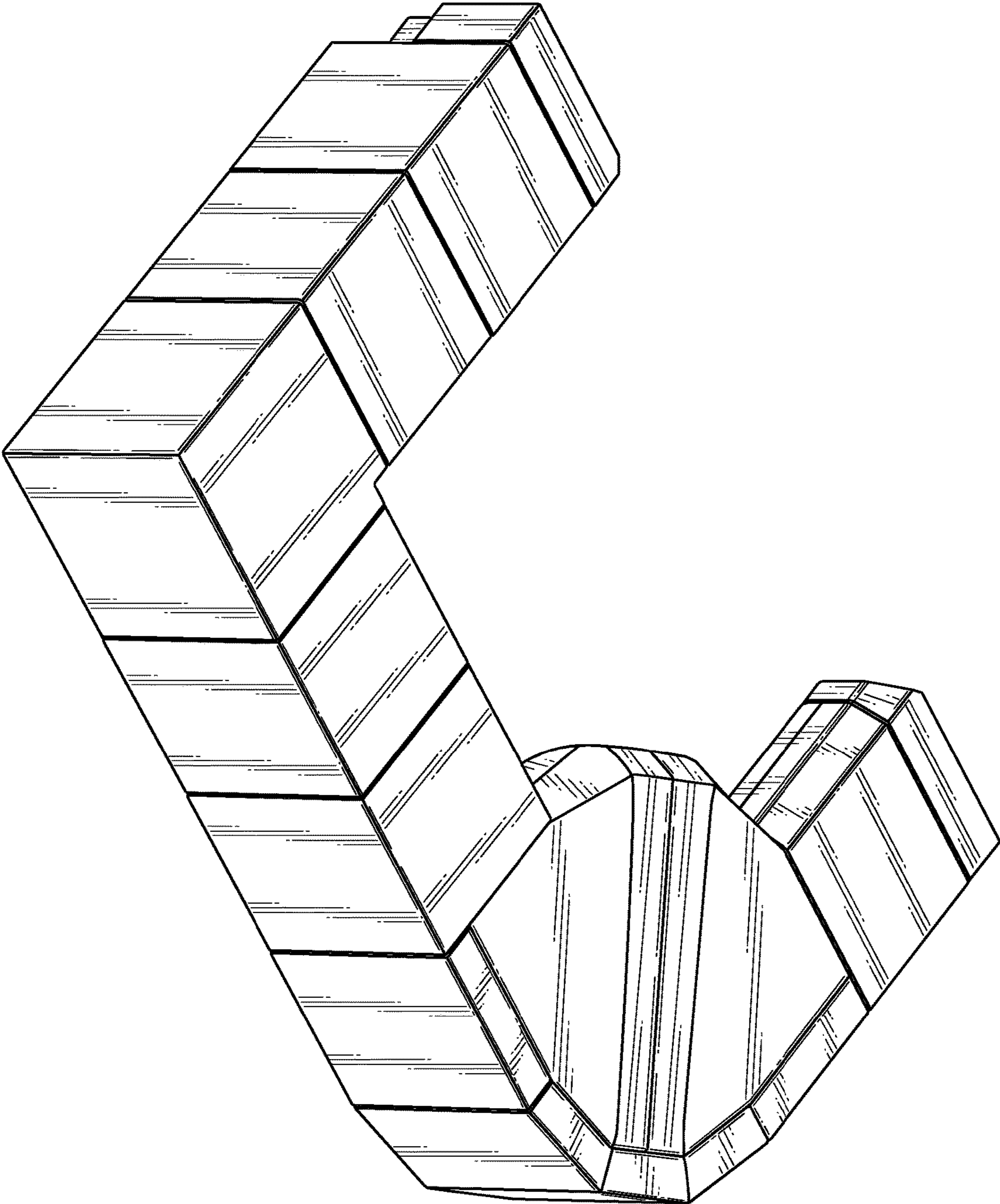

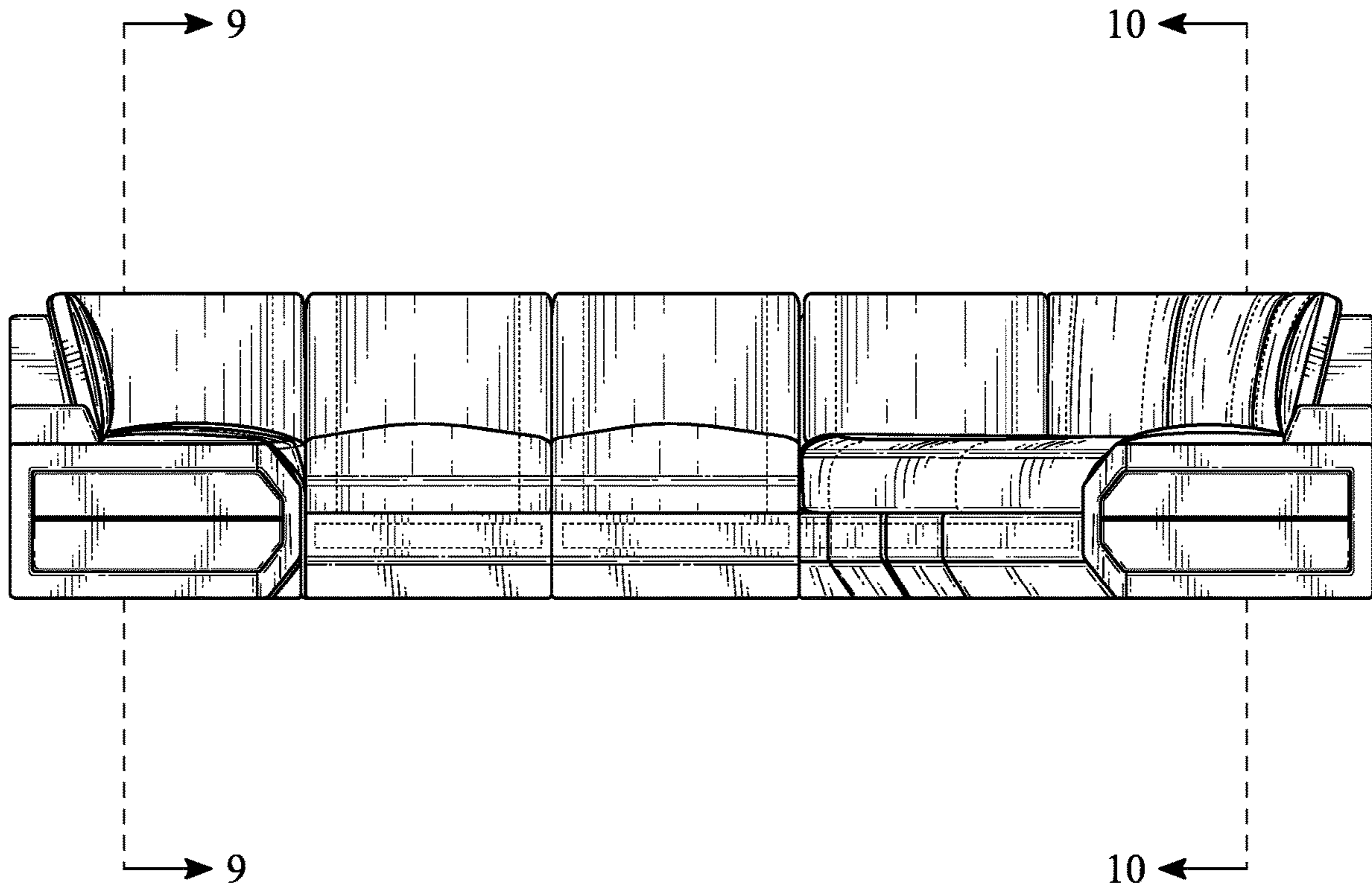

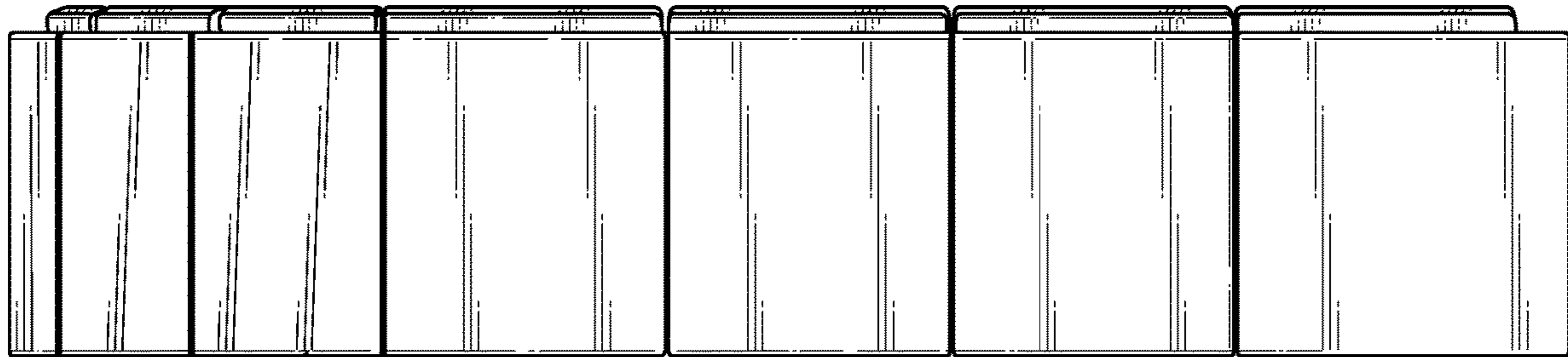

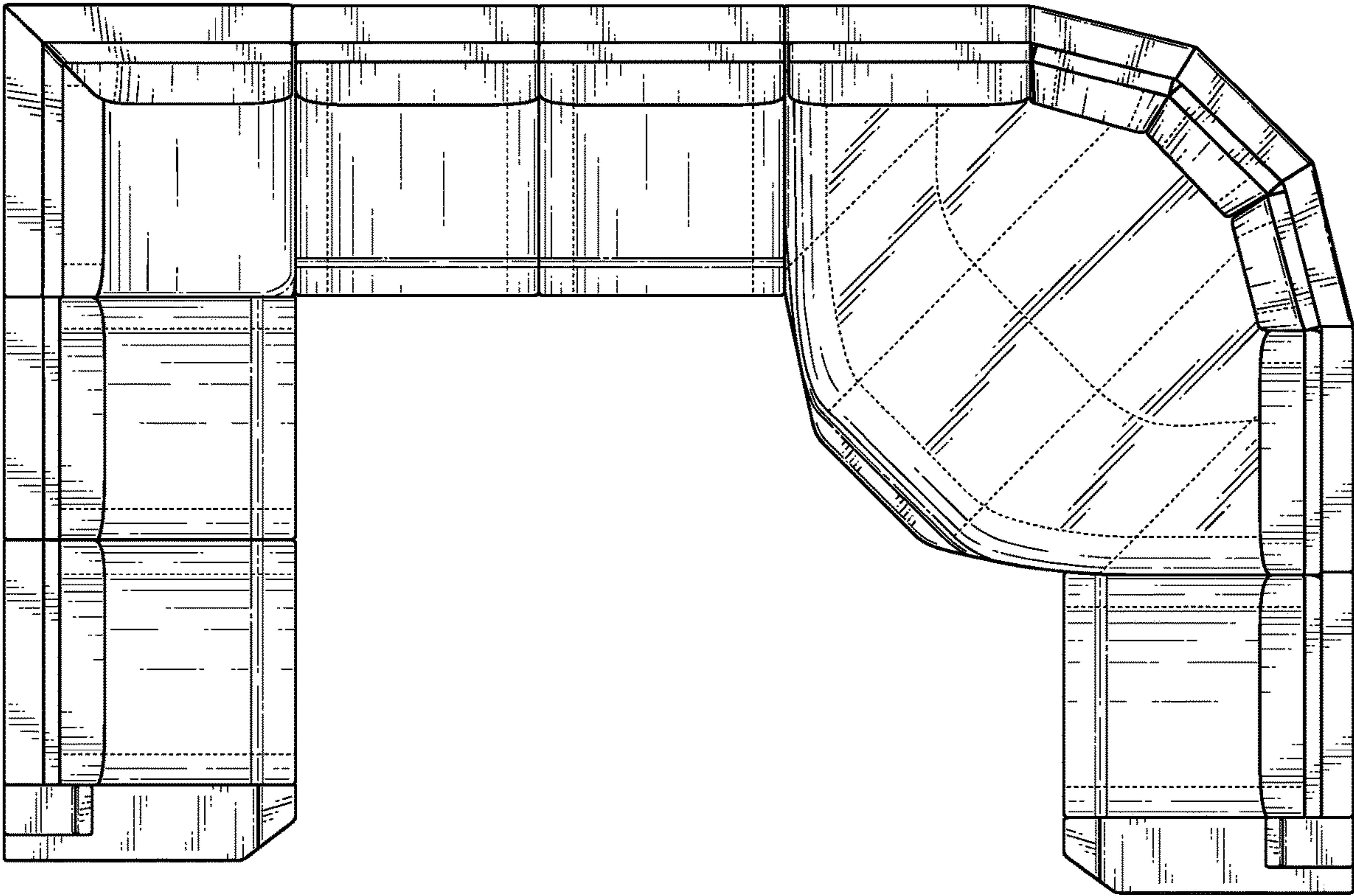

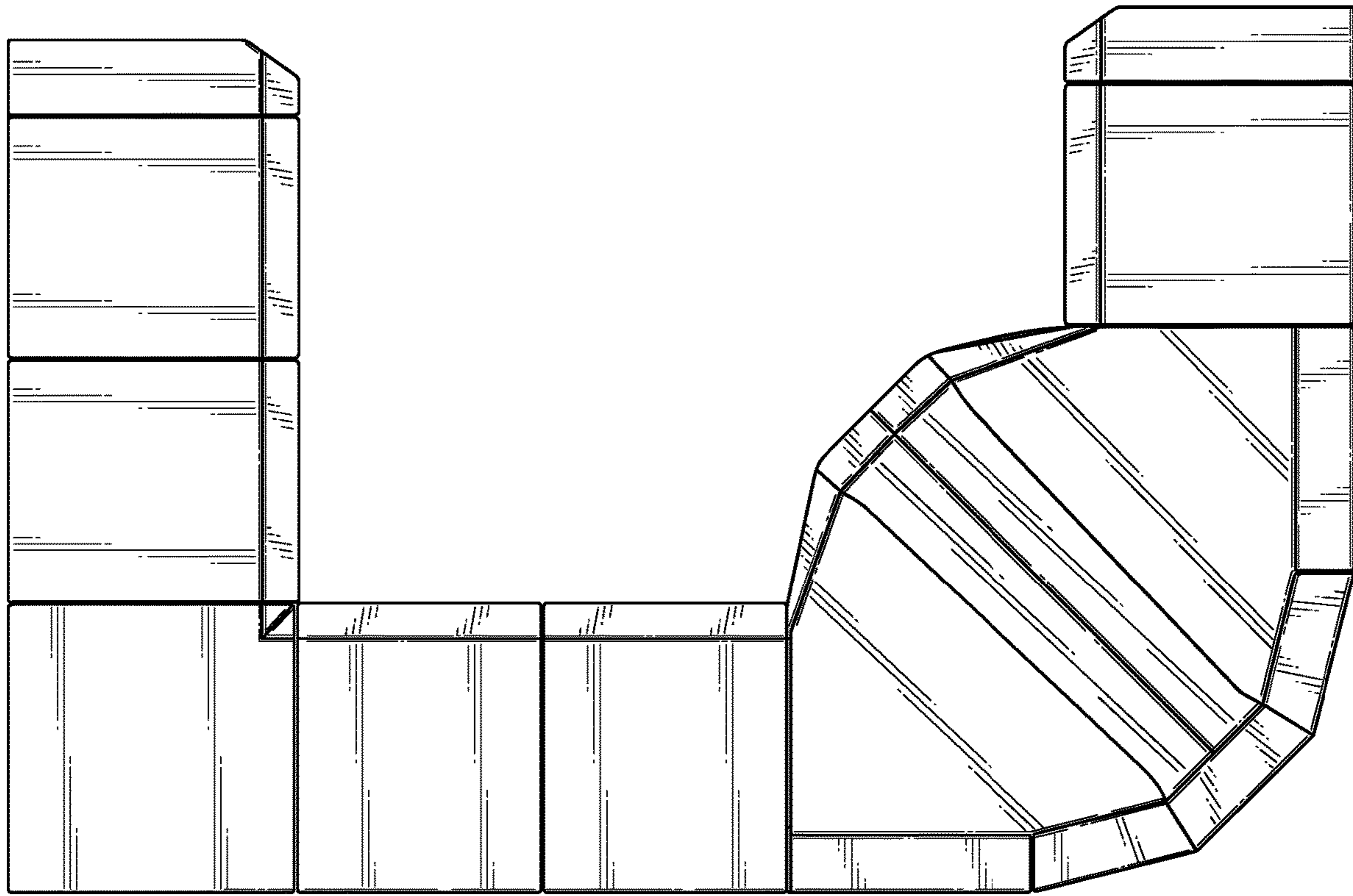

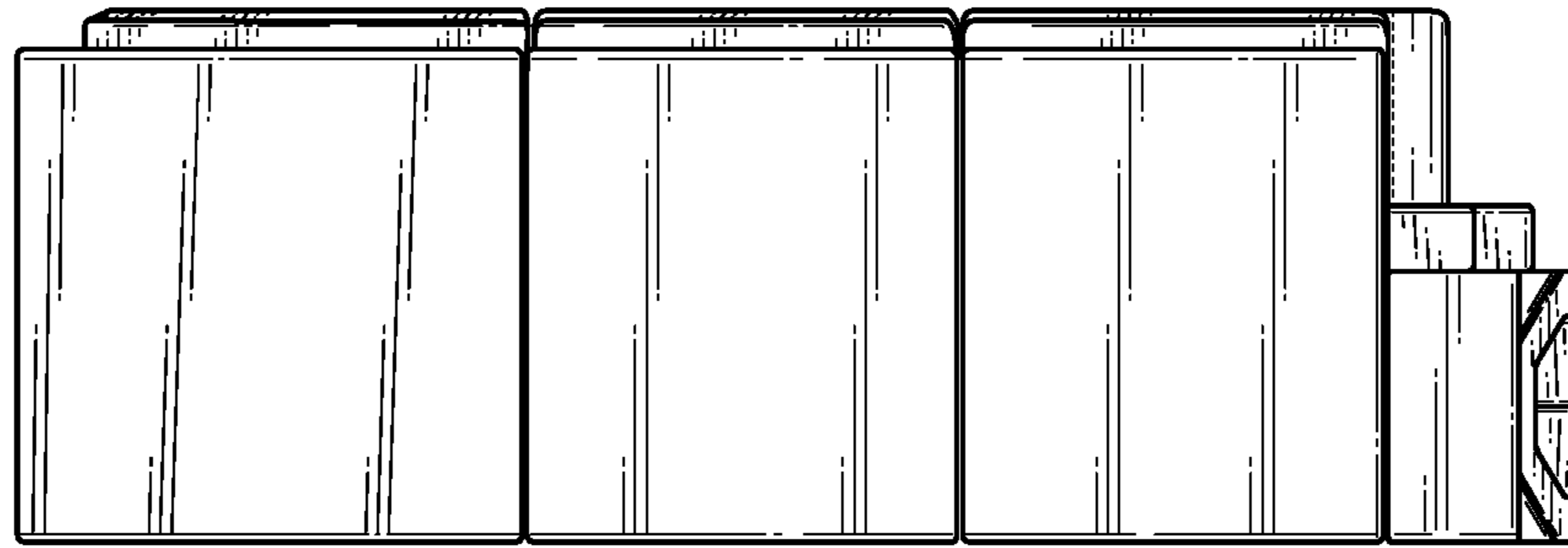

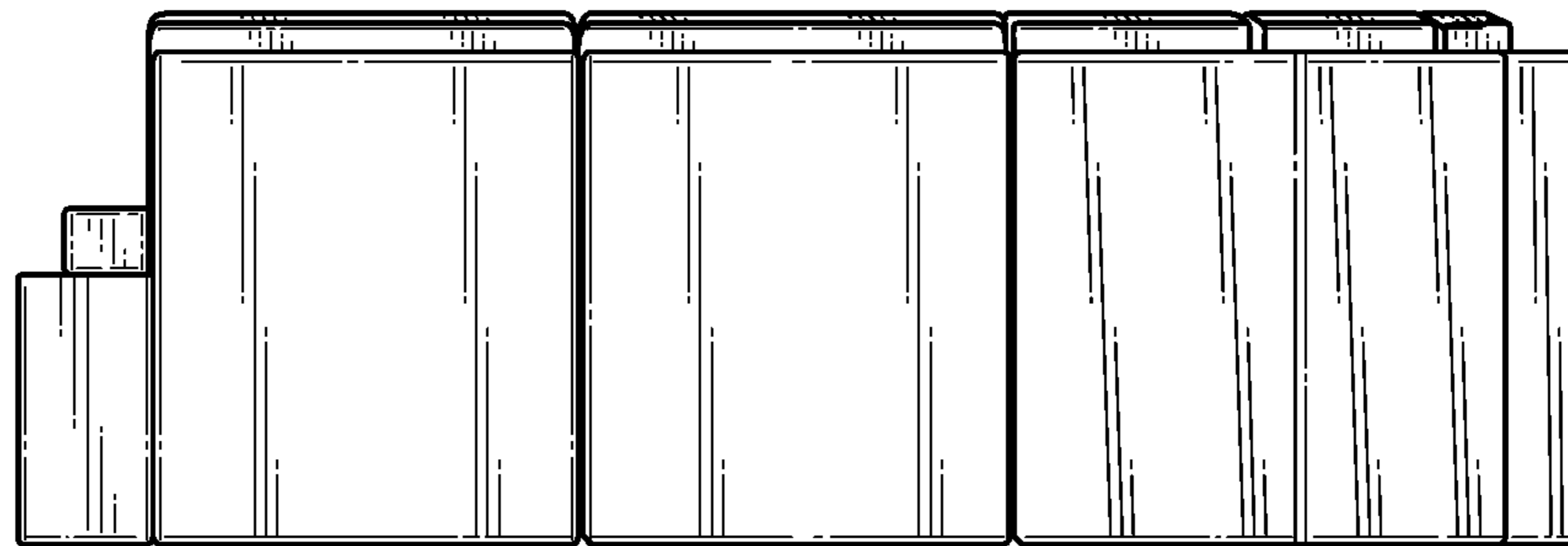

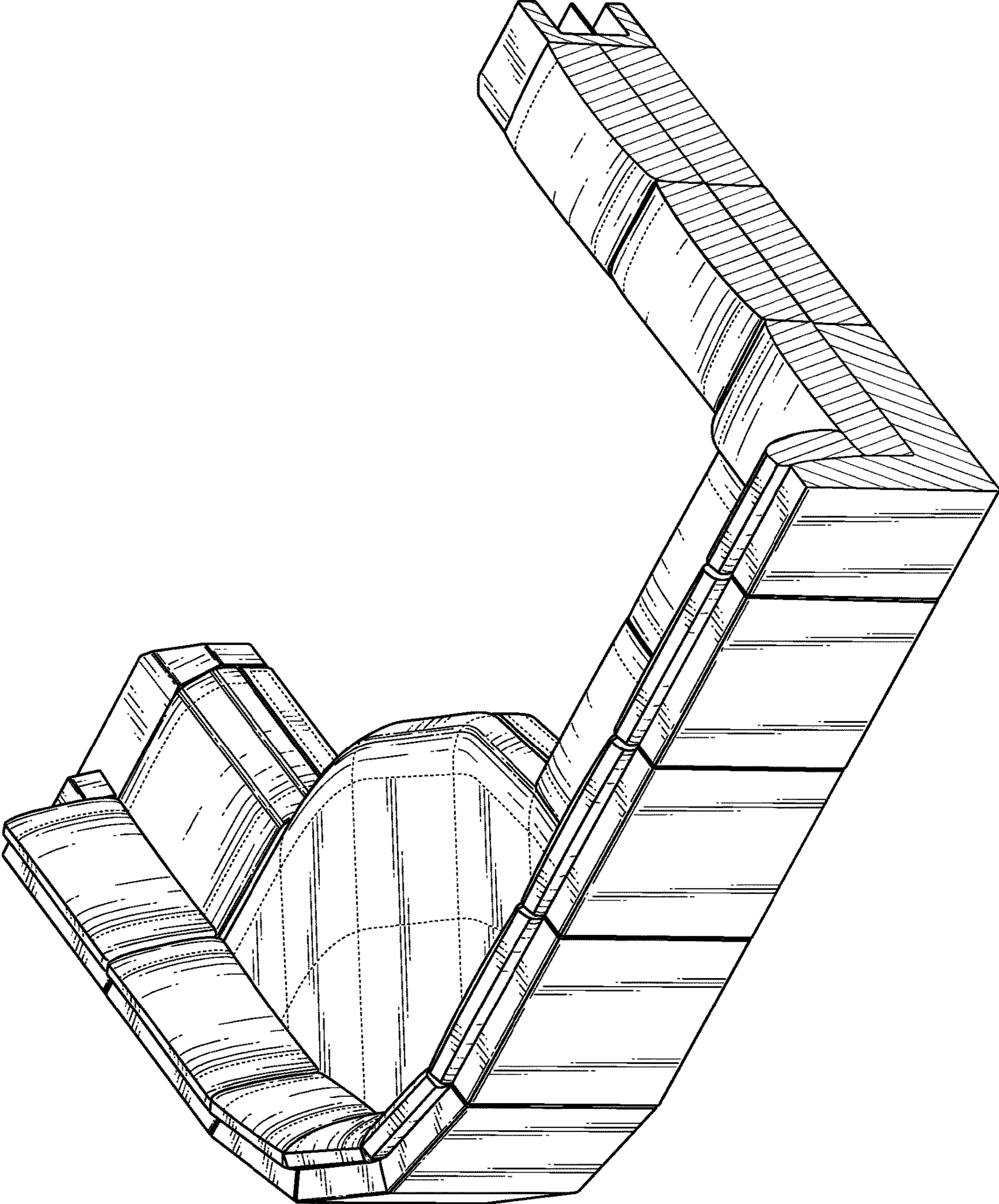

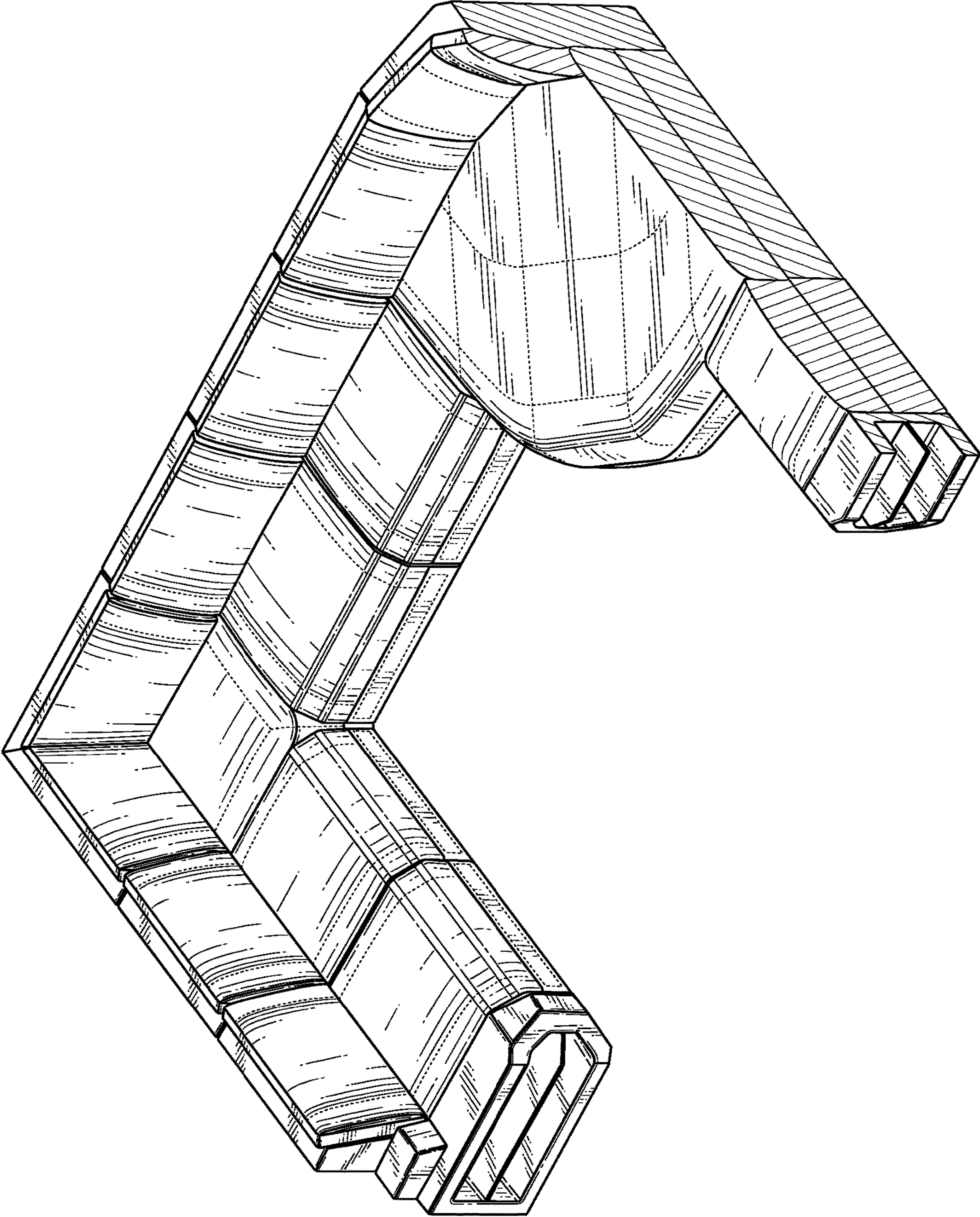
