DESCRIPTION

FIG. 1 is a perspective view of a safety lock showing my new design;
FIG. 2 is a front view of the safety lock as shown in FIG. 1;

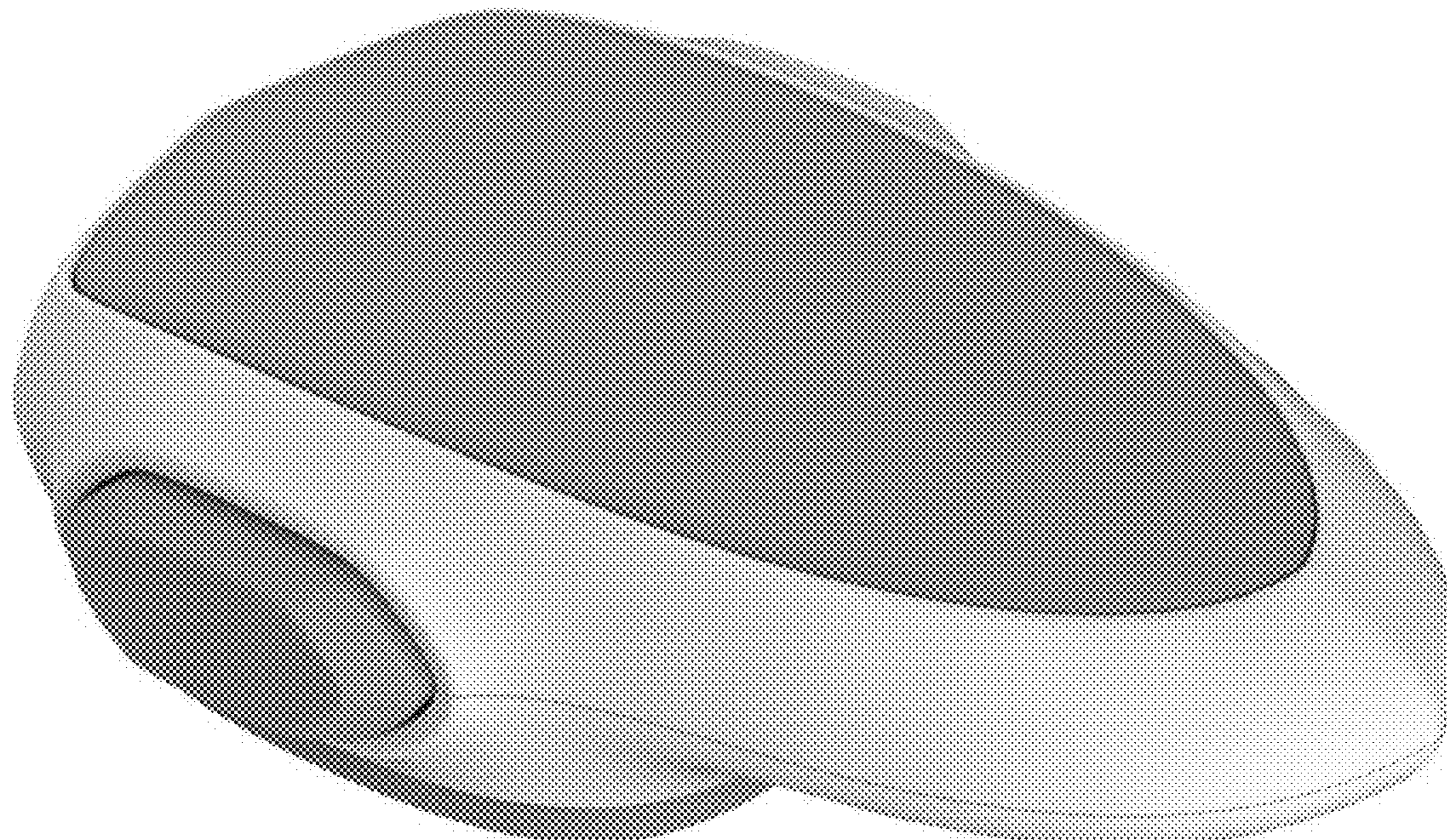

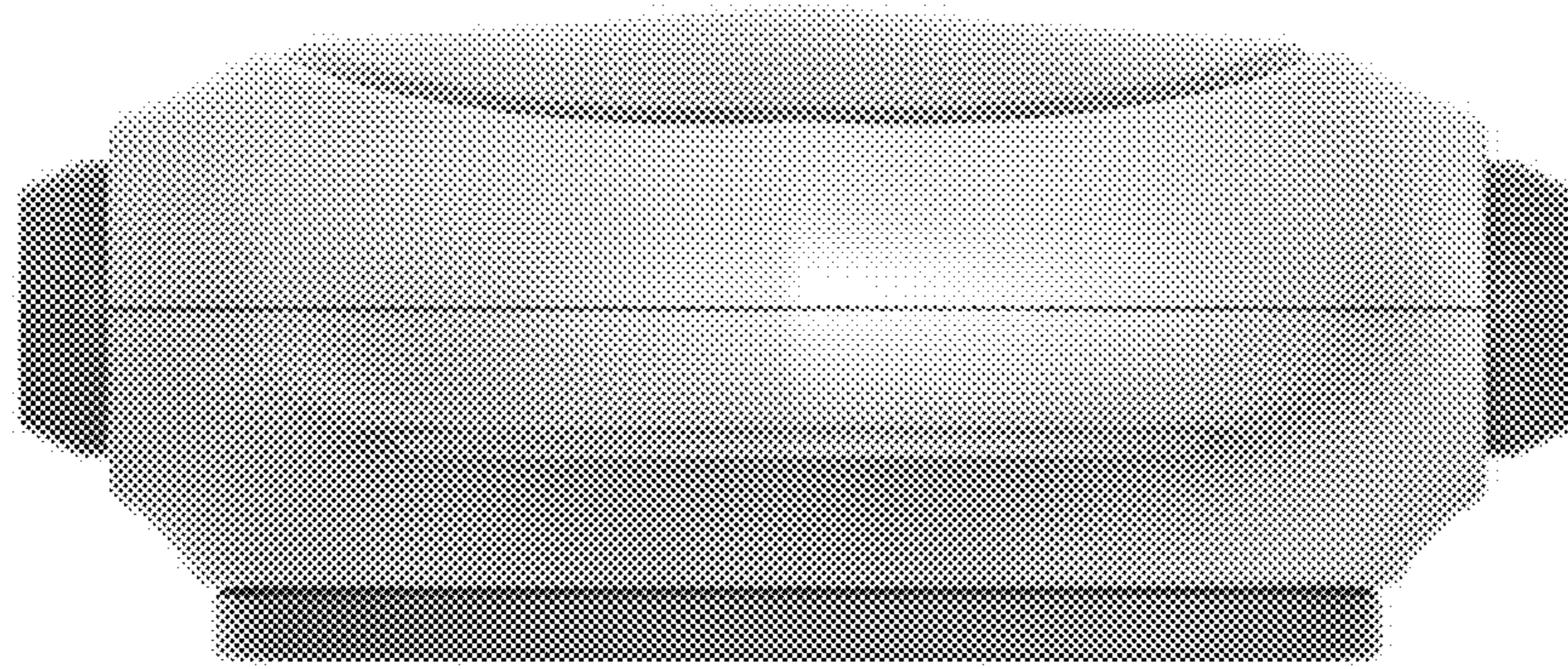

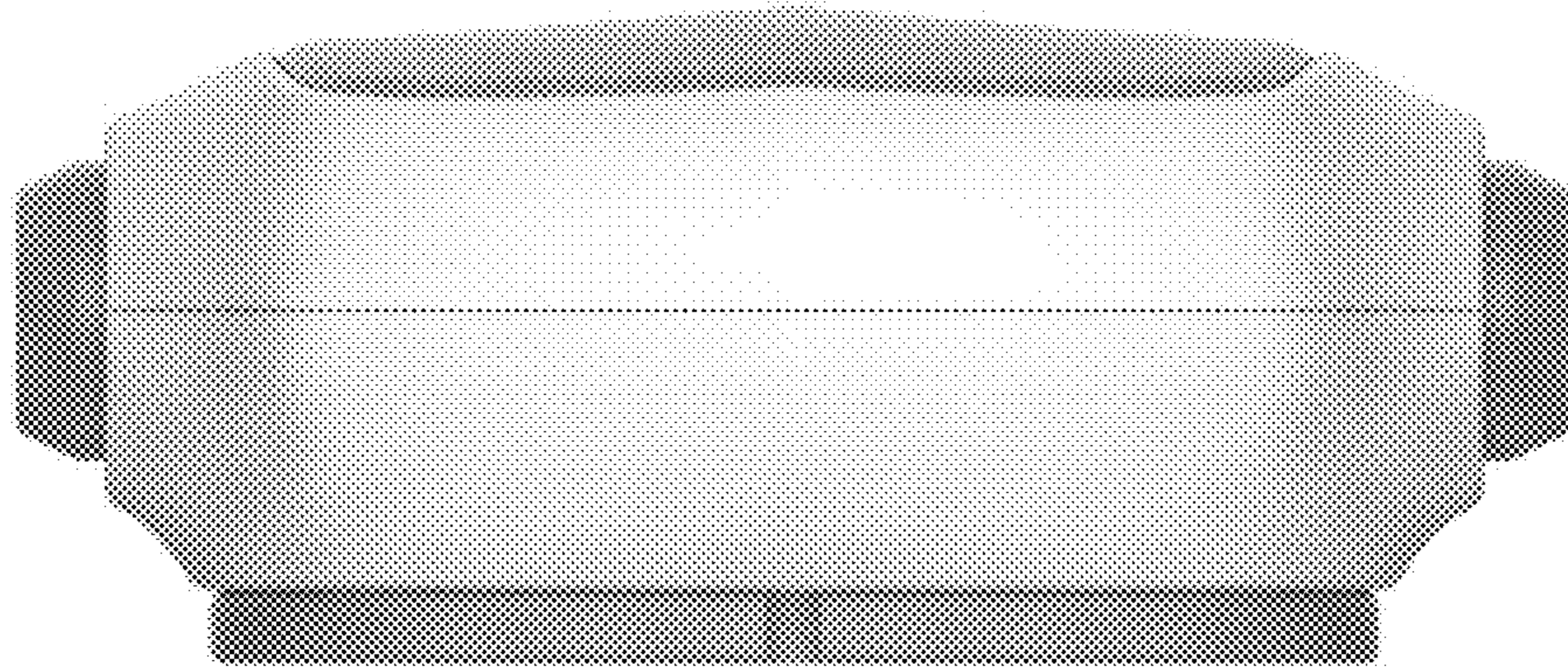

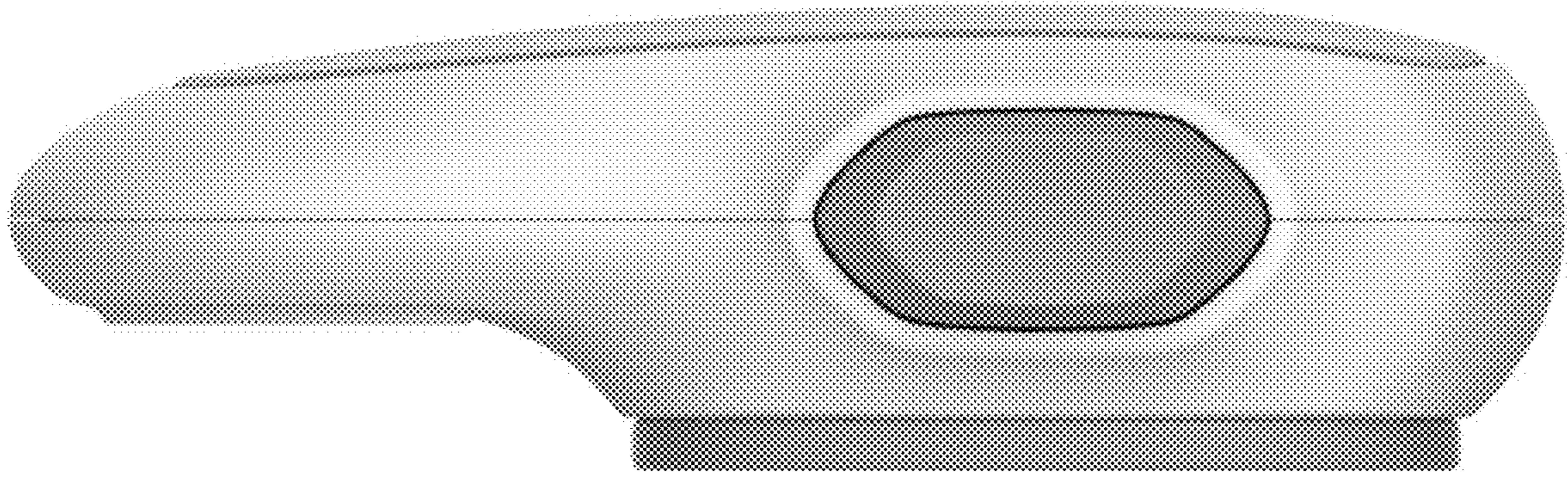

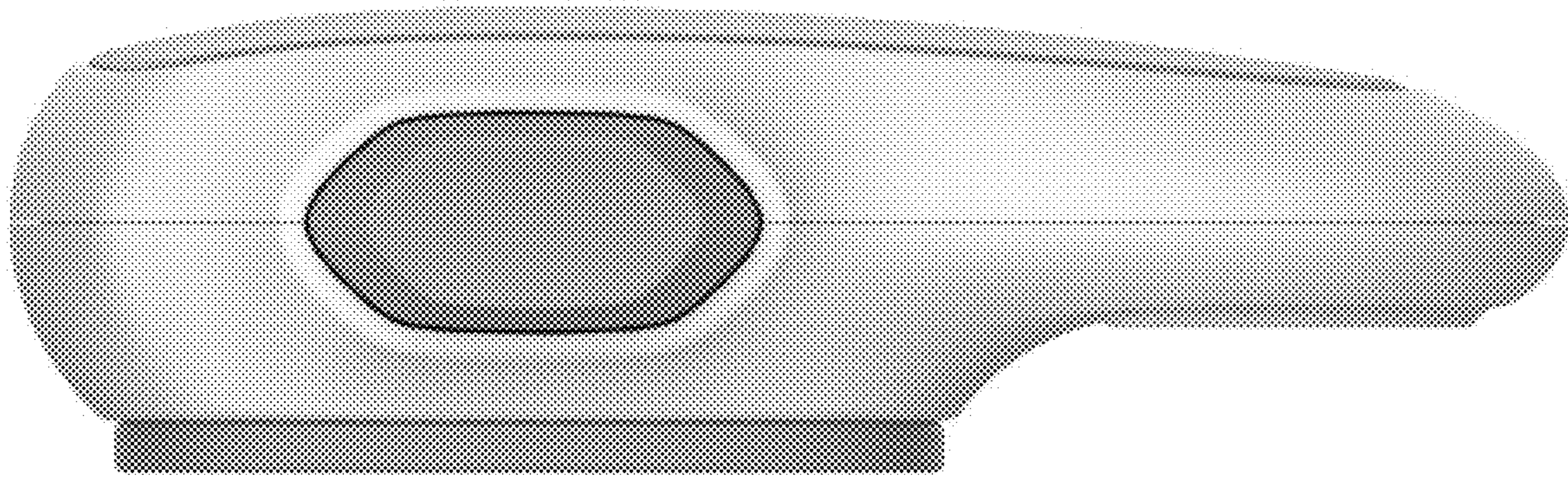

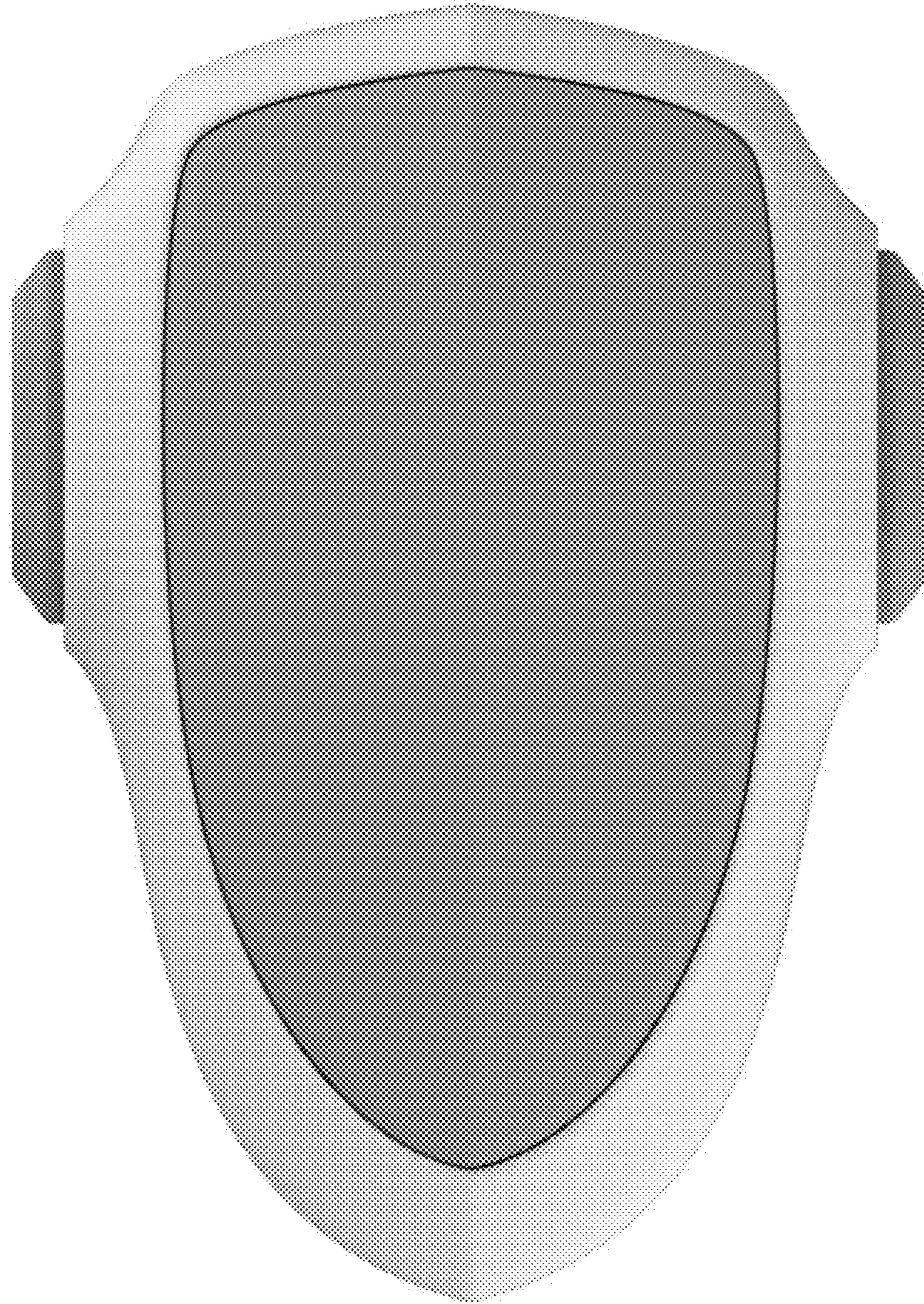

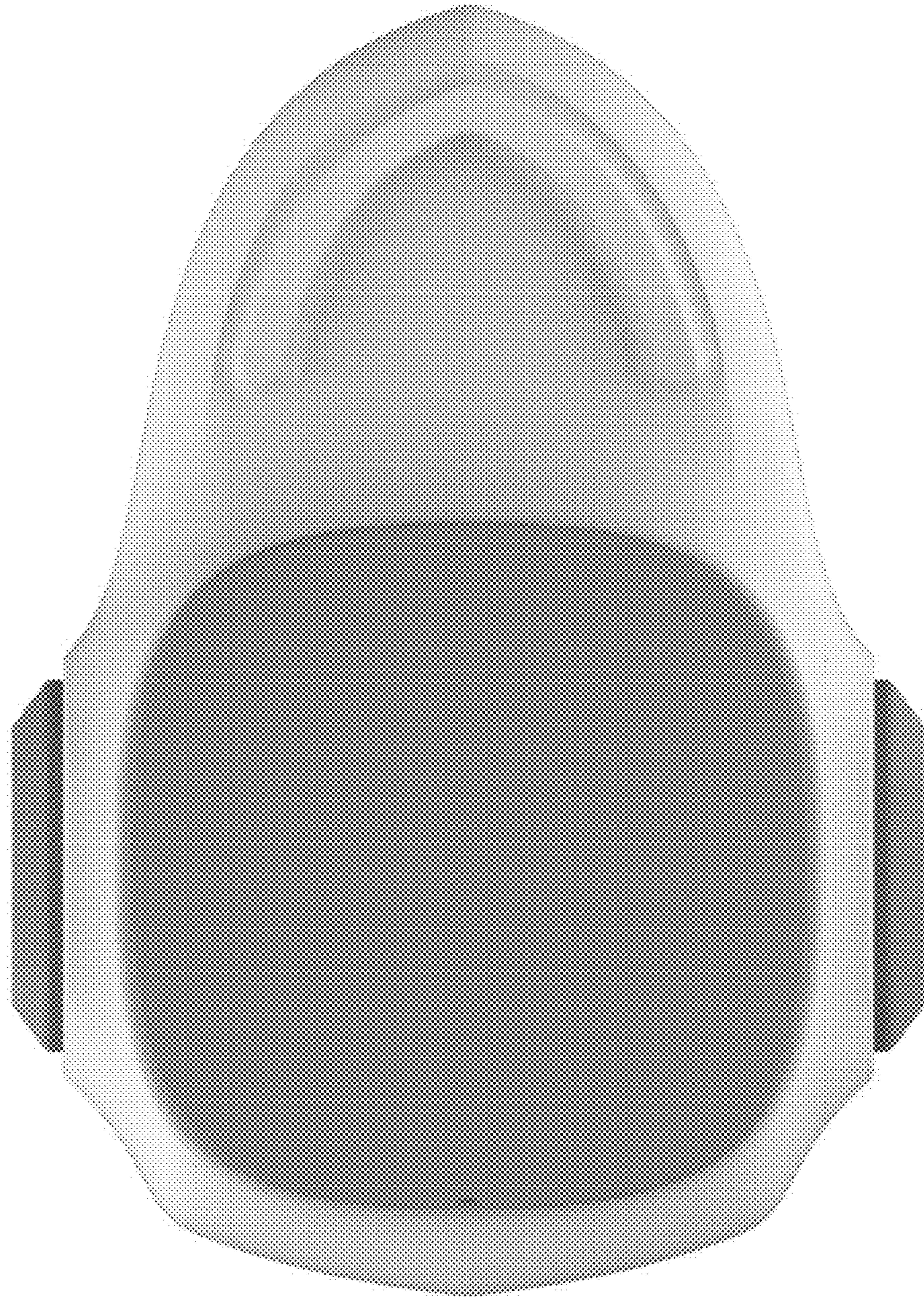
