FIG. 16 is a rear view thereof.

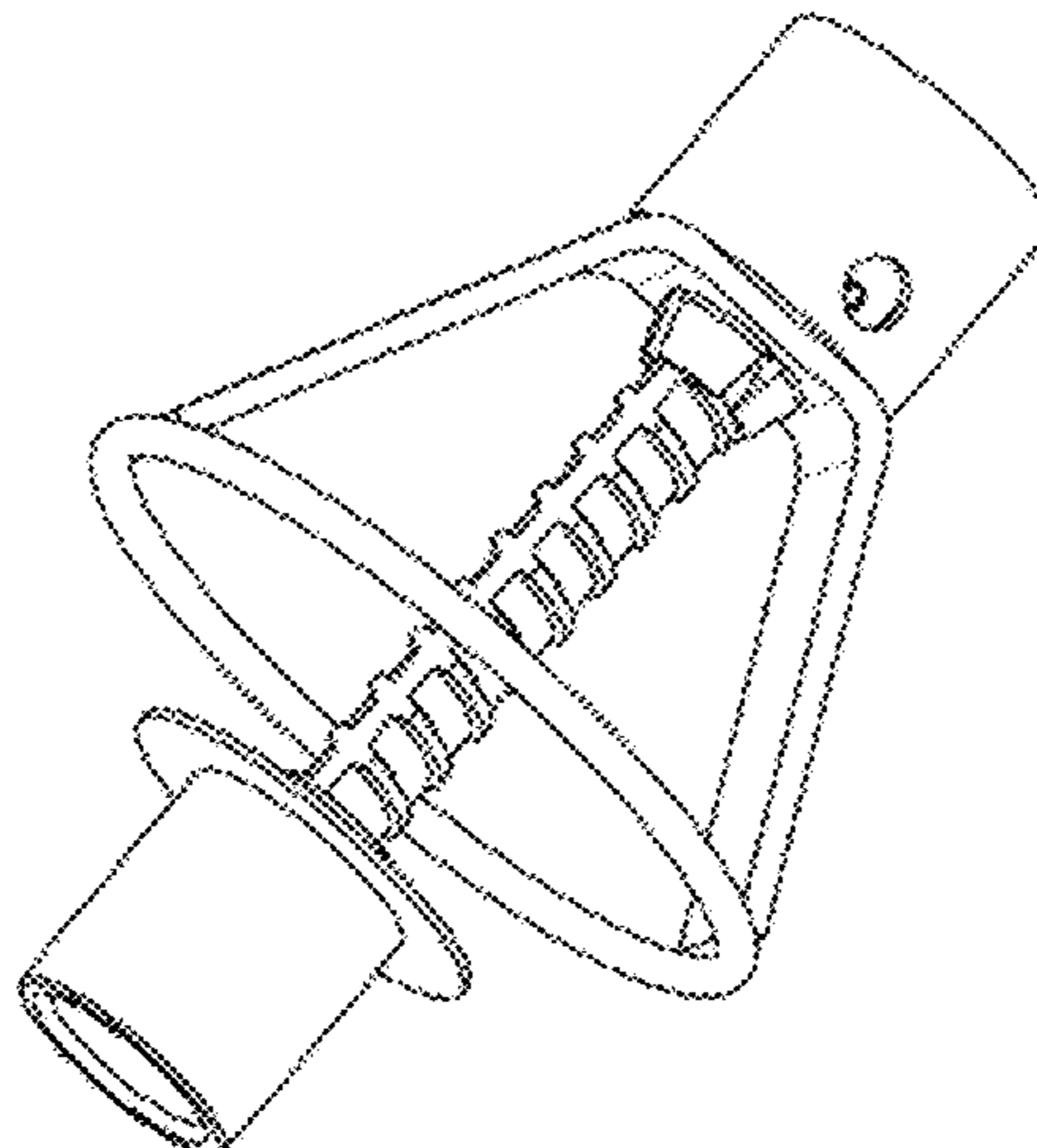
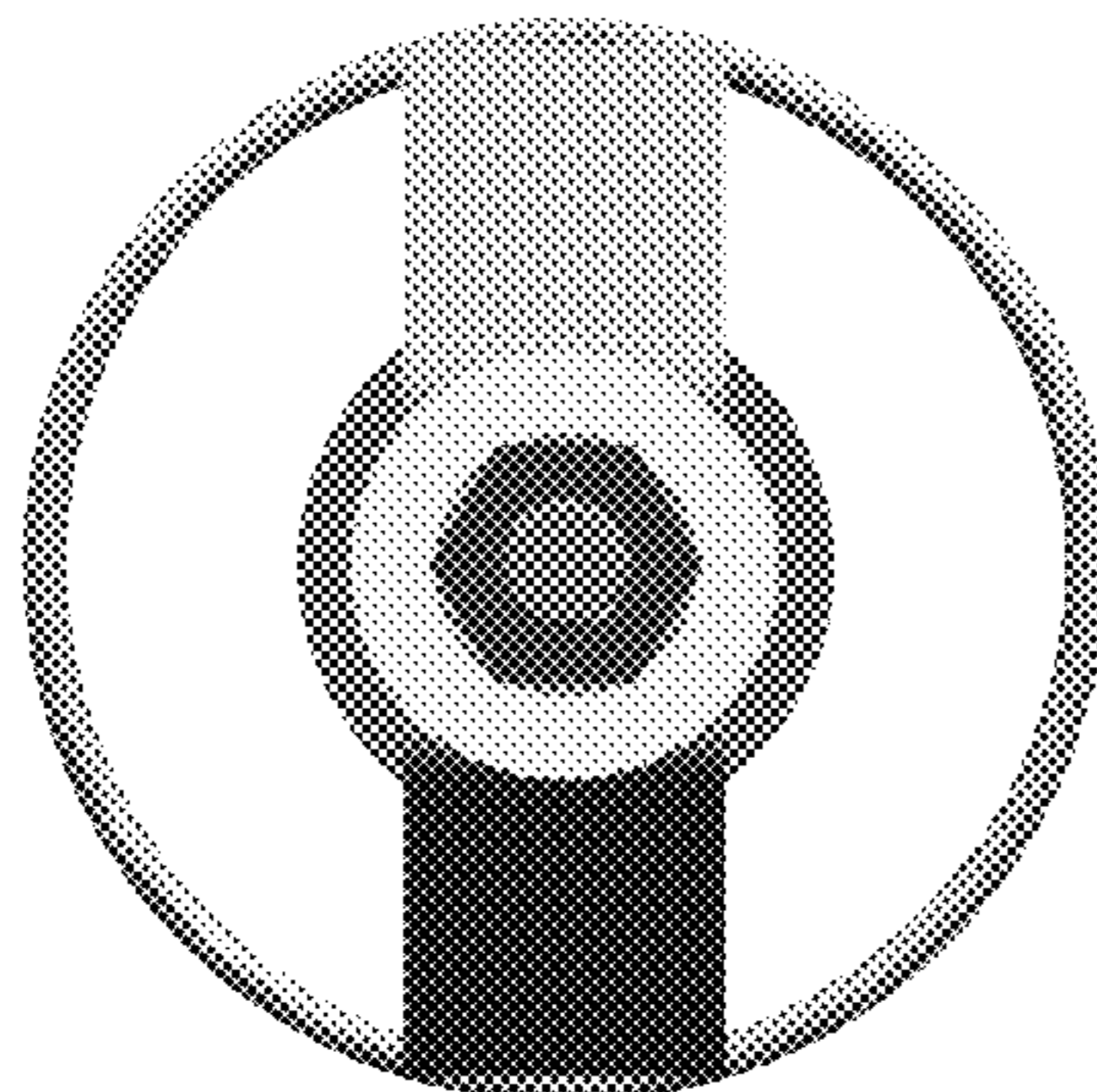

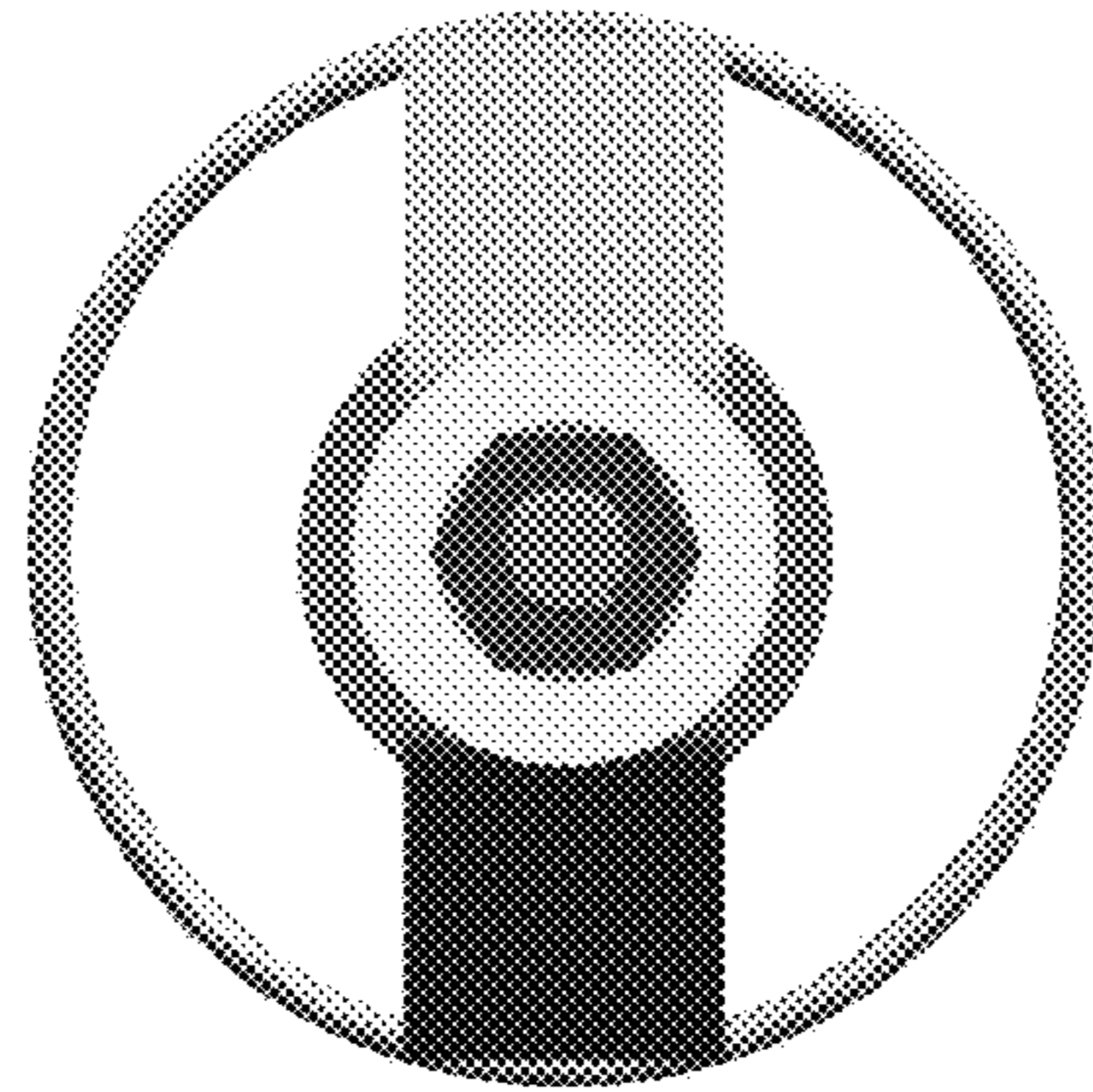

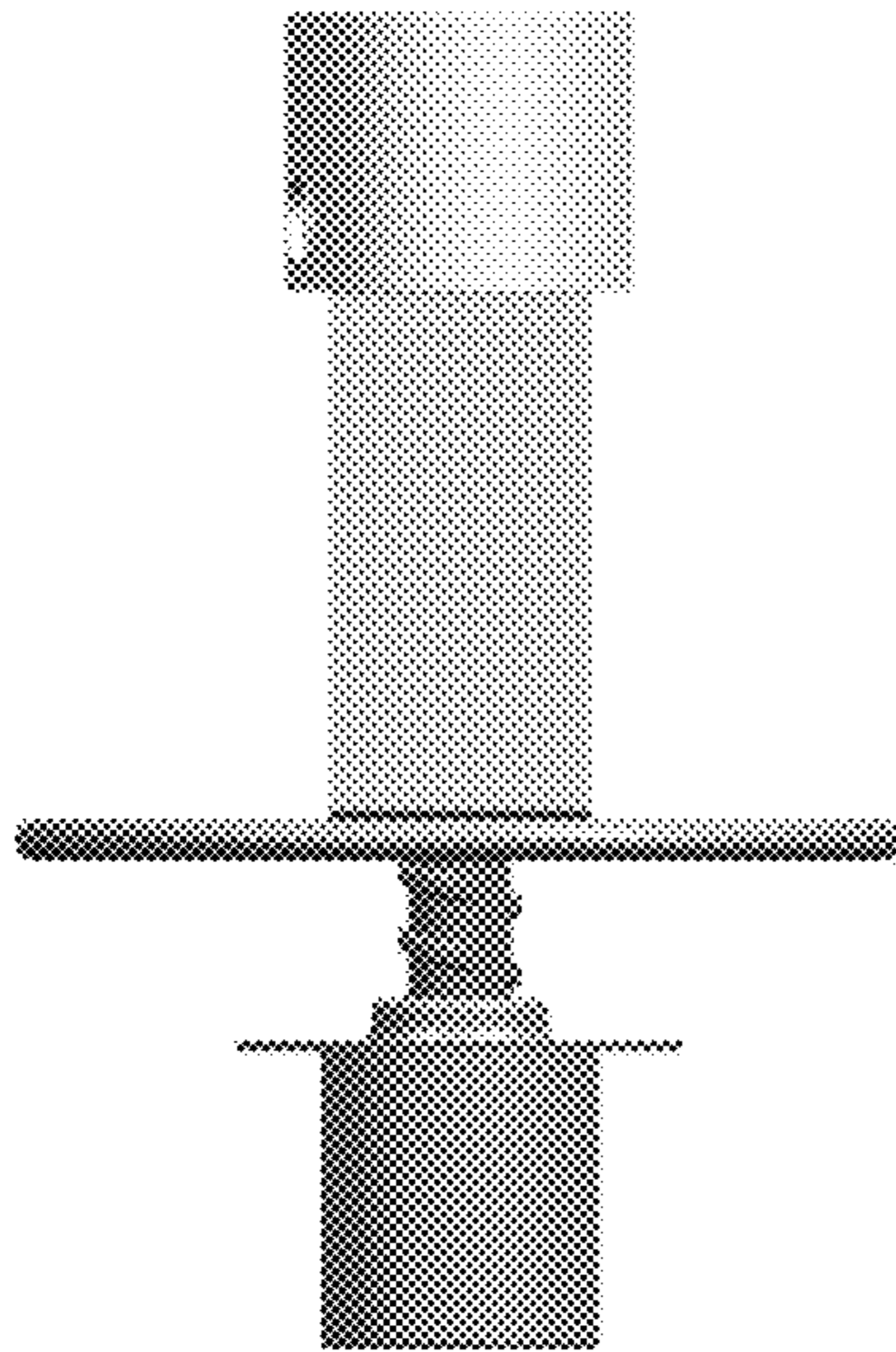

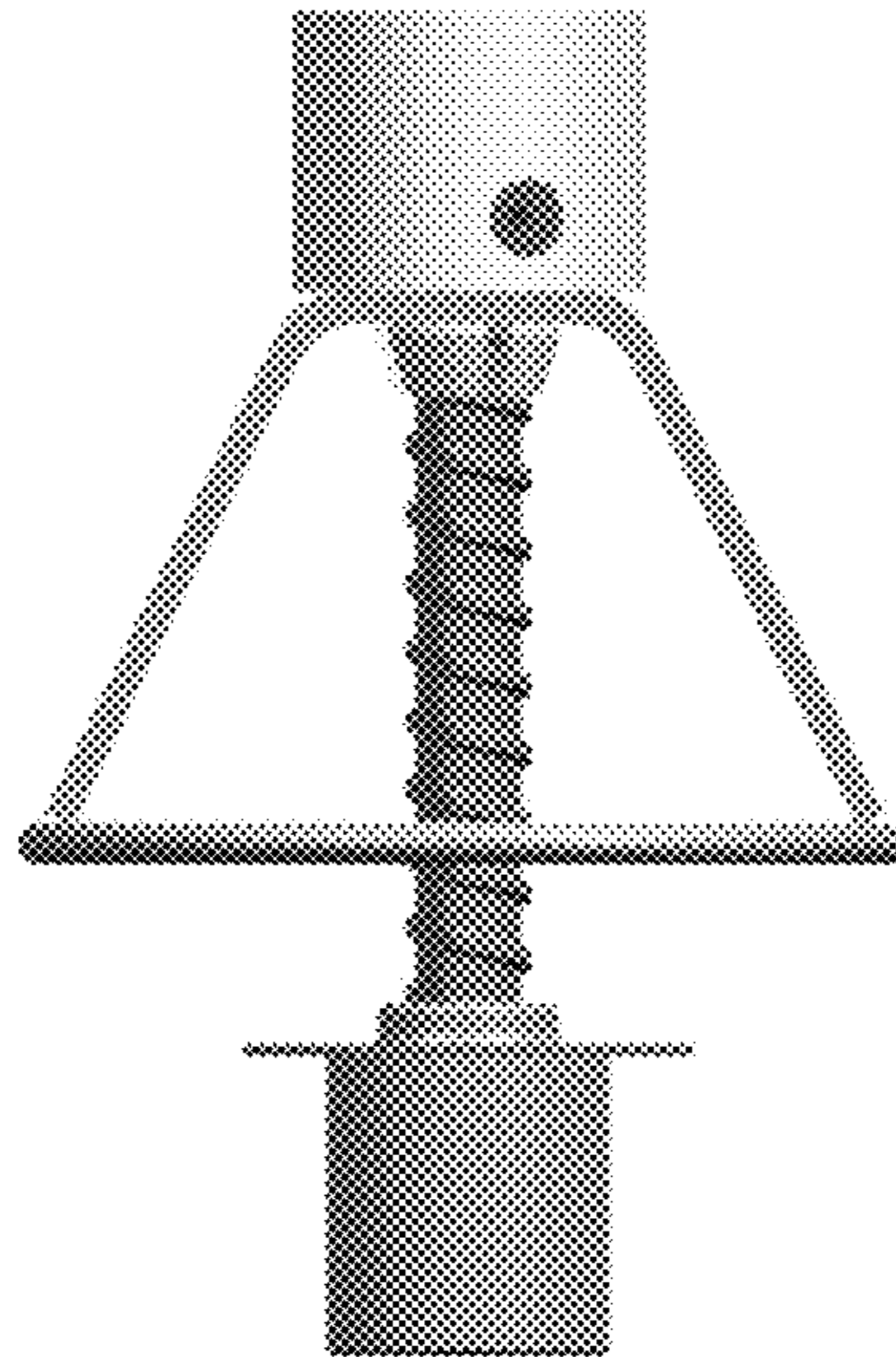

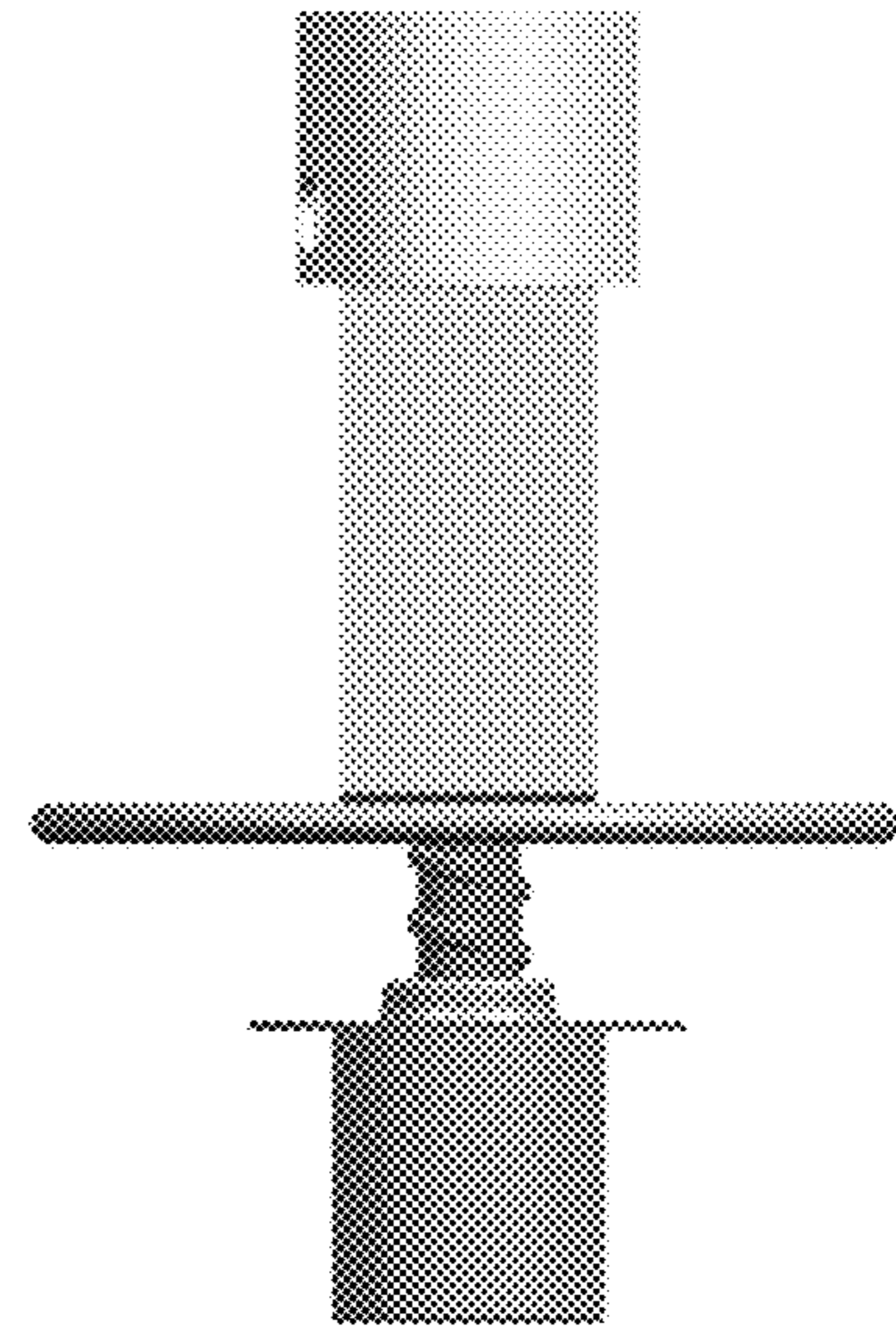

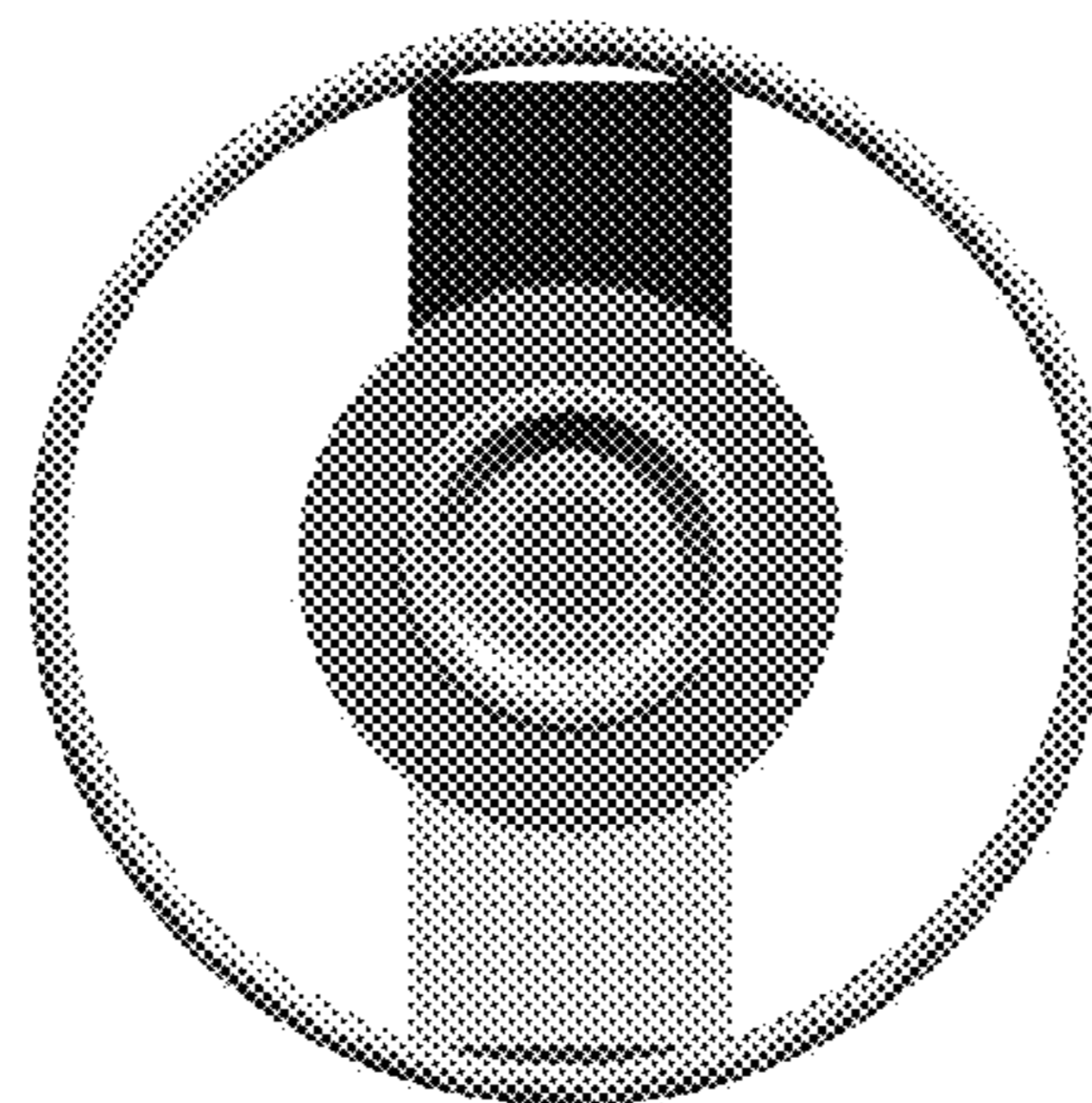

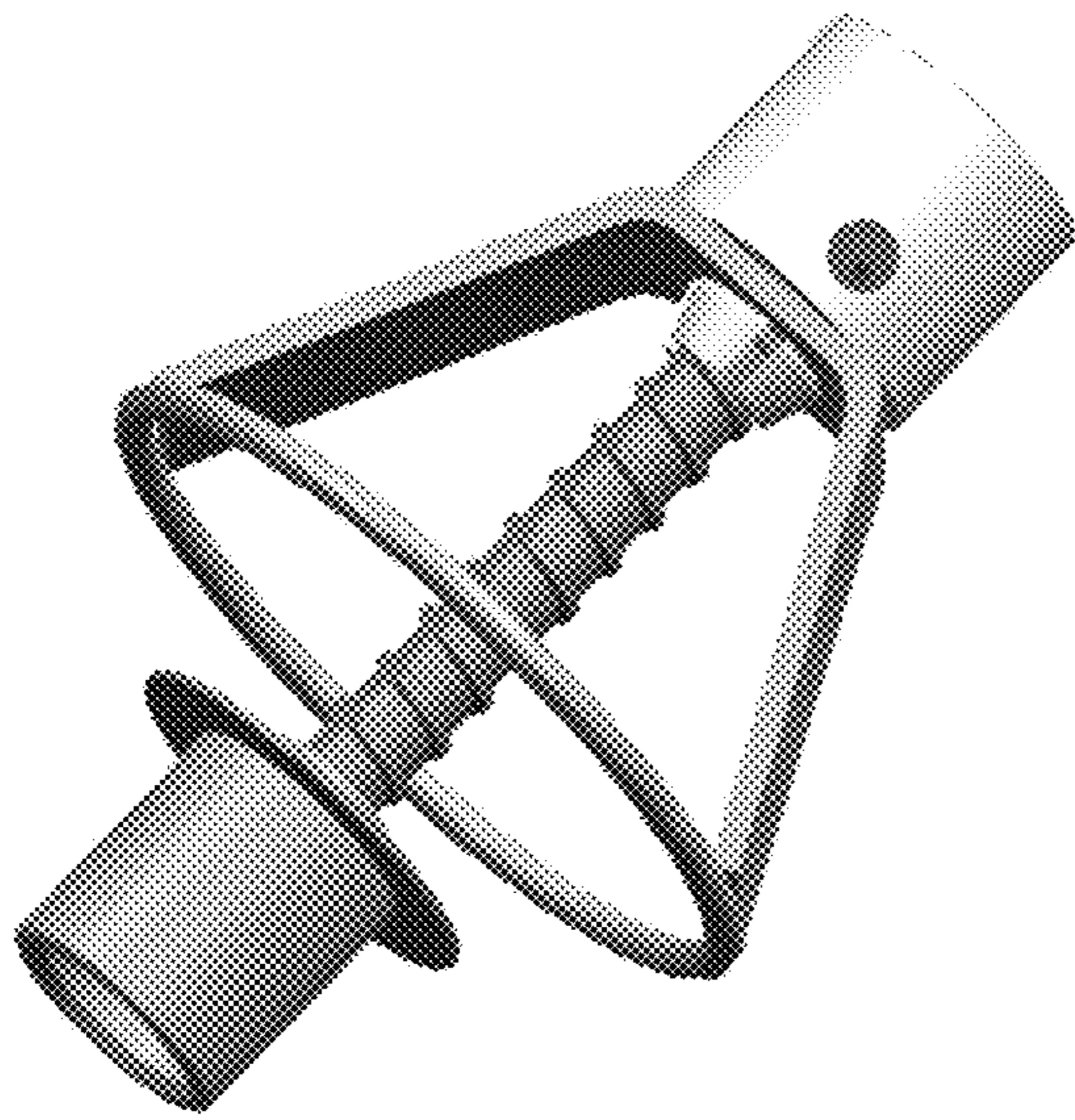

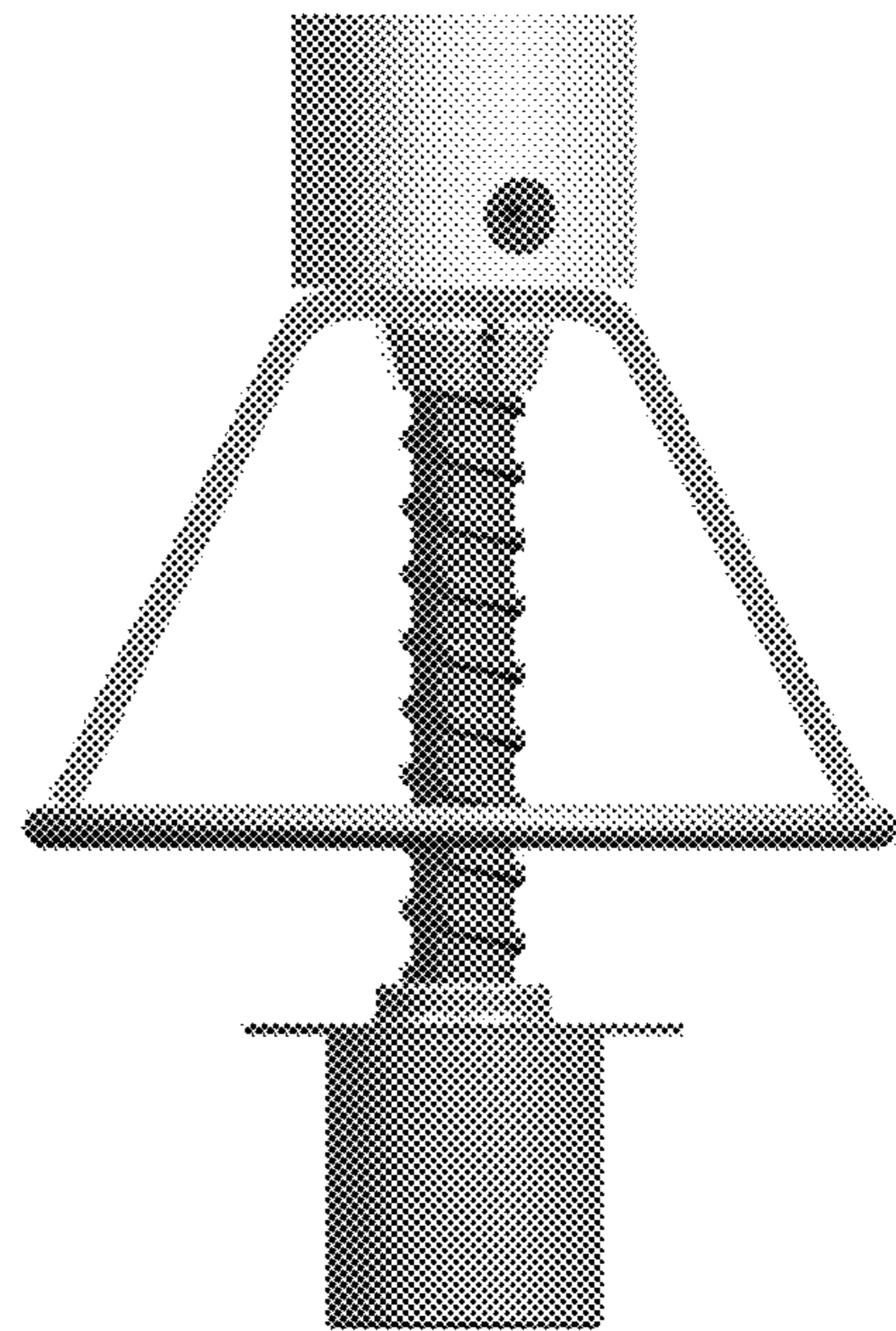

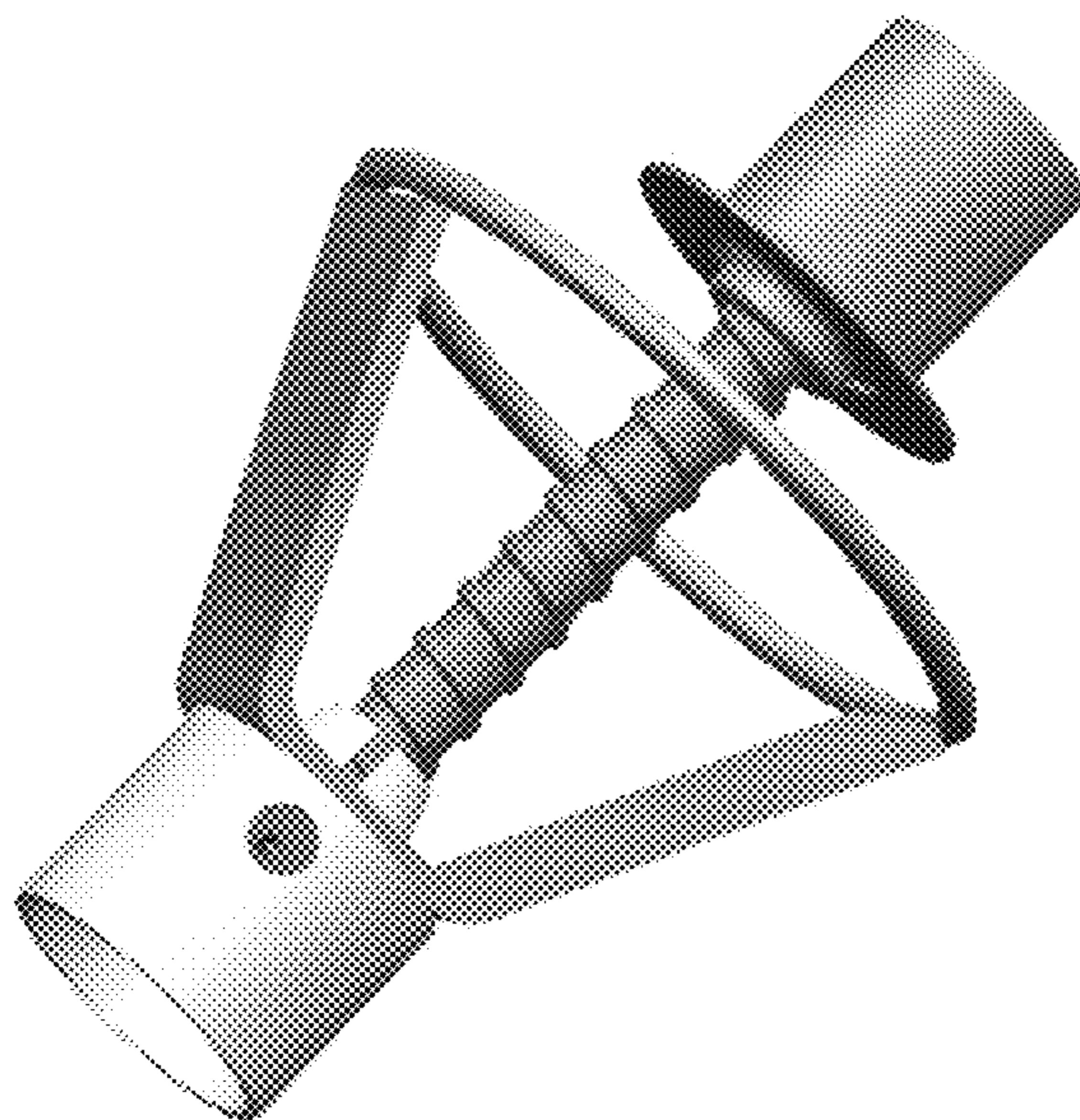

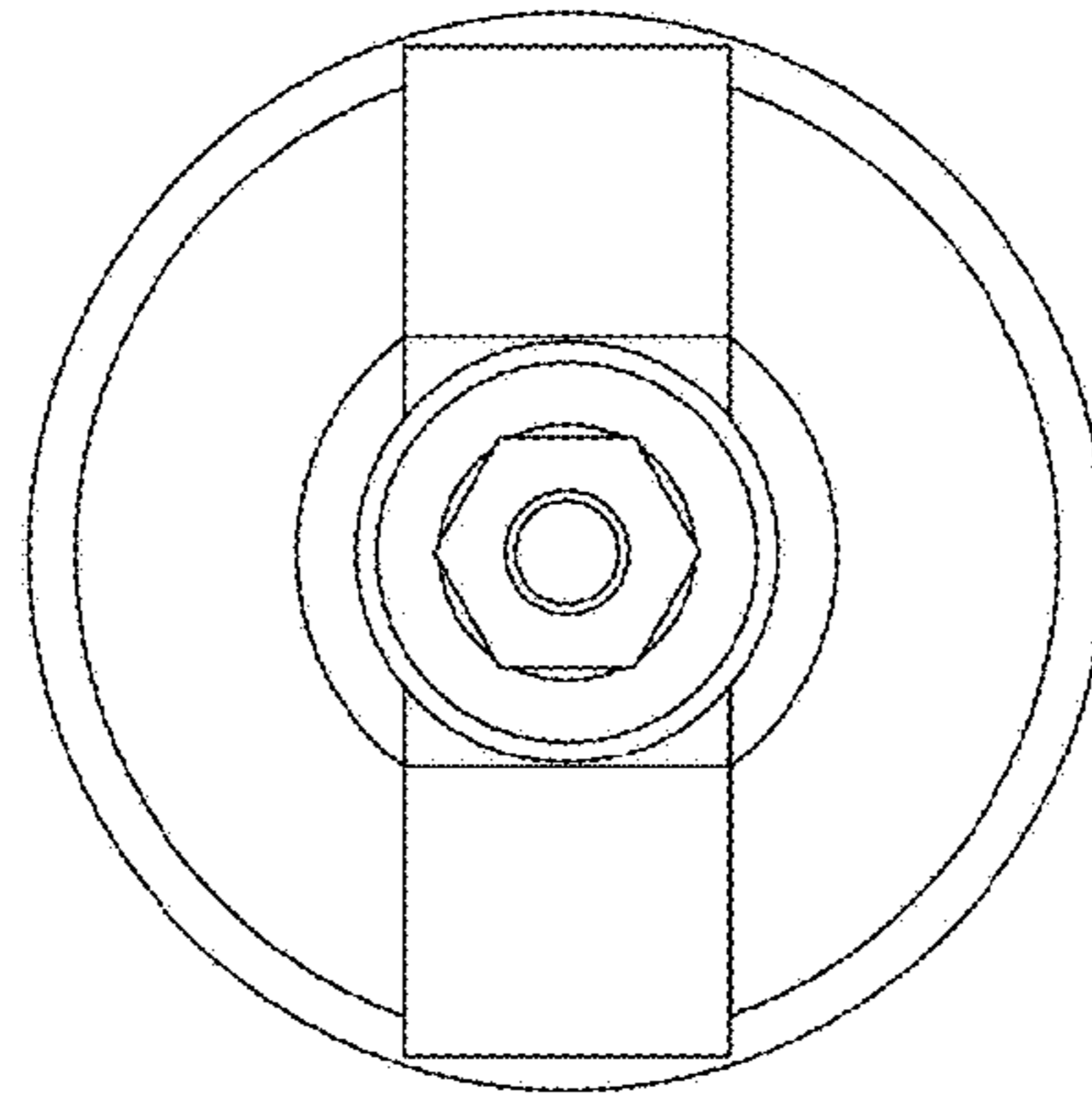

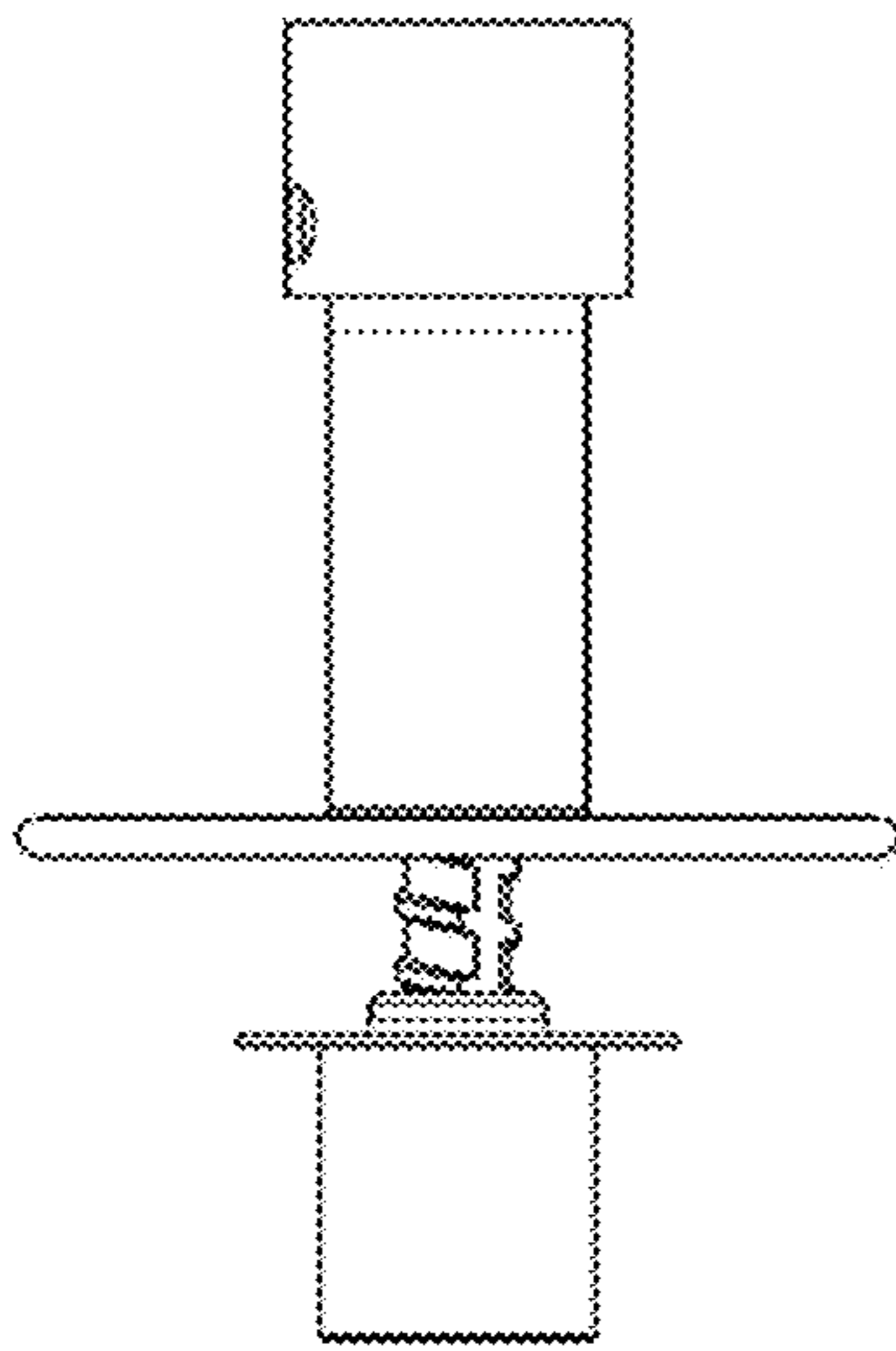

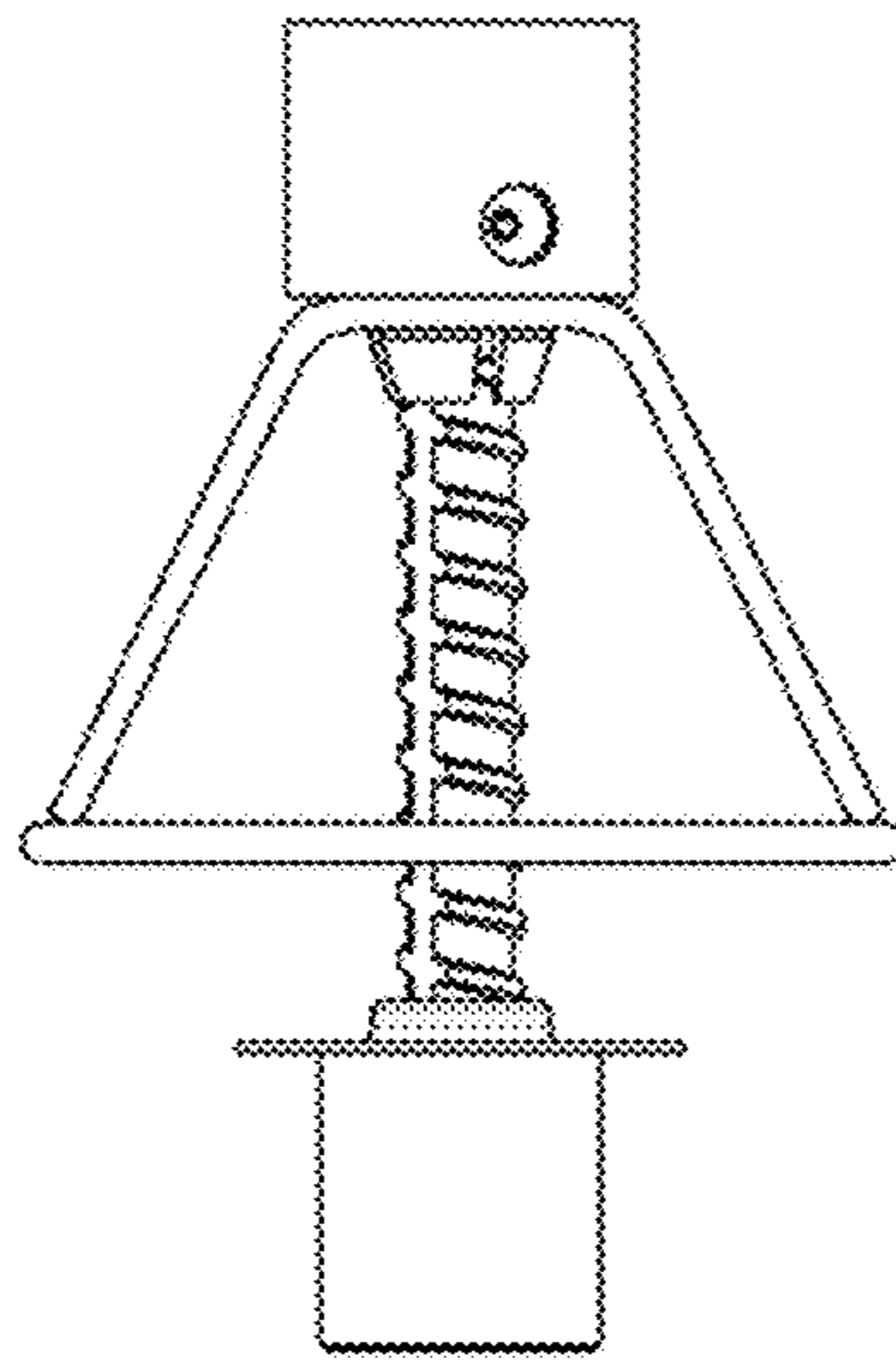

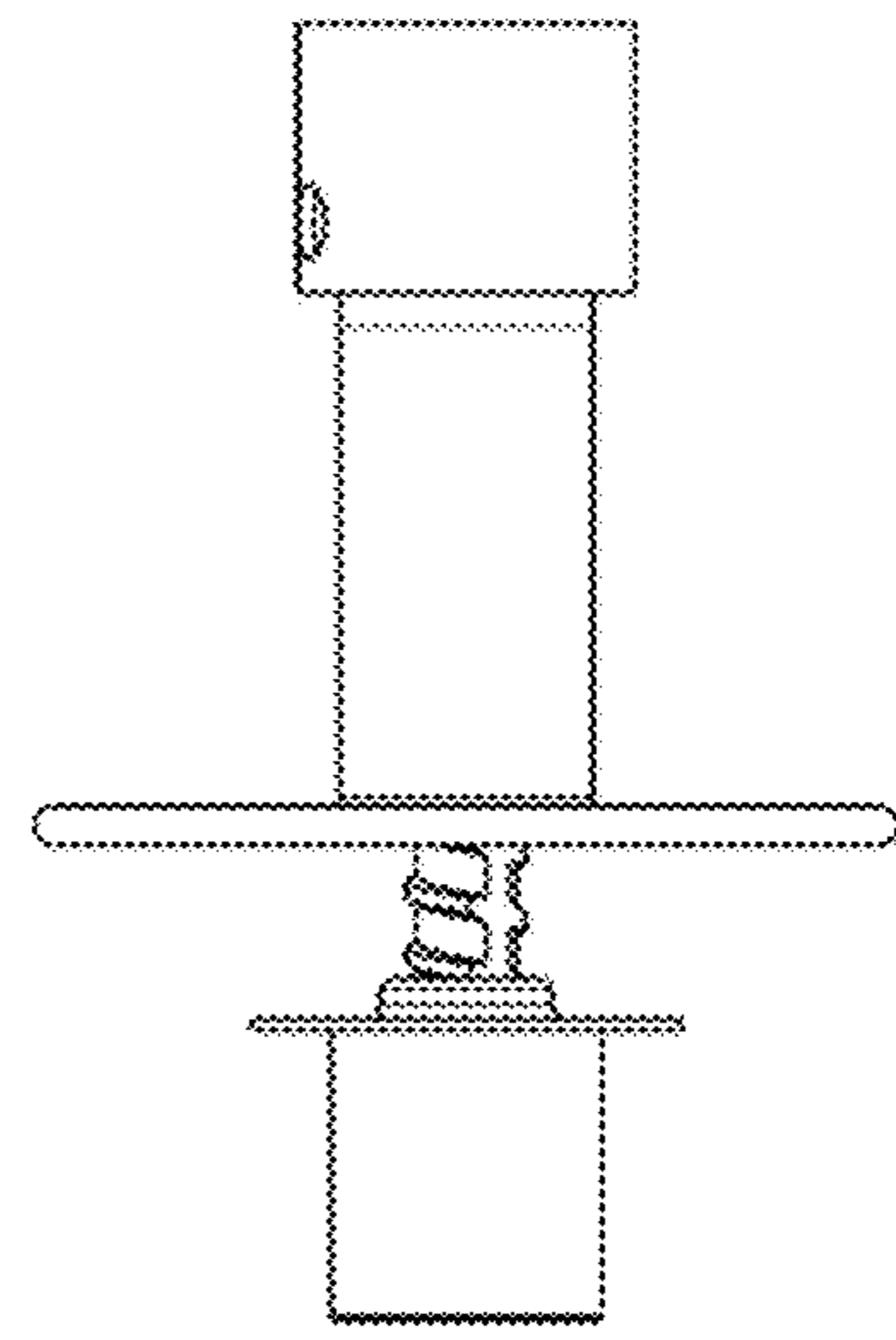

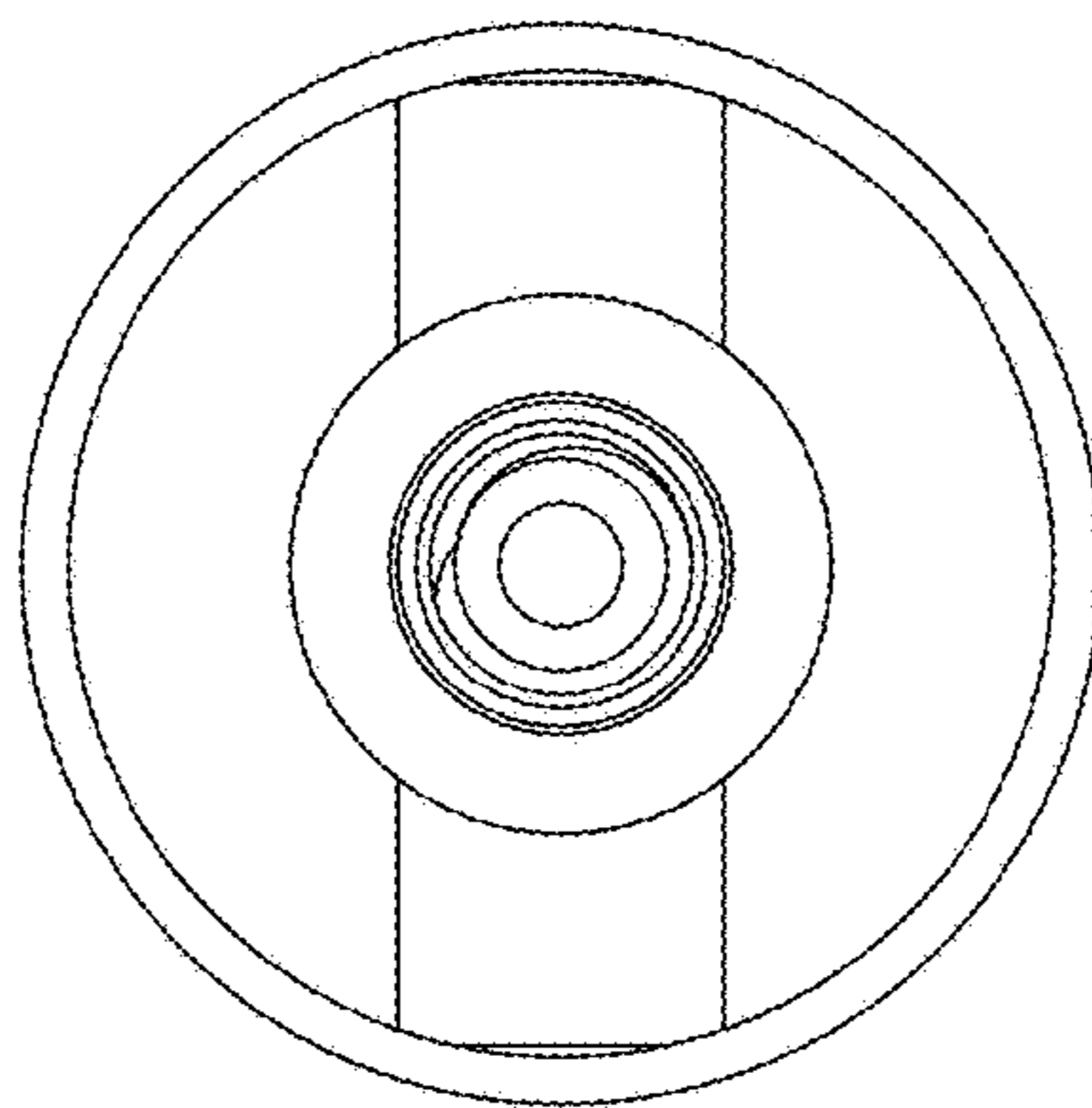

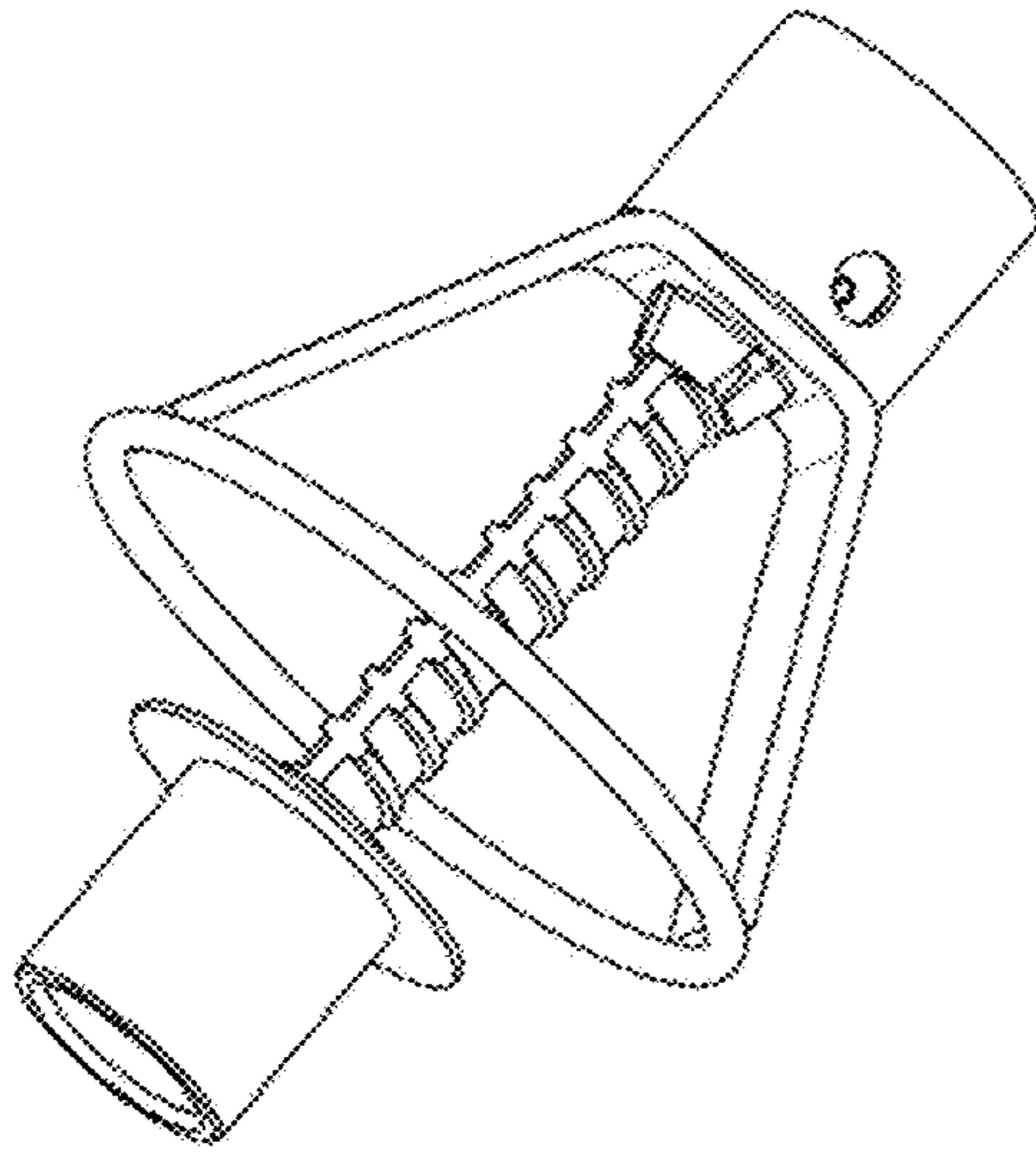

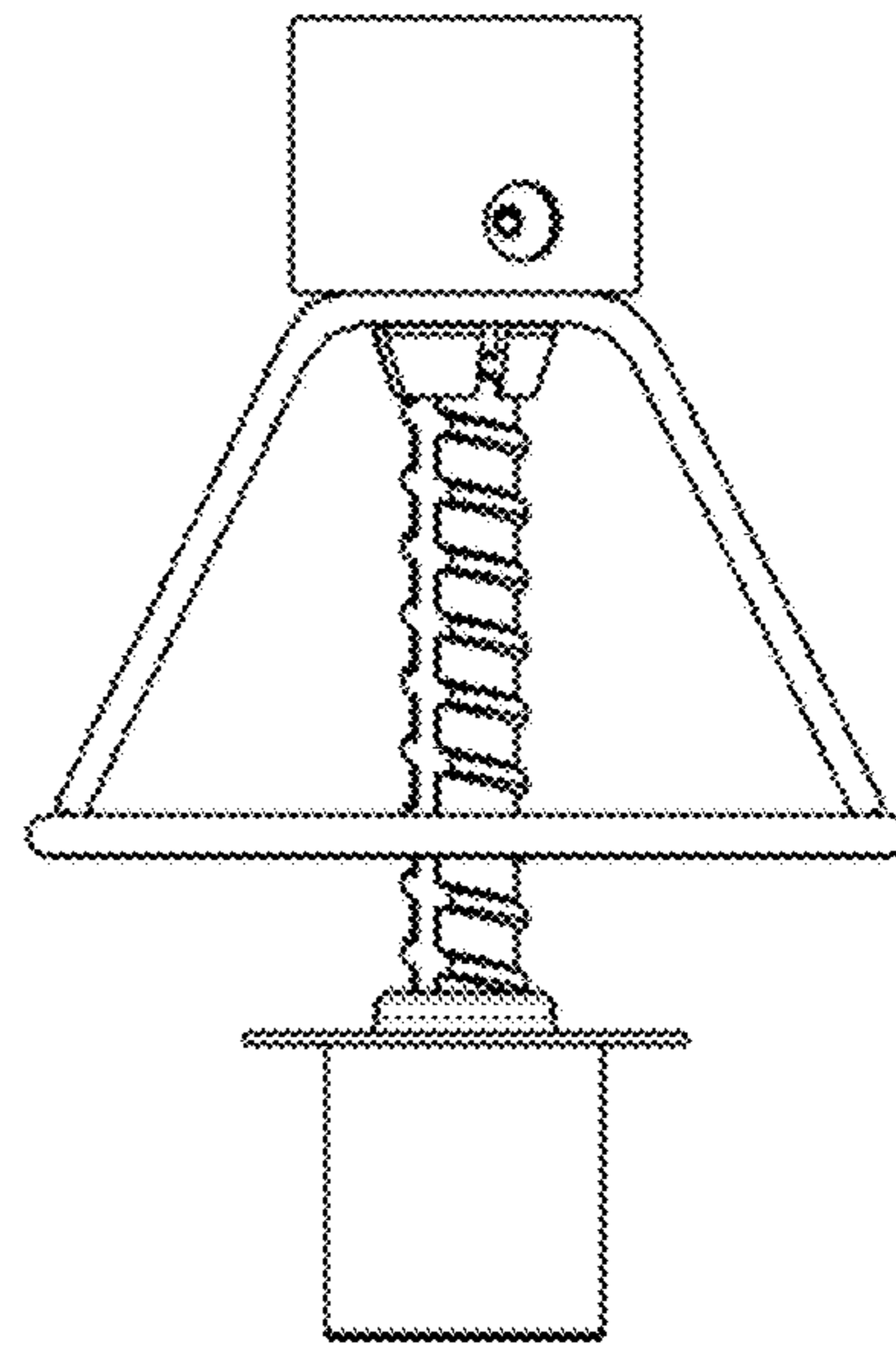

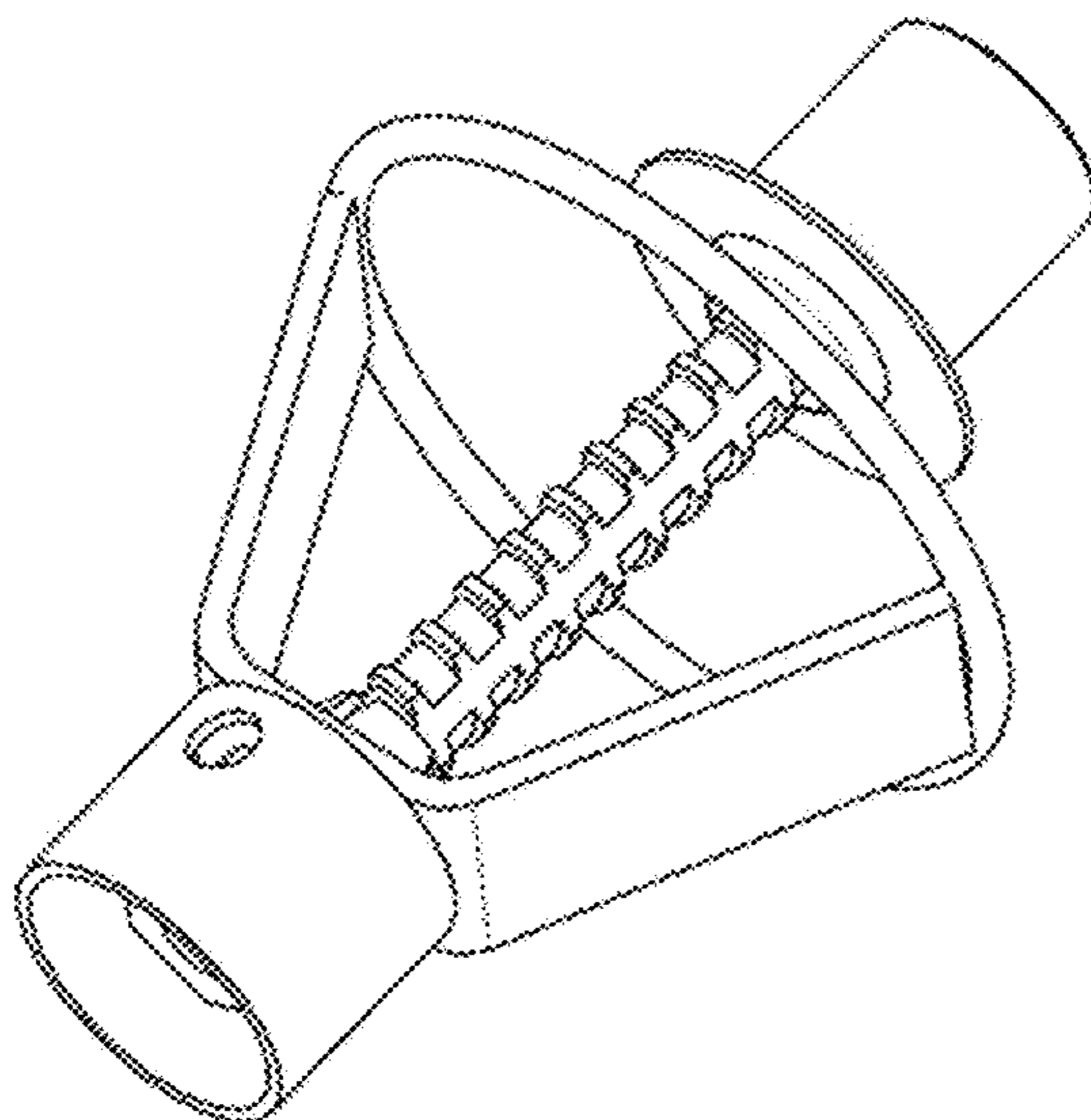
