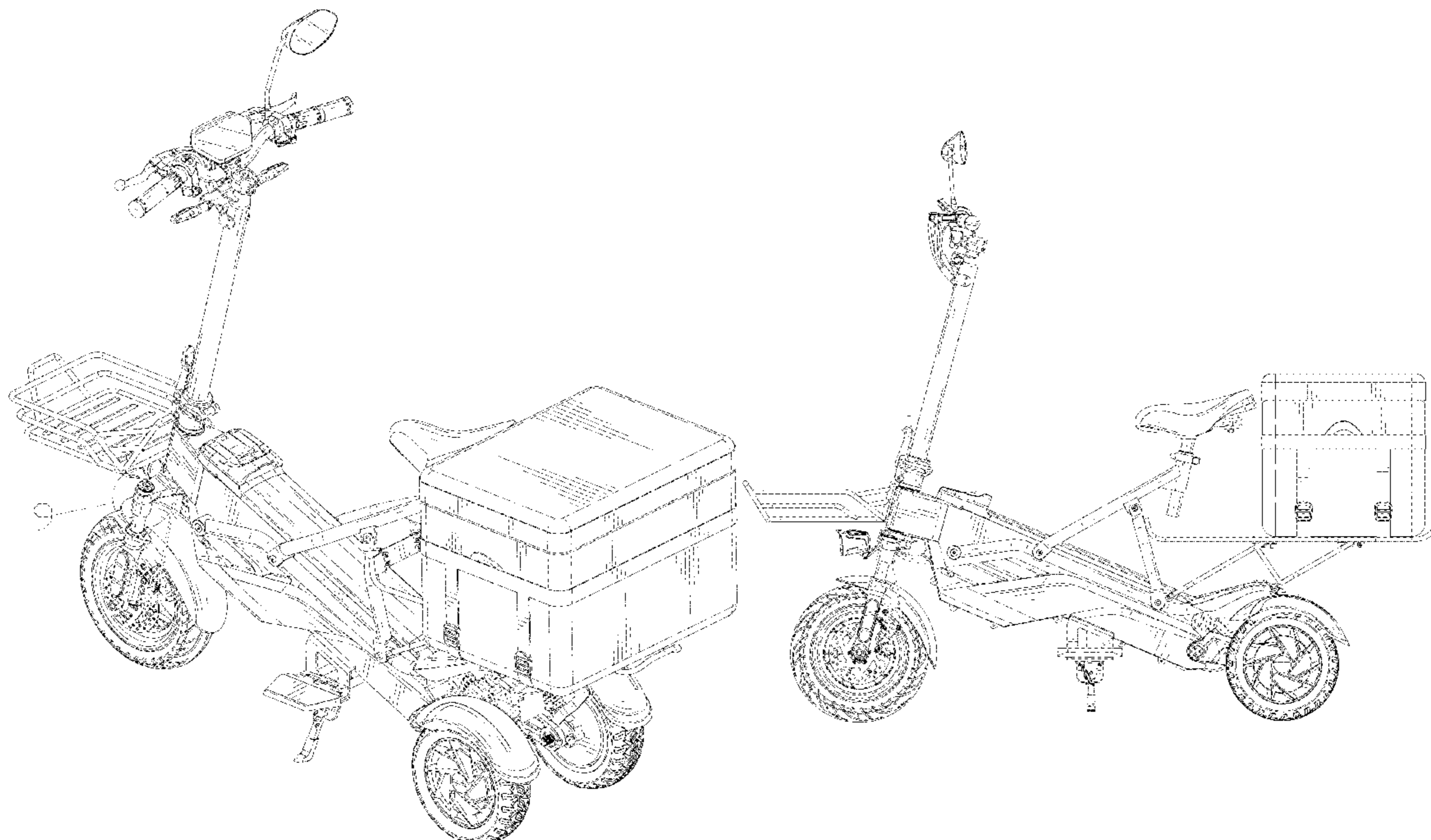
(57) **CLAIM**

The ornamental design for an electric tricycle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electric tricycle showing our new design;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a top plan view thereof;  
FIG. 8 is a bottom plan view thereof; and,  
FIG. 9 is an enlarged view of portion 9 shown in FIG. 1.  
The dash-dash broken lines in the drawings depict portions of the electric tricycle that form no part of the claimed design. The dot-dash broken lines represent the boundary of the enlarged portion and form no part of the claimed design.

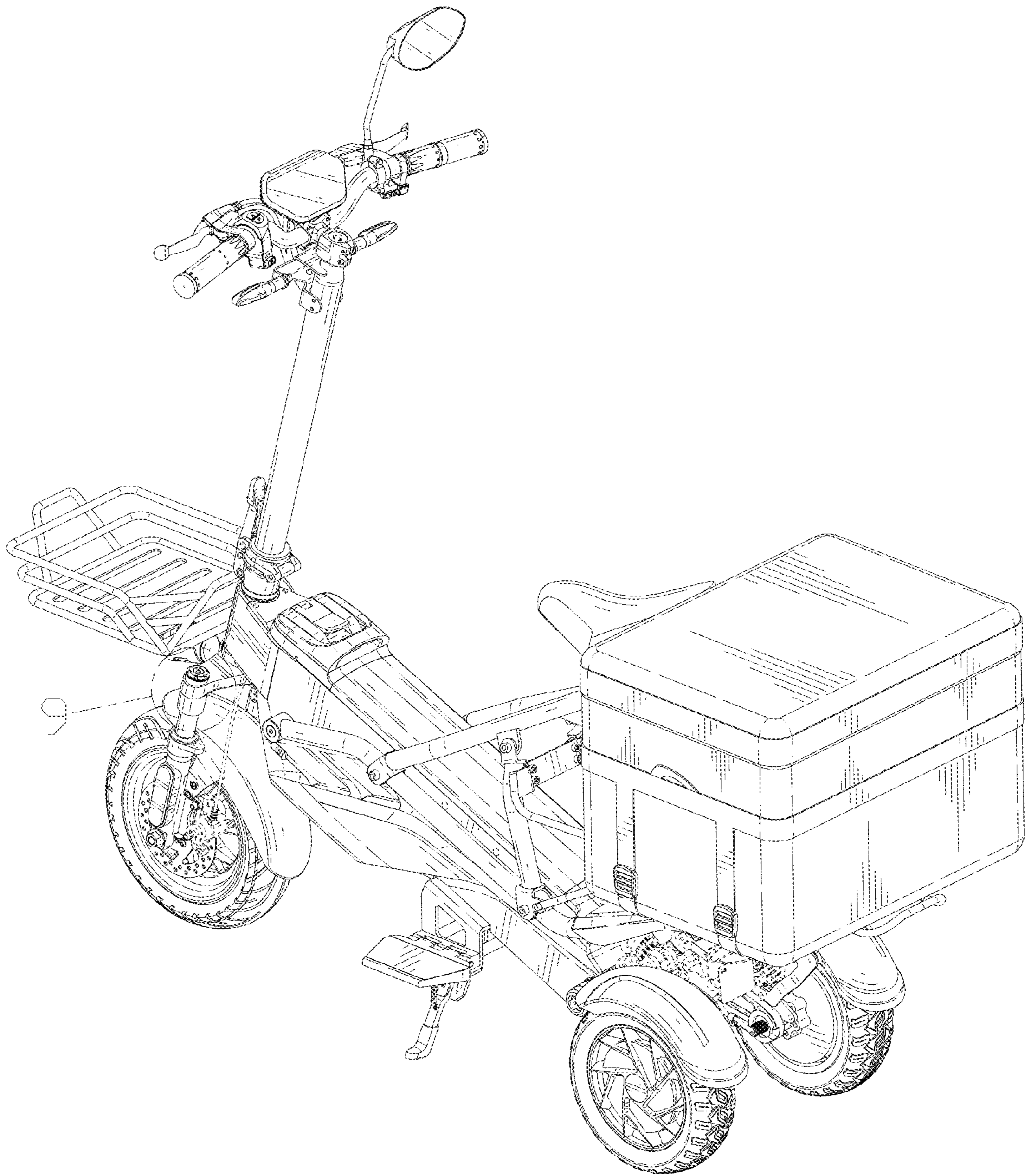

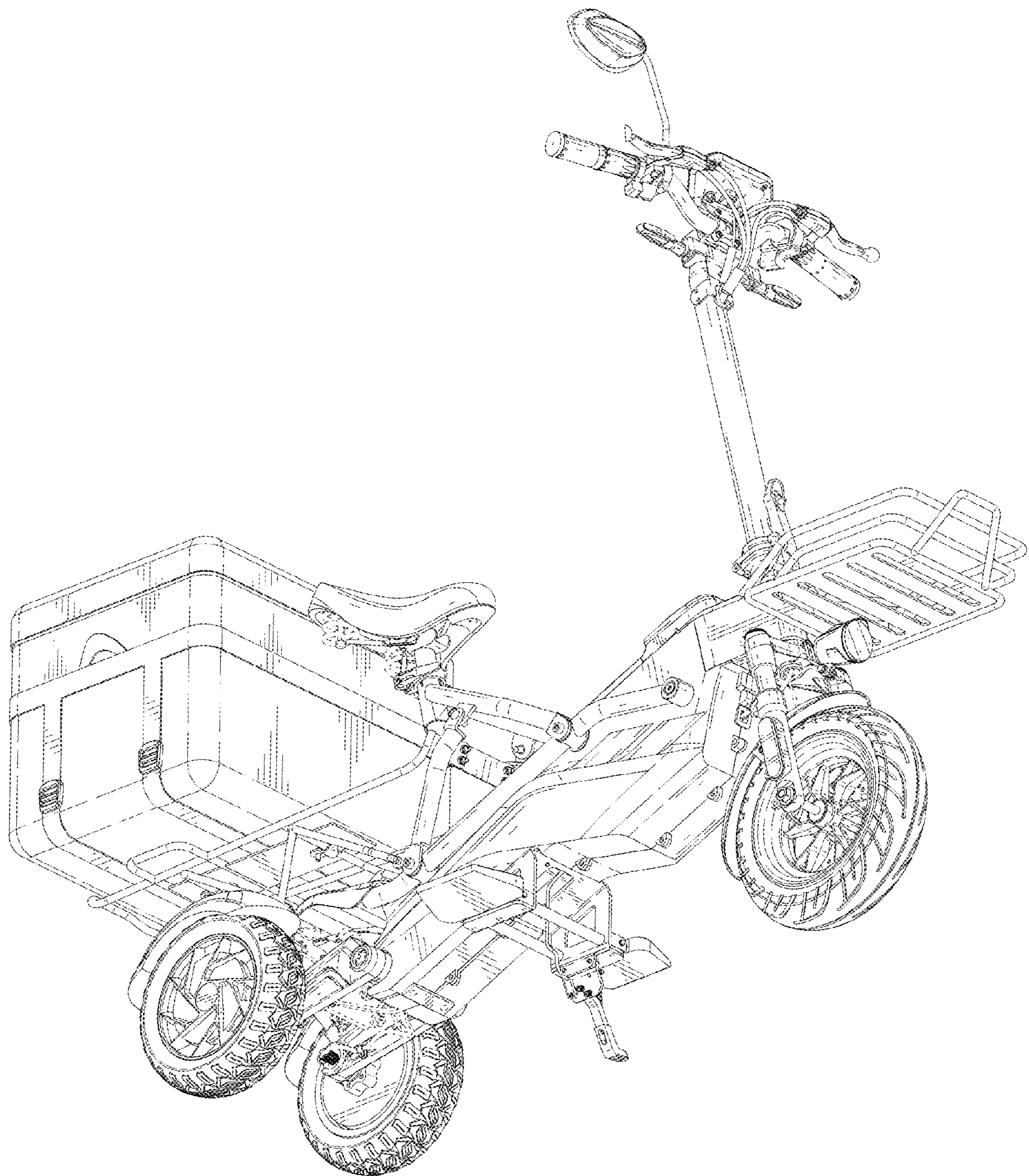

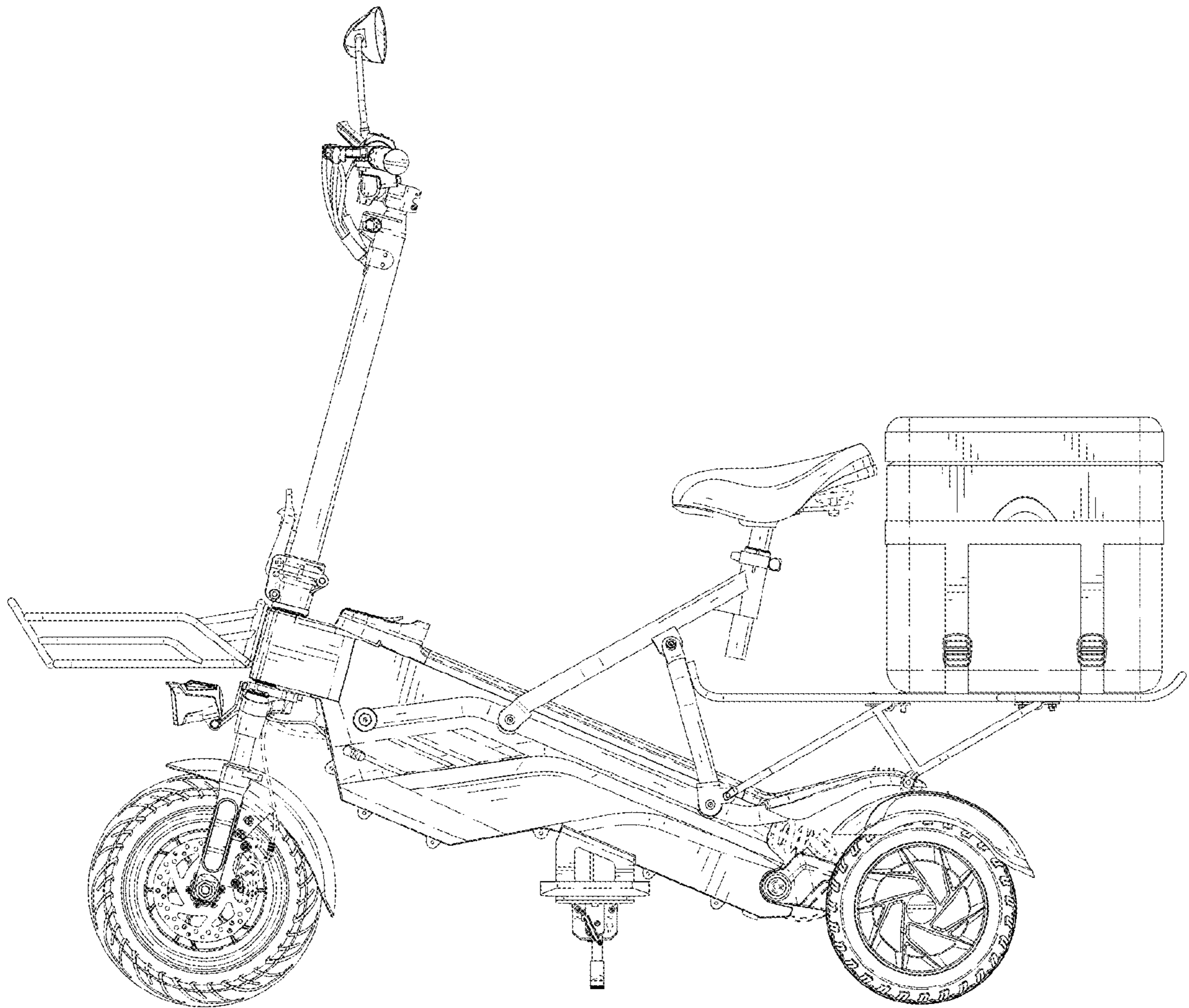

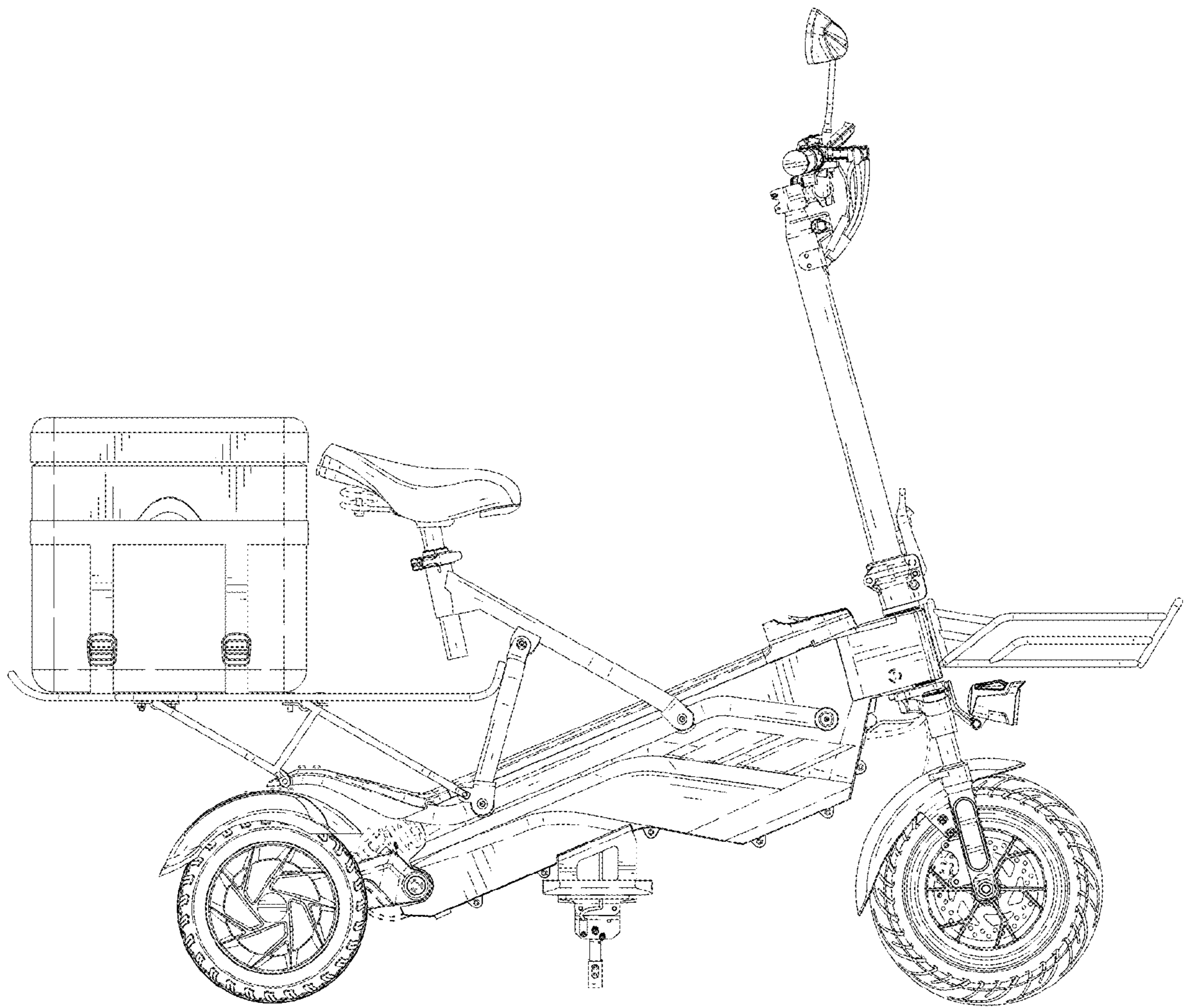

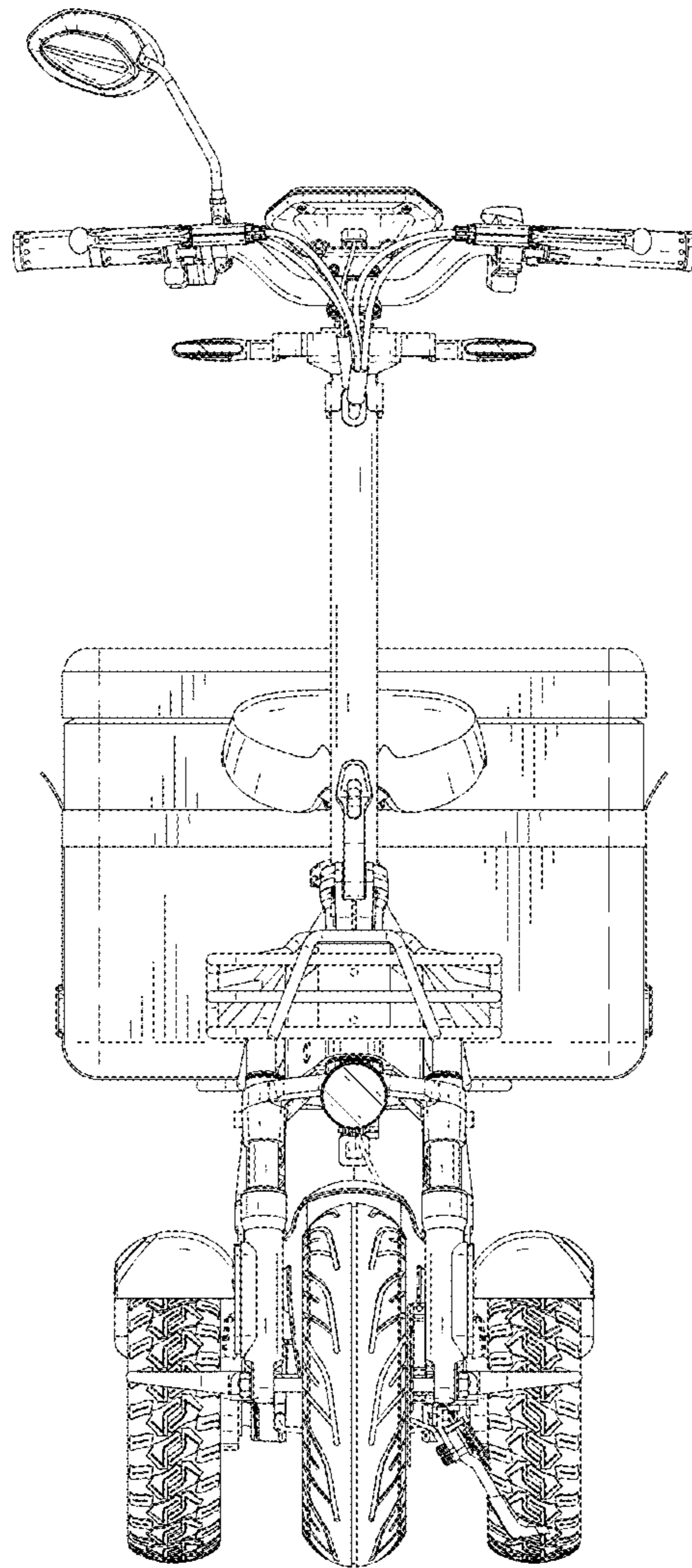

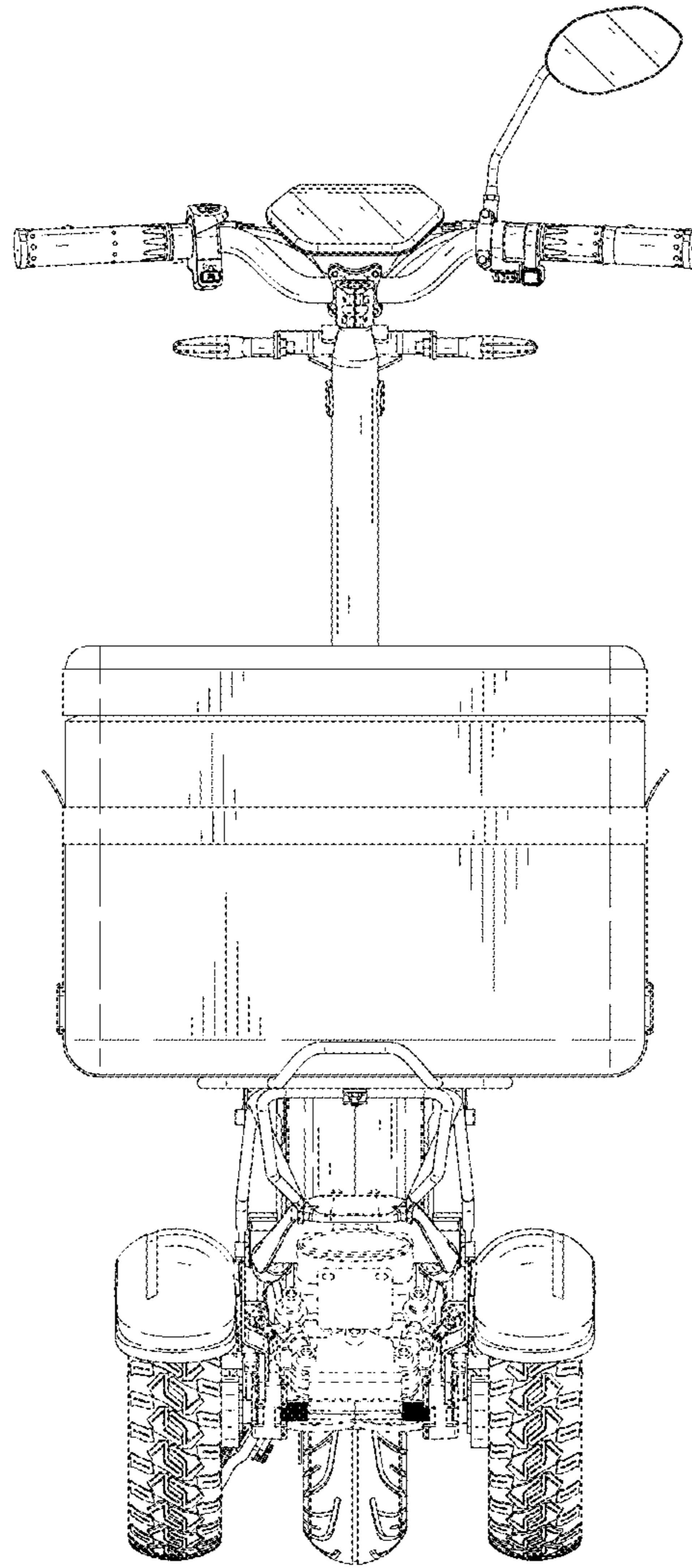

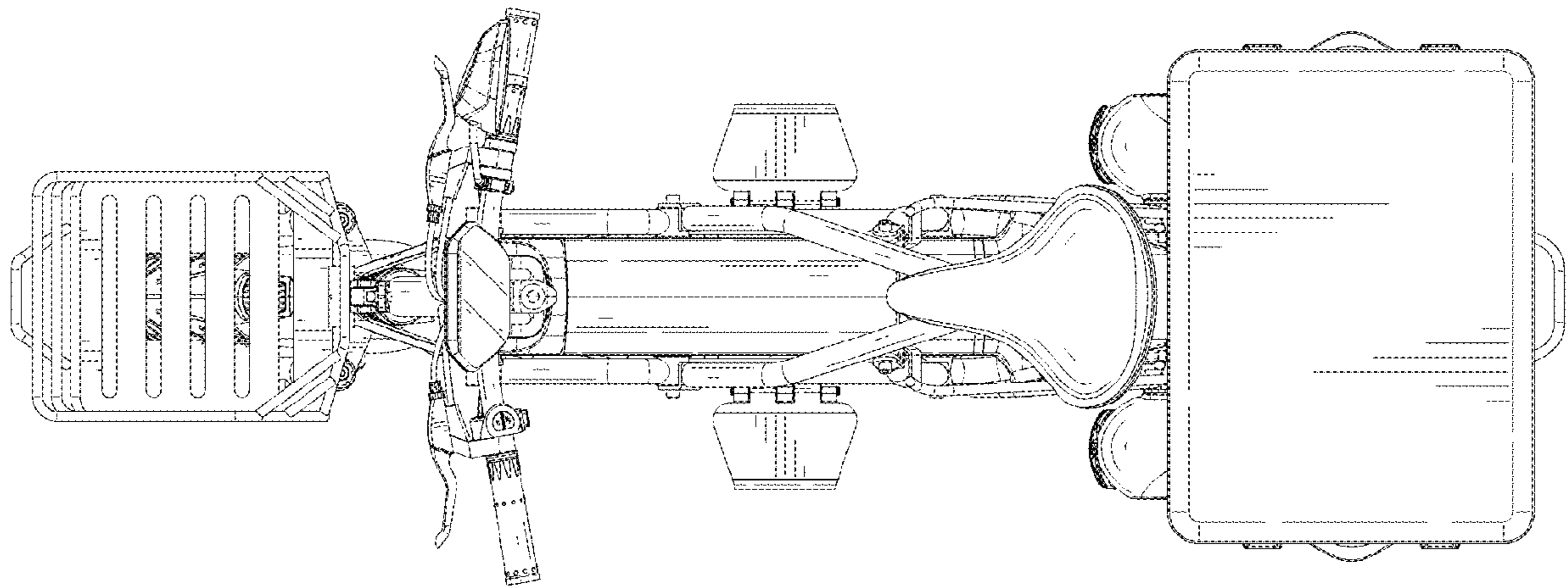

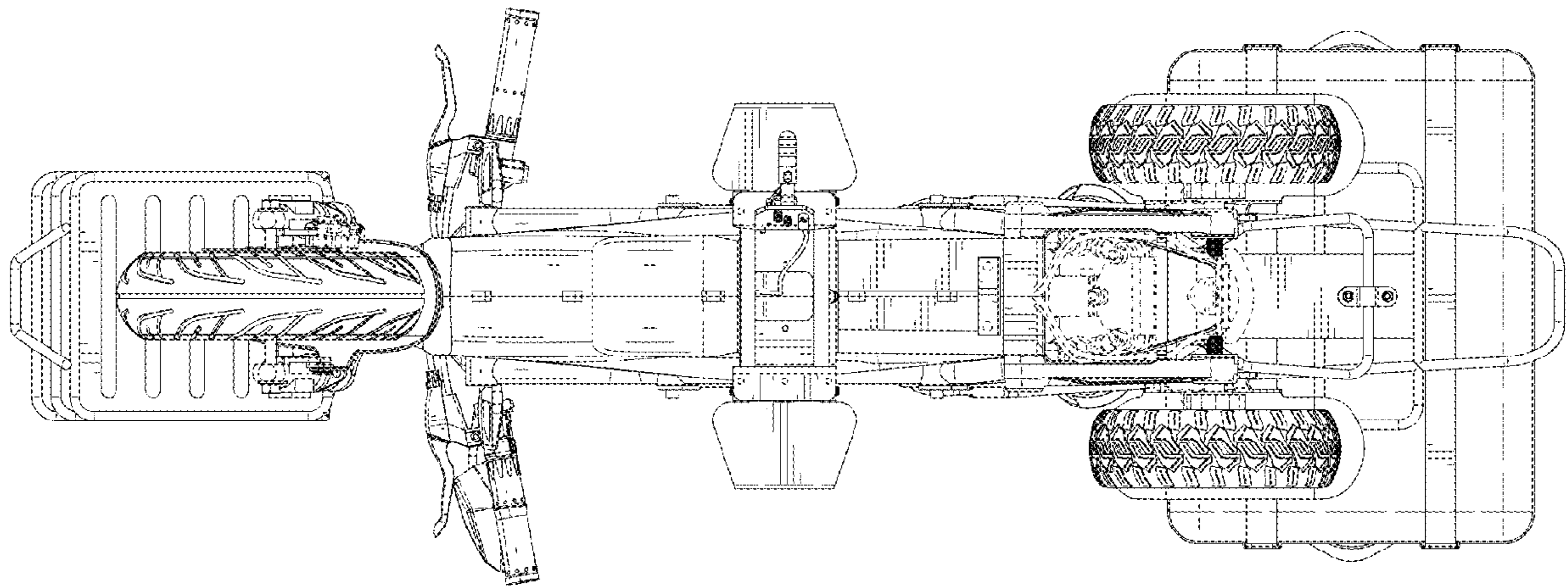

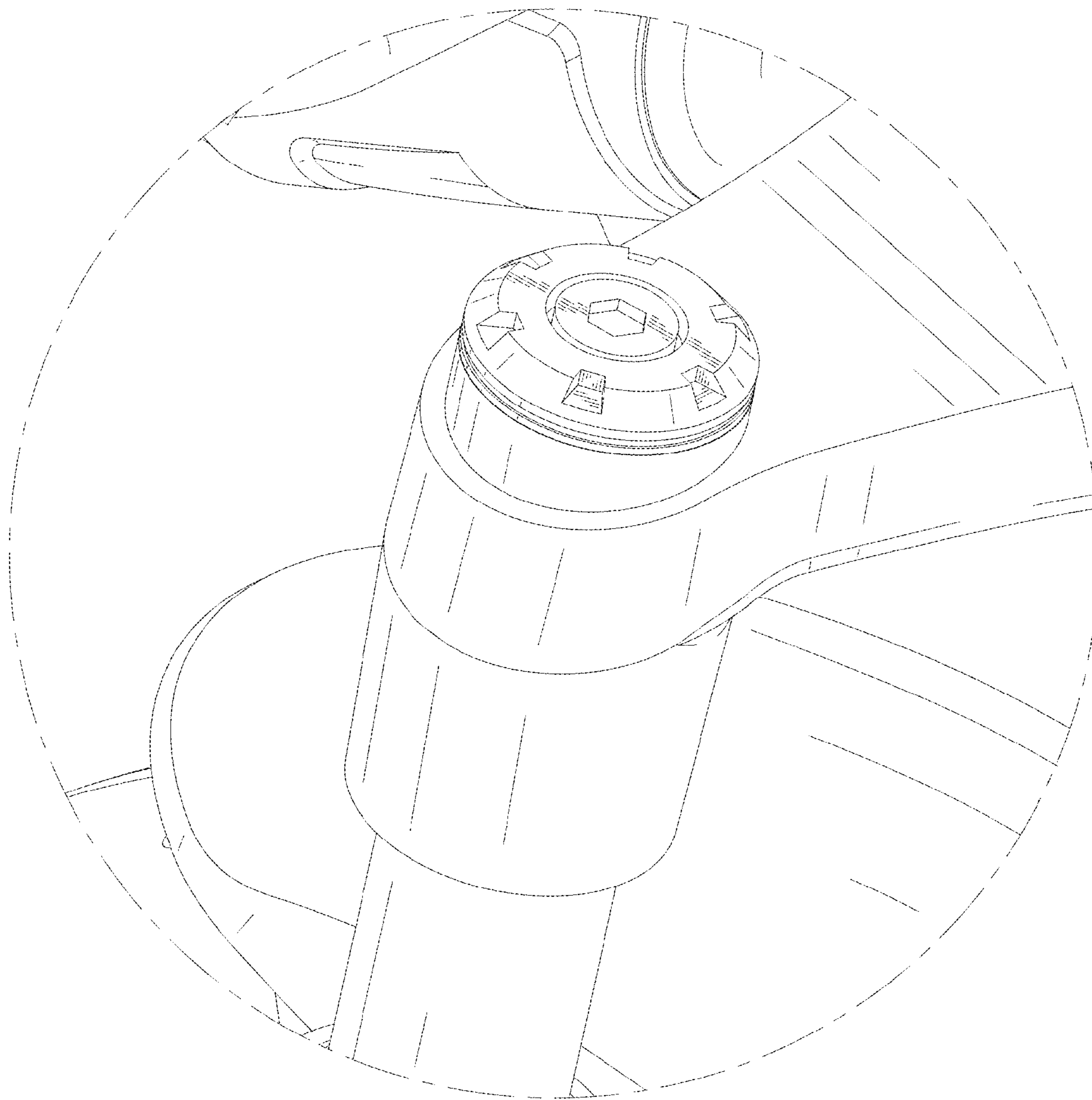
