This application contains subject matter related to the following co-pending U.S. design patent application:

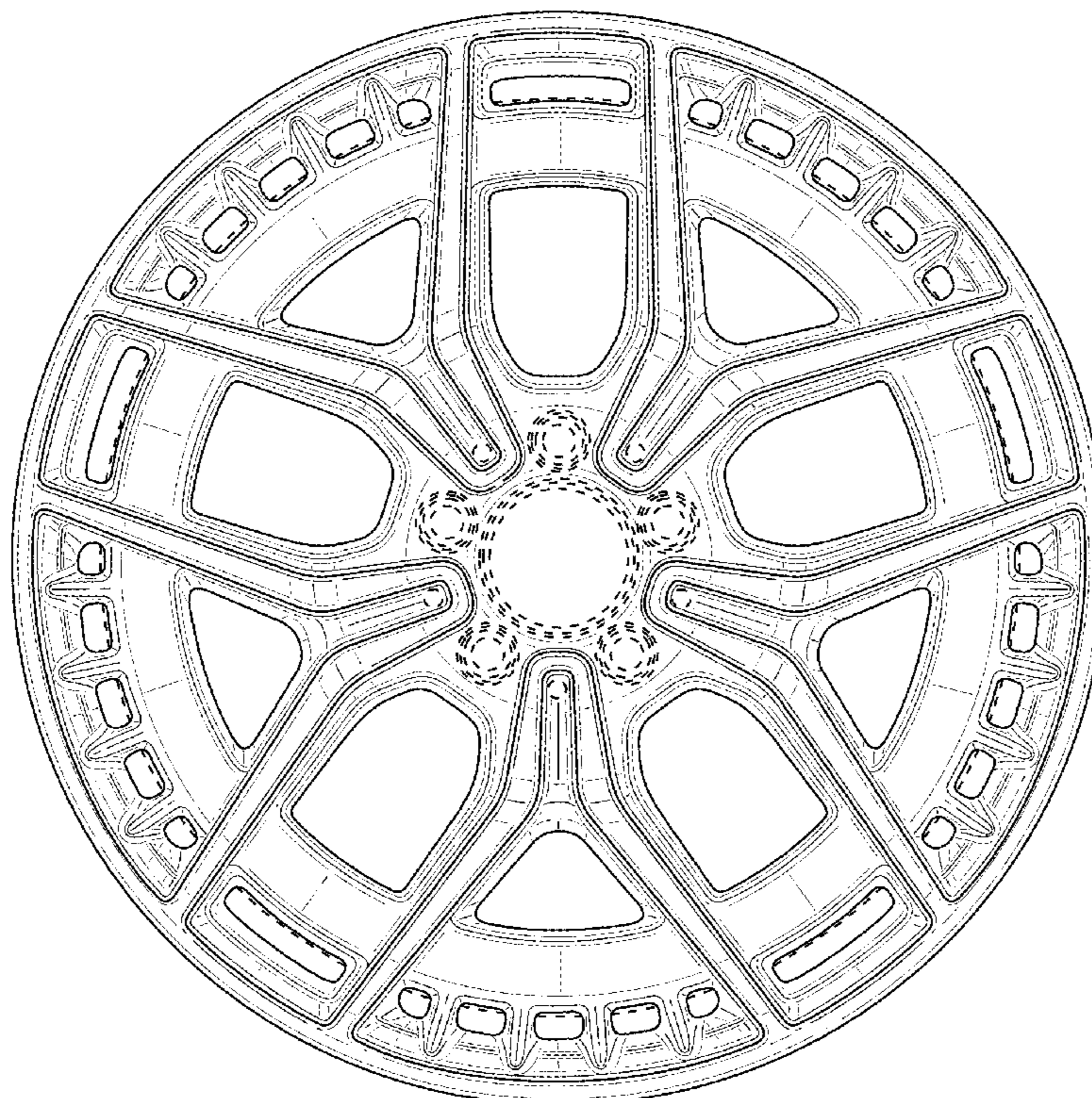
Application Ser. No. 29/741,672, filed Jul. 15, 2020 and entitled “Wheel or Wheel Cover.”

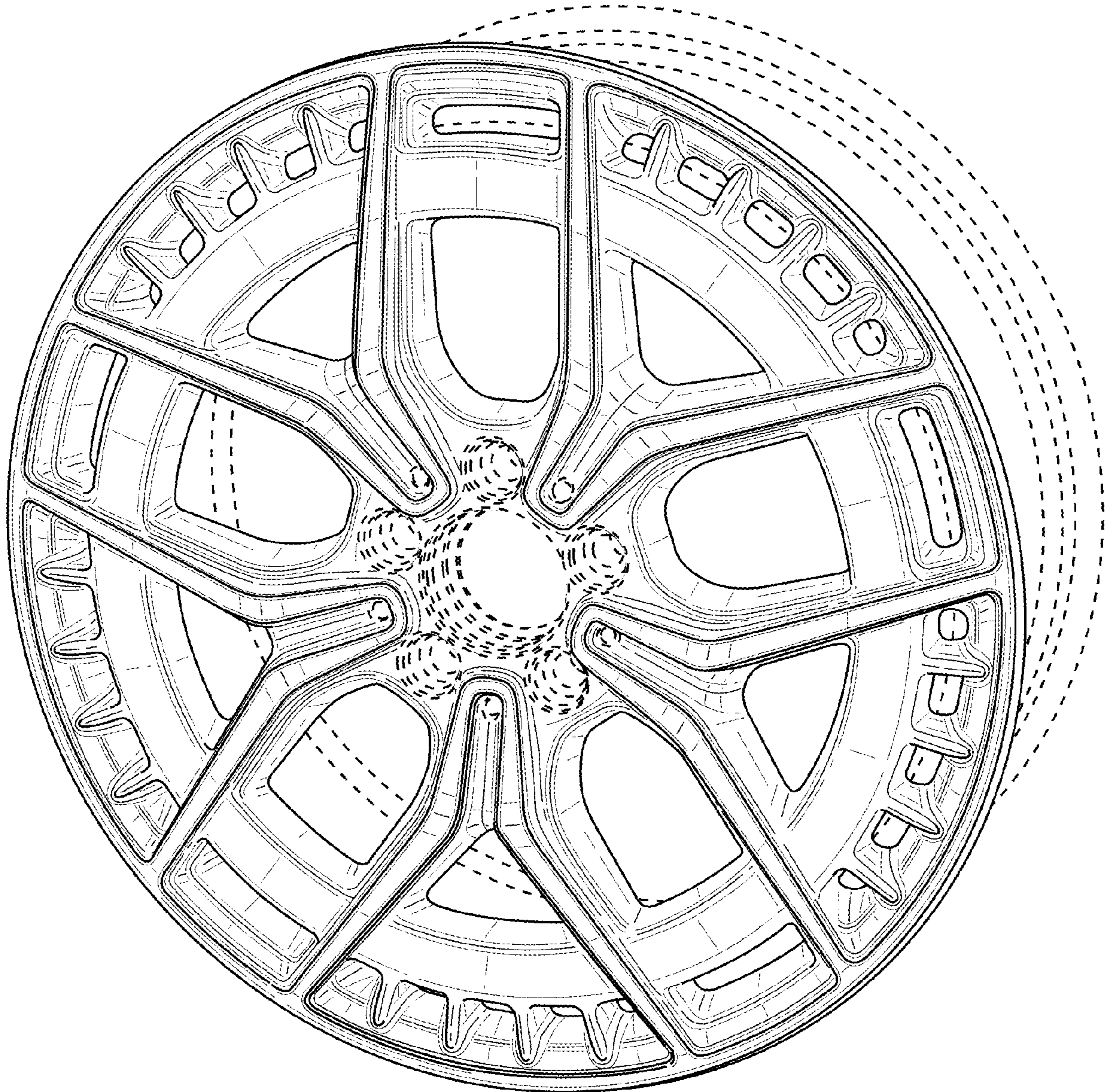

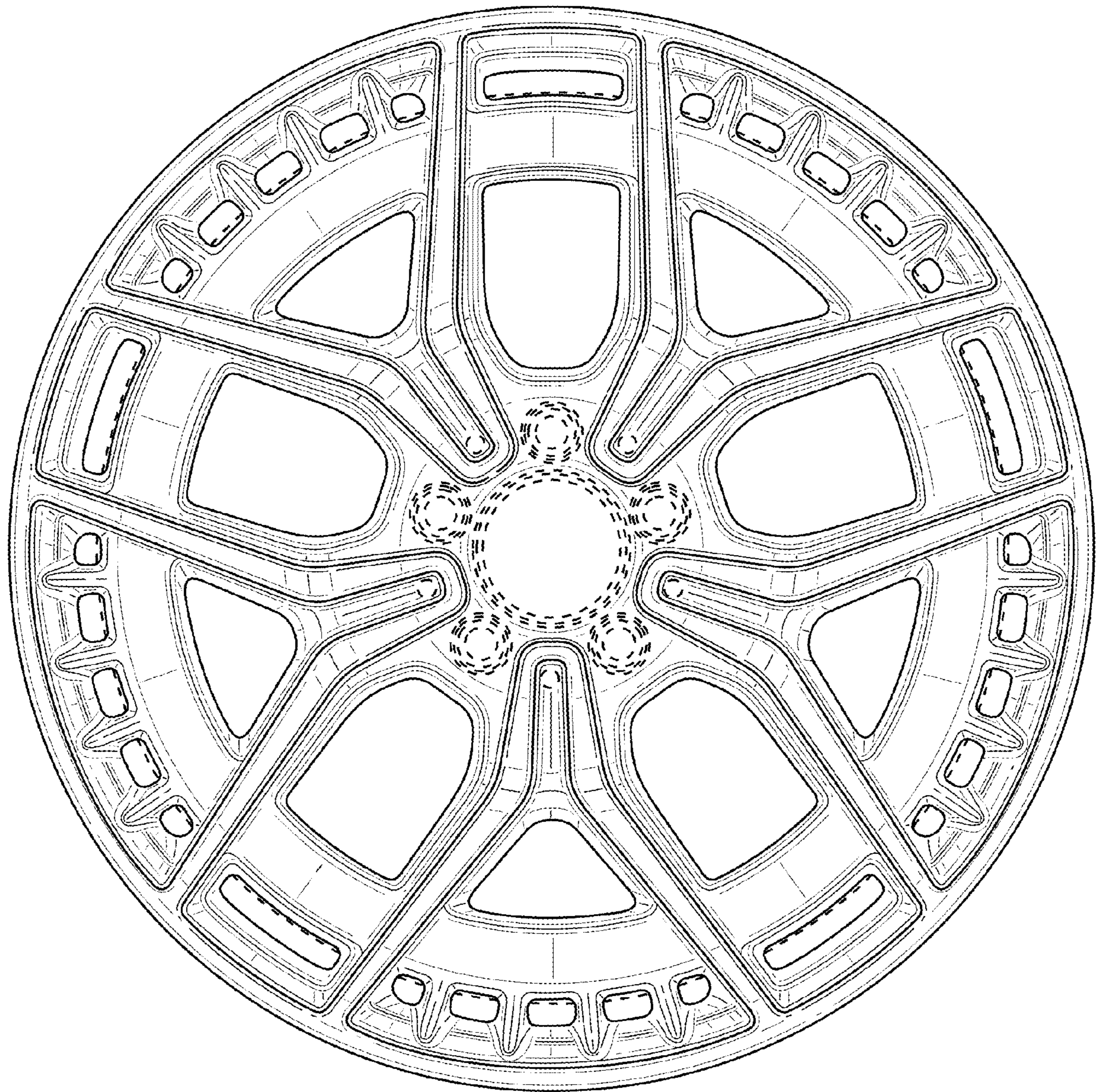
