DESCRIPTION

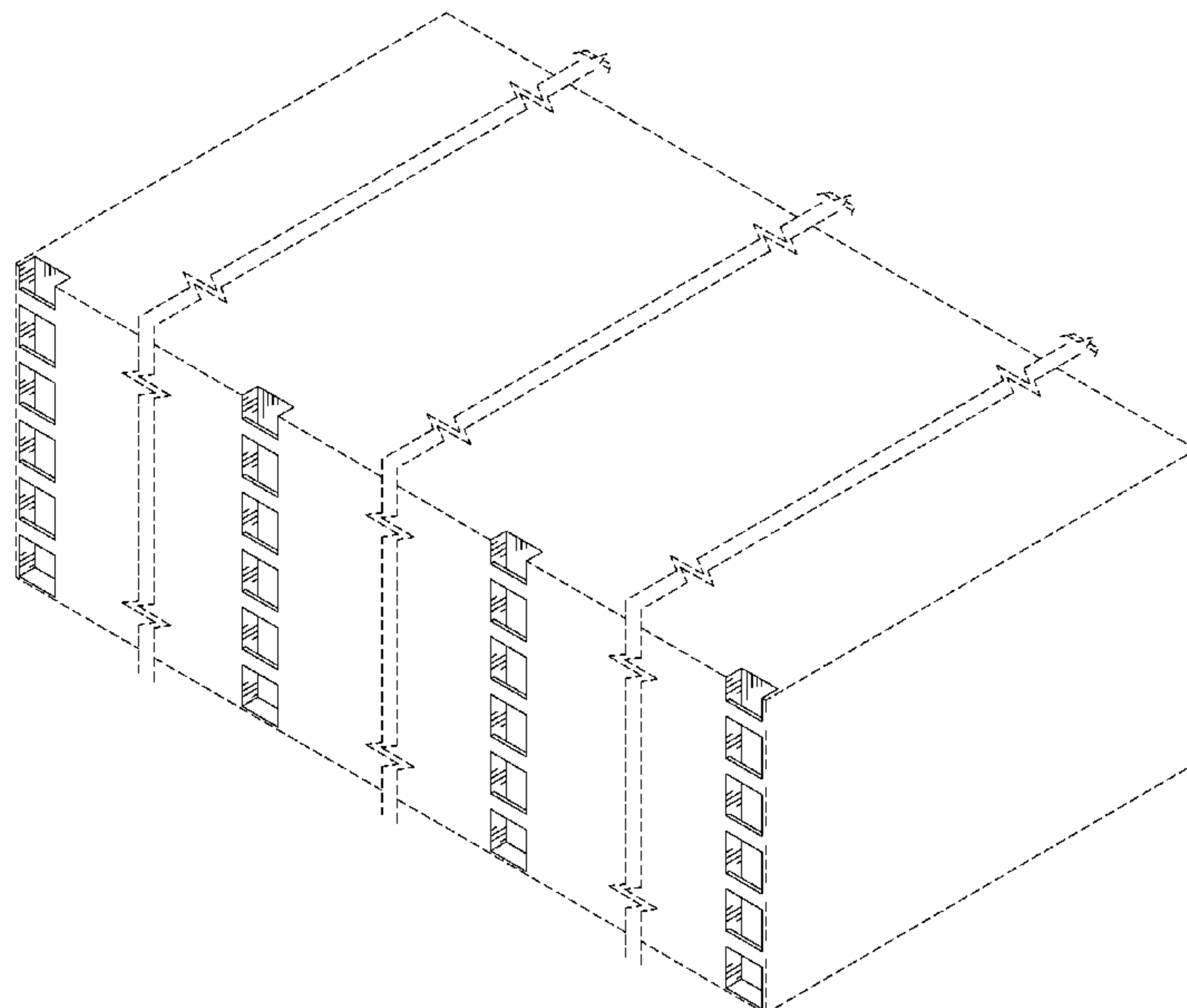
FIG. 1 is a front perspective view of a barge assembly according to the present application.

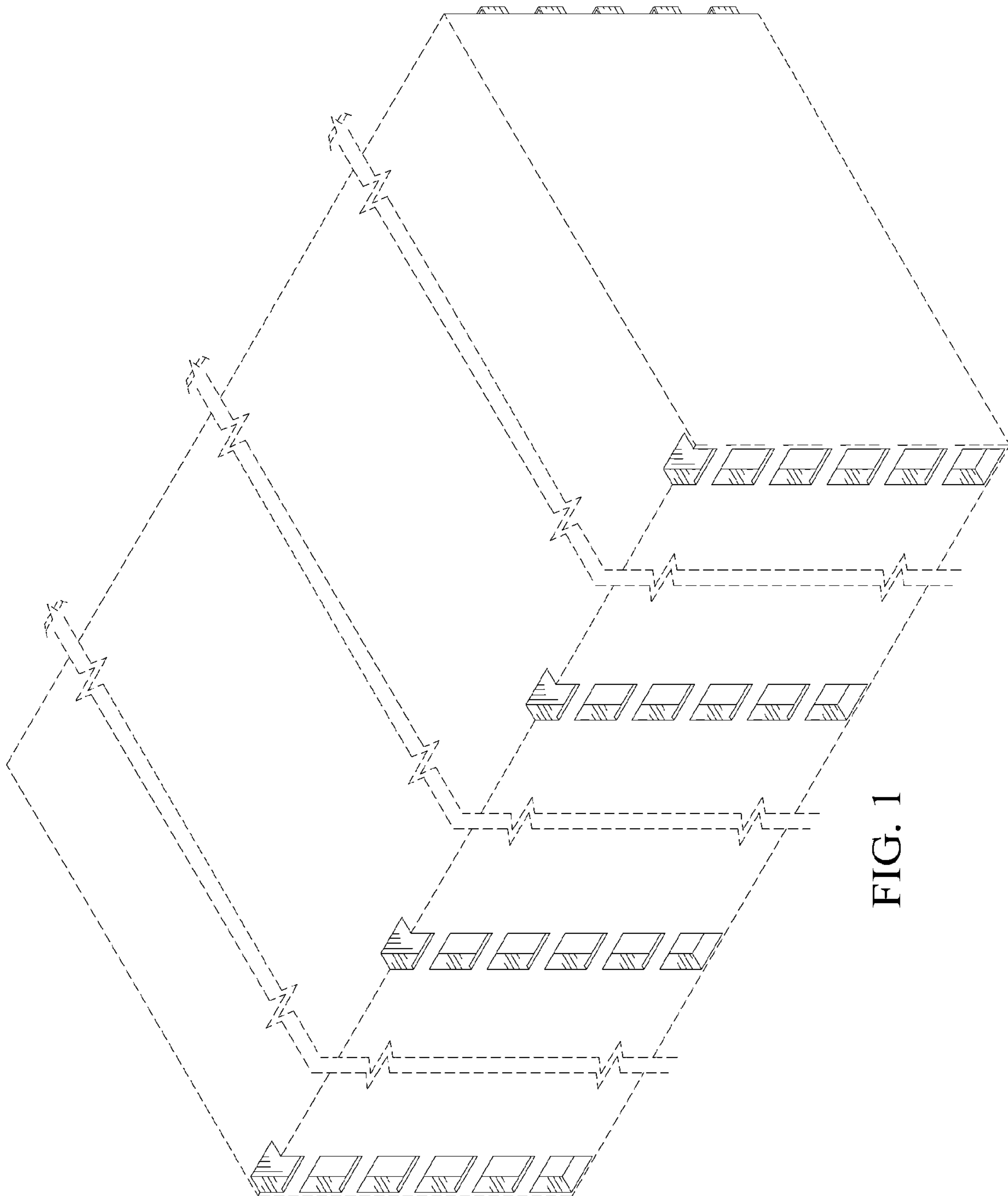

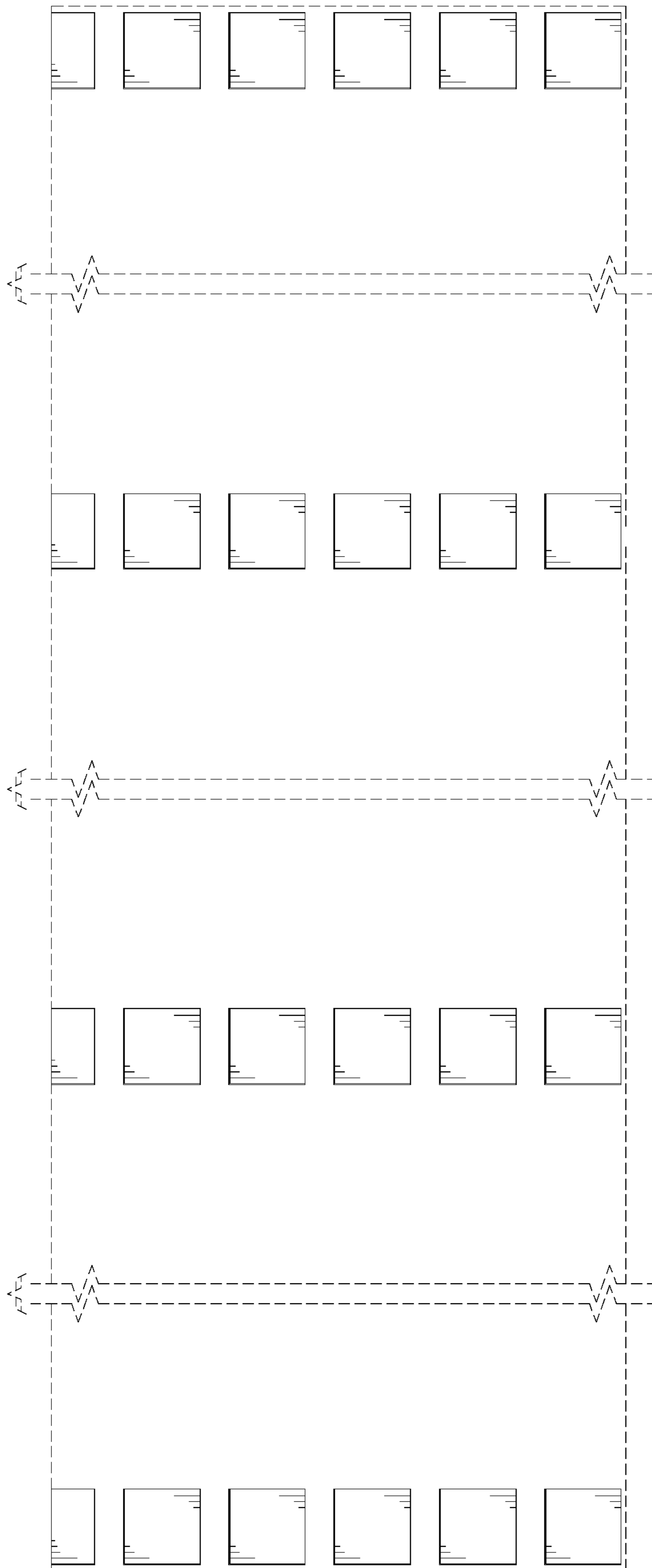

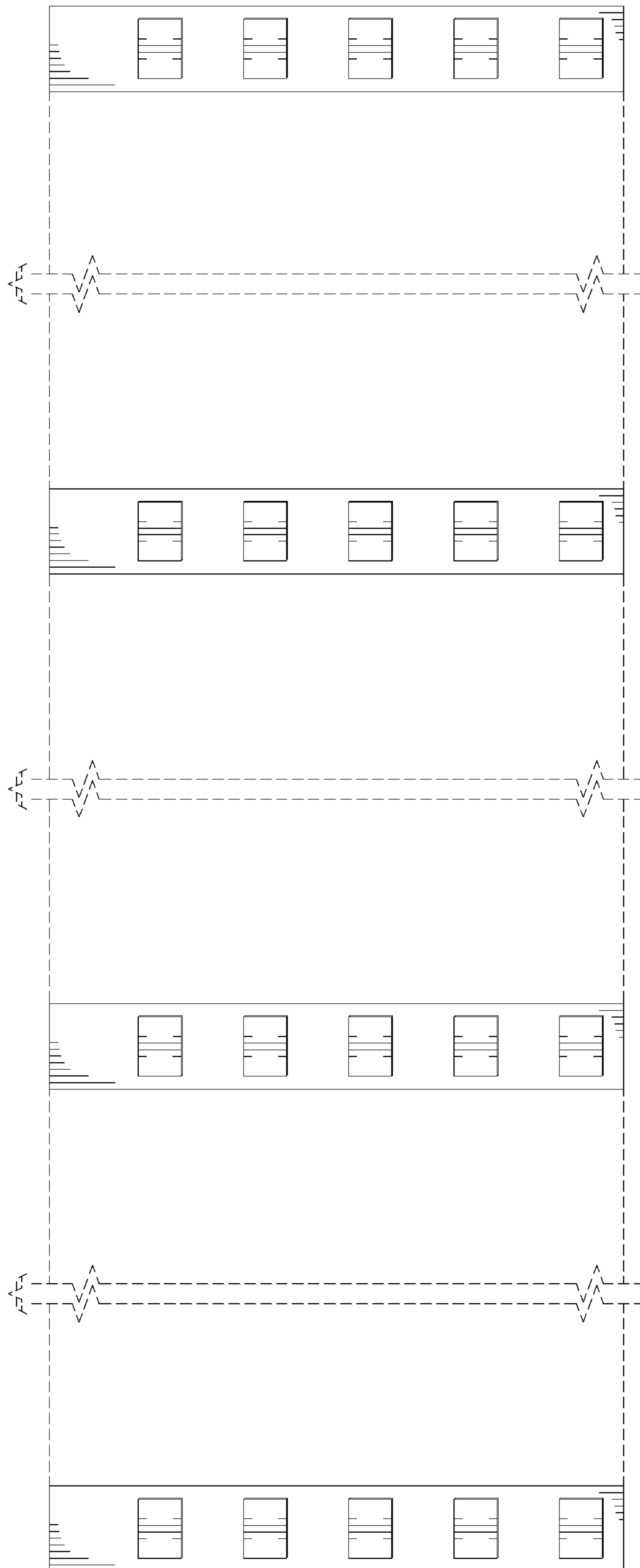

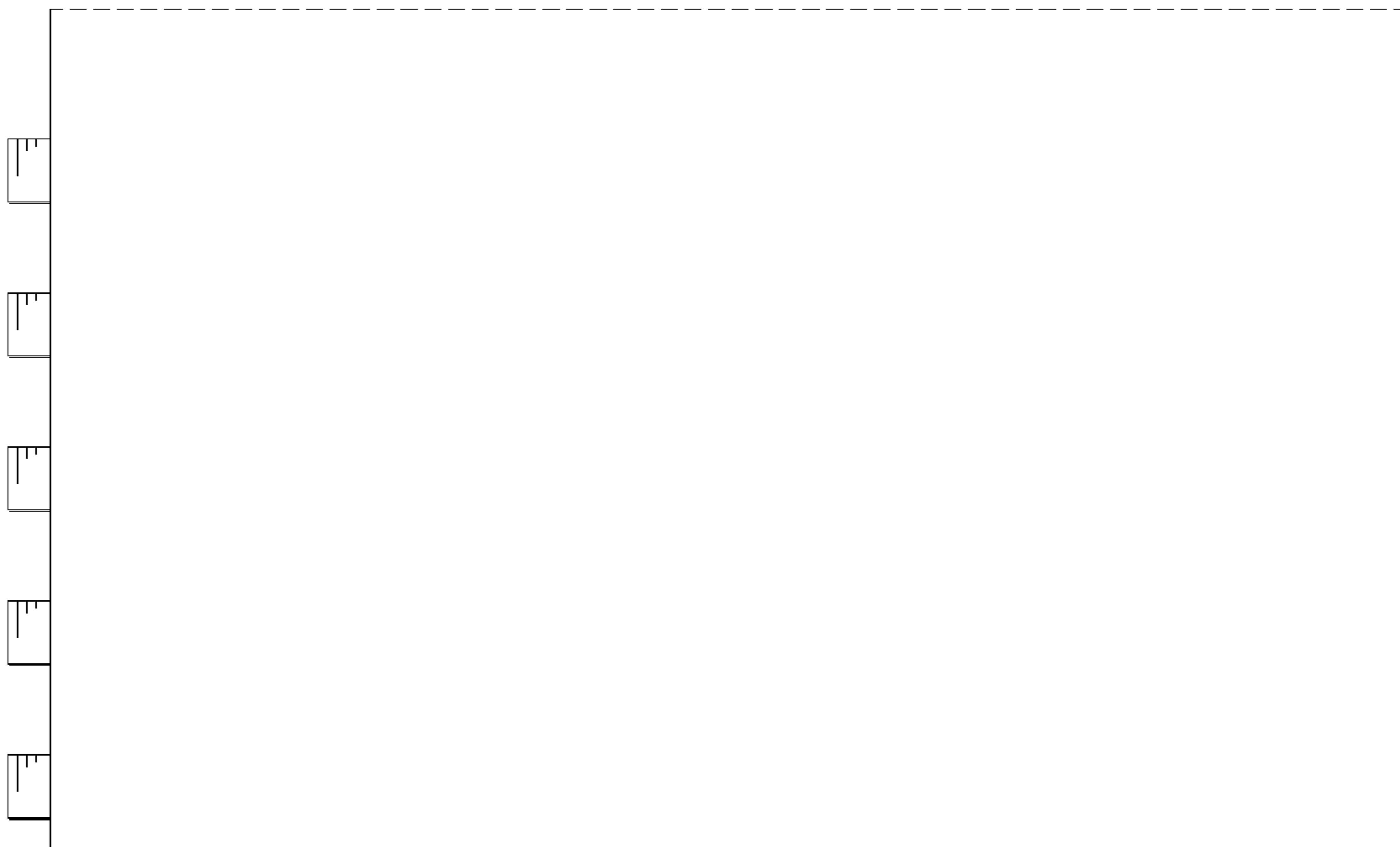

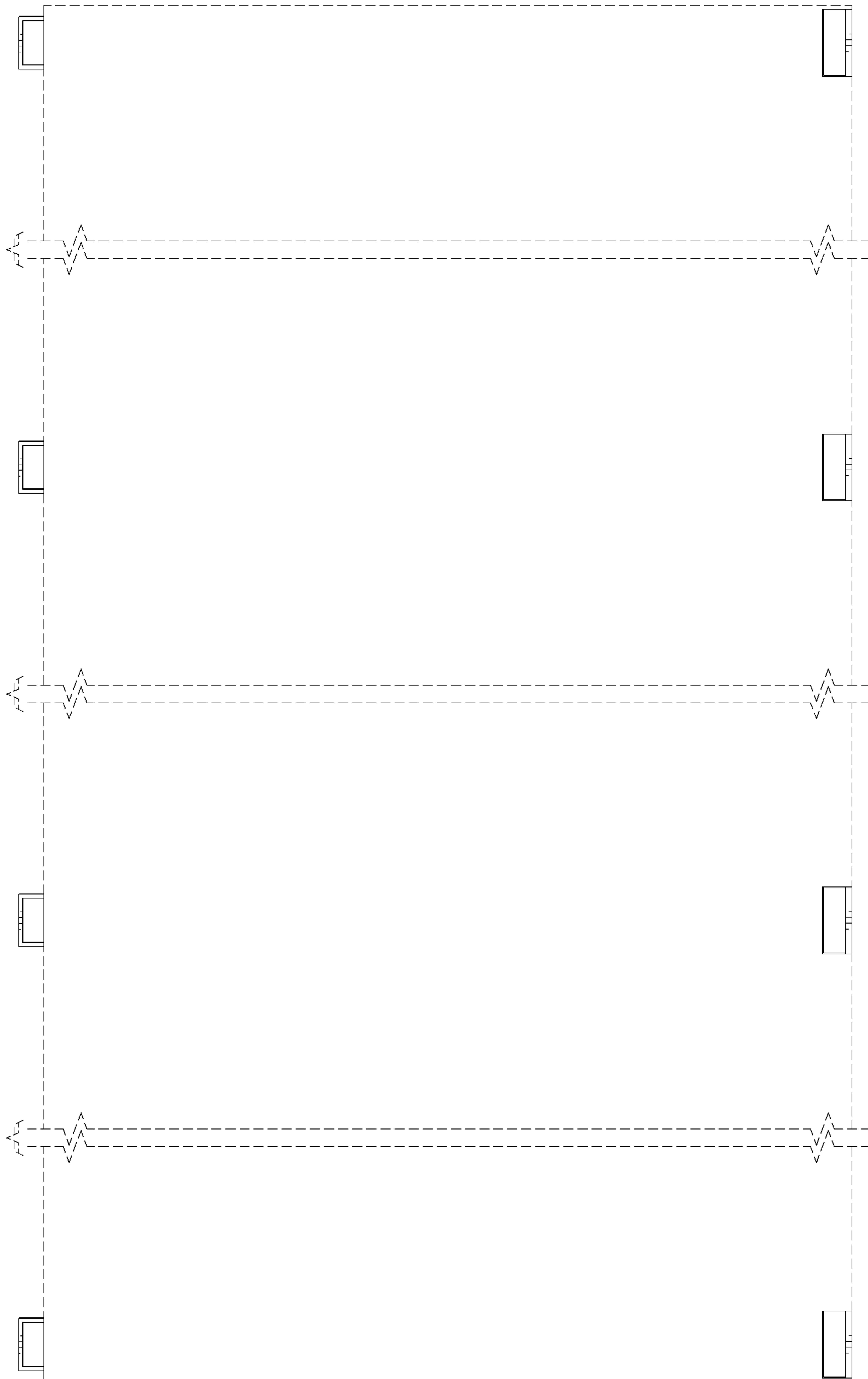

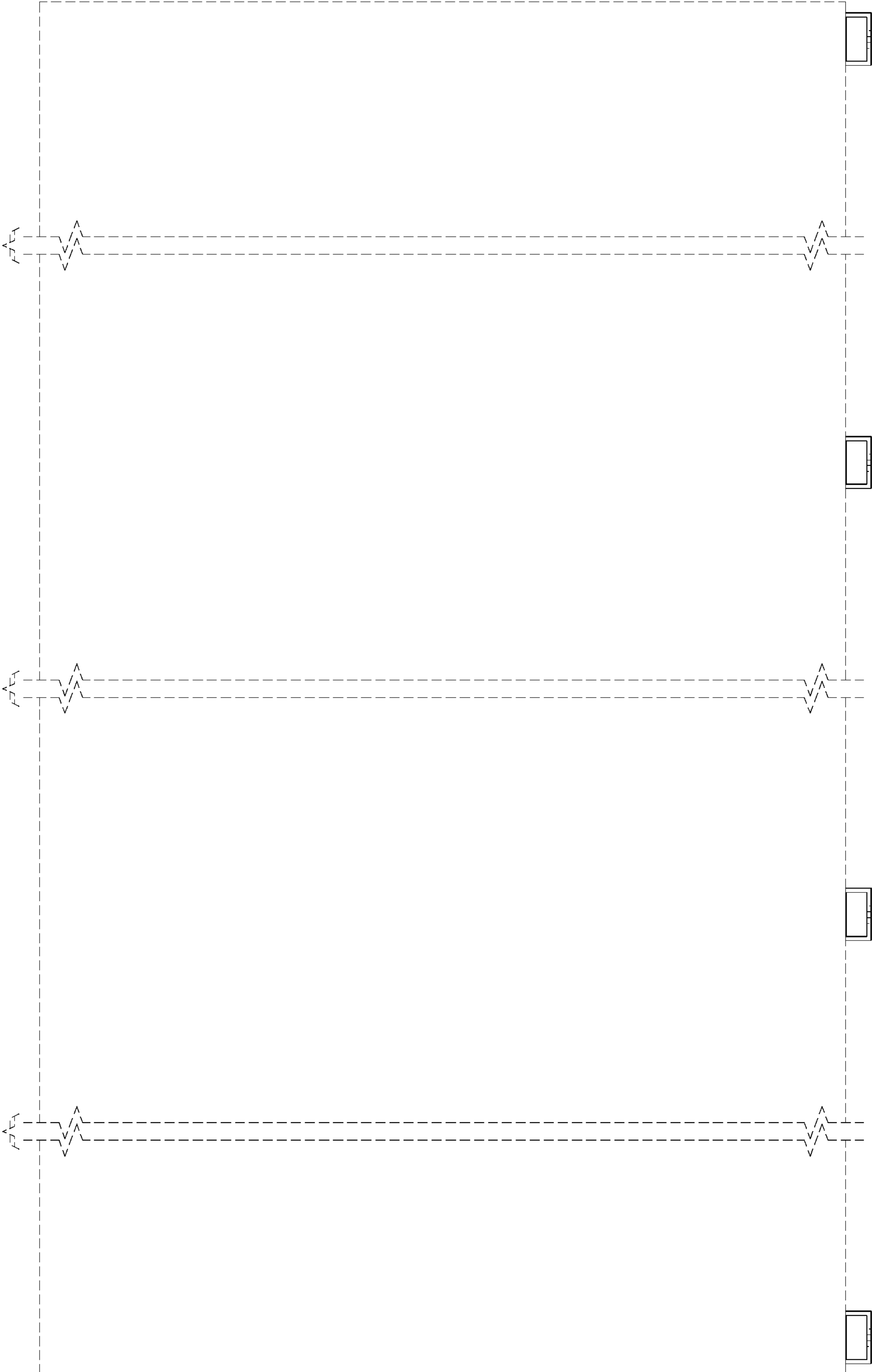

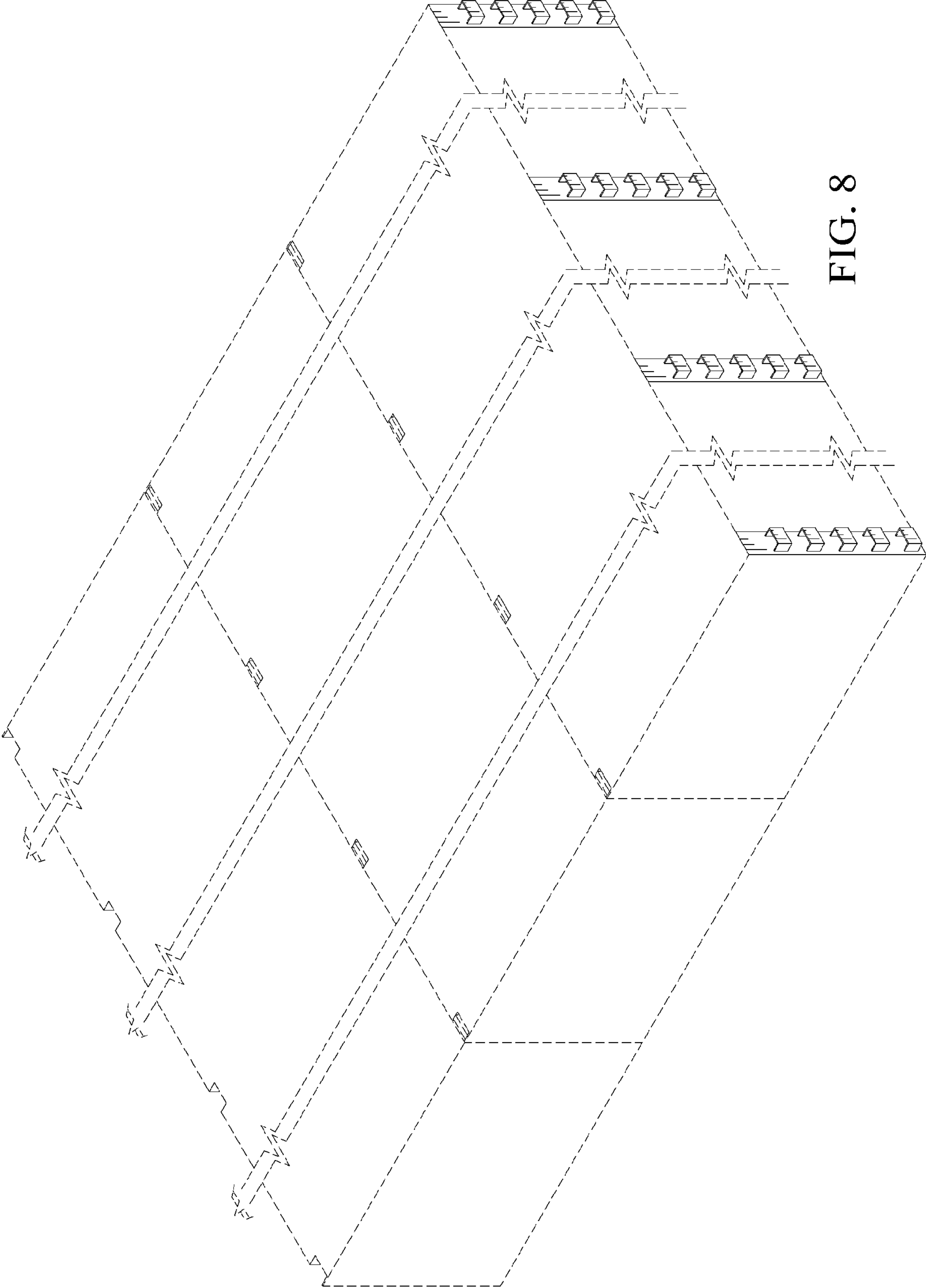

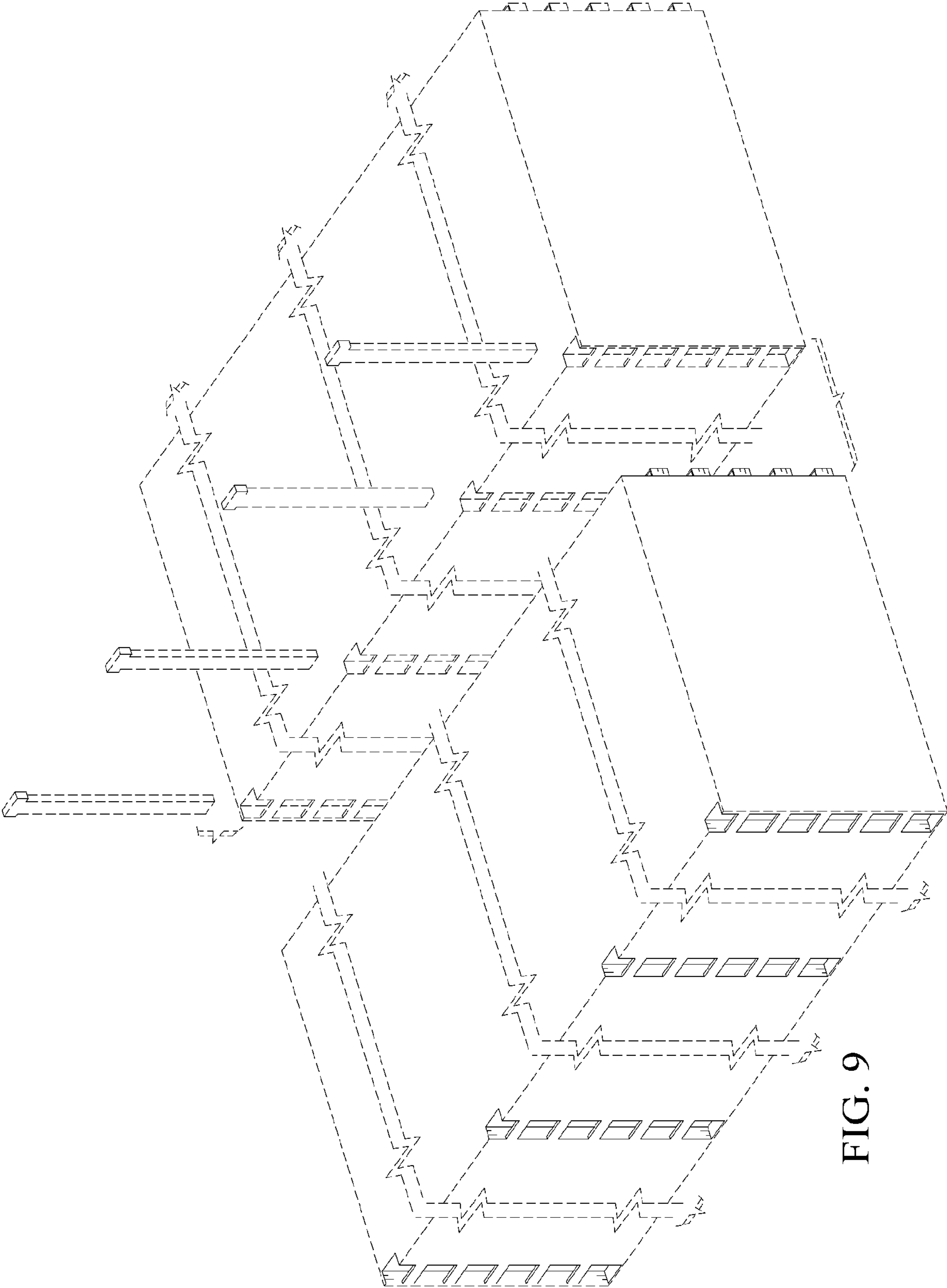
