DESCRIPTION

FIG. 1 is a perspective view of a cable management box and organizer showing my new design;

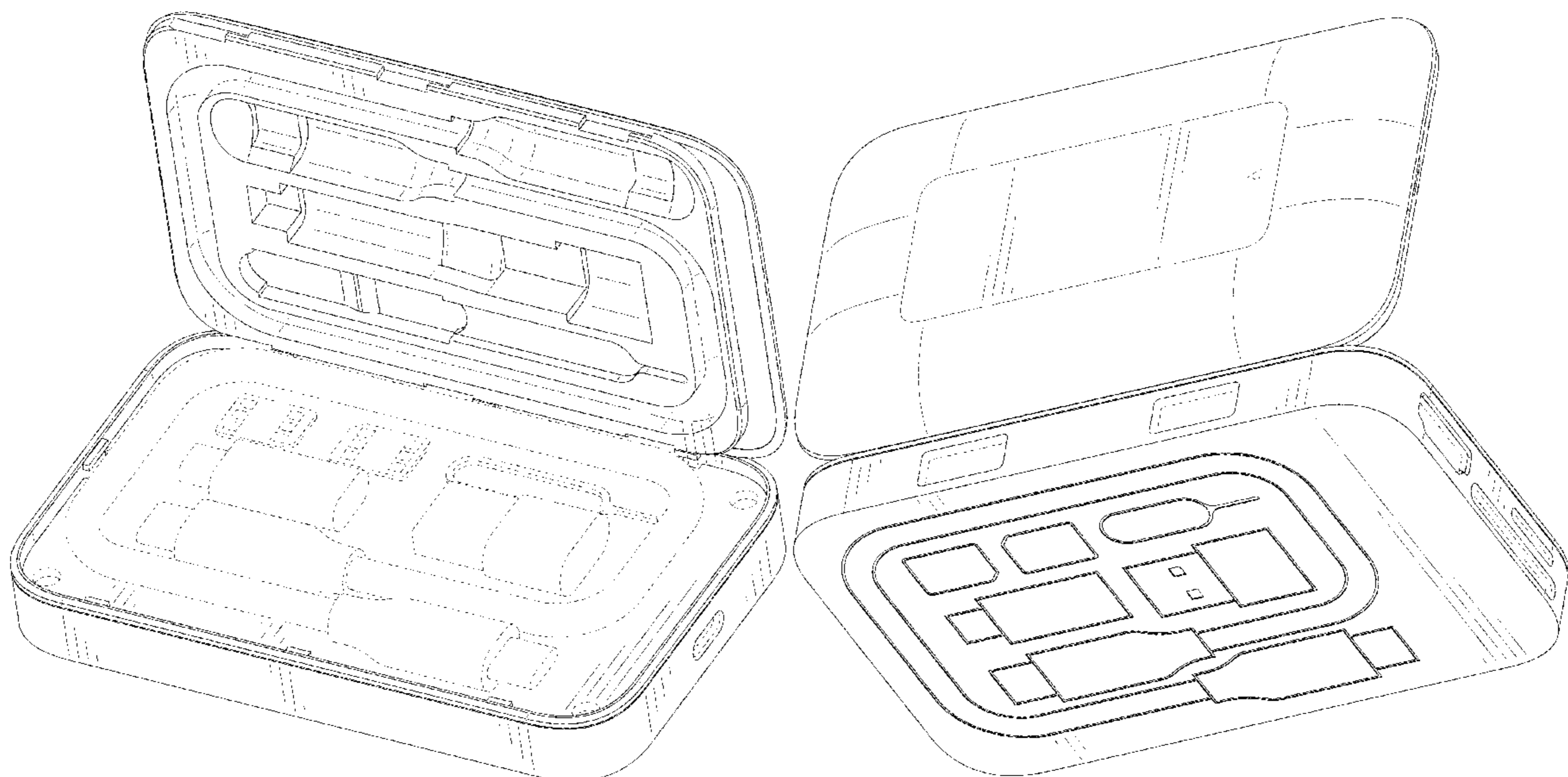

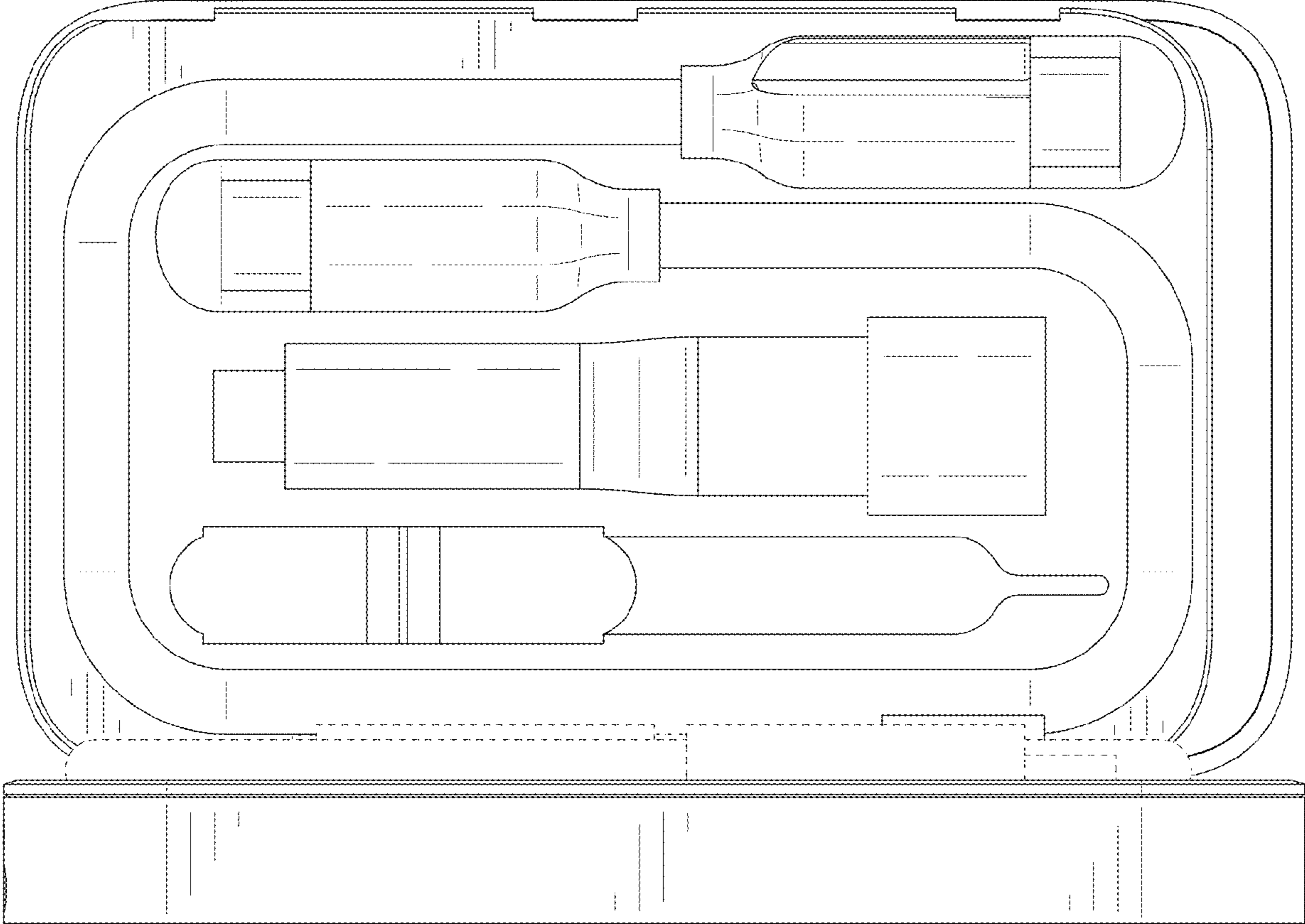

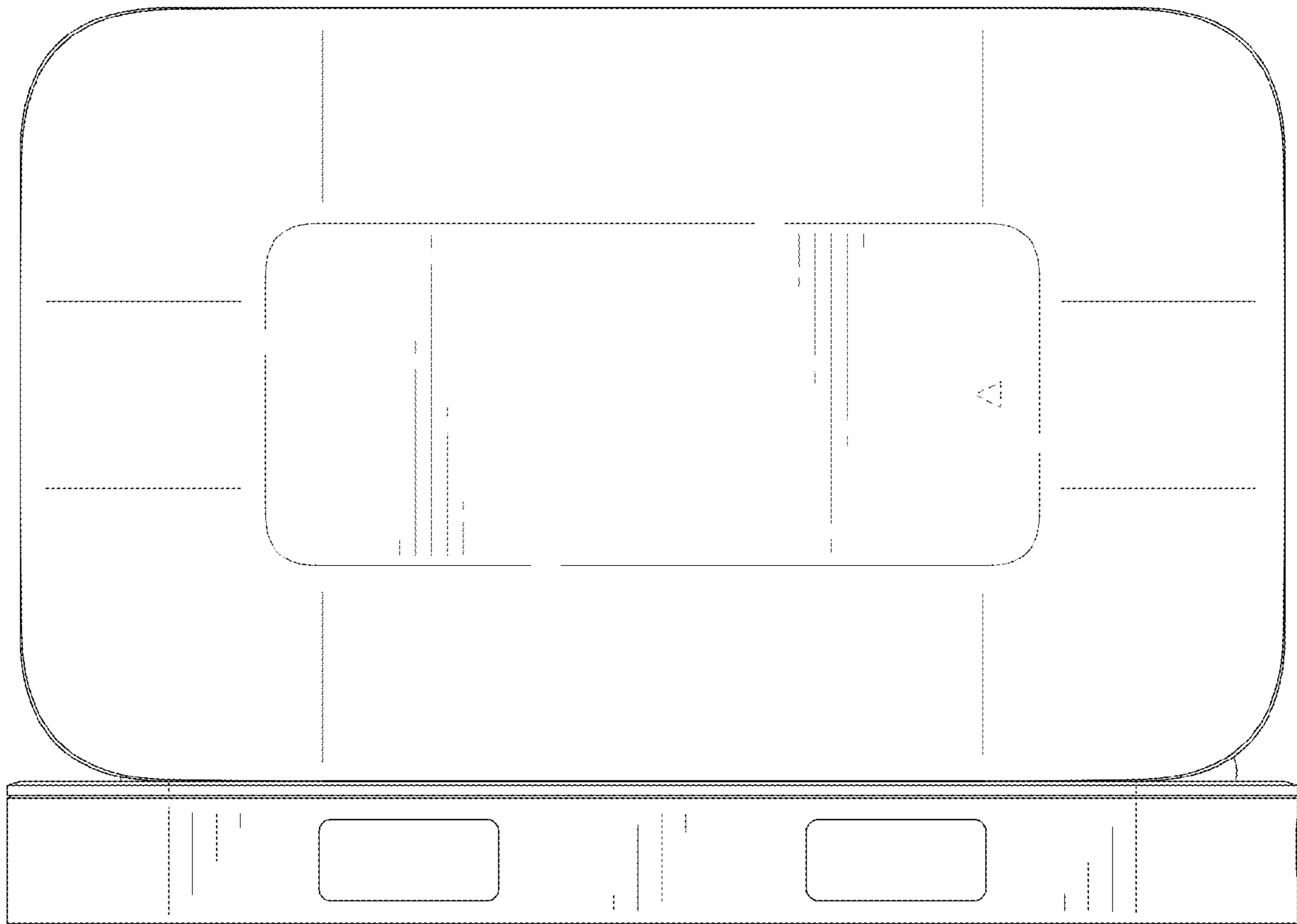

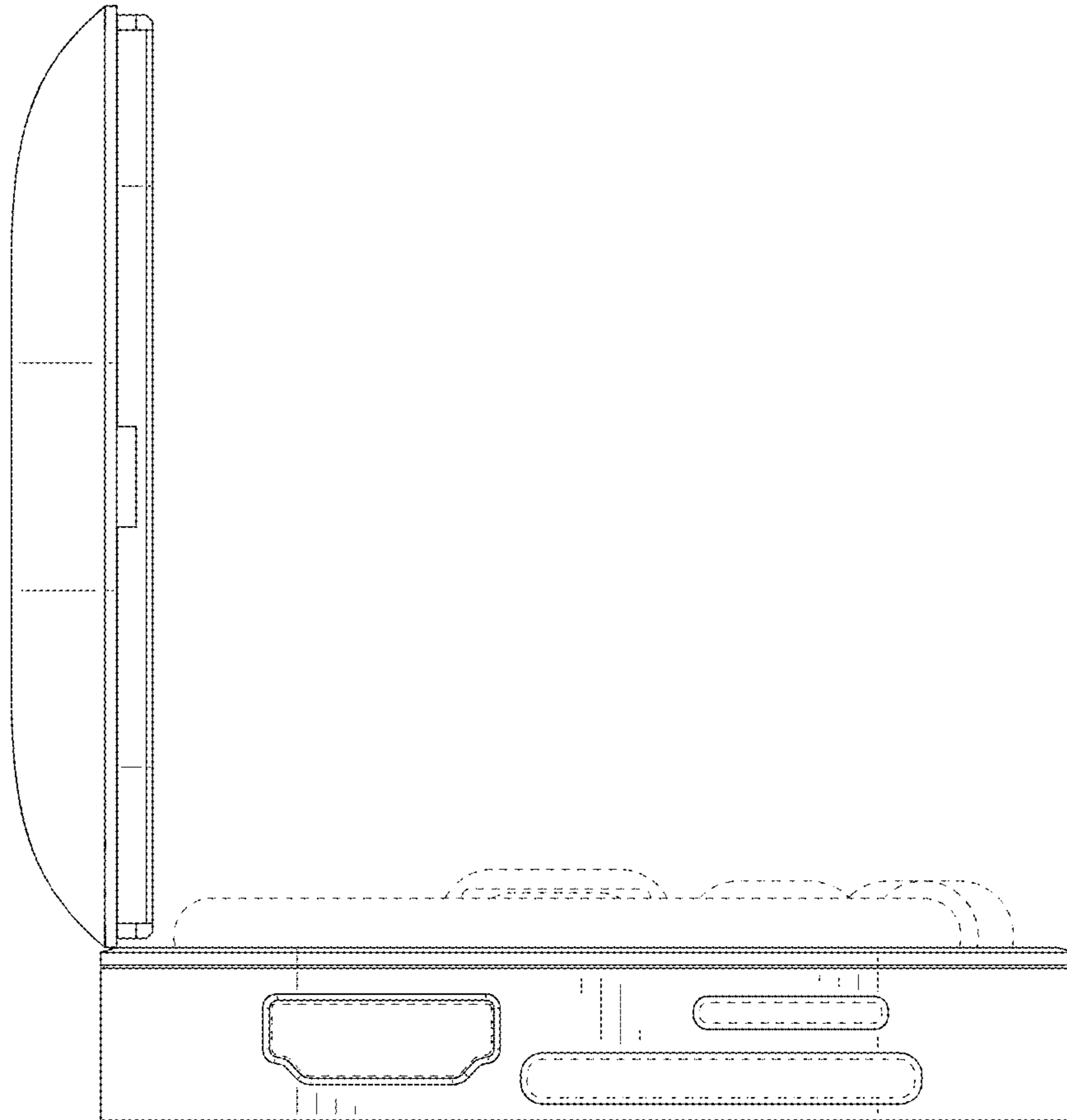

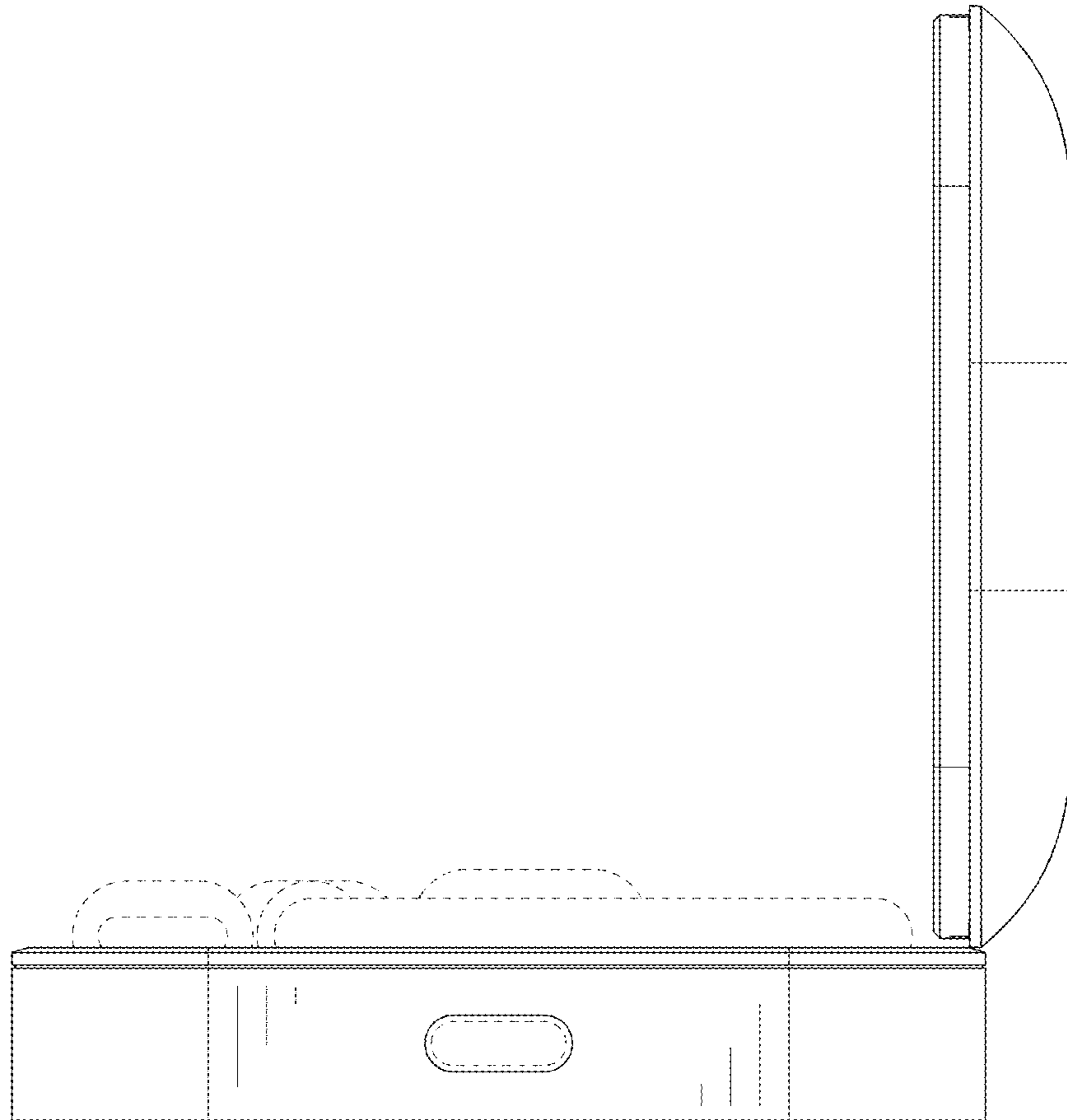

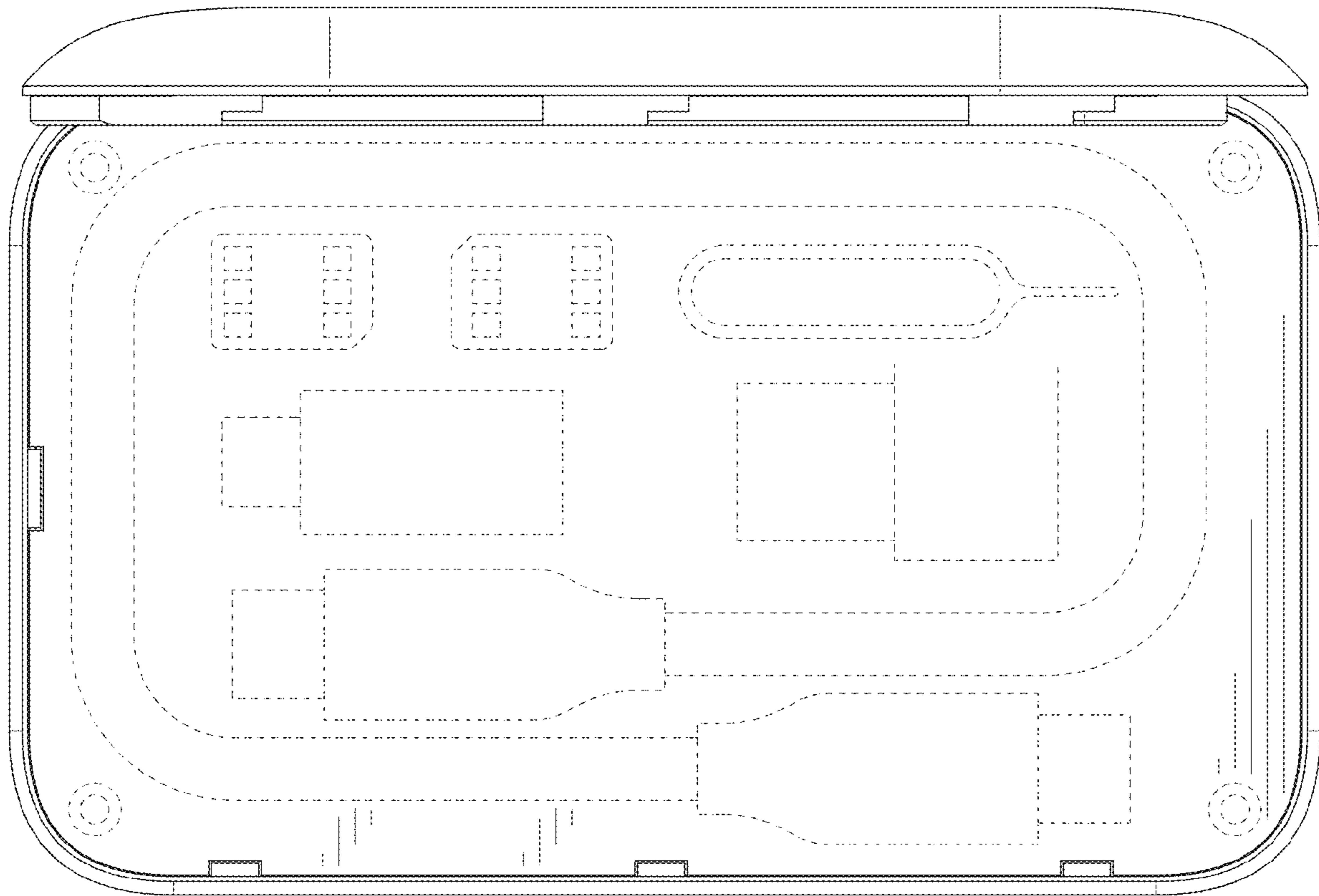

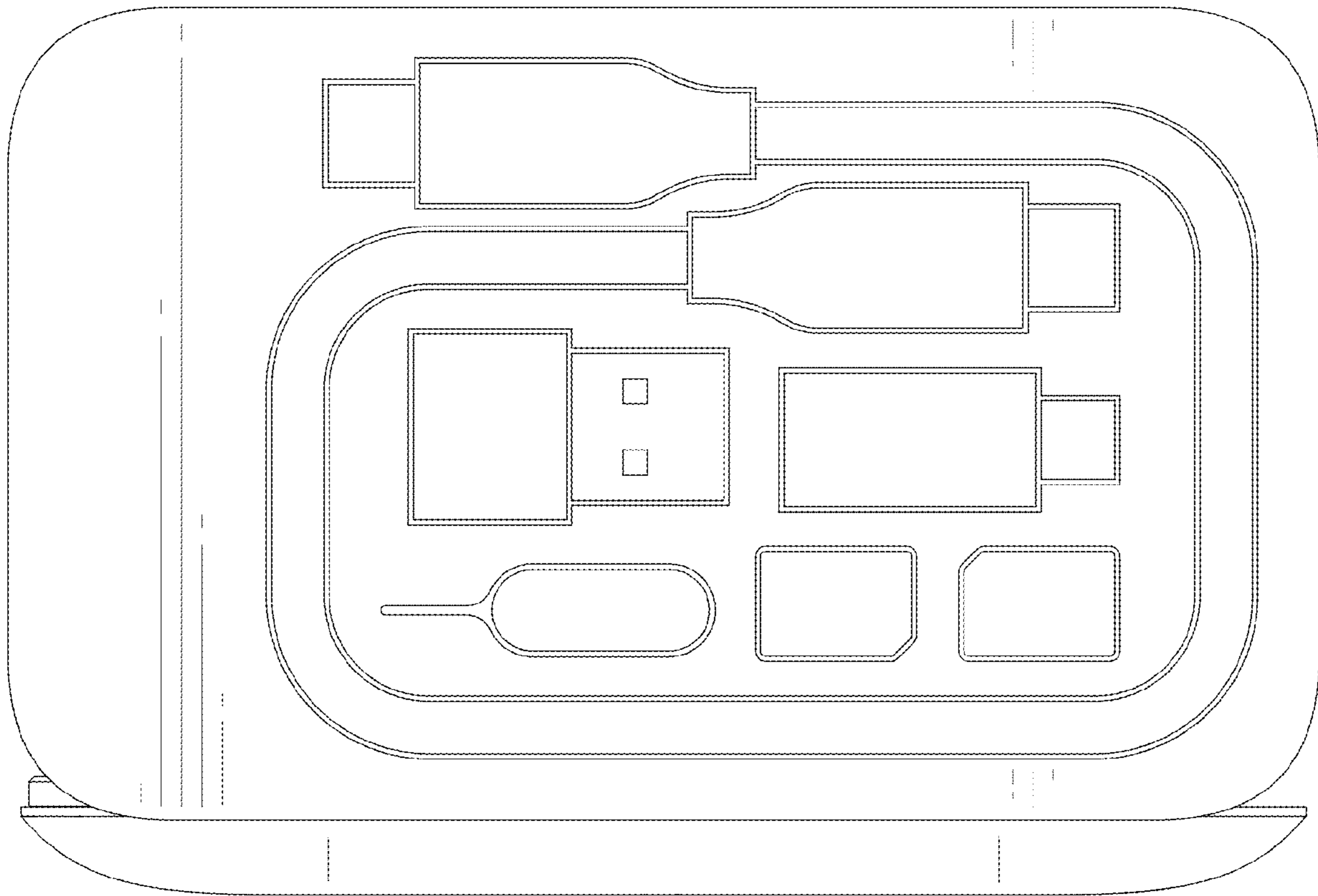

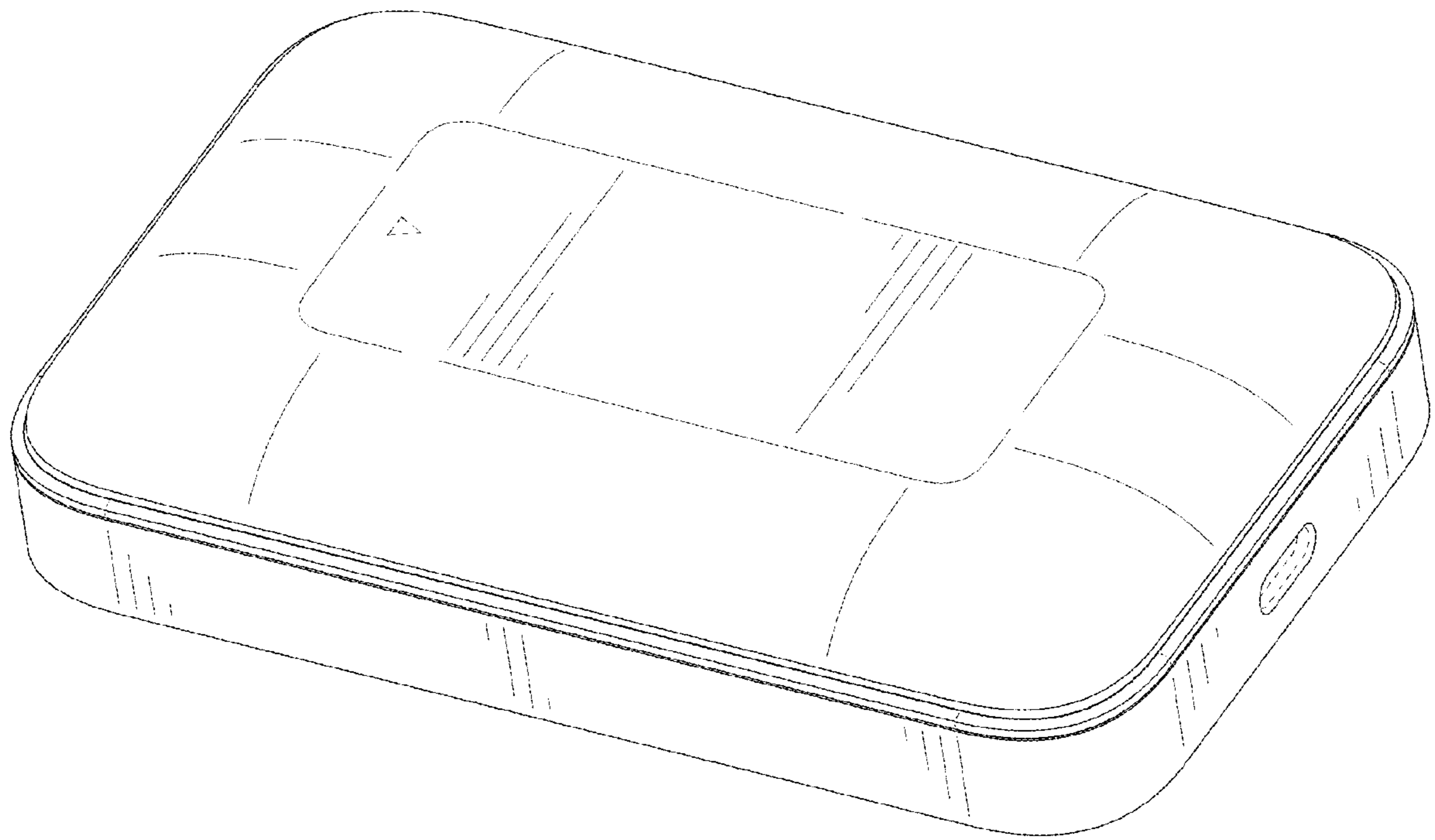
