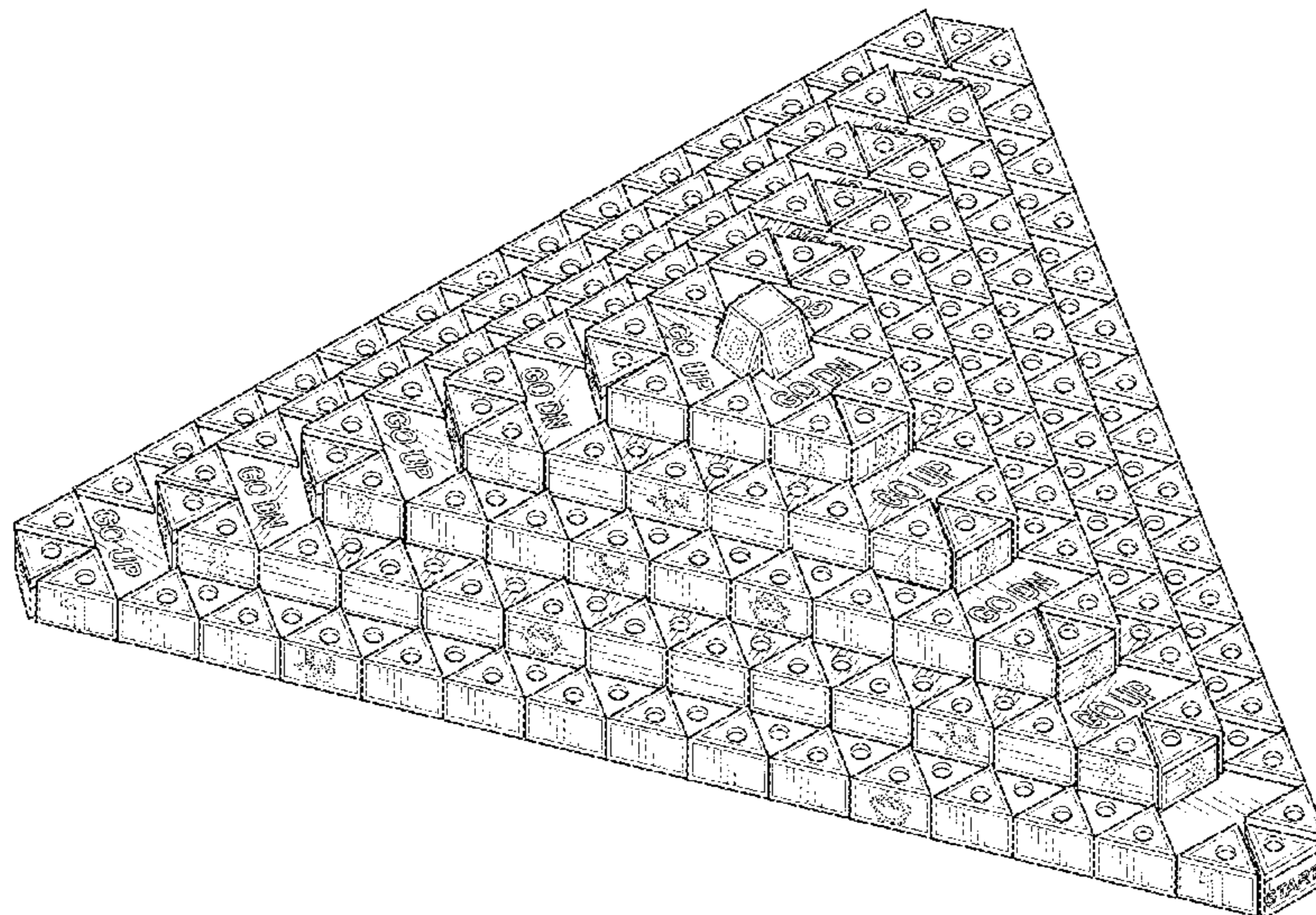
(57) **CLAIM**

FIG. 5 is a rear elevation view of the game board;
FIG. 6 is a right side view of the game board; and,

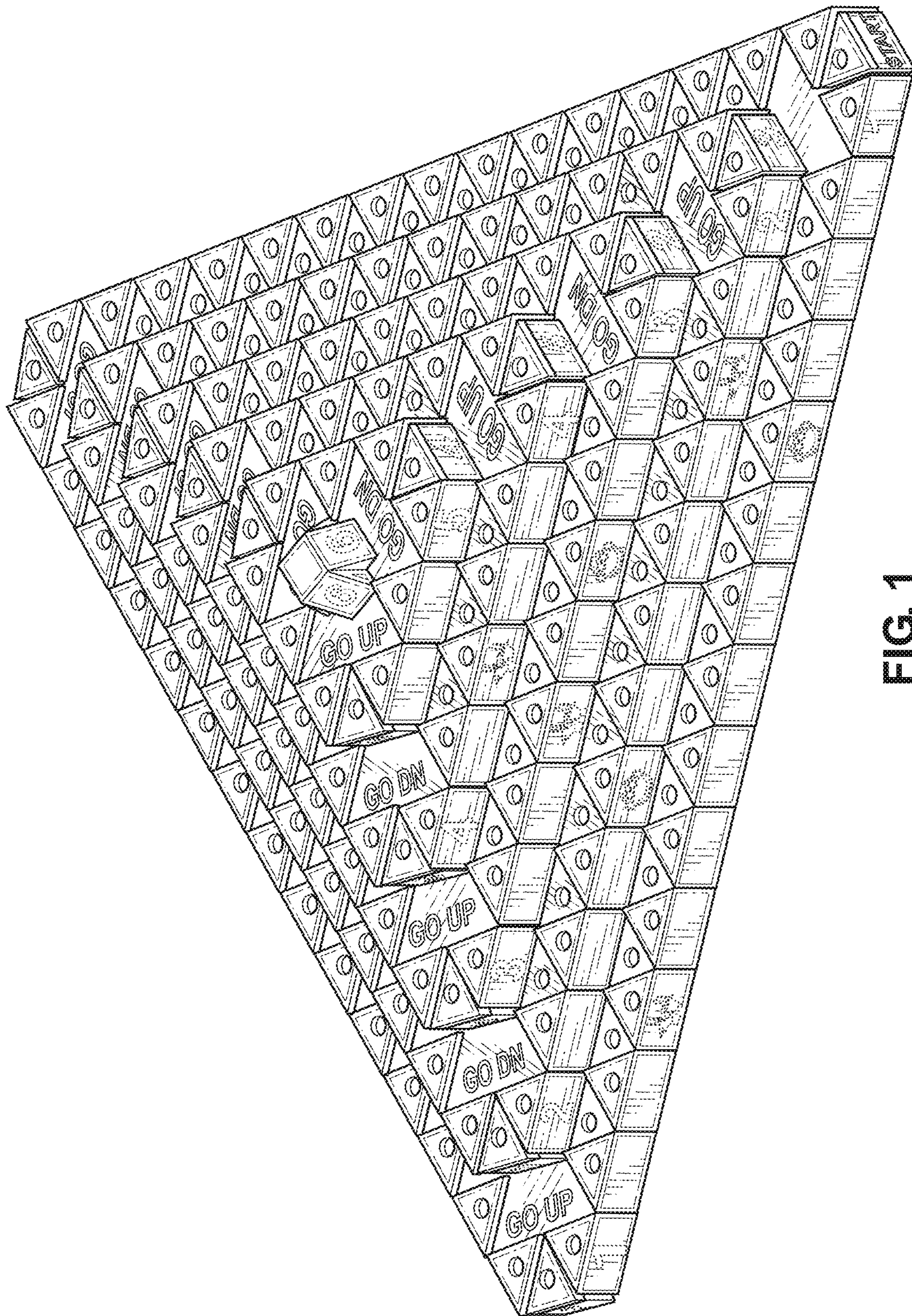

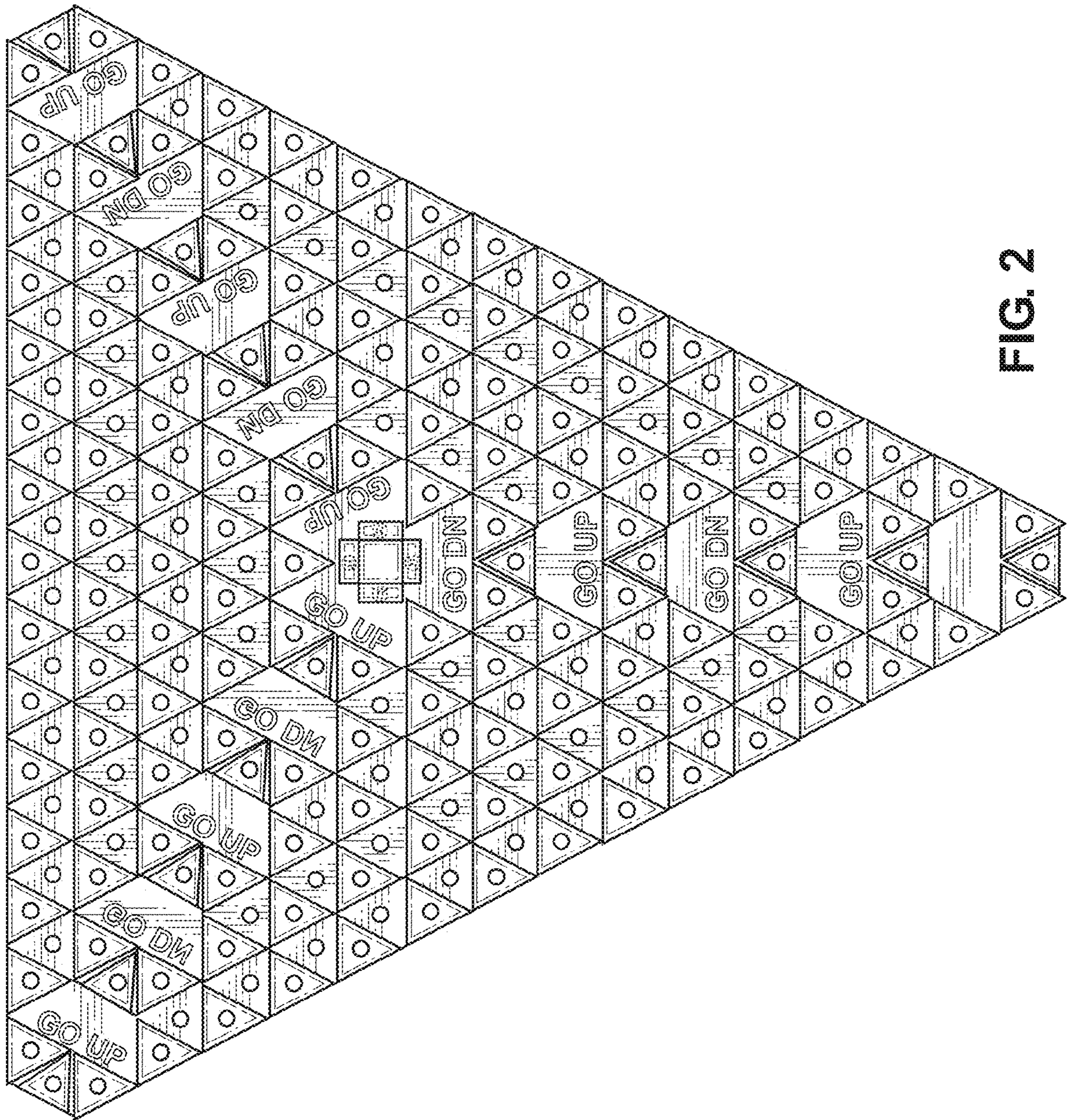

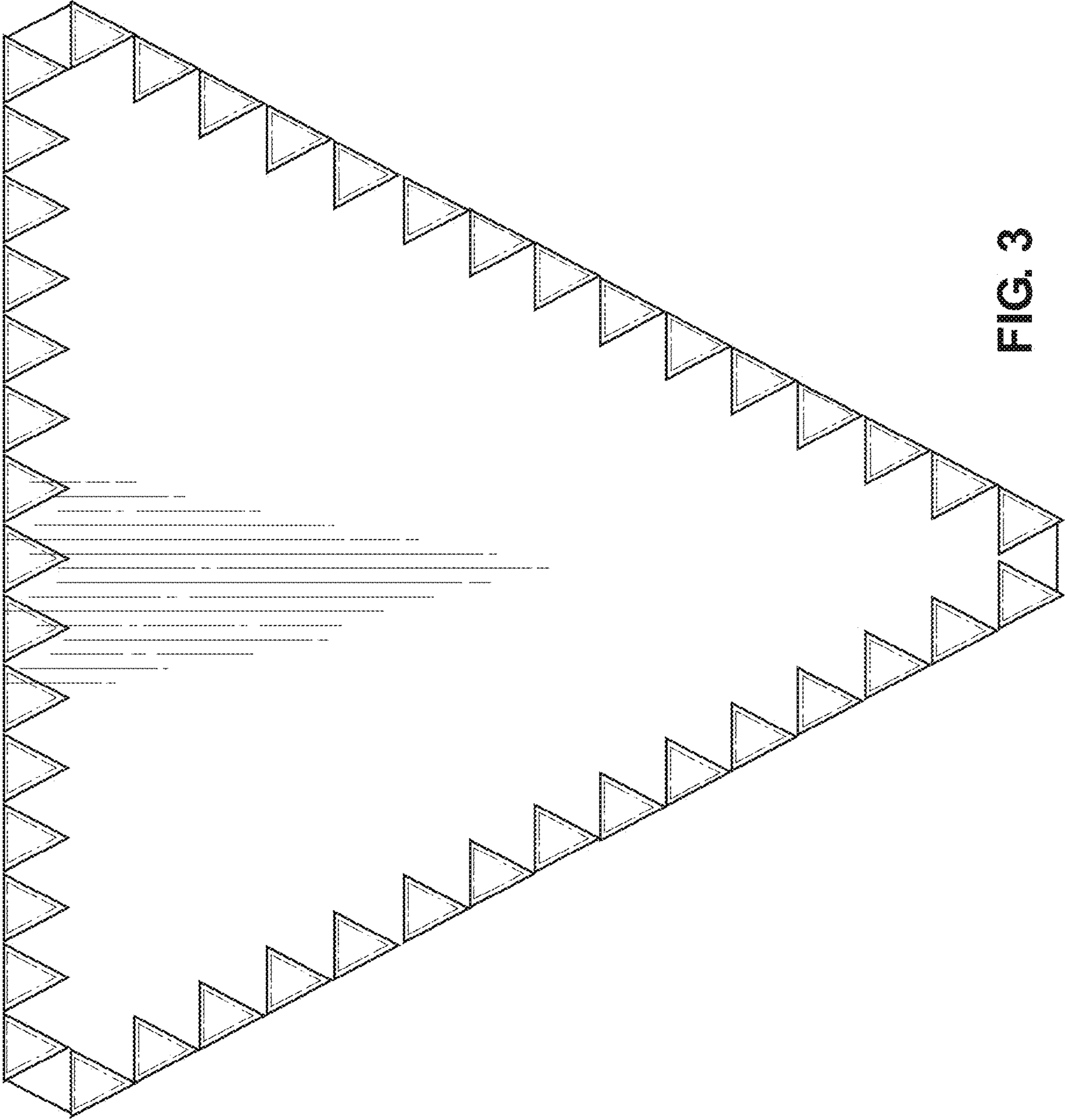

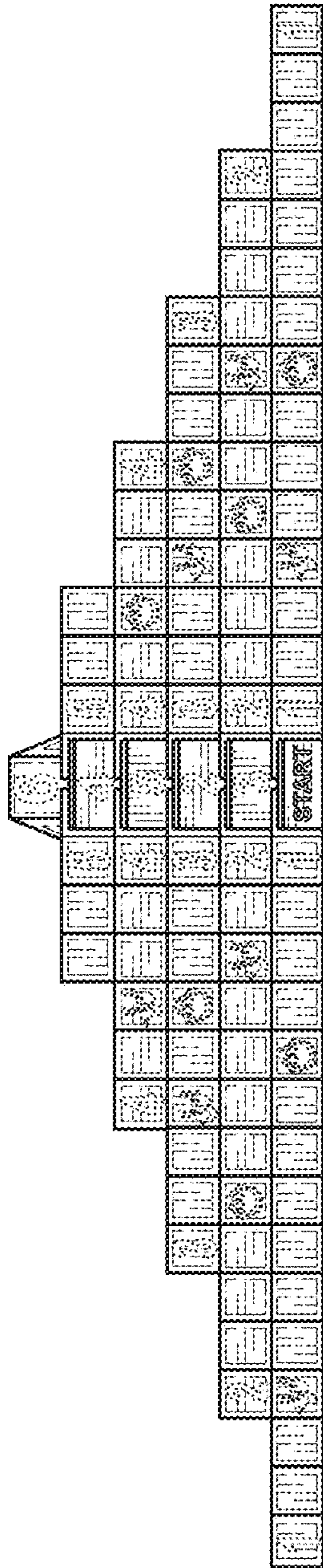

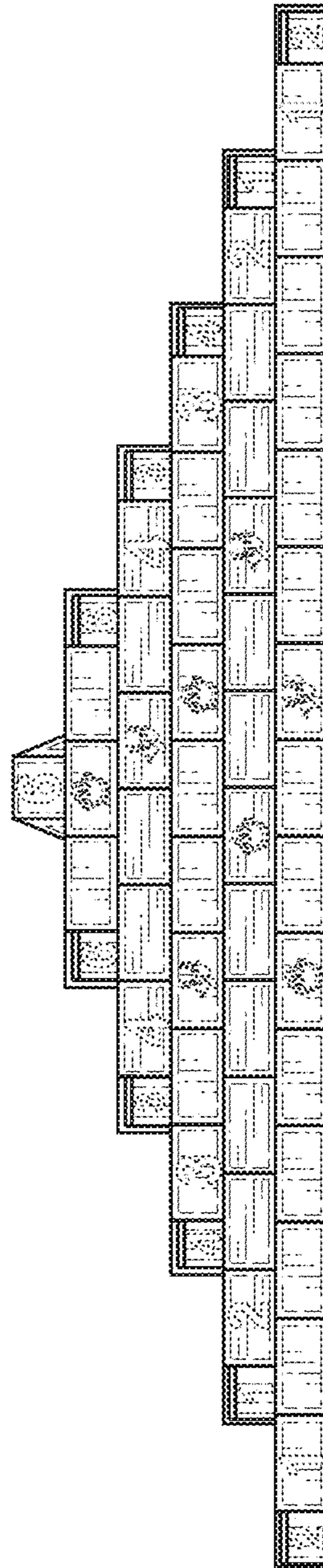

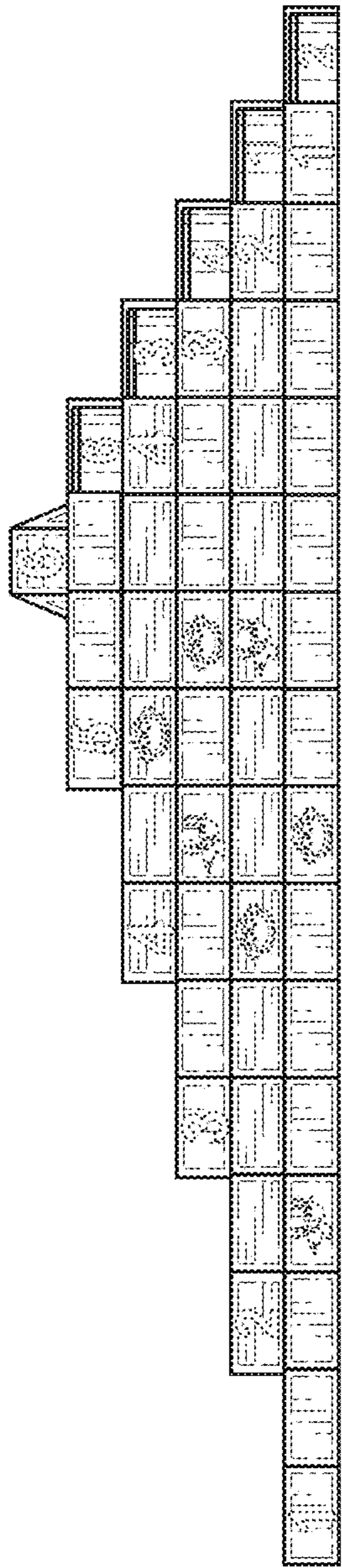

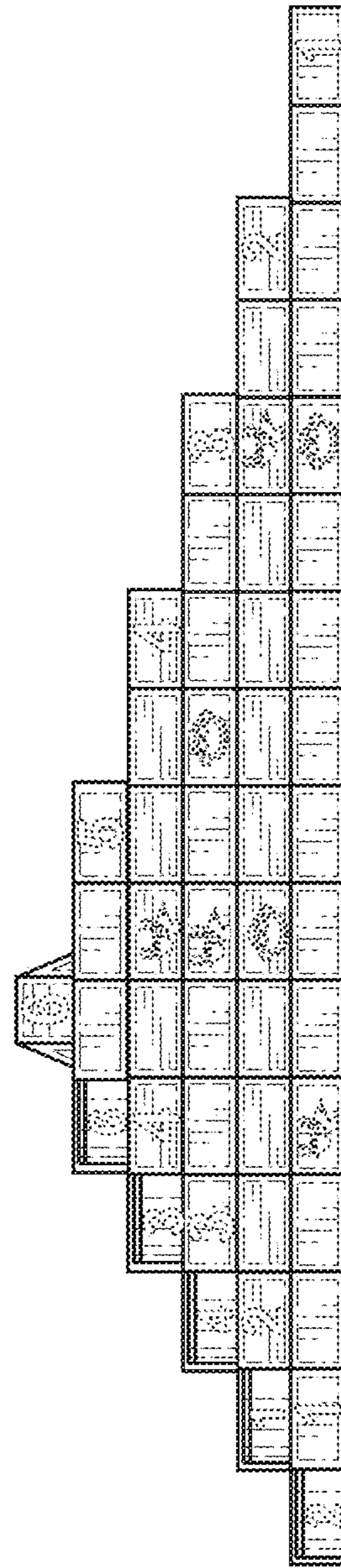
