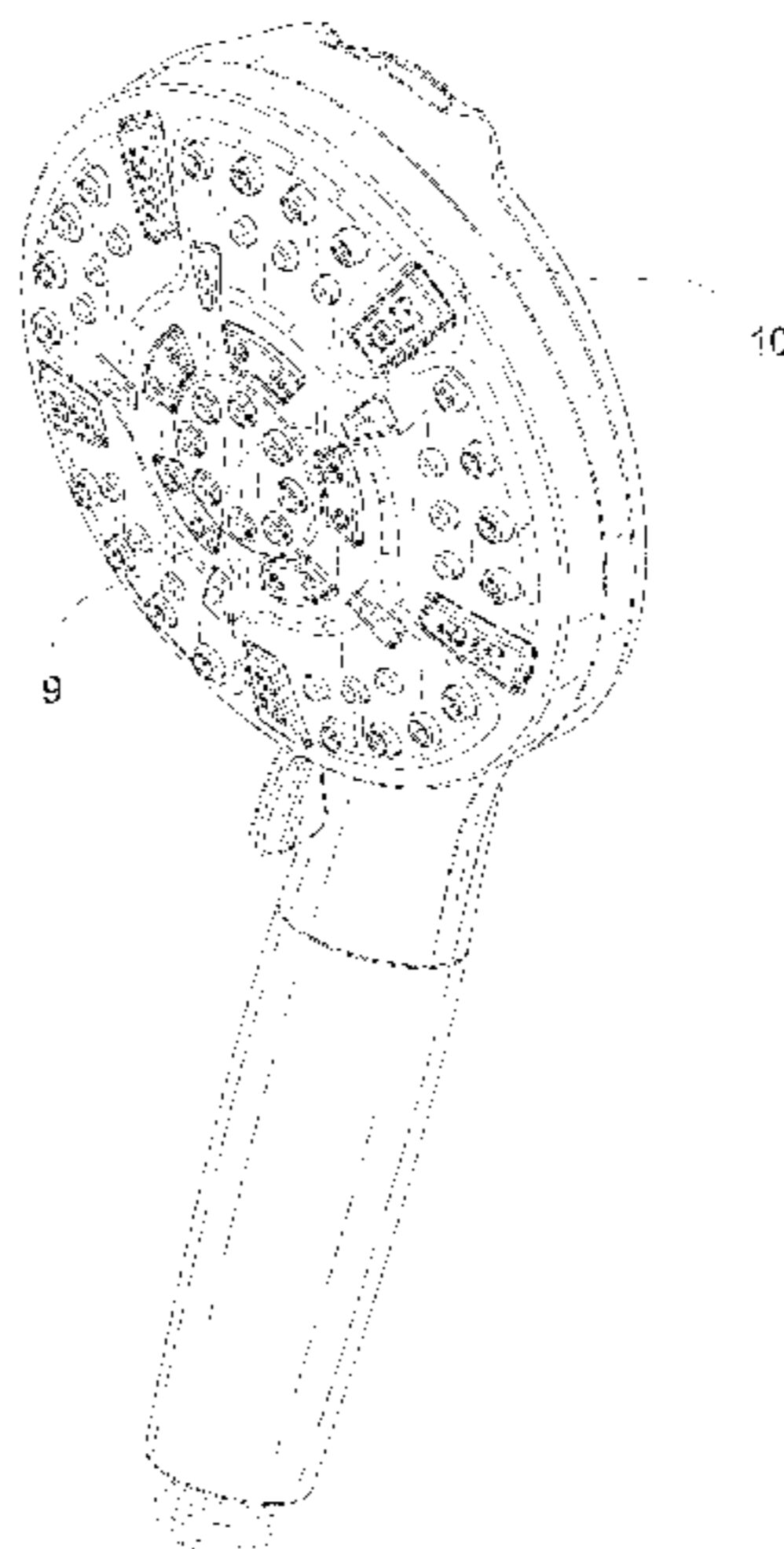


FIG. 10 is an enlarged detail view of the selected portion 10 in FIG. 1.

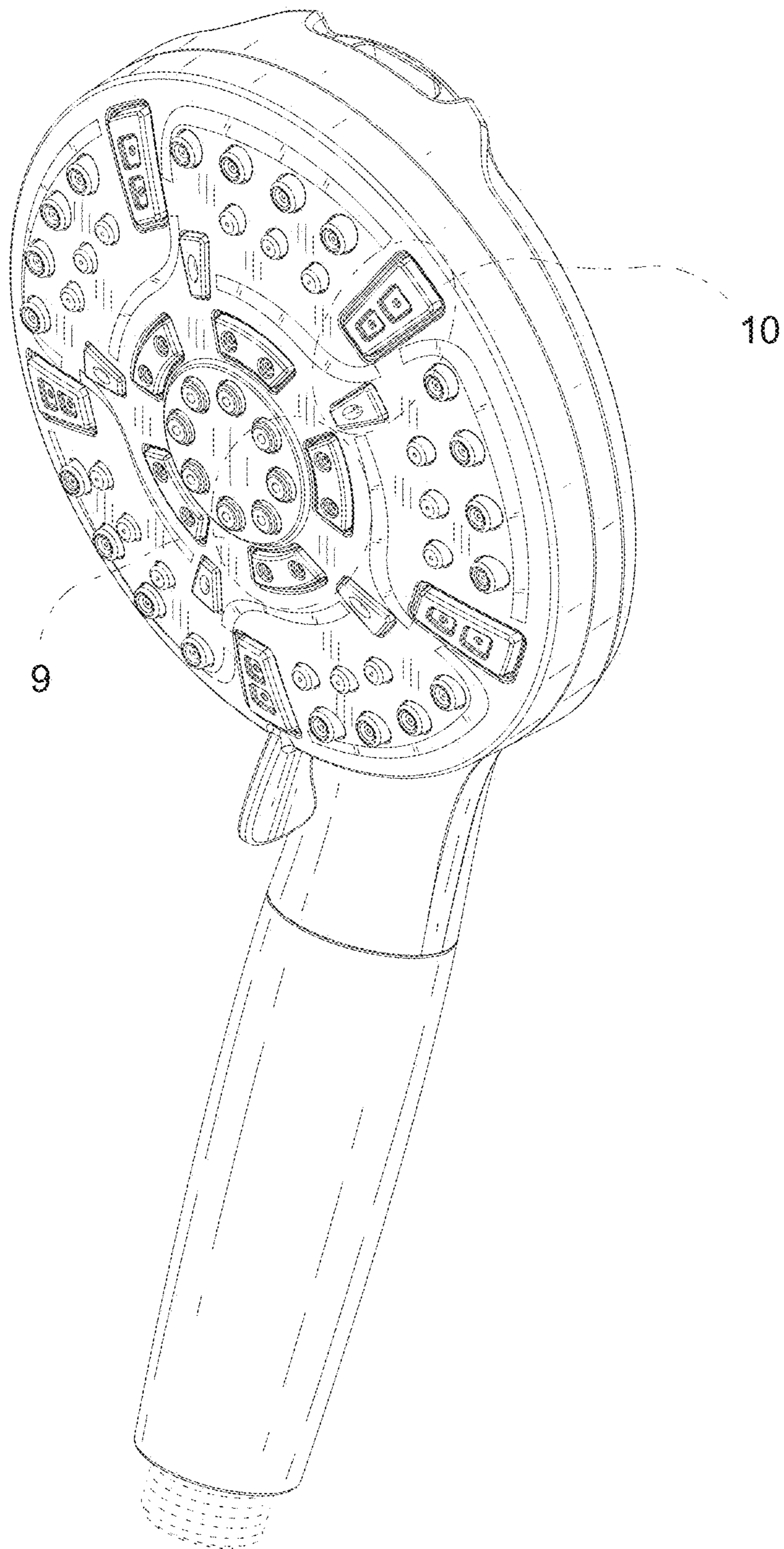

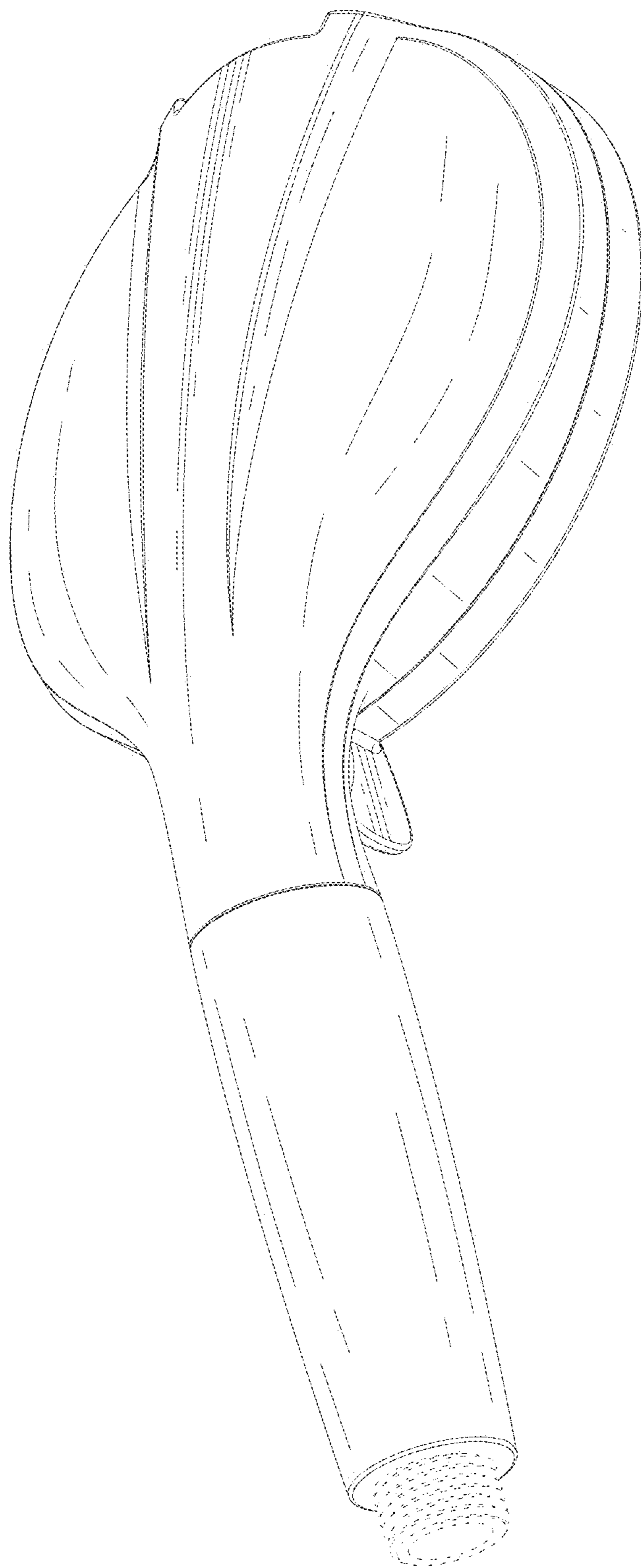

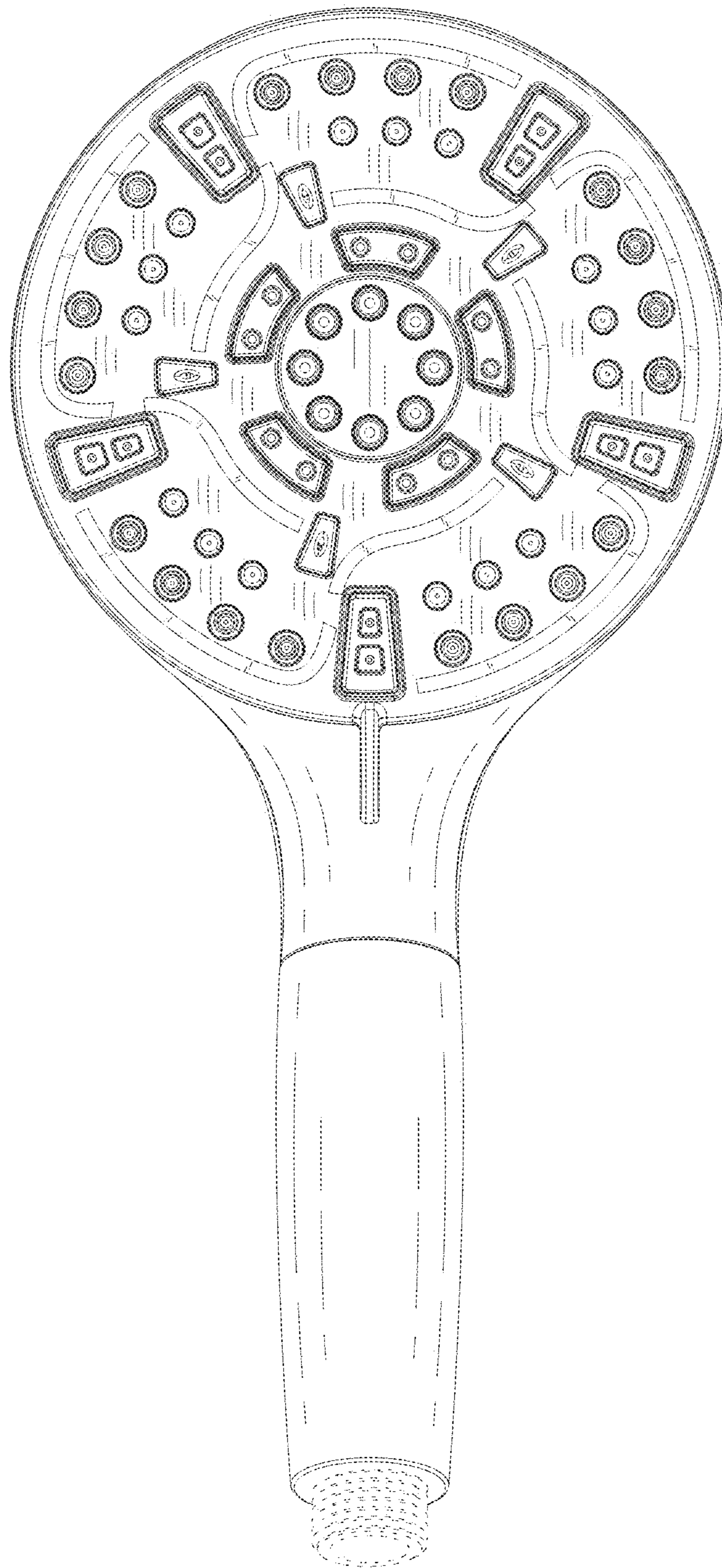

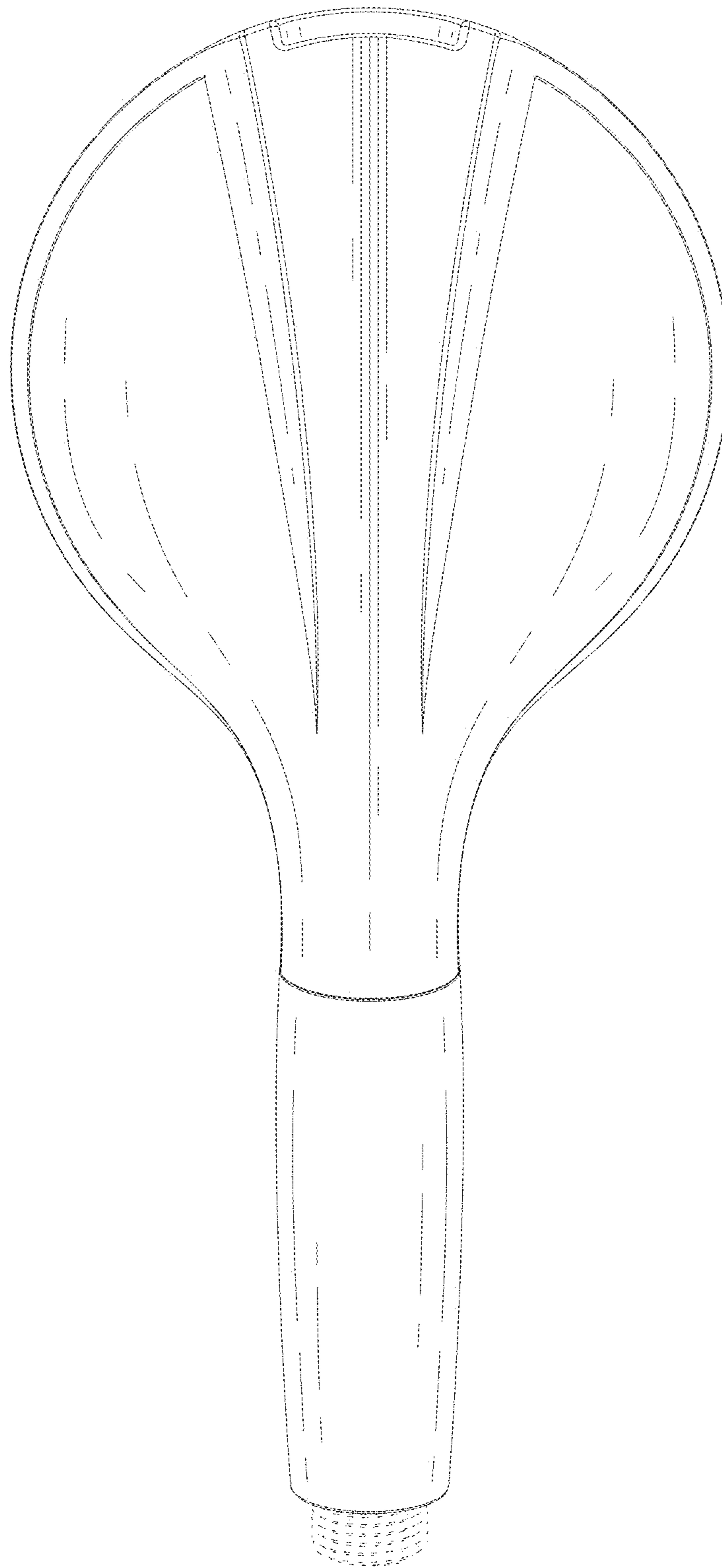

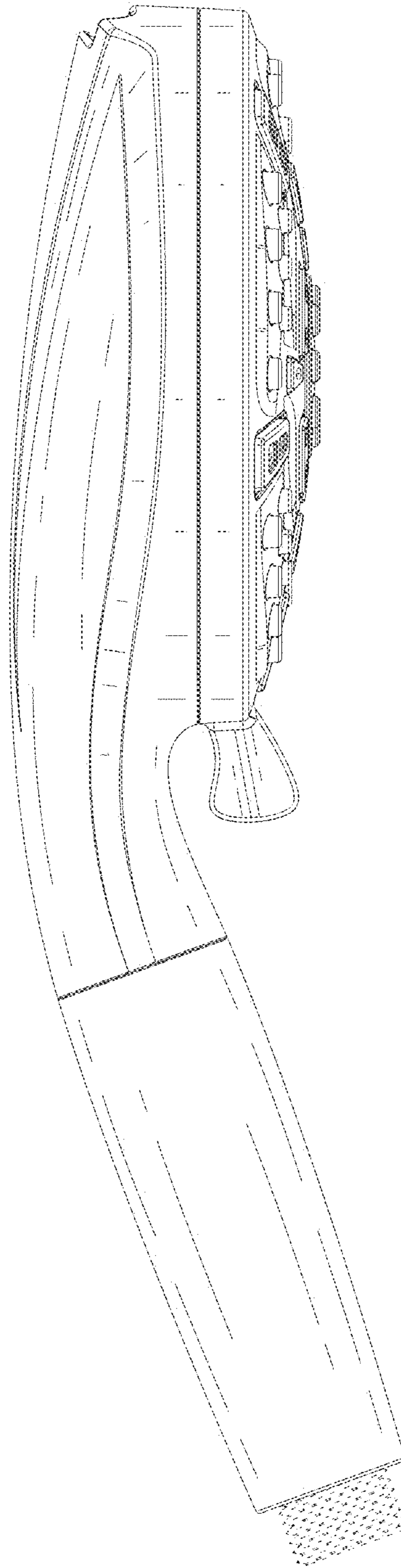

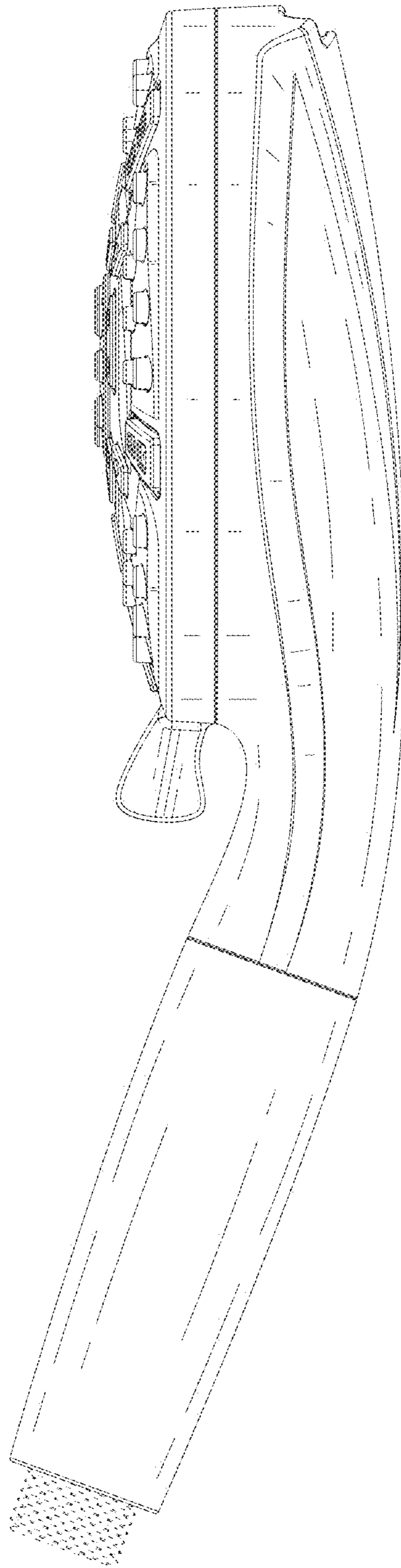

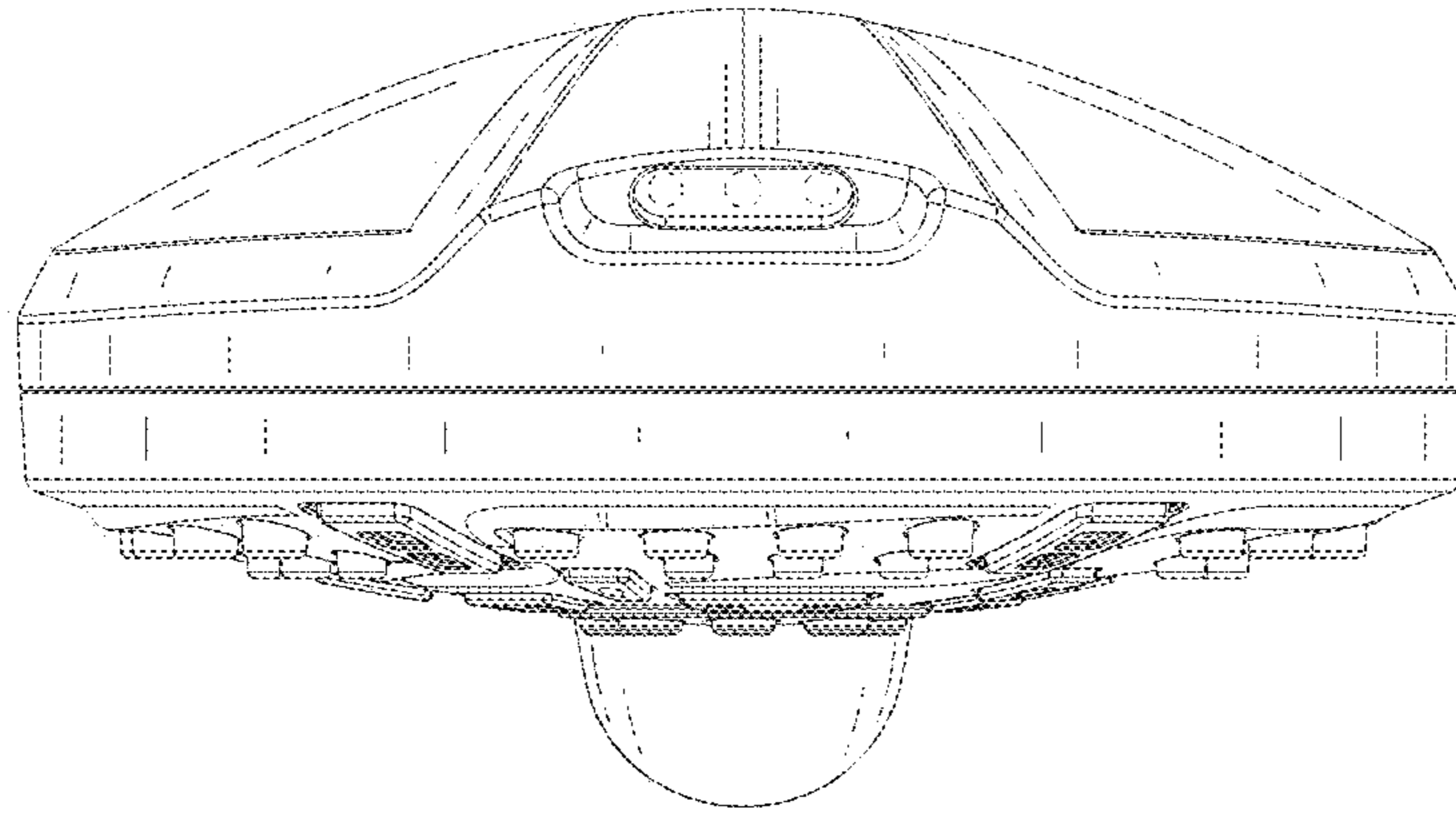

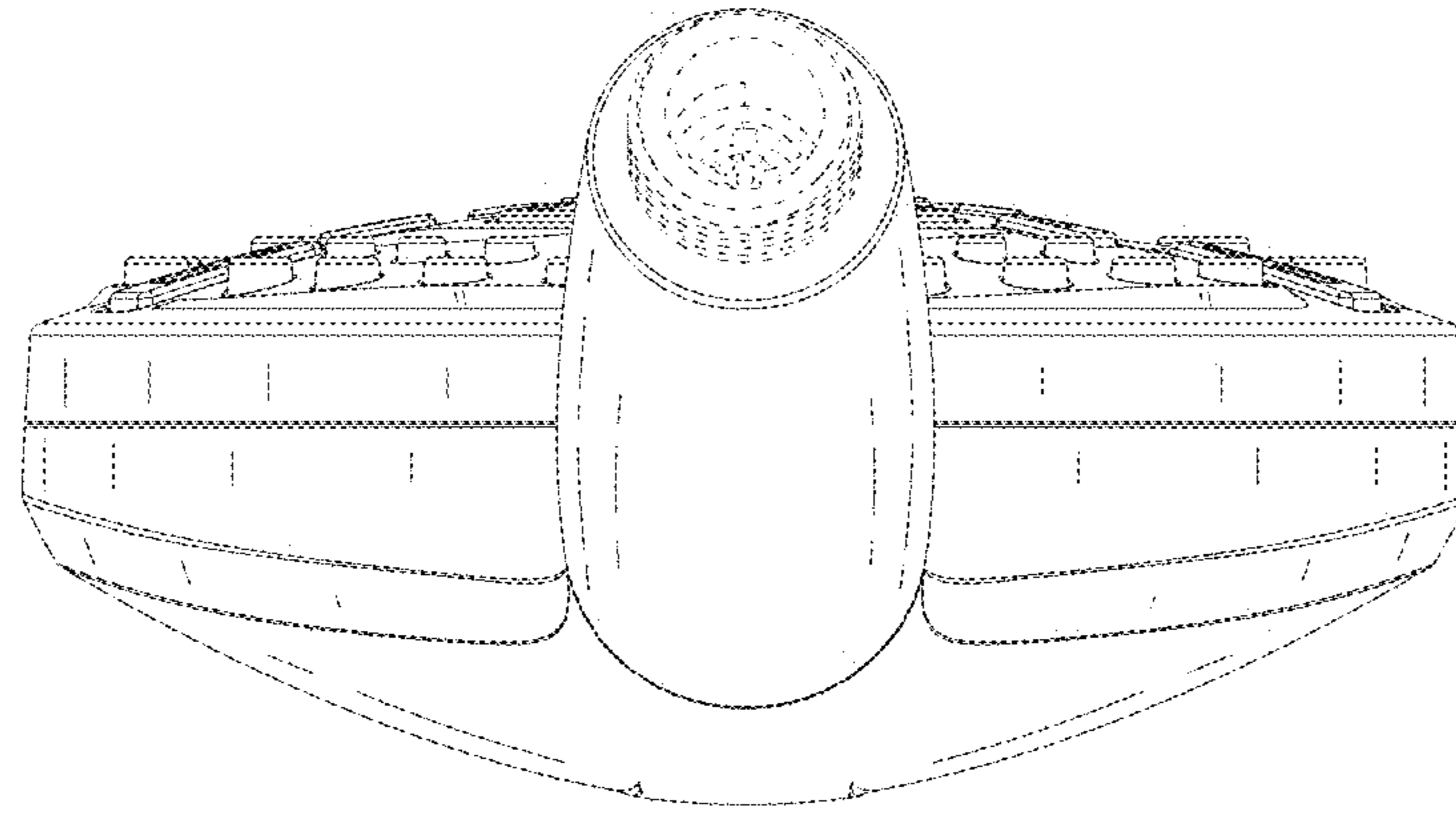

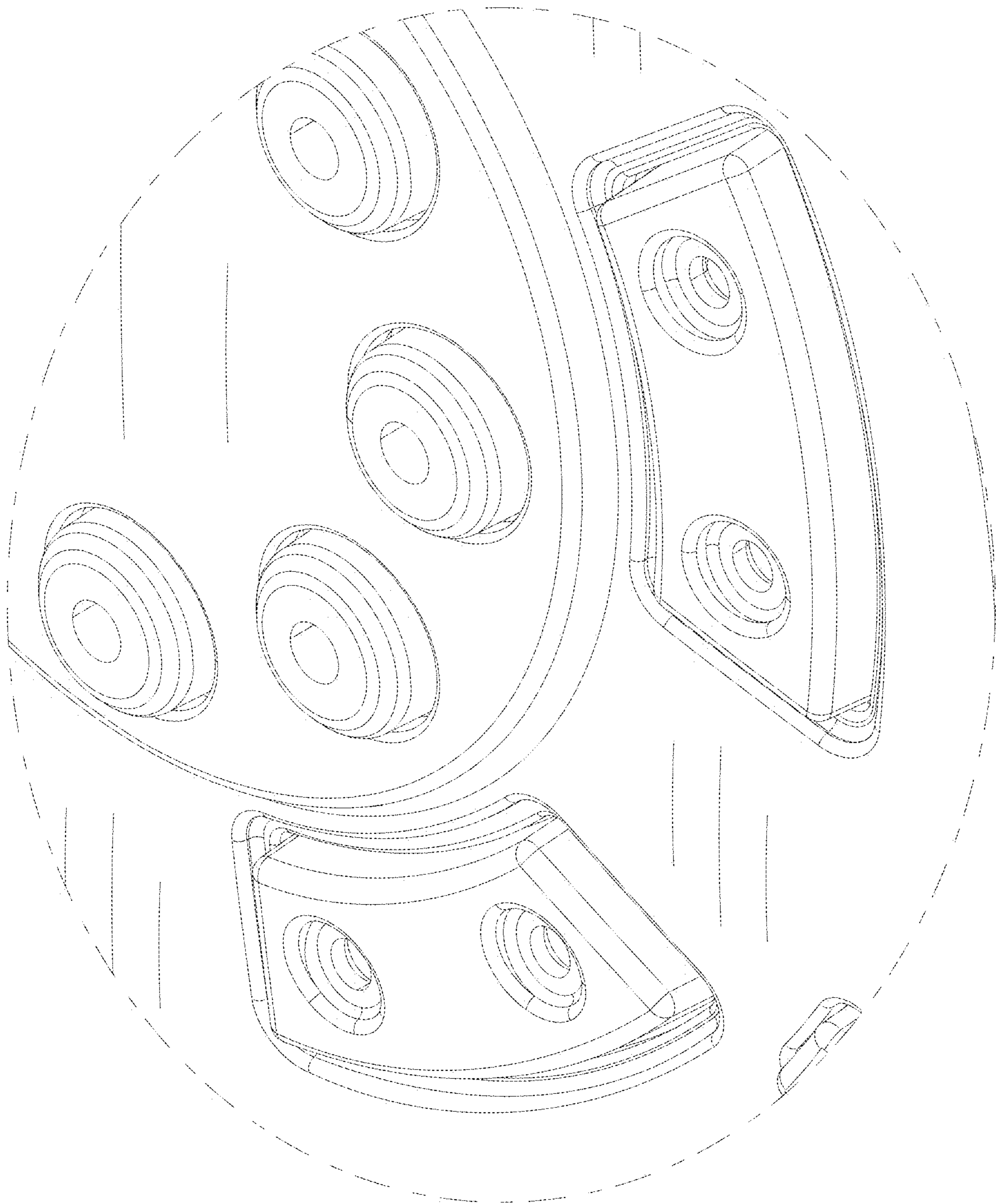

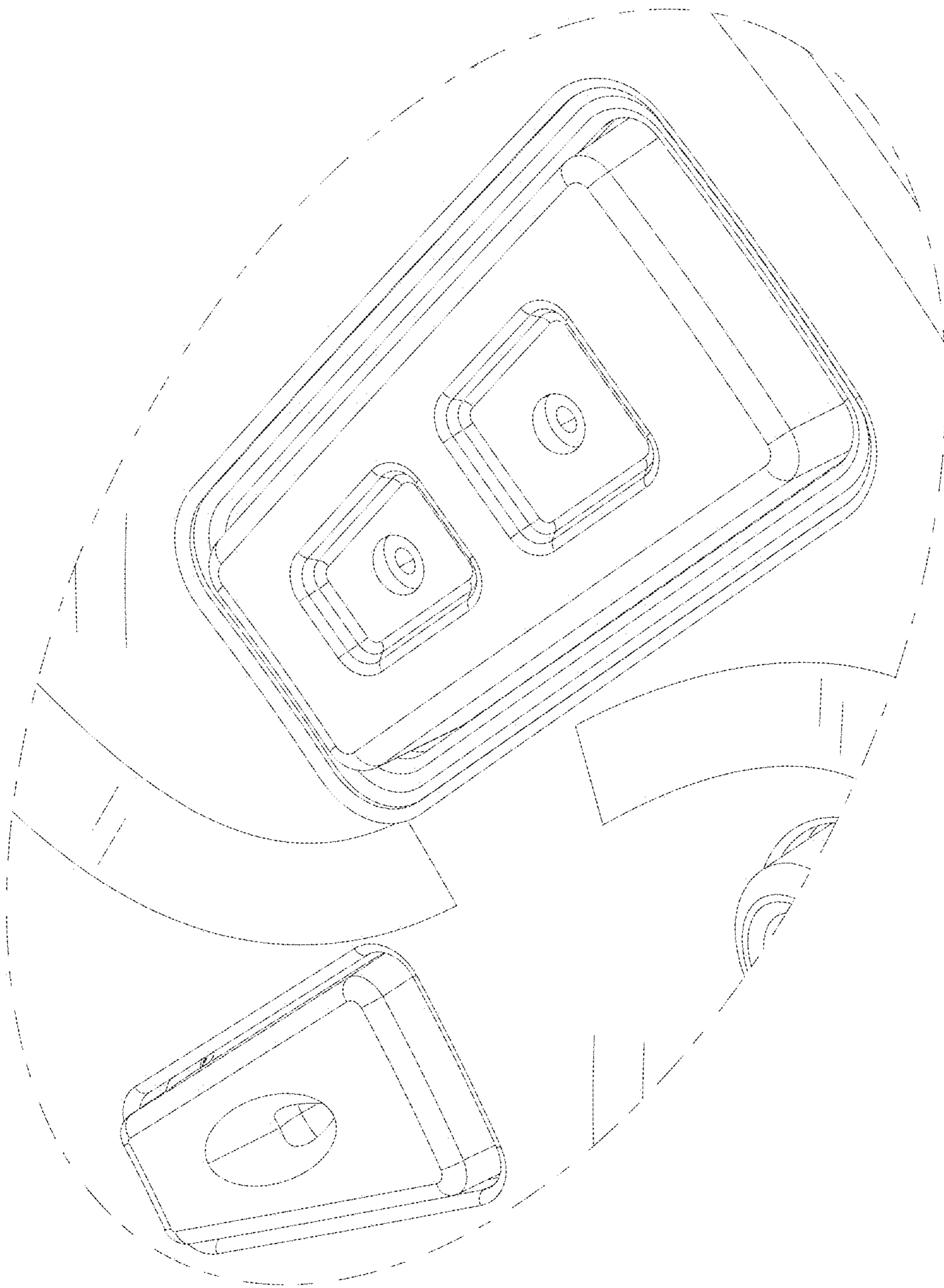
