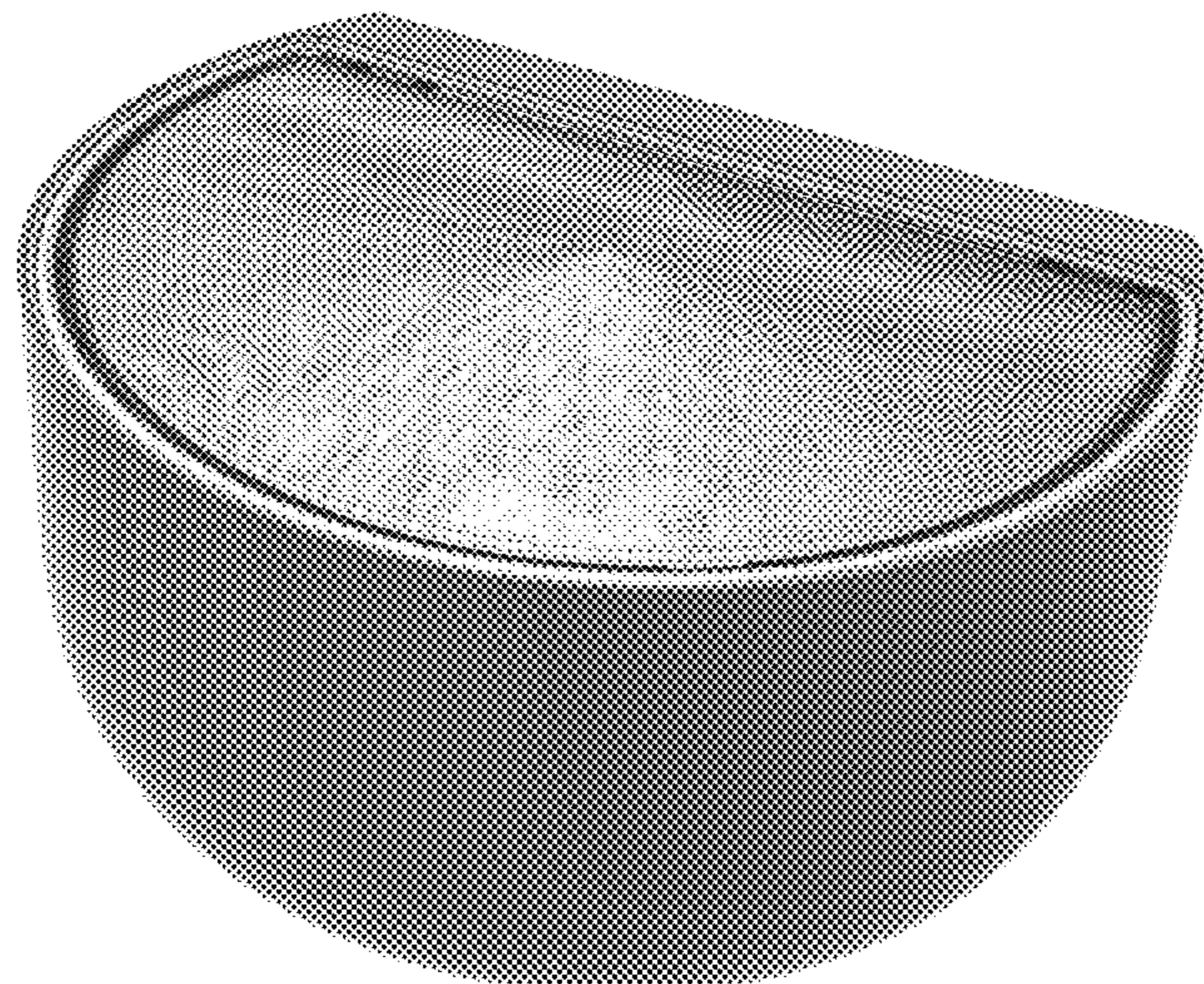
(57) **CLAIM**

The ornamental design for a wall lamp, as shown and described.

DESCRIPTION

1. Wall lamp
Fig. 1.1 is a perspective view of the wall lamp;
Fig. 1.2 is a left view thereof;
Fig. 1.3 is a right view thereof;
Fig. 1.4 is a front view thereof;
Fig. 1.5 is a rear view thereof;
Fig. 1.6 is a top view thereof;
Fig. 1.7 is a bottom view thereof; and
Fig. 1.8 is a perspective view thereof representing the wall lamp with the light on; the light reflection and the shade on the reproductions are for illustrative purposes only and form no part of the claimed design.

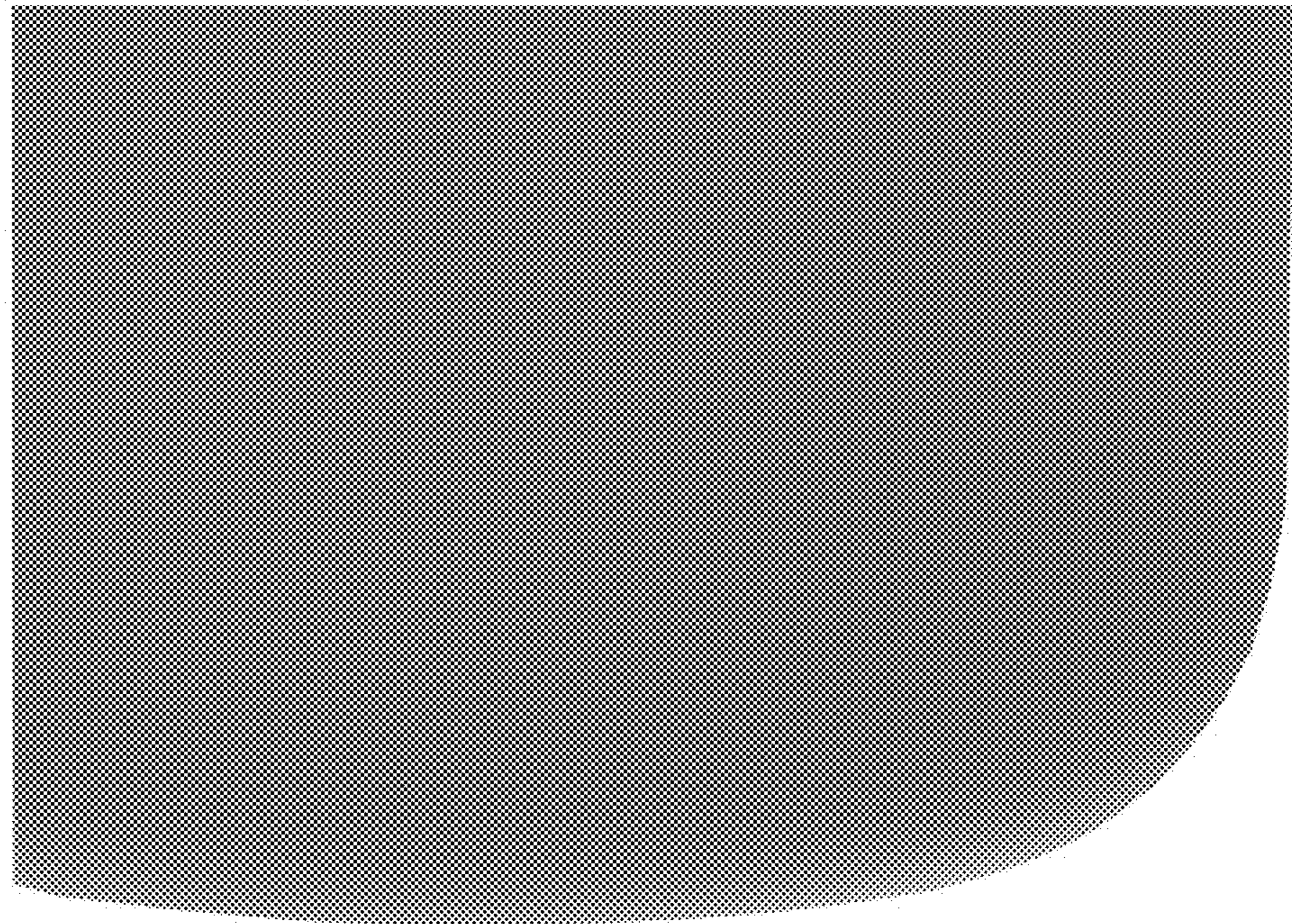

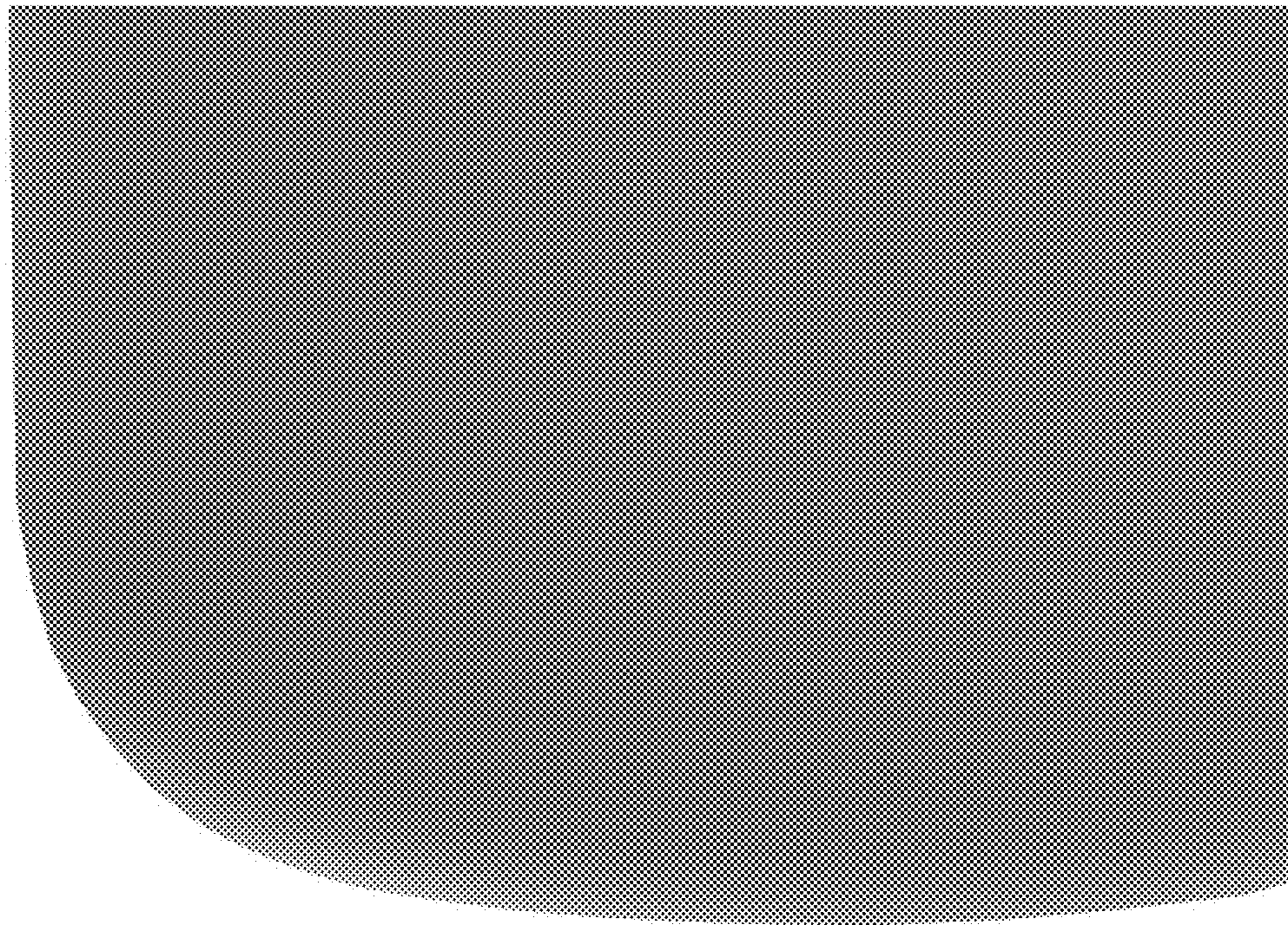

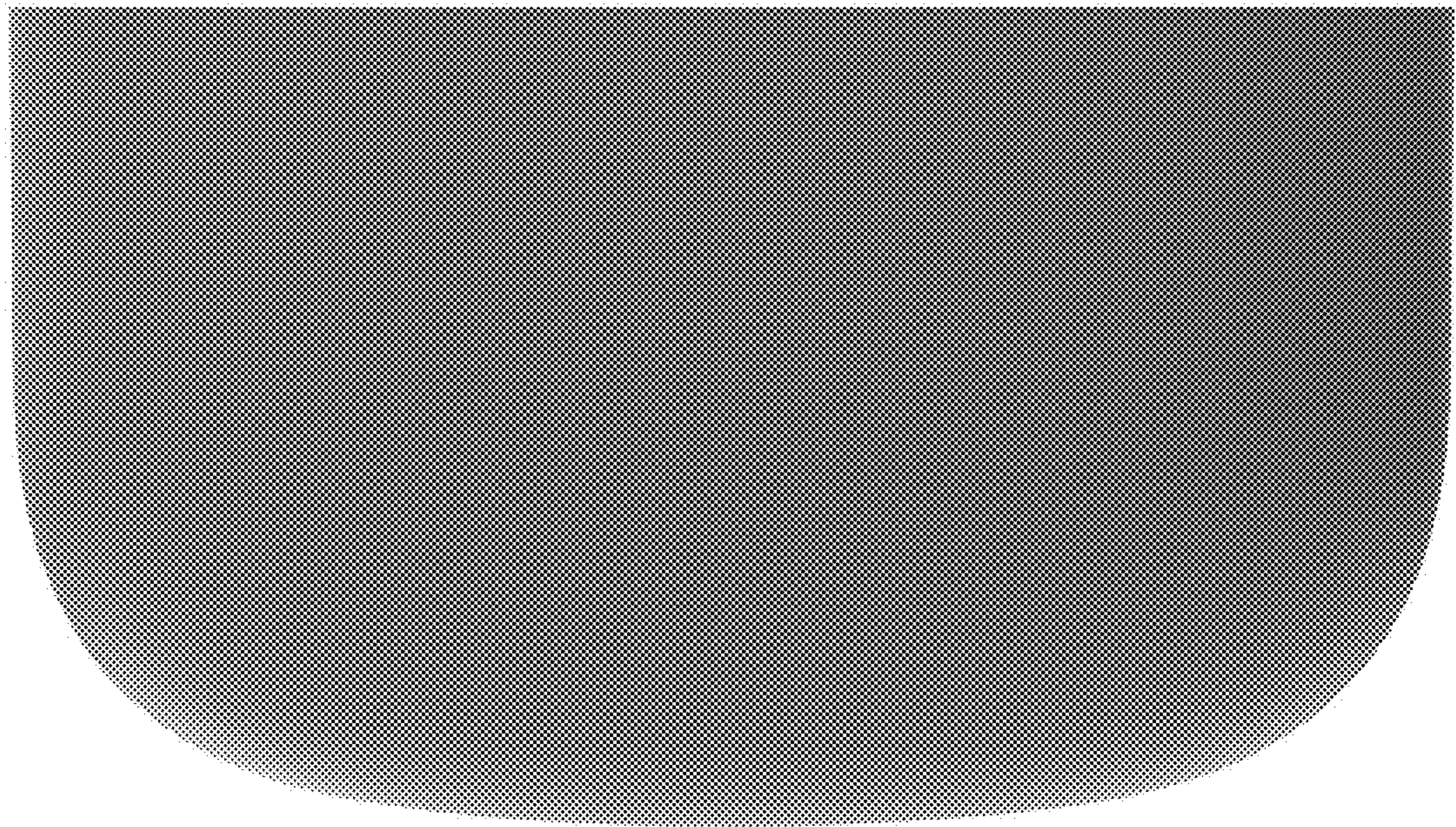

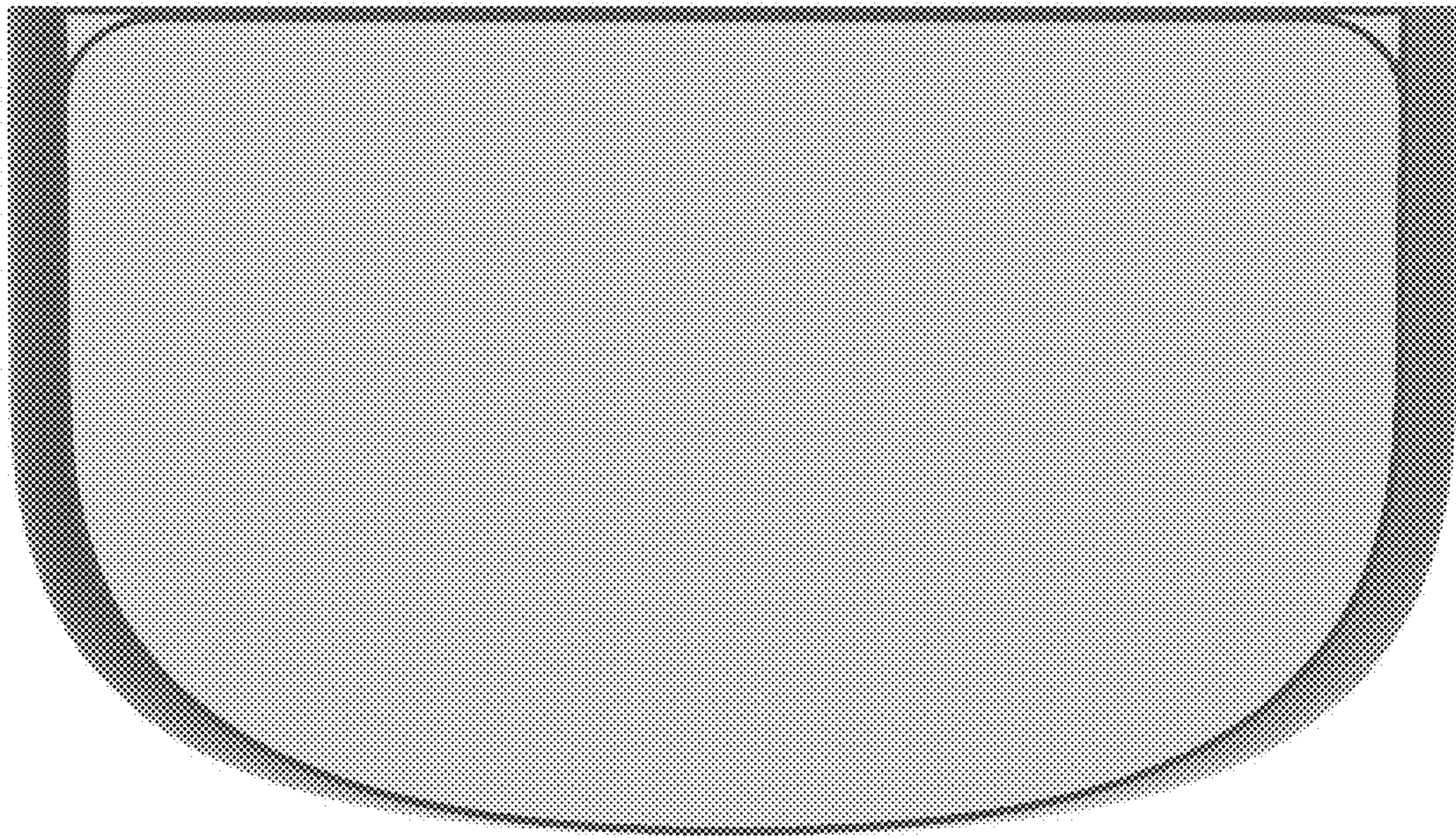

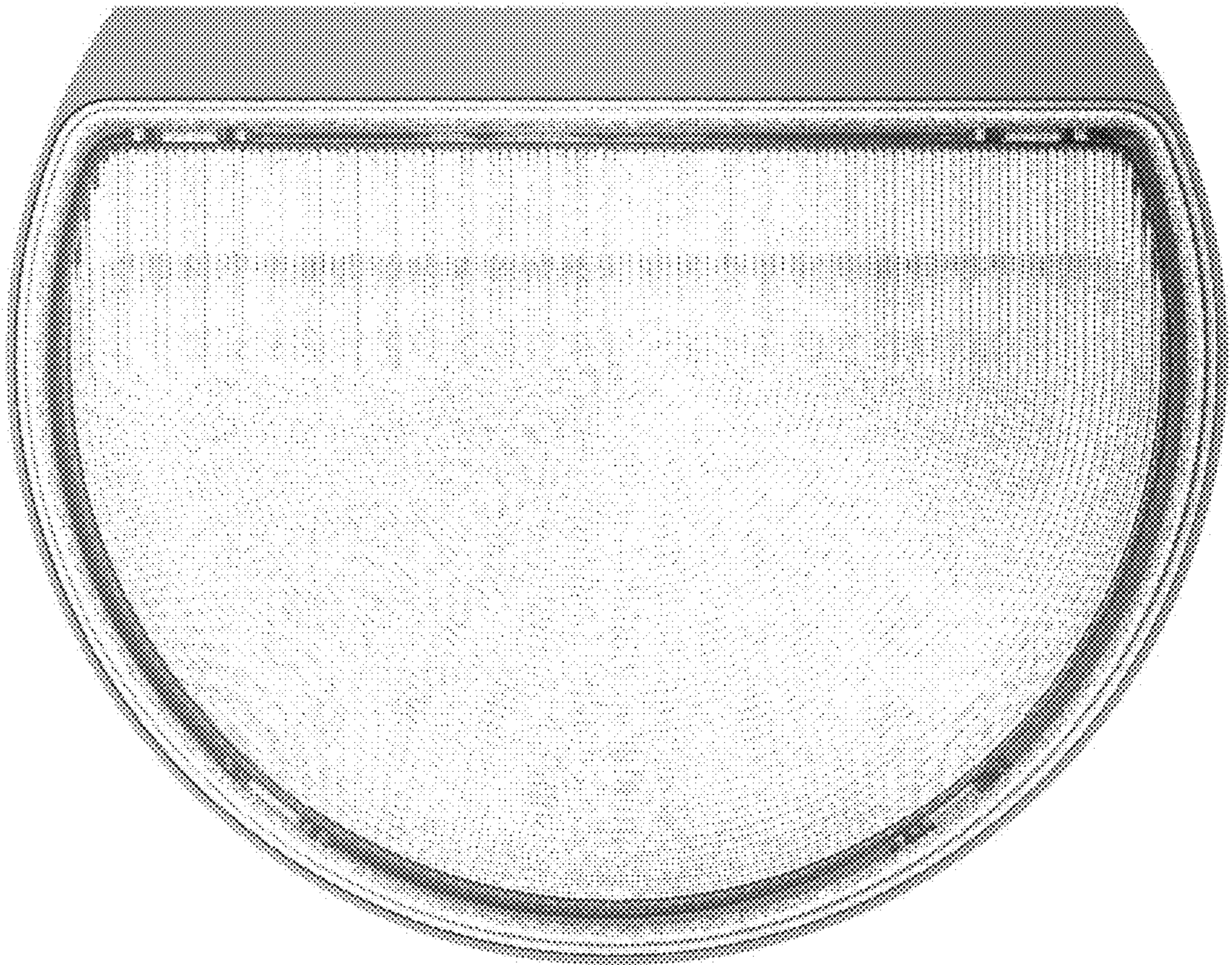

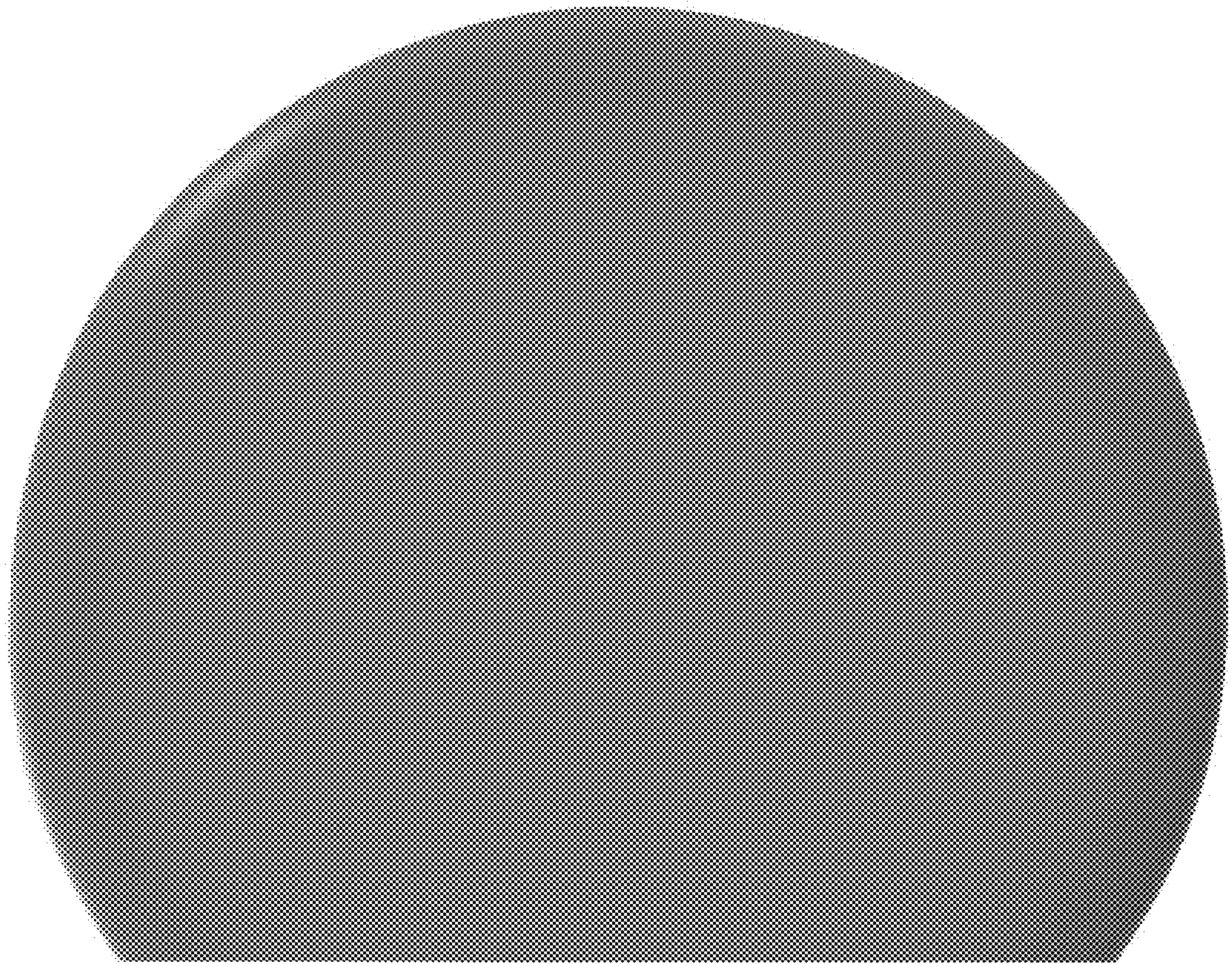
