DESCRIPTION

FIG. 1 is a top, front and right side perspective of a razor cartridge showing my new design;

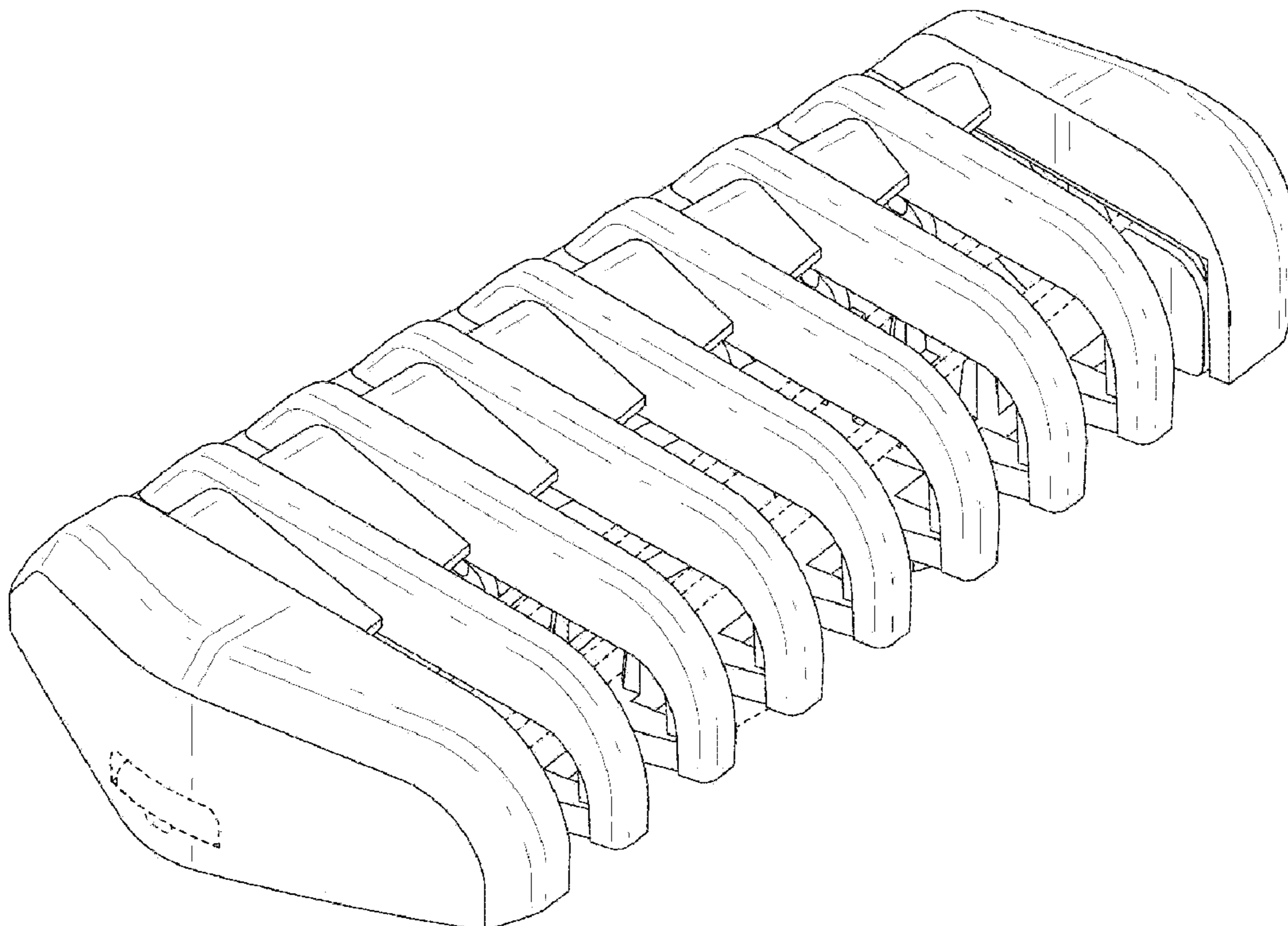

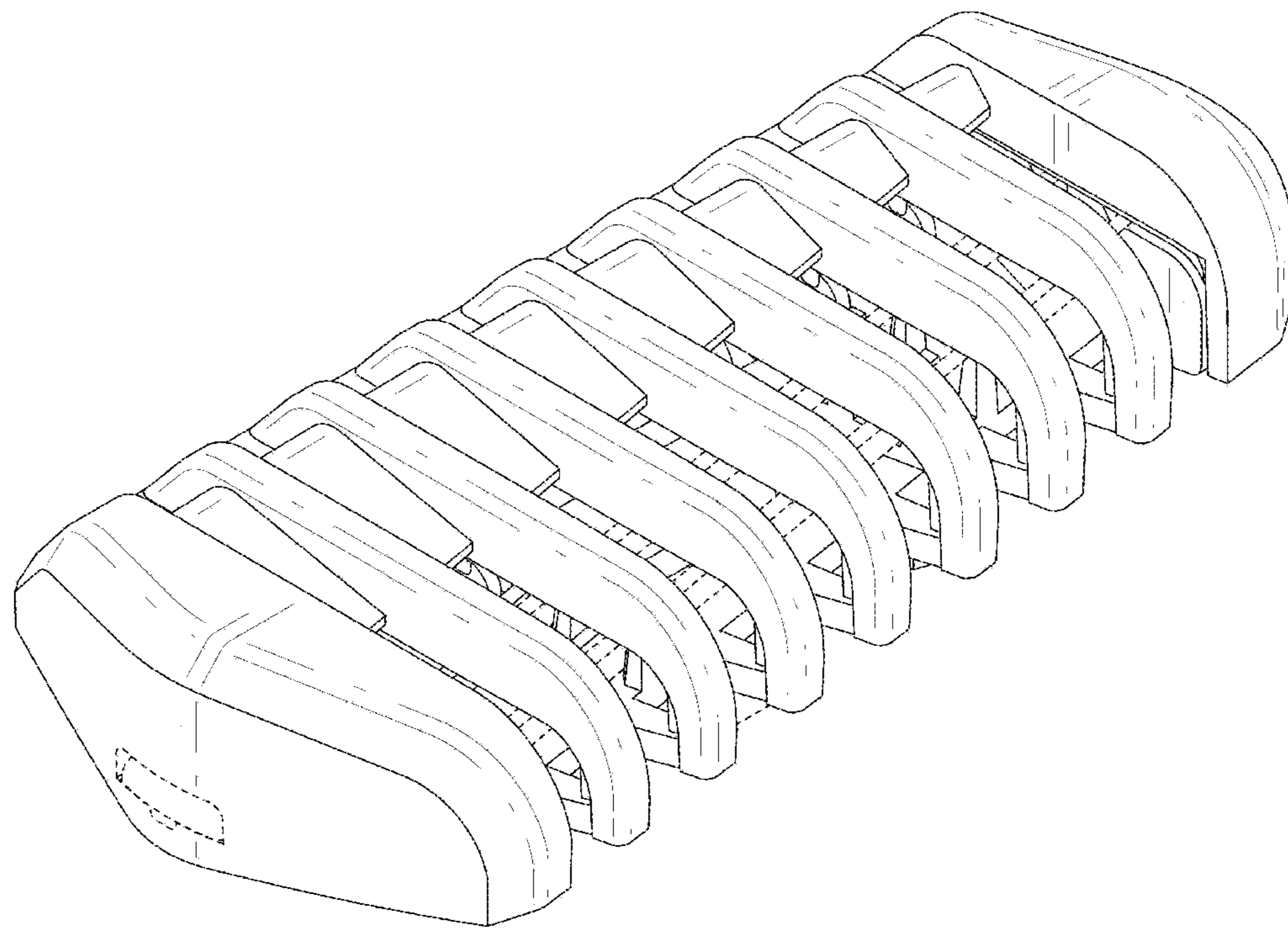

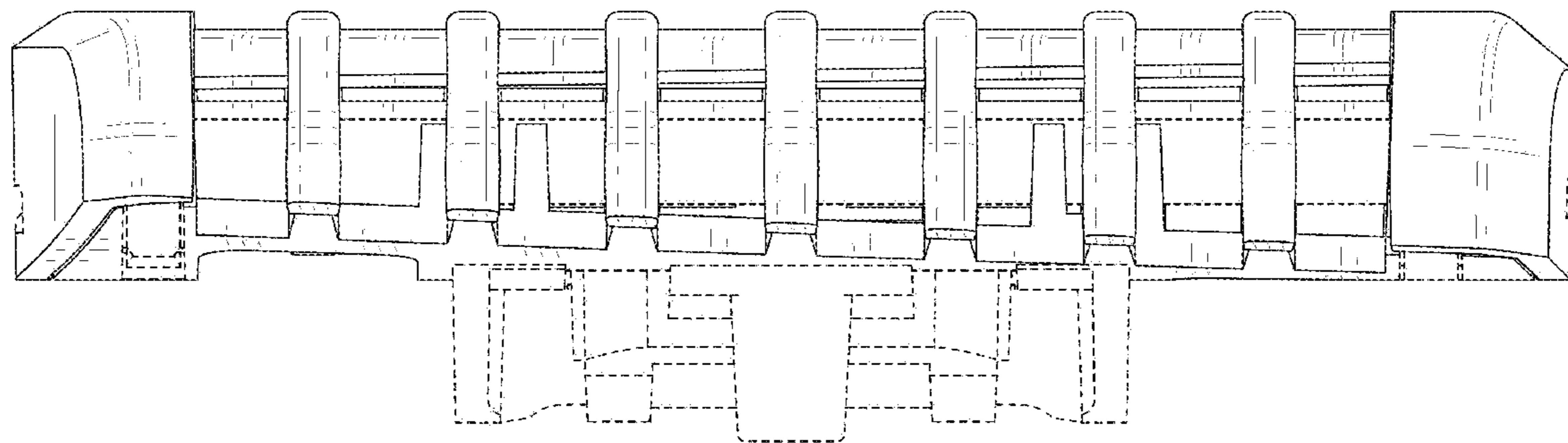

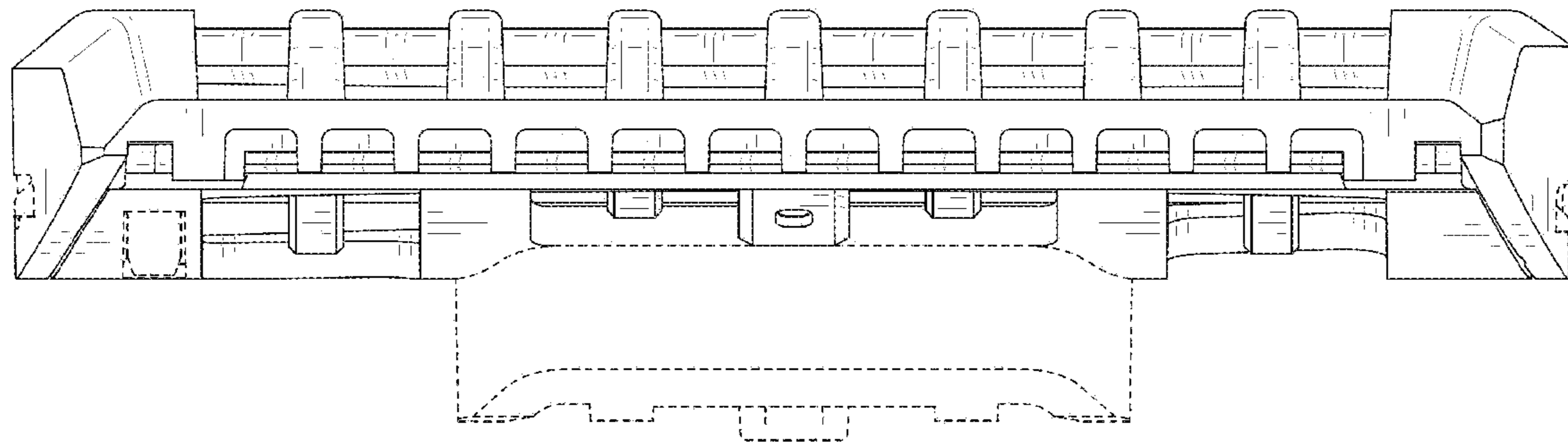

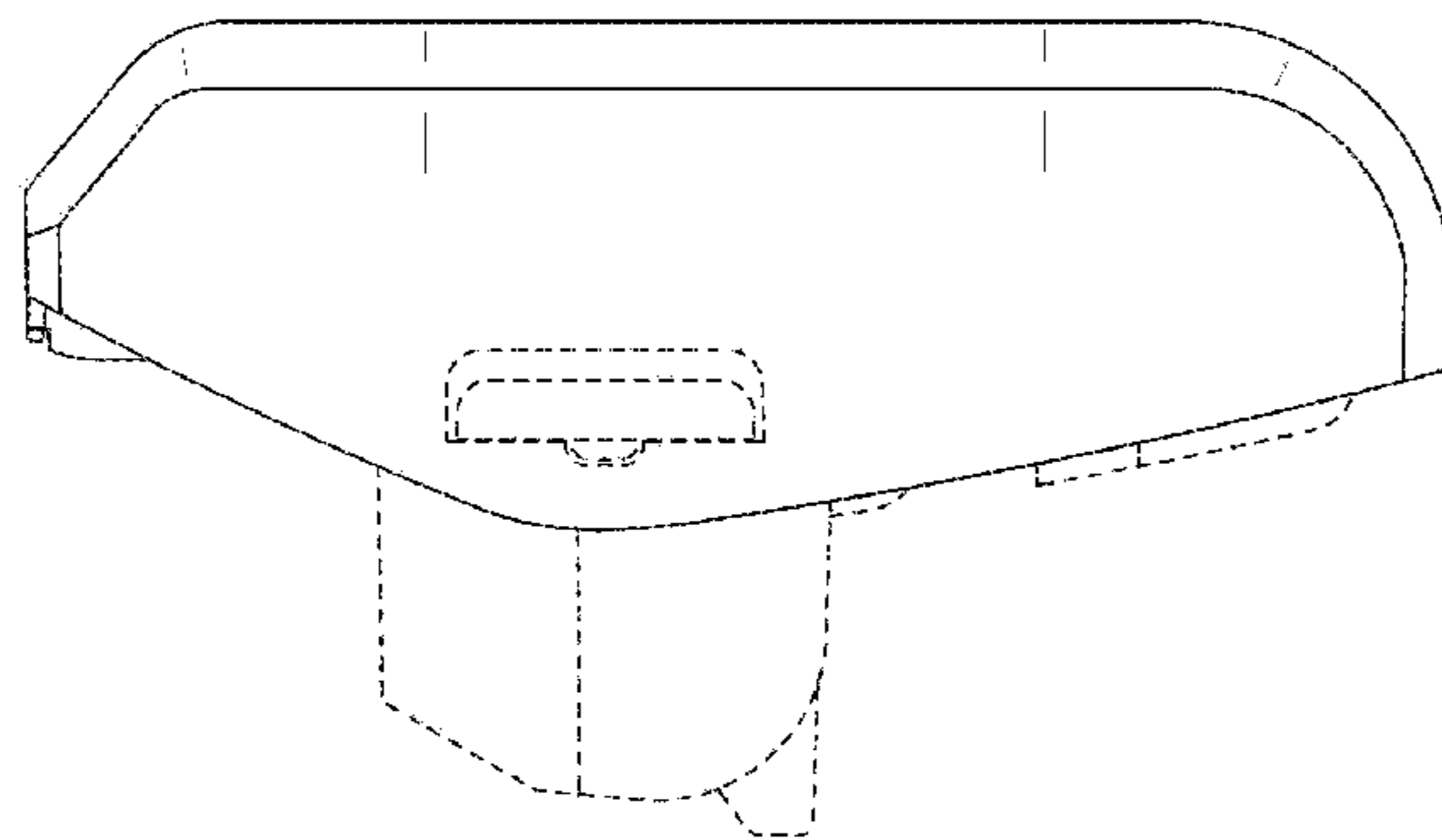

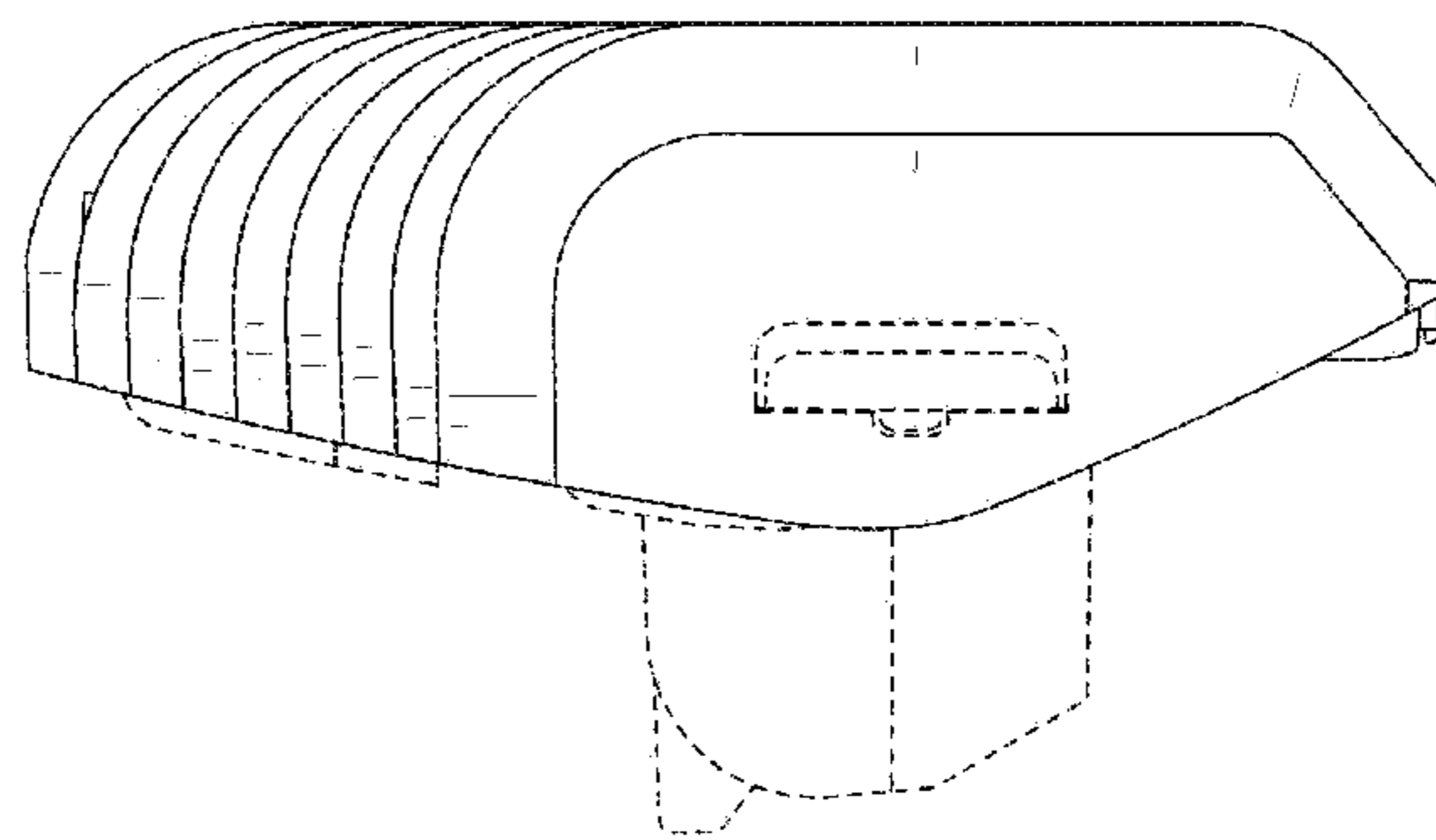

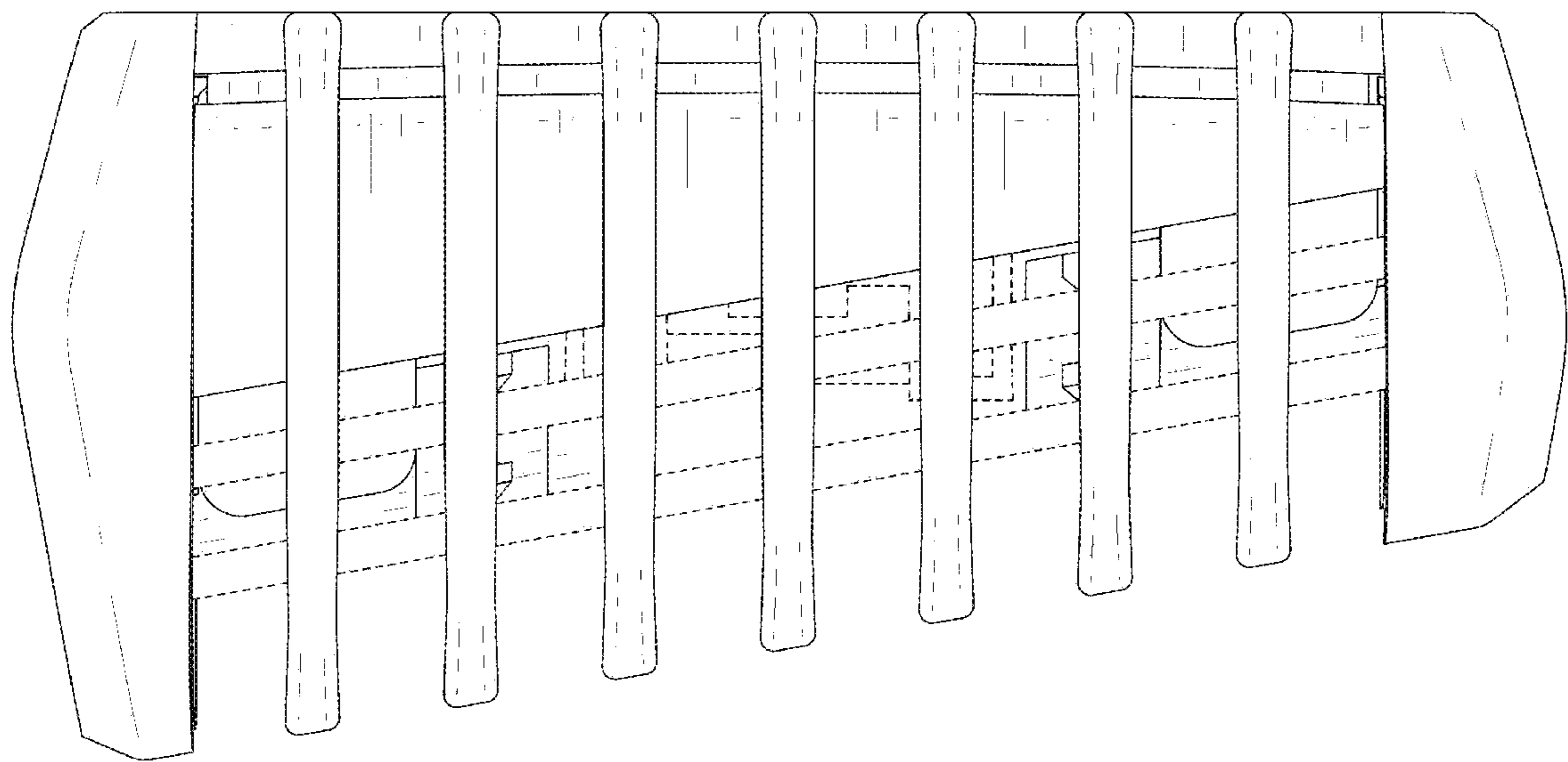

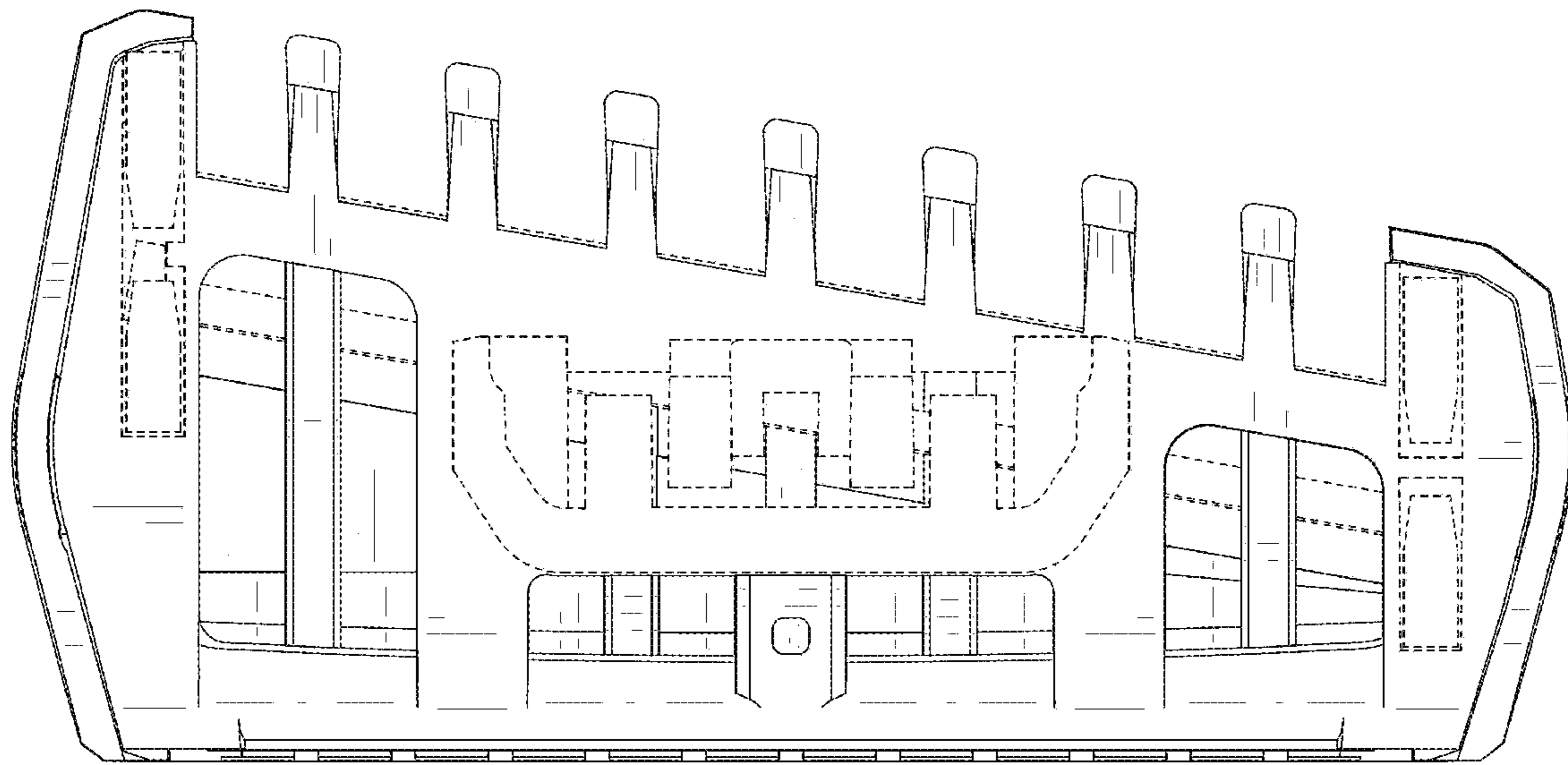
