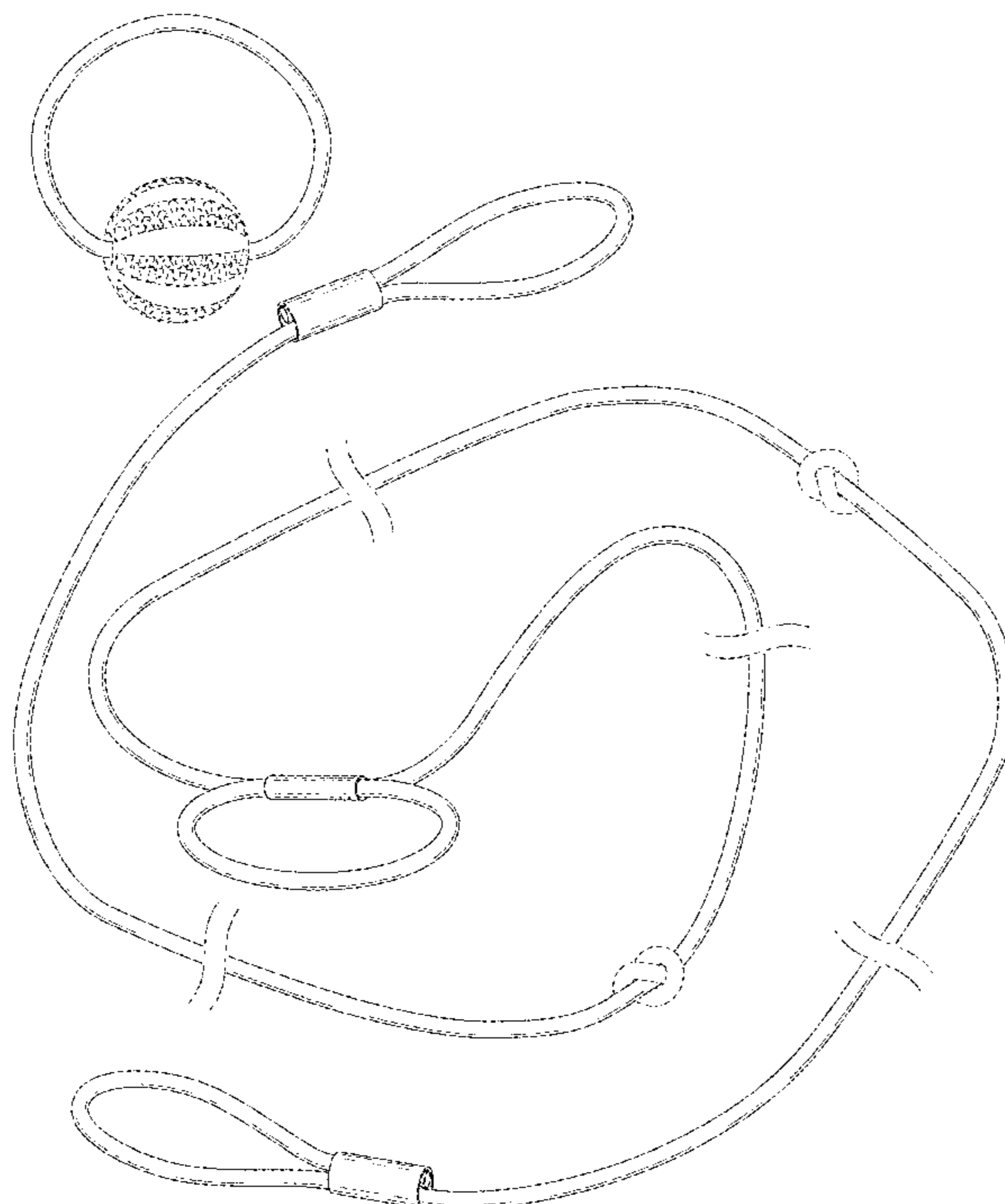
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of my new dog toy design;

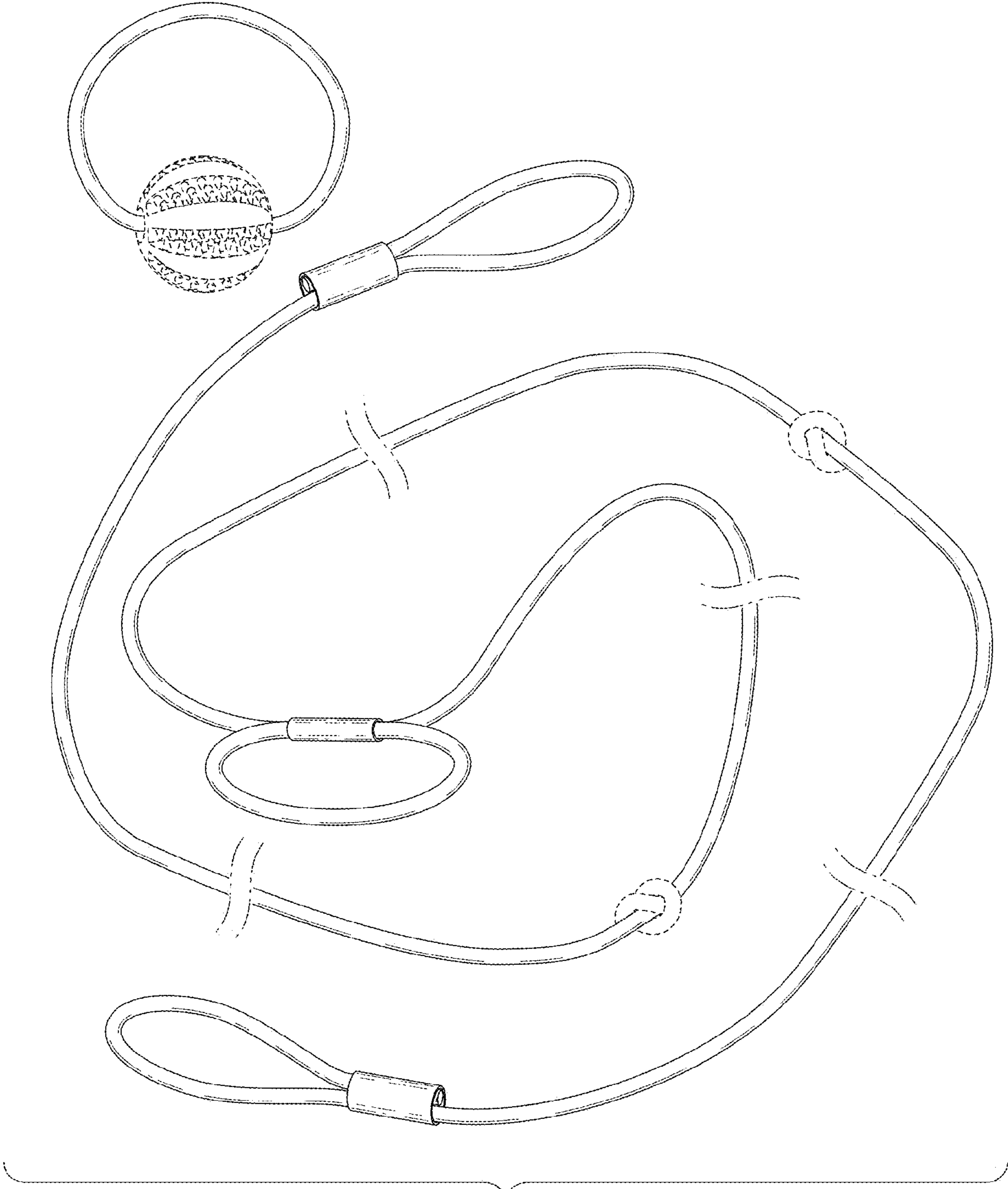

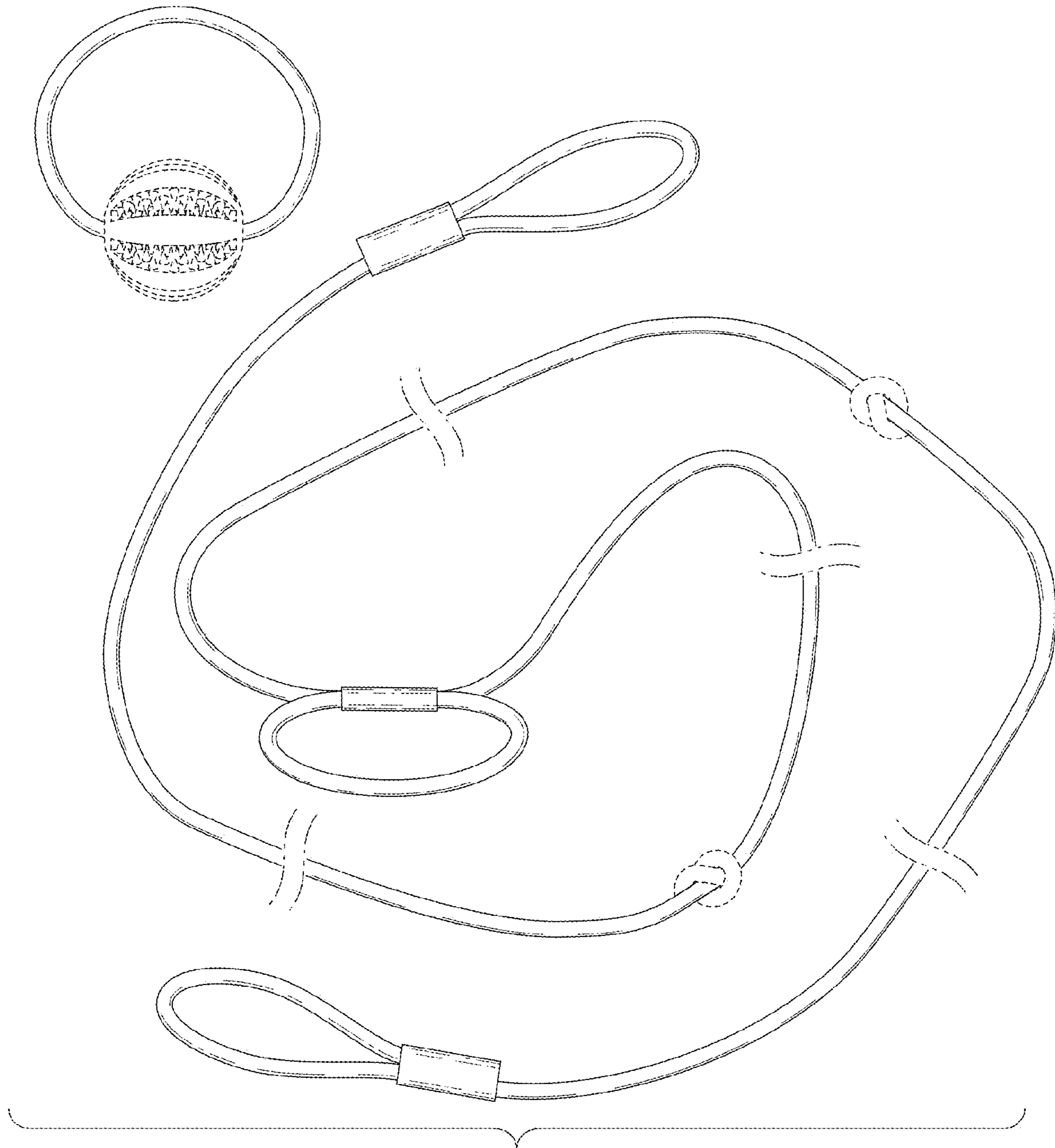

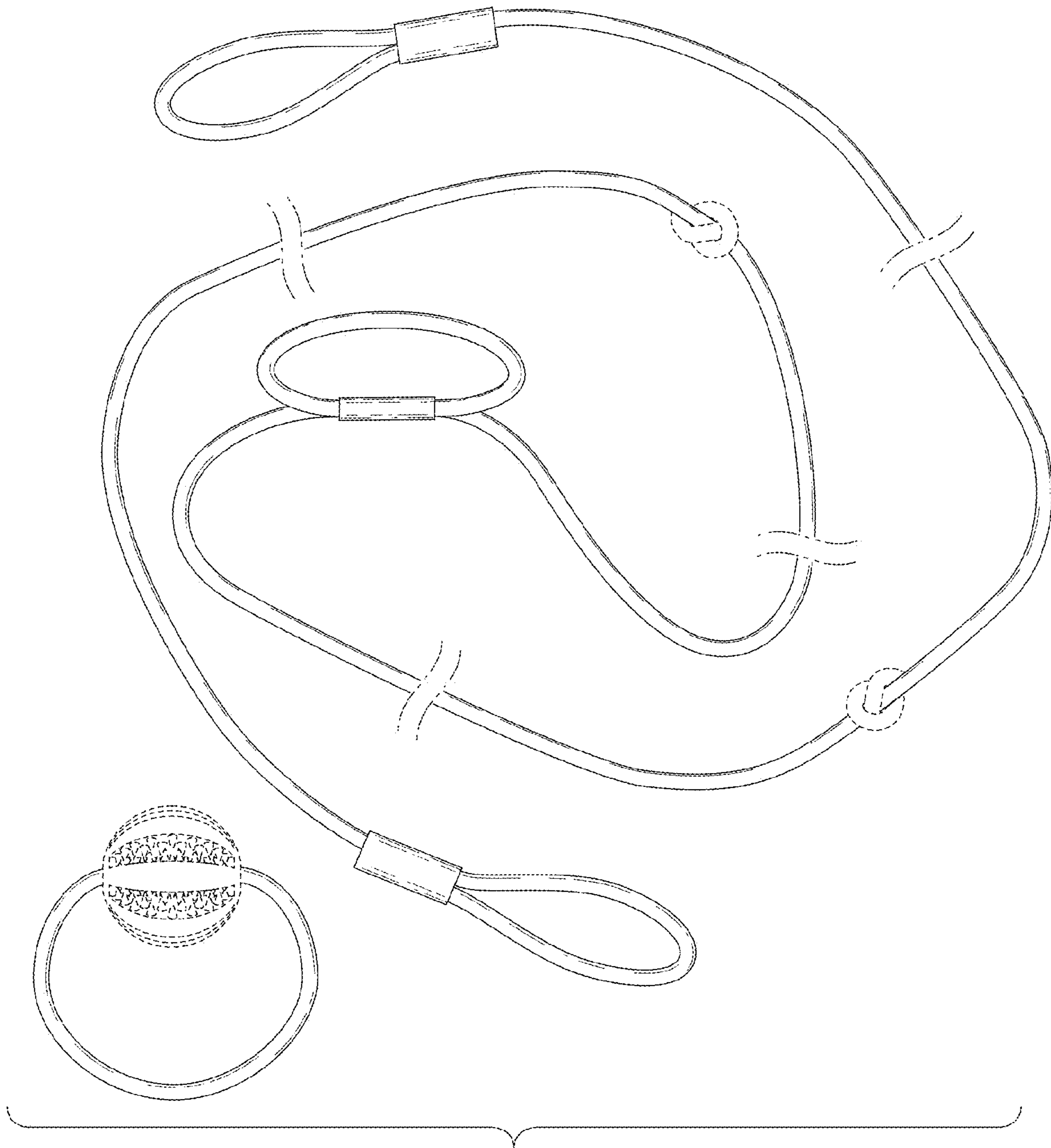

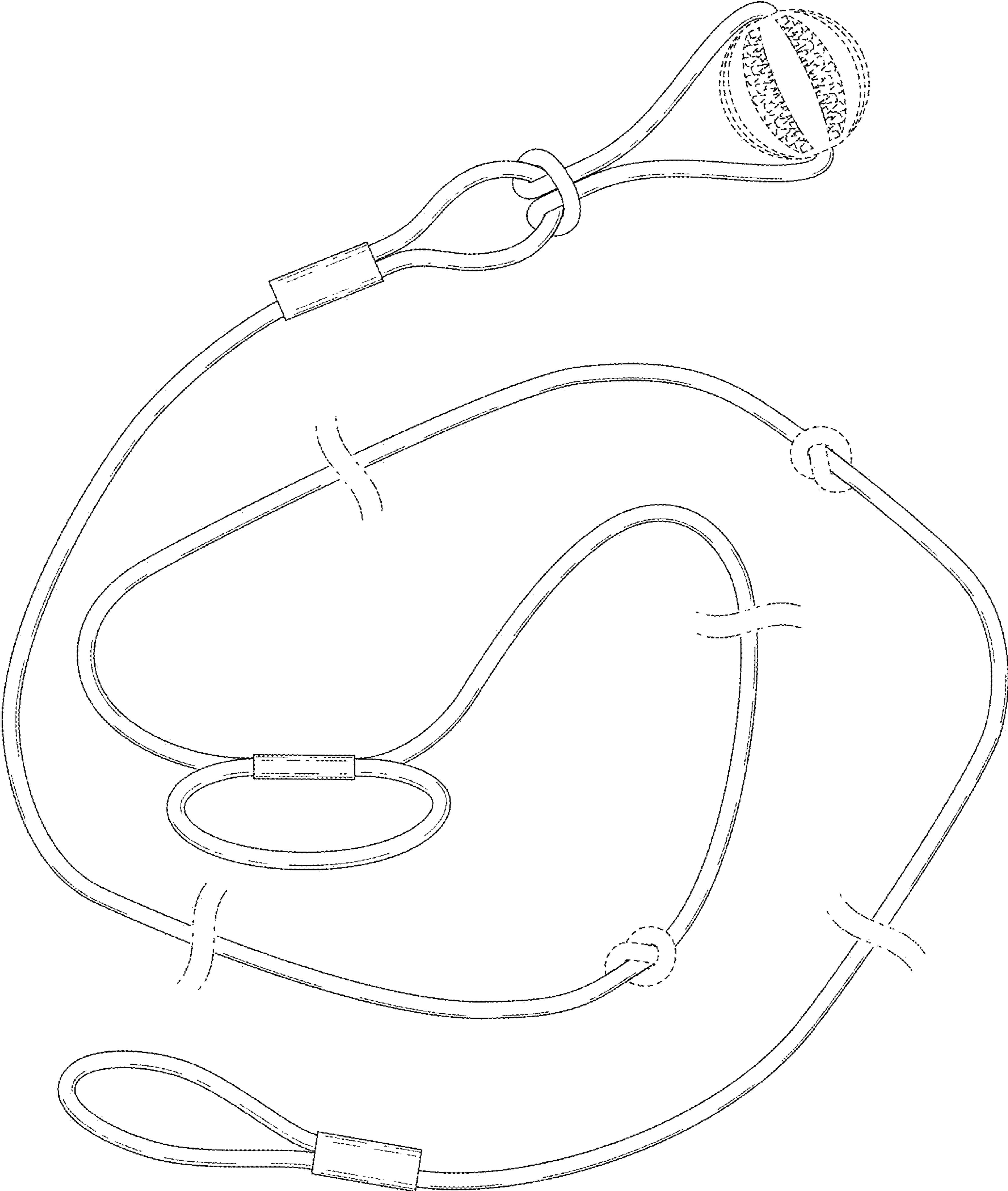
