DESCRIPTION

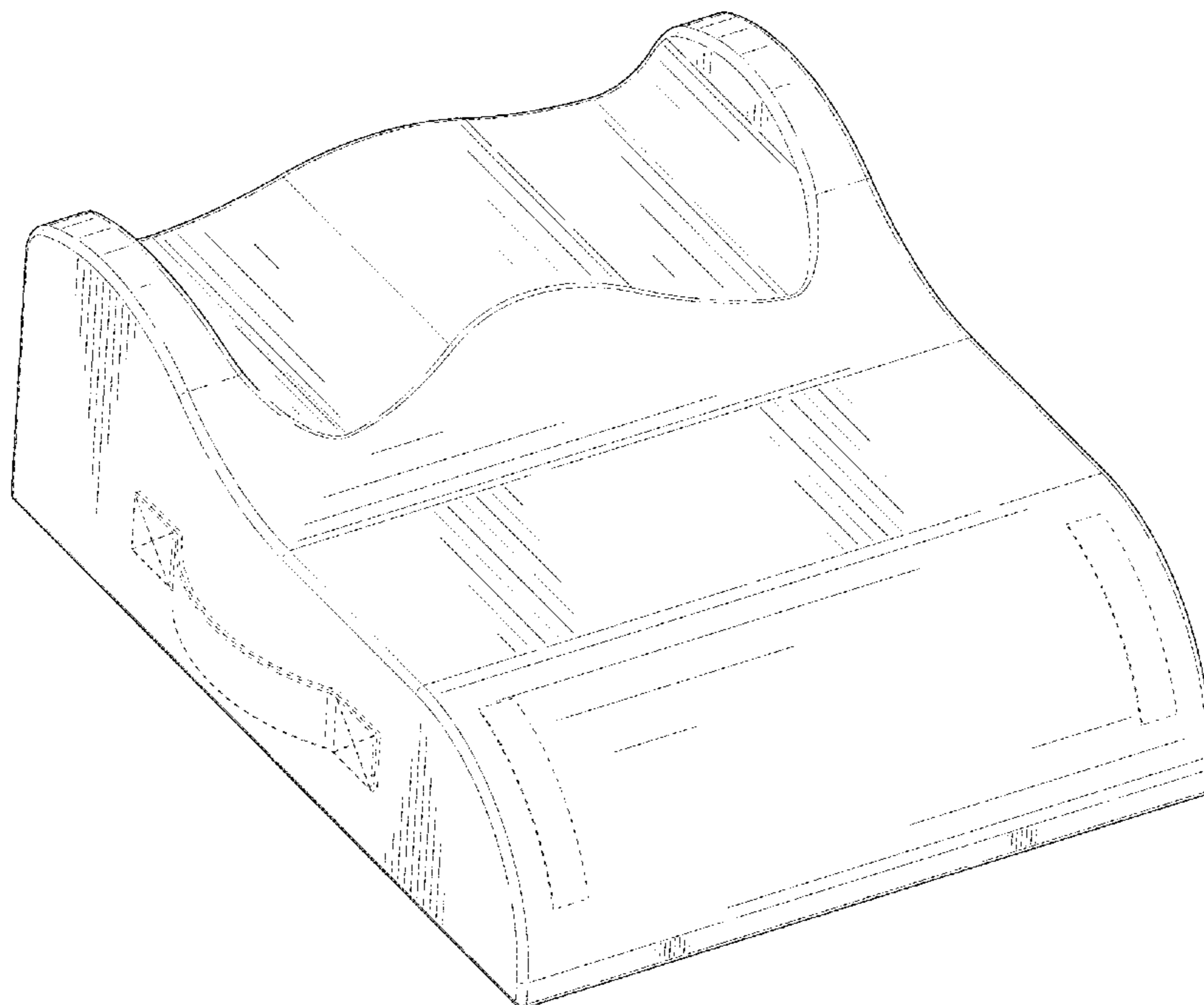
FIG. 1 is a perspective view of a leg pillow showing my new design;

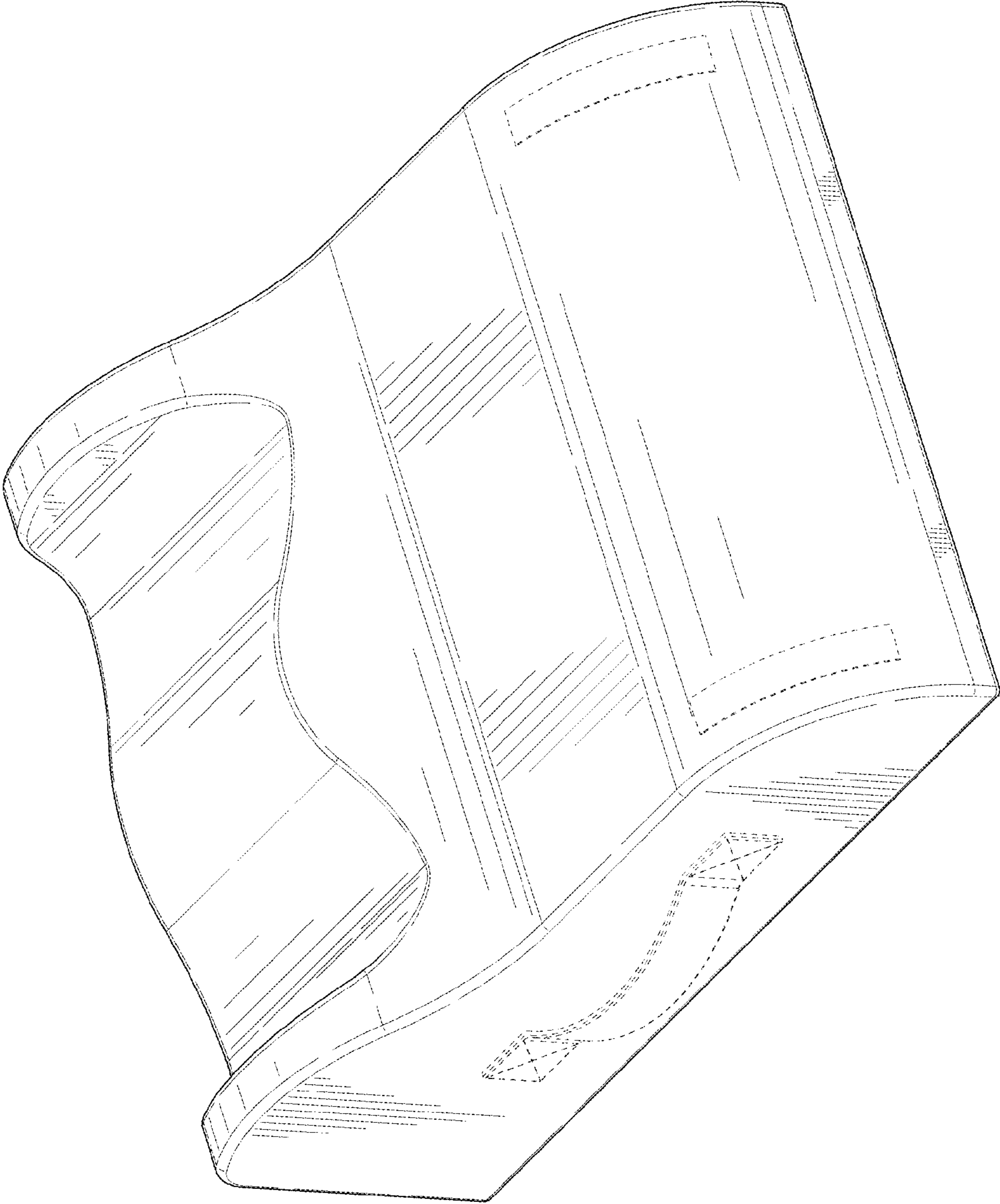

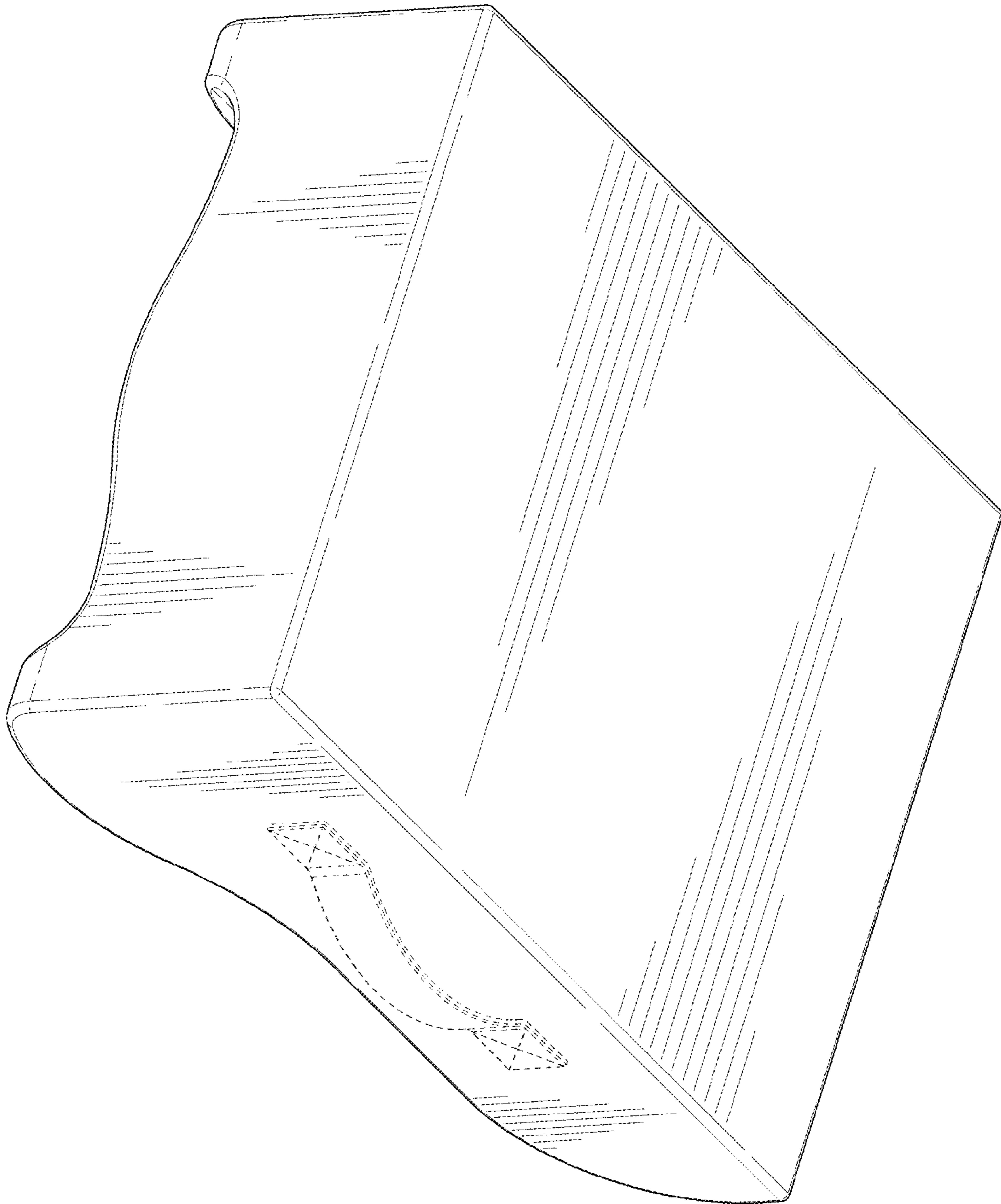

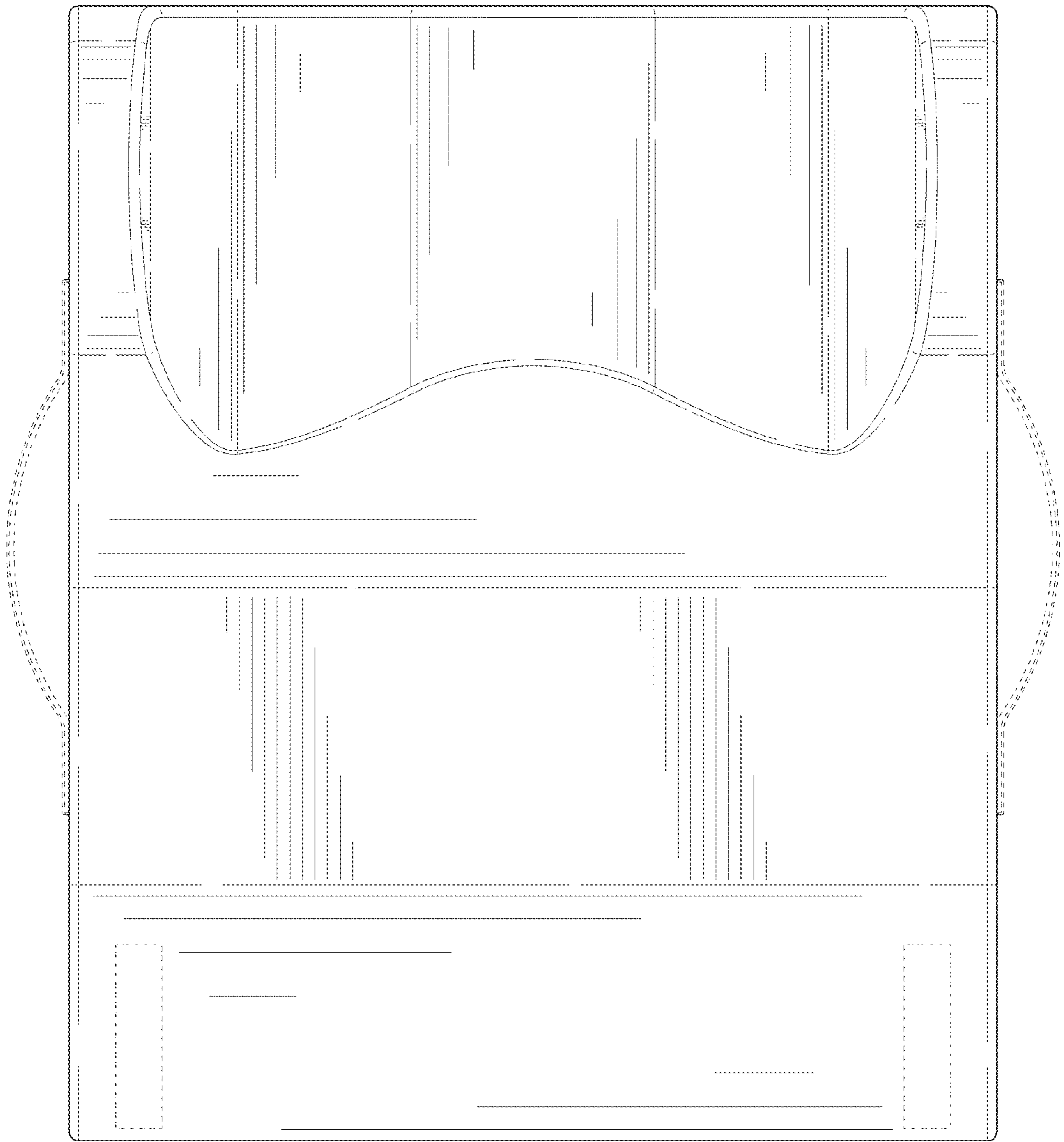

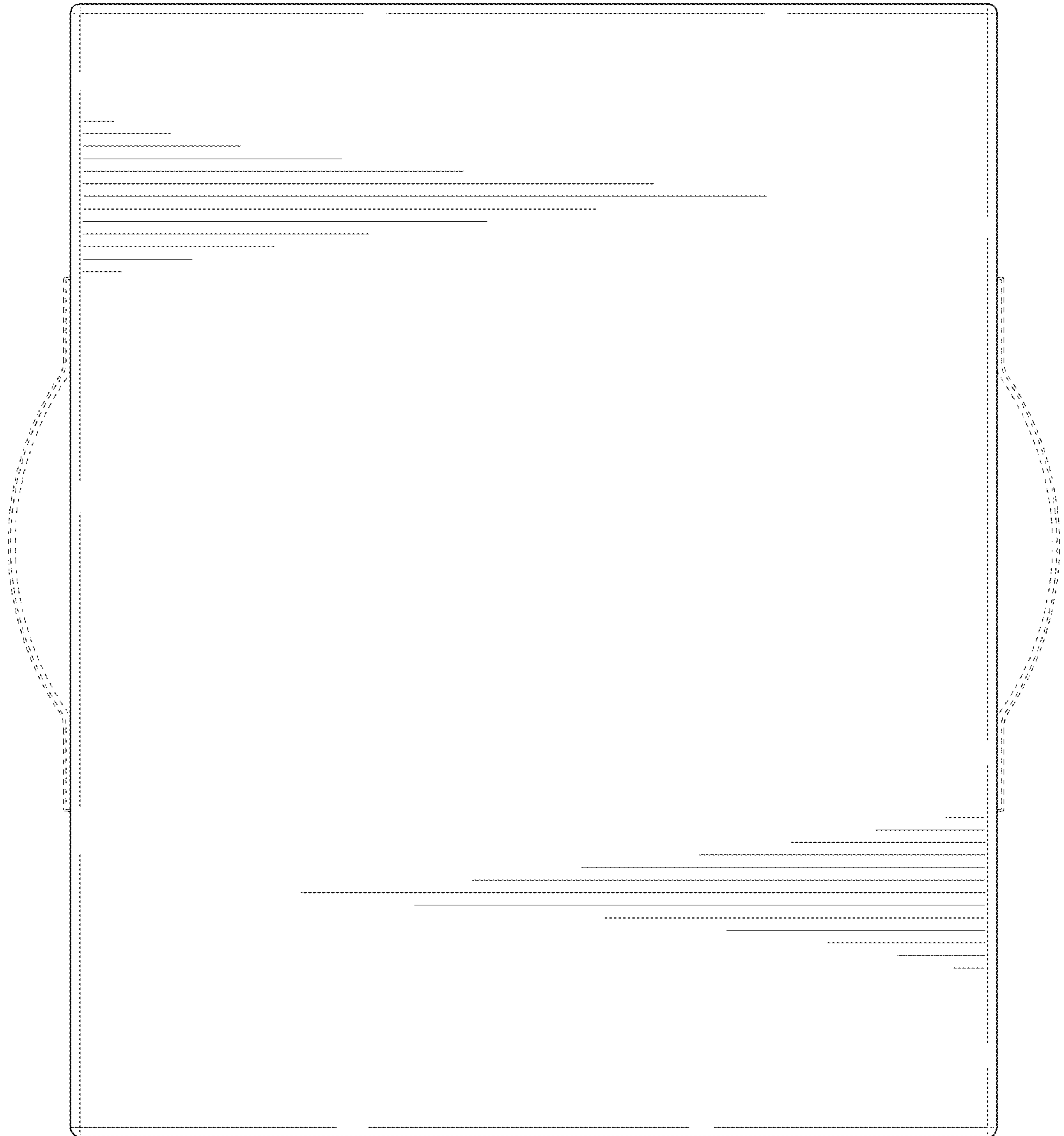

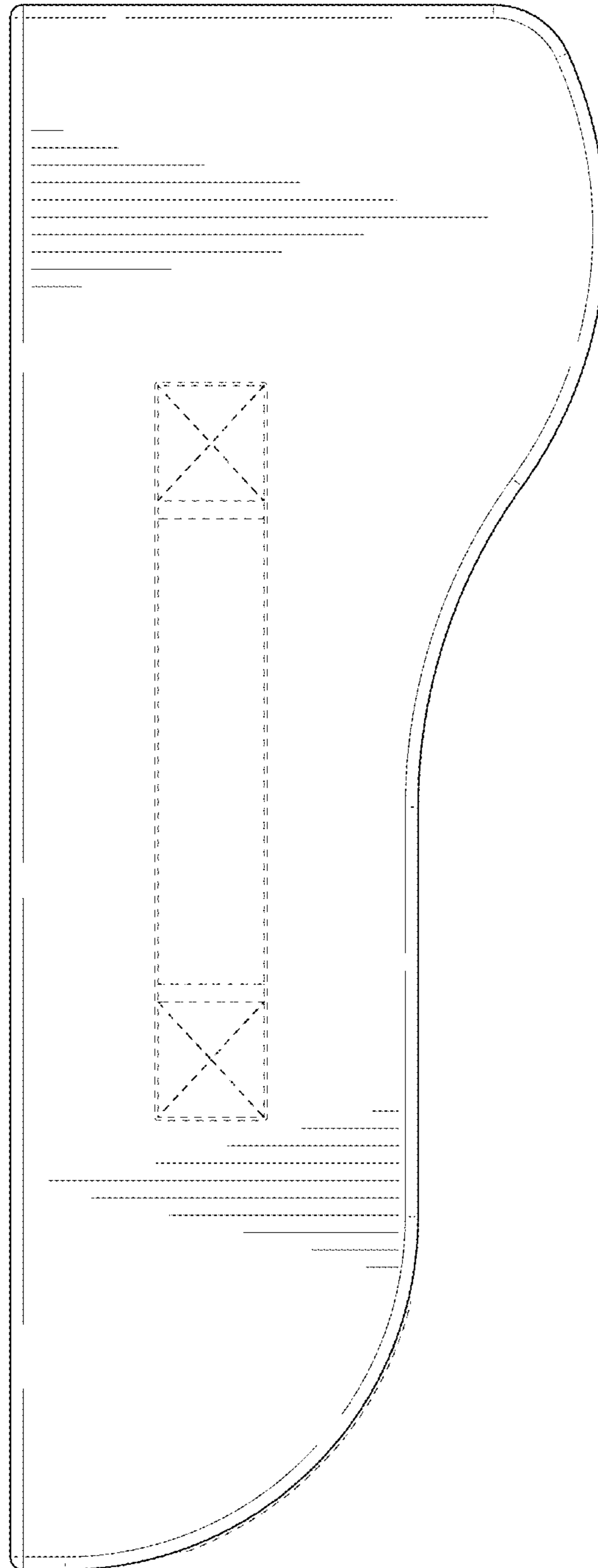

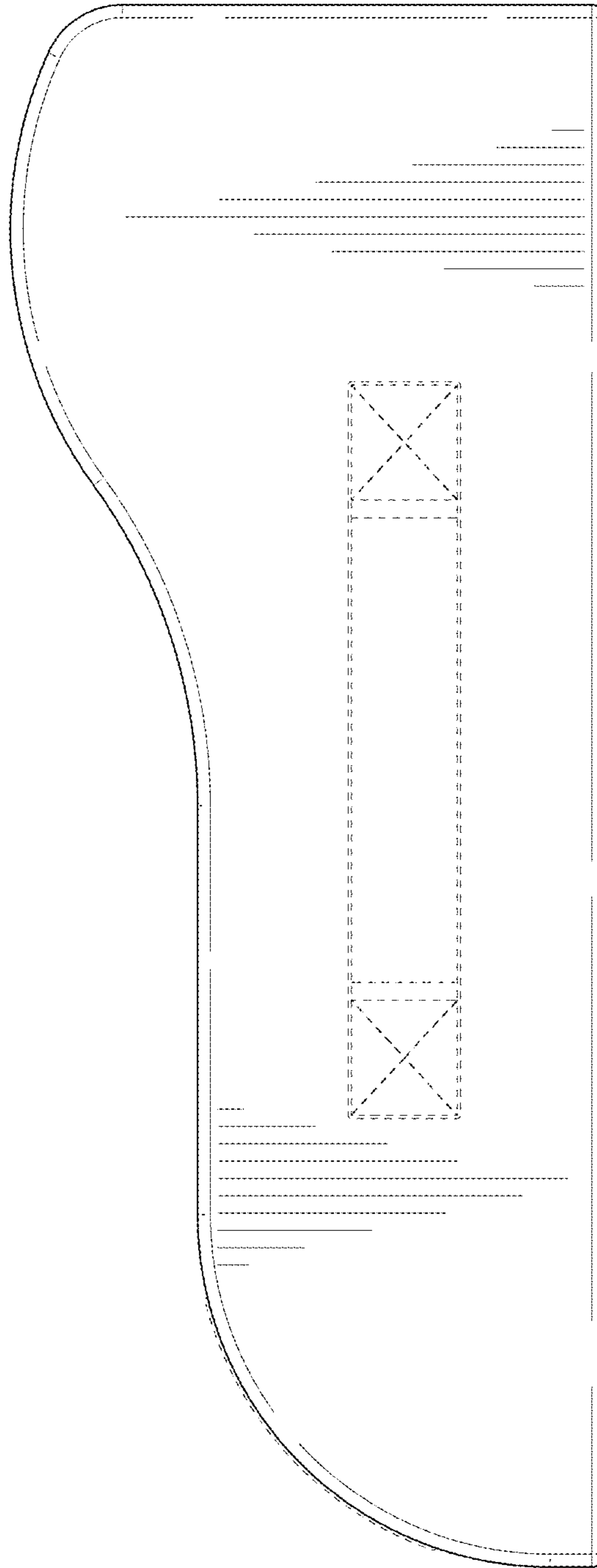

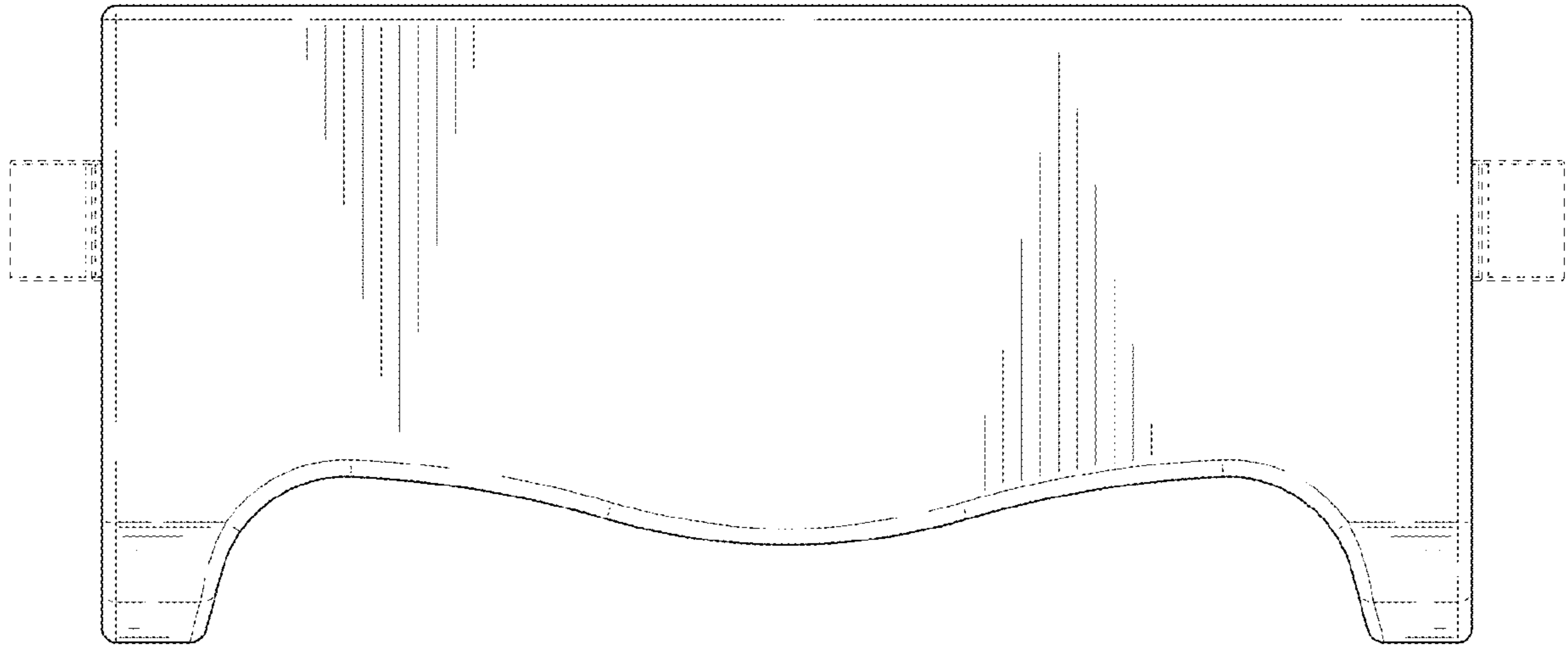

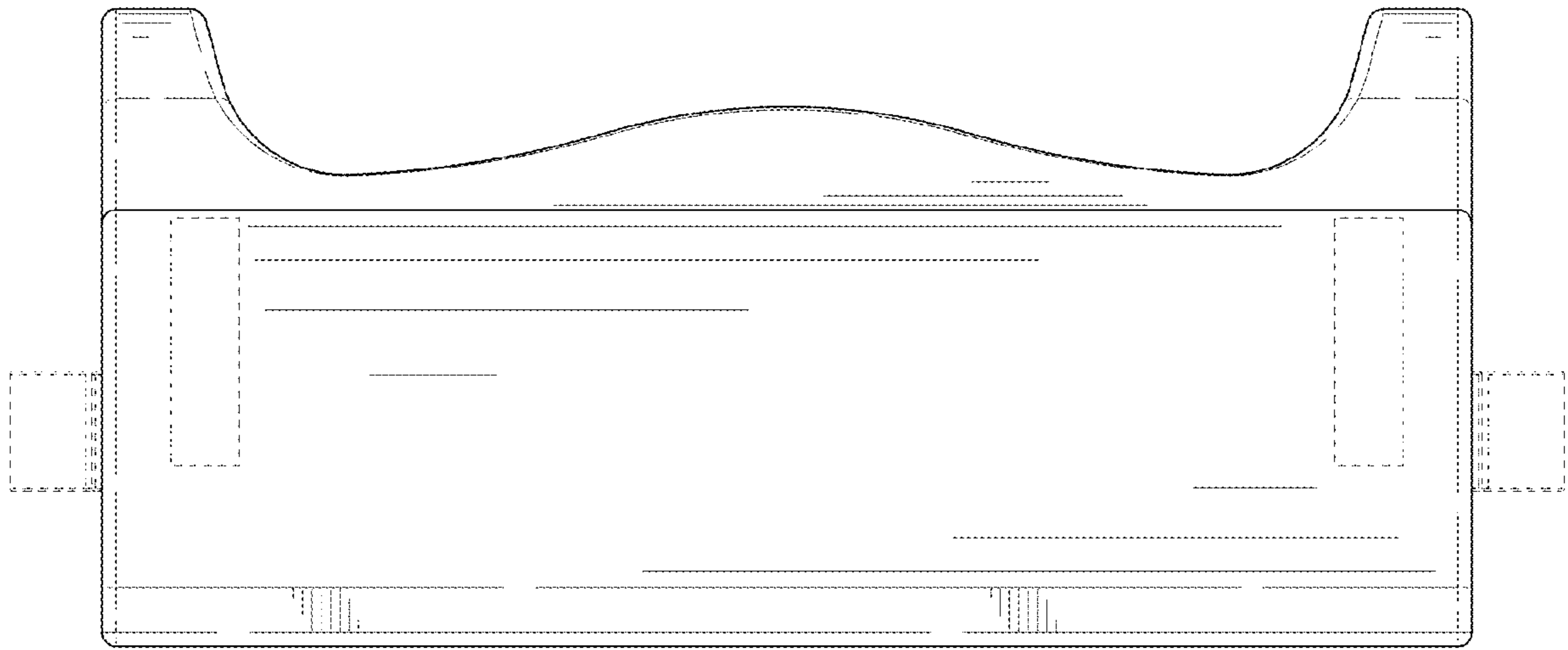
