DESCRIPTION

FIG. 1 is a perspective view of a scoop having a deformable handle;

FIG. 2 is a top view of a scoop having a deformable handle; FIG. 3 is a bottom view of a scoop having a deformable handle;

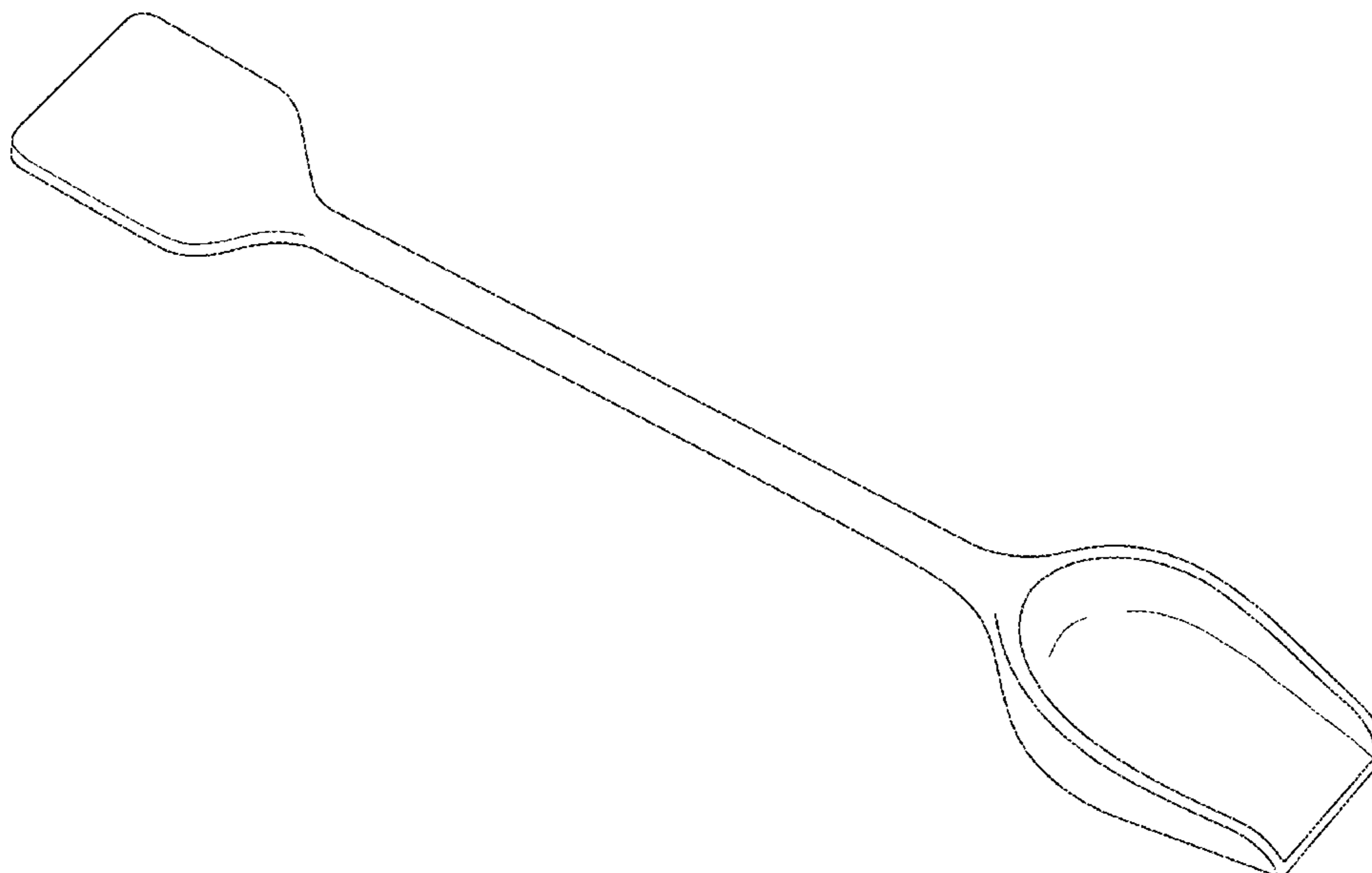
FIG. 4 is a left side view of a scoop having a deformable handle including deformable members;

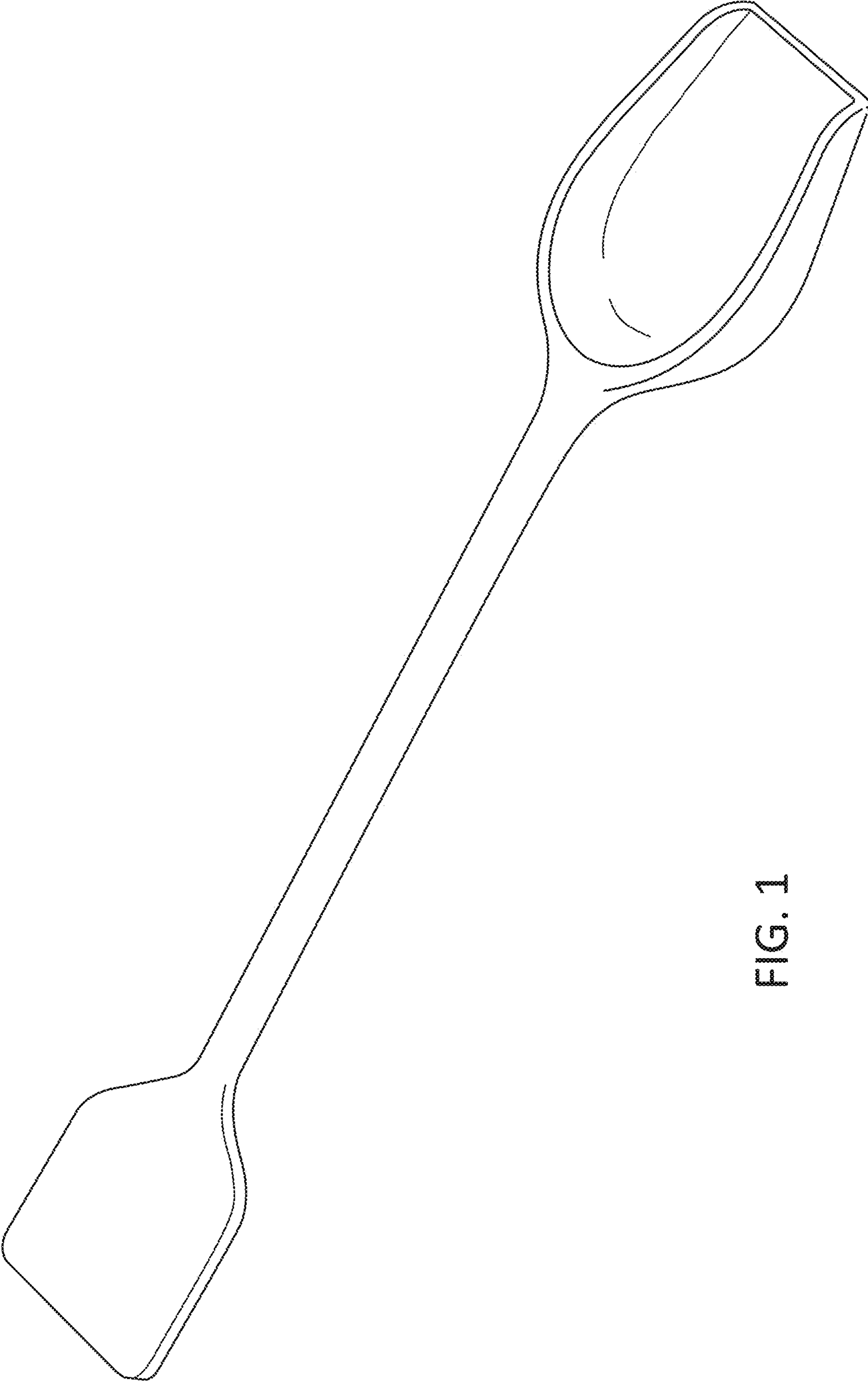

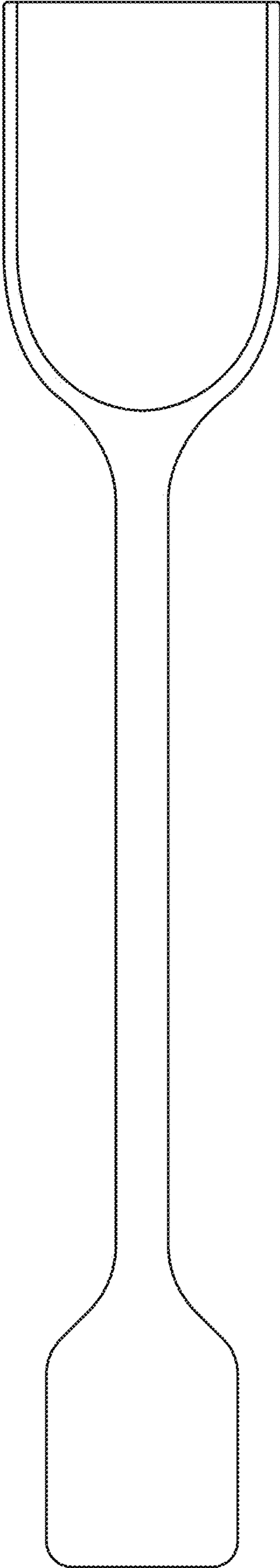

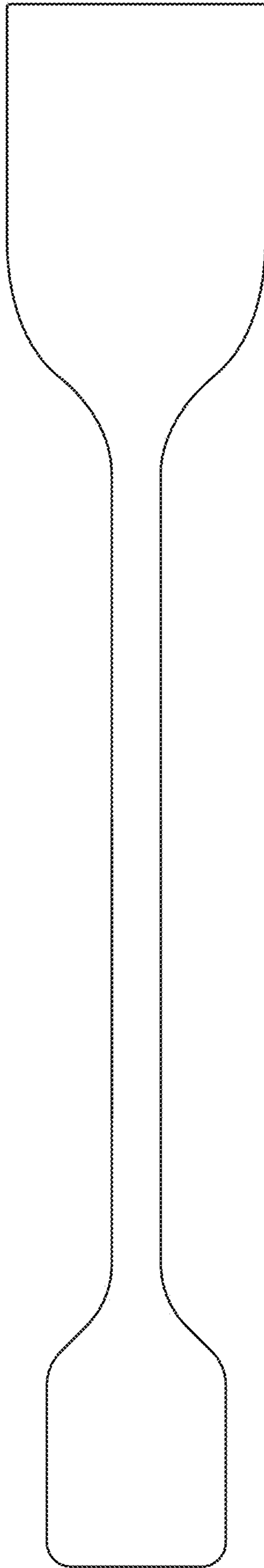

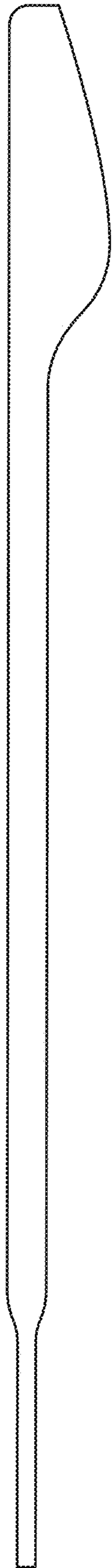

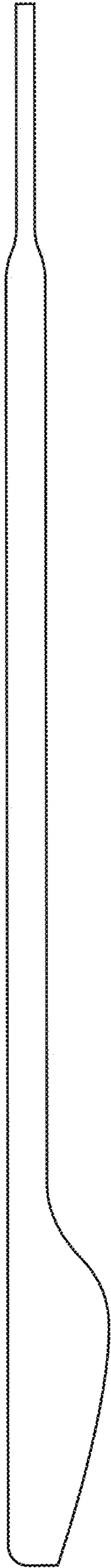

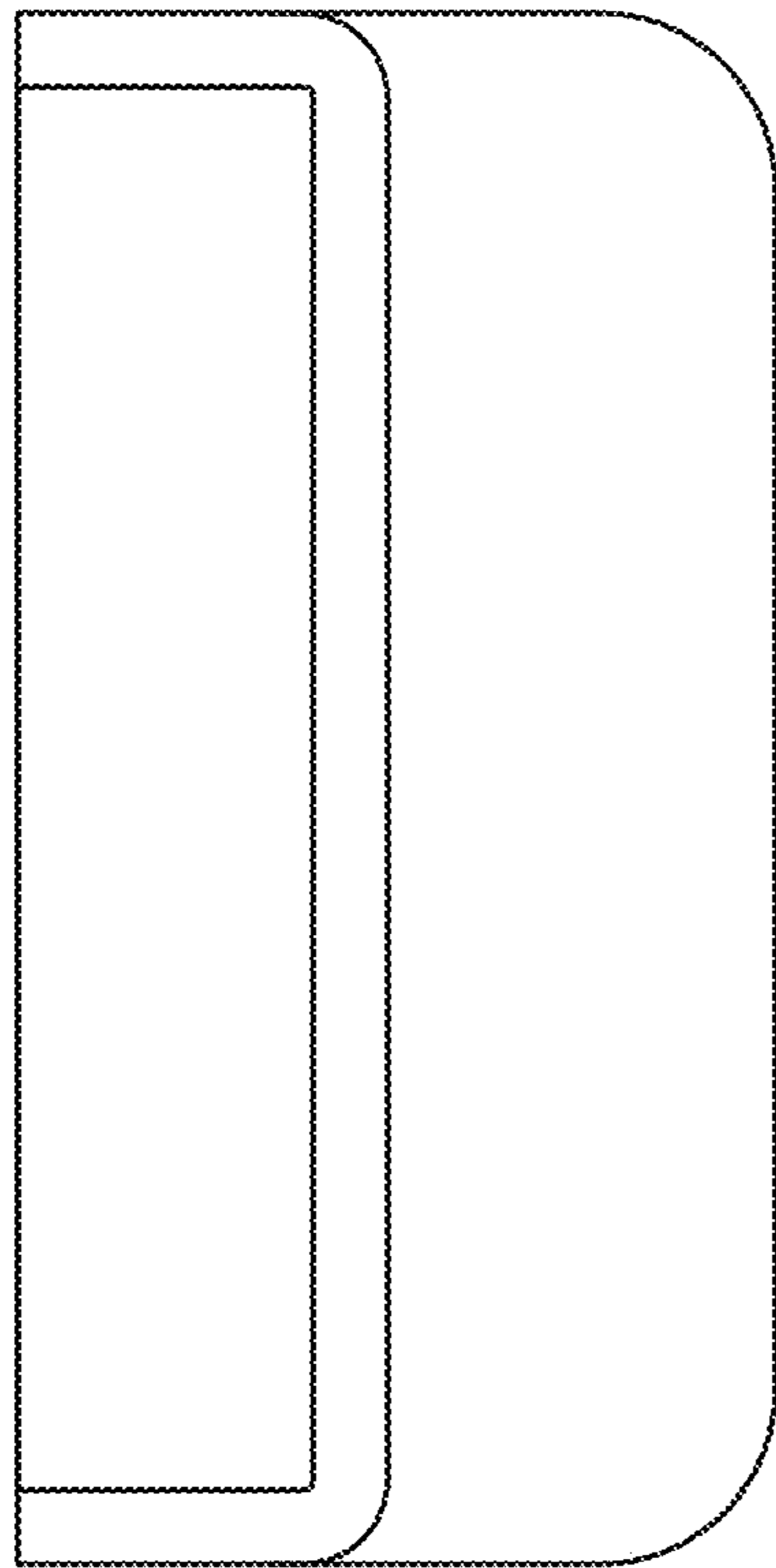

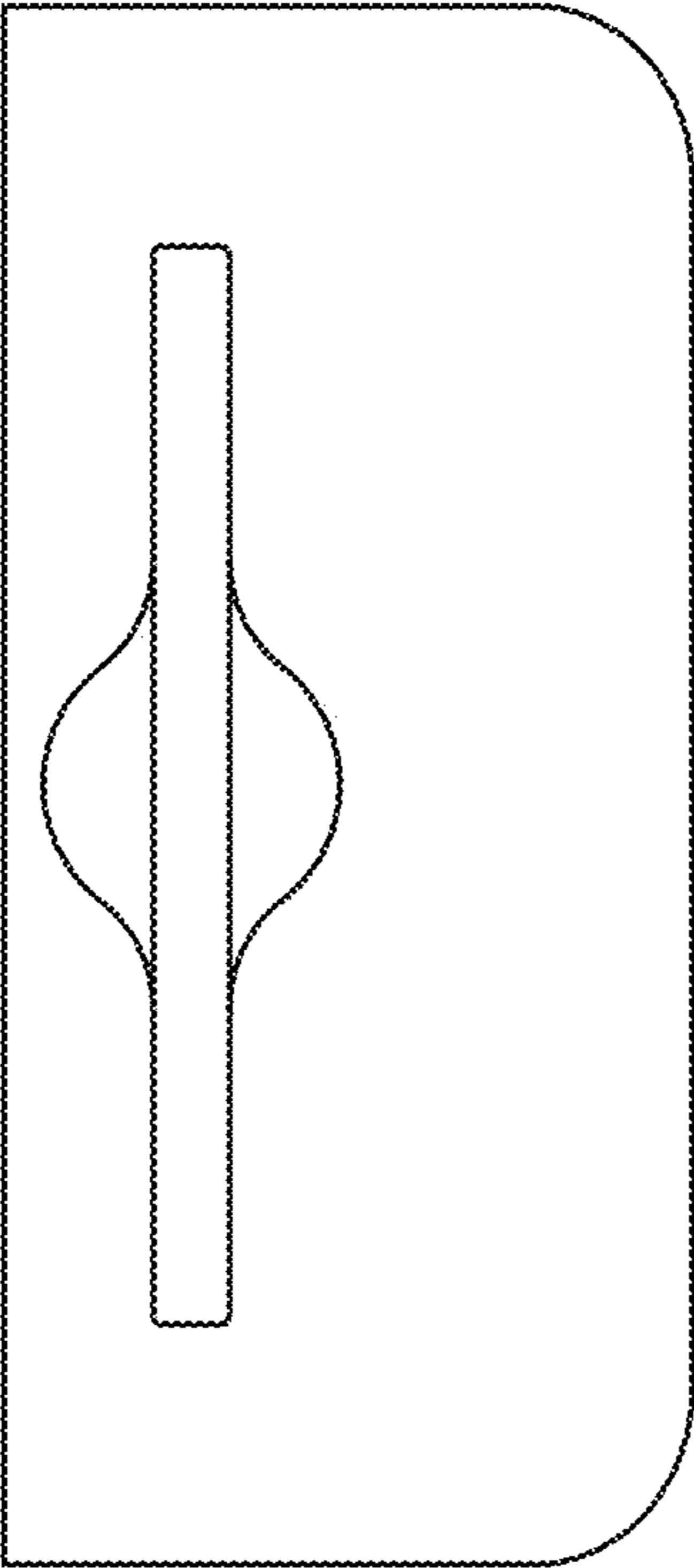
