The ornamental design for scissors, as shown and described.

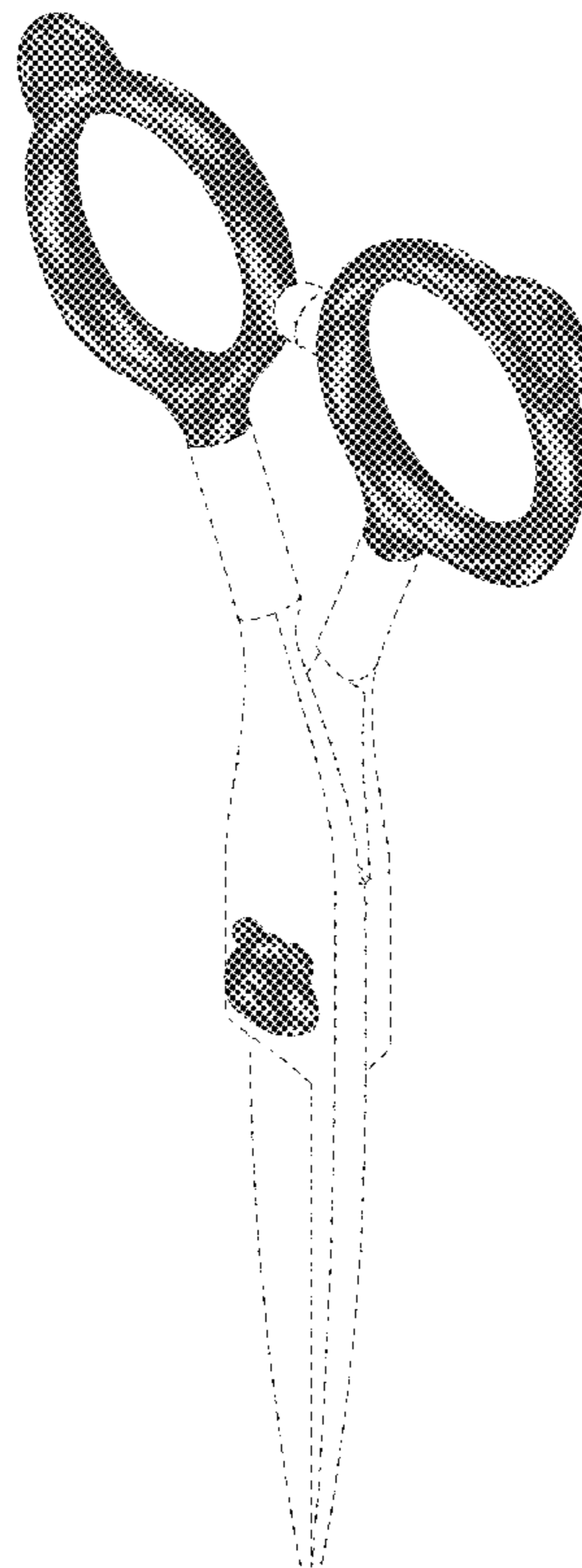
DESCRIPTION

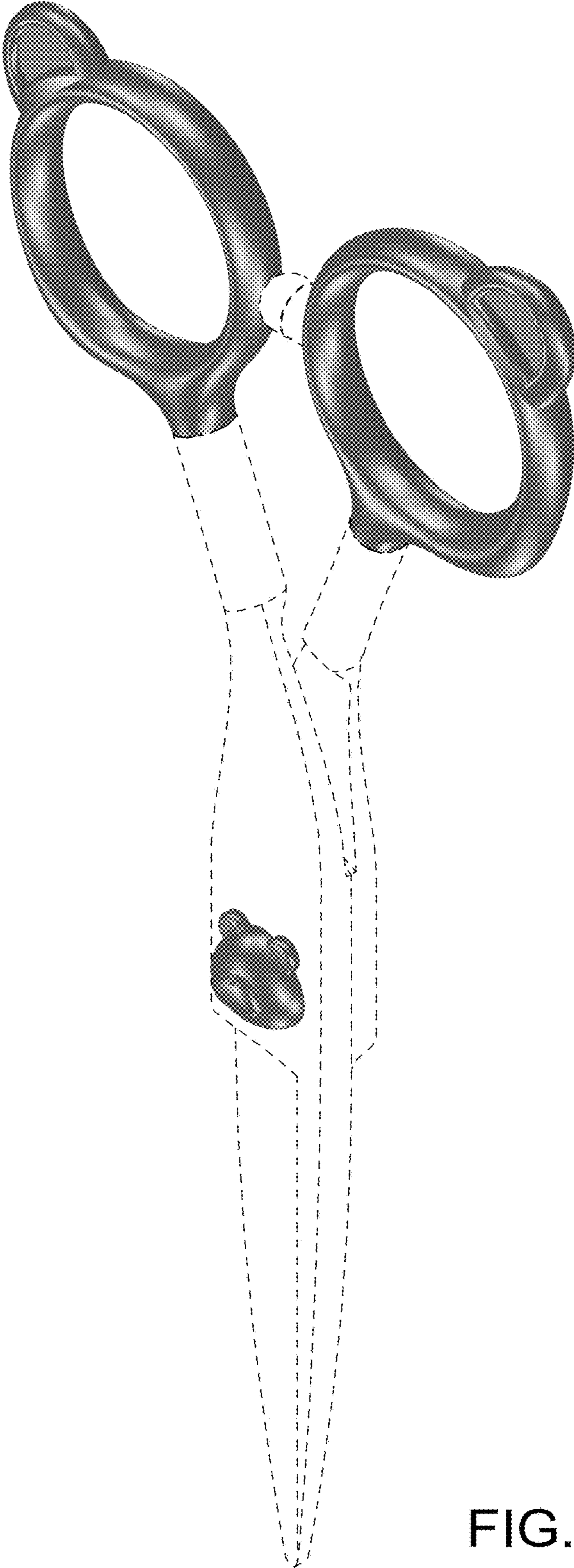

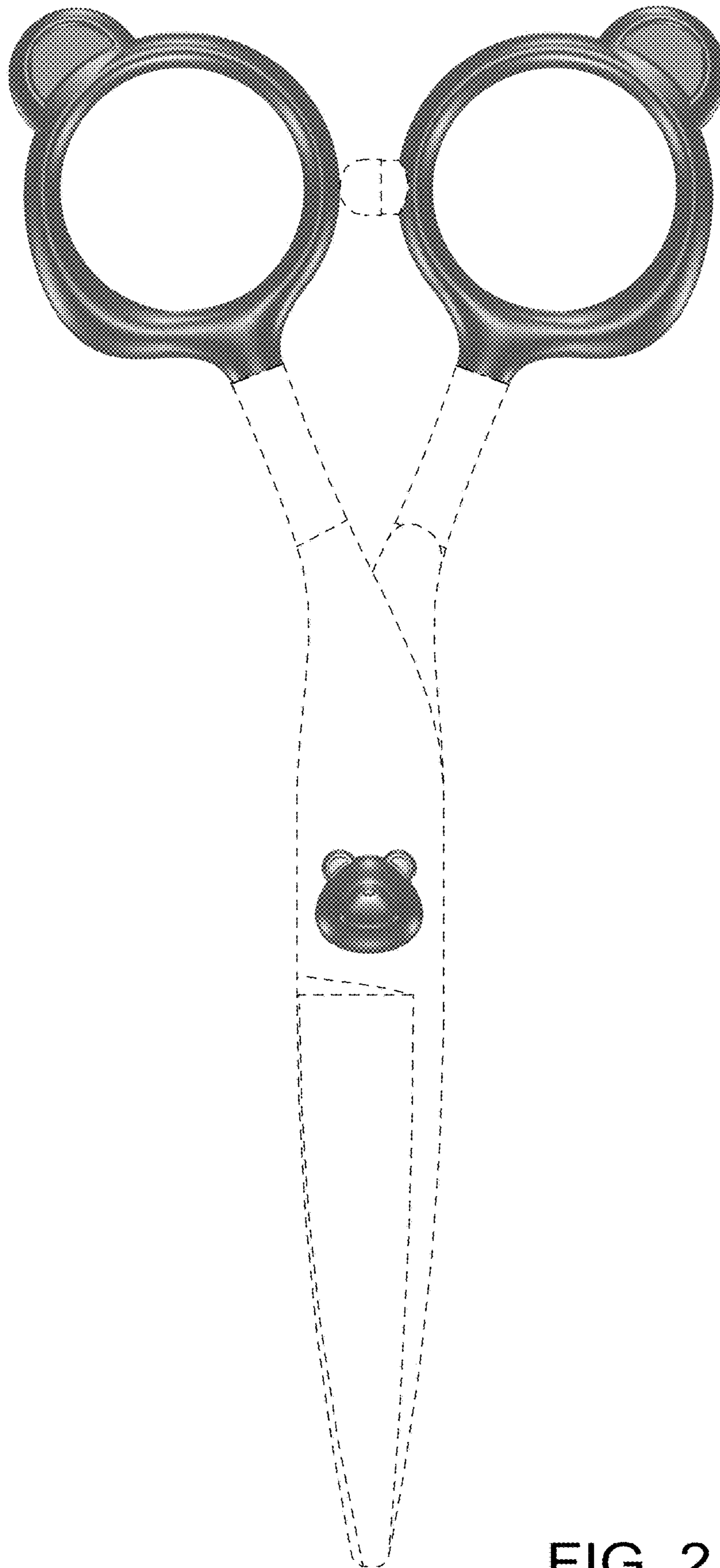

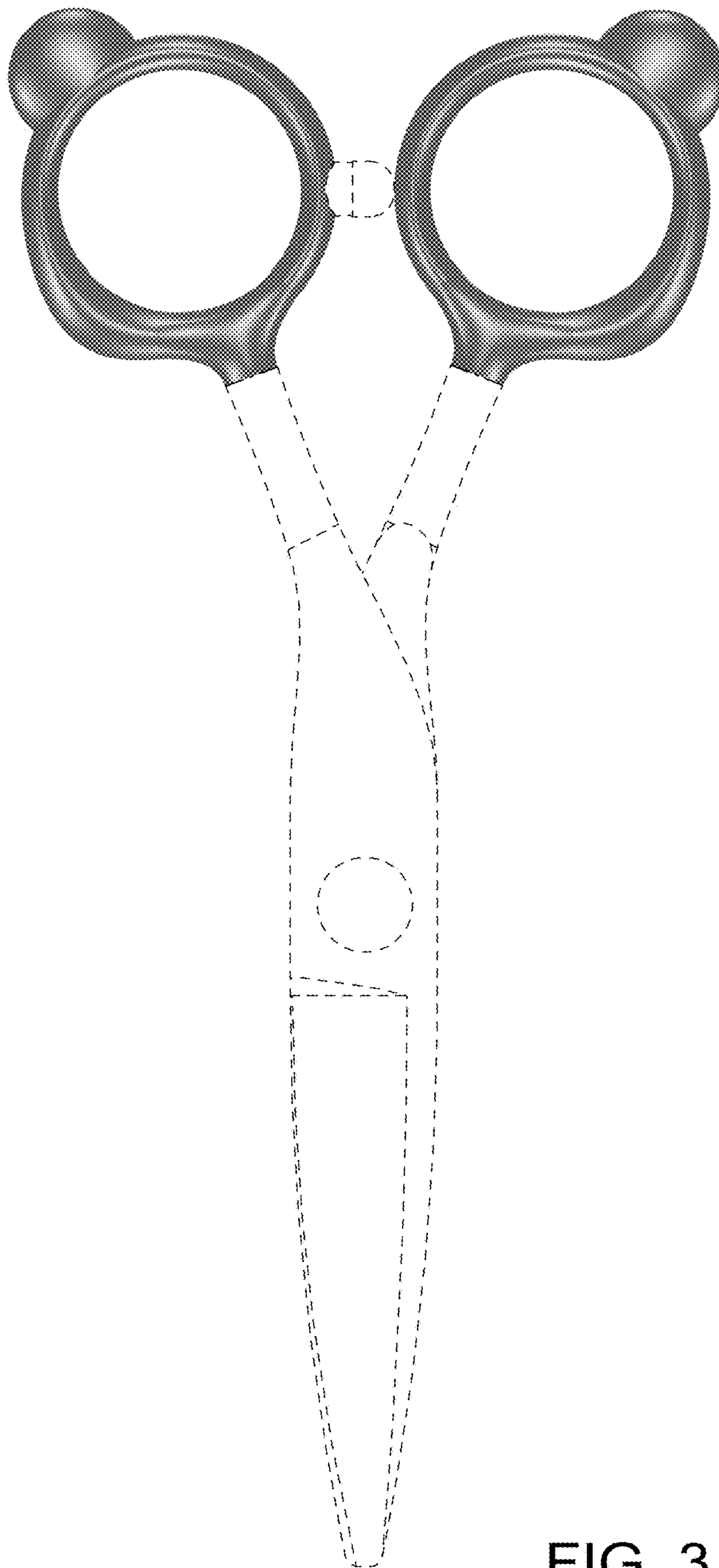

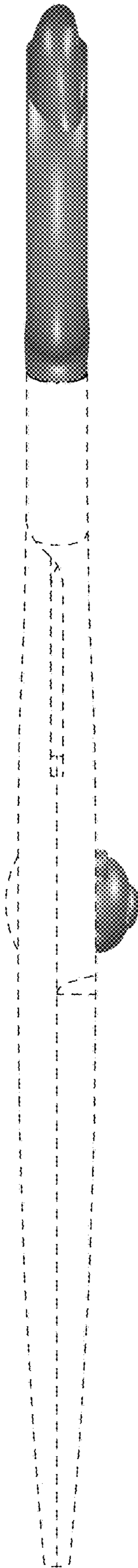

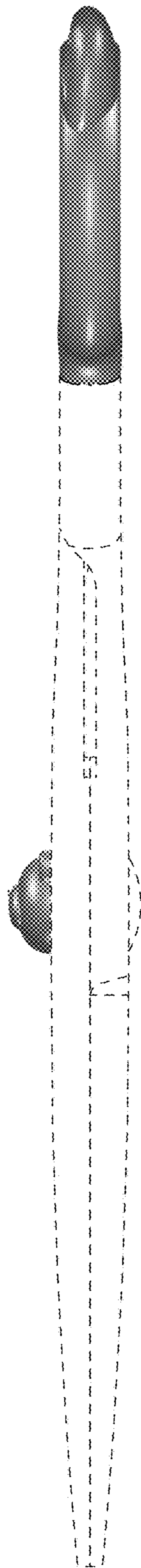

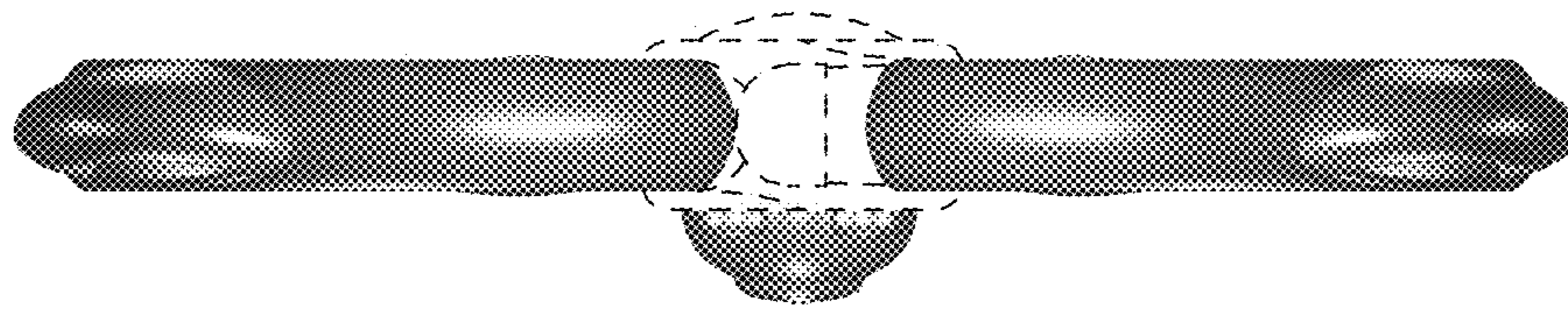

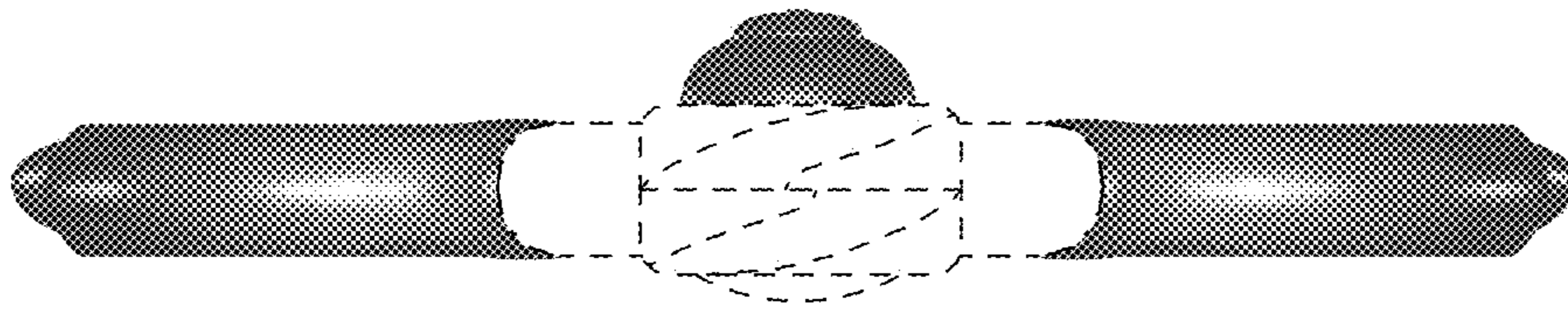
